(57) **CLAIM**

The ornamental design for a steering tiller for personal mobility vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a left side view of our new design for a steering

tiller for personal mobility vehicle shown in a operating position with the personal mobility vehicle being shown in phantom;

FIG. 2 is view similar to FIG. 1 with the steering tiller for personal mobility vehicle being shown in an open position;

FIG. 3 is view similar to FIG. 1 with the steering tiller for personal mobility vehicle being shown in a first operating position;

FIG. 4 is view similar to FIG. 1 with the steering tiller for personal mobility vehicle being shown in a second operating position;

FIG. 5 is an enlarged left side view of our new design for a steering tiller for personal mobility vehicle;

FIG. 6 is a front view thereof;

FIG. 7 is a right side view thereof;

FIG. 8 is a rear view thereof;

FIG. 9 is an enlarged top view of FIG. 7;

FIG. 10 is an enlarged bottom view of FIG. 7;

FIG. 13 is a right side view thereof;

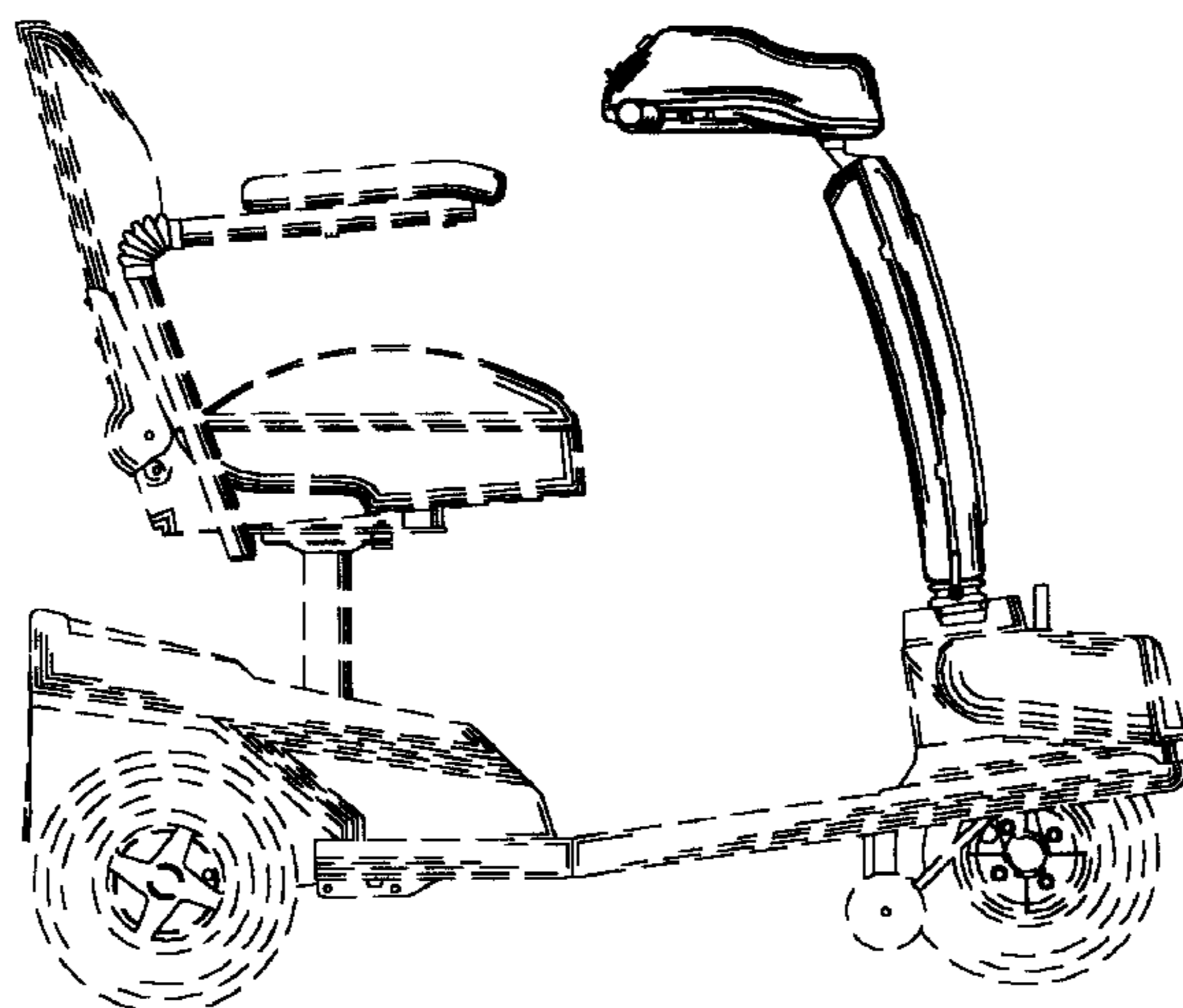
FIG. 14 is a rear view thereof;

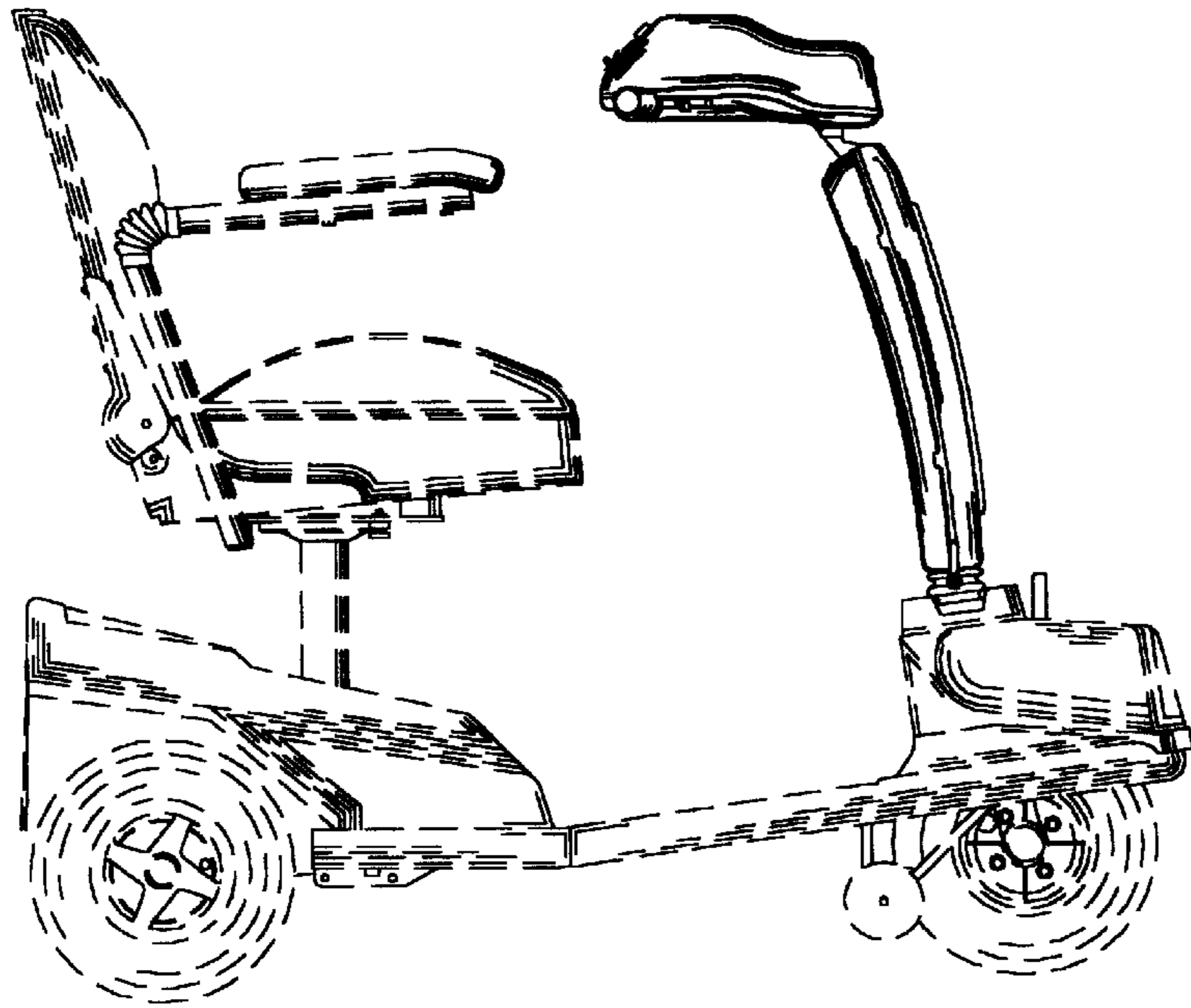

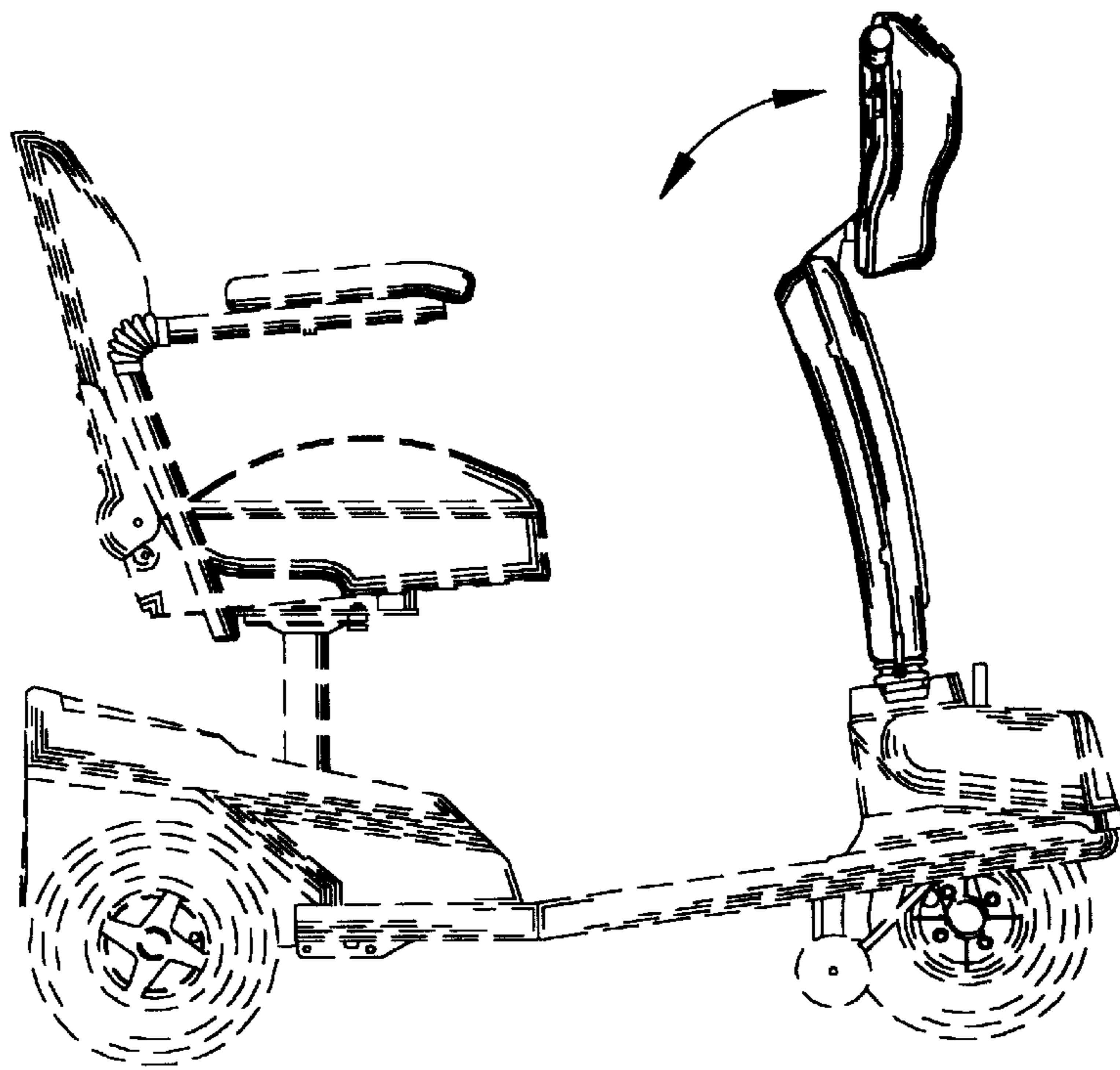

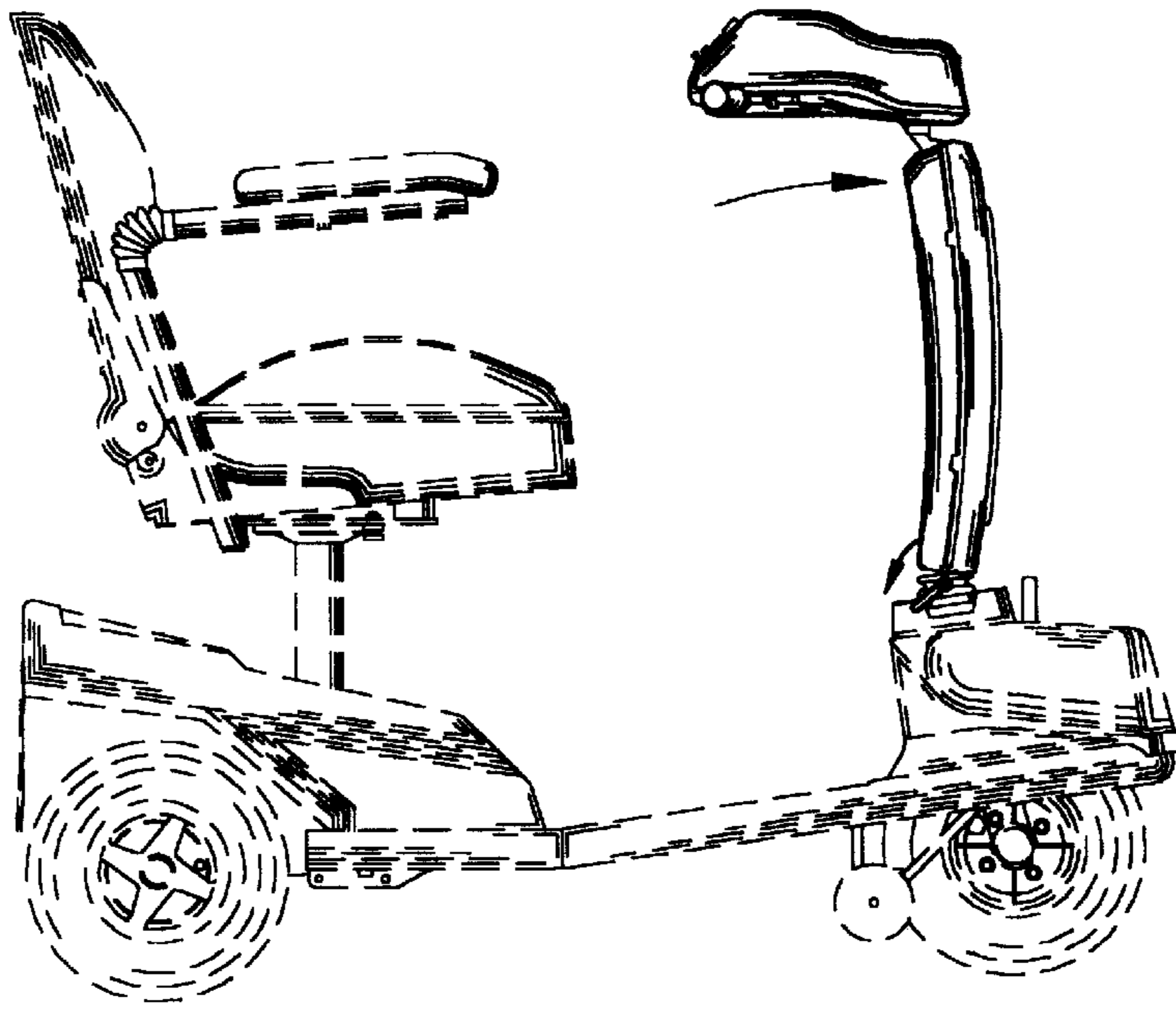

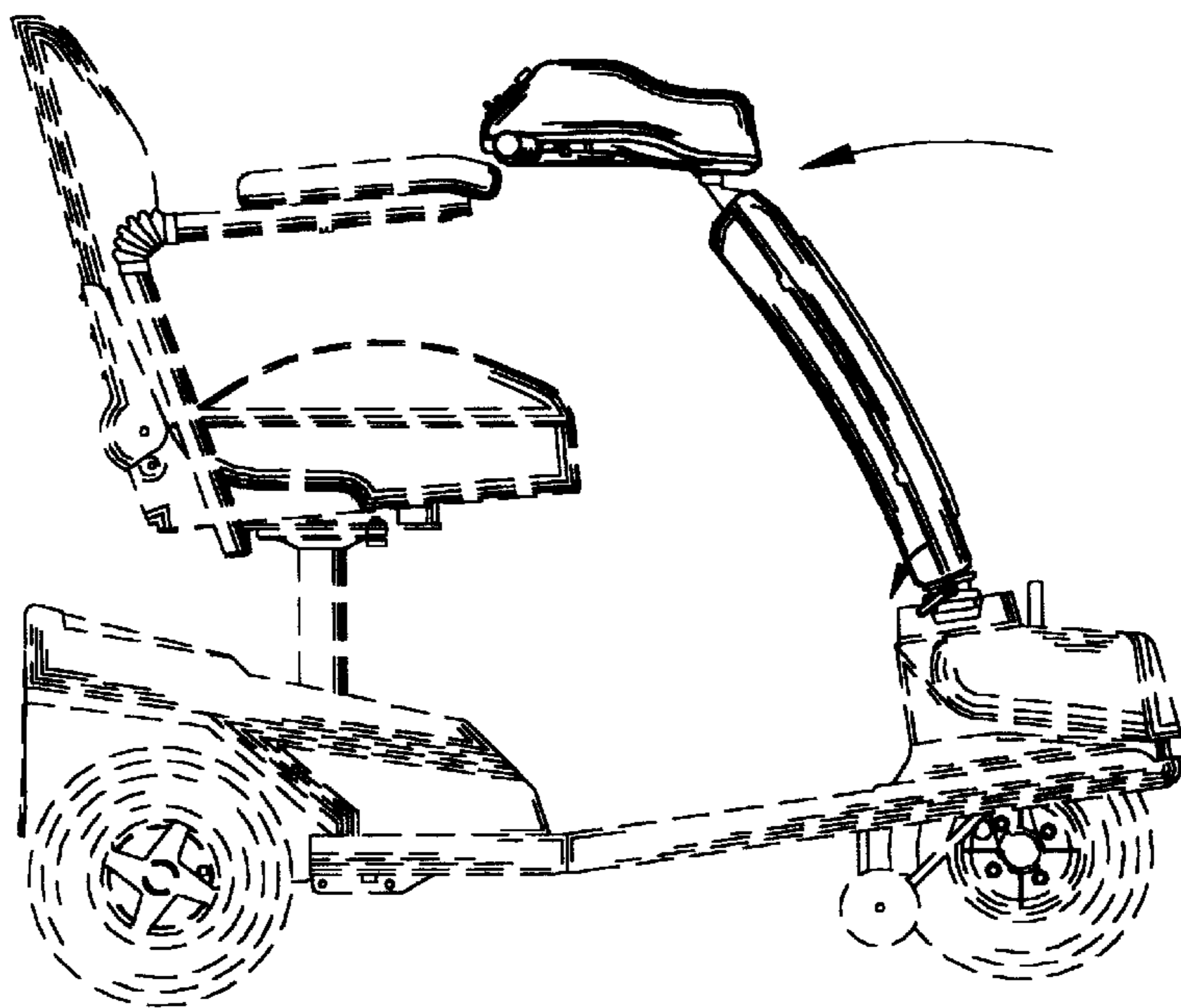

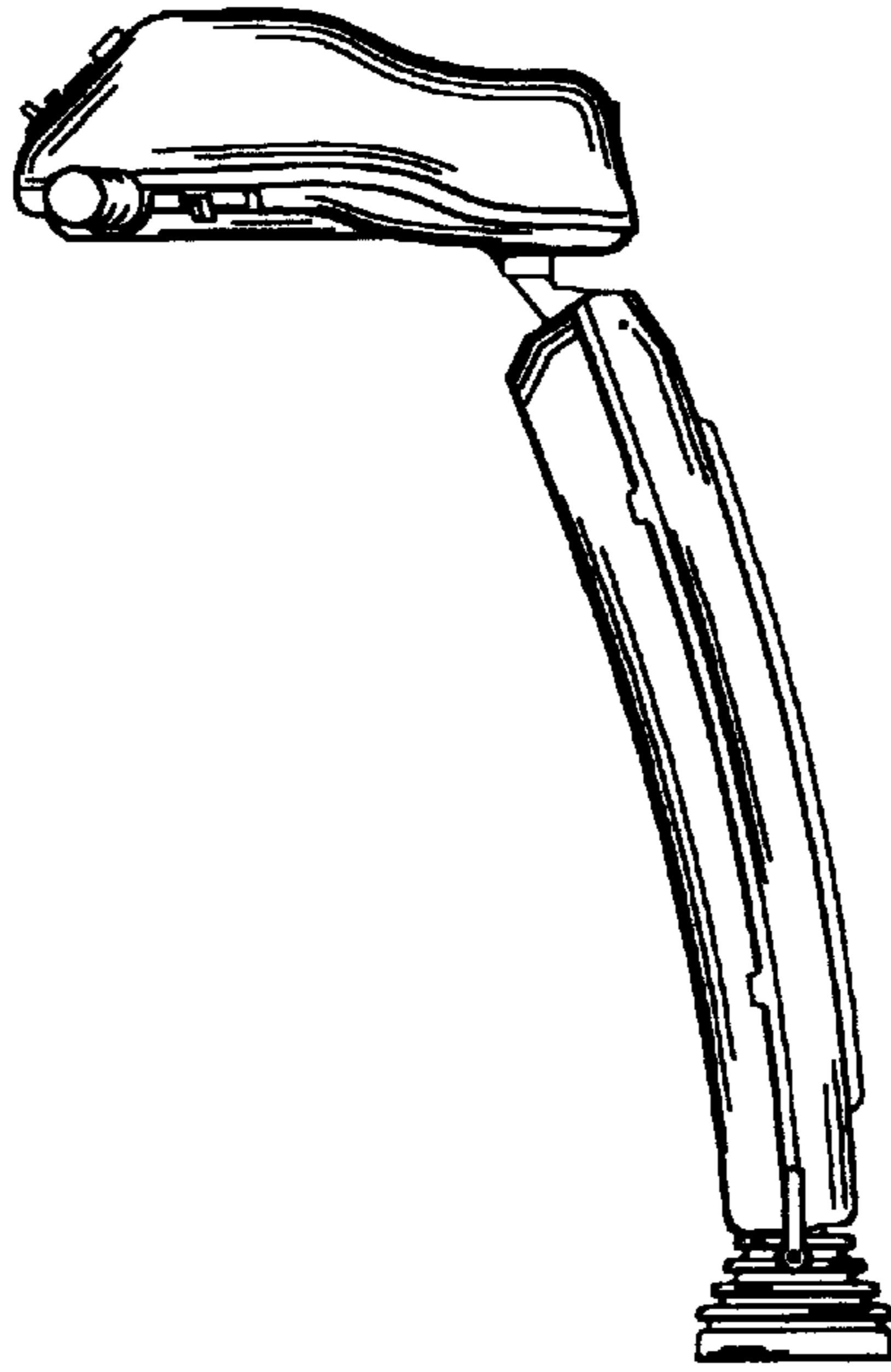

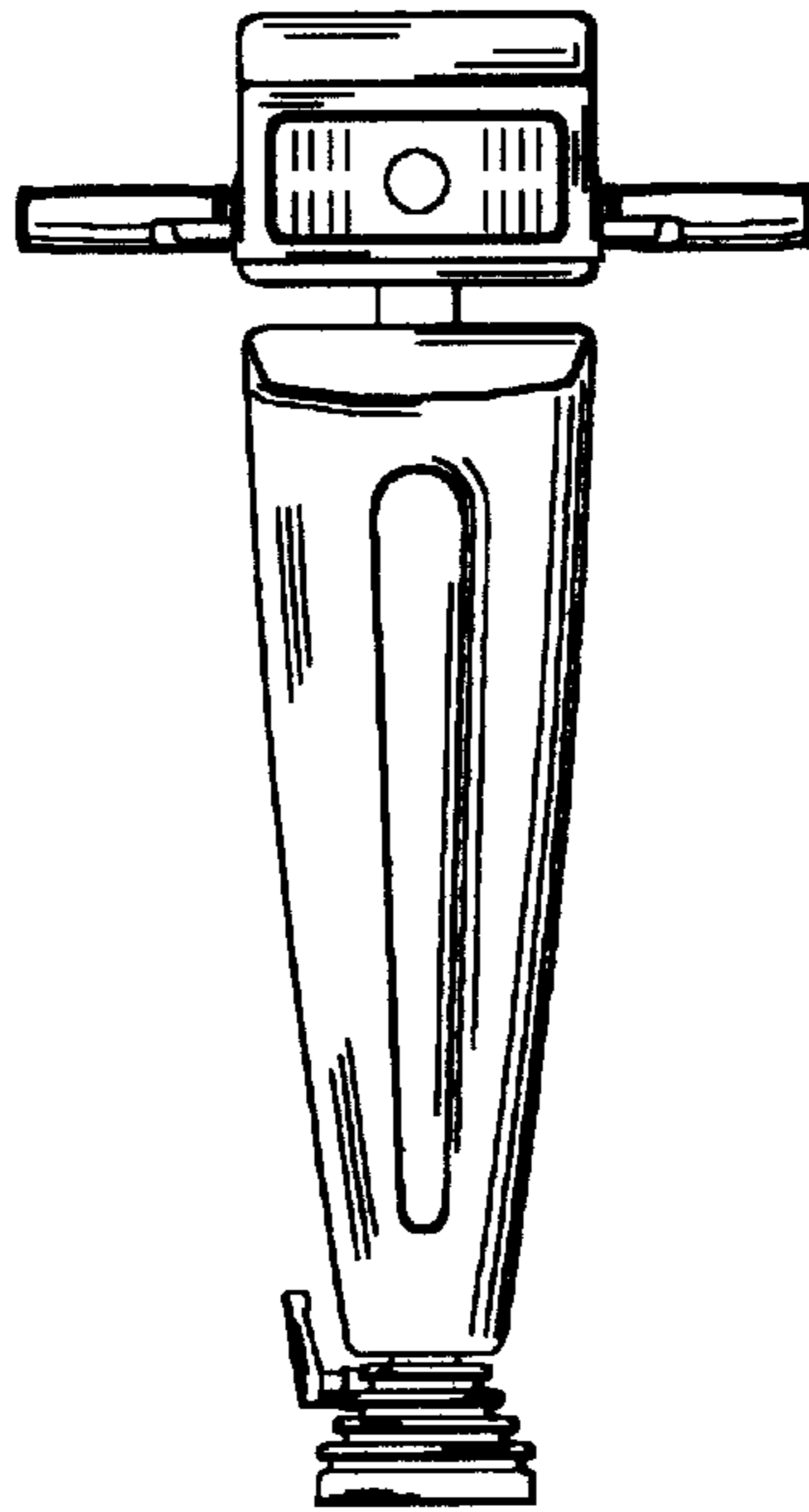

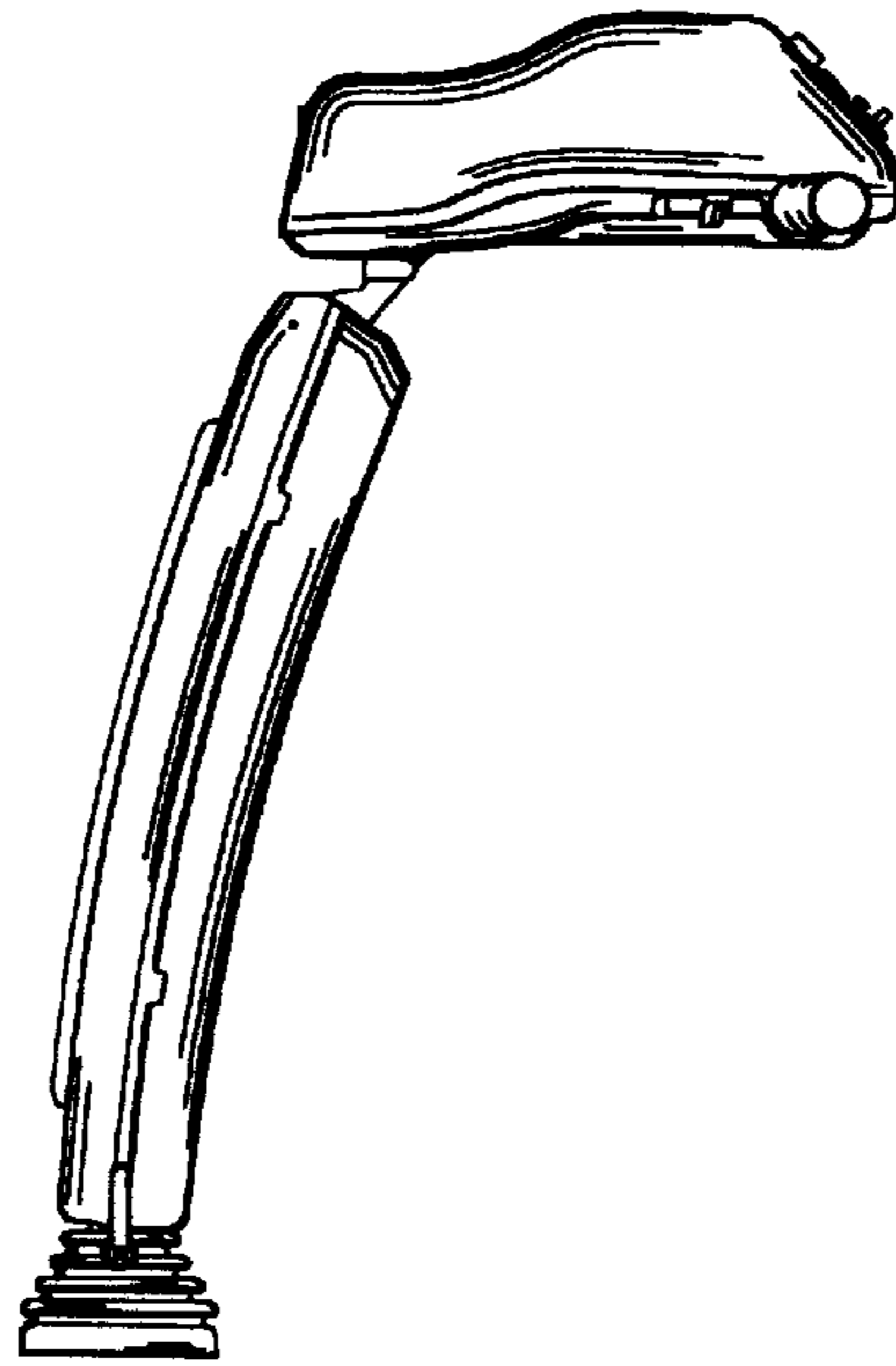

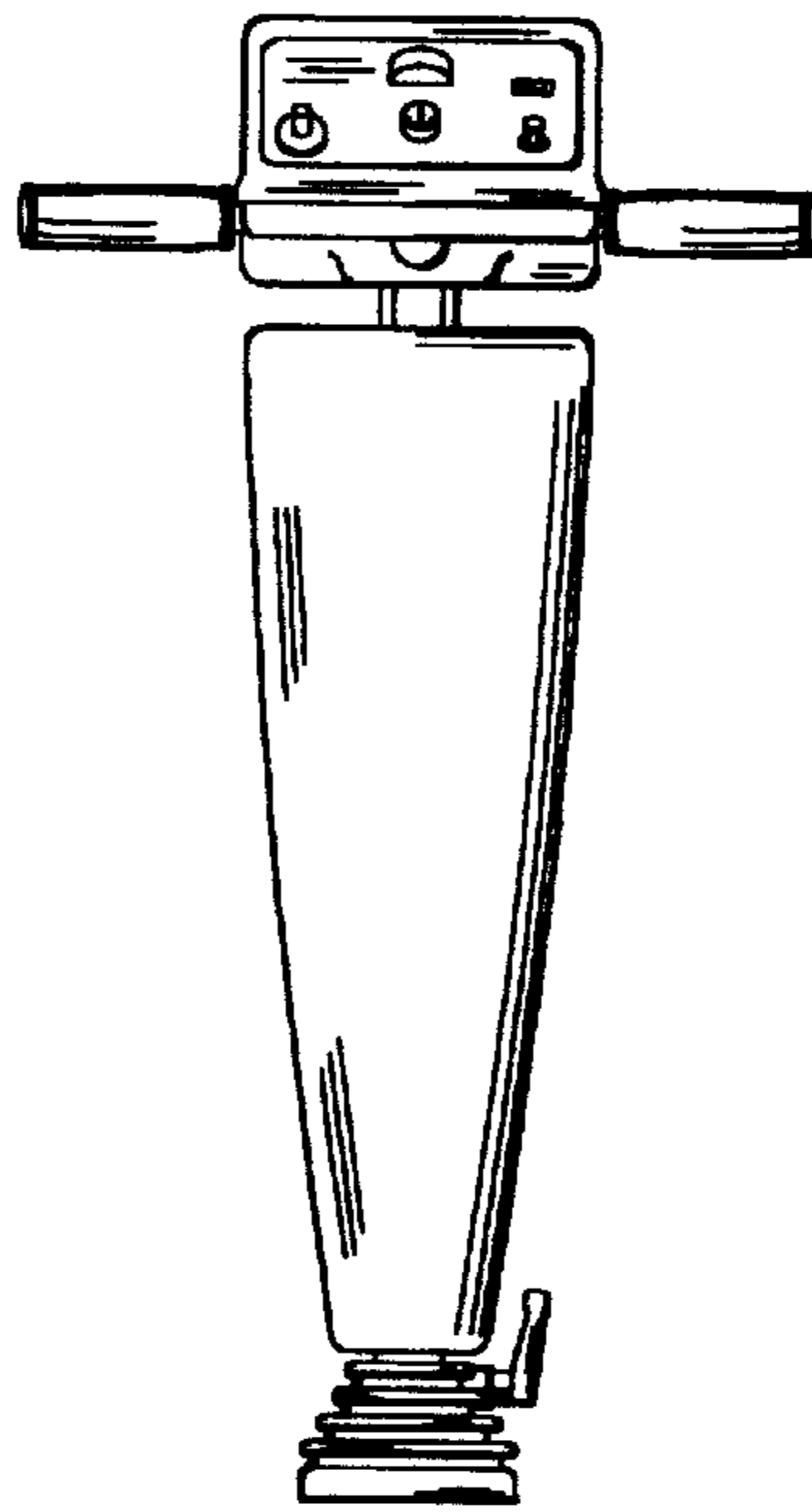

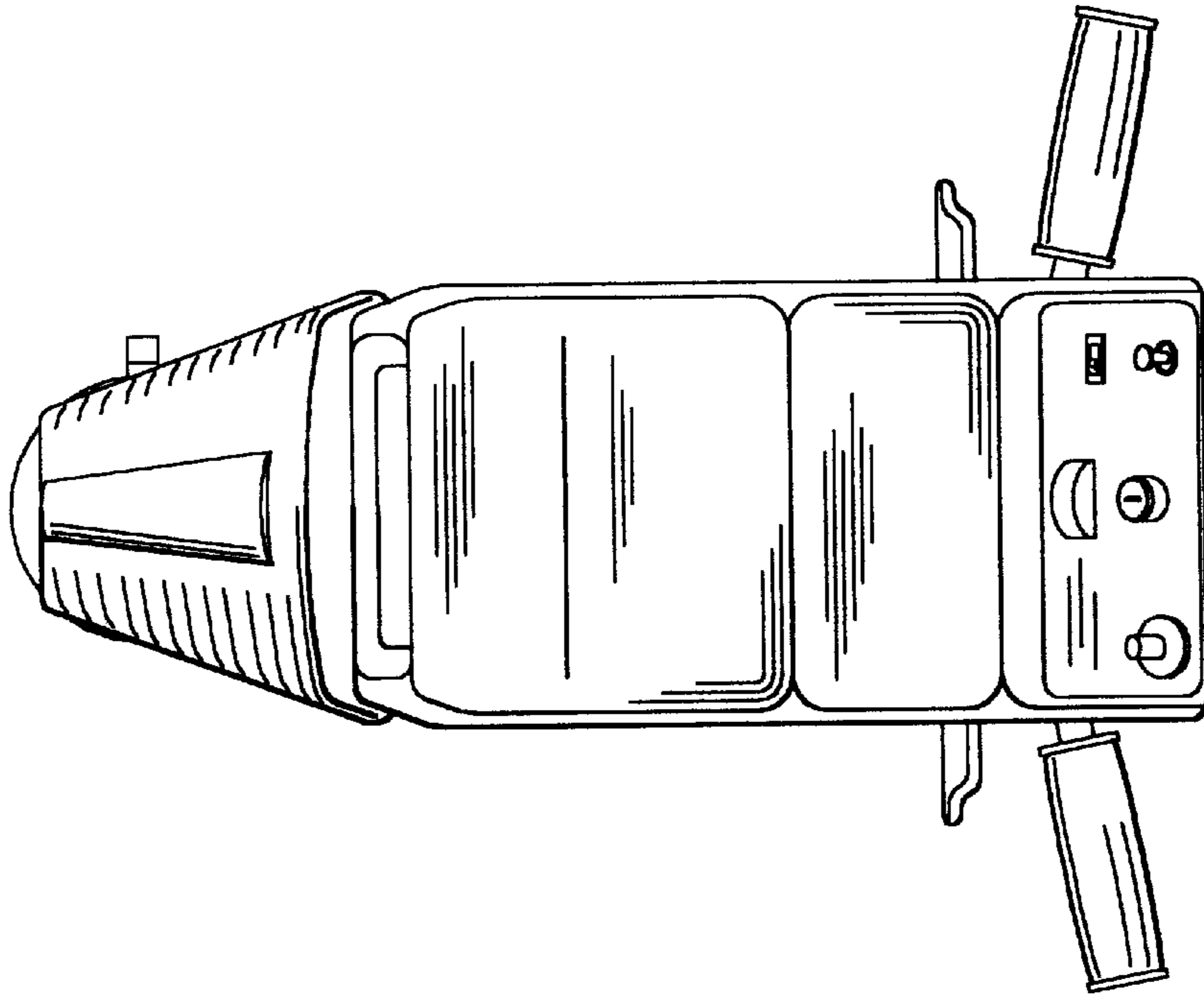

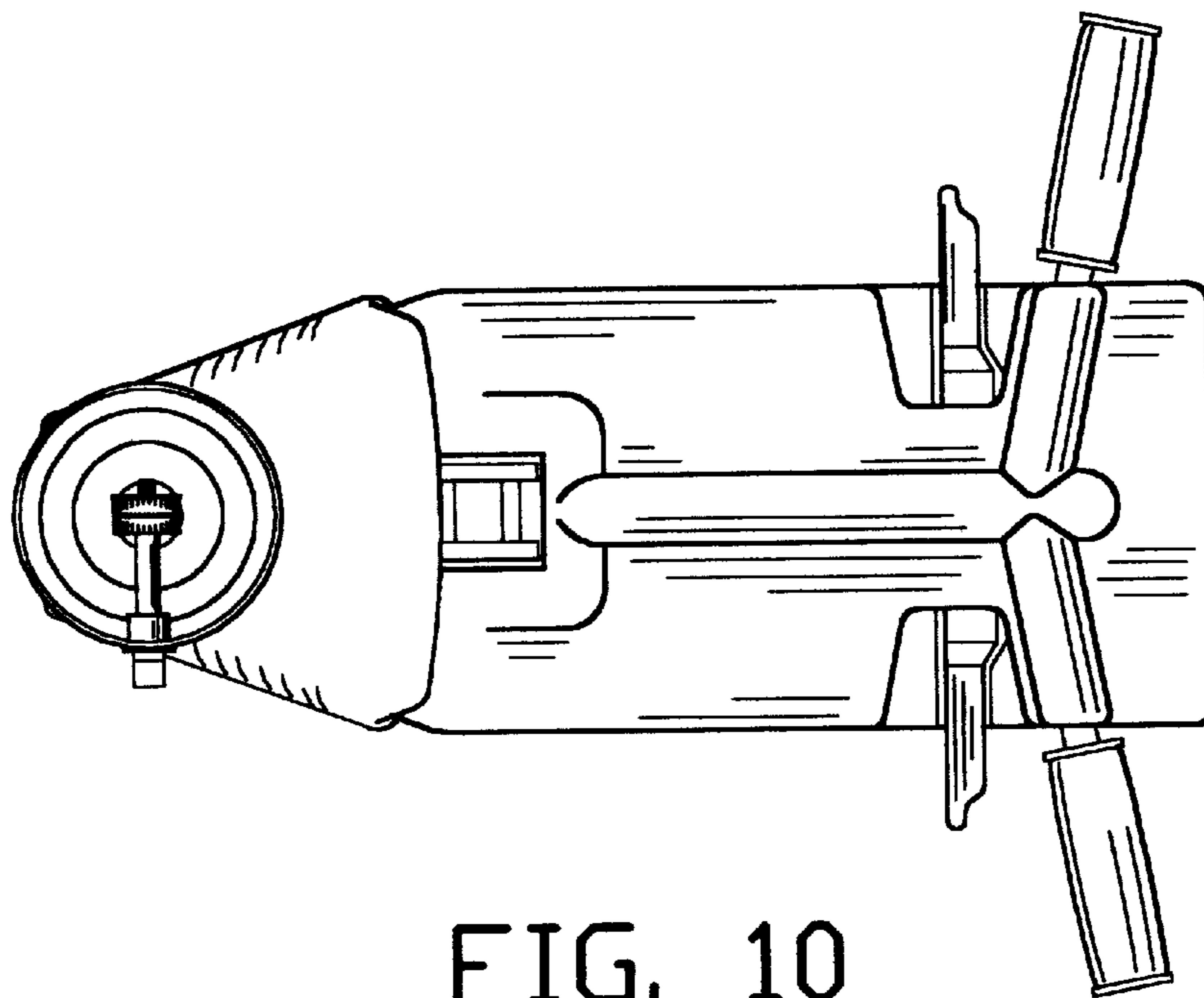

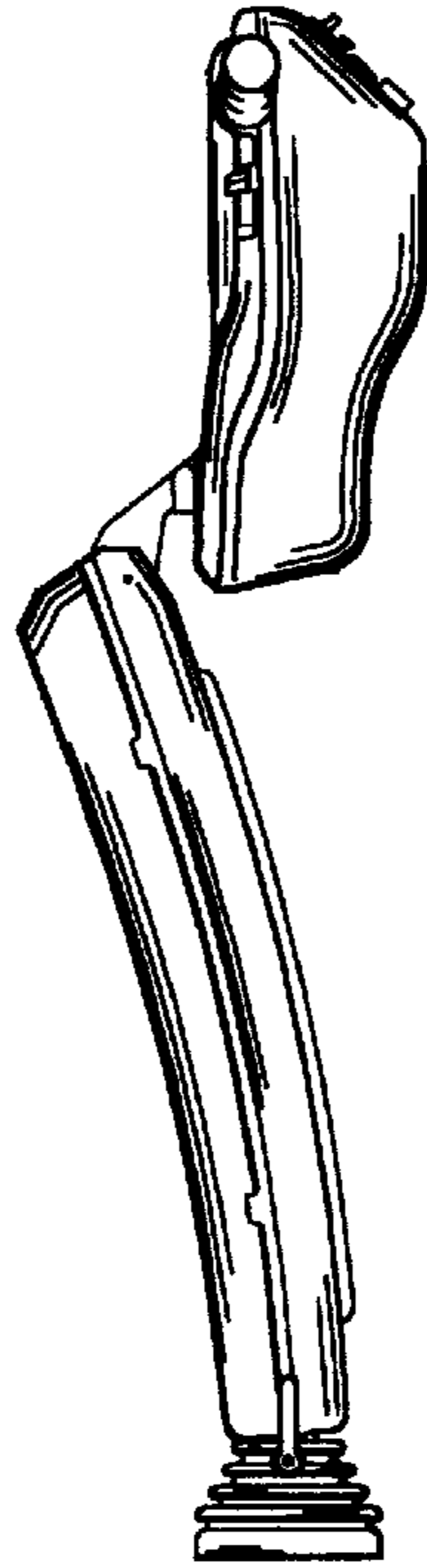

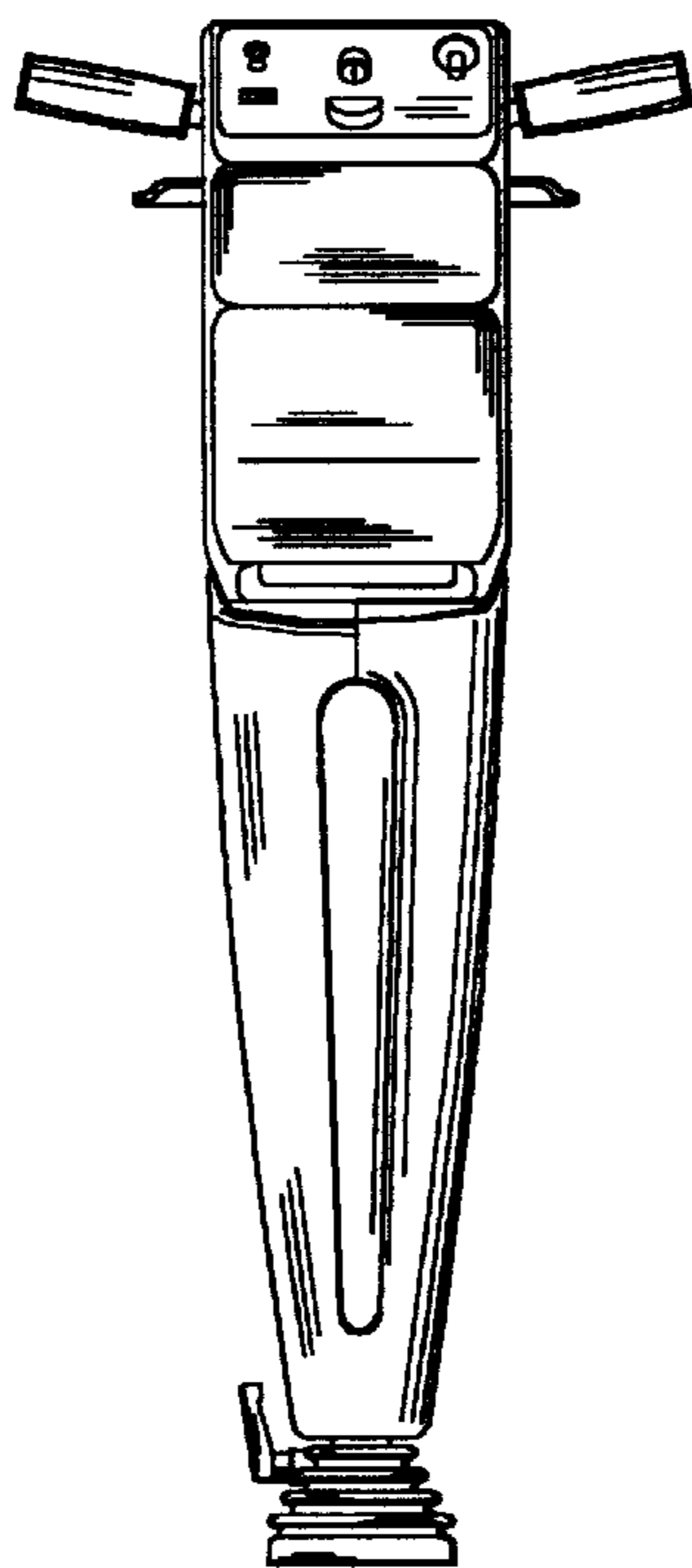

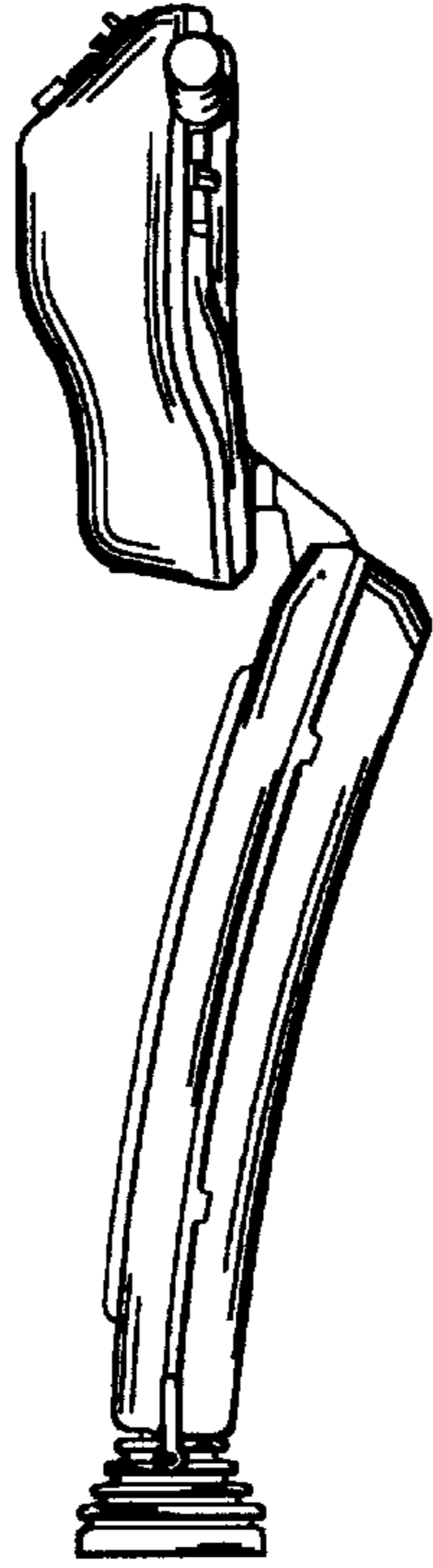

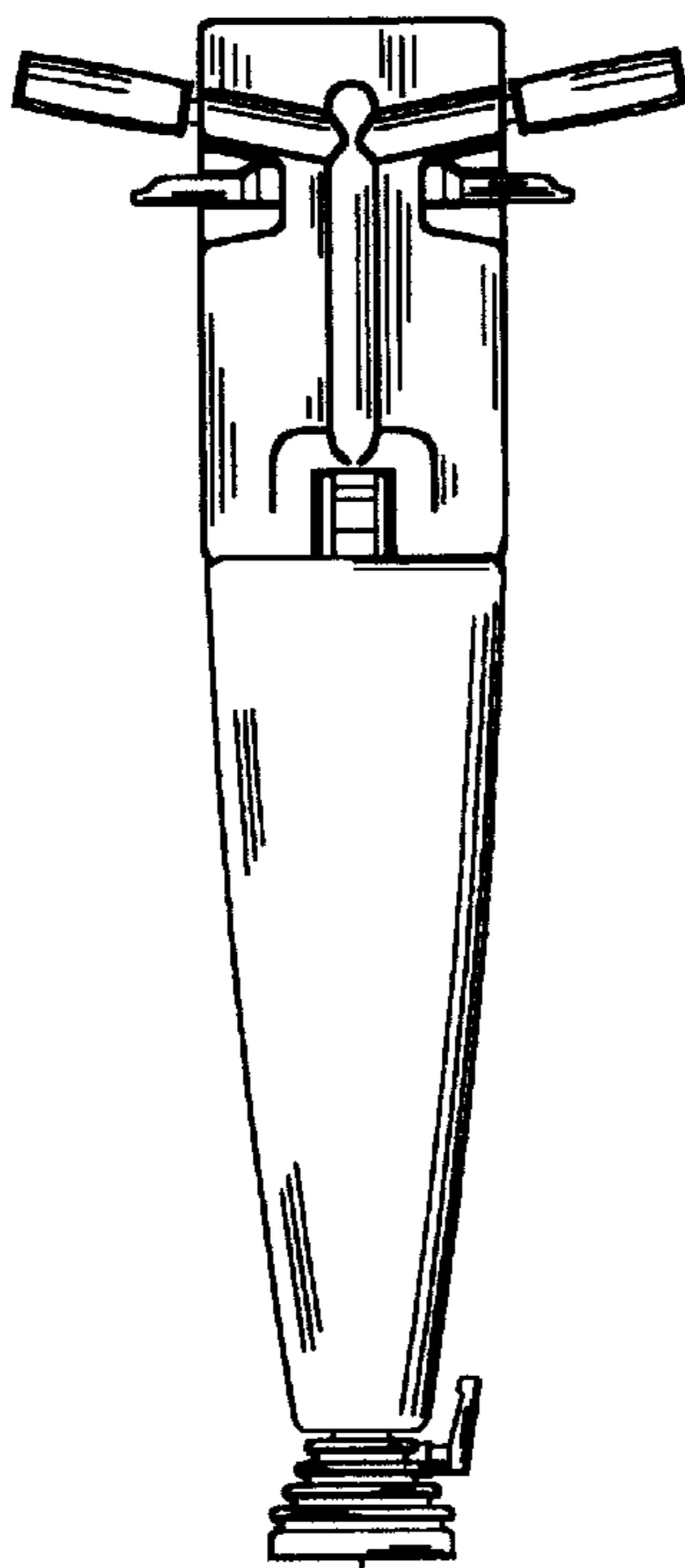

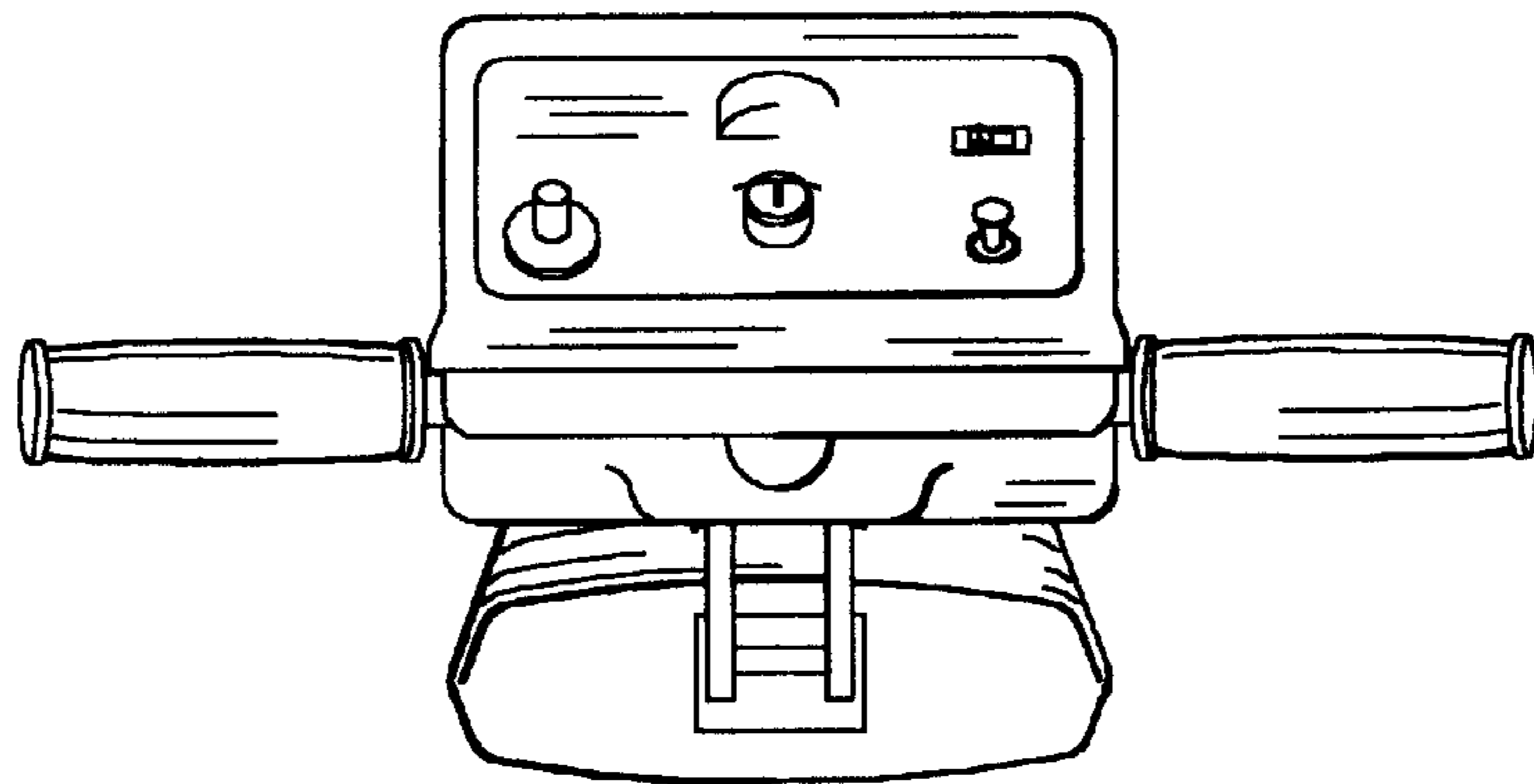

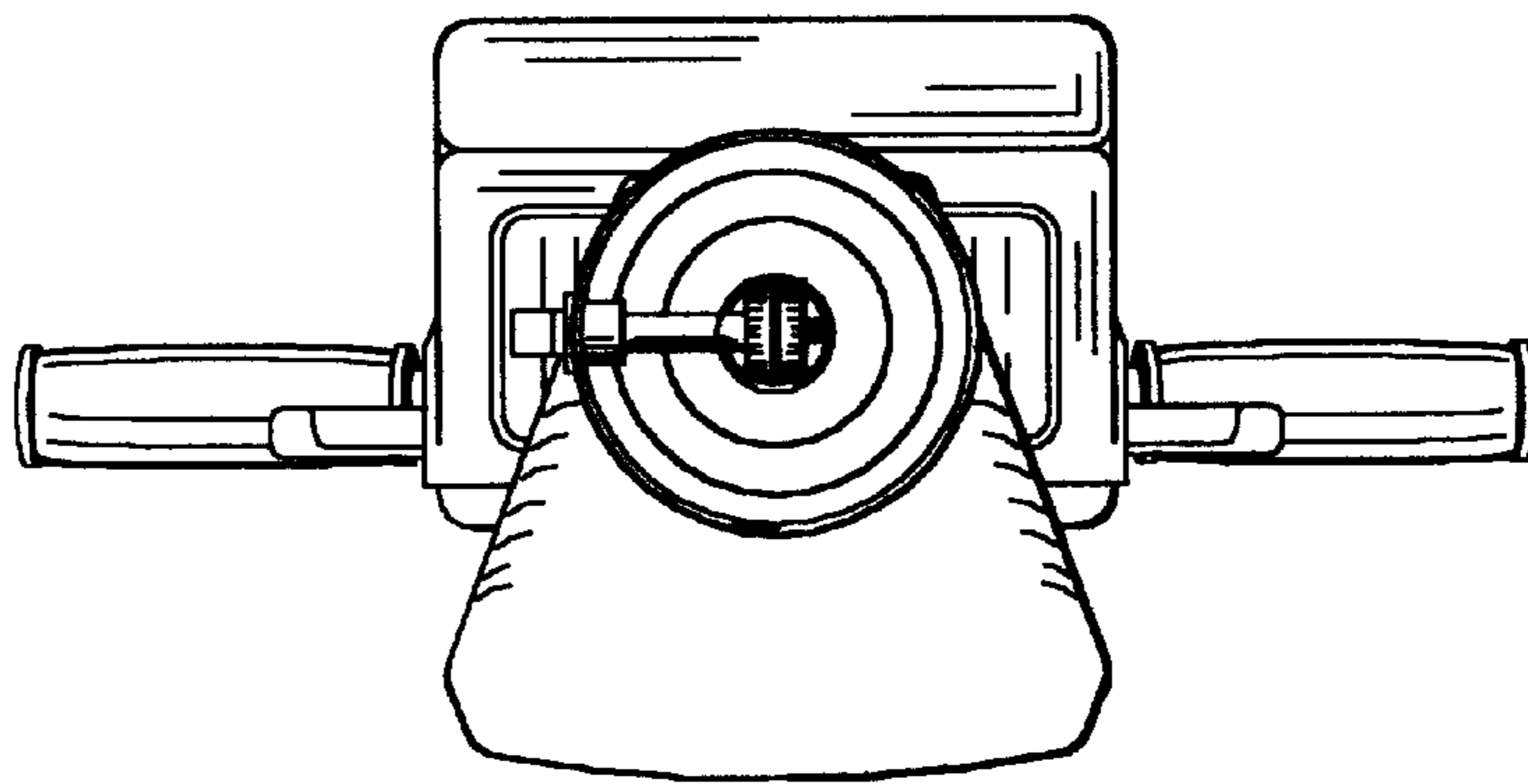
