The ornamental design for a windshield protector, as shown and described.

**DESCRIPTION**

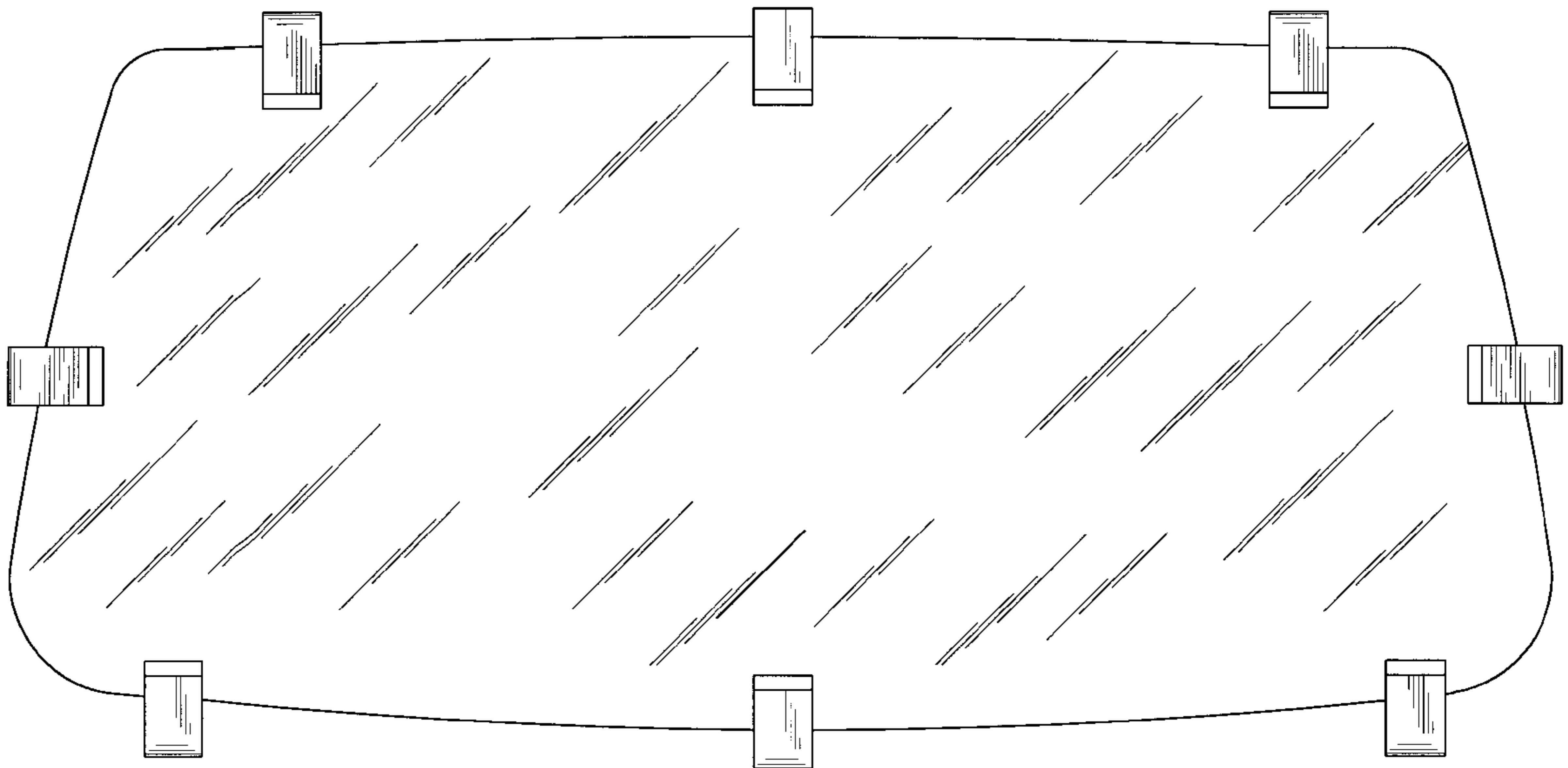

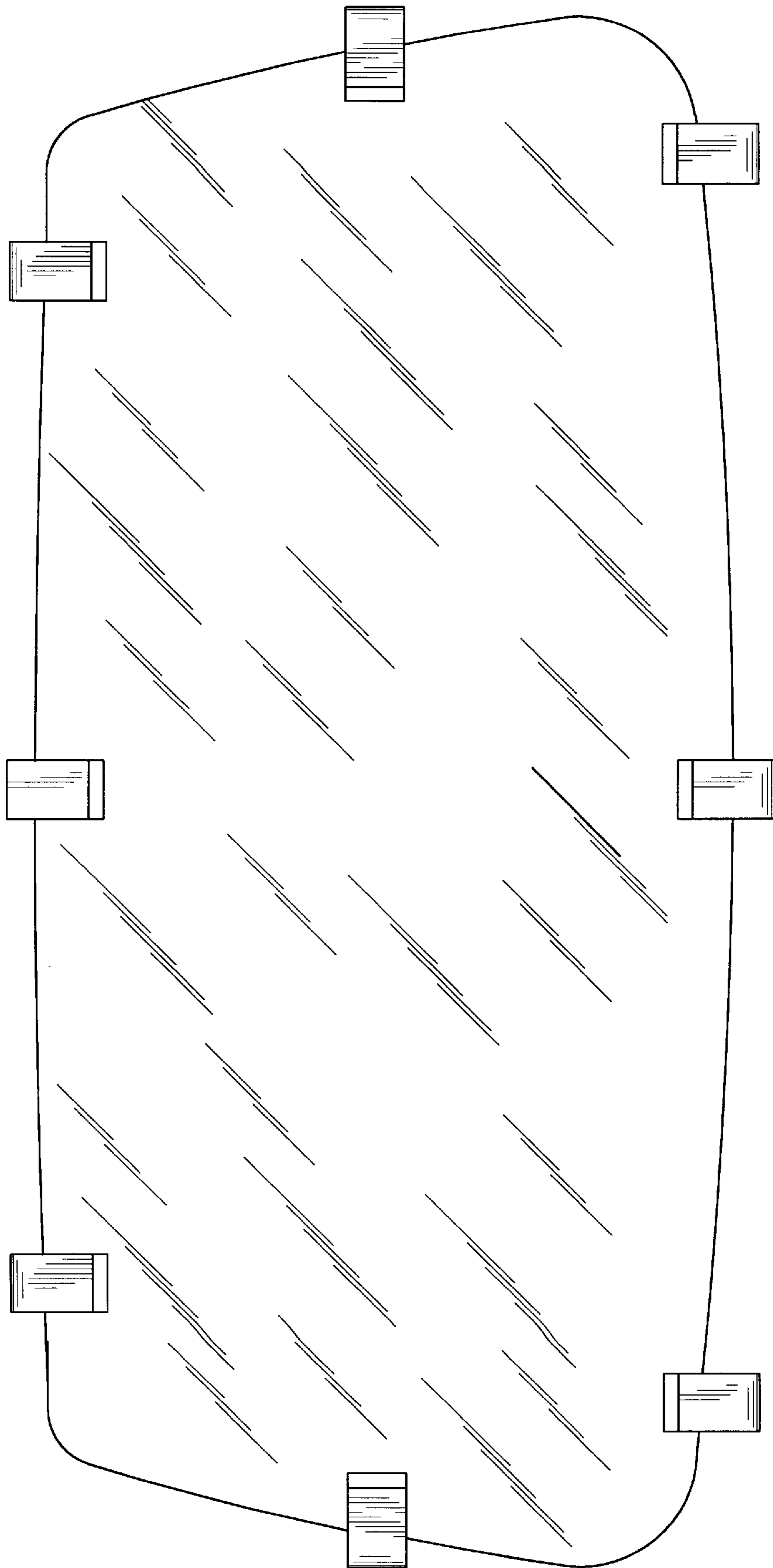
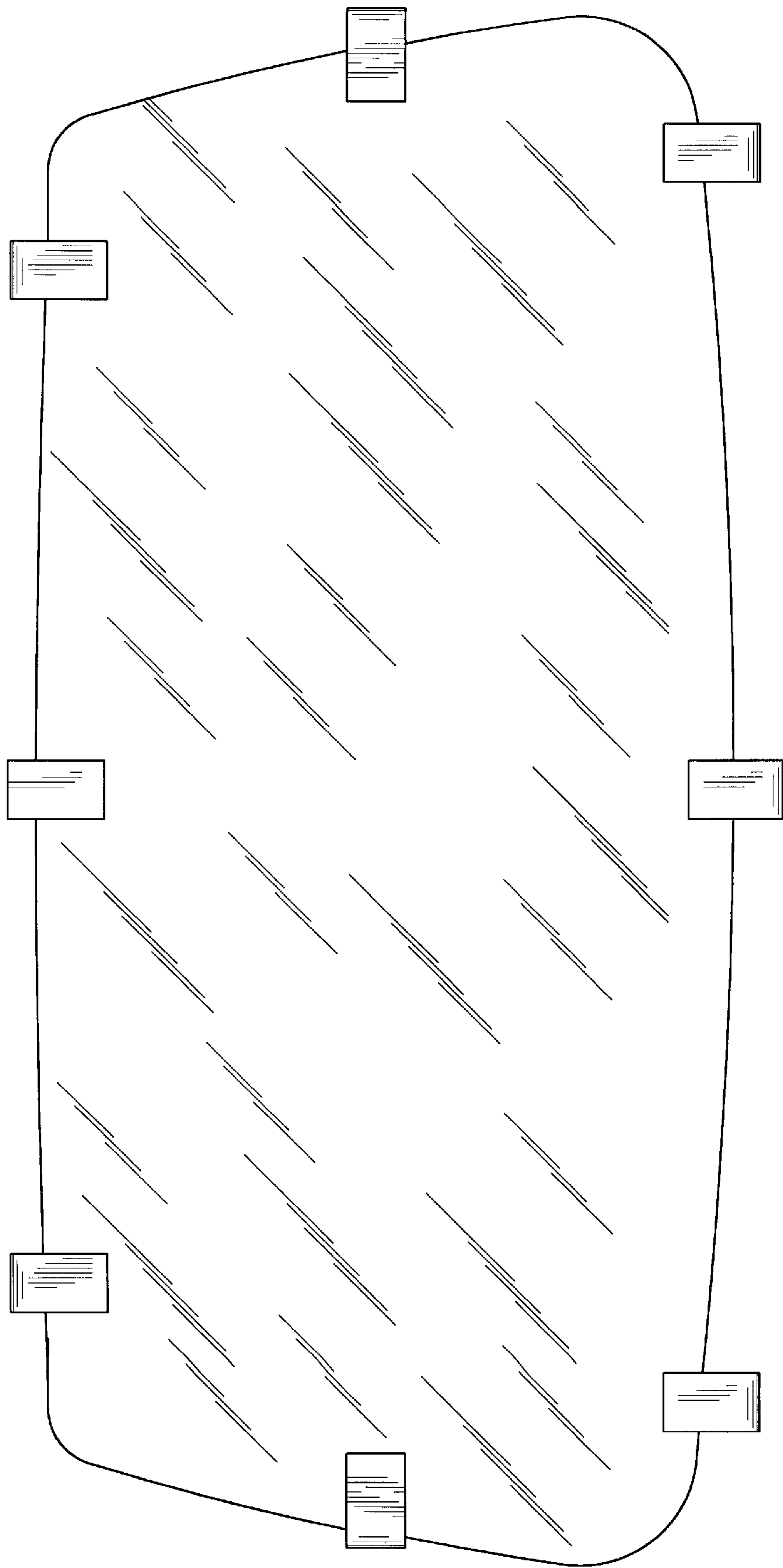
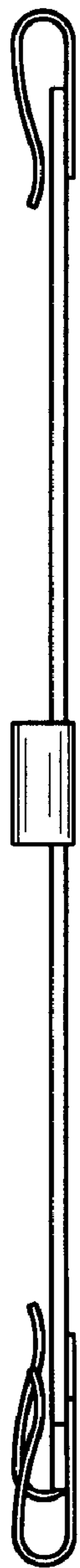

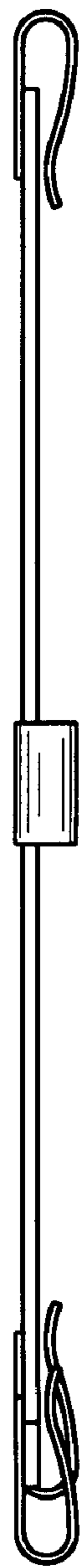
