**DESCRIPTION**

FIG. 1 is a top plan view of the illuminated keyboard of the present invention;

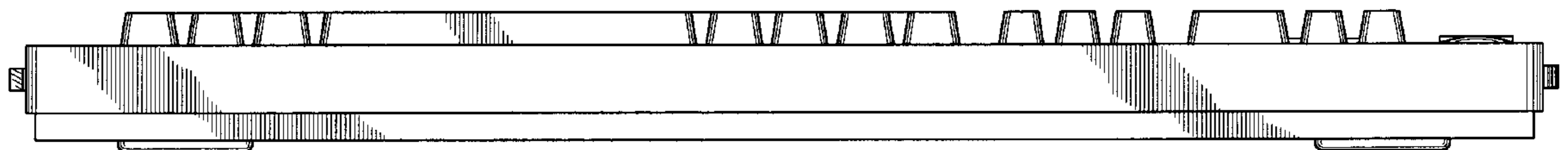
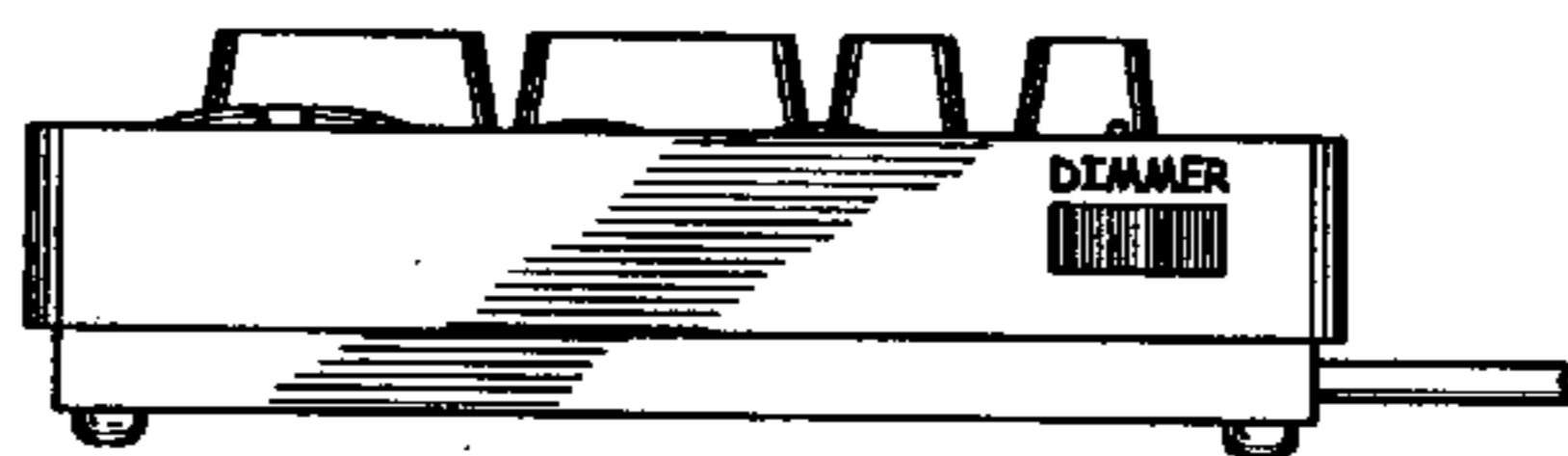
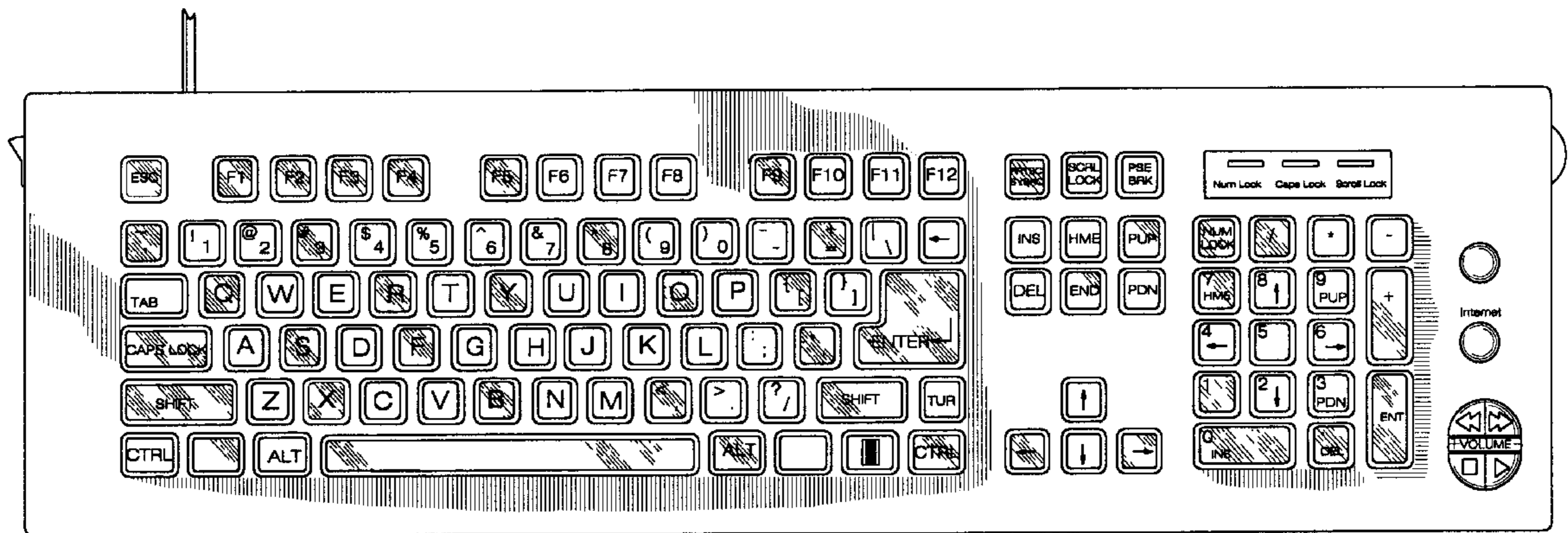

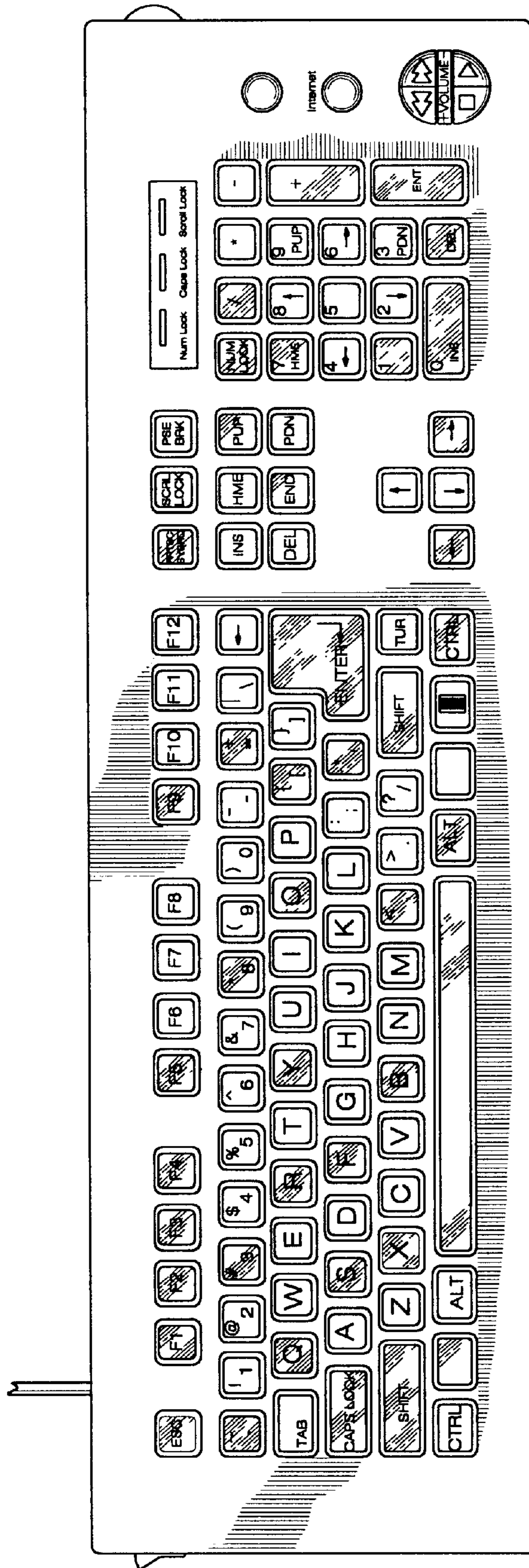

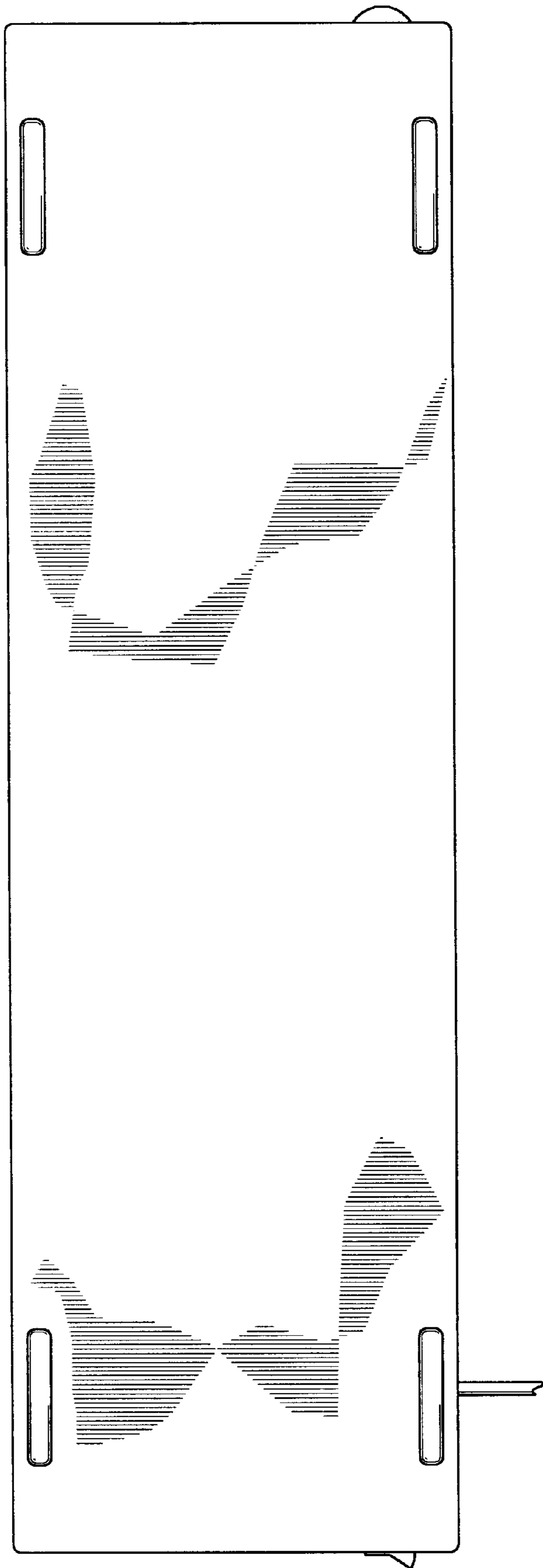

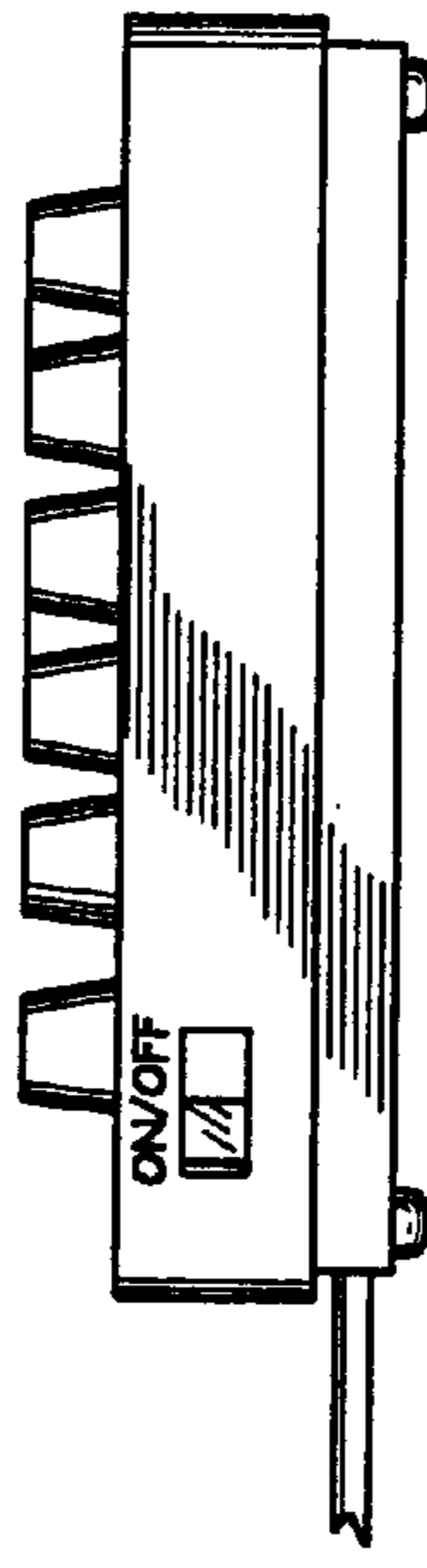

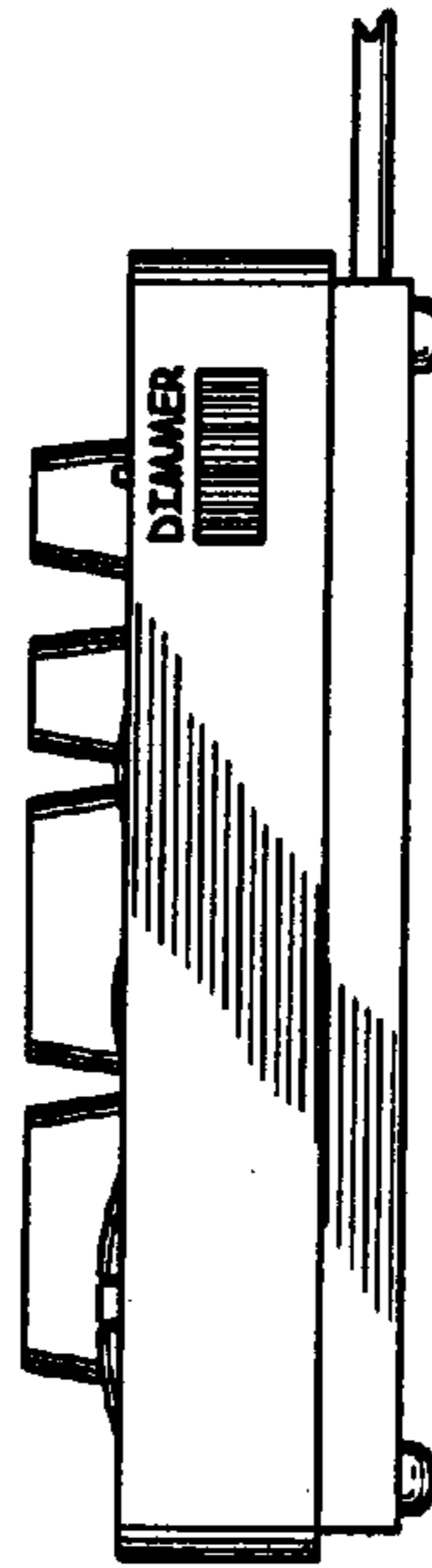

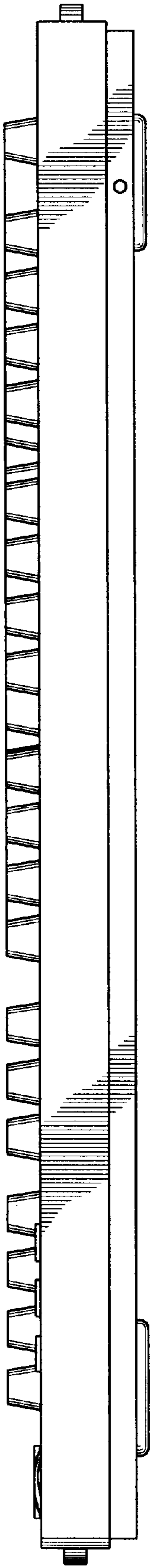
