(57) **CLAIM**

The ornamental design for a car tape dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of the car tape dispenser with the opposite side being a mirror image of the same.

FIG. 2 is a top plan view of the car tape dispenser.

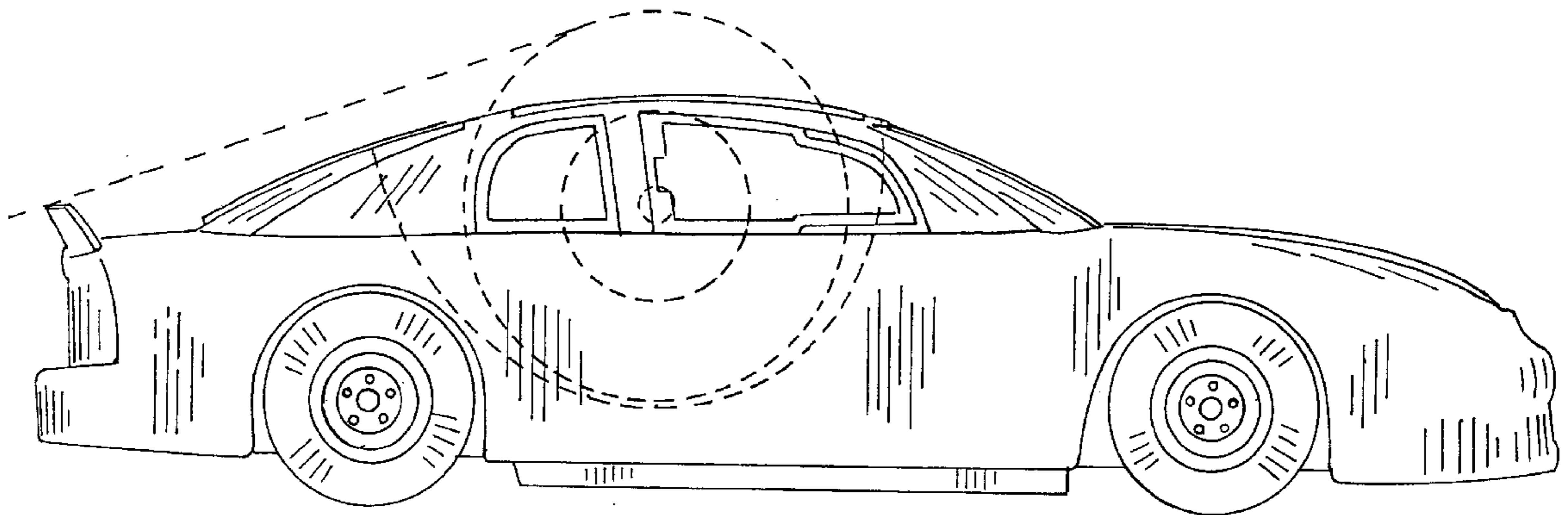
FIG. 3 is a bottom plan view of the car tape dispenser.

FIG. 4 is a front elevational view of a car tape dispenser; and,

FIG. 5 is a rear elevational view of the car tape dispenser.

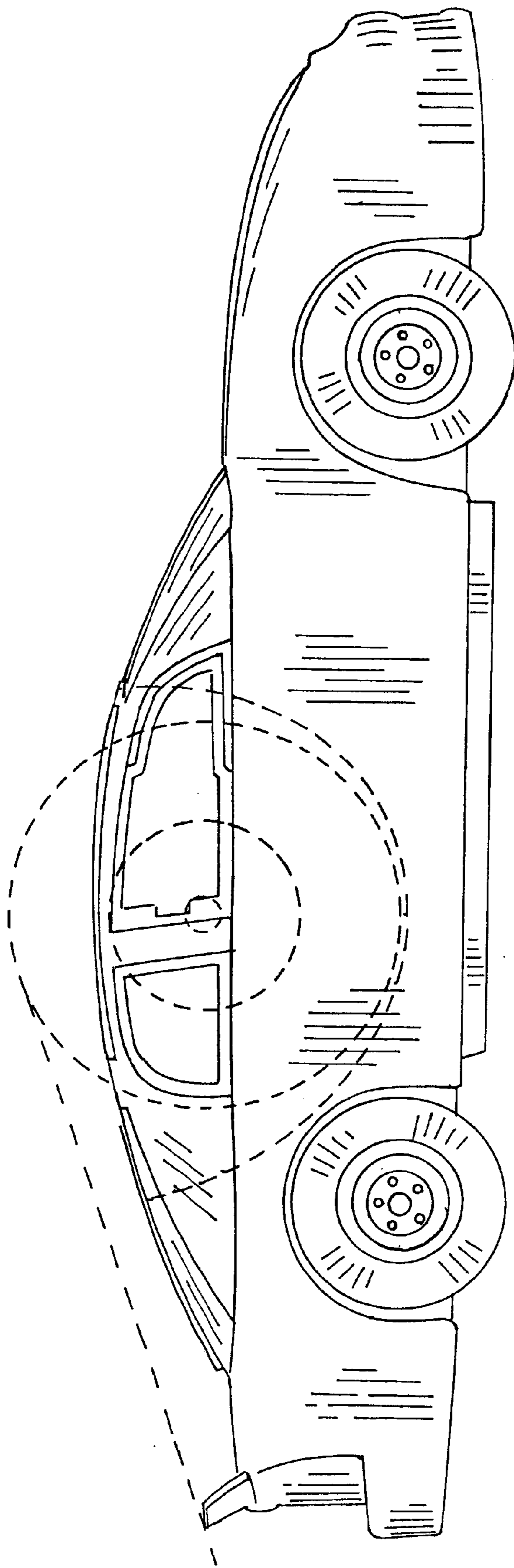

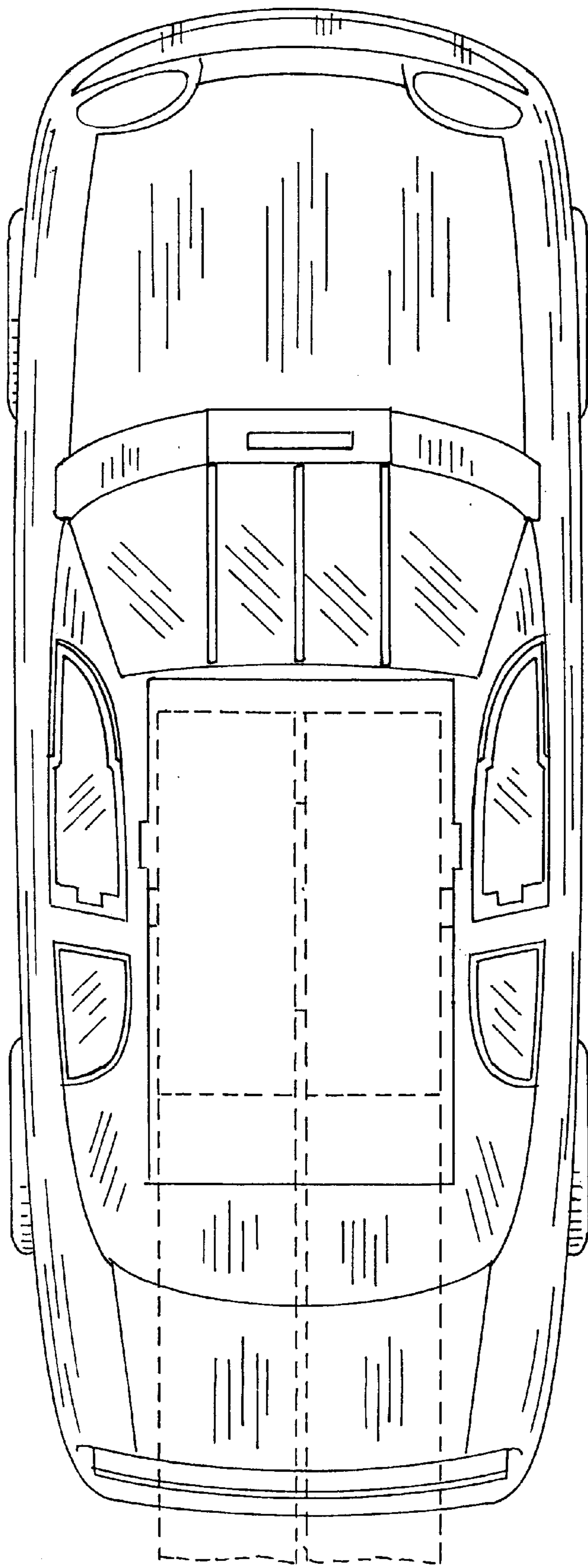

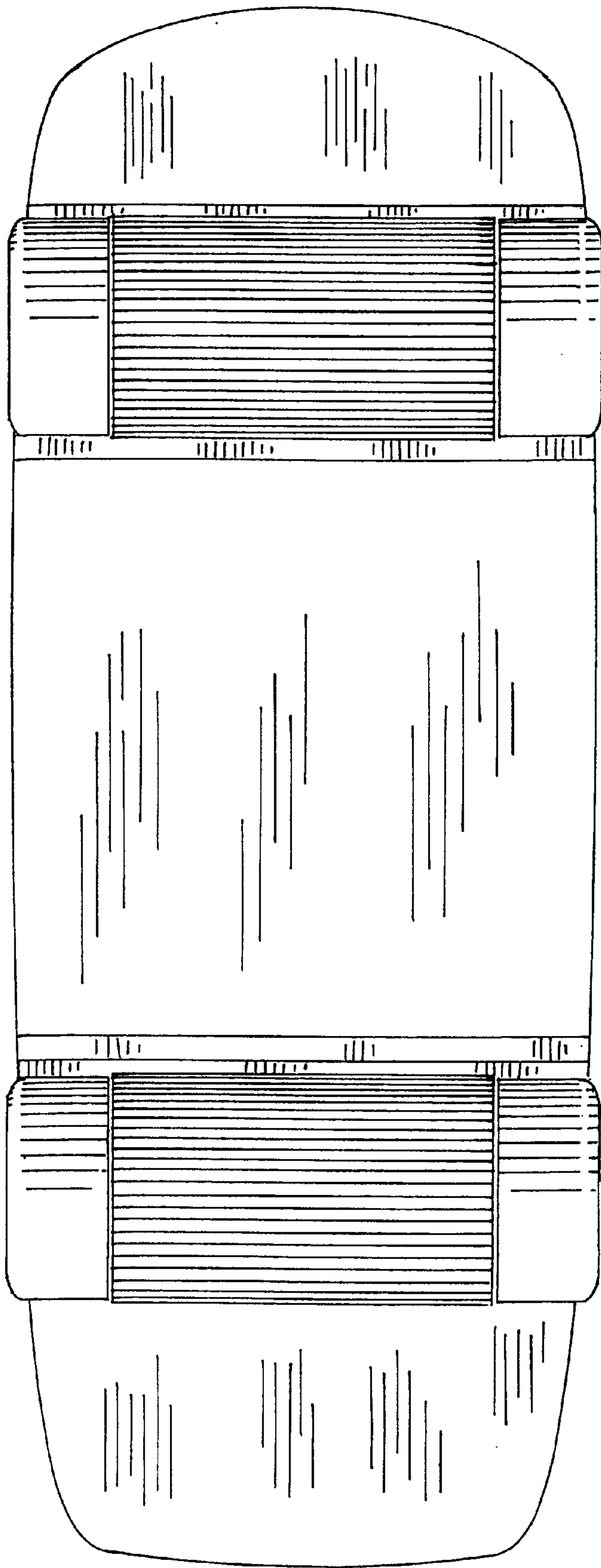

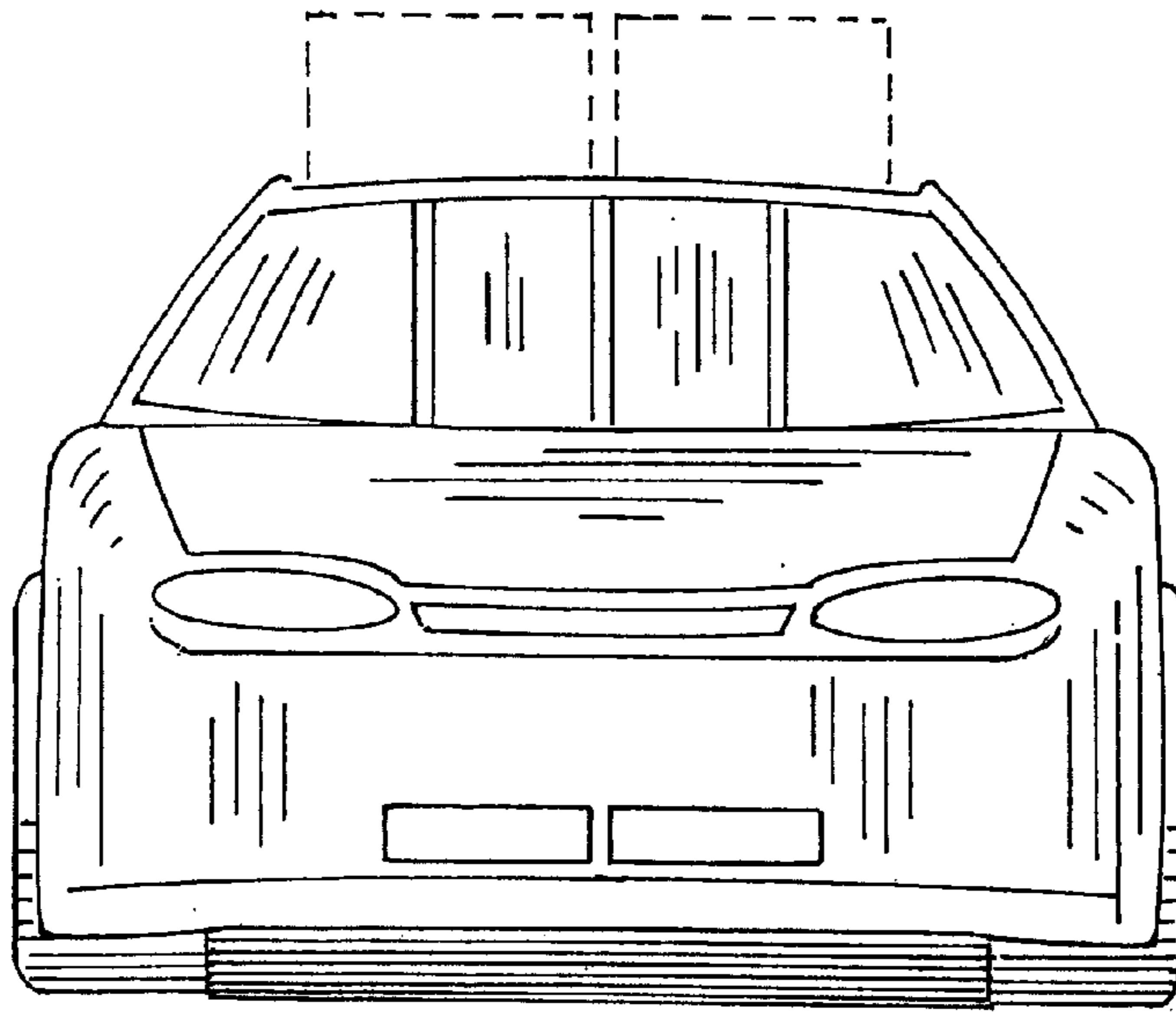

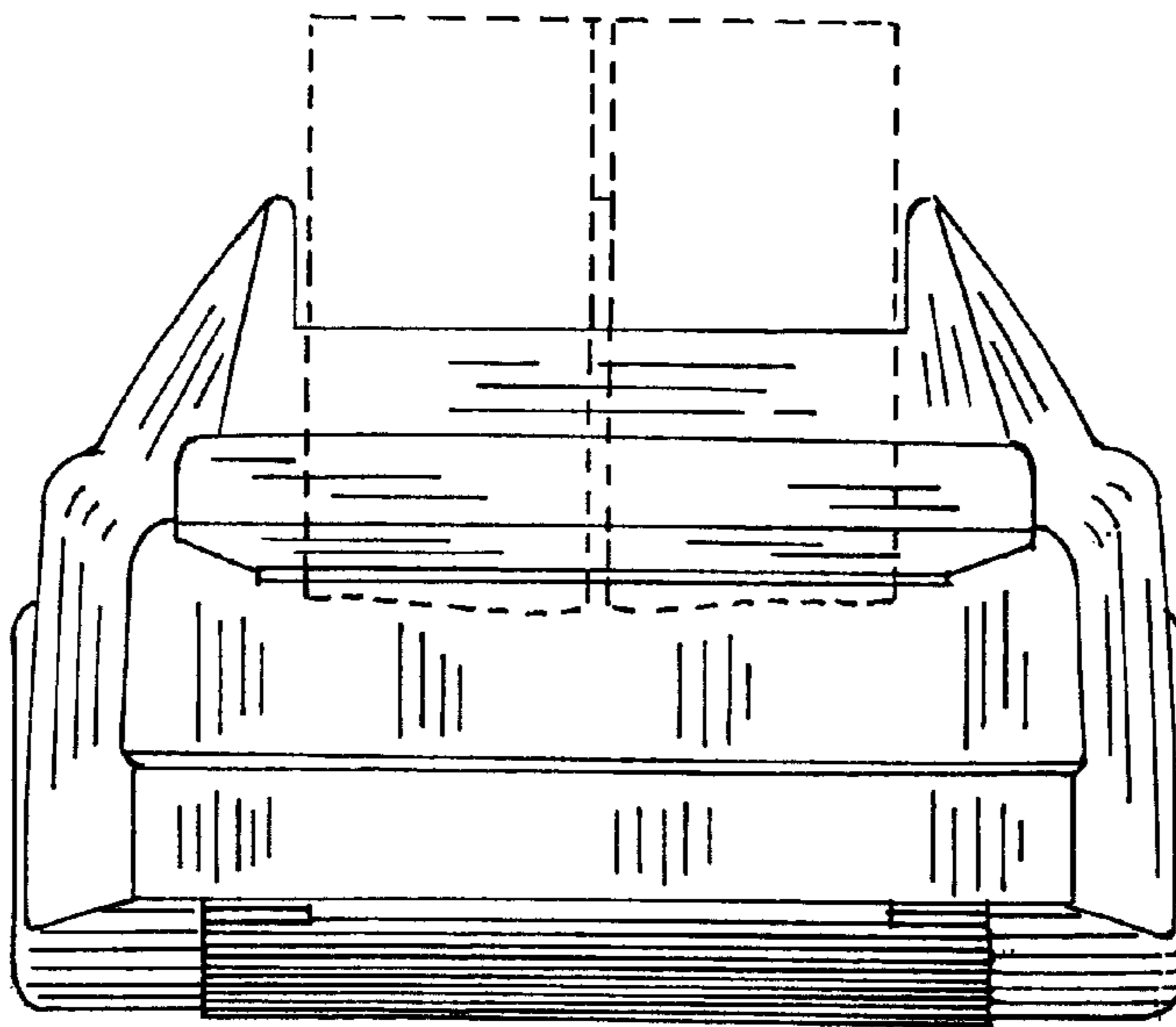
