(57) **CLAIM**

The ornamental design for a hosel for a golf putter head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hosel for a golf putter head showing a first embodiment of our new design;

FIG. 2 is a rear elevational view of the hosel shown in FIG. 1;

FIG. 3 is an end view of the hosel shown in FIG. 1;

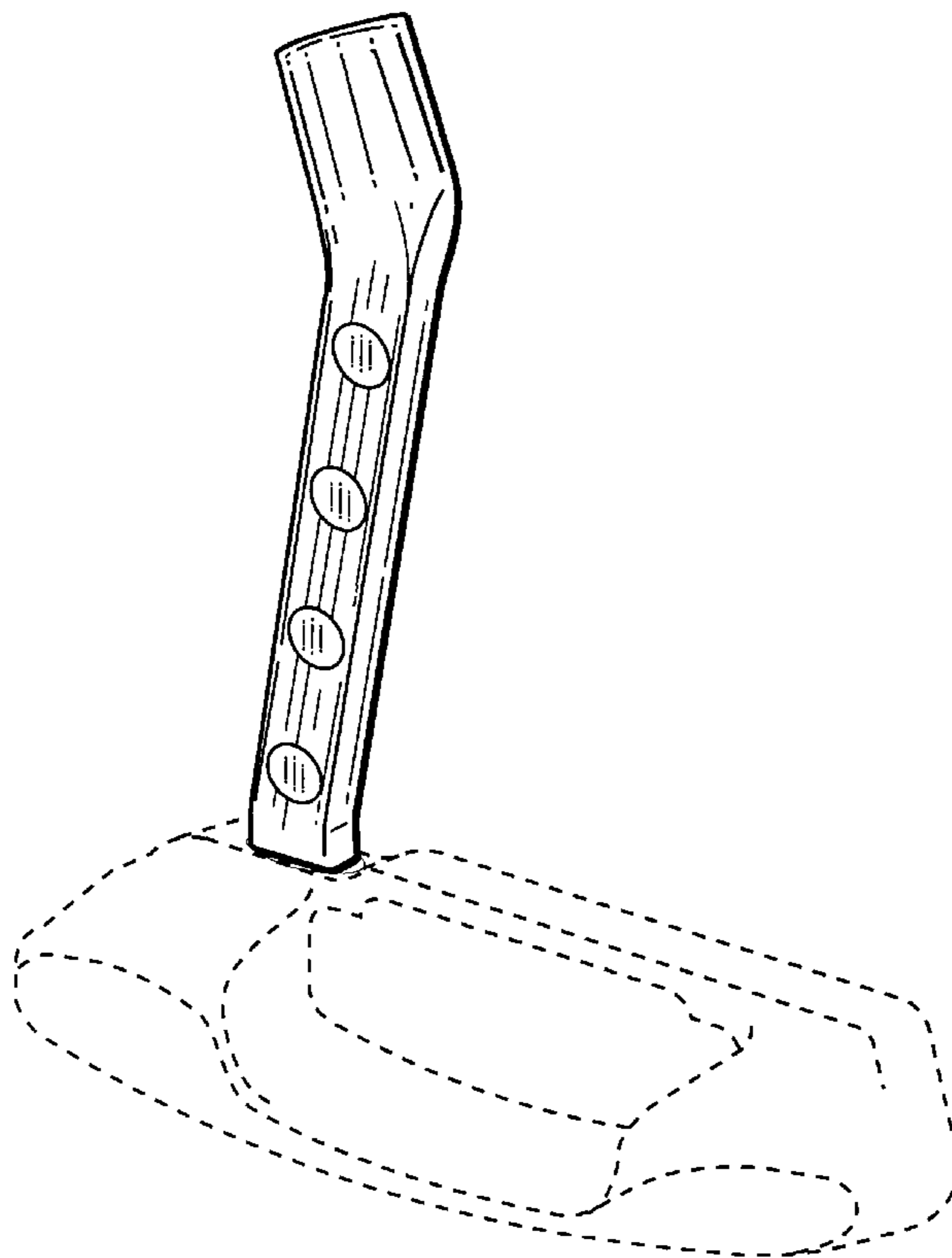
FIG. 4 is a top plan view of the hosel shown in FIG. 1;

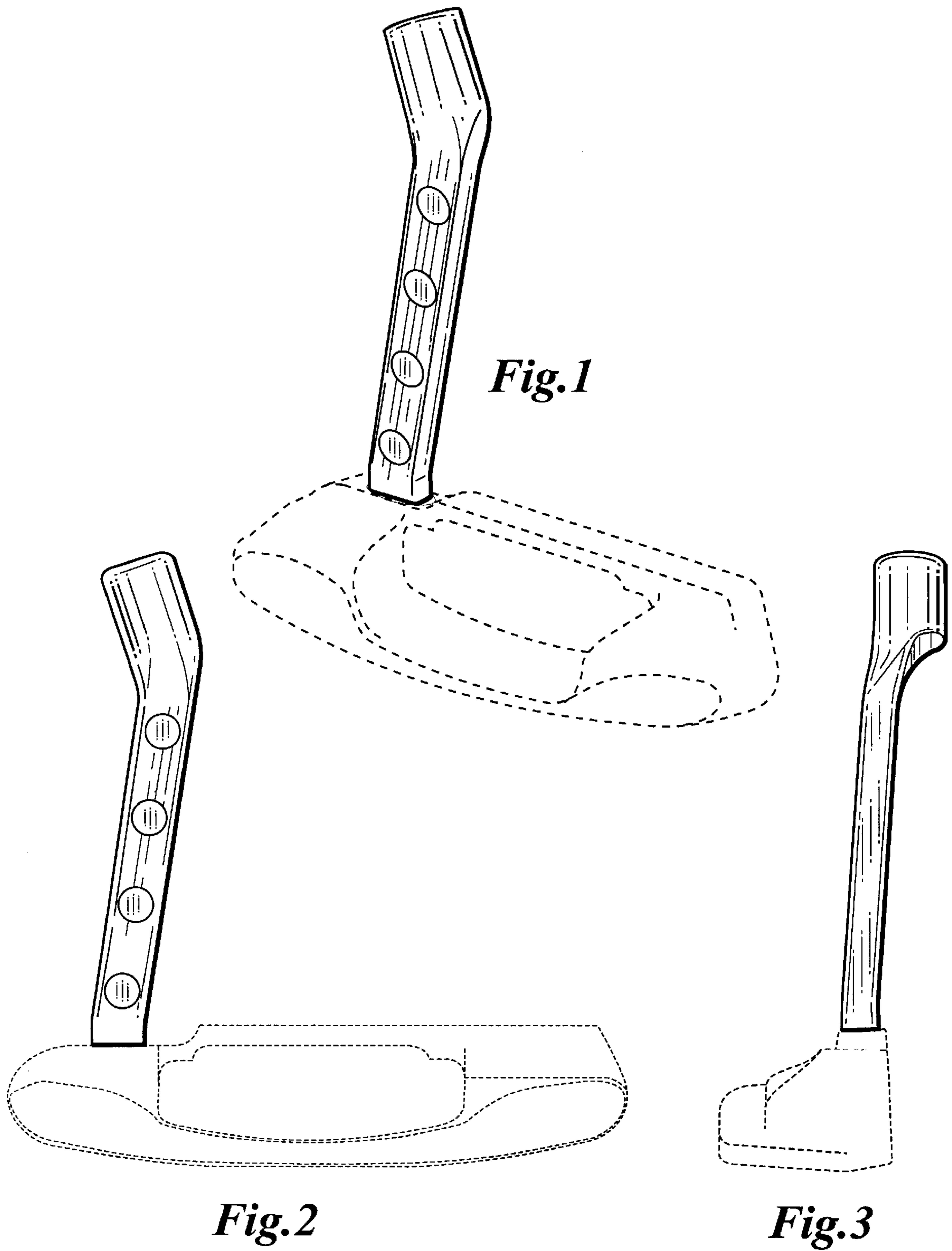
FIG. 5 is a front elevational view of the hosel shown in FIG. 1;

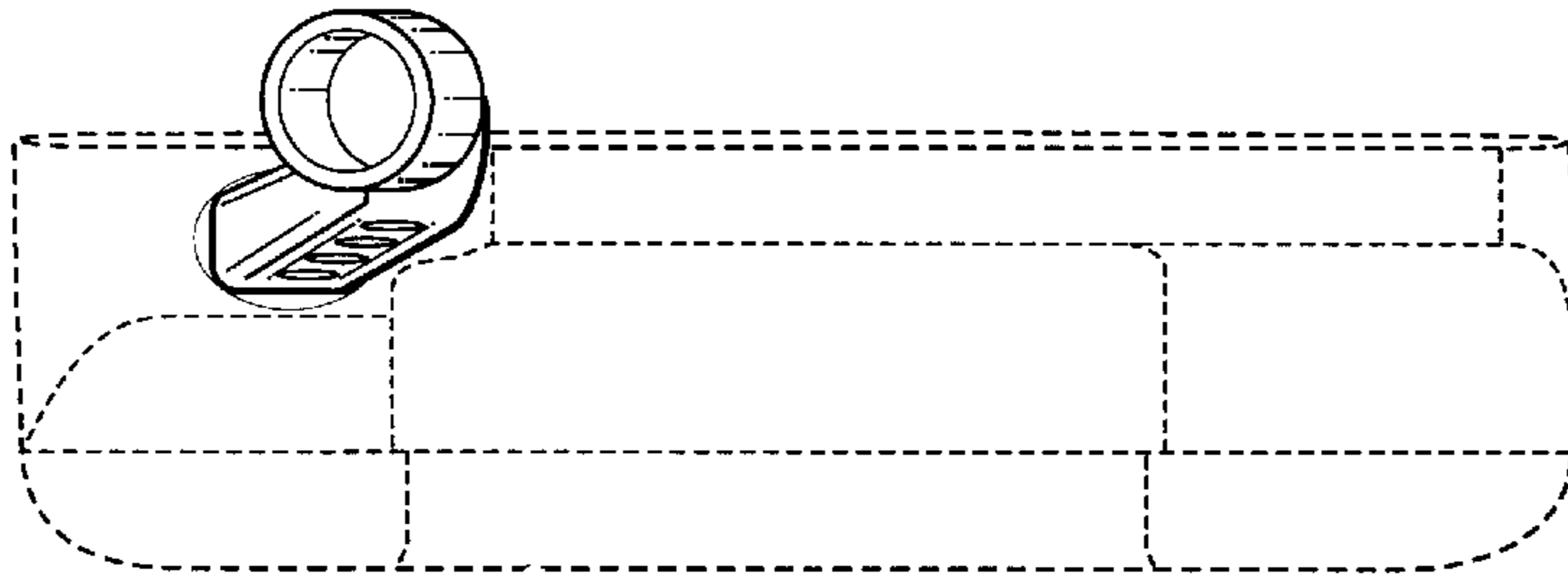
FIG. 6 is another end view of the hosel shown in FIG. 1; and, FIG. 7 is a bottom view of the hosel shown in FIG. 1.

The broken line showing of a golf putter head in FIGS. 1-7 is for illustrative purposes only and forms no part of the claimed design.

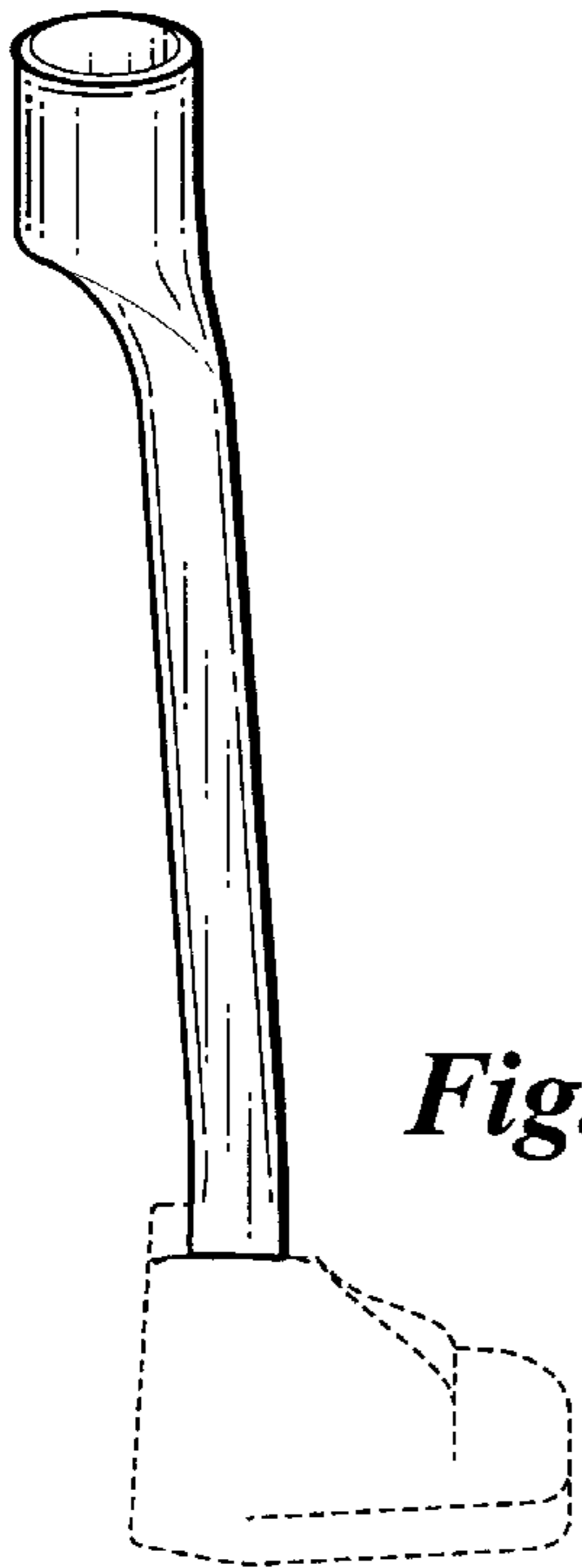

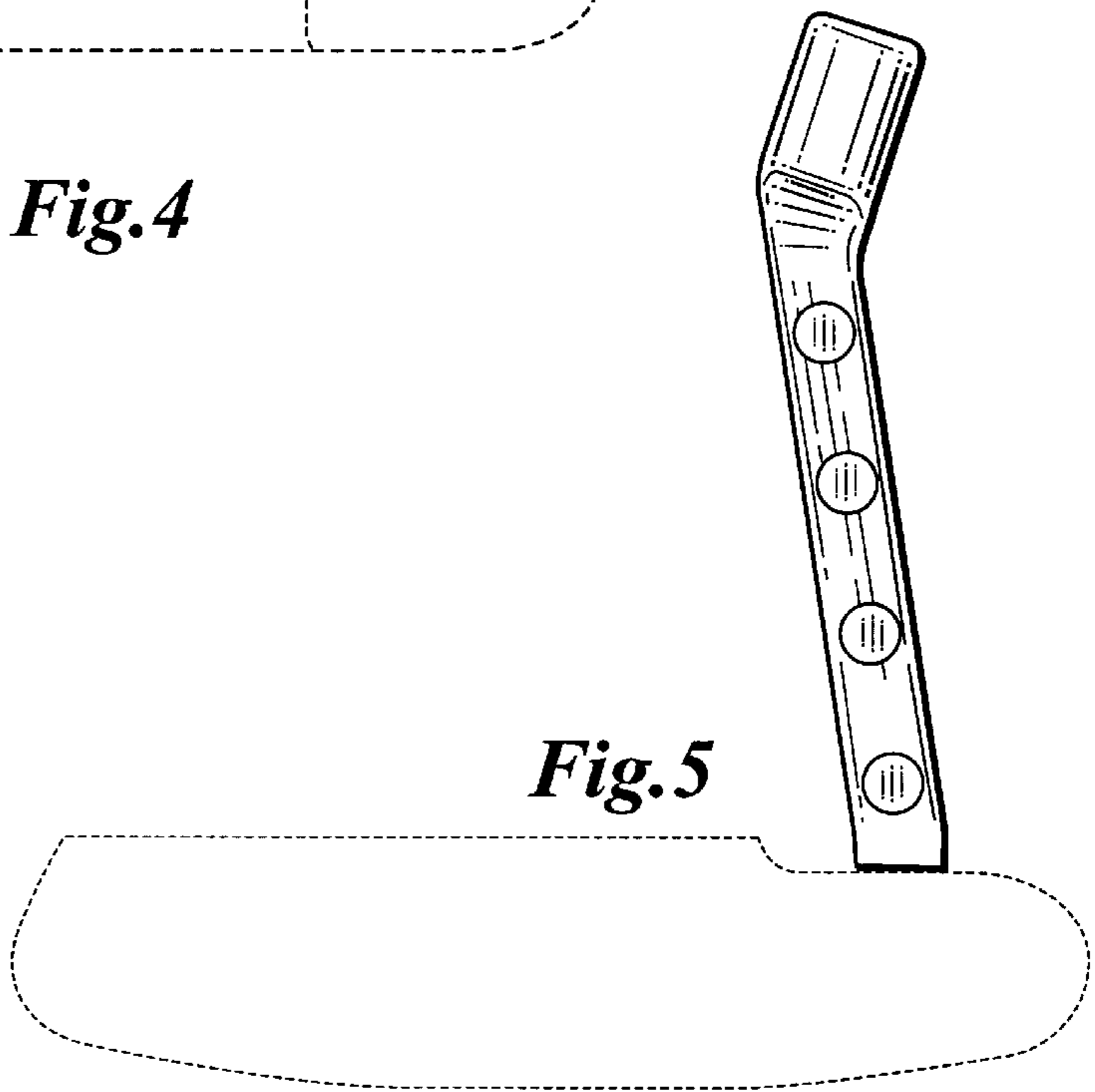




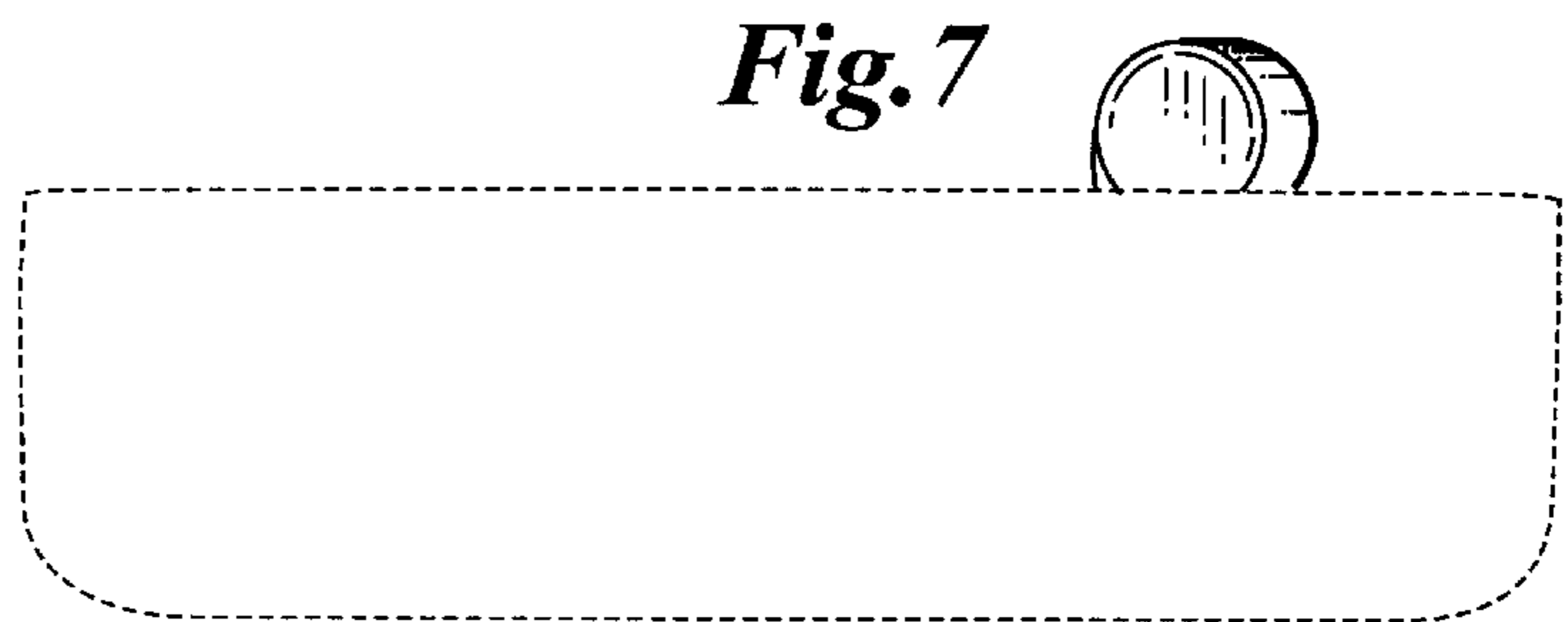
