(57) **CLAIM**

I claim the ornamental design for a wrestling ear guard, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a wrestling ear guard showing my new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a right side view thereof; and,  
FIG. 6 is a left side view thereof.  
The crosshatch shading shown in FIGS. 1-6 is understood to repeat throughout the indicated area.

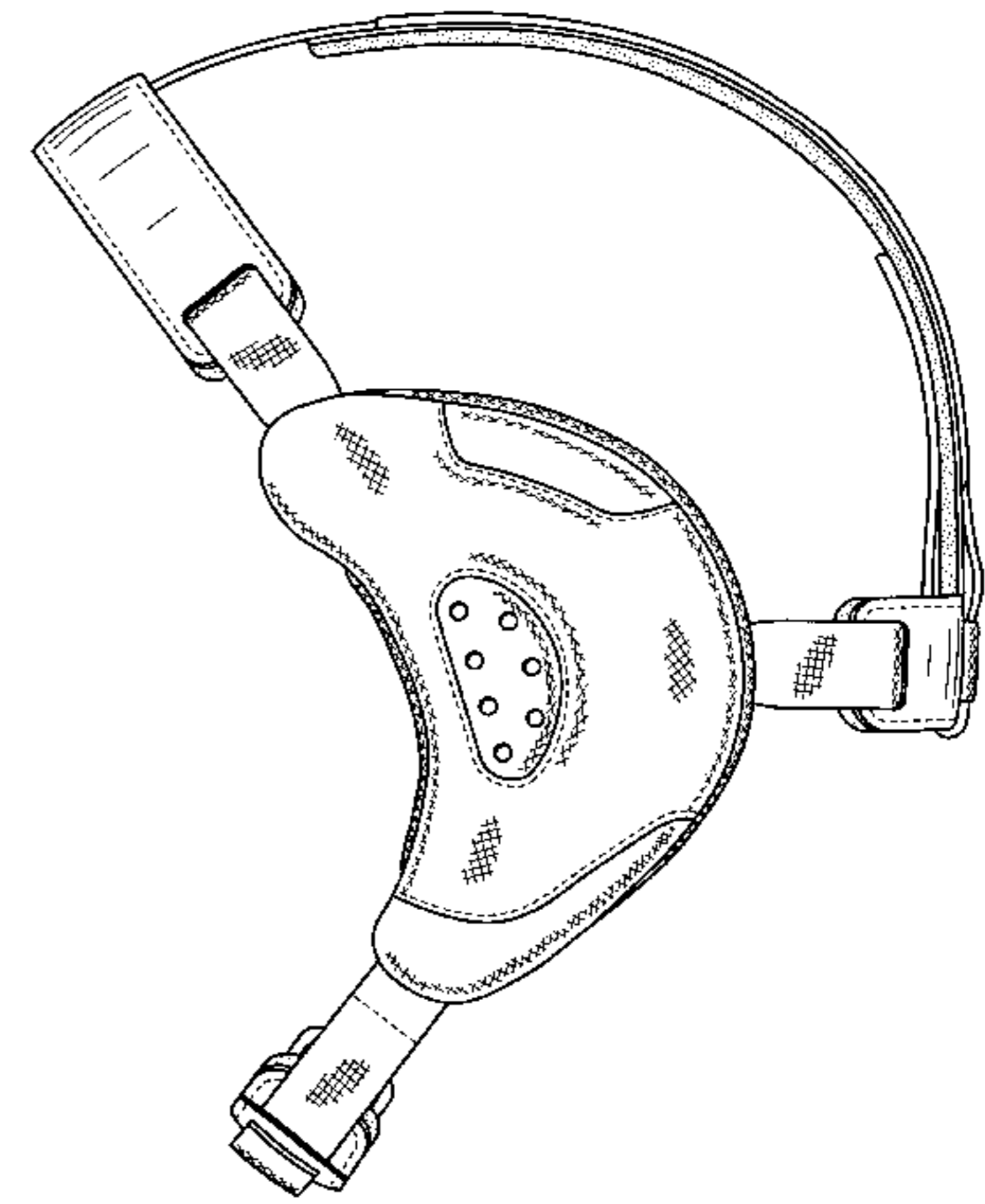
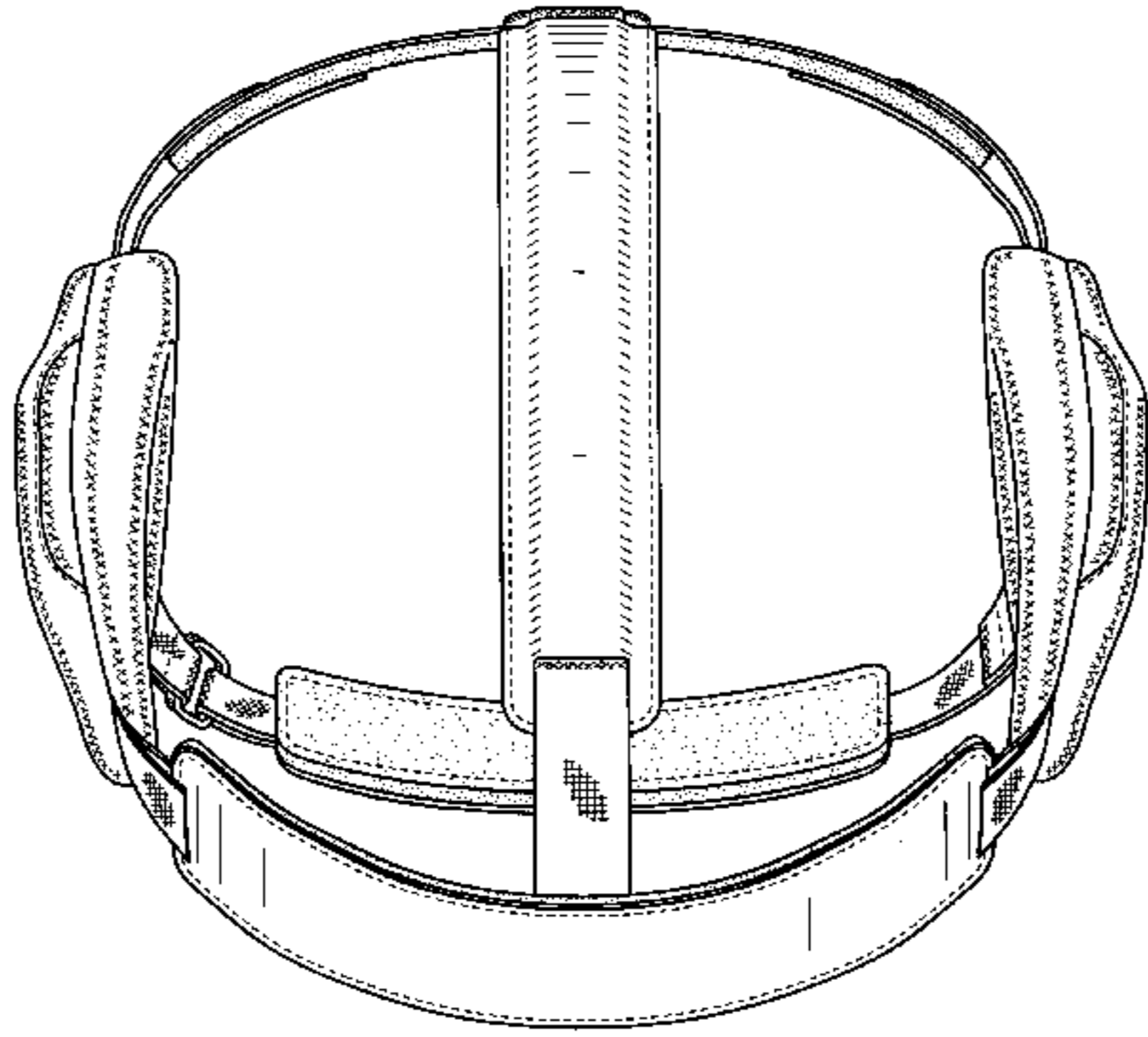
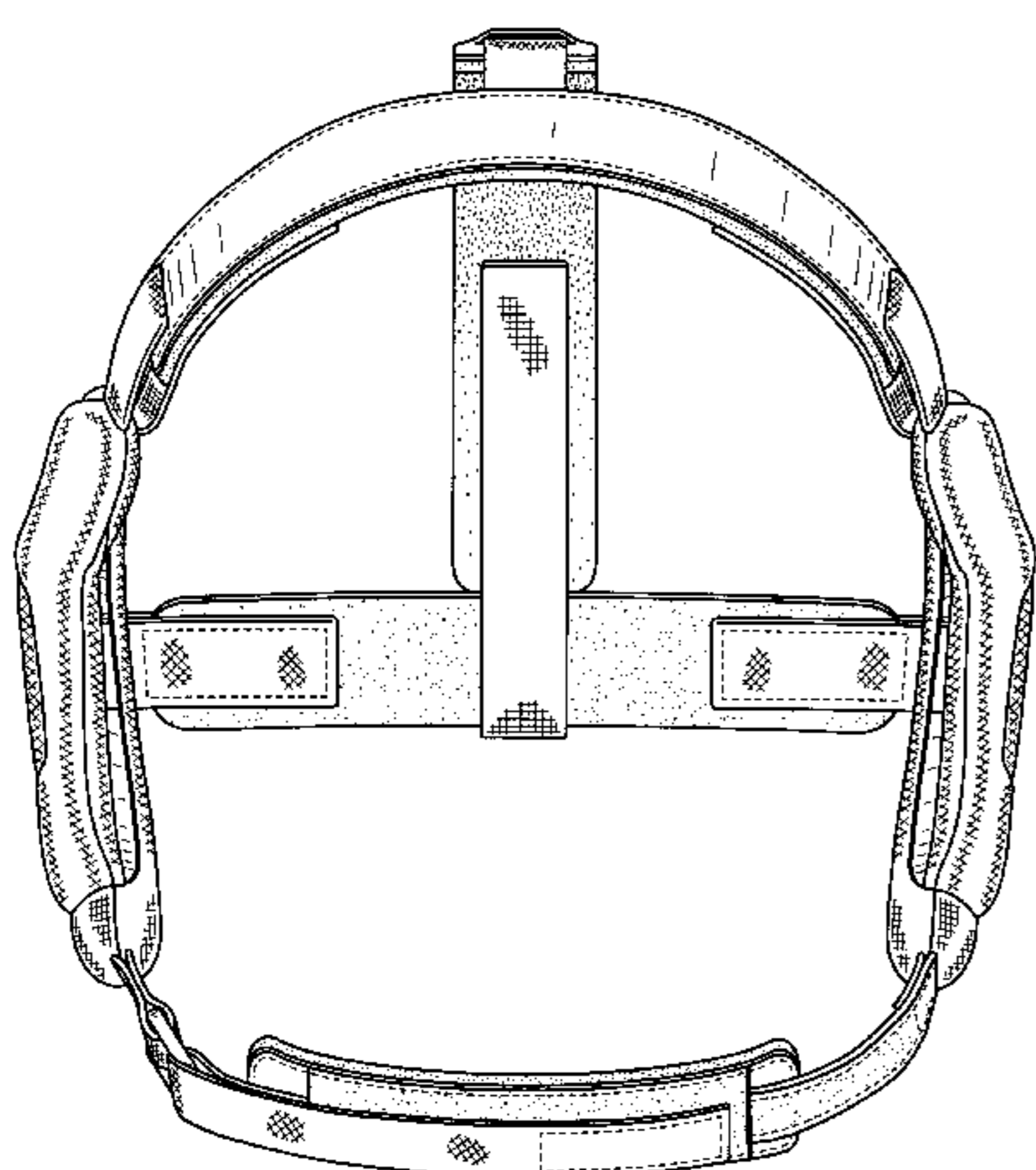

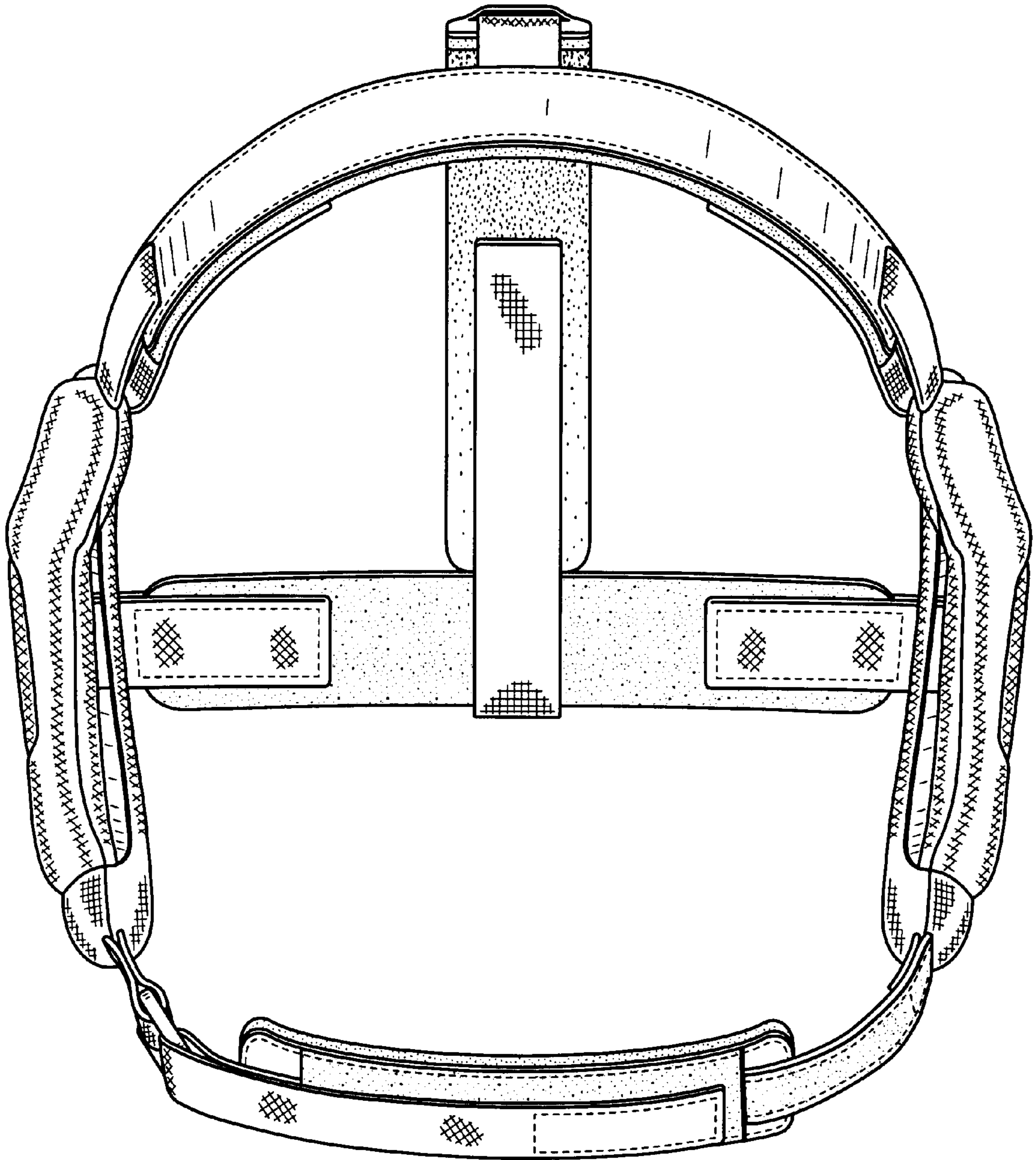

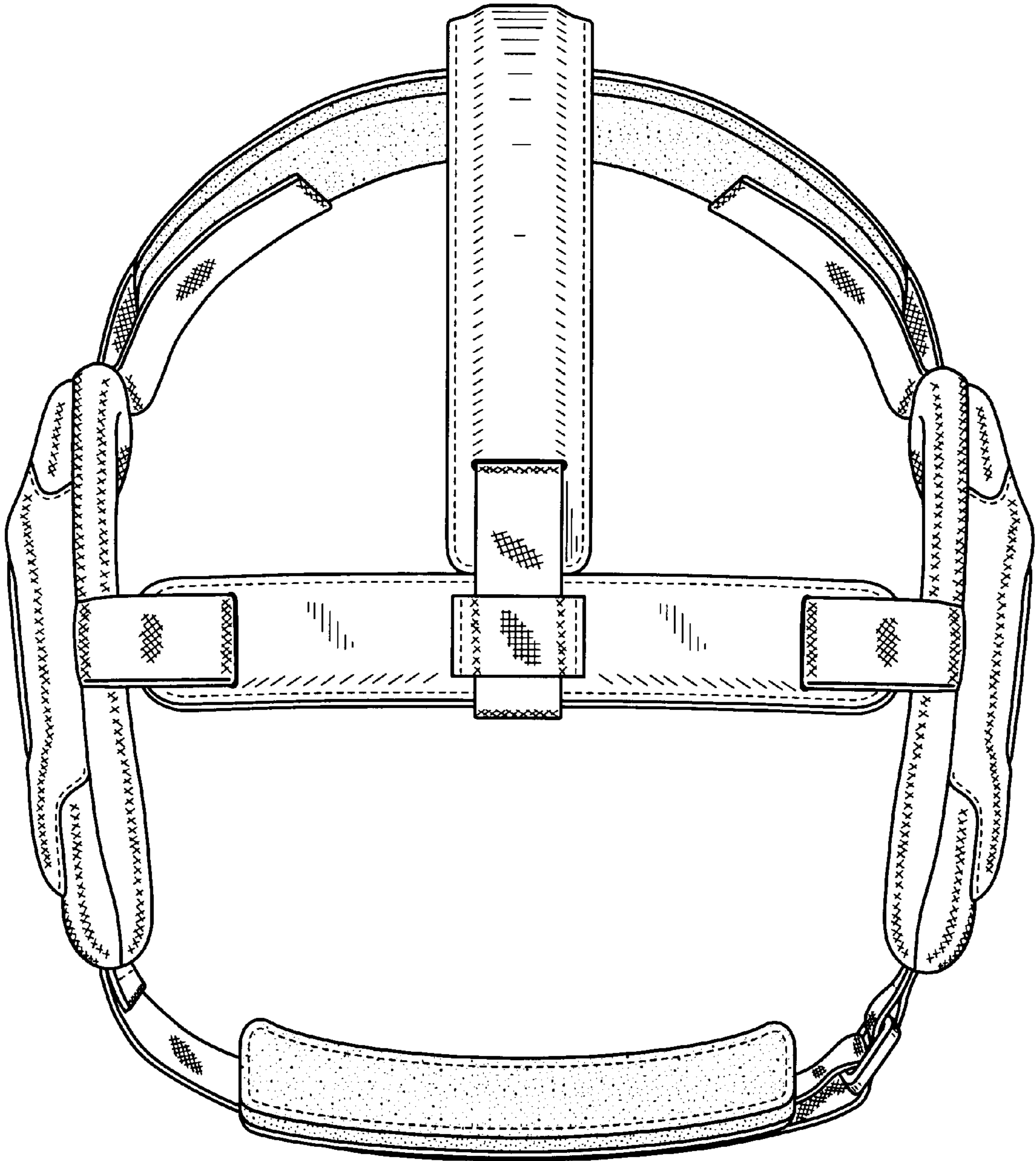

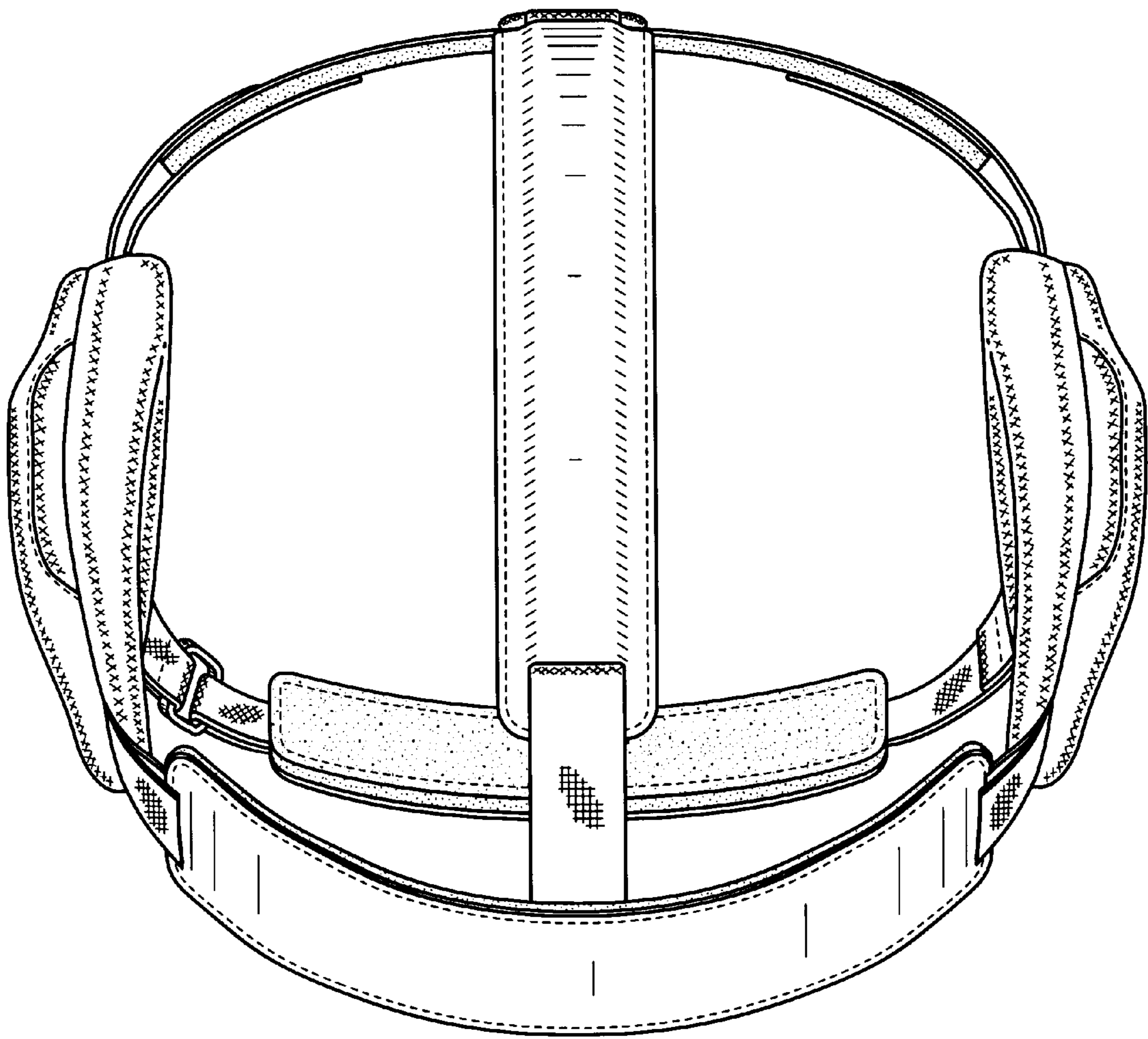

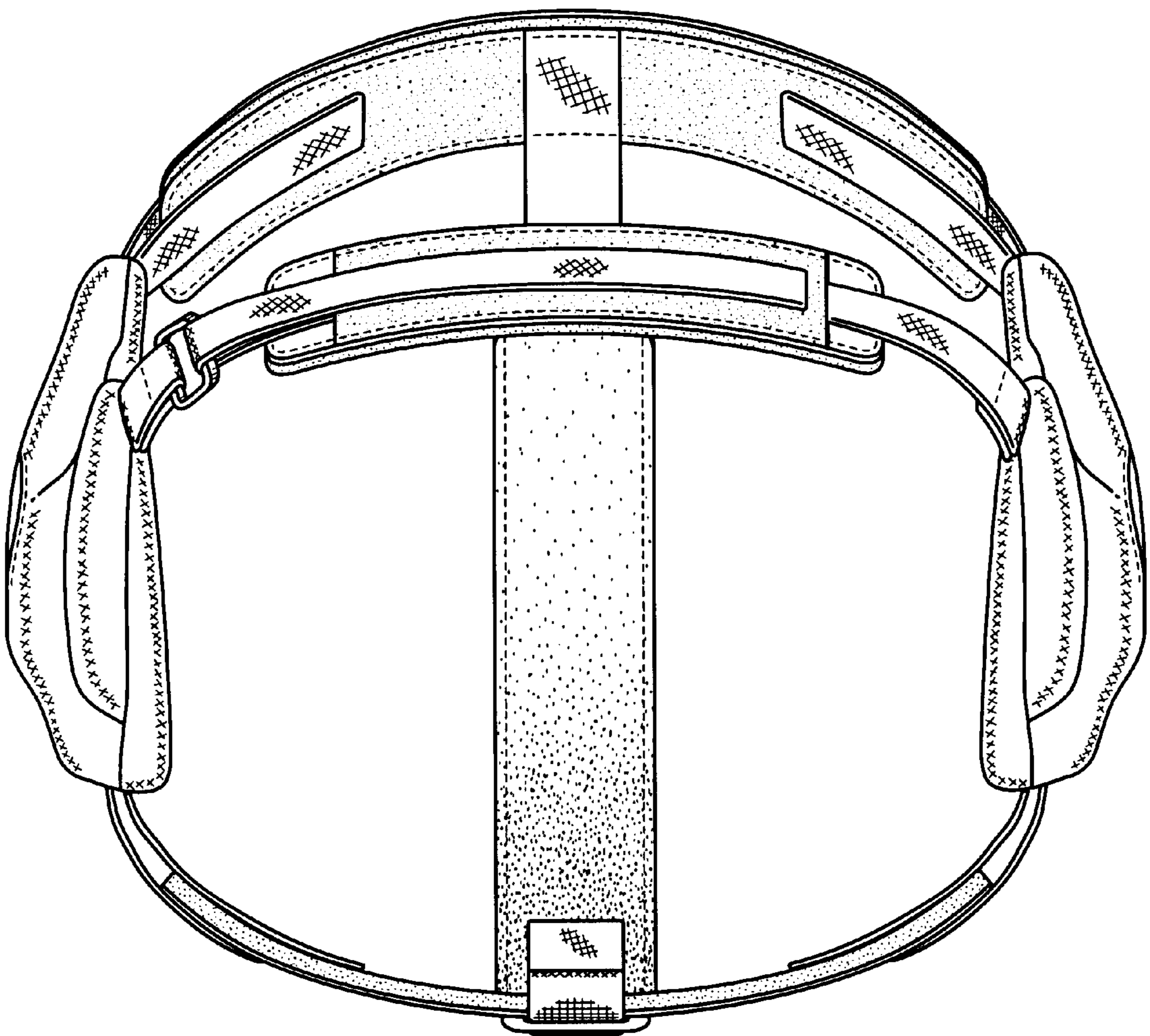

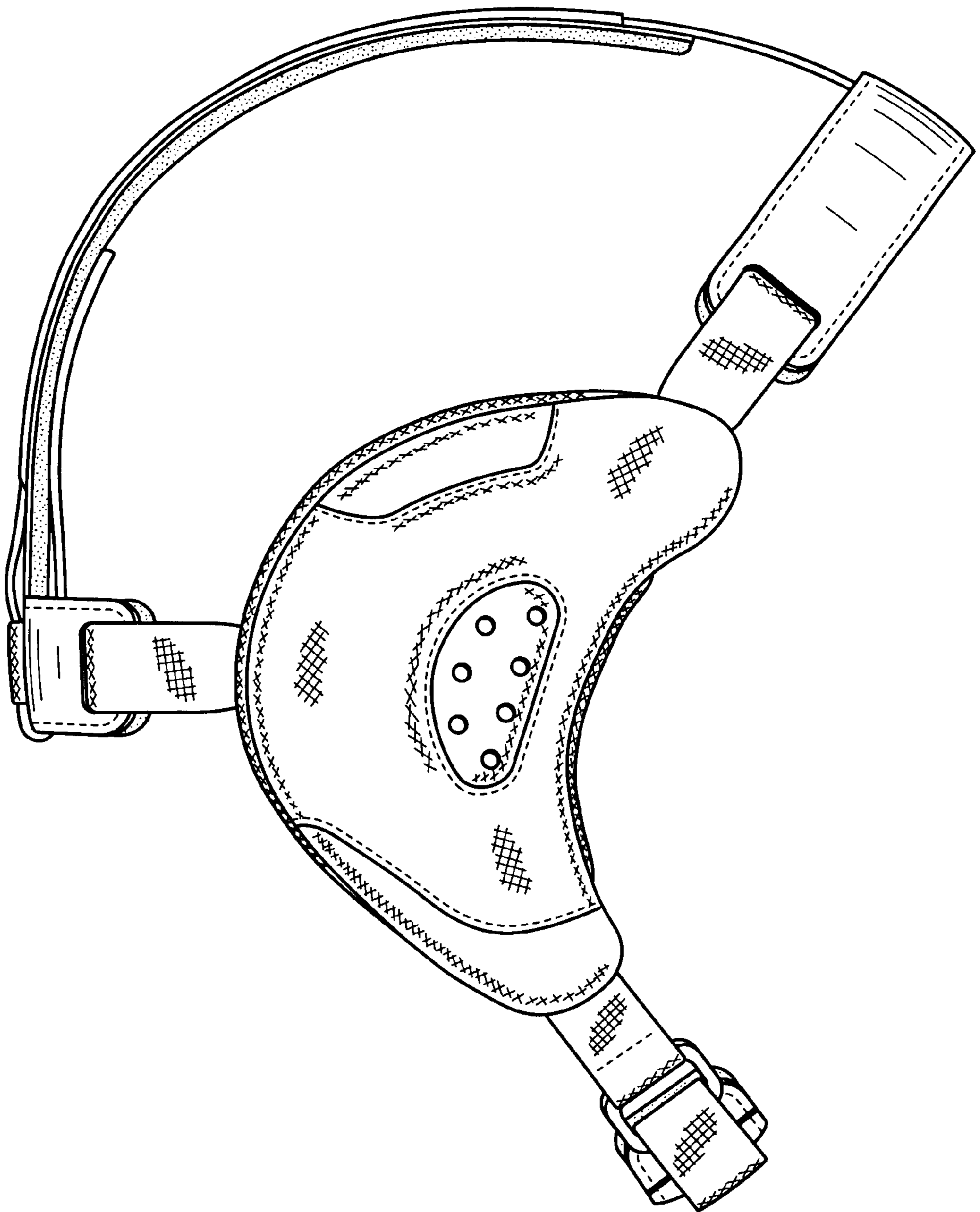
