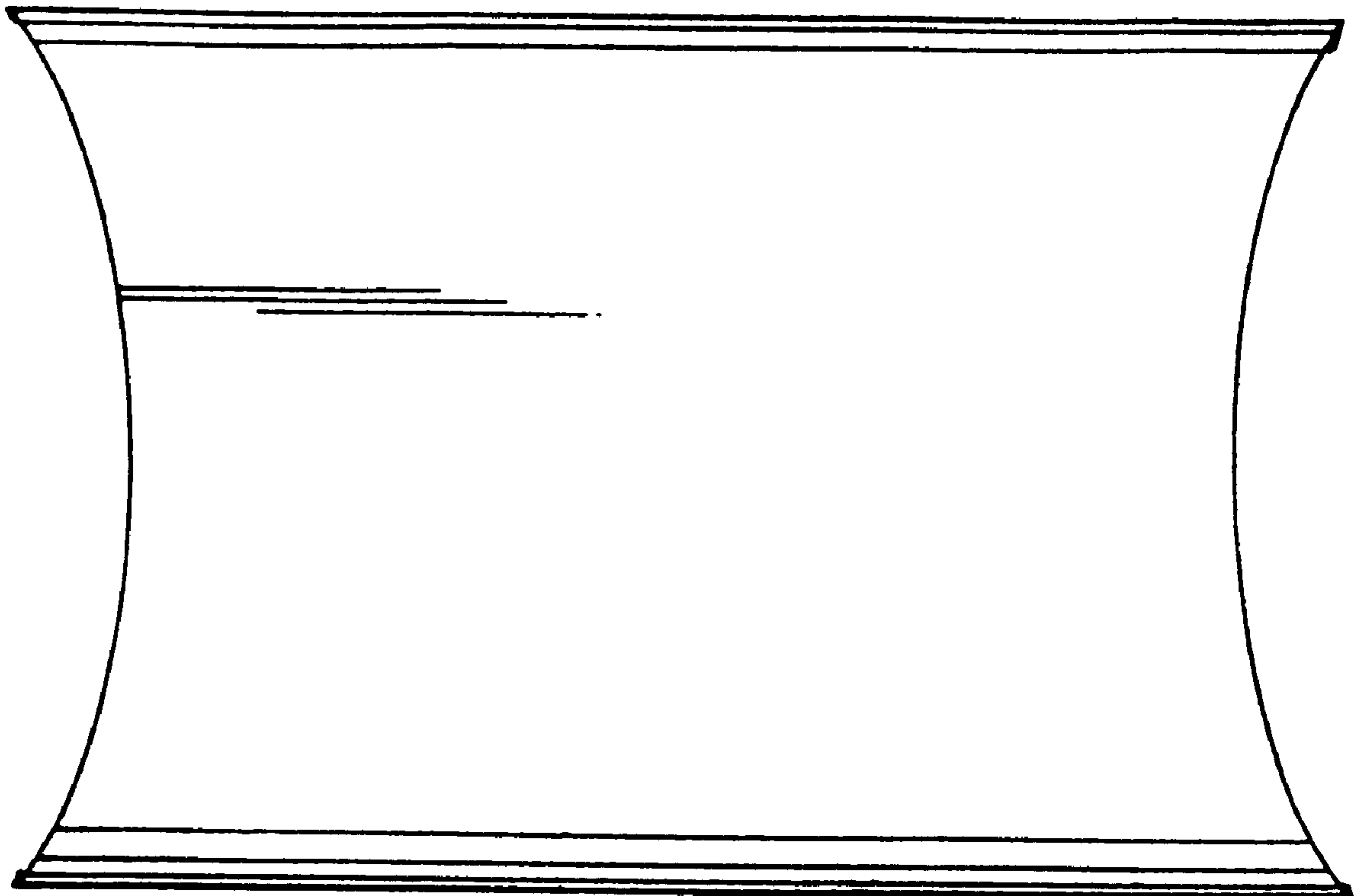
(57) **CLAIM**

The ornamental design for an urn, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of the urn and embodying our new design;  
 FIG. 2 is a side view of the urn embodying our new design, the opposite side being a mirror image of that shown;  
 FIG. 3 is an end view of the urn embodying our new design, the opposite side being a mirror image of that shown; and,  
 FIG. 4 is a perspective view of the urn embodying our new design.

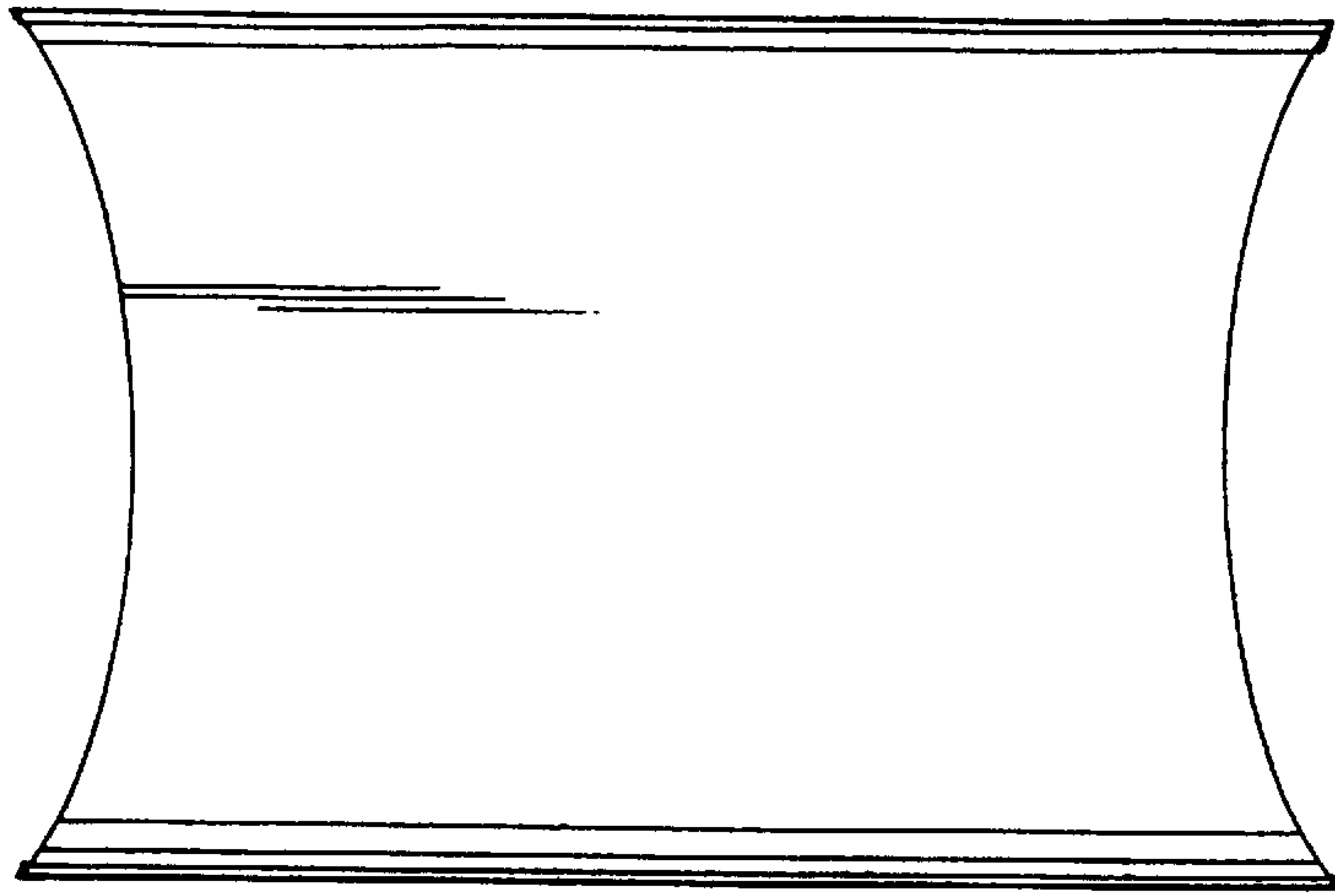

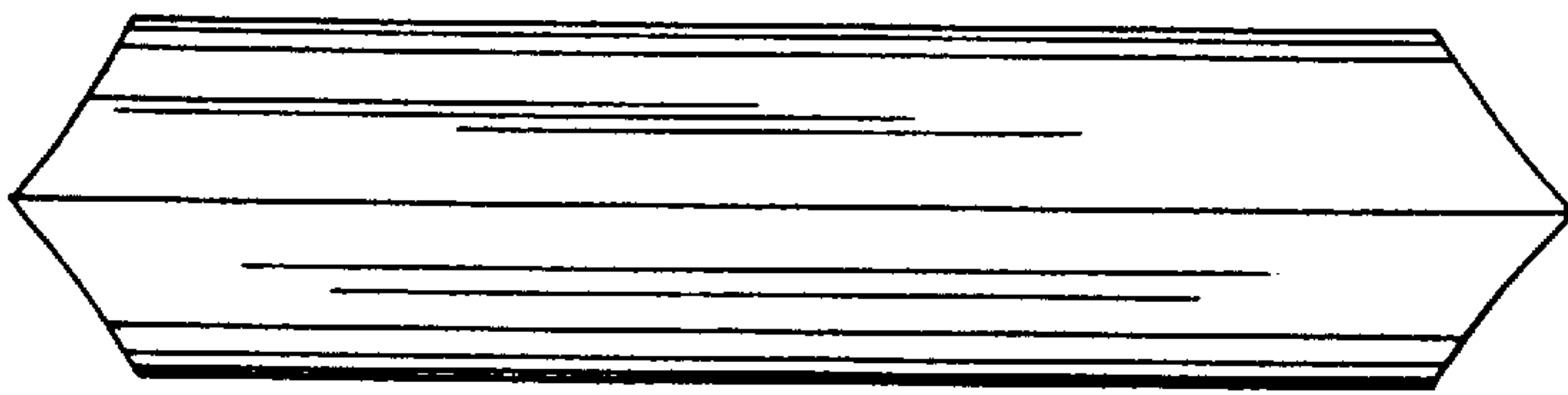

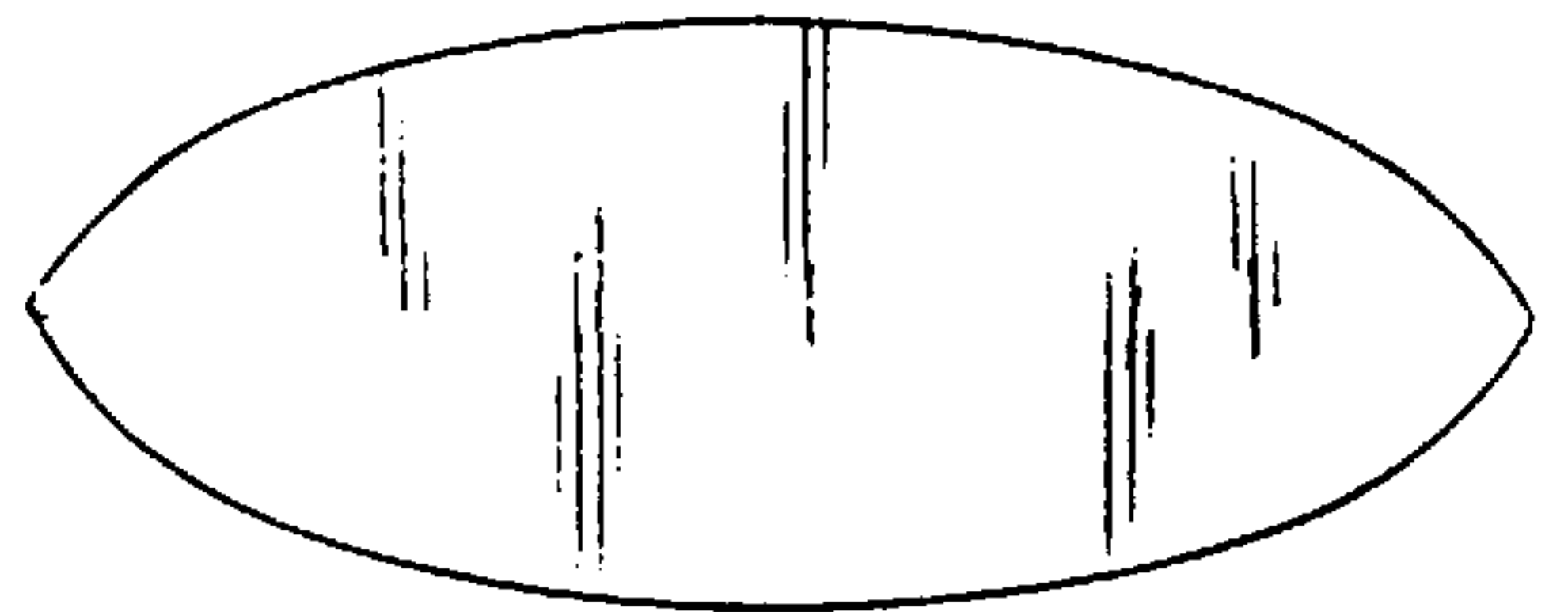

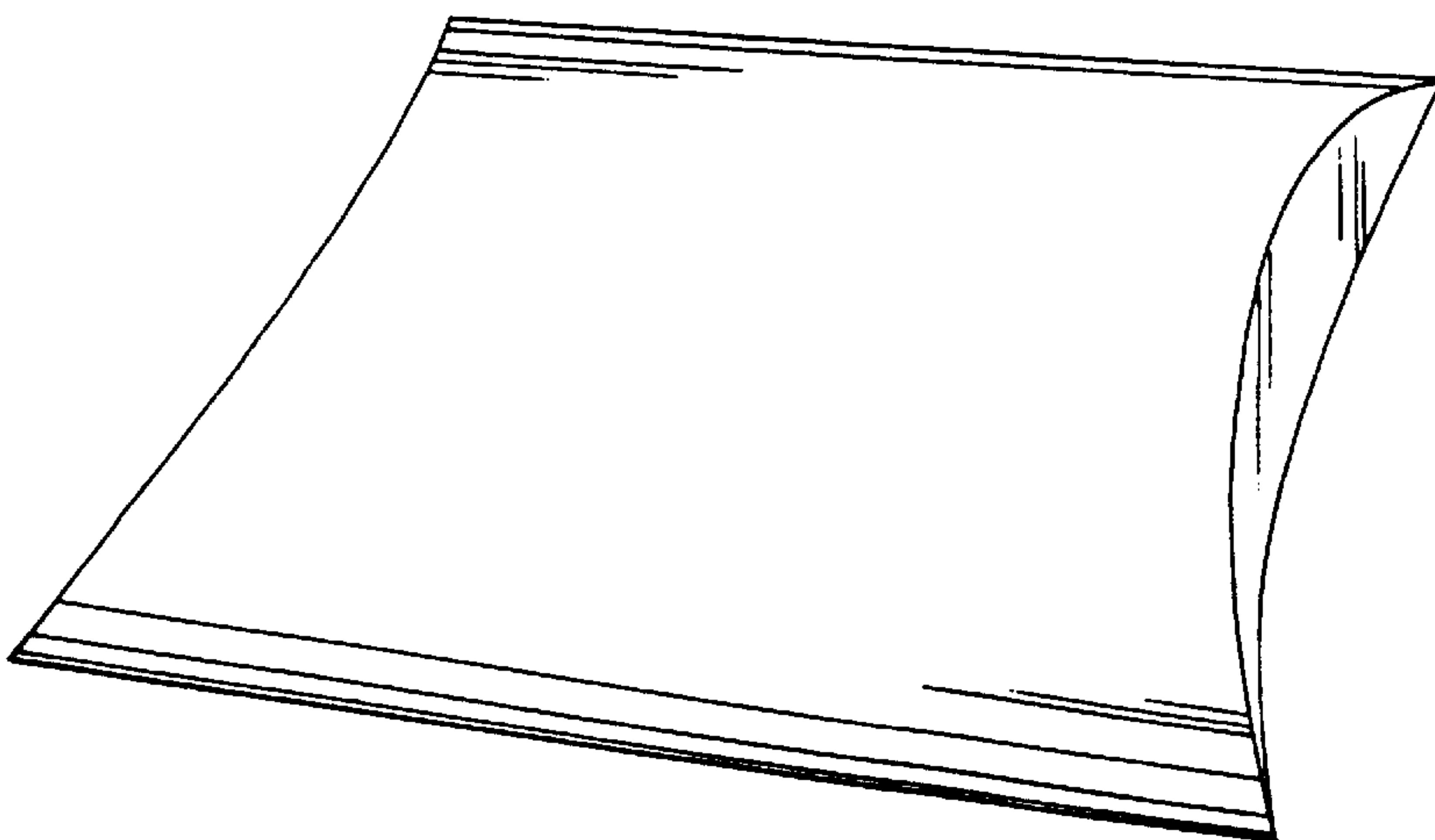
