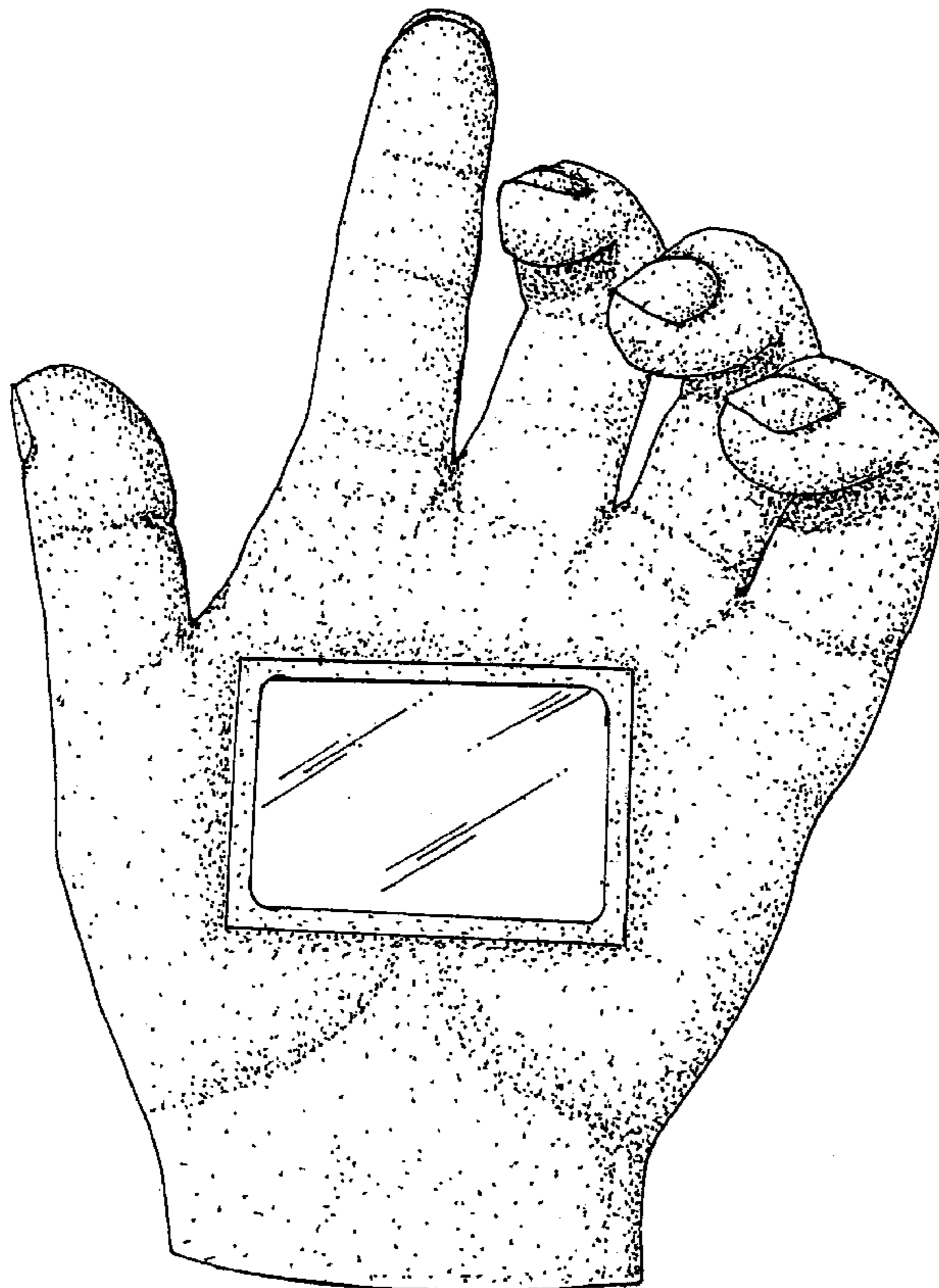
(57) **CLAIM**

The ornamental design for a glove merchandising display, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of a glove merchandising display embodying our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is one side elevational view thereof; FIG. 4 is the other side elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

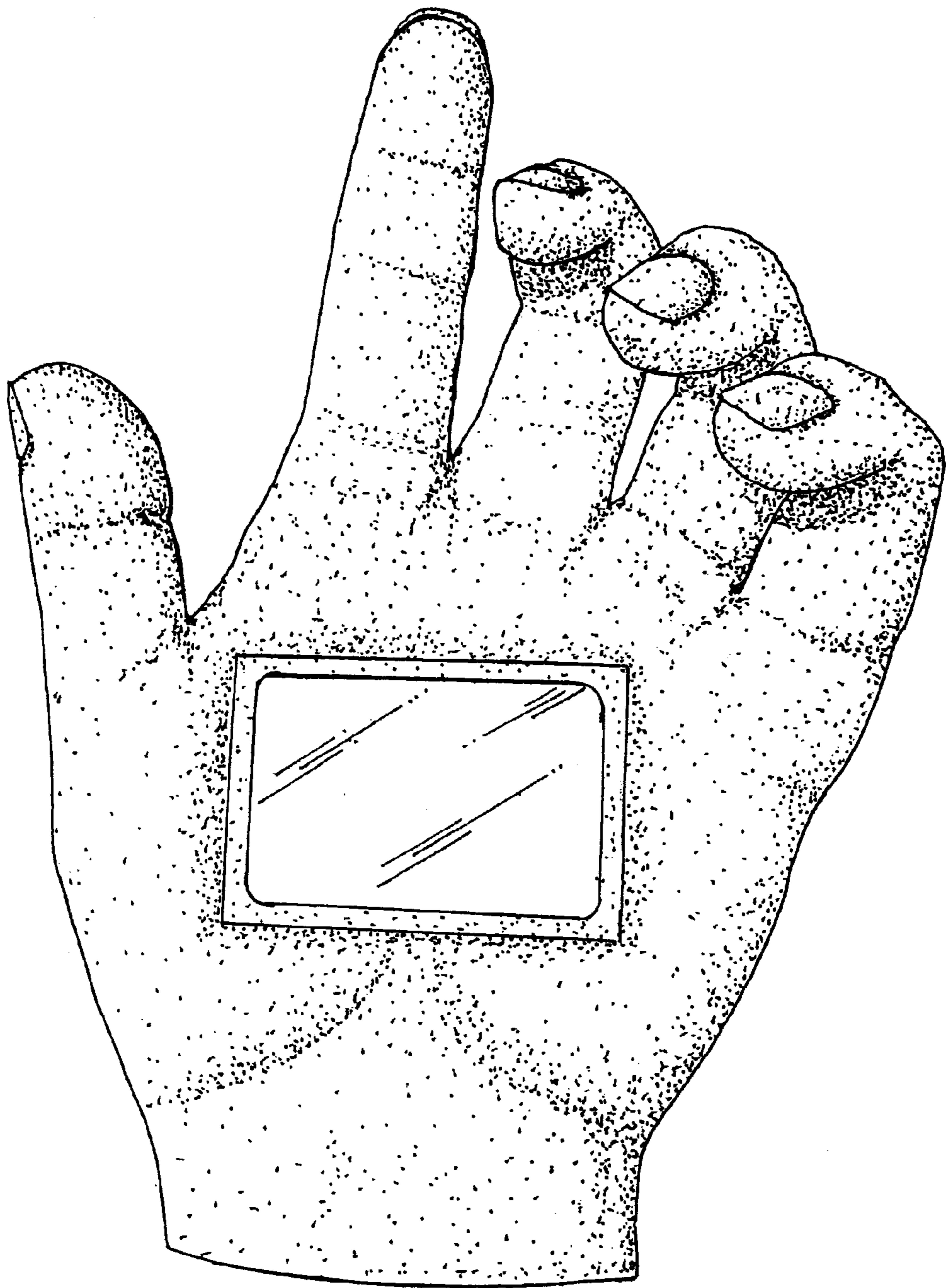

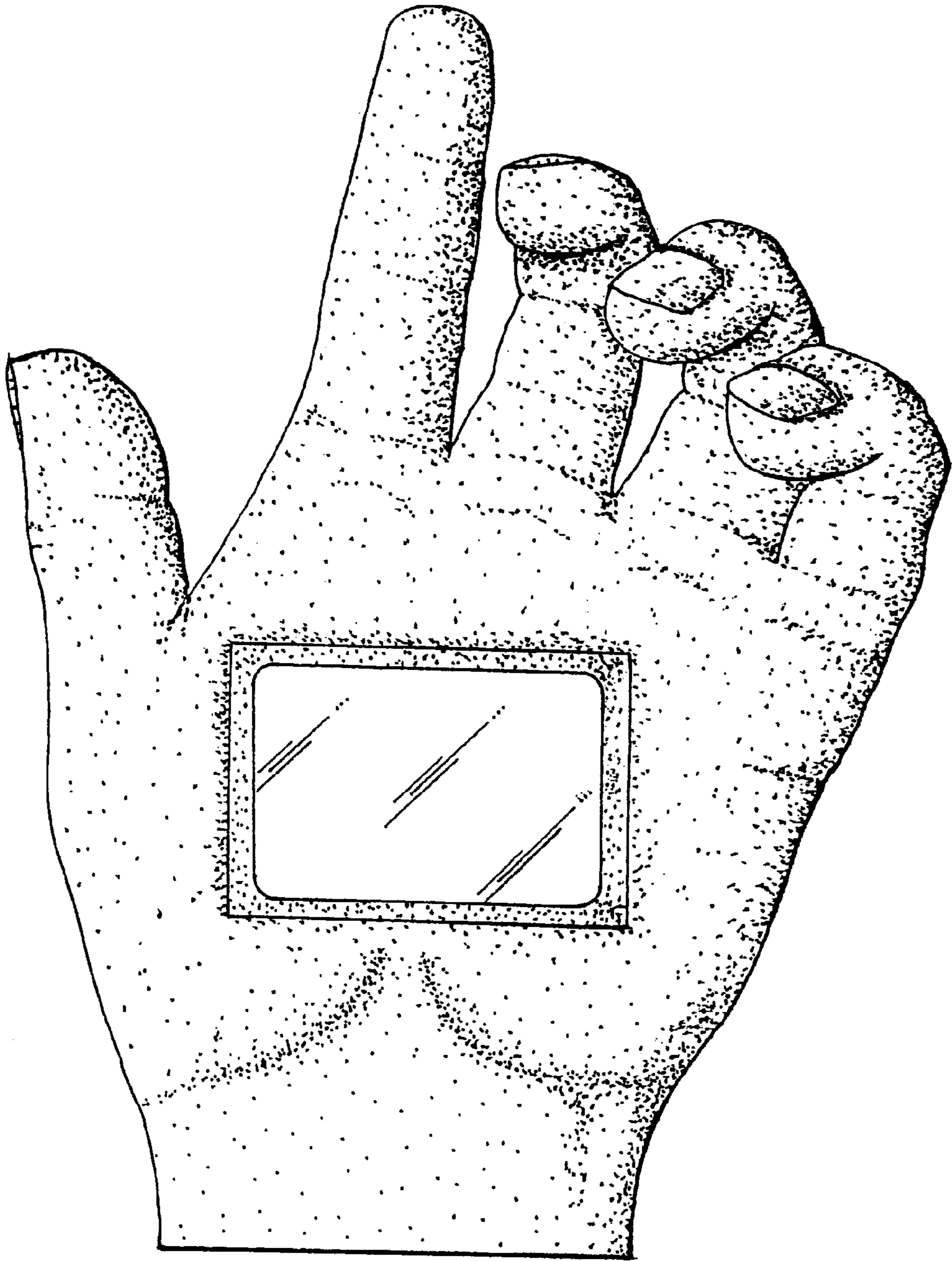

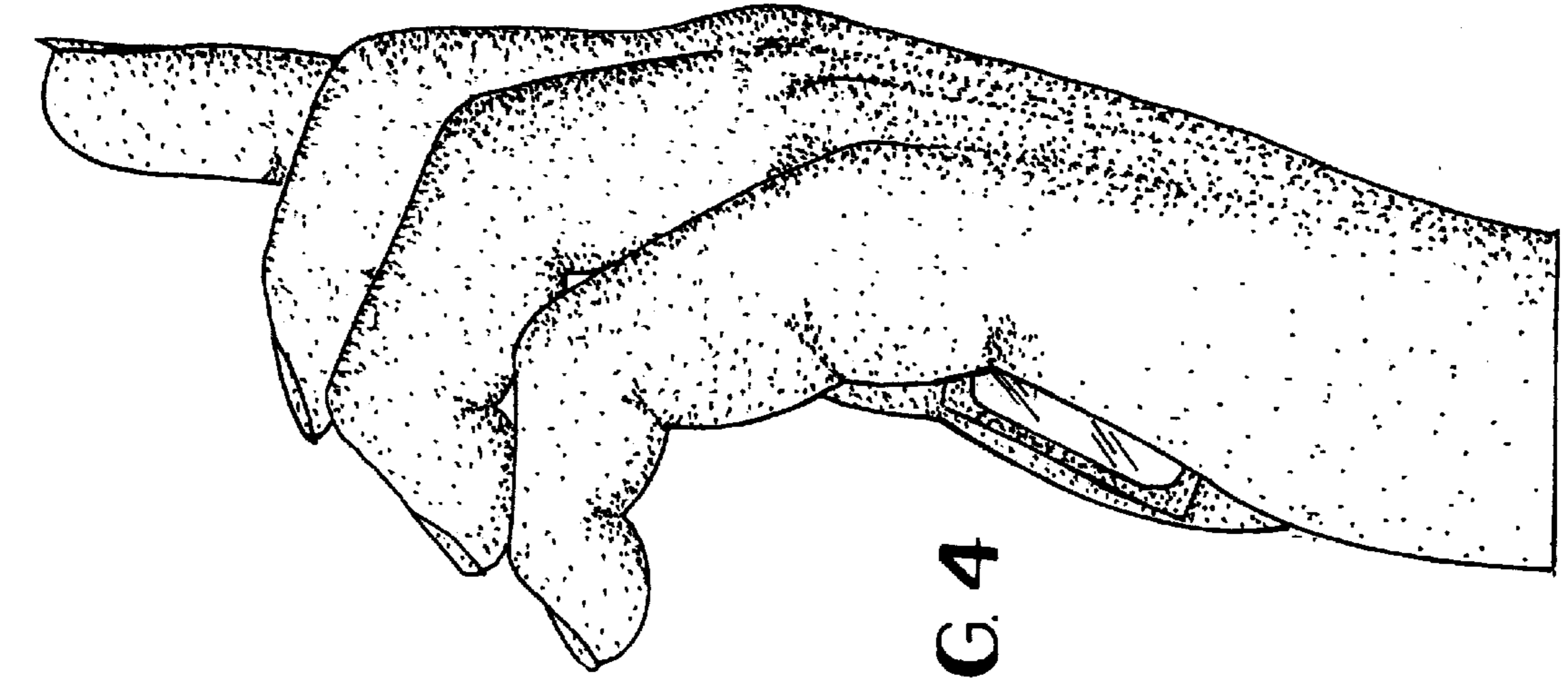

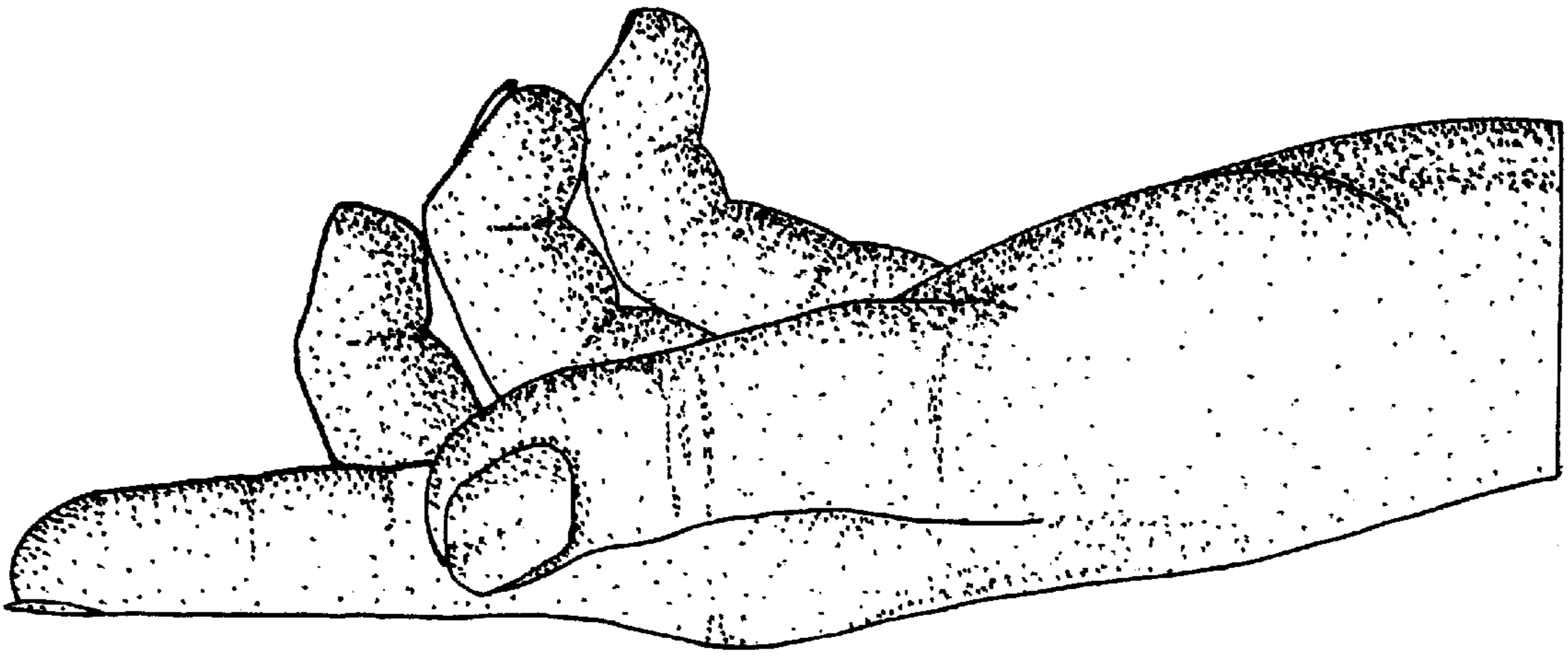

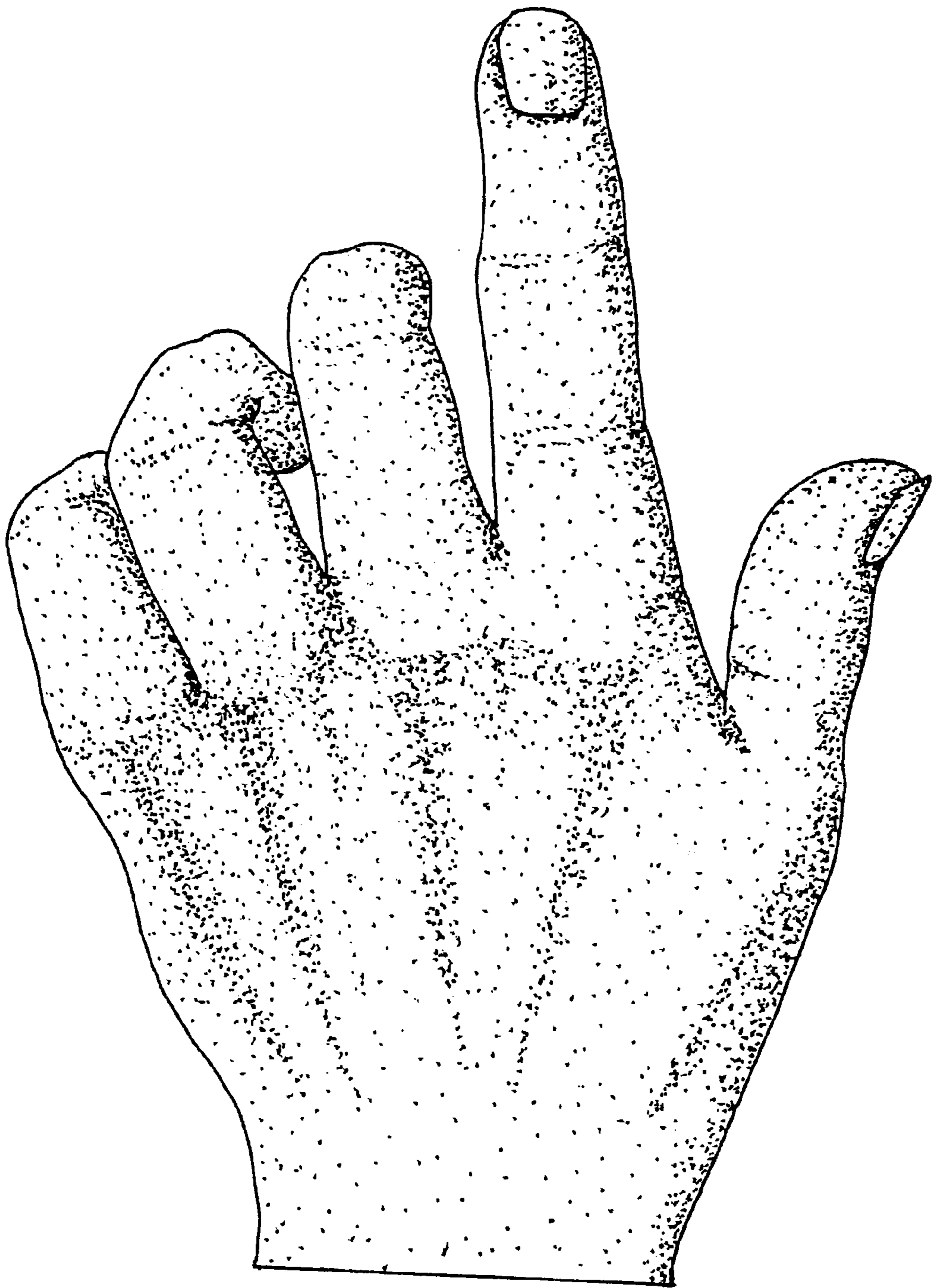

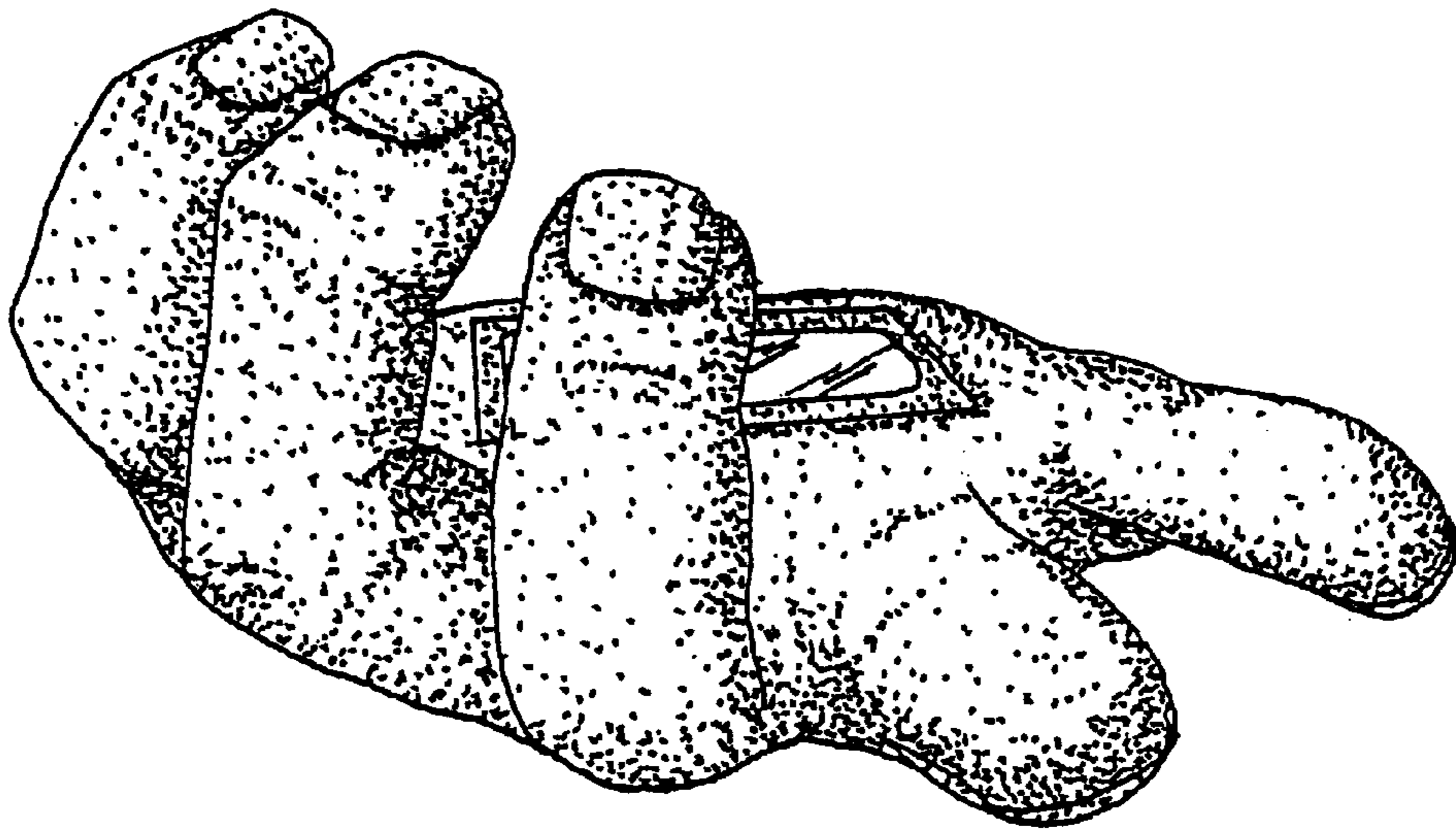

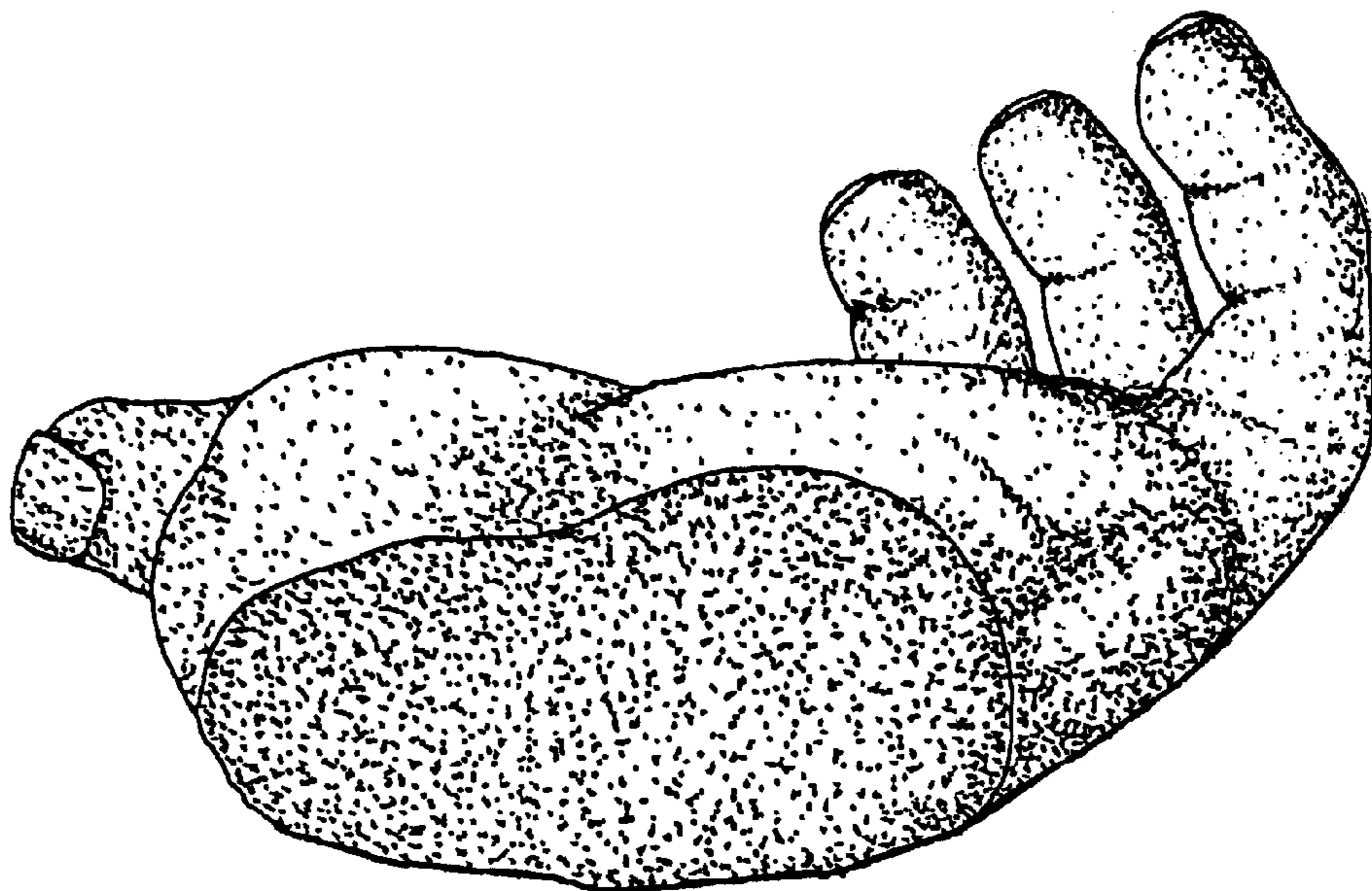
