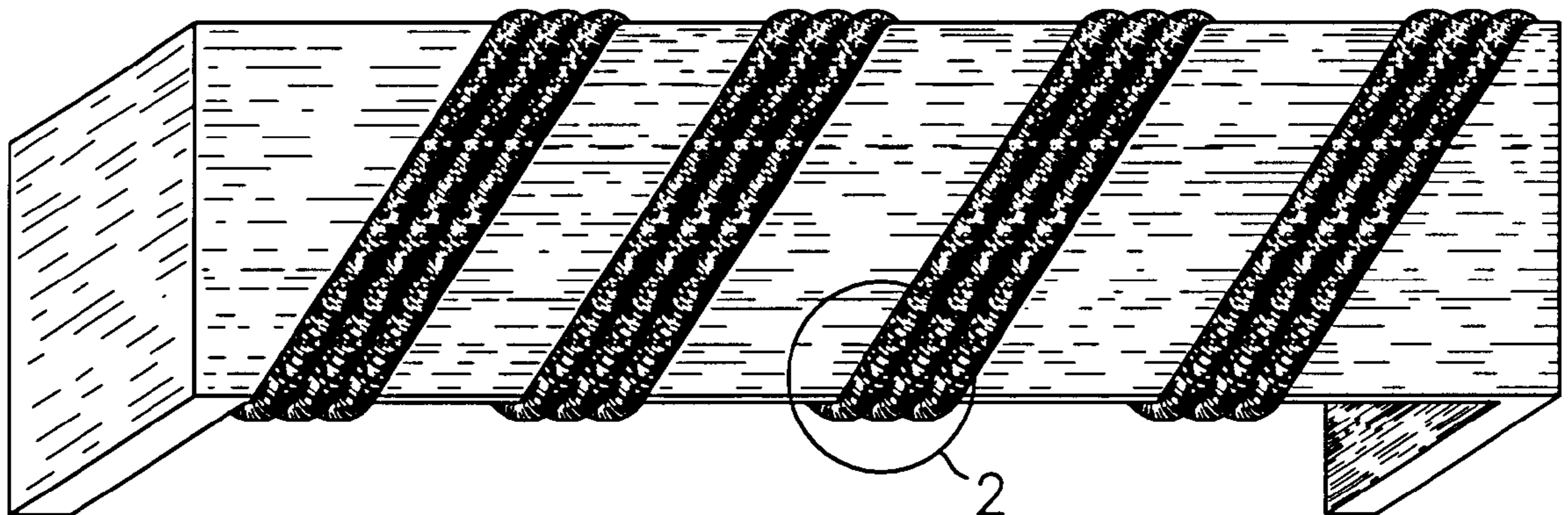

**DESCRIPTION**

FIG. 1 is a bottom perspective view of the decorative valance showing our new design;  
FIG. 2 is an enlarged fragmented bottom perspective view, showing a detailed portion of the valance;  
FIG. 3 is a top plan view of FIG. 1; and,  
FIG. 4 is a side view thereof, the other side being a mirror image.

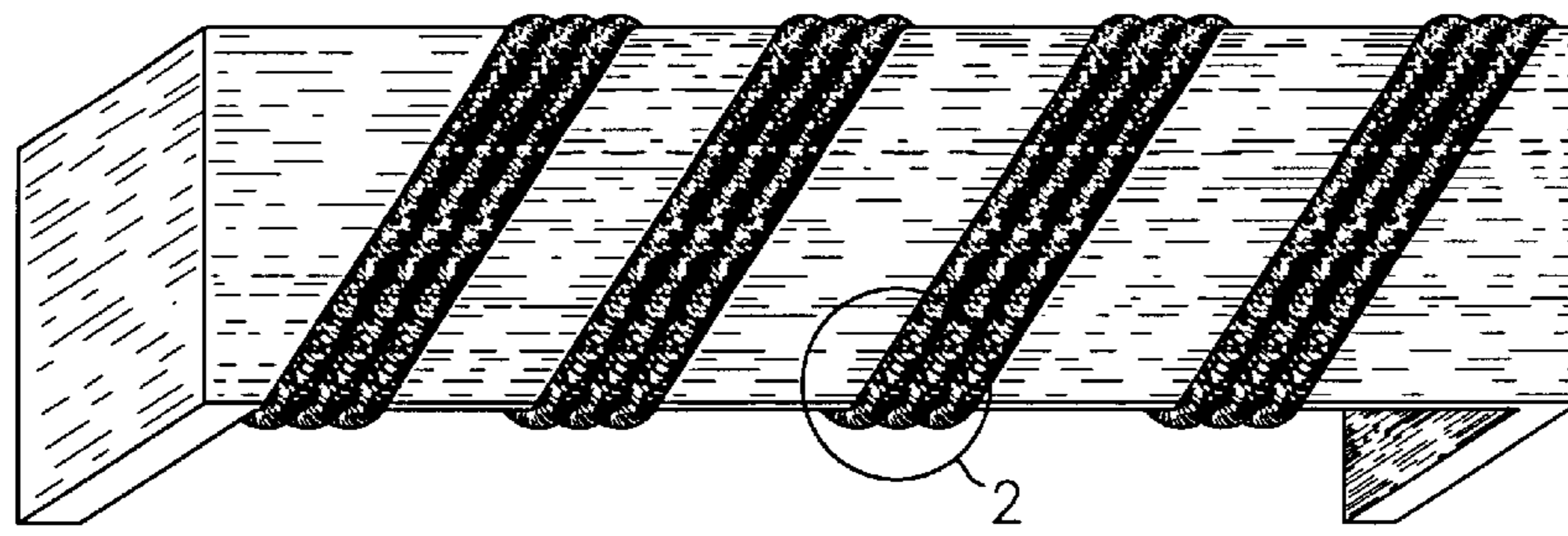

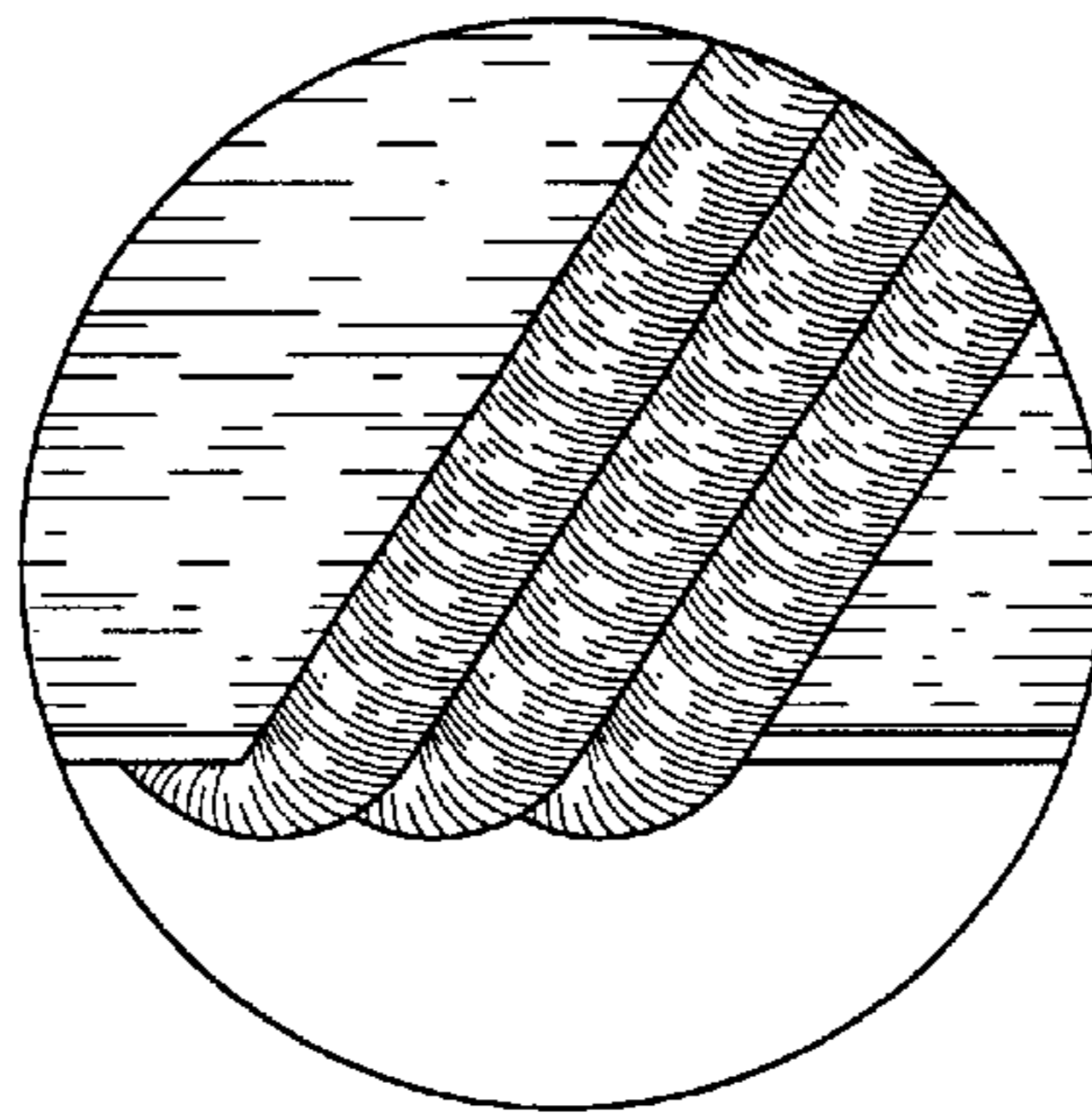

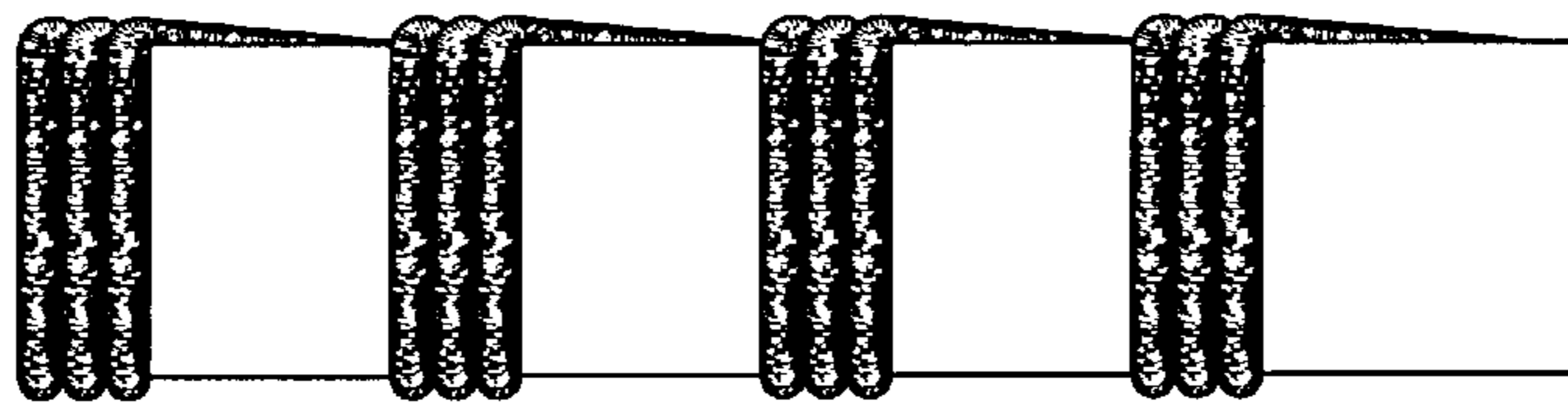

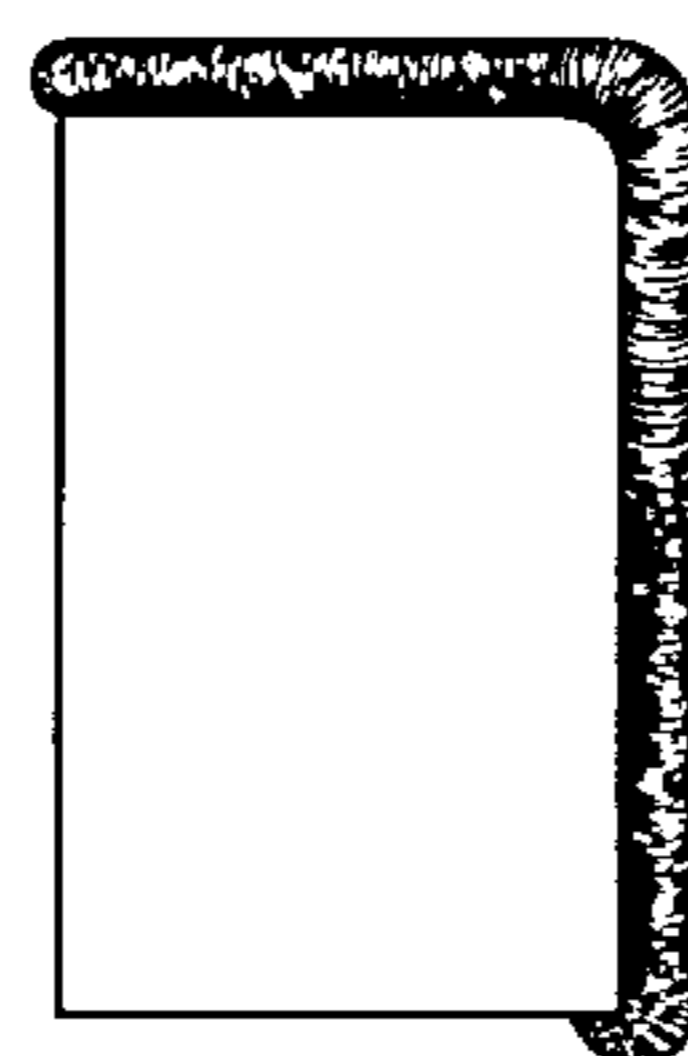
