The ornamental design for a cutter knife, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a cutter knife showing my new design;

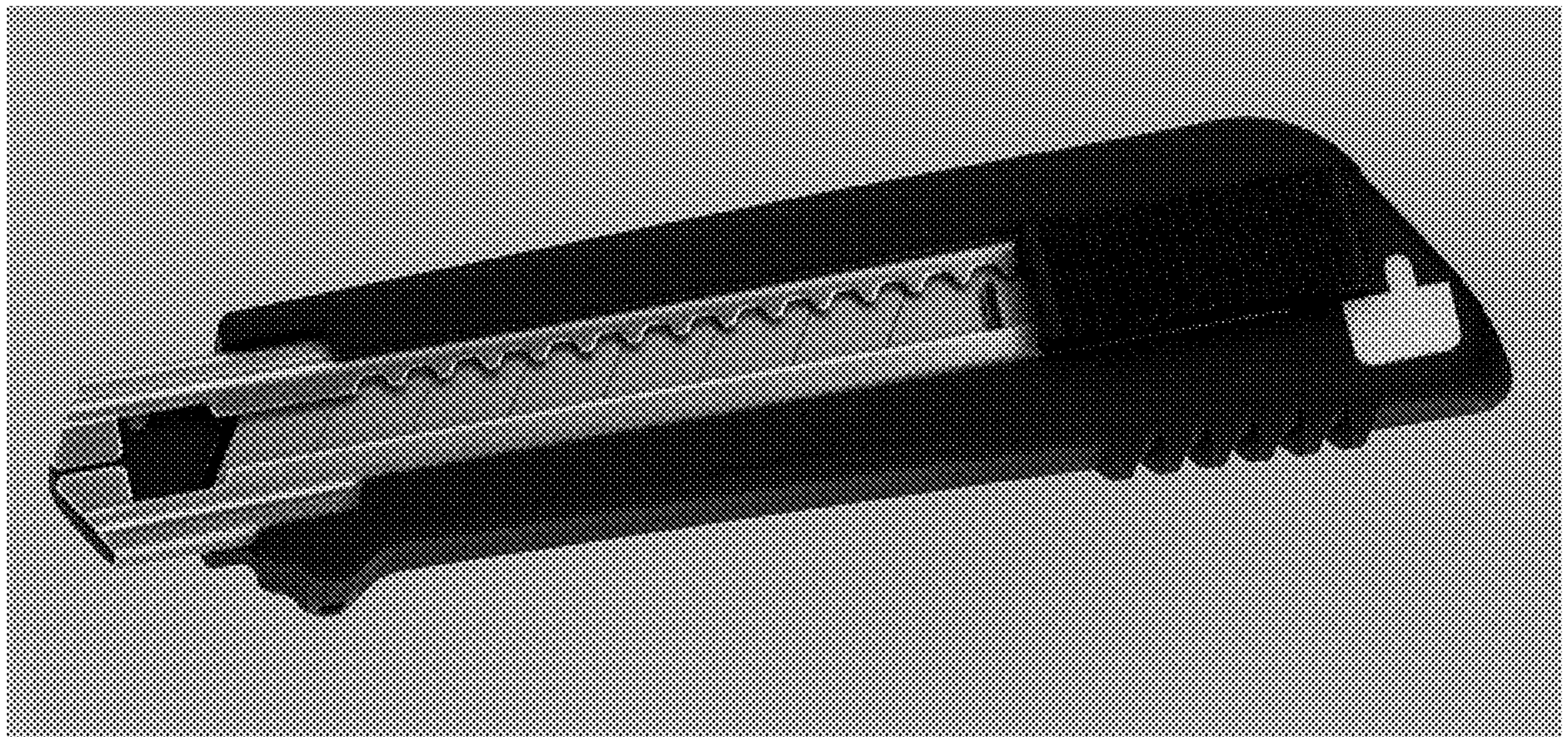
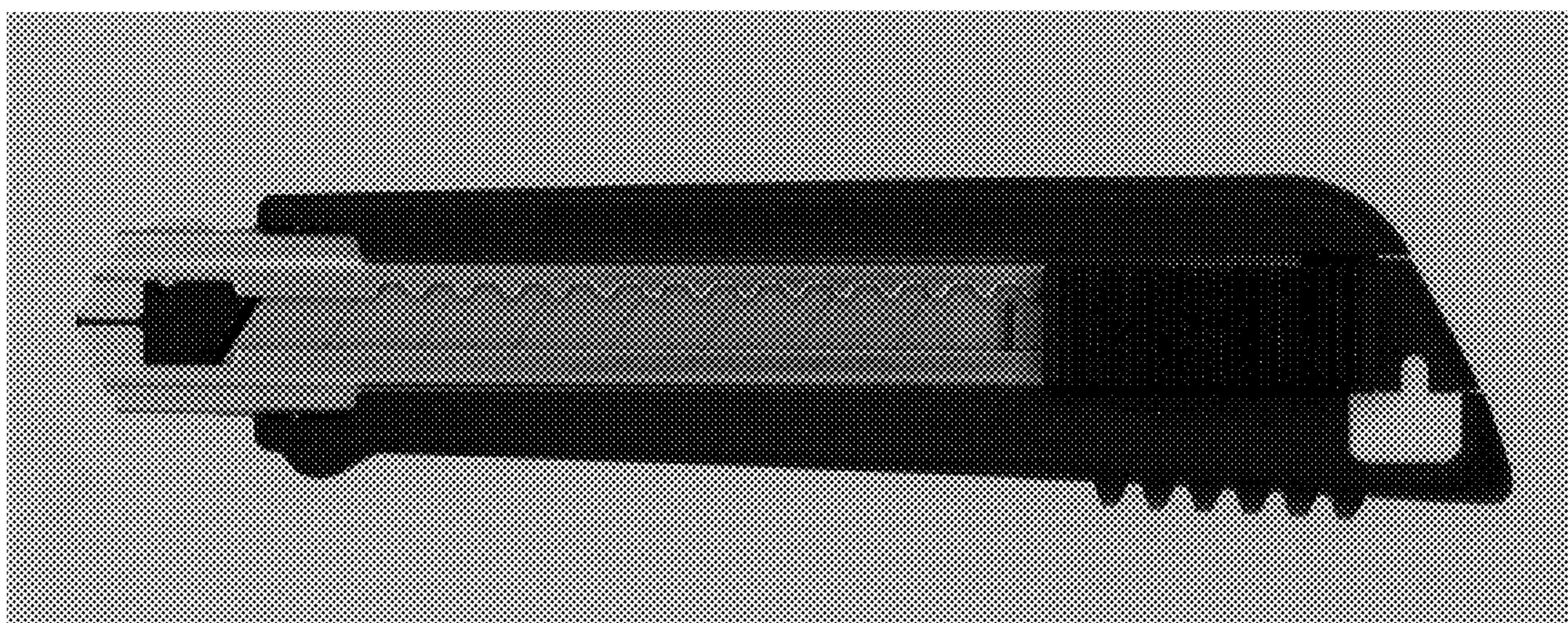

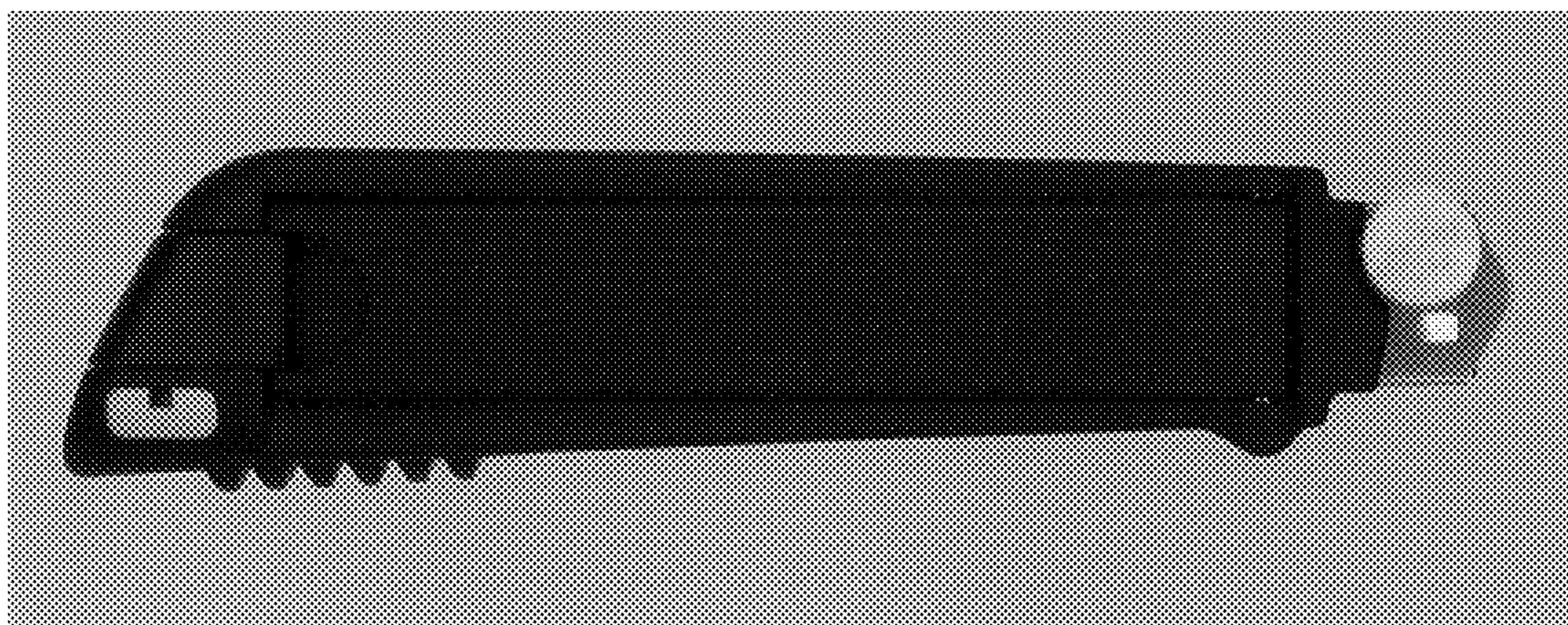

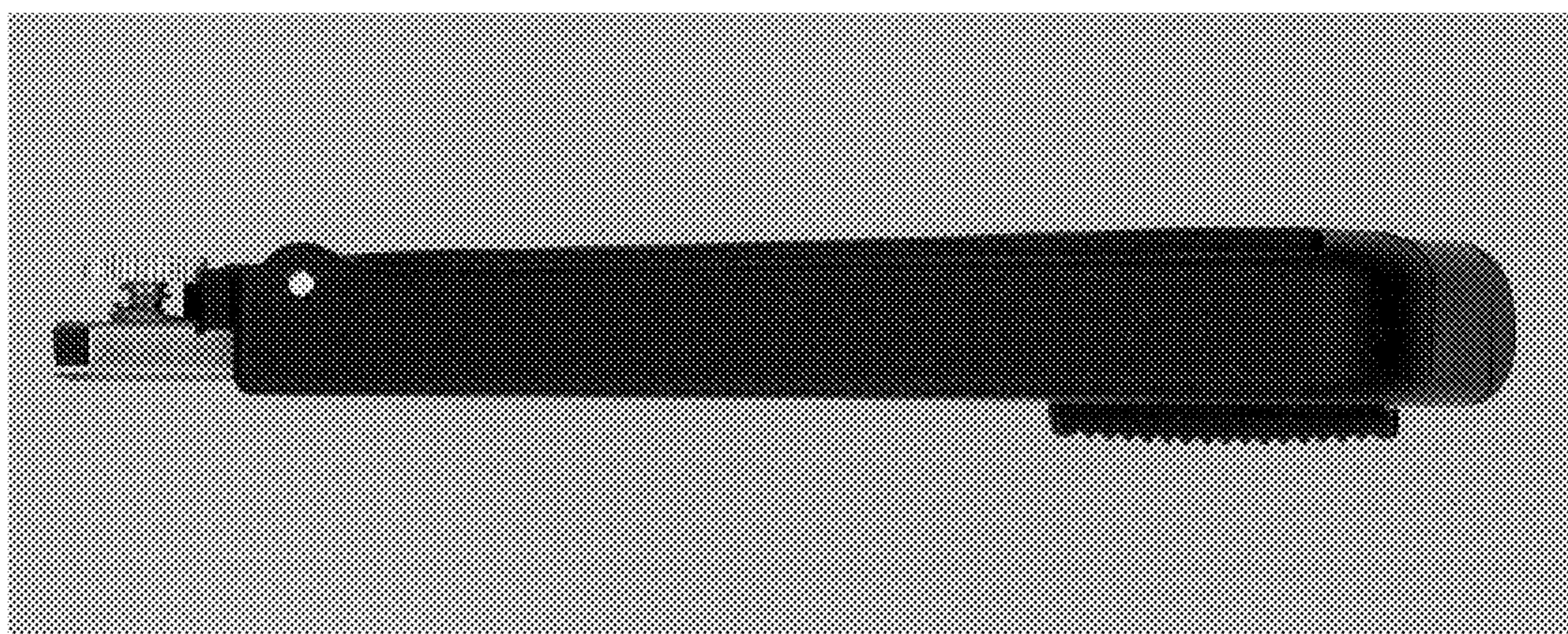

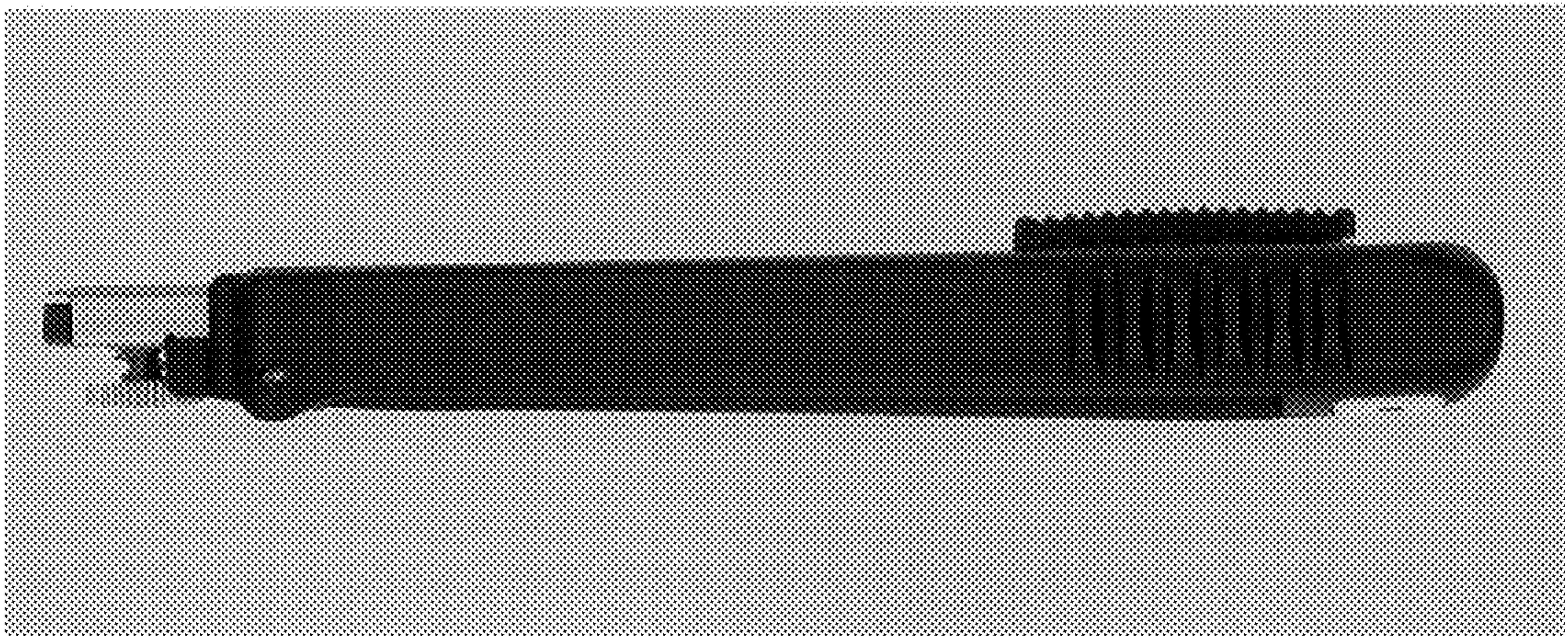

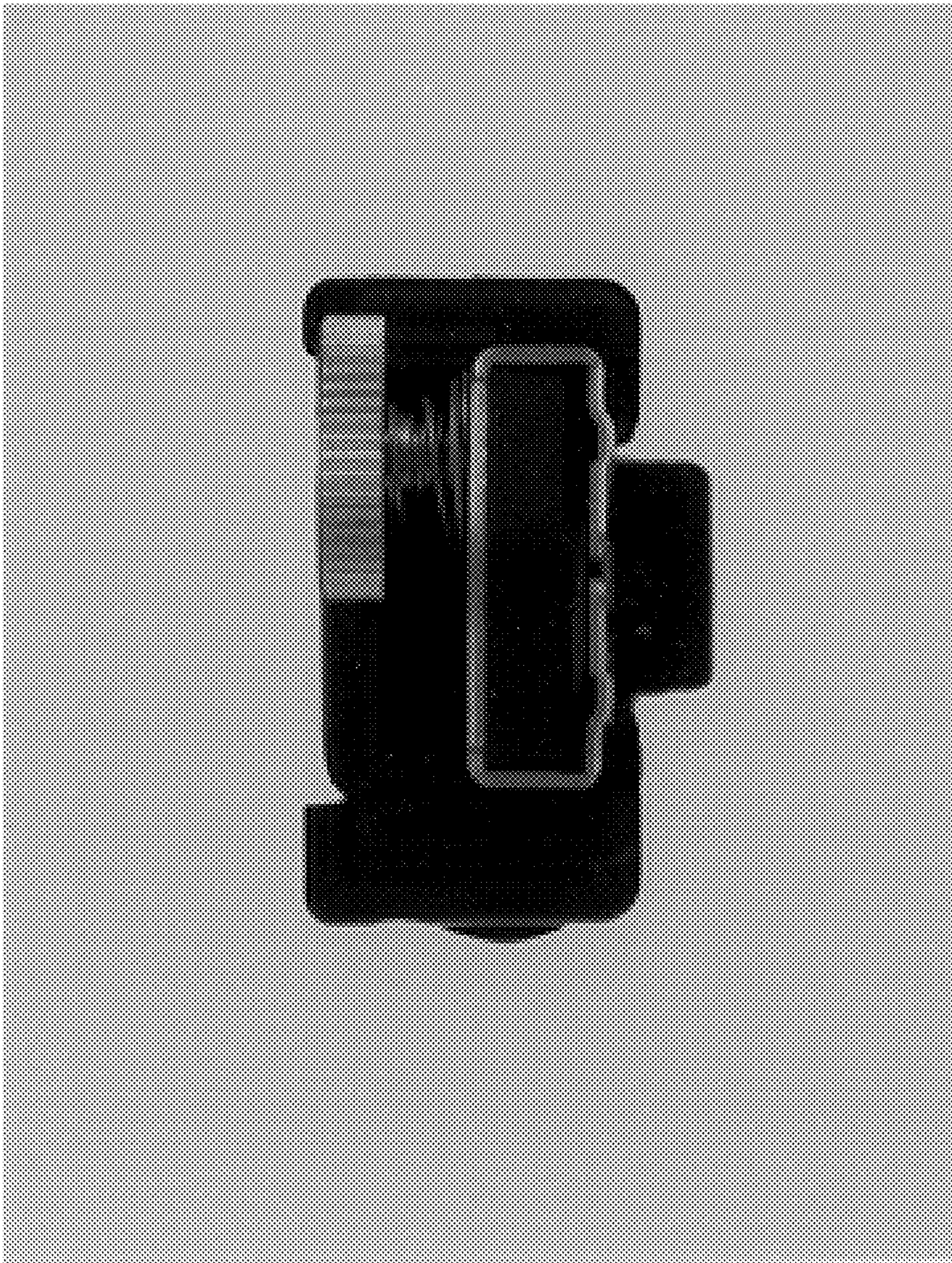

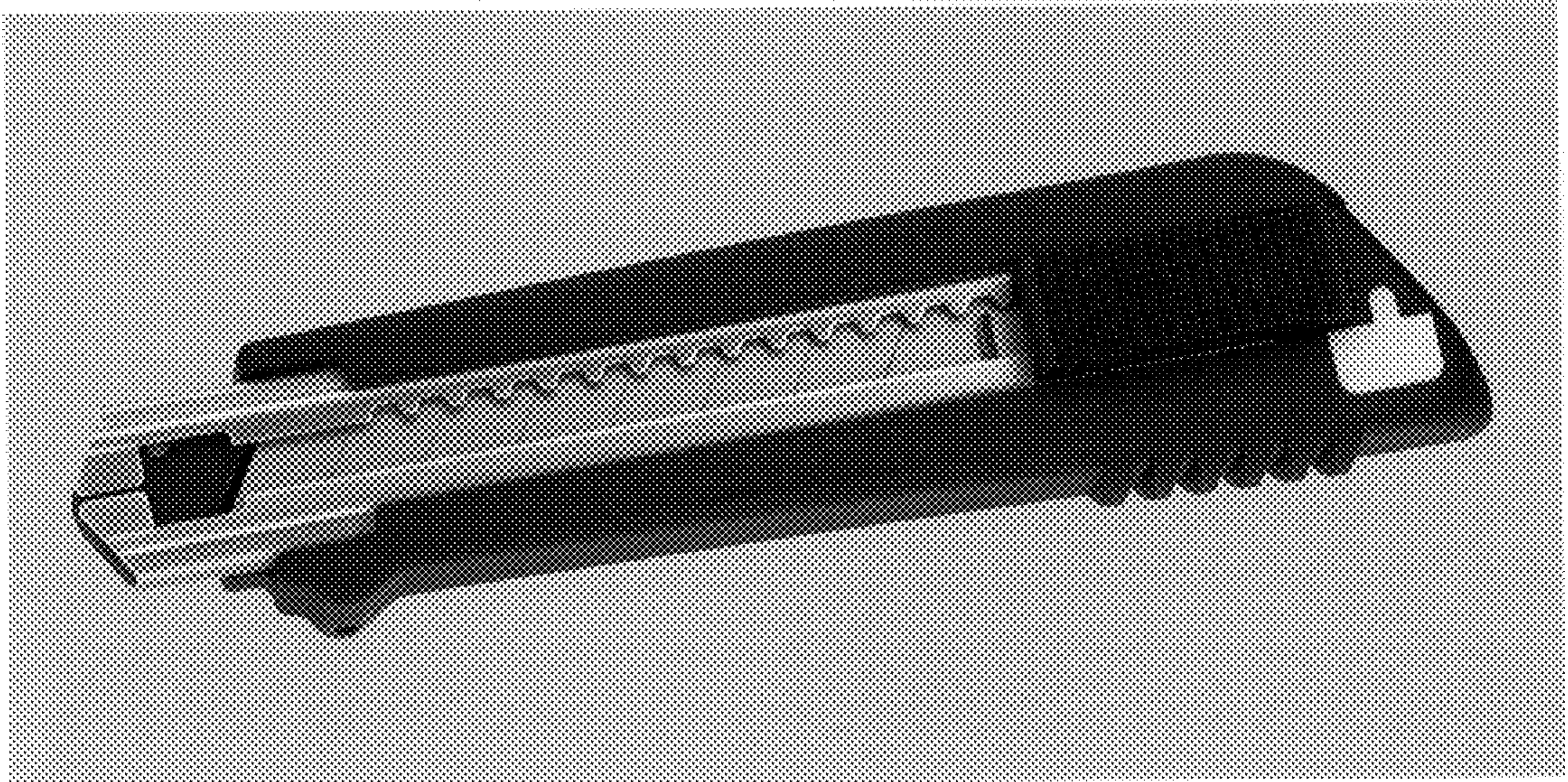

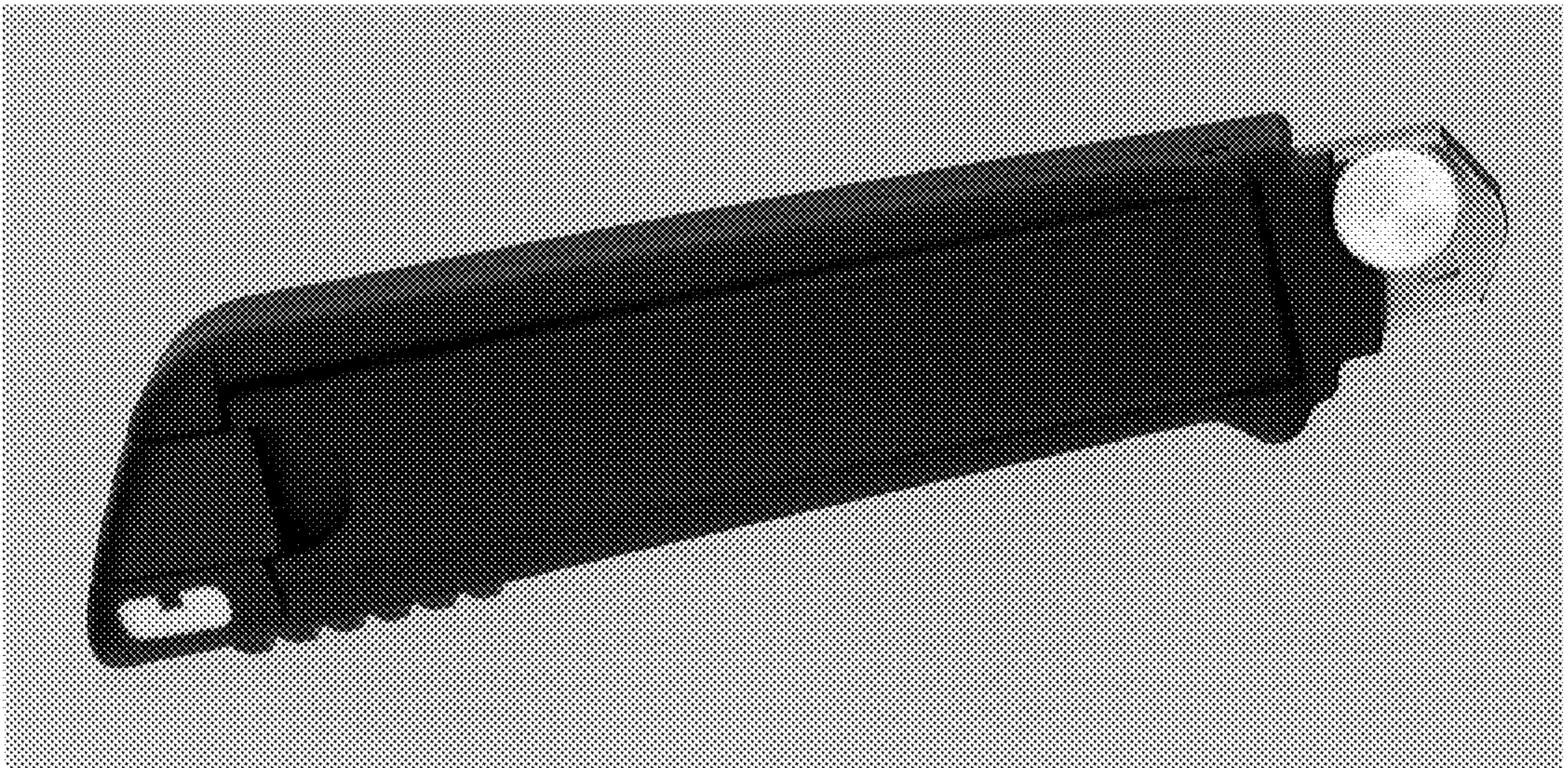
