DESCRIPTION

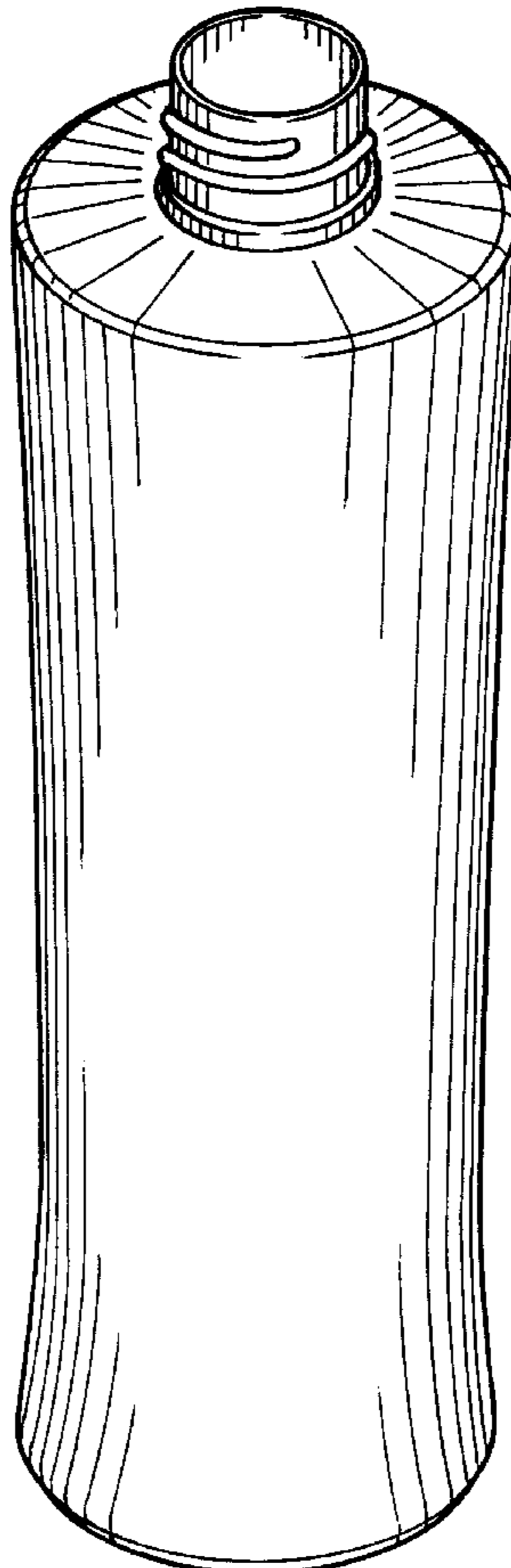
FIG. 1 is a front perspective view of bottle showing my new design;

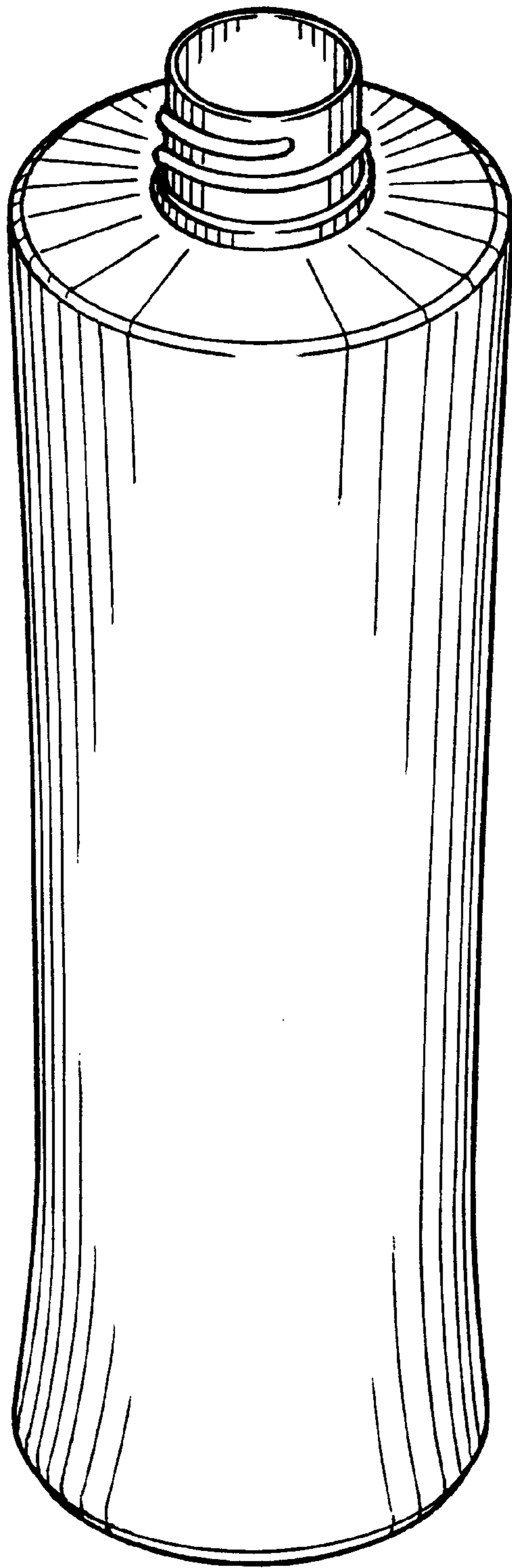

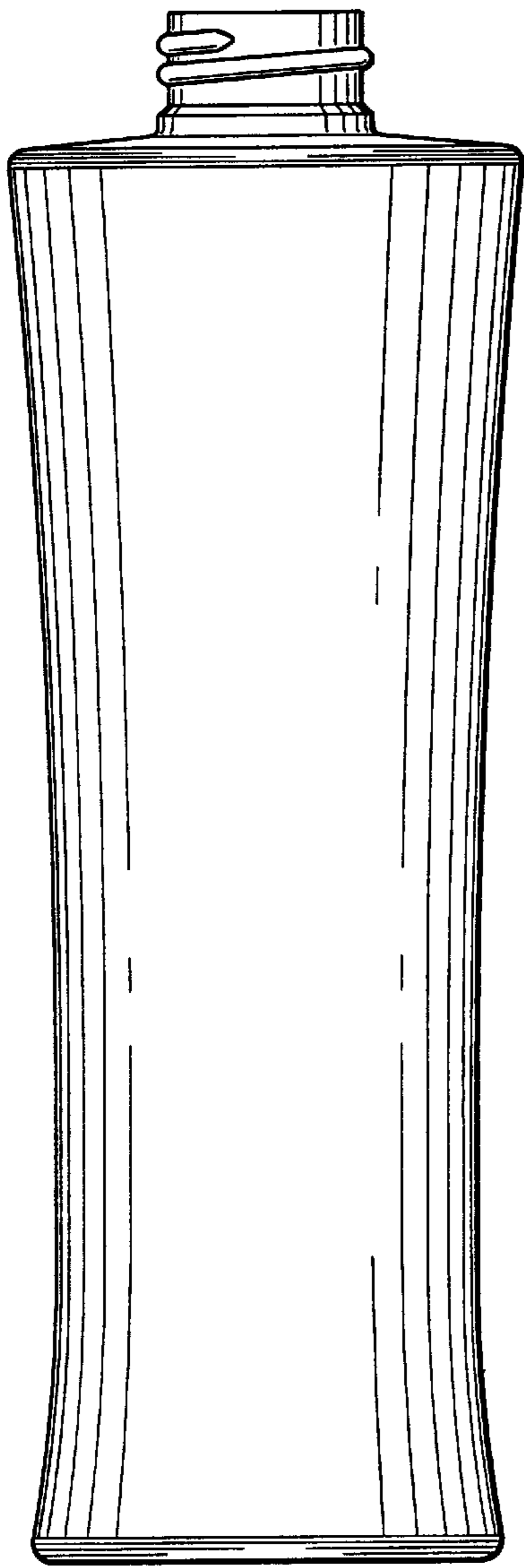

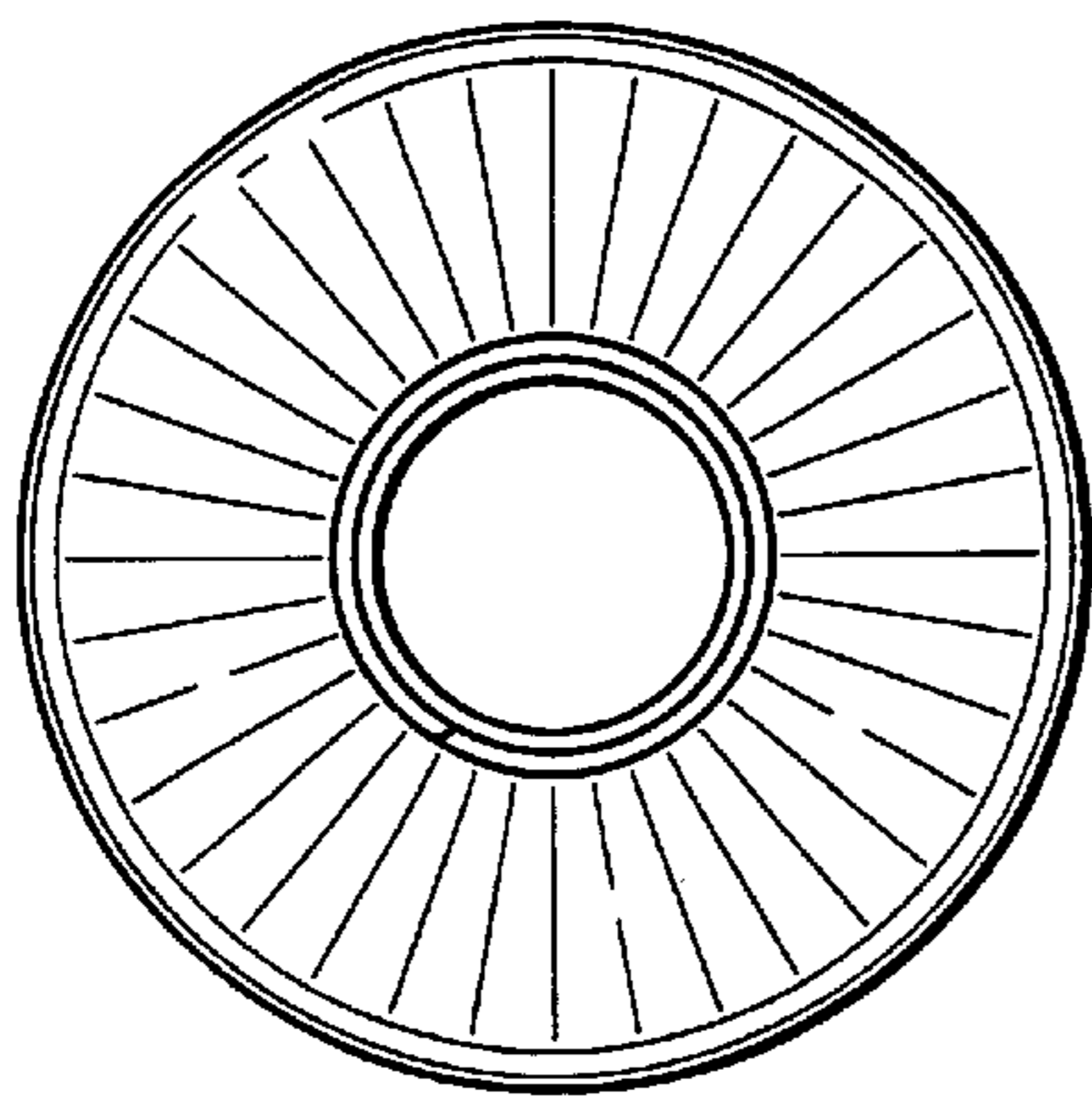

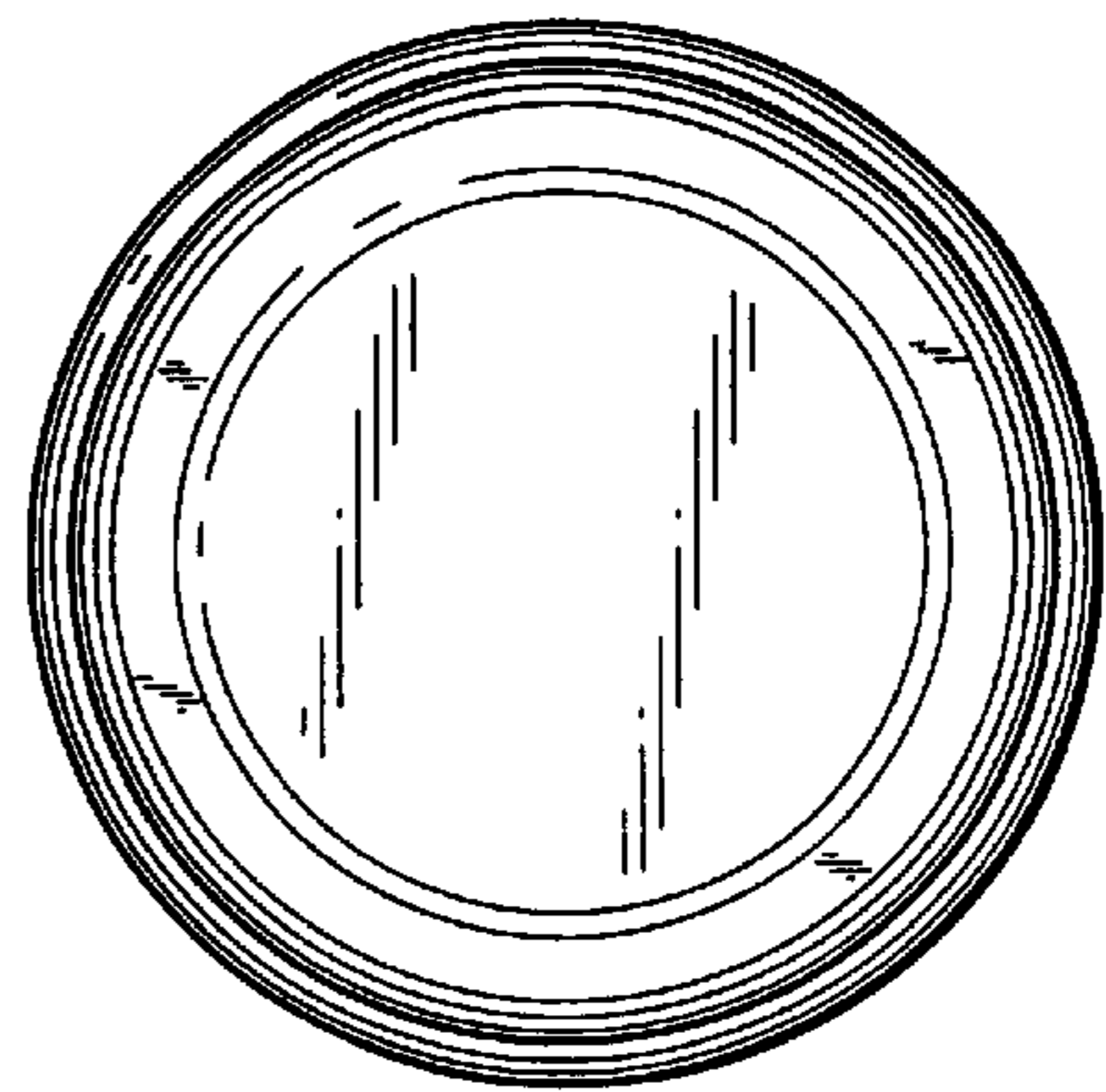
