(57) **CLAIM**

The ornamental design for a firearm stock with opening therein, as shown and described.

DESCRIPTION

FIG. 1 is a left hand side elevational view of the firearm stock with opening therein which is the present invention; FIG. 2 is a right side elevational view thereof; FIG. 3 is a top view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a front plan view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a left hand perspective view of the invention; FIG. 8 is a left hand side elevational view of an alternative embodiment of the firearm stock with opening therein which firearm stock with opening therein is comprised of wood; FIG. 9 is a right side view of the embodiment of FIG. 8; FIG. 10 is a top view of the embodiment of FIG. 8; FIG. 11 is a bottom view of the embodiment of FIG. 8; FIG. 12 is a front view of the embodiment of FIG. 8; FIG. 13 is a rear view of the embodiment of FIG. 8; and, FIG. 14 is left hand perspective view of the FIG. 8 embodiment.

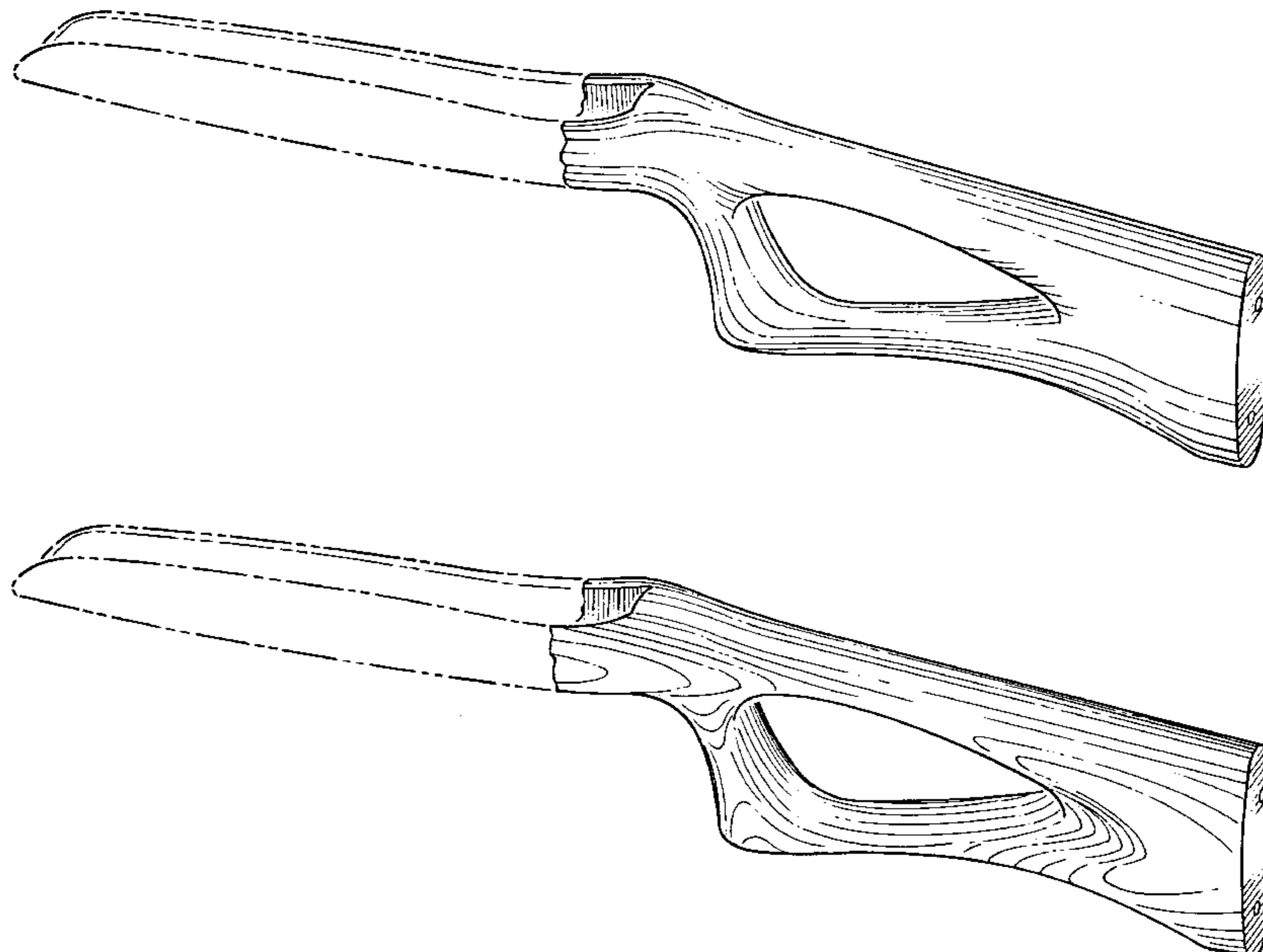
The broken line showing of a receiver, in FIGS. 1–14, is for illustrative purposes only and forms no part of the claimed design.

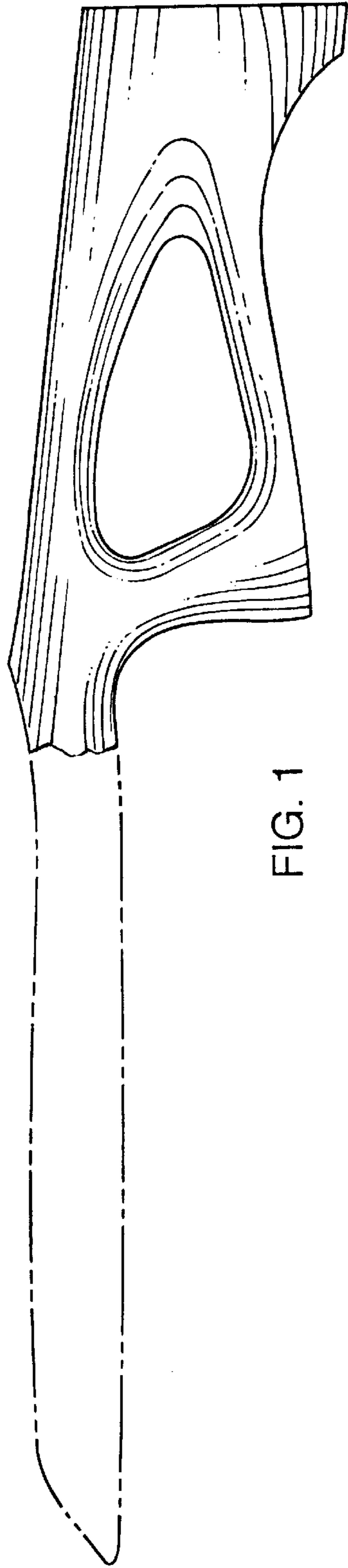

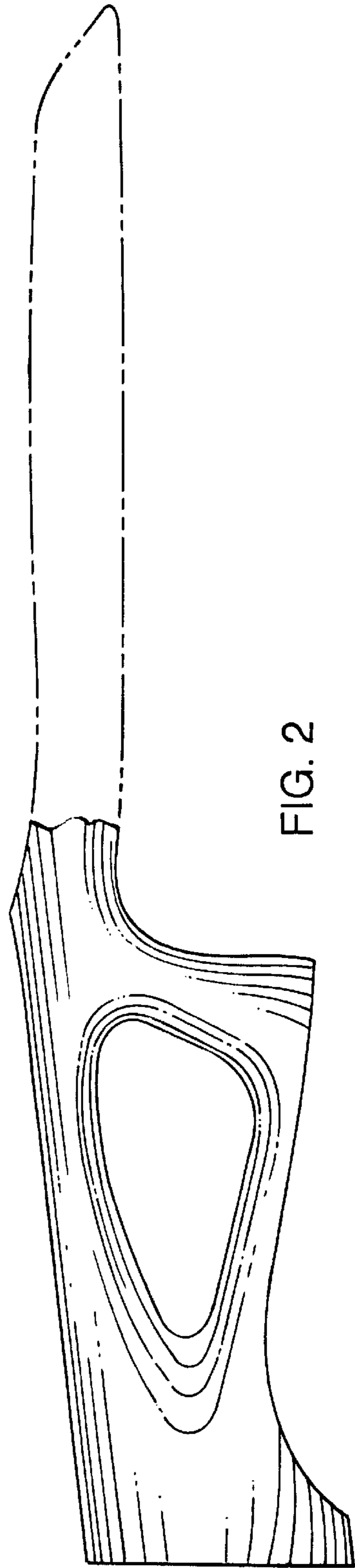

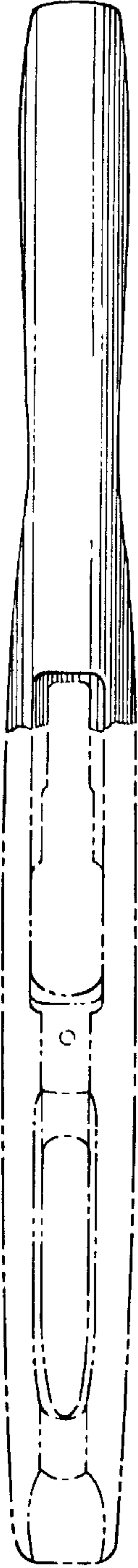

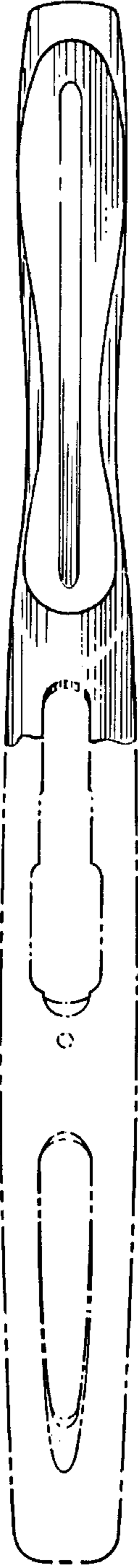

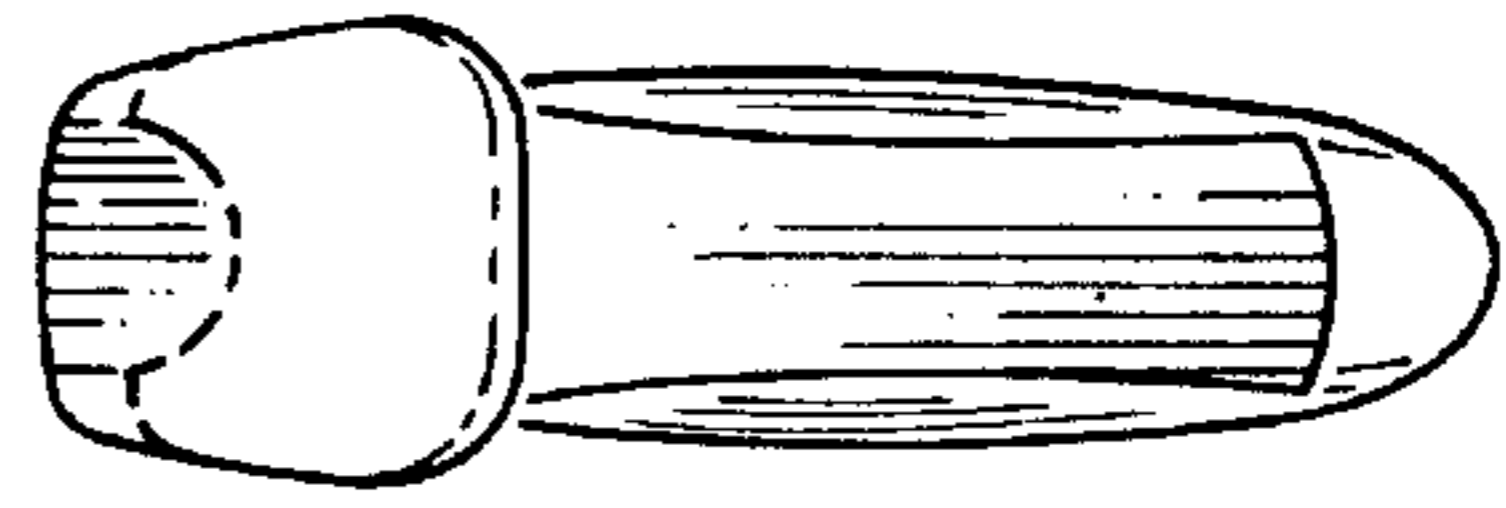

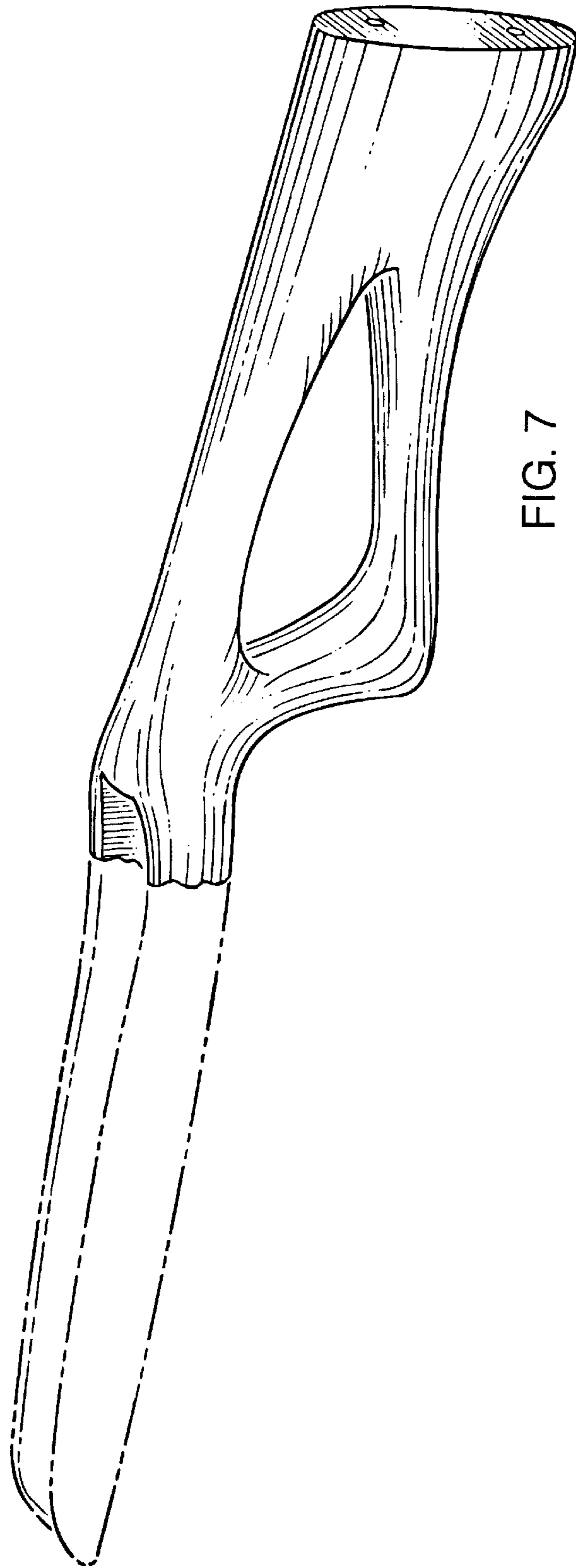

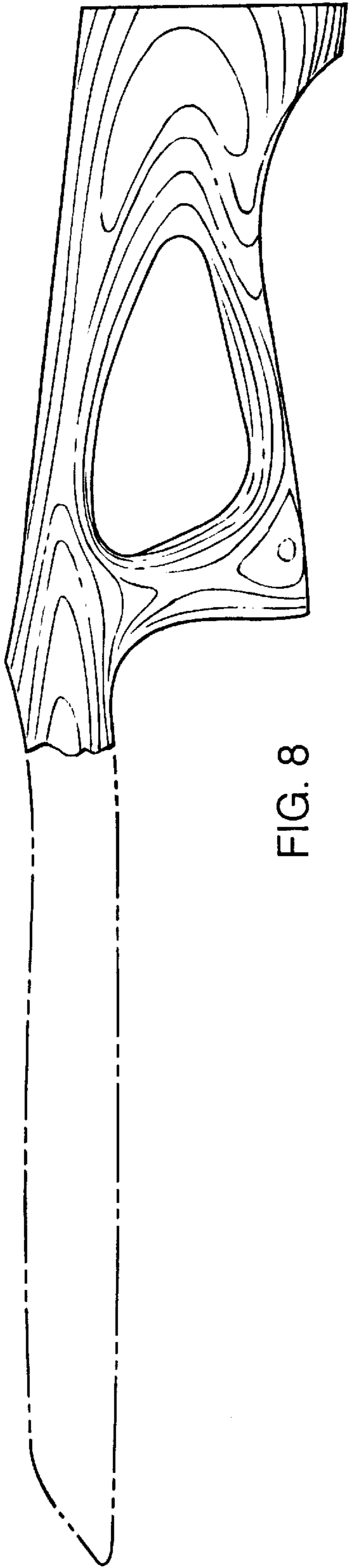

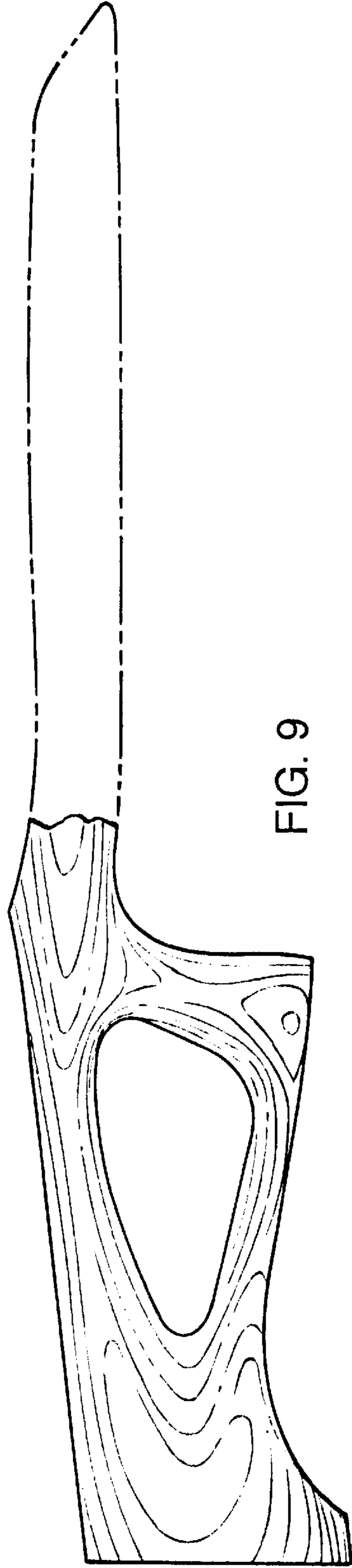

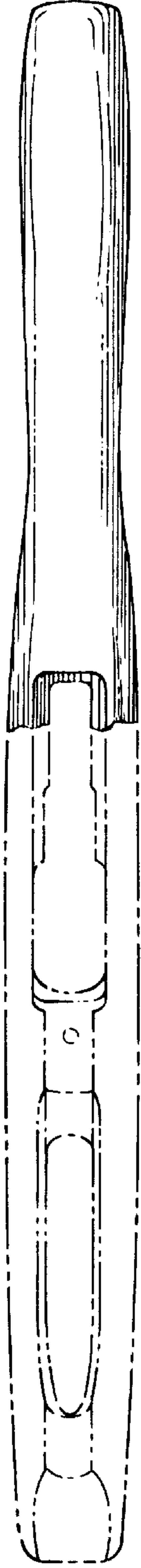

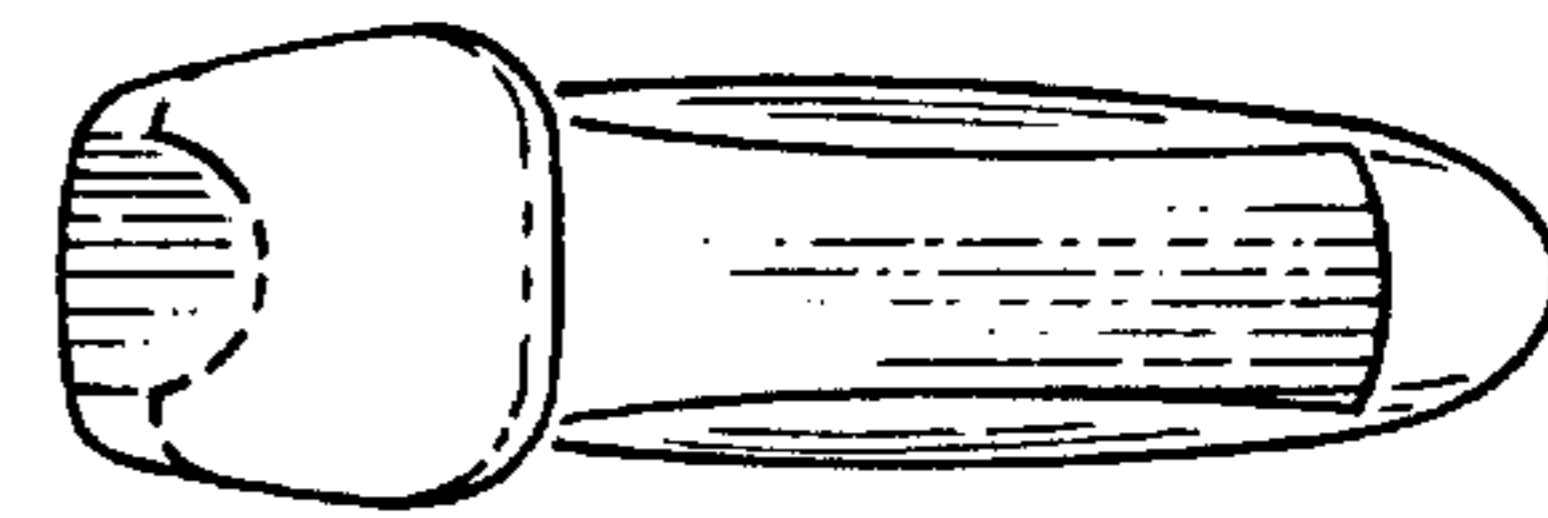

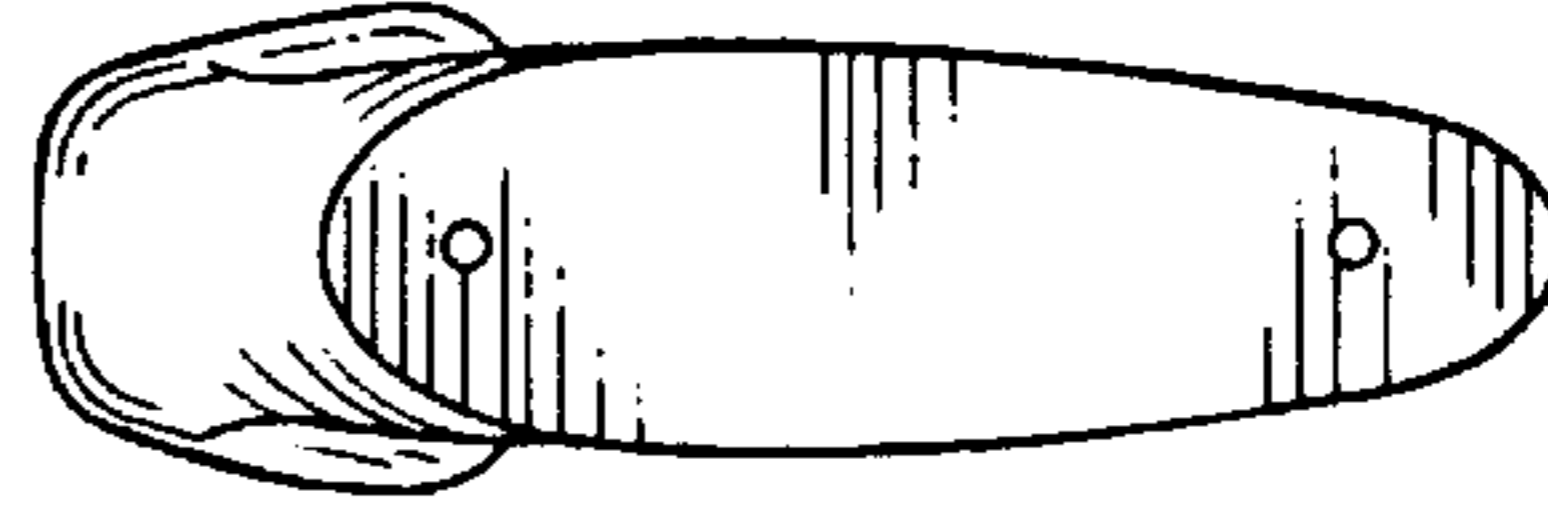

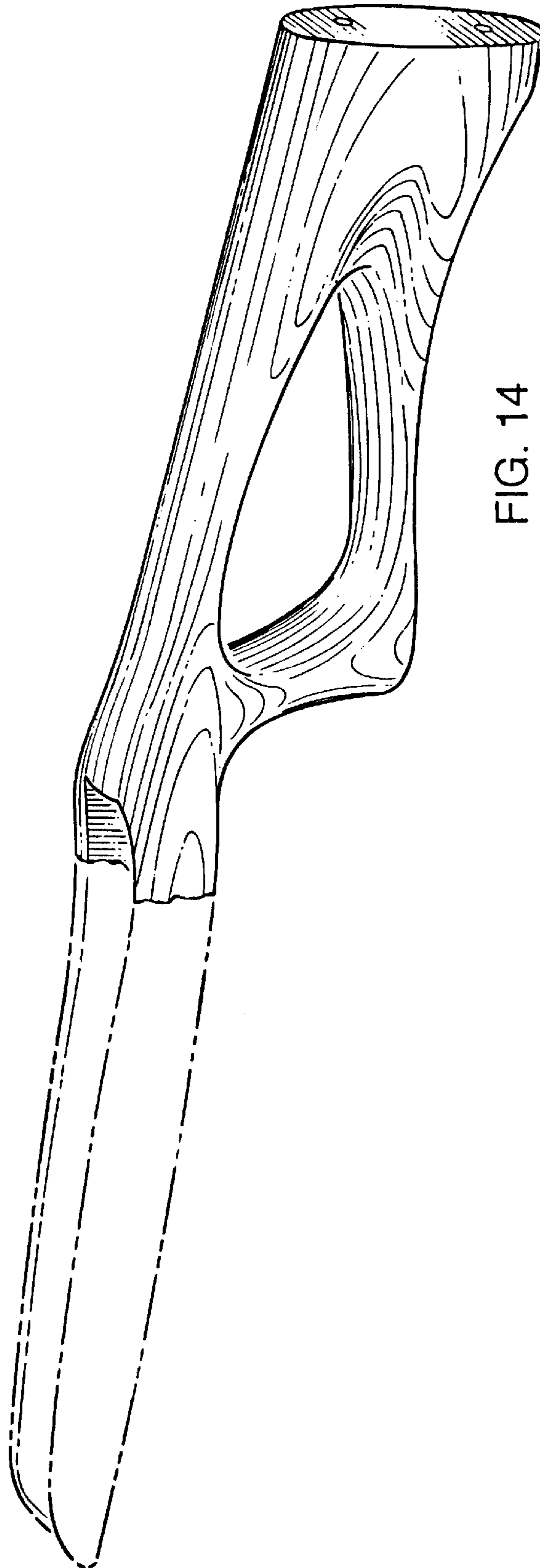
