(57) **CLAIM**

The ornamental design of a portable spa platform, as shown.

**DESCRIPTION**

FIG. 1 is a top plan view of my portable spa platform showing my new design, wherein the platform is made up of two half-platforms joined by a tape hinge (cross-hatched area) along the joint on the top surface between the two half-platforms;

FIG. 2 is a bottom plan view of the portable spa platform shown in FIG. 1

FIG. 3 is a perspective view of the portable spa platform shown in FIG. 1

FIG. 4 is a front side view of another embodiment of the platform showing one embodiment of my design of rounded edges;

FIG. 5 is a front side view of another embodiment of the platform showing another embodiment of my design of beveled edges;

FIG. 6 is a front side view of another embodiment of the platform showing another embodiment of my design of half-beveled edges;

FIG. 7 is a front side view of the embodiment of the platform shown in FIG. 1 showing the vertical edges;

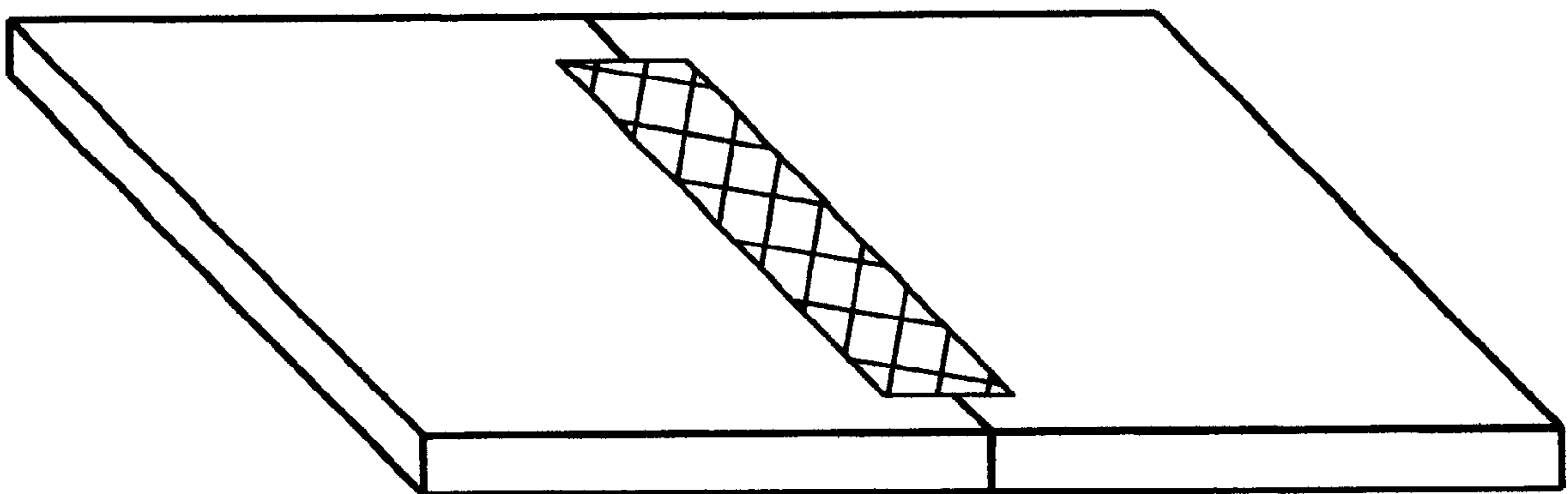
FIG. 8 is a side side view of the embodiment of the platform shown in FIG. 4;

FIG. 9 is a side side view of the embodiment of the platform shown in FIG. 5;

FIG. 10 is a side side view of the embodiment of the platform shown in FIG. 6; and,

FIG. 11 is a side side view of the embodiment of the platform shown in FIG. 7.

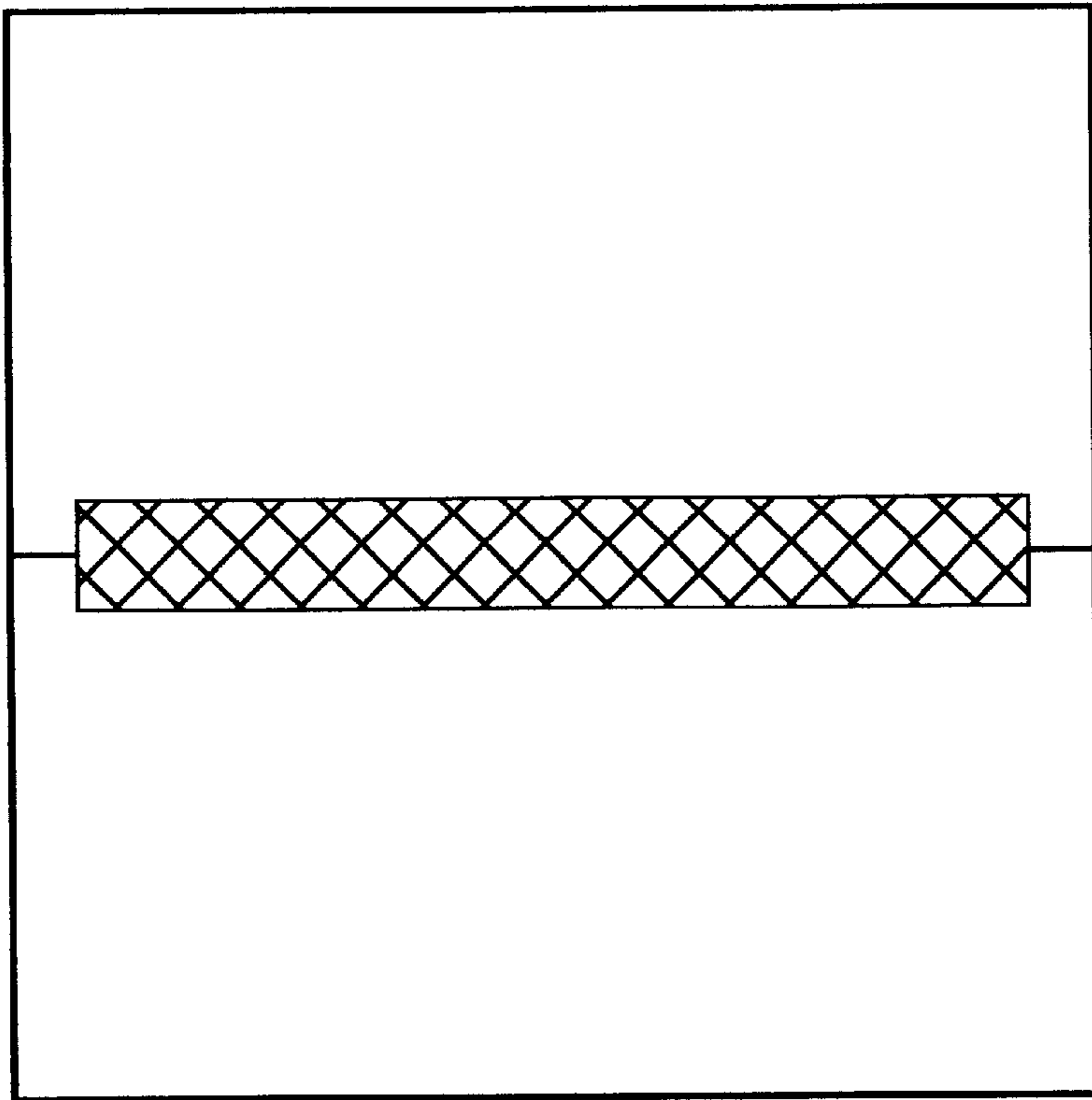

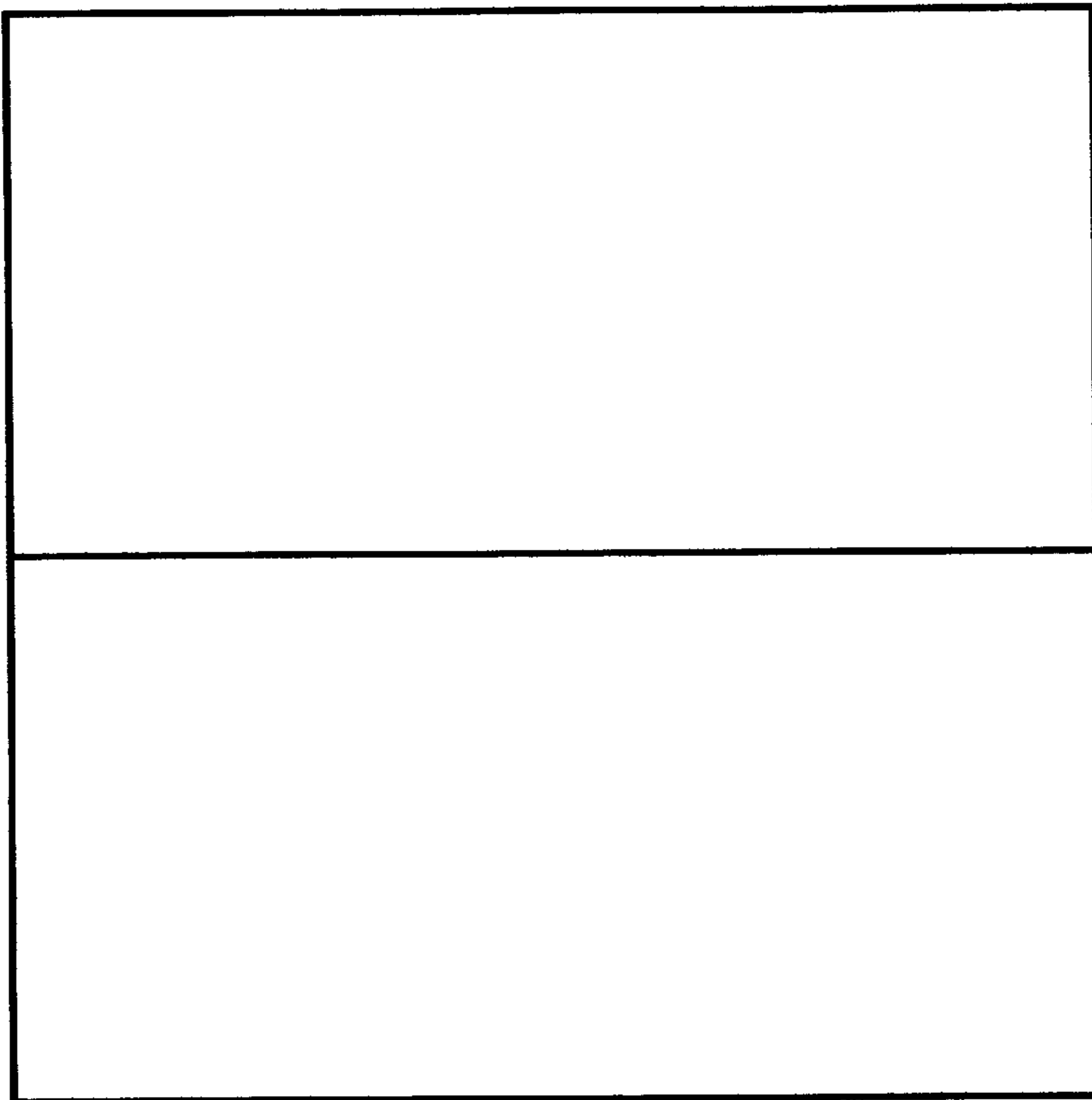

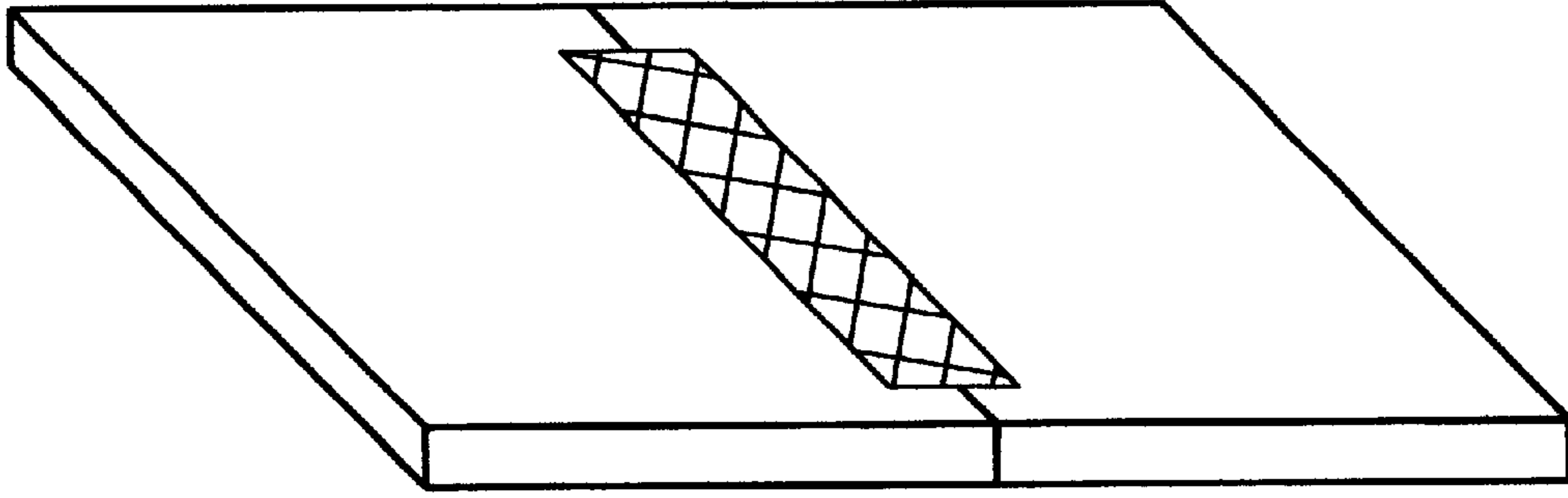

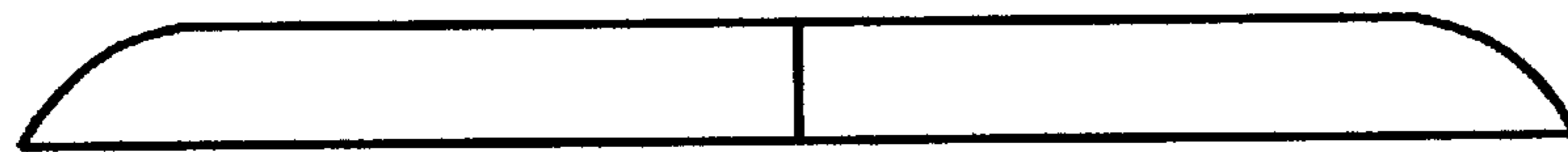
