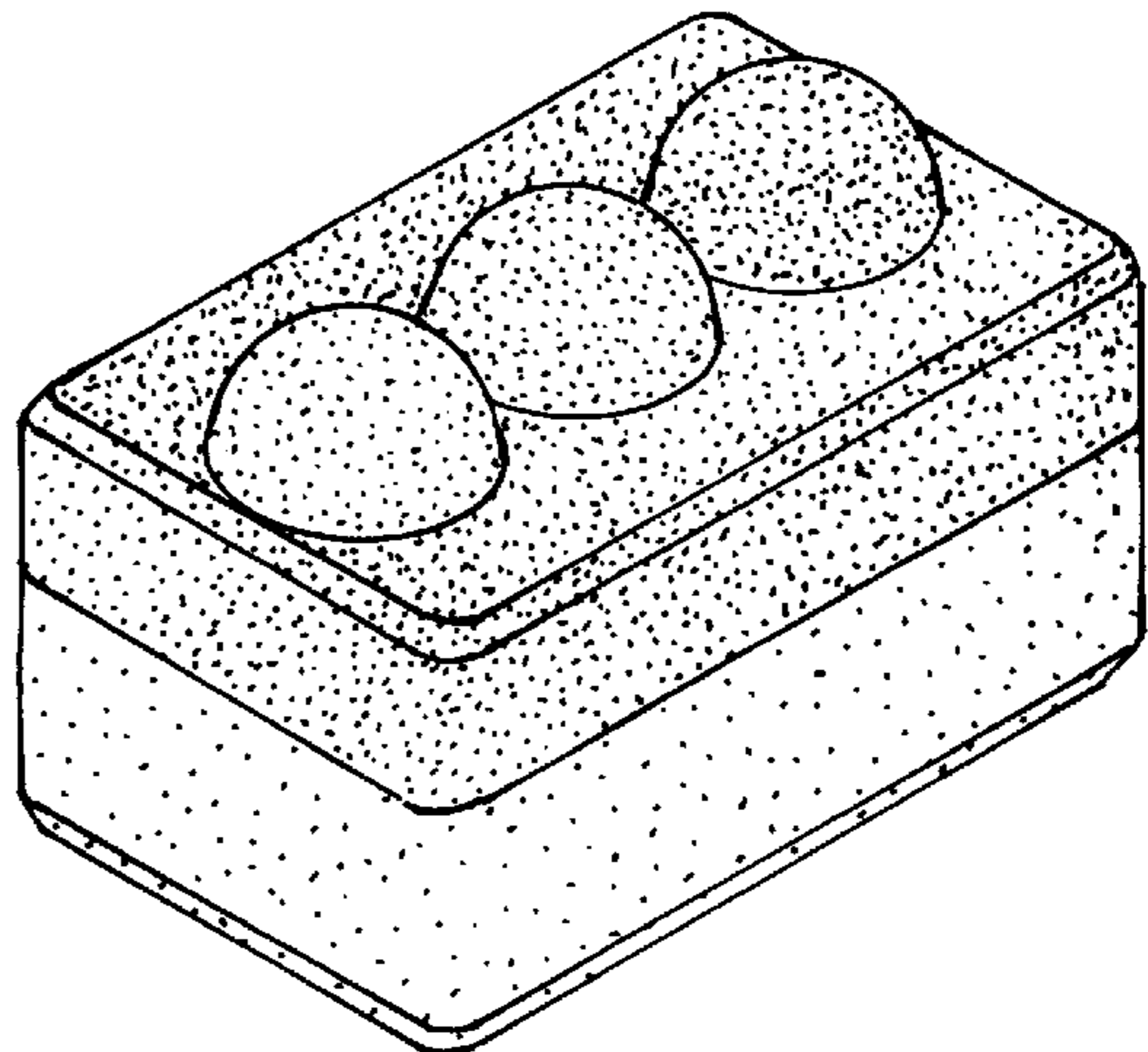
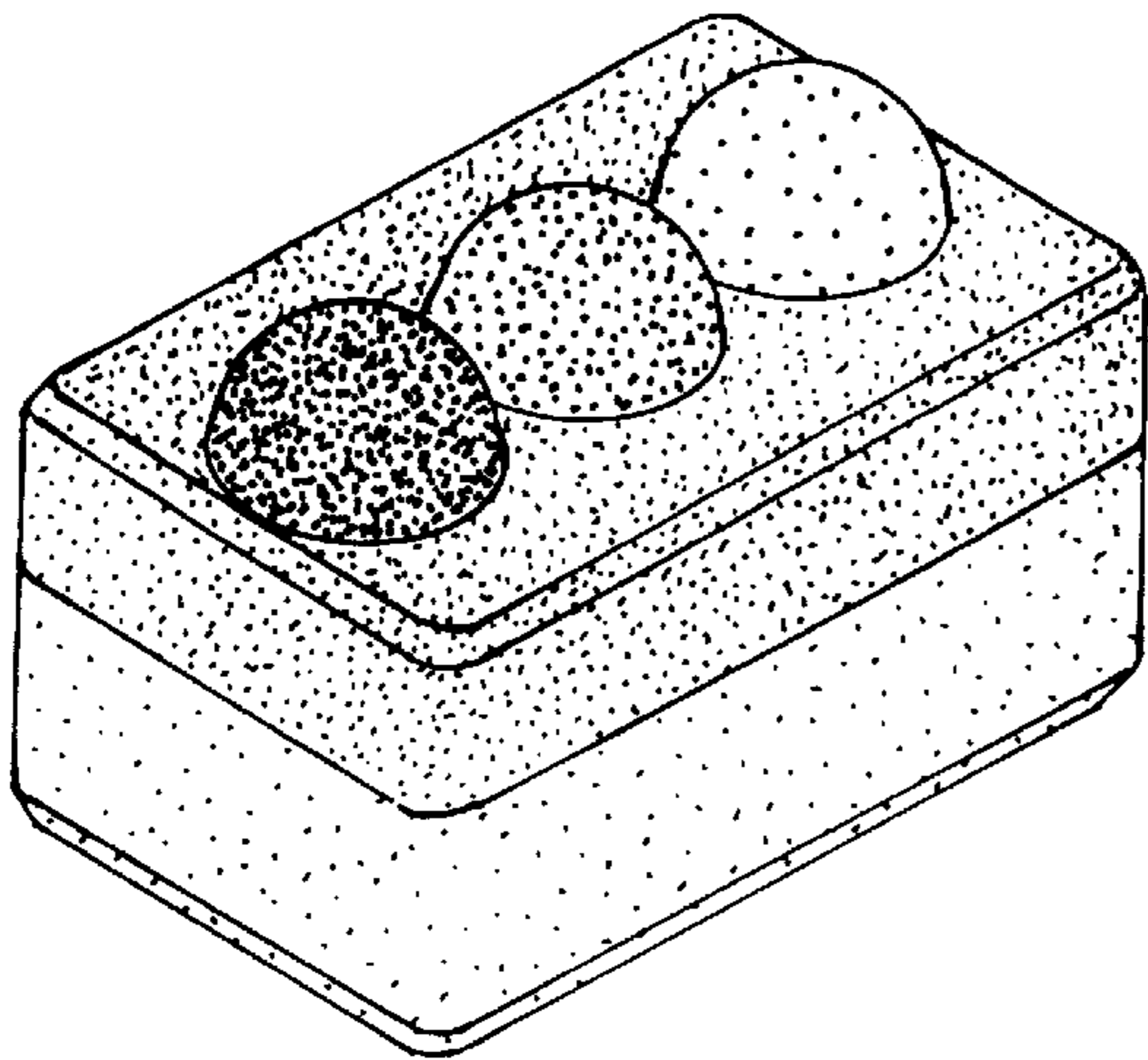
(57) **CLAIM**

The ornamental design for a detergent tablet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the detergent tablet showing my new design; FIG. 2 is a top plan view of the tablet shown in FIG. 1; FIG. 3 is a side elevational view of the tablet shown in FIG. 1; FIG. 4 is a left end elevational view of the tablet shown in FIG. 1; FIG. 5 is a right end elevational view of the tablet shown in FIG. 1; FIG. 6 is a bottom view of the tablet shown in FIG. 1; and, FIG. 7 is a perspective view of a second embodiment of the detergent tablet showing my new design. The stippling in the drawings is representative of color contrast, not pattern. The surface(s) or portion(s) of the article not shown in the drawing or described in the specification form(s) no part of the claimed design.

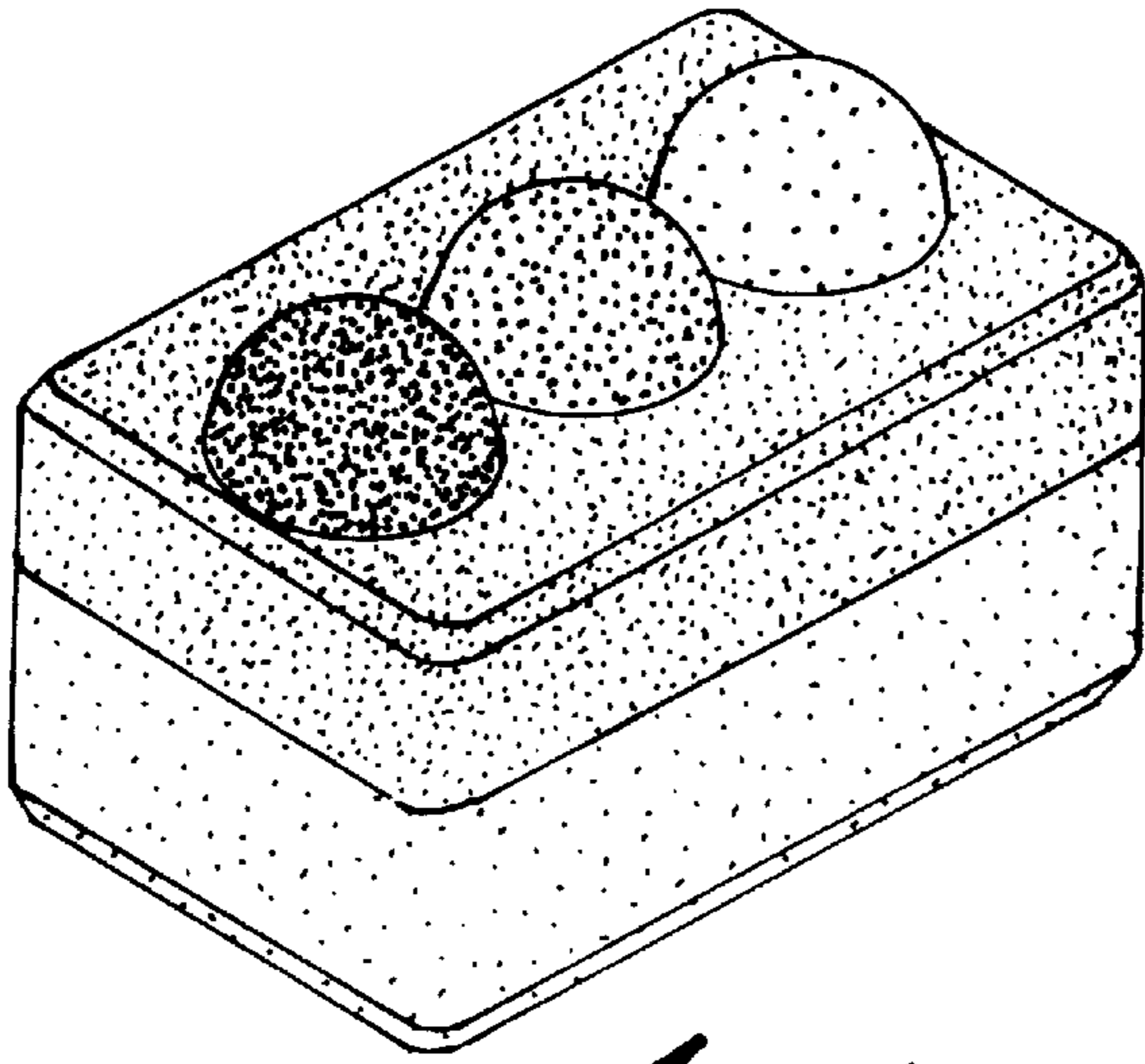

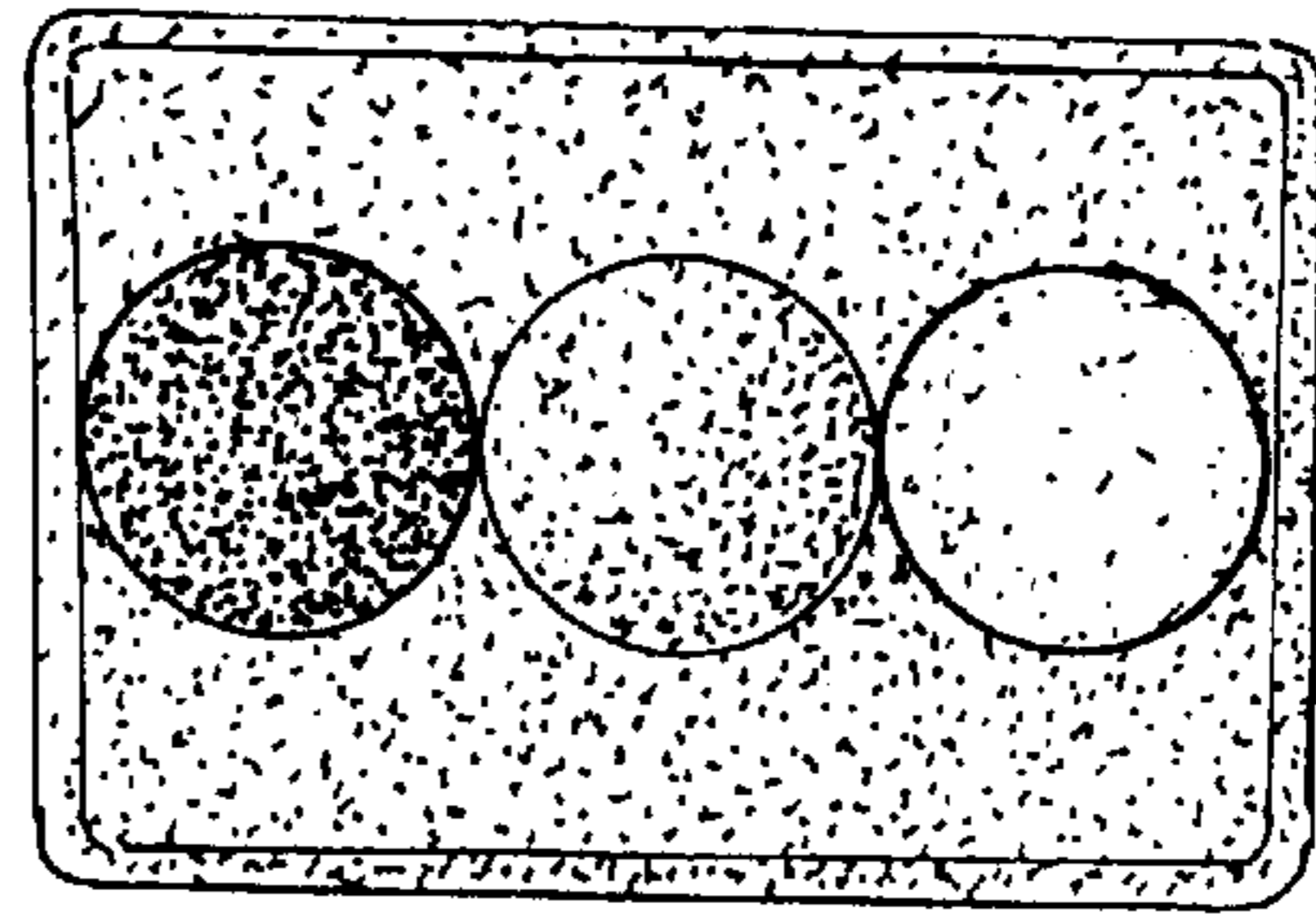

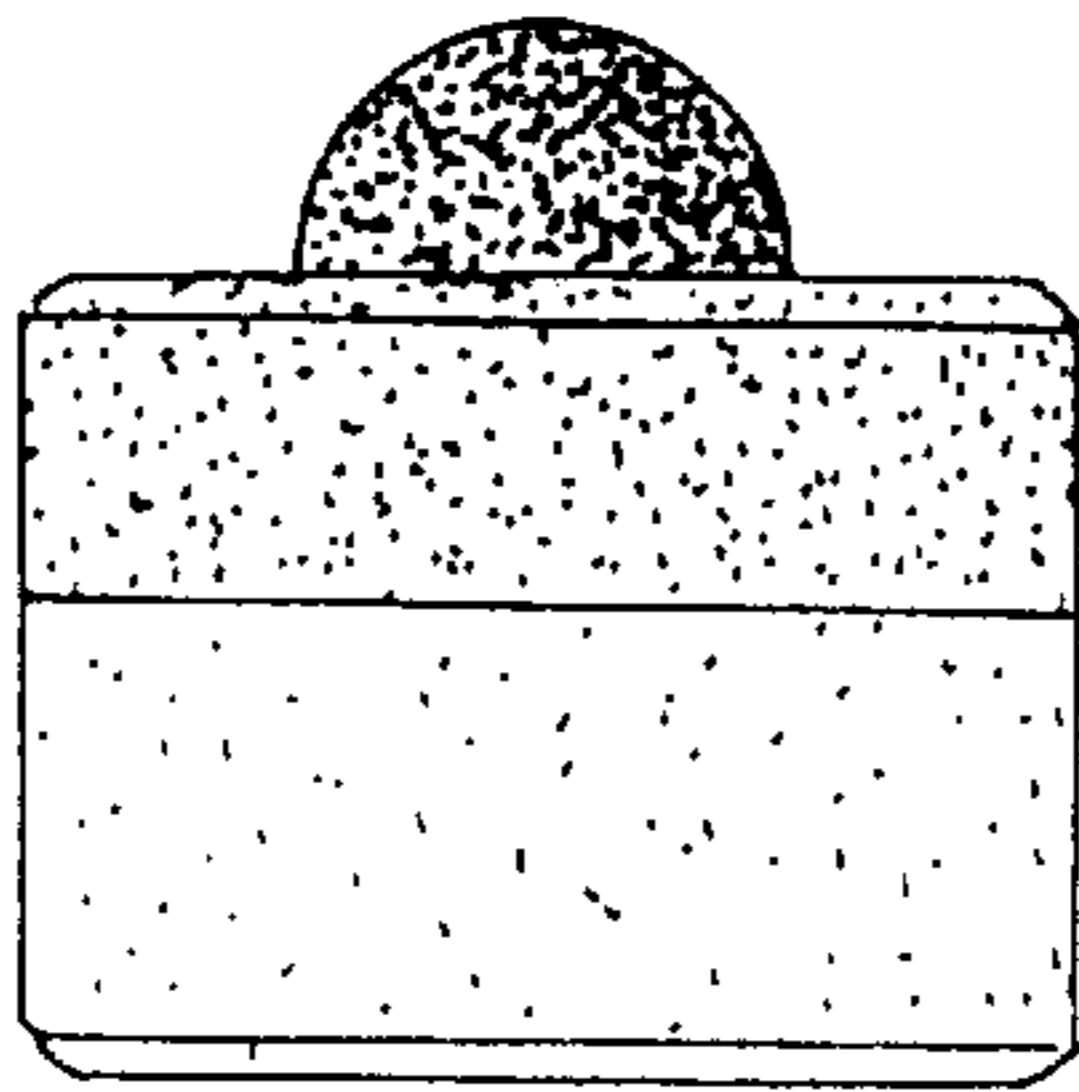

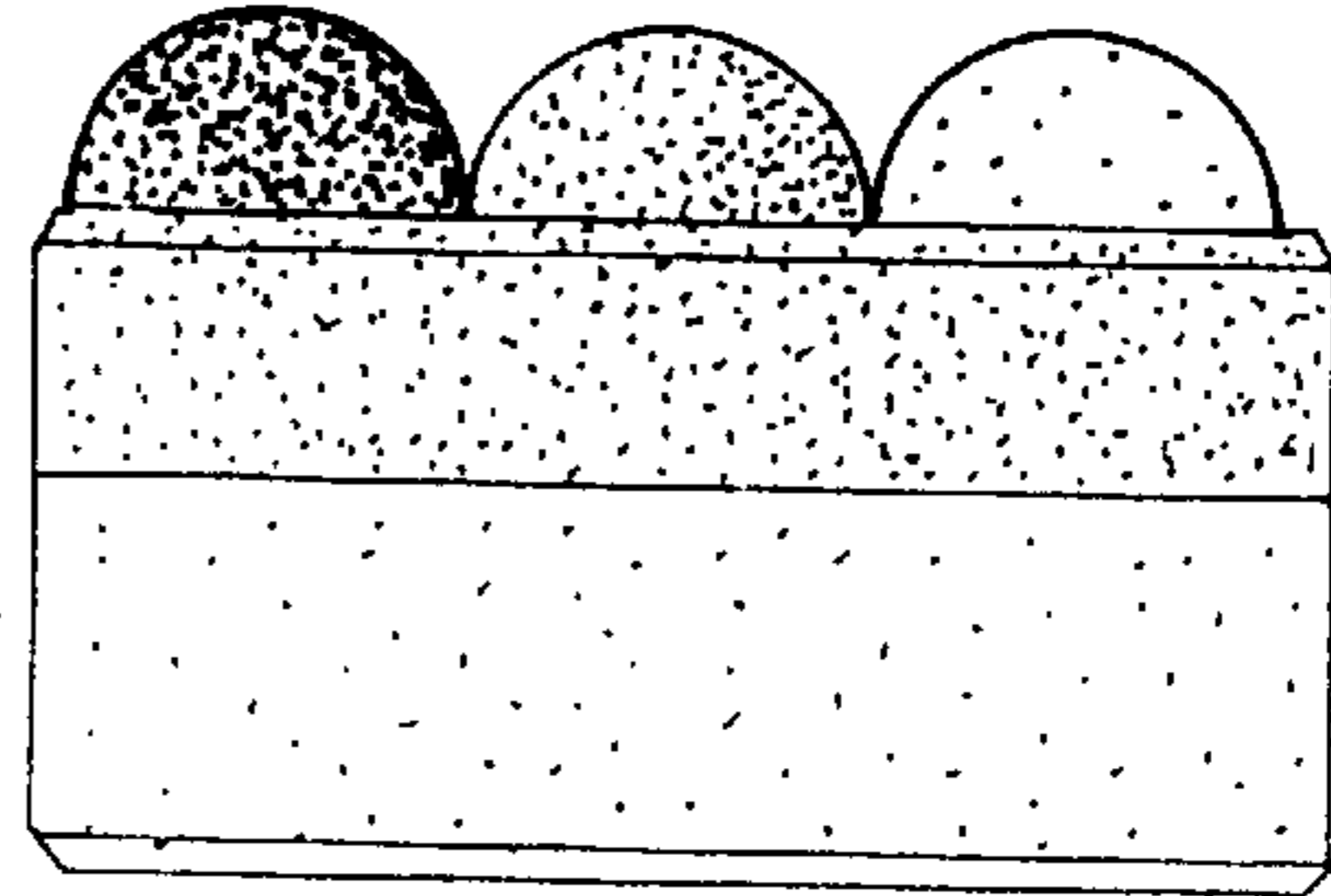

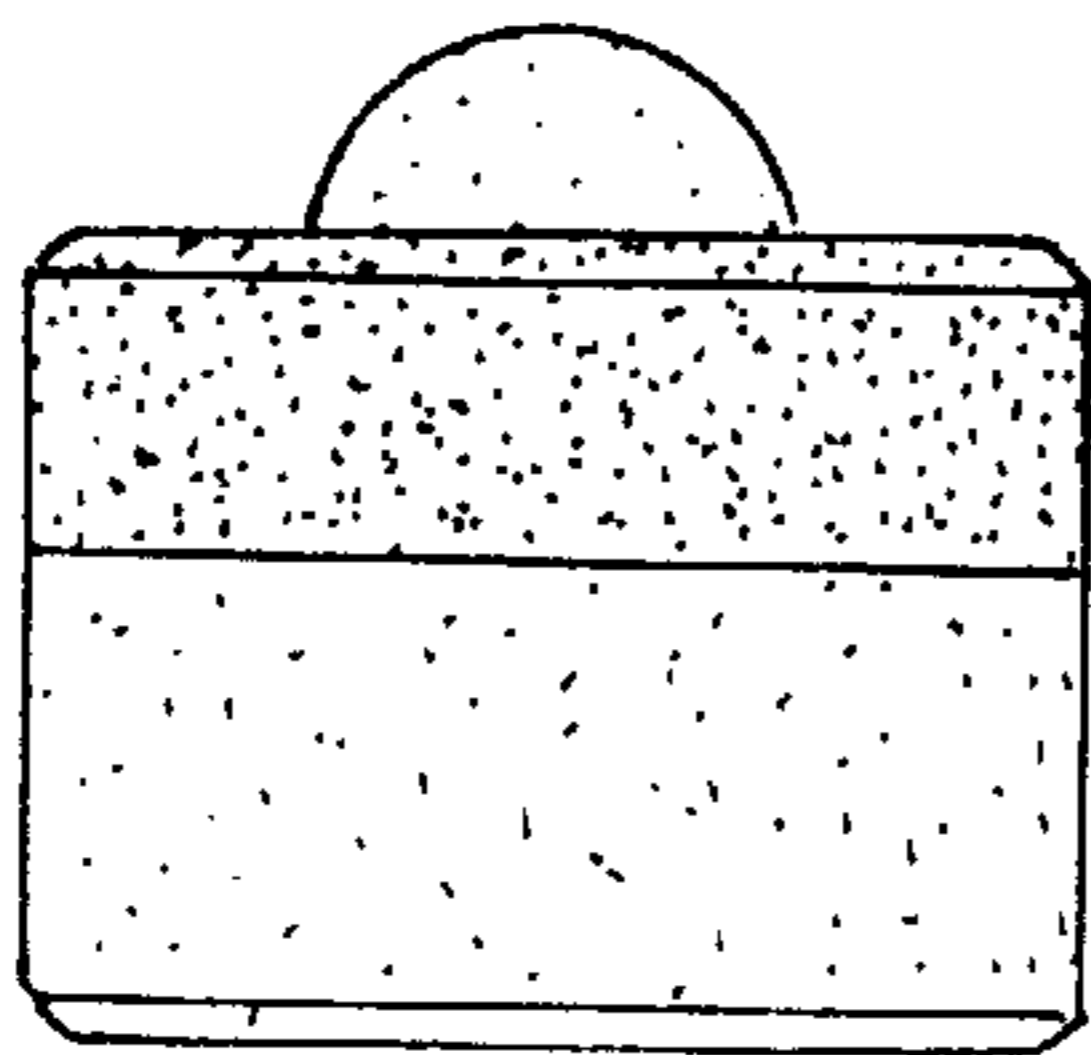

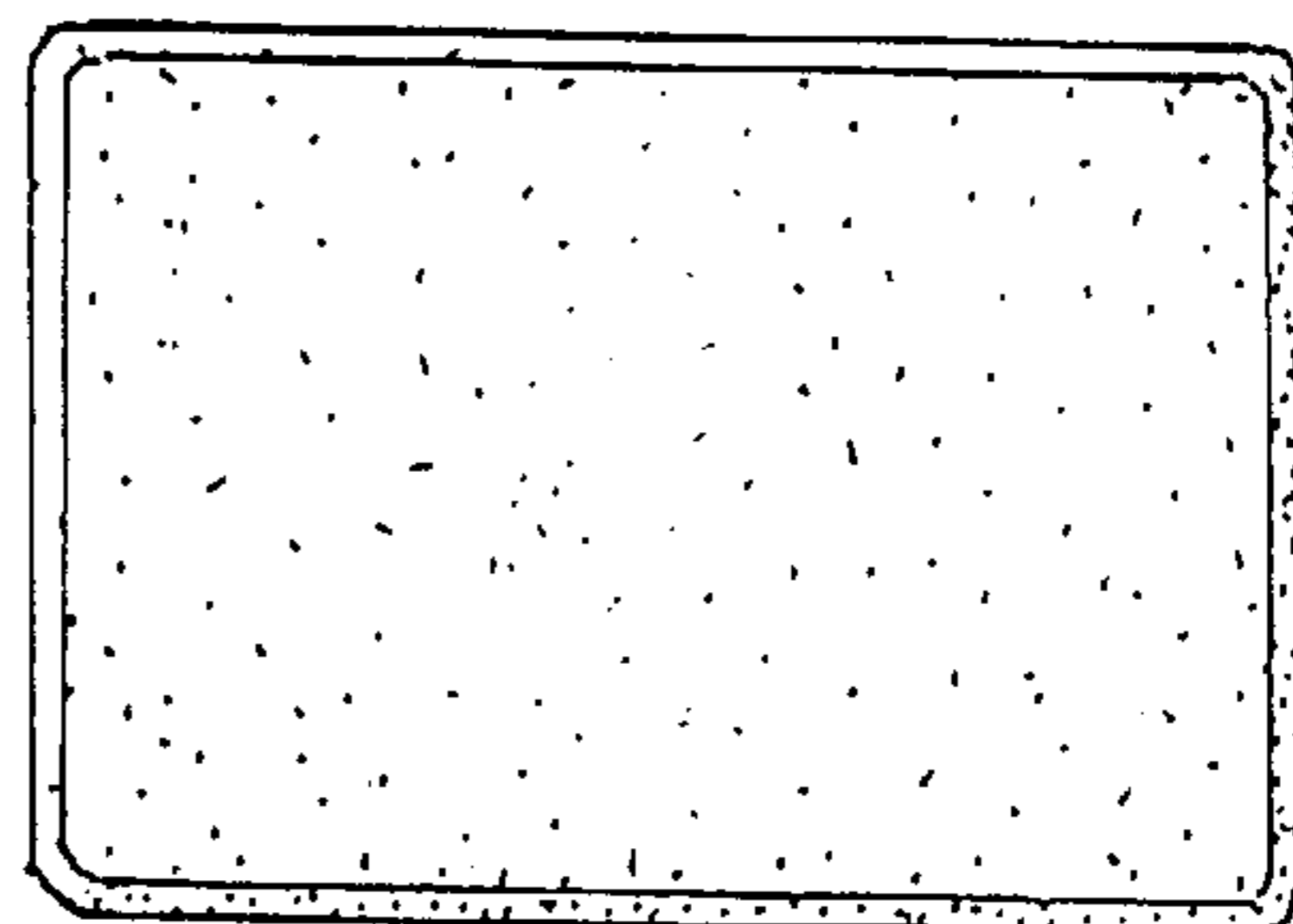

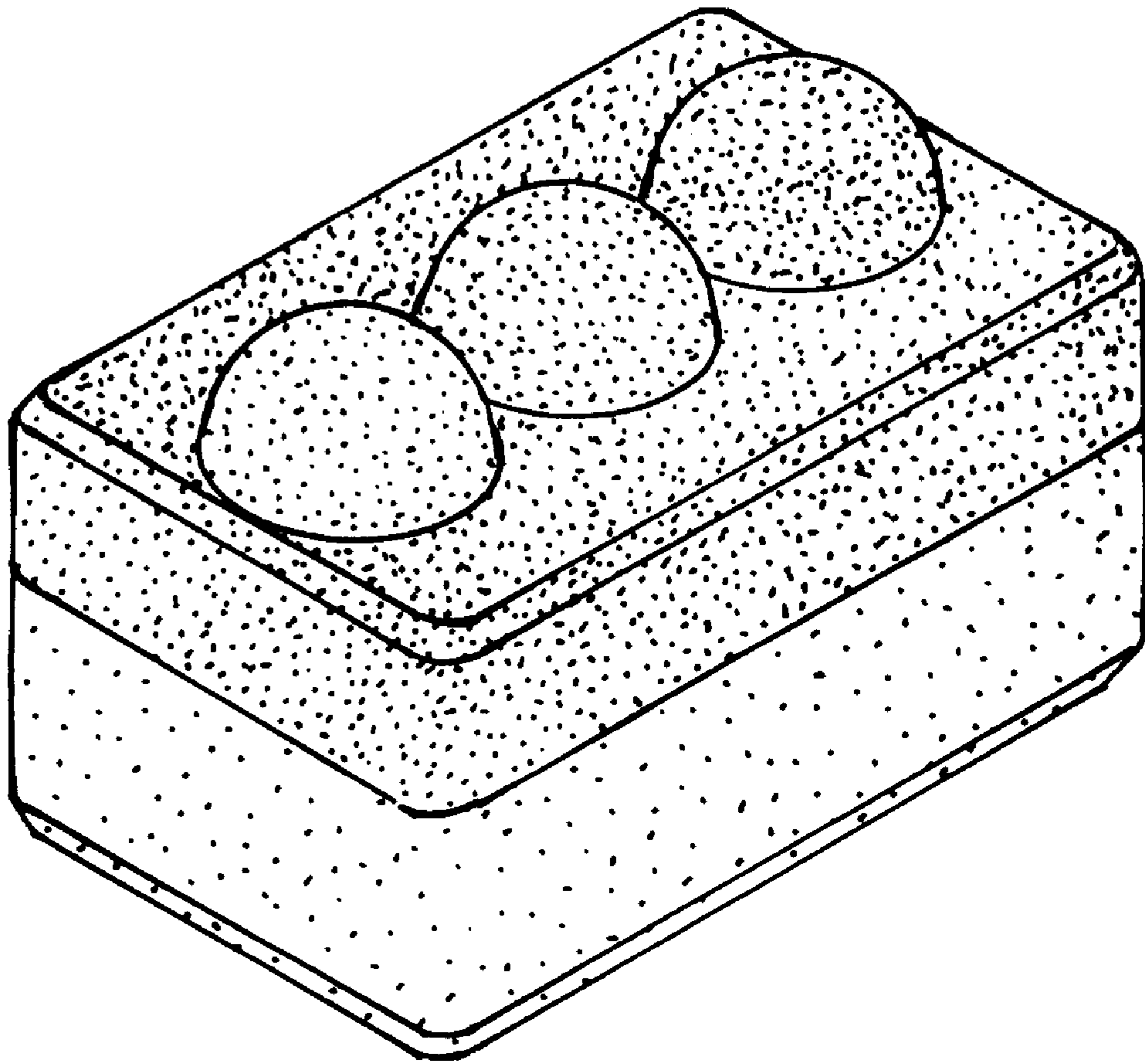
