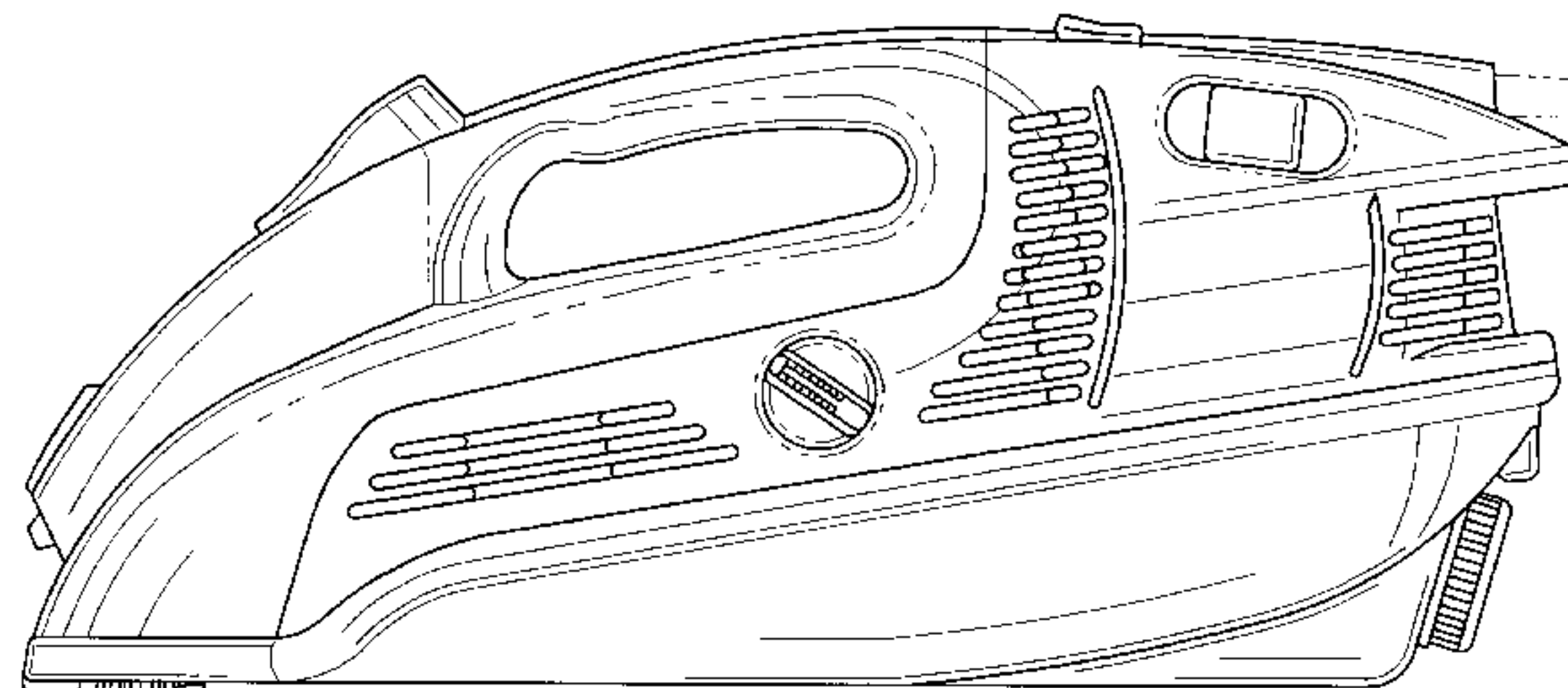
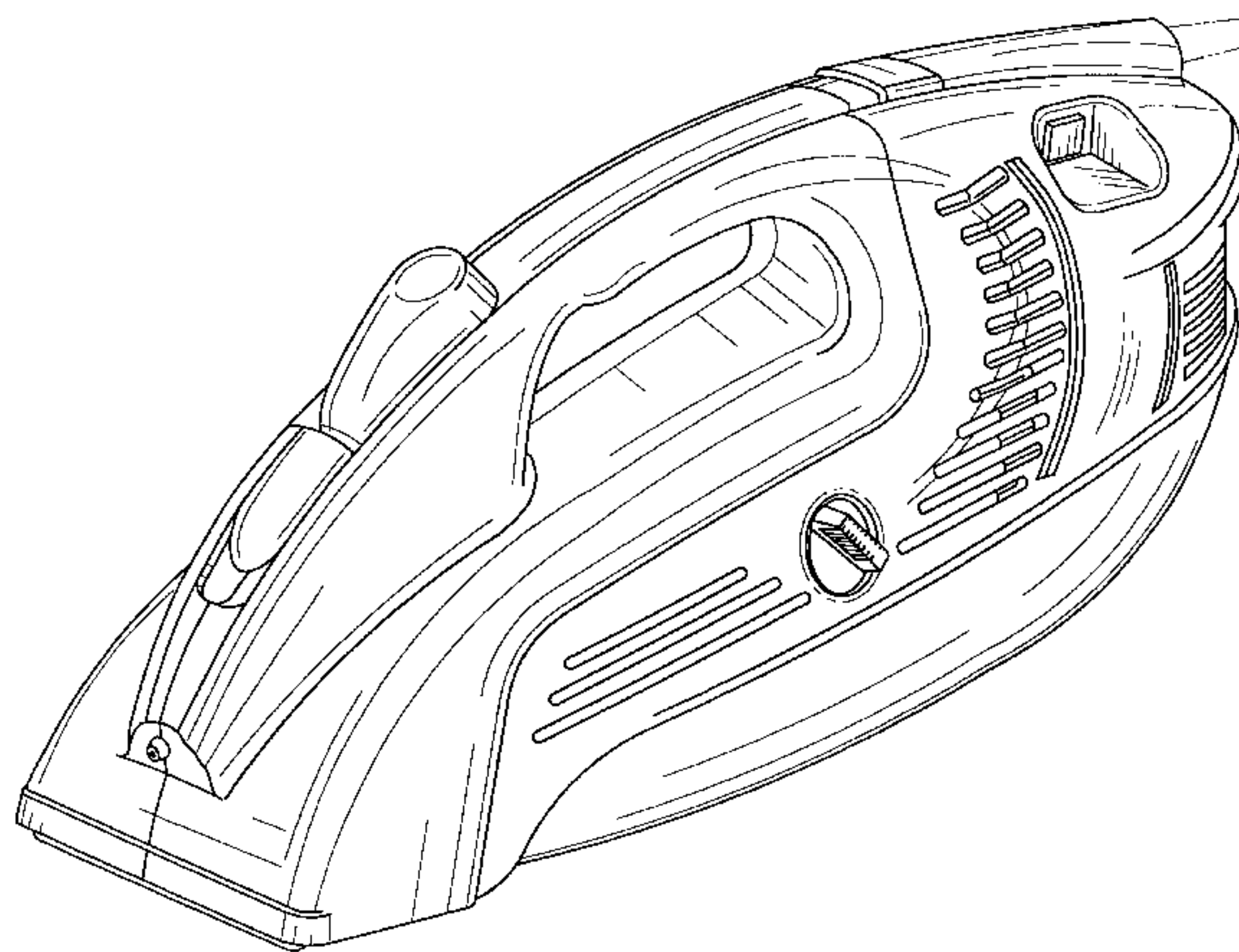
The ornamental design for a portable wet/dry vacuum cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the portable wet/dry vacuum cleaner showing our new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a rear elevational view thereof.

The power cord illustrated in broken lines in FIGS. 1-5 is shown merely to illustrate the environment of the vacuum cleaner and forms no part of the claimed design.

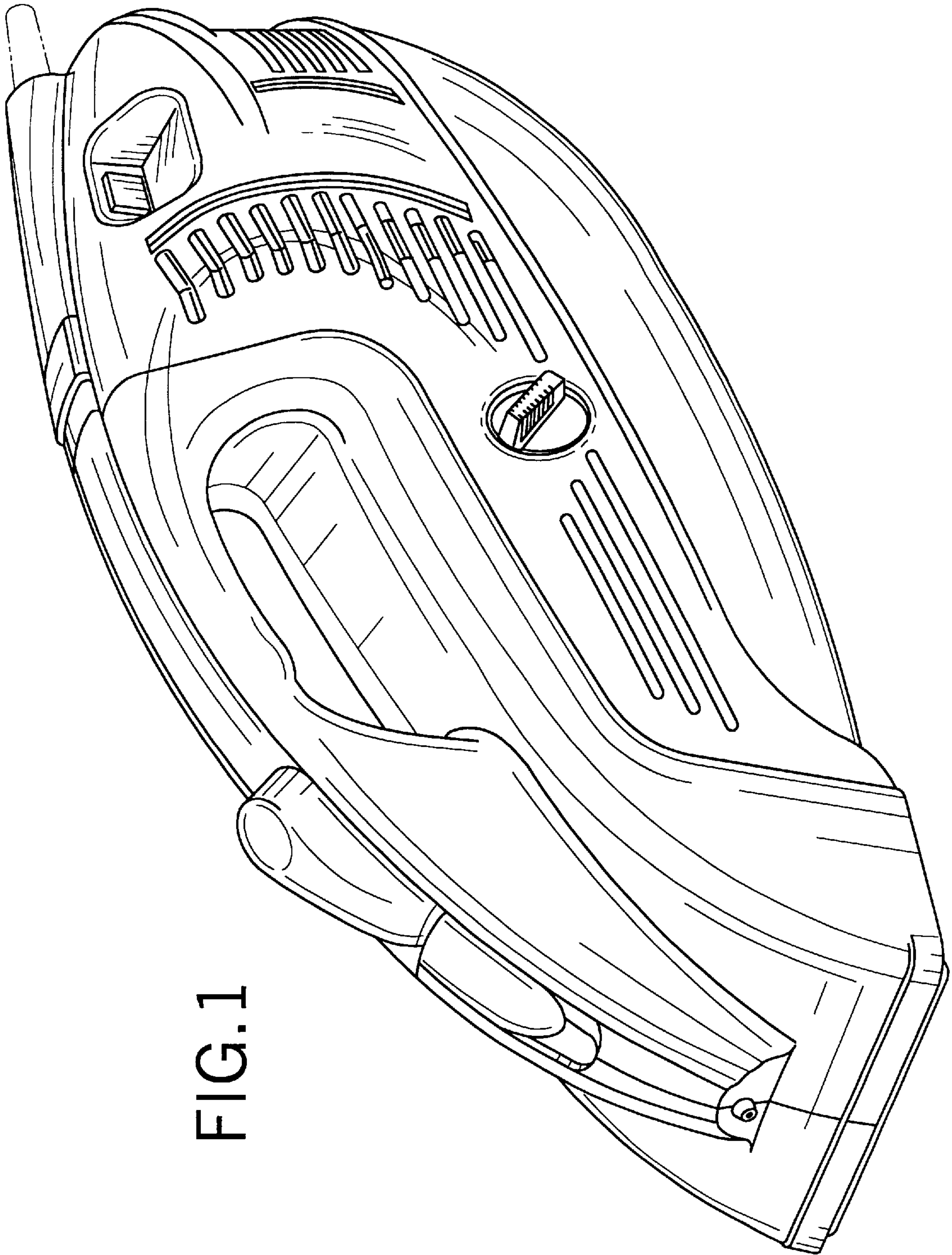

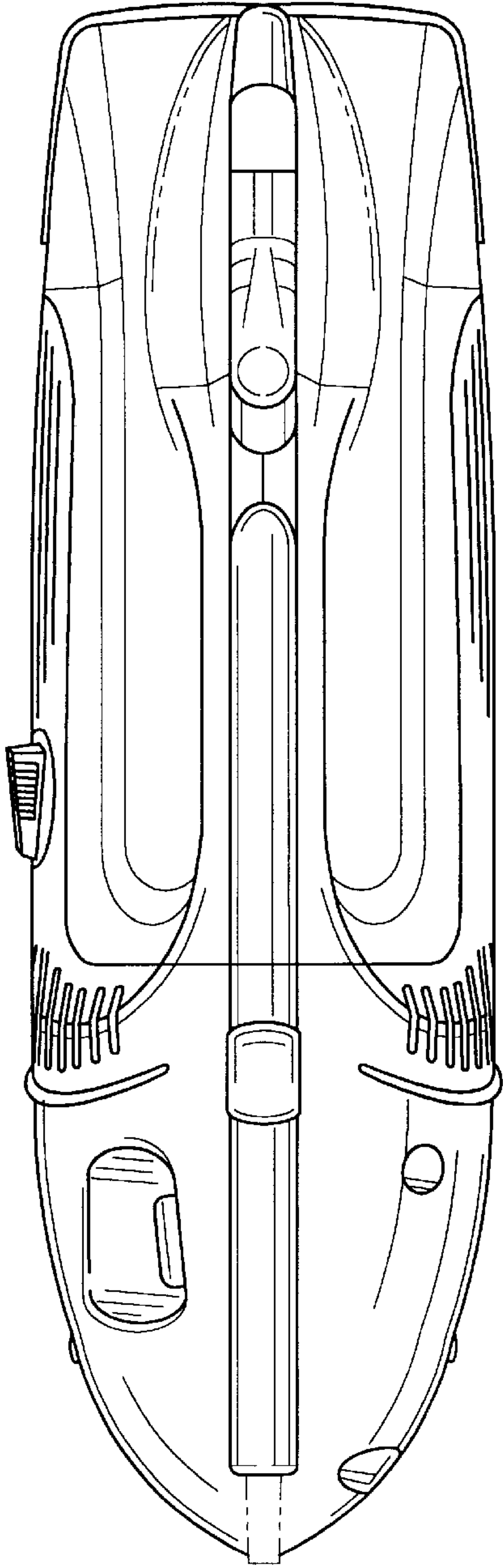

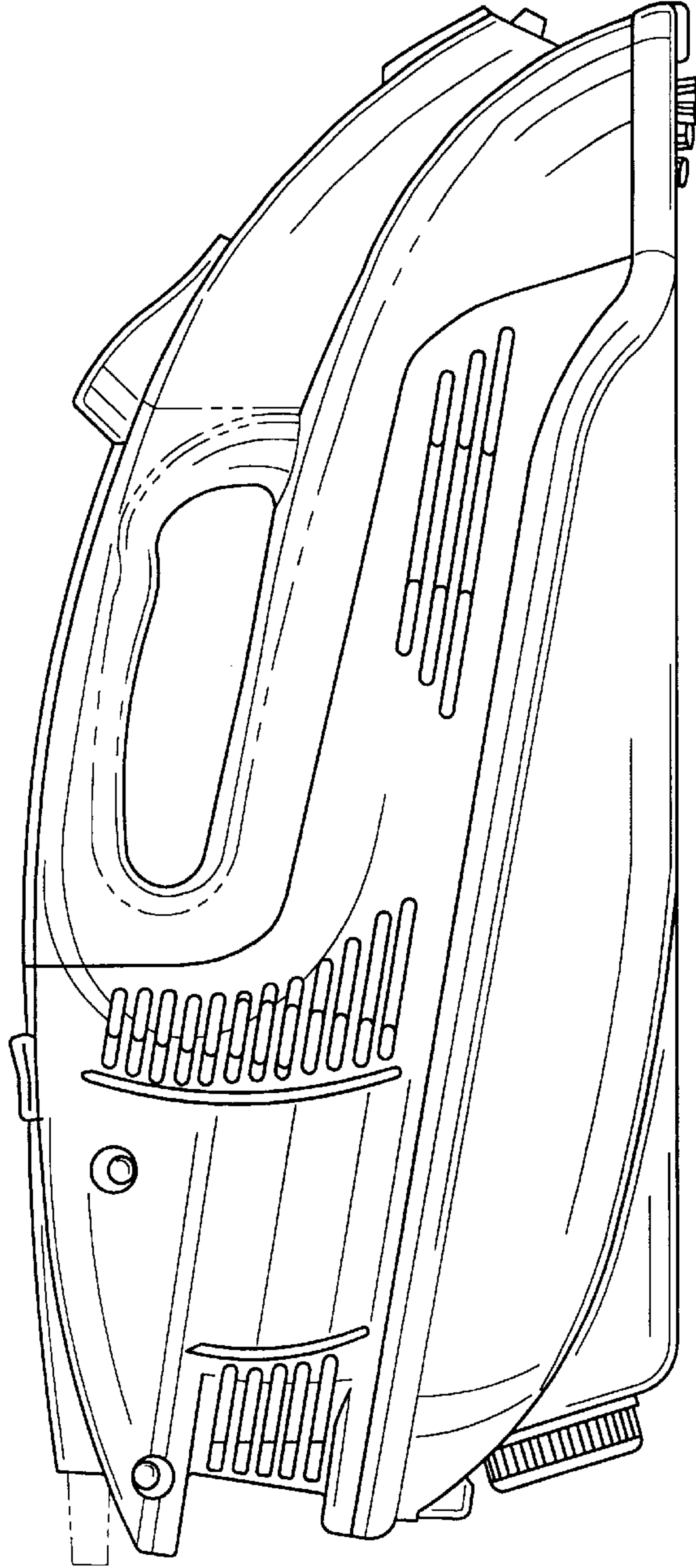

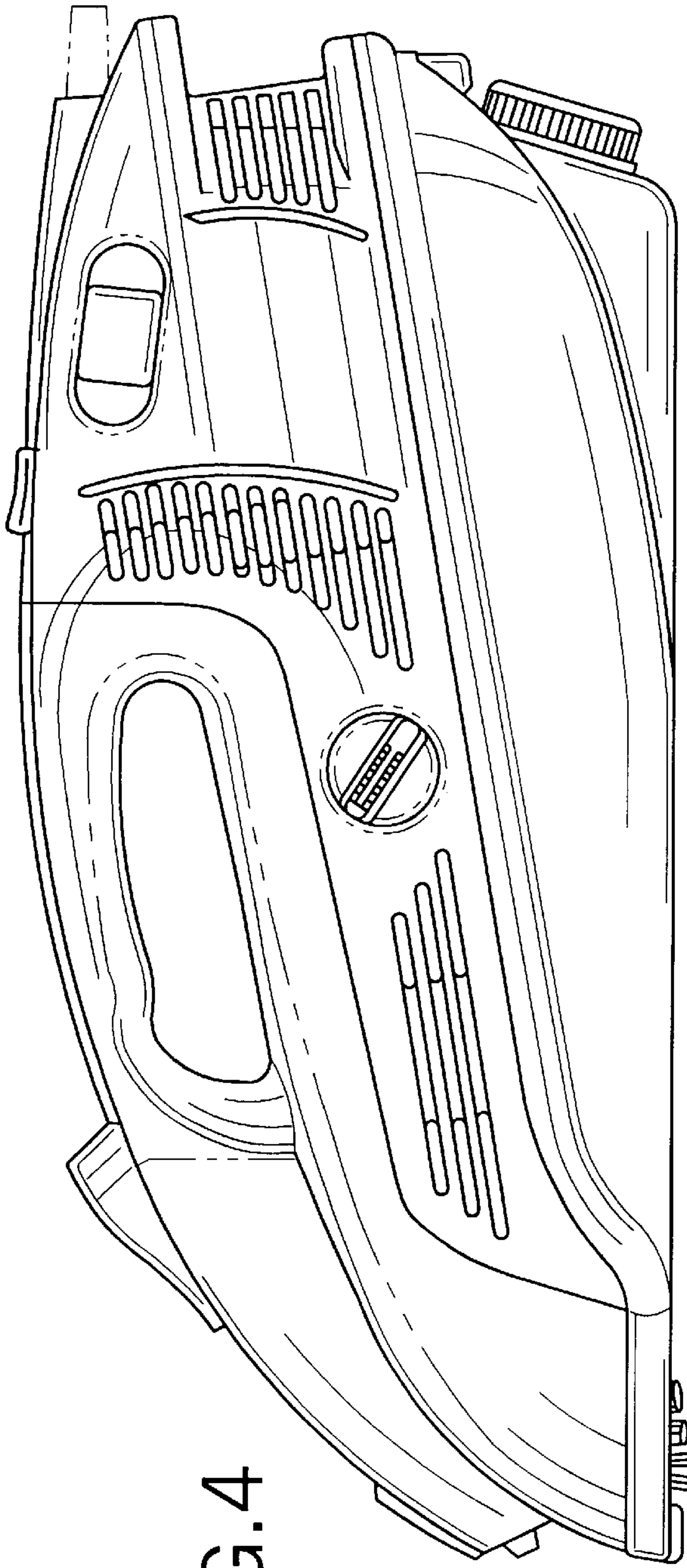

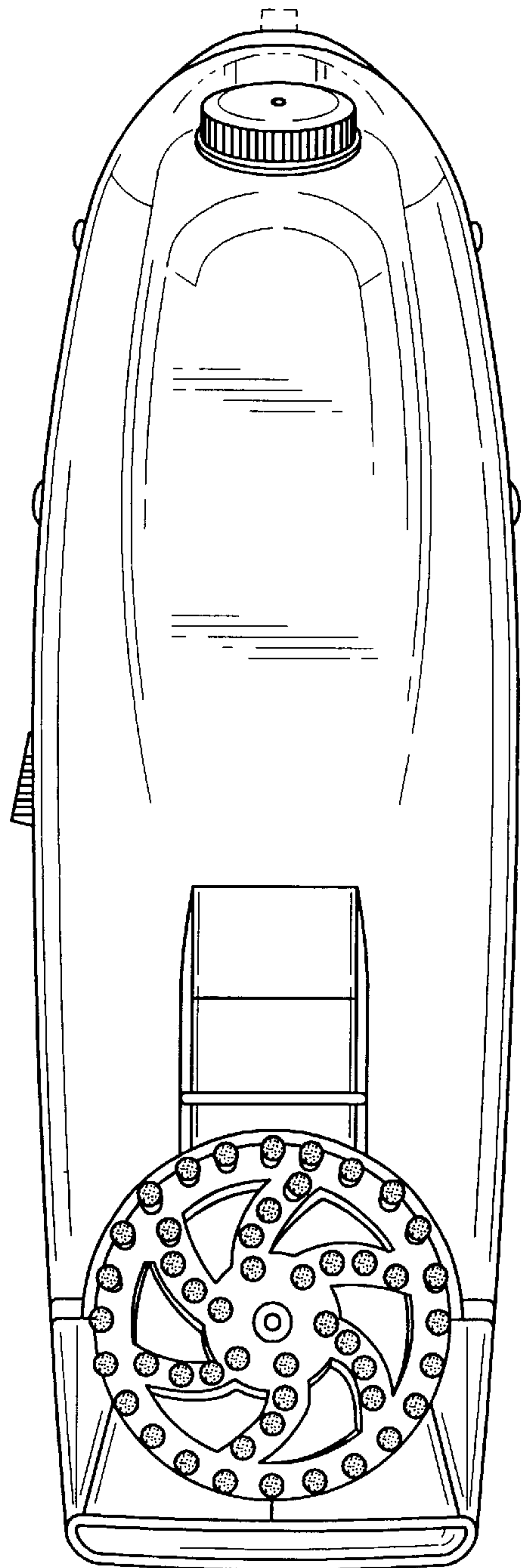

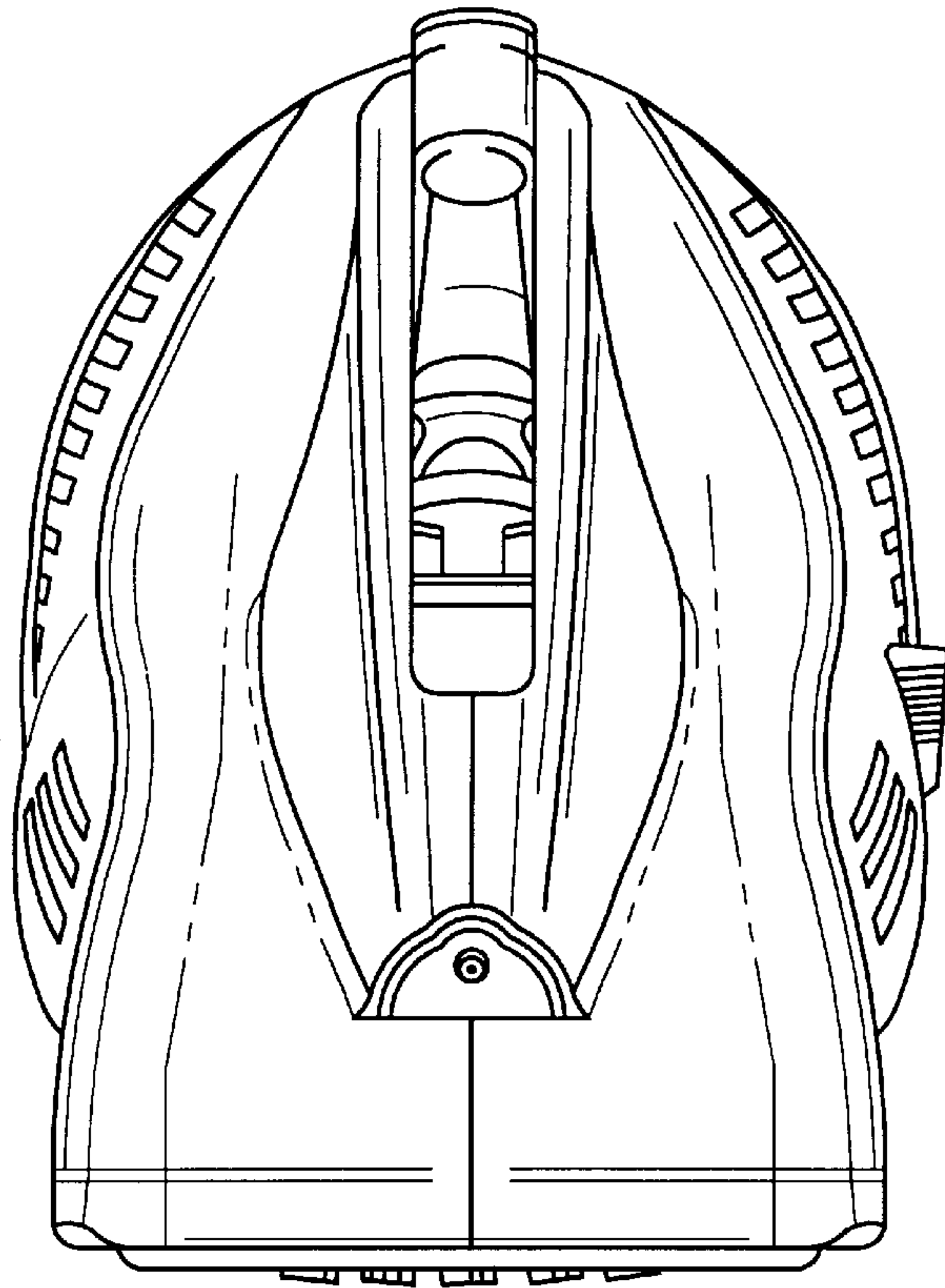
