(57) **CLAIM**

The ornamental design for a ceramic downdraft cooktop having integral, angled front face portion, as shown and described.

DESCRIPTION

FIG. 1 is a top right perspective view of a ceramic downdraft cooktop having integral, angled front face portion, showing my new design;

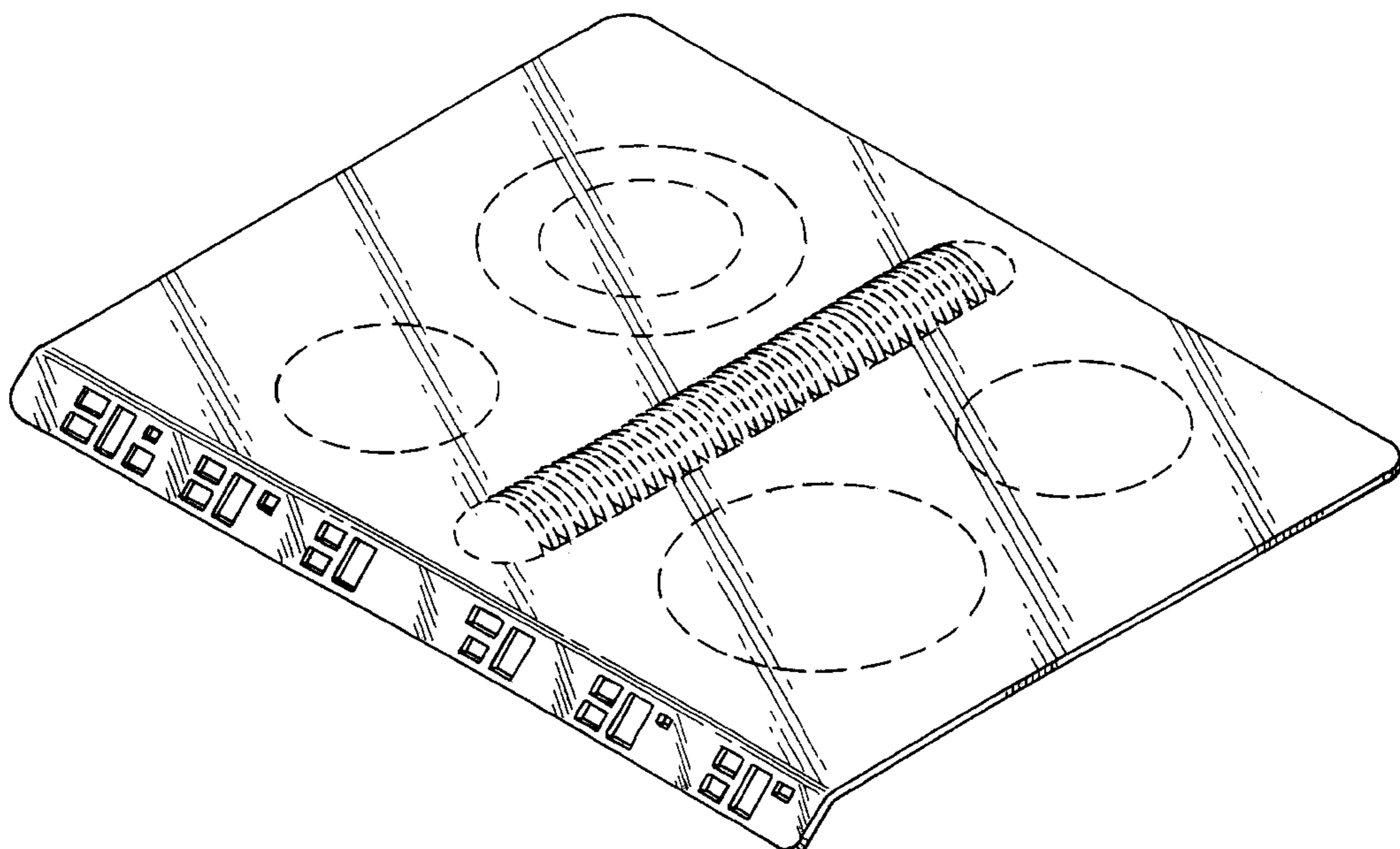
FIG. 2 is a top plan view of the cooktop of the invention;

FIG. 3 is a left elevational view of the cooktop of FIGS. 1 and 2, with the right elevational view being a mirror image; and,

FIG. 4 is a rear elevational view of the cooktop.

The broken line showing of electric heating zones and a downdraft grill is for illustrative purposes only and forms no part of the claimed invention.

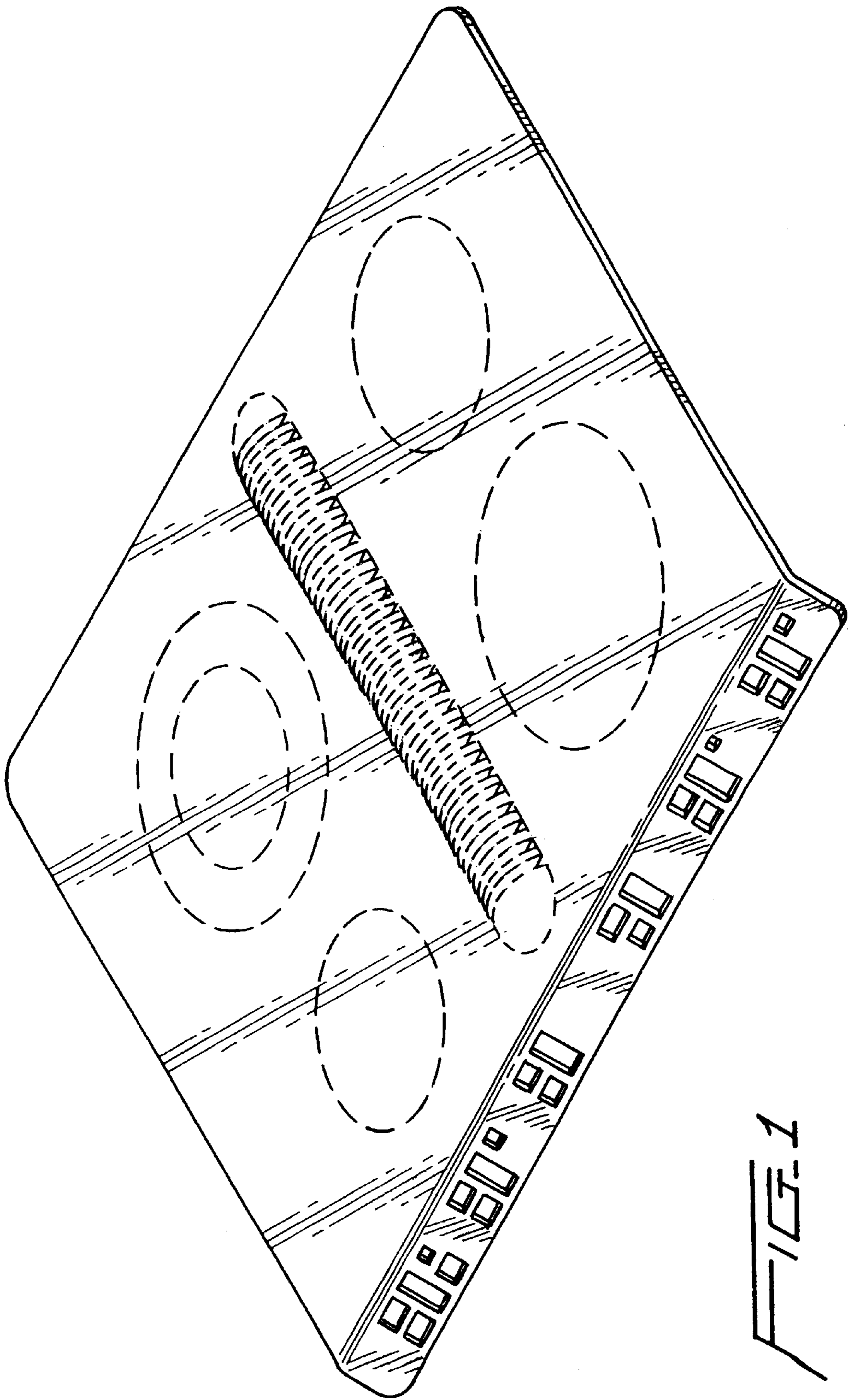

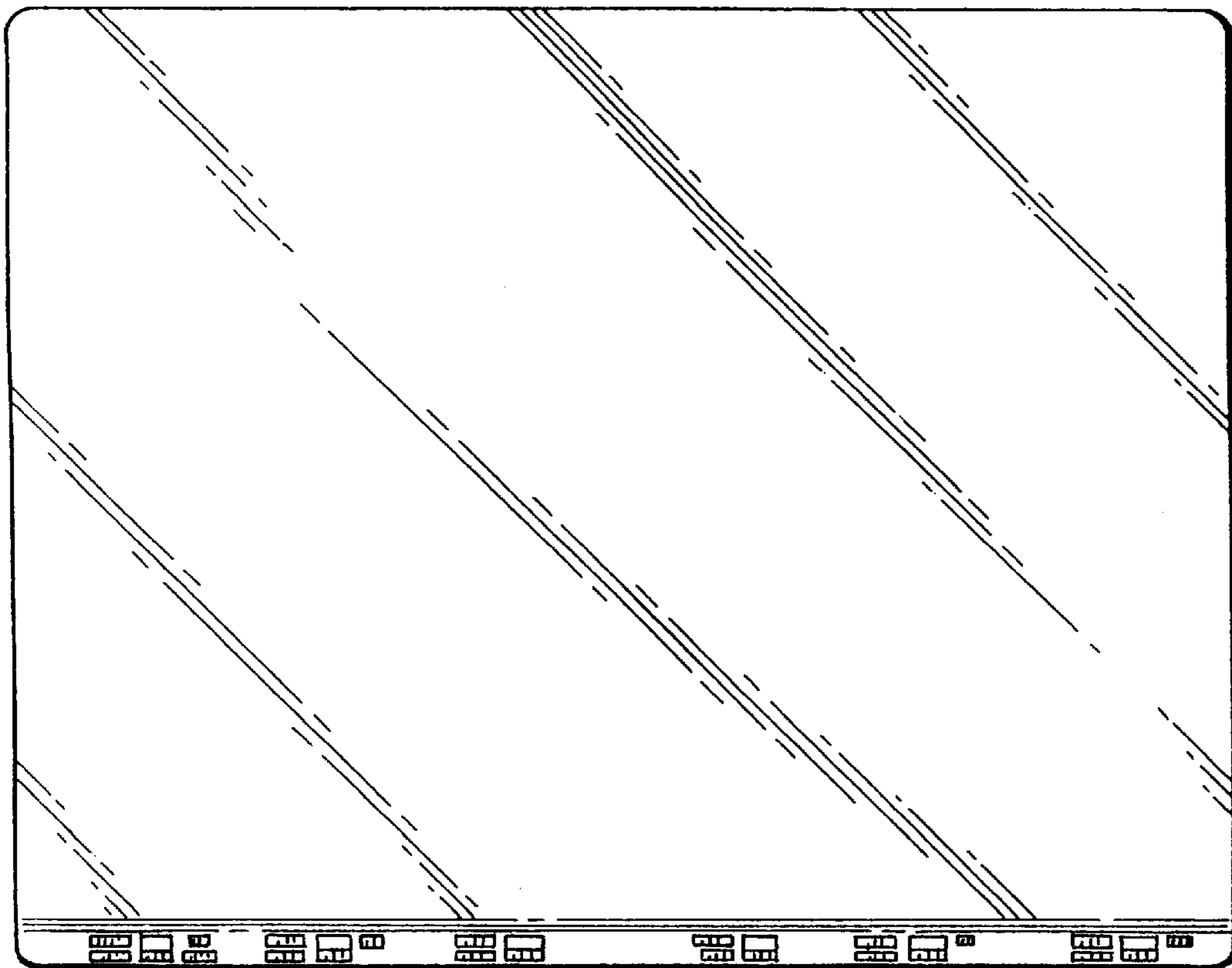

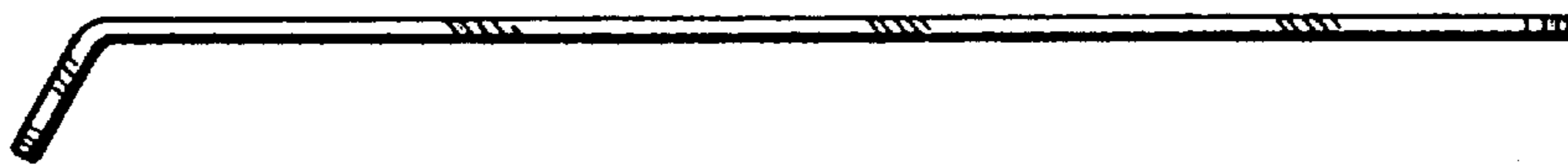
