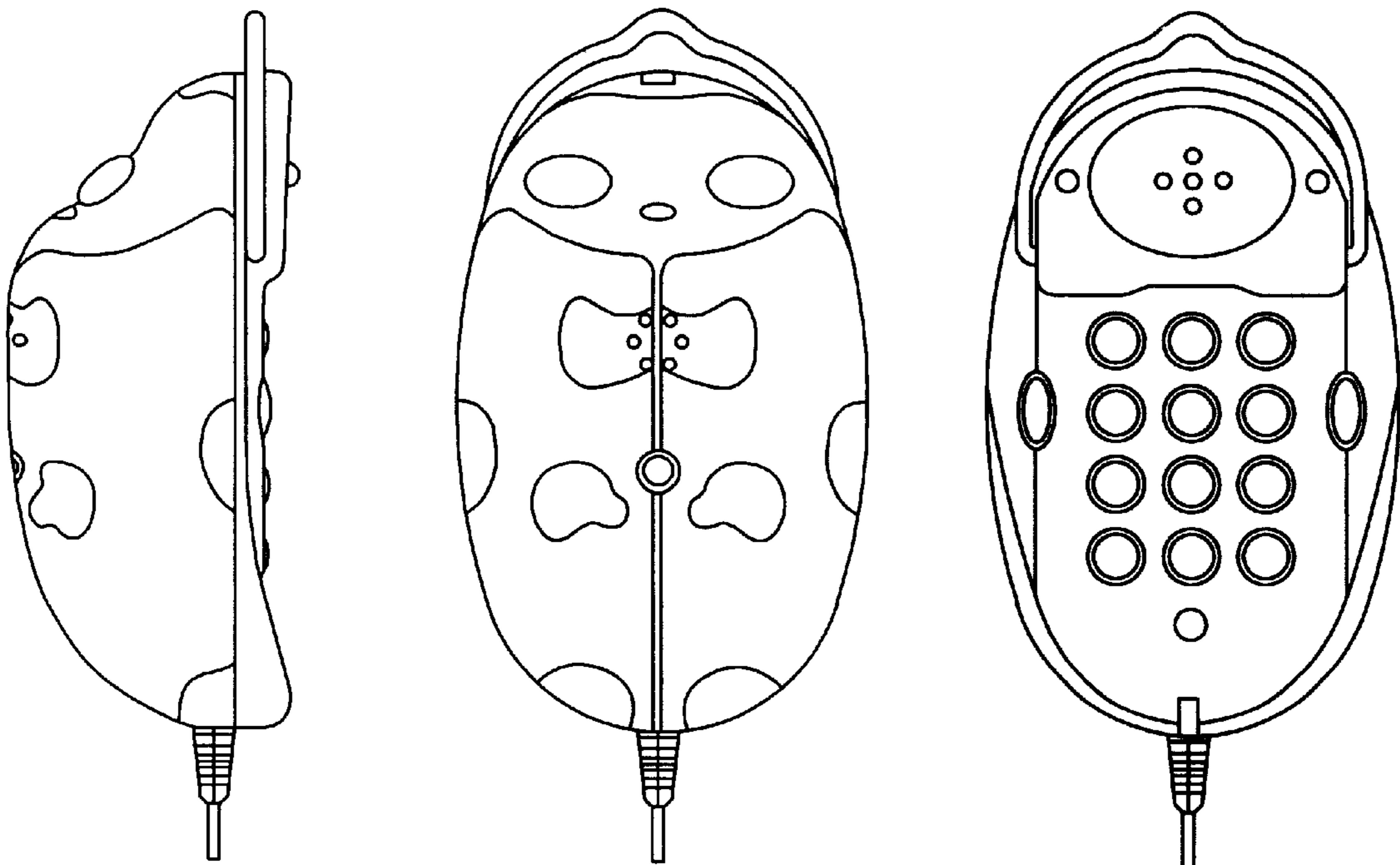

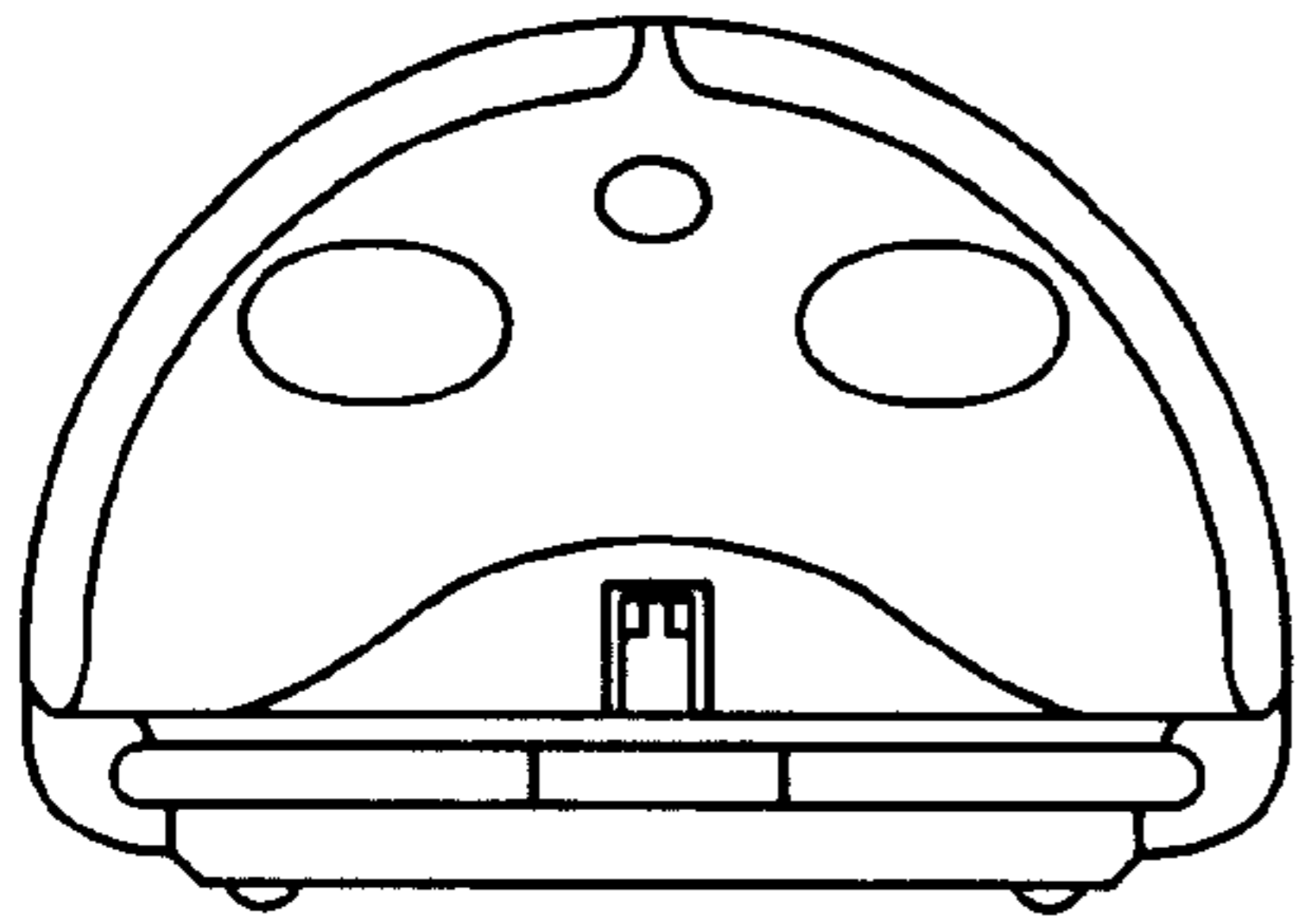
The ornamental design for a telephone for wire/wireless communication, as shown and described.

**DESCRIPTION**

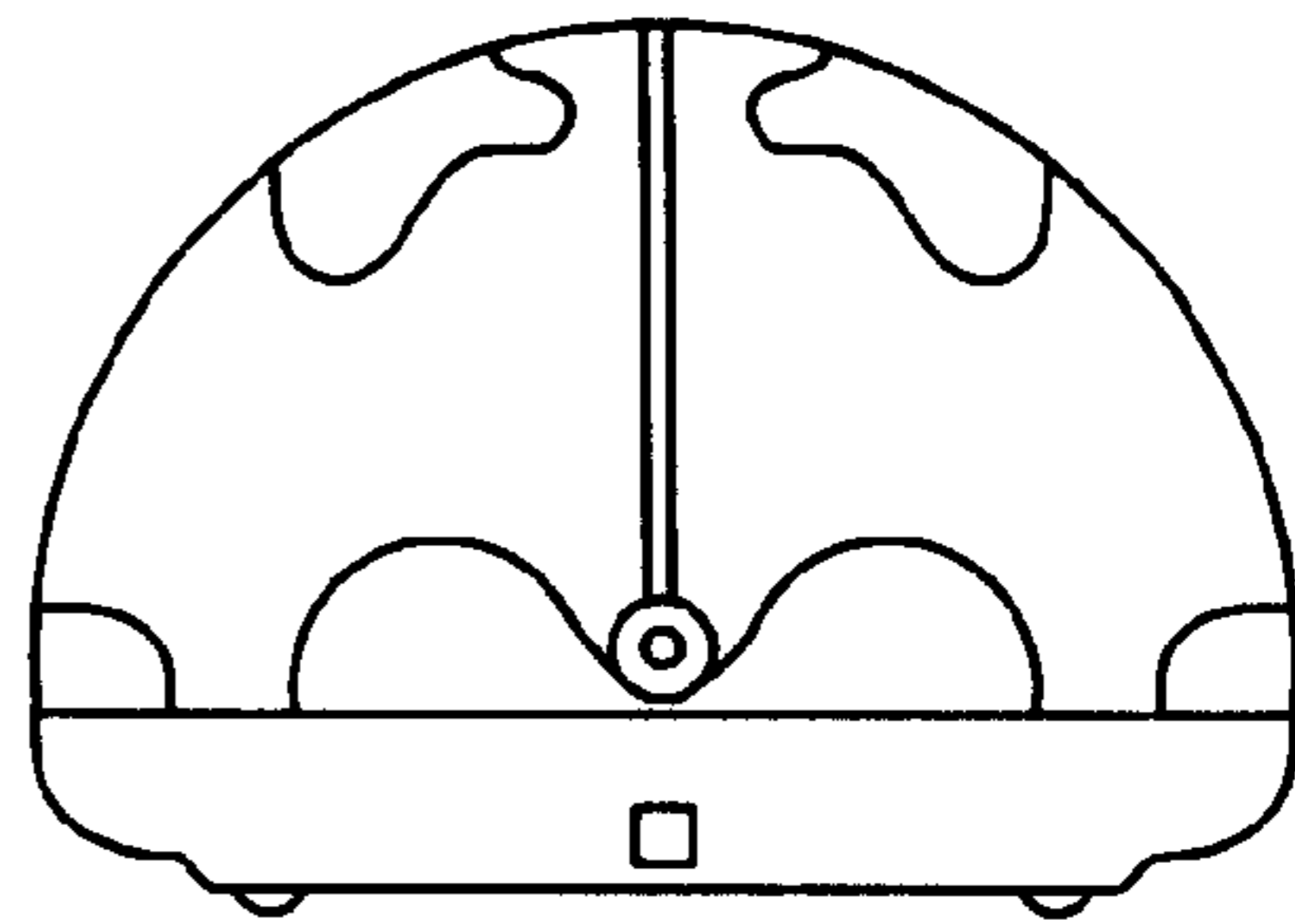
FIG. 1 is a front view;

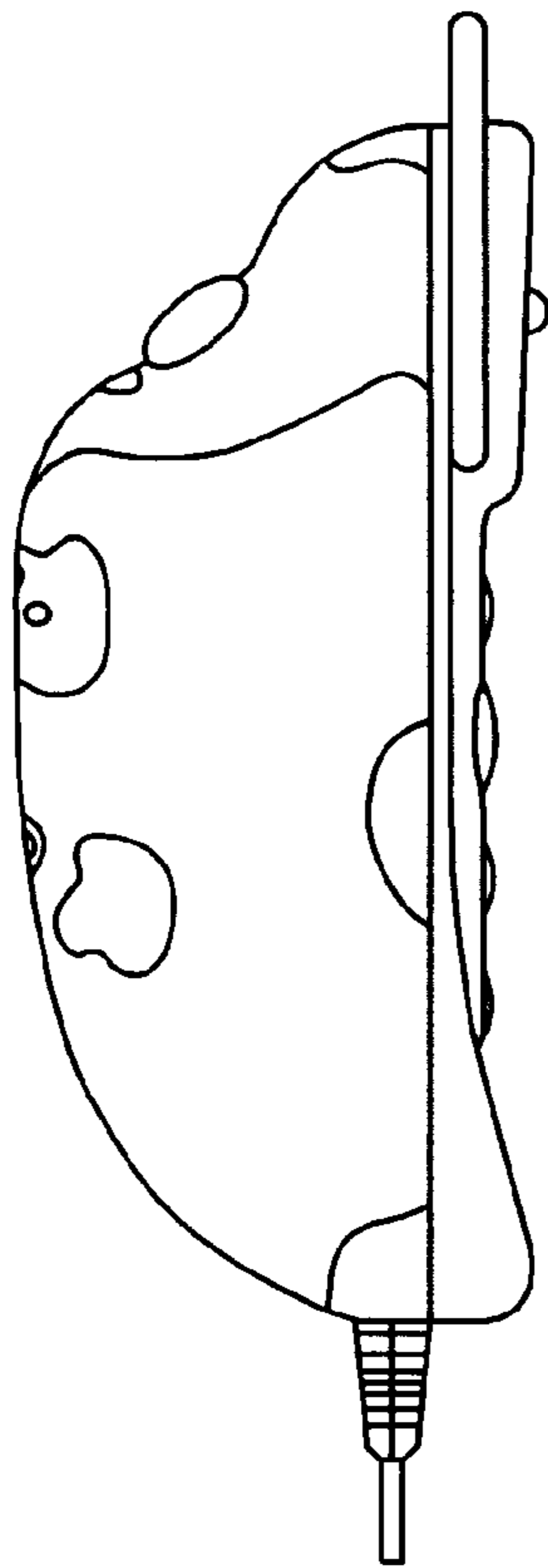




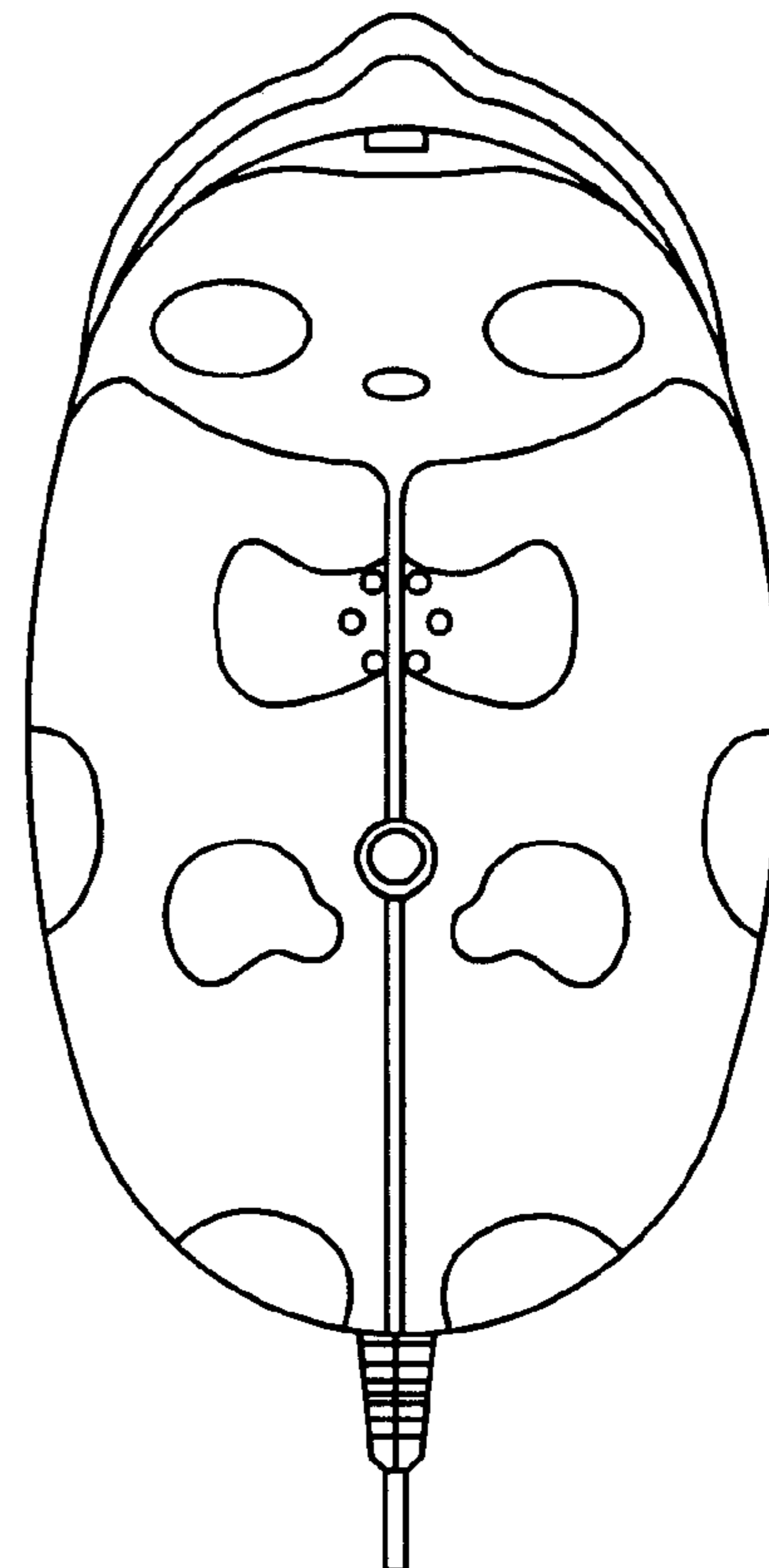

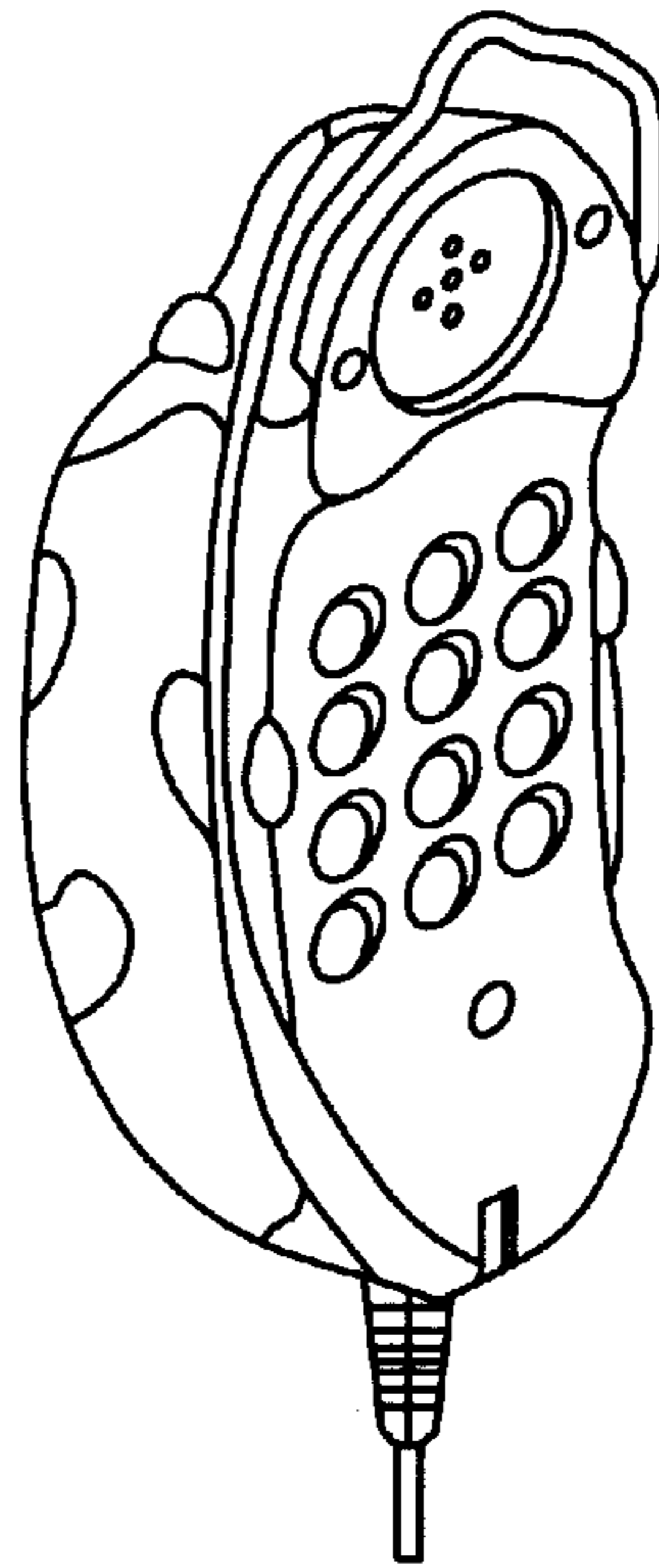

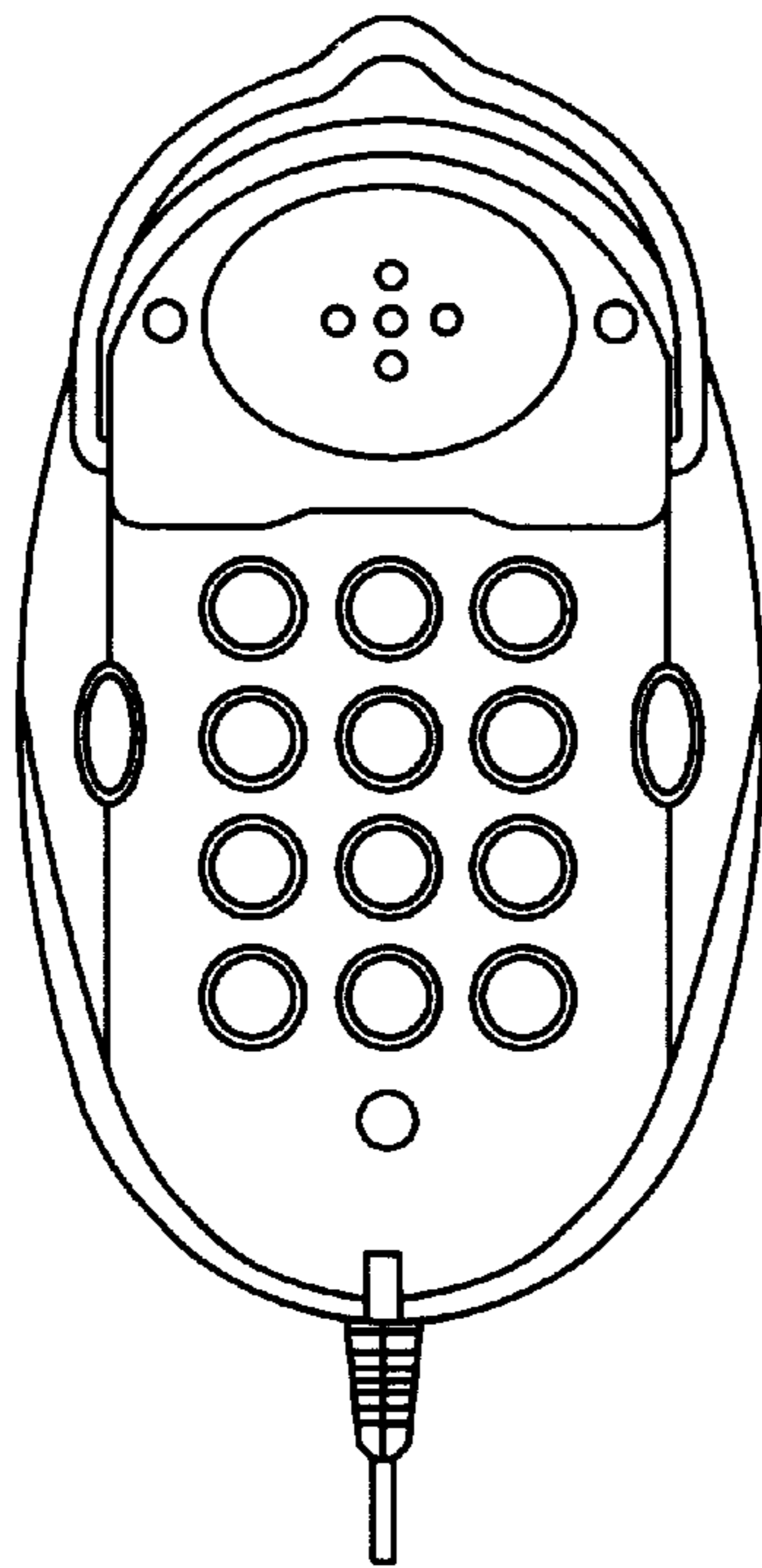

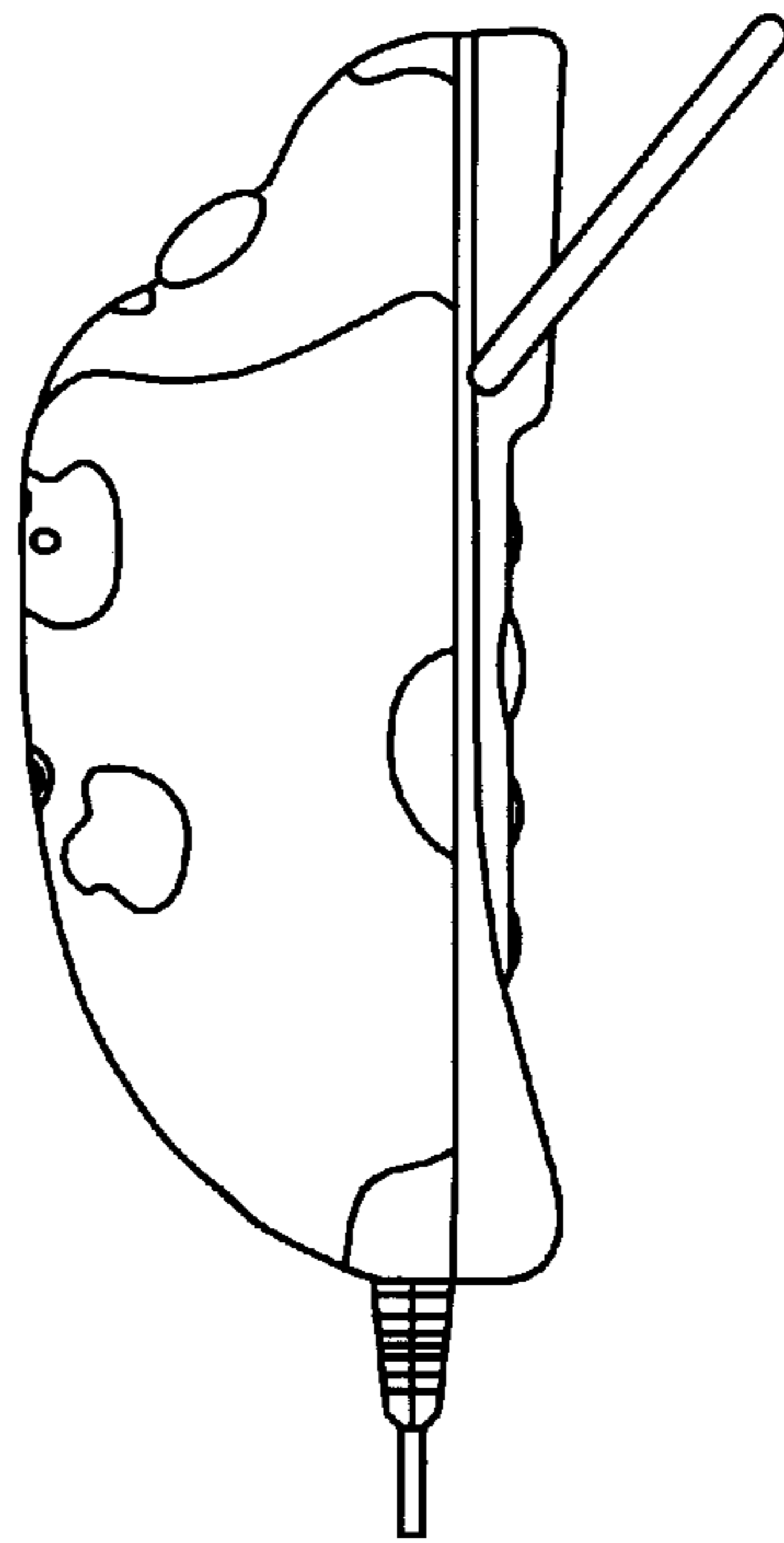
