(57) **CLAIM**

We claim the ornamental design for a golf club iron head, as shown.

DESCRIPTION

FIG. 1 is a front elevational view of a golf club iron head embodying our new design.

FIG. 2 is a right side elevational view thereof.

FIG. 3 is a rear elevational view thereof.

FIG. 4 is a left side elevational view thereof.

FIG. 5 is a top plan view thereof.

FIG. 6 is a bottom plan view thereof.

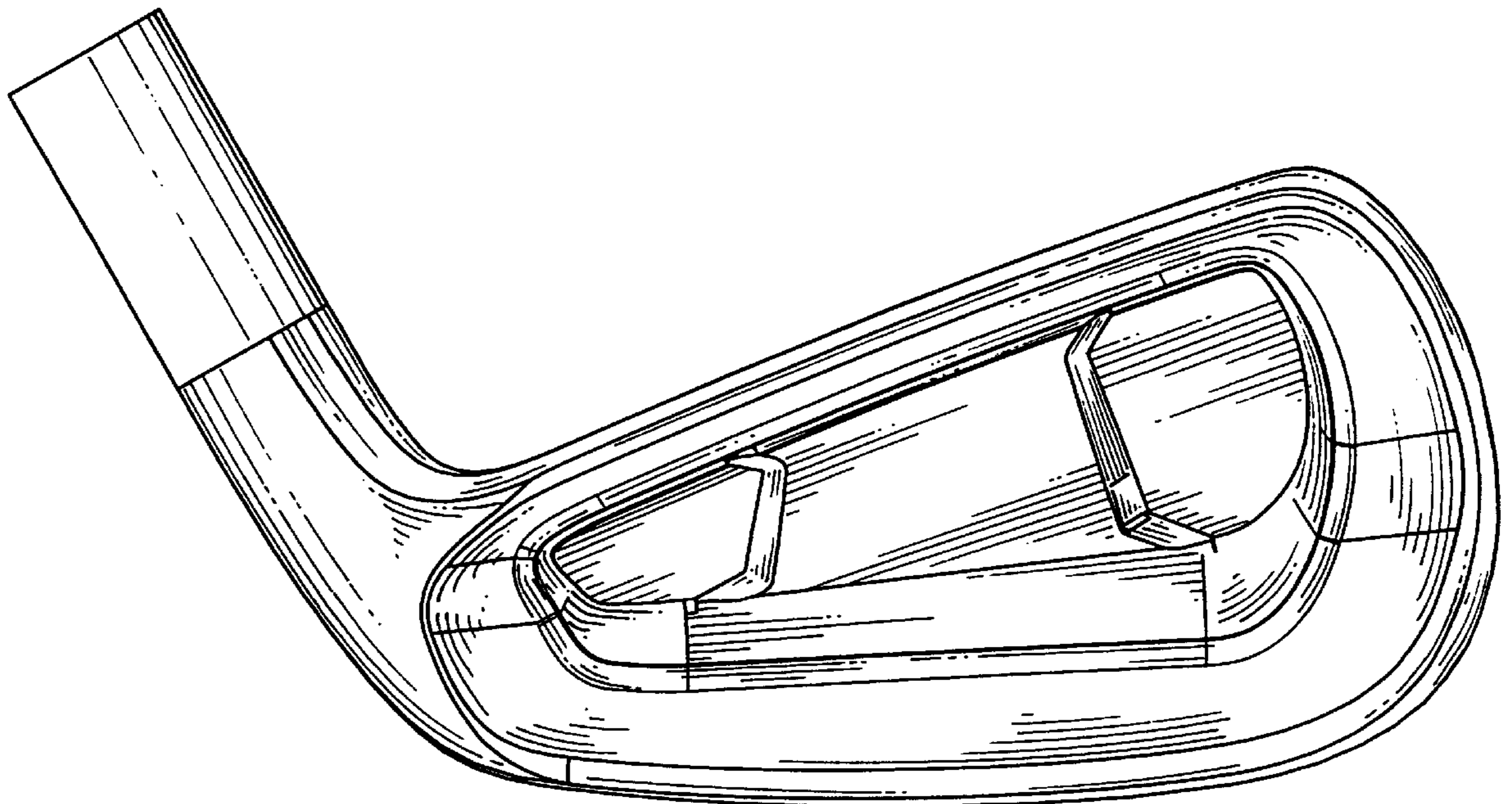

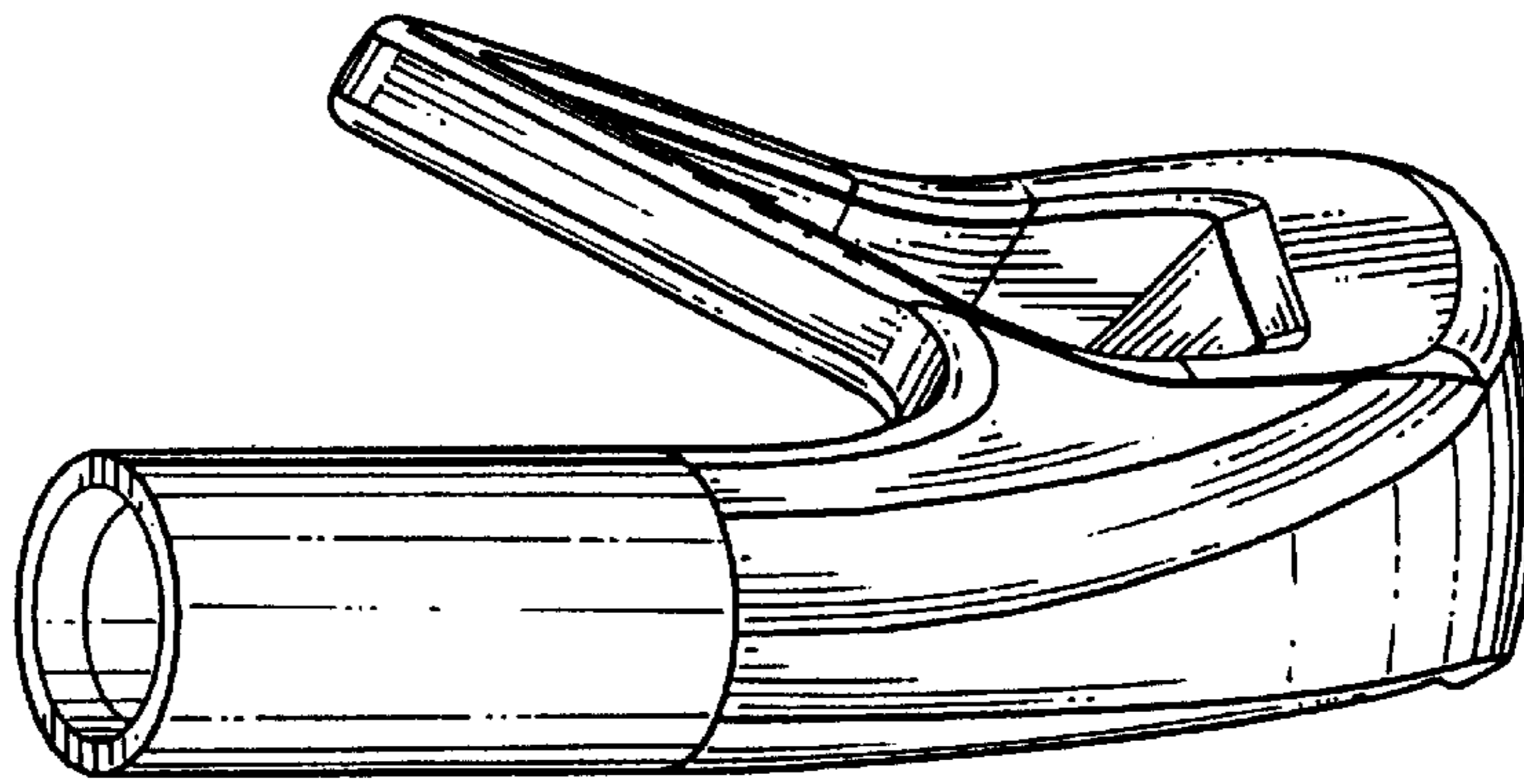

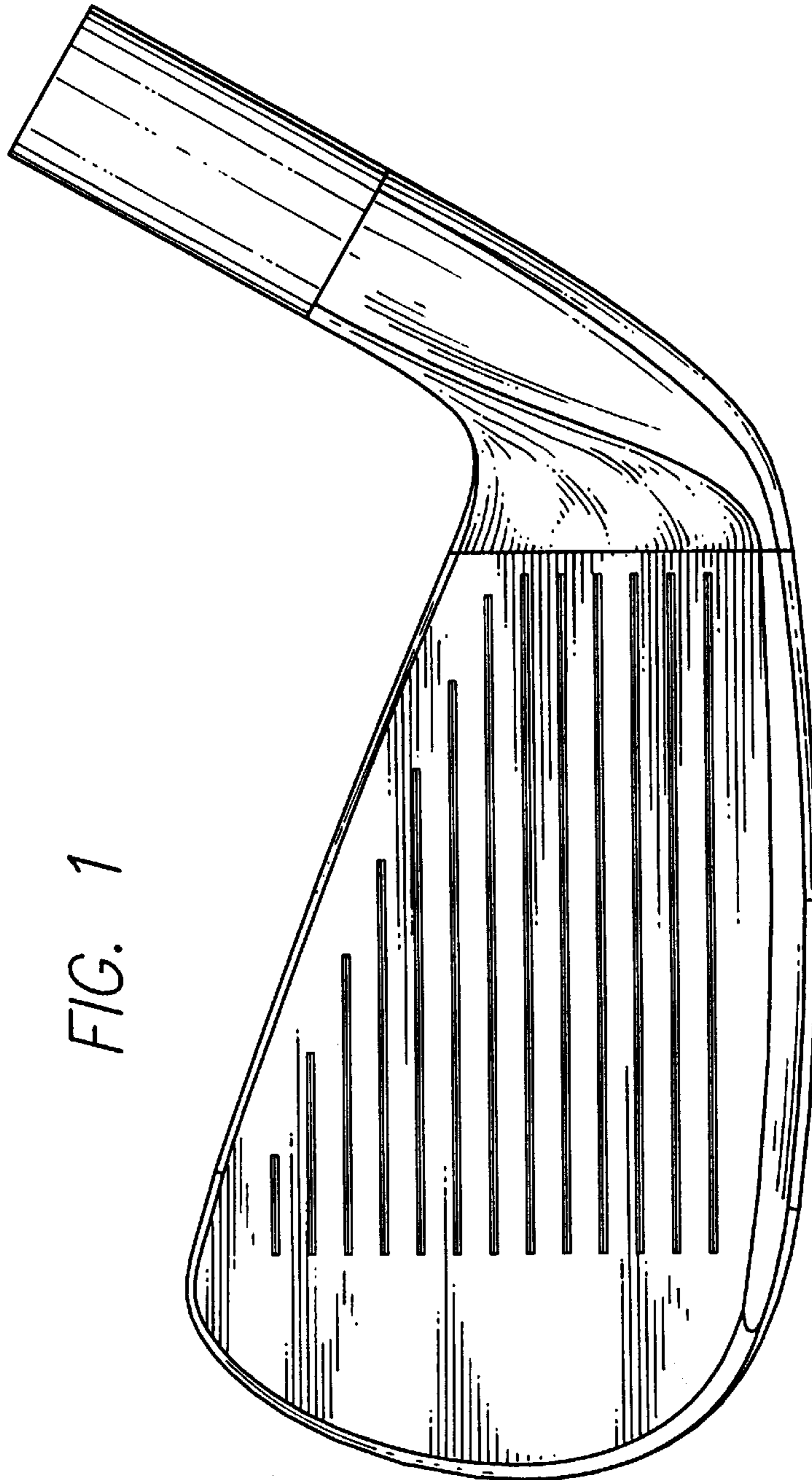

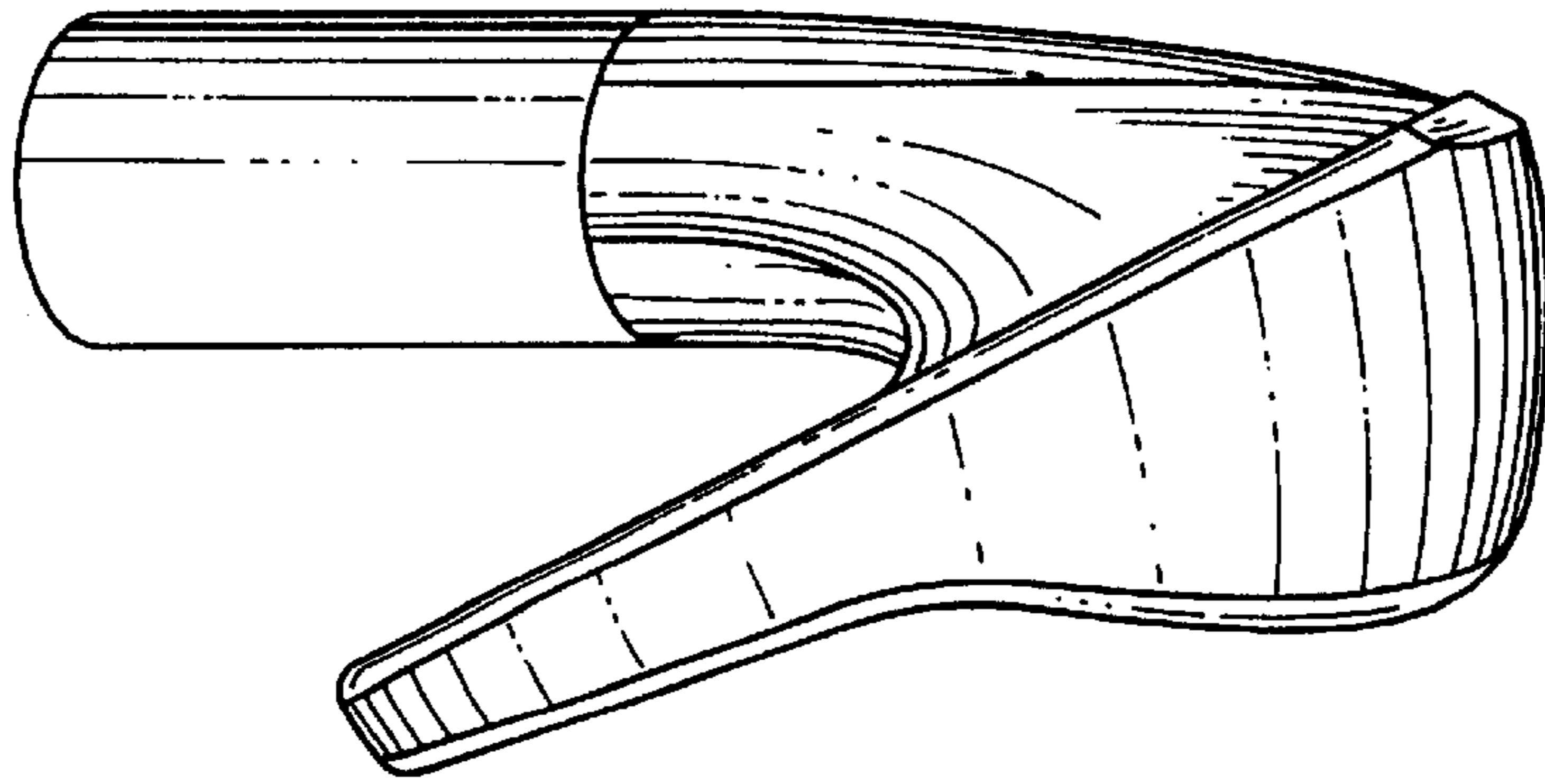
