**DESCRIPTION**

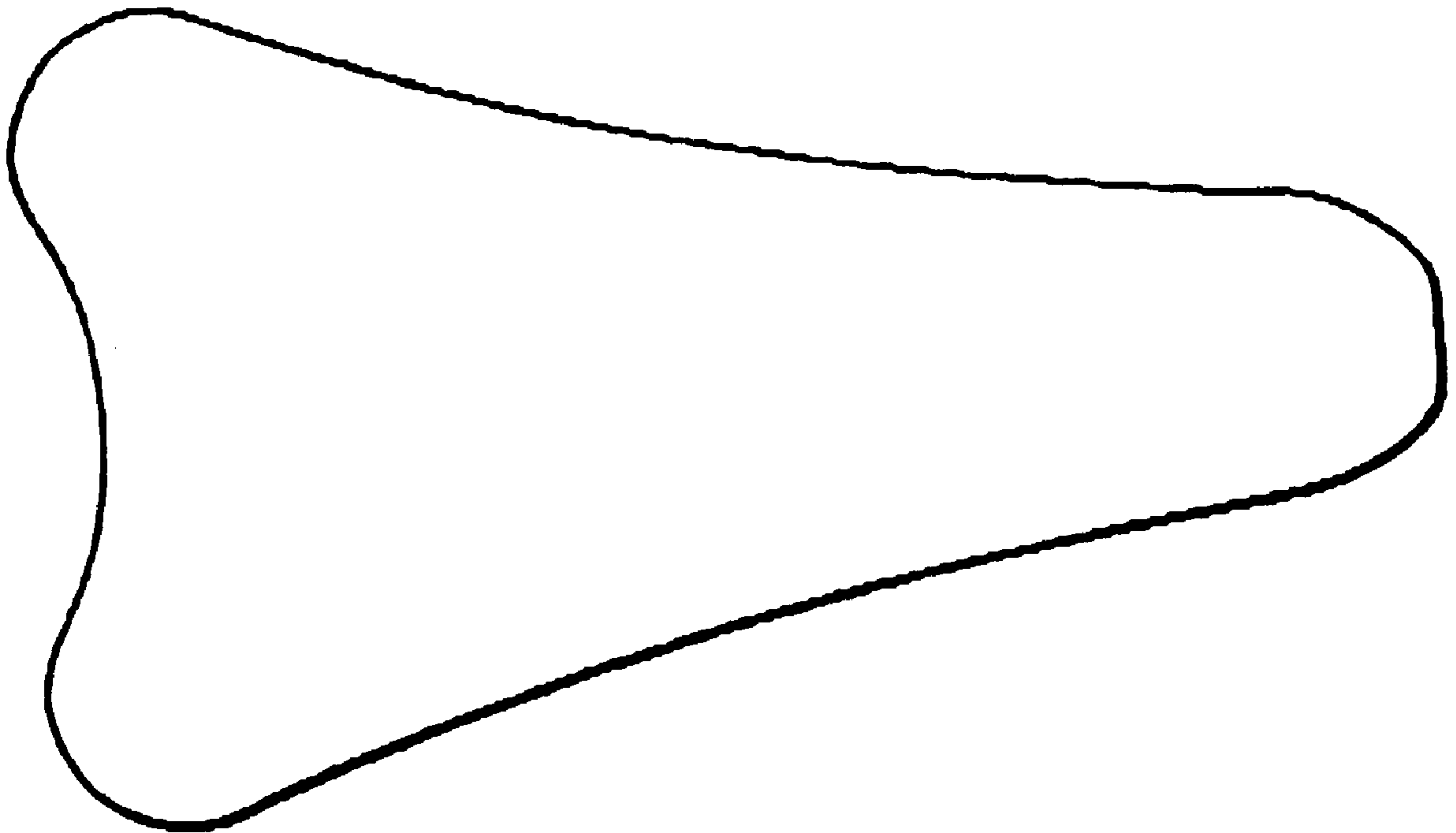
FIG. 1 is a top plan view of a pantiliner, embodying our new design, the bottom plan view being a mirror image in appearance;

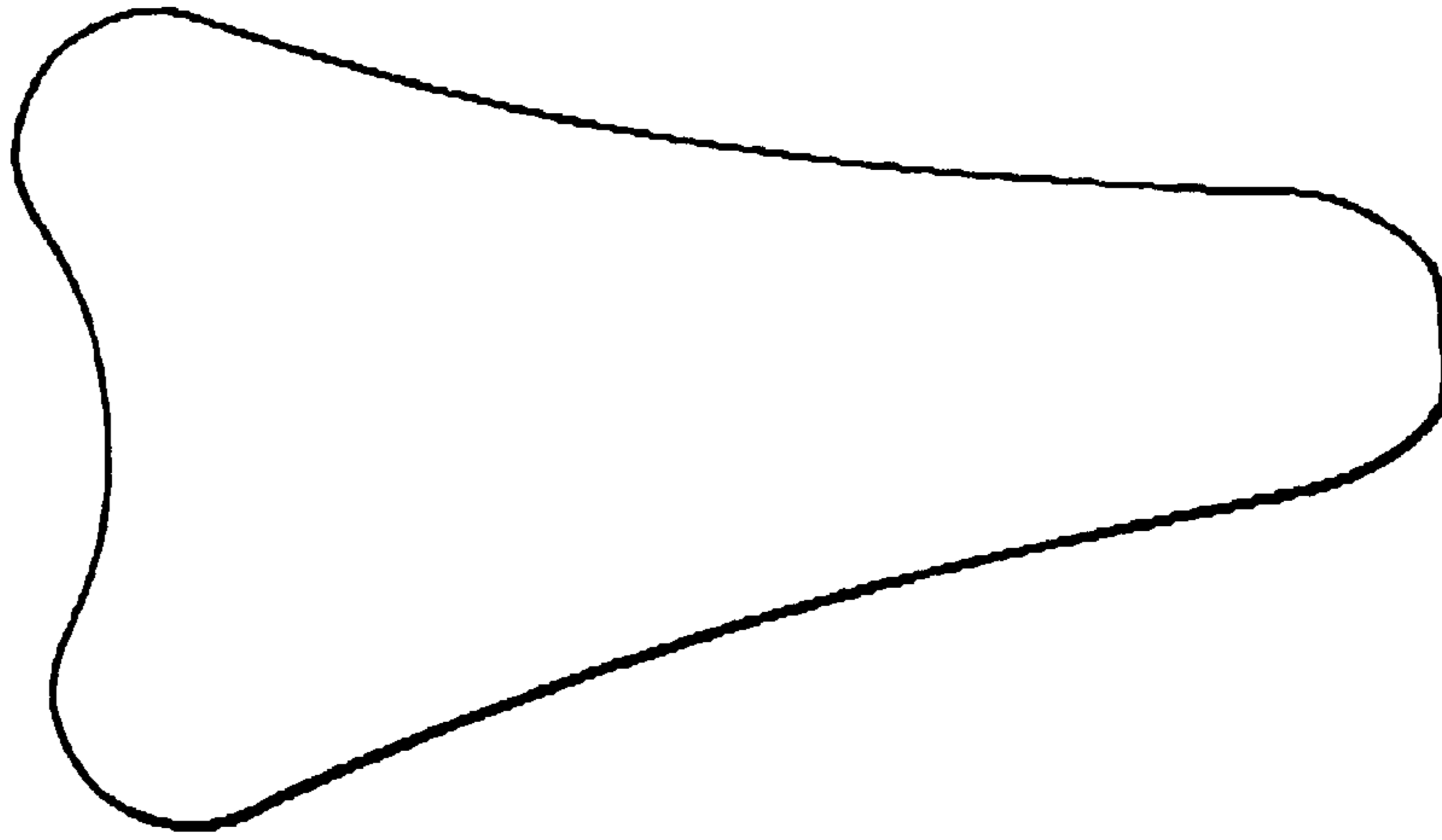

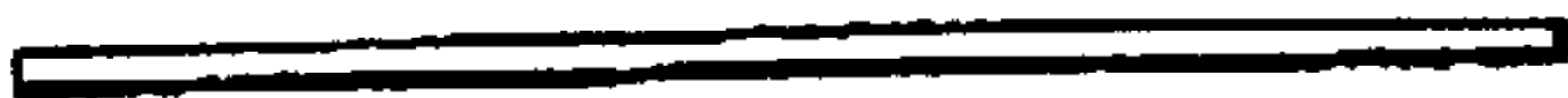
