FIG. 1 is a perspective view thereof;

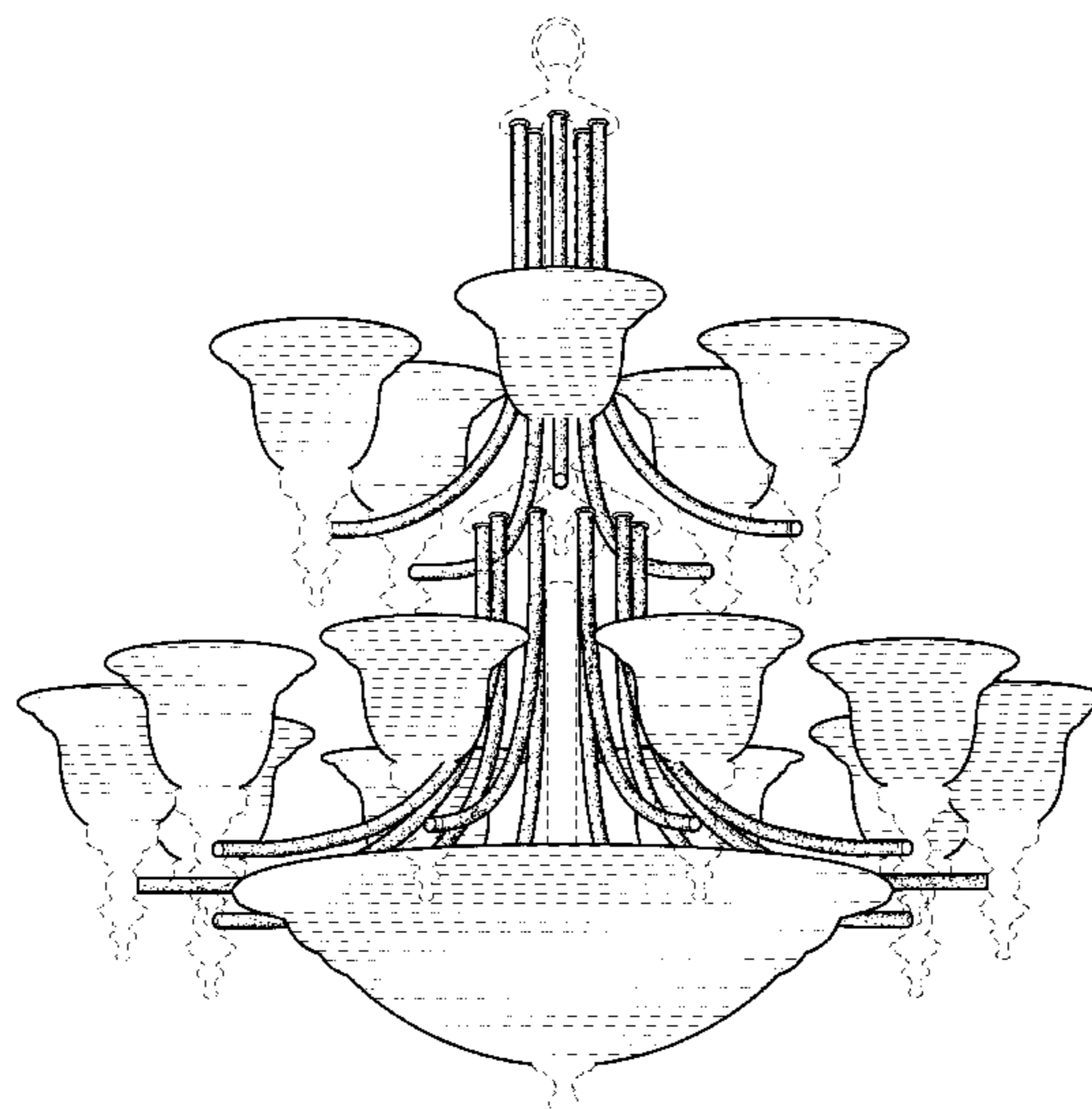
FIG. 2 is a front elevational view thereof;

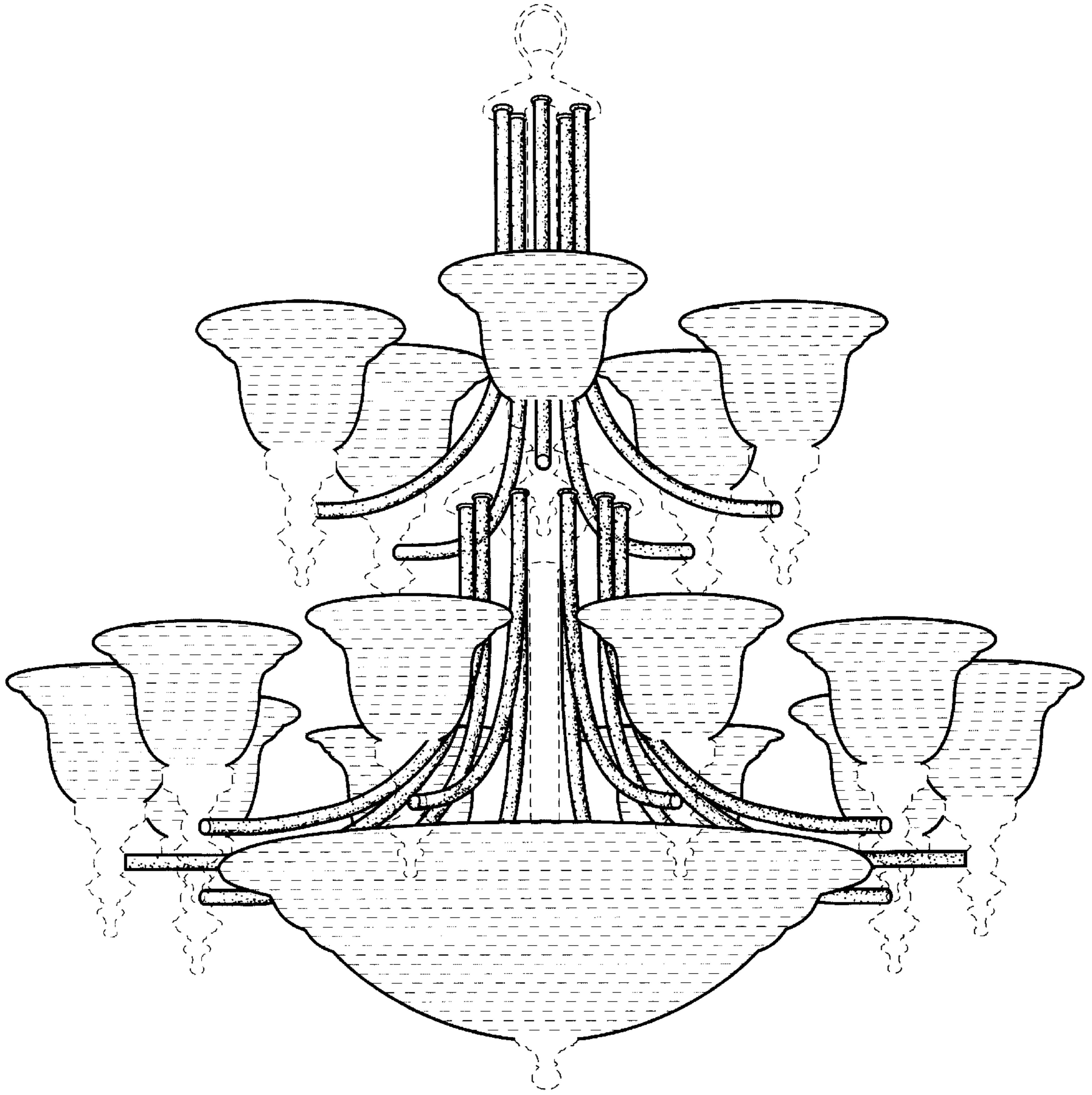

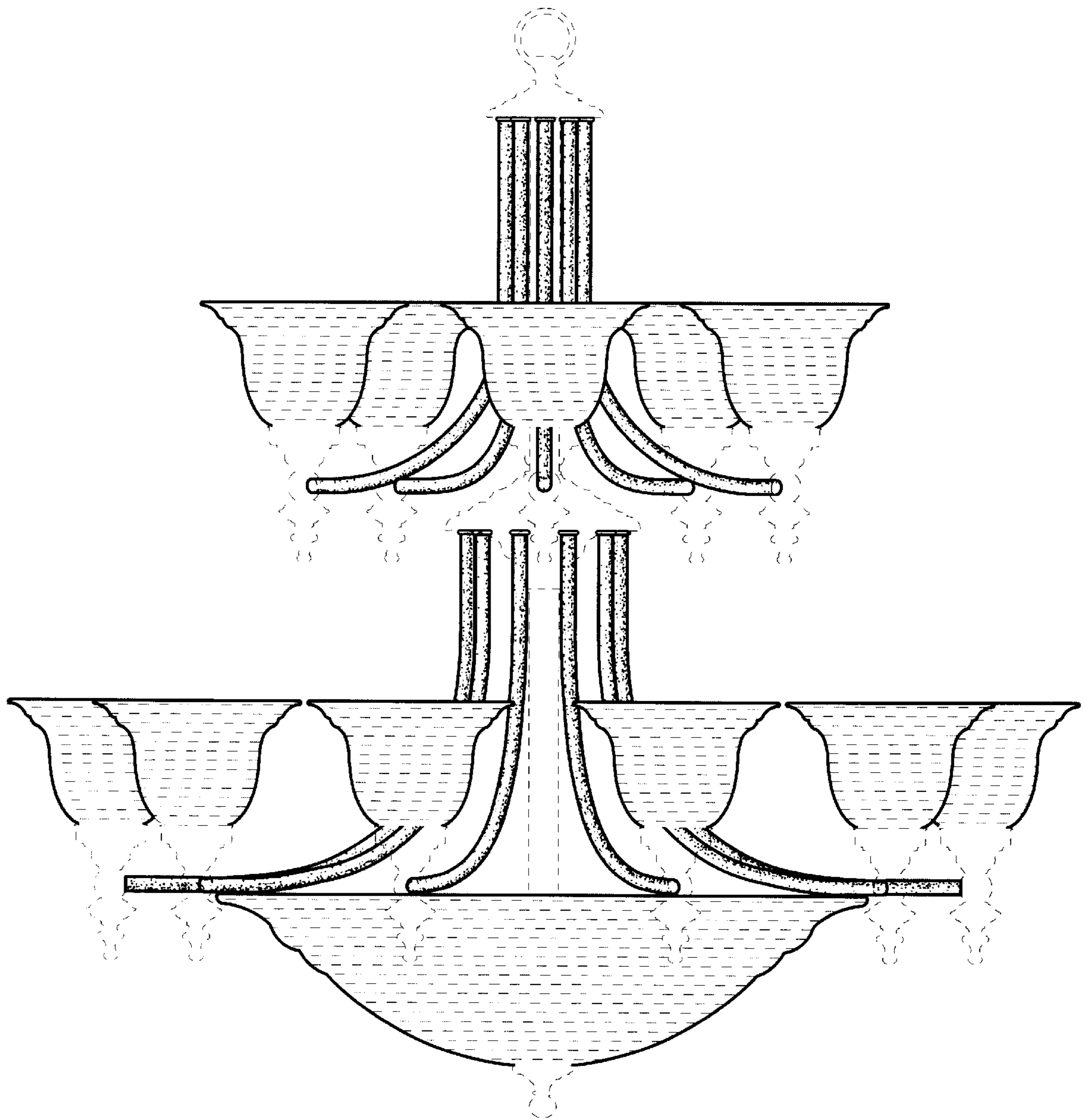

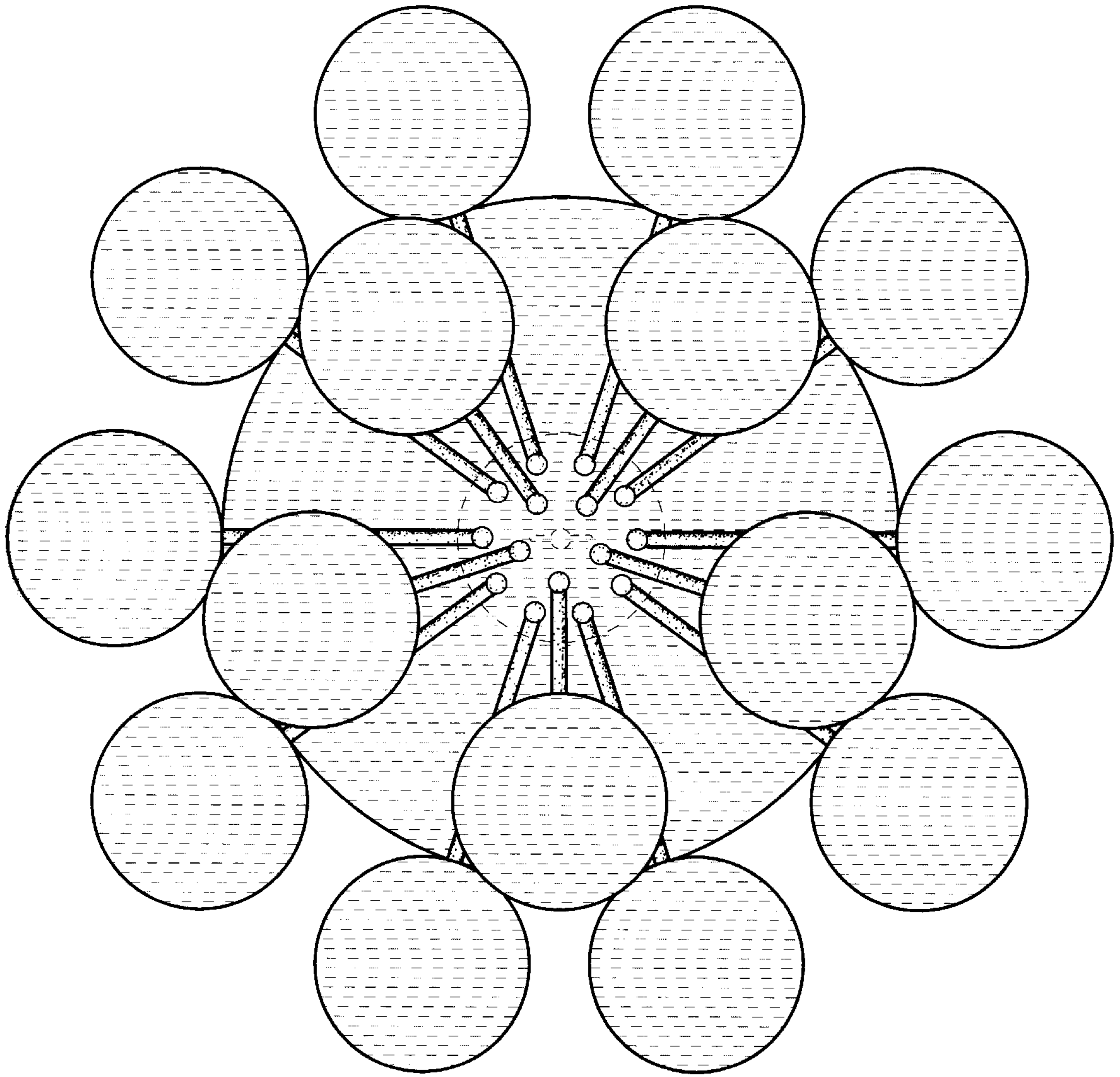

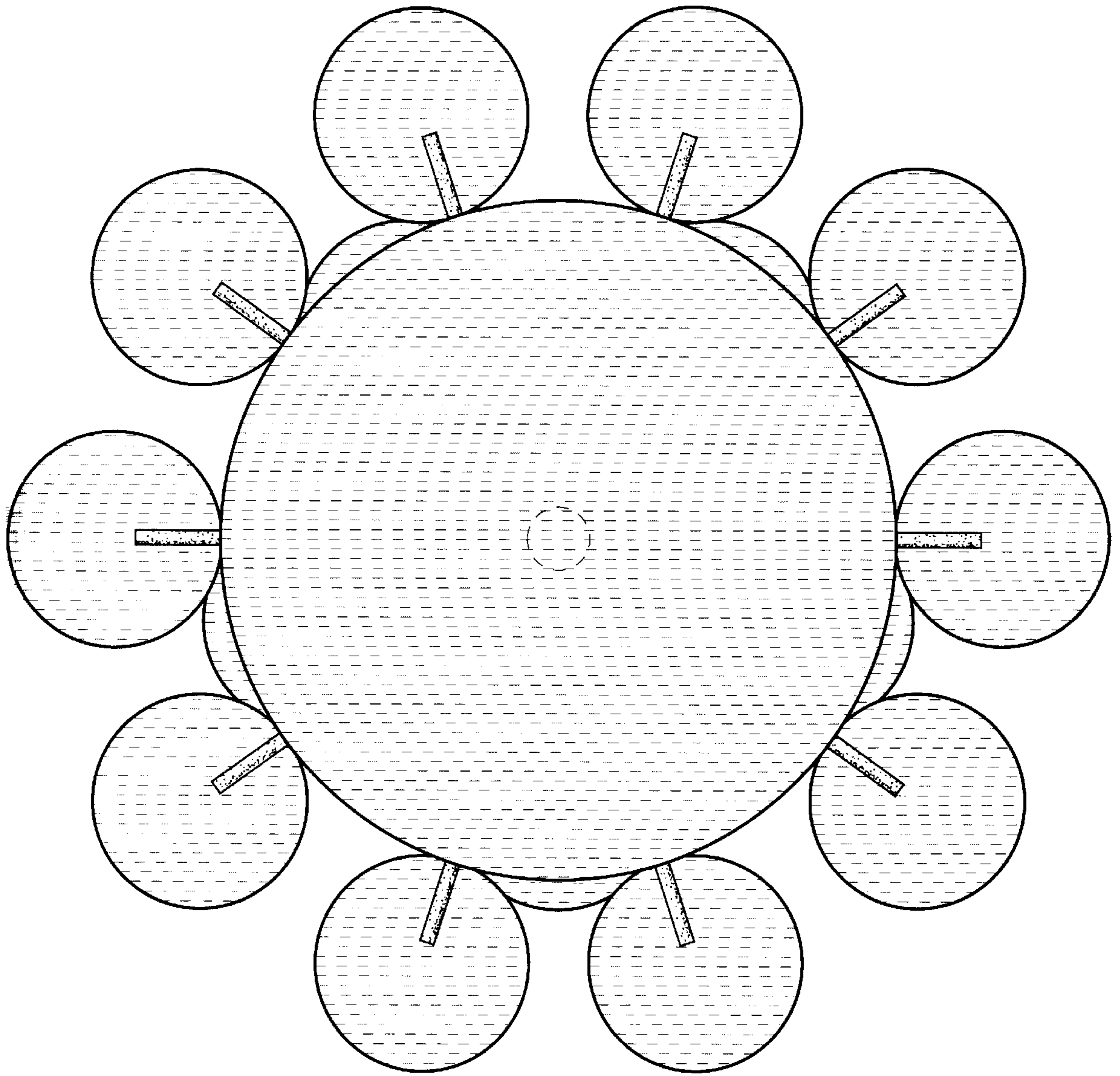
