DESCRIPTION

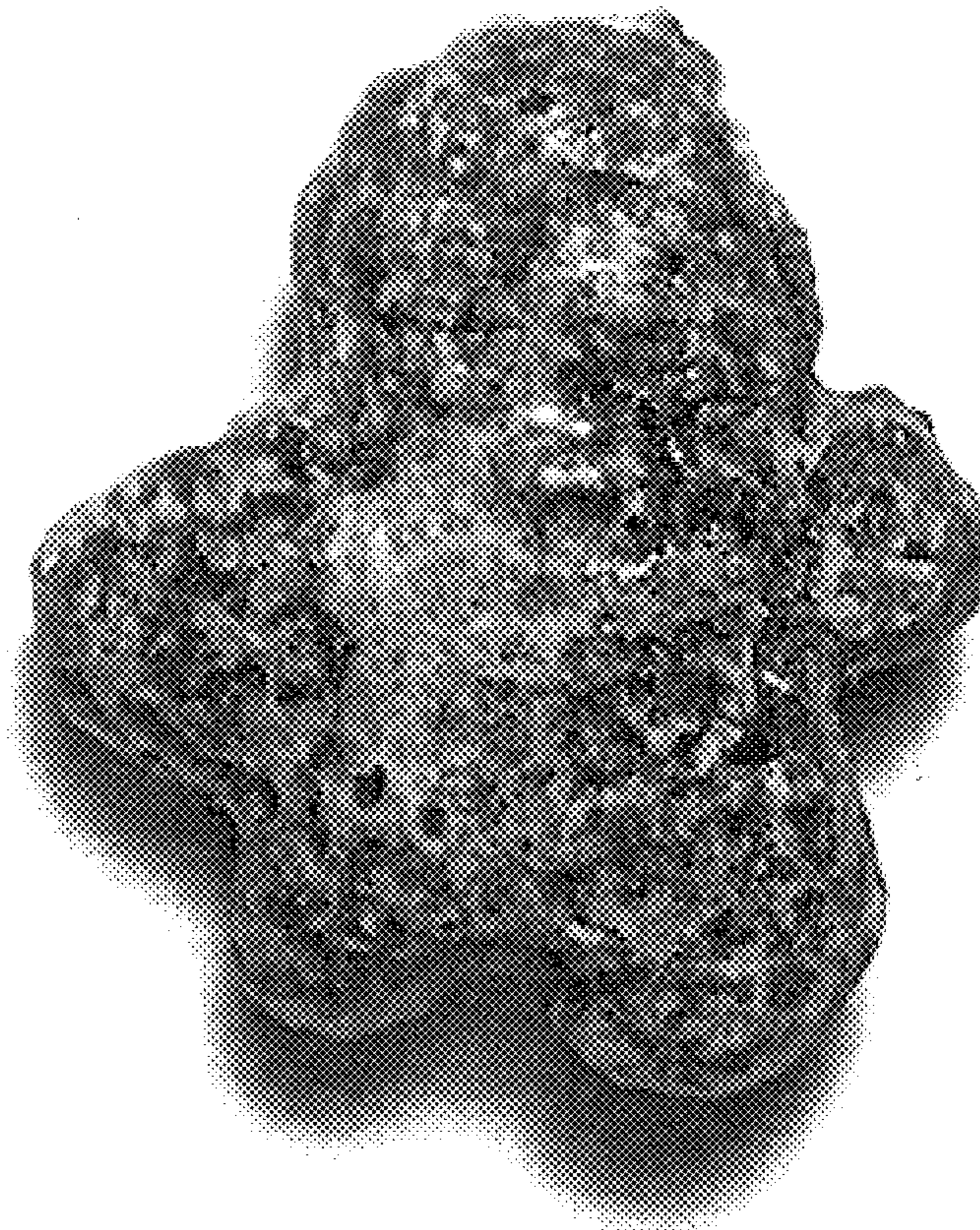
FIG. 1 is a top plan view of the five lobed puffed cereal piece of the invention;

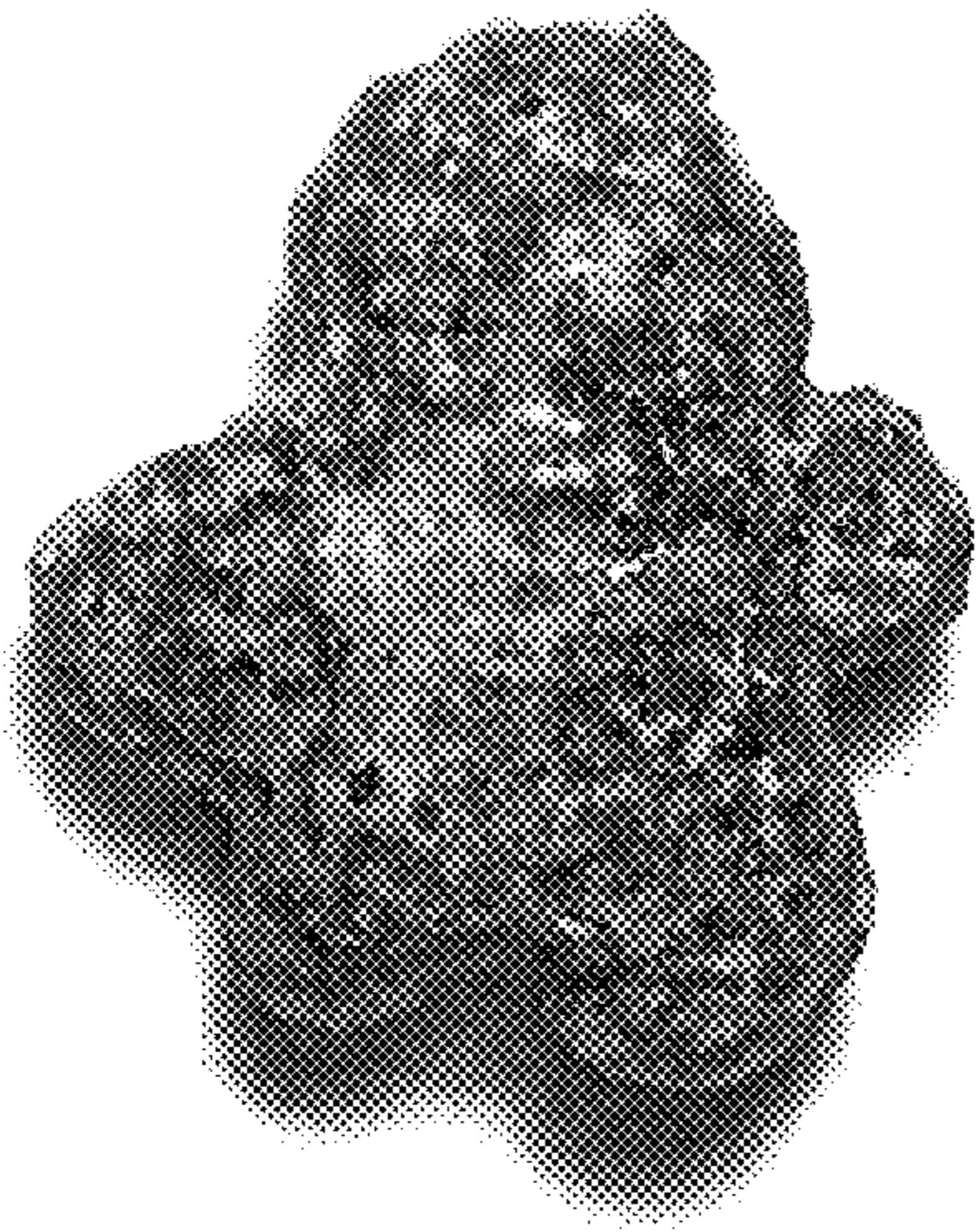

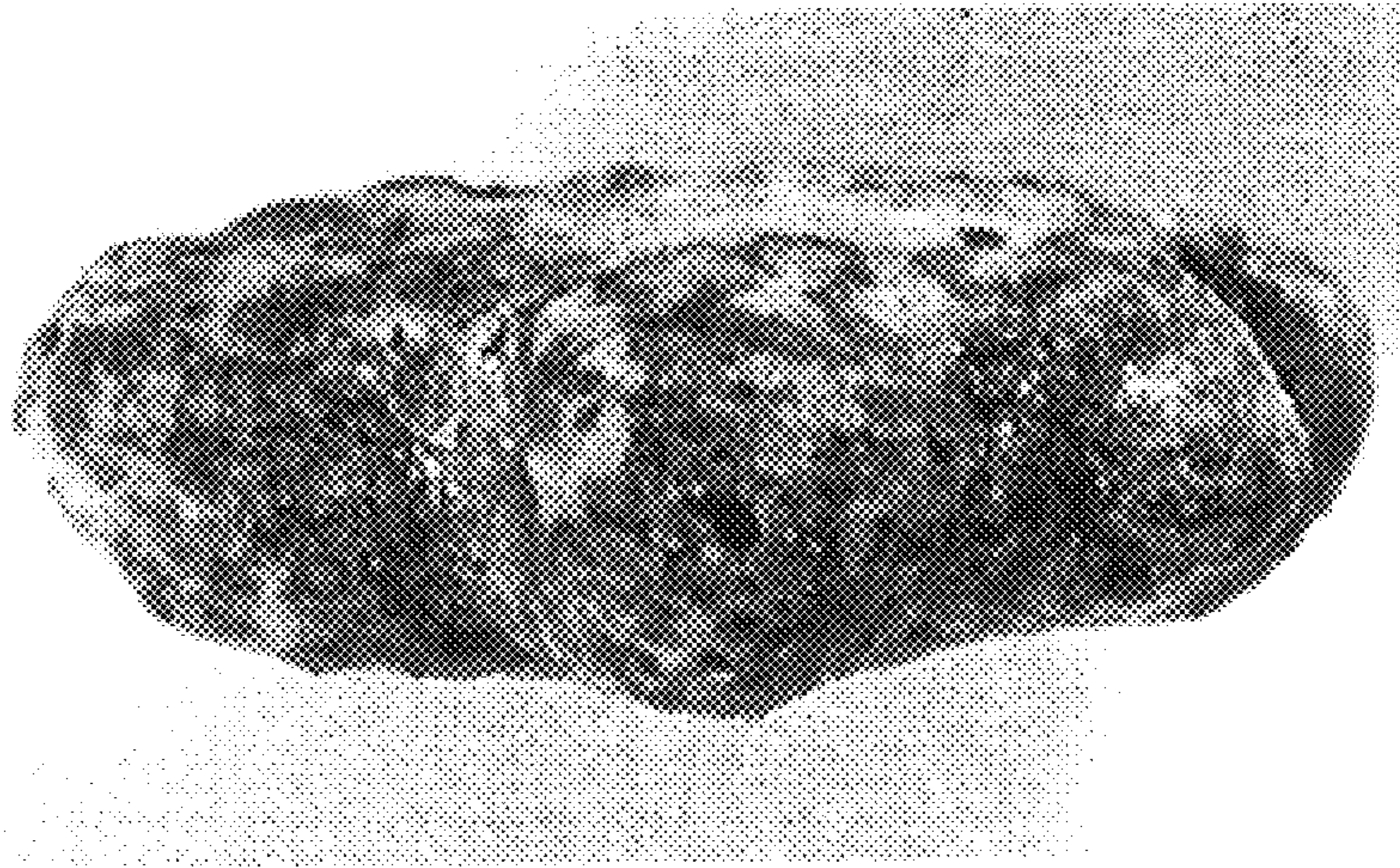

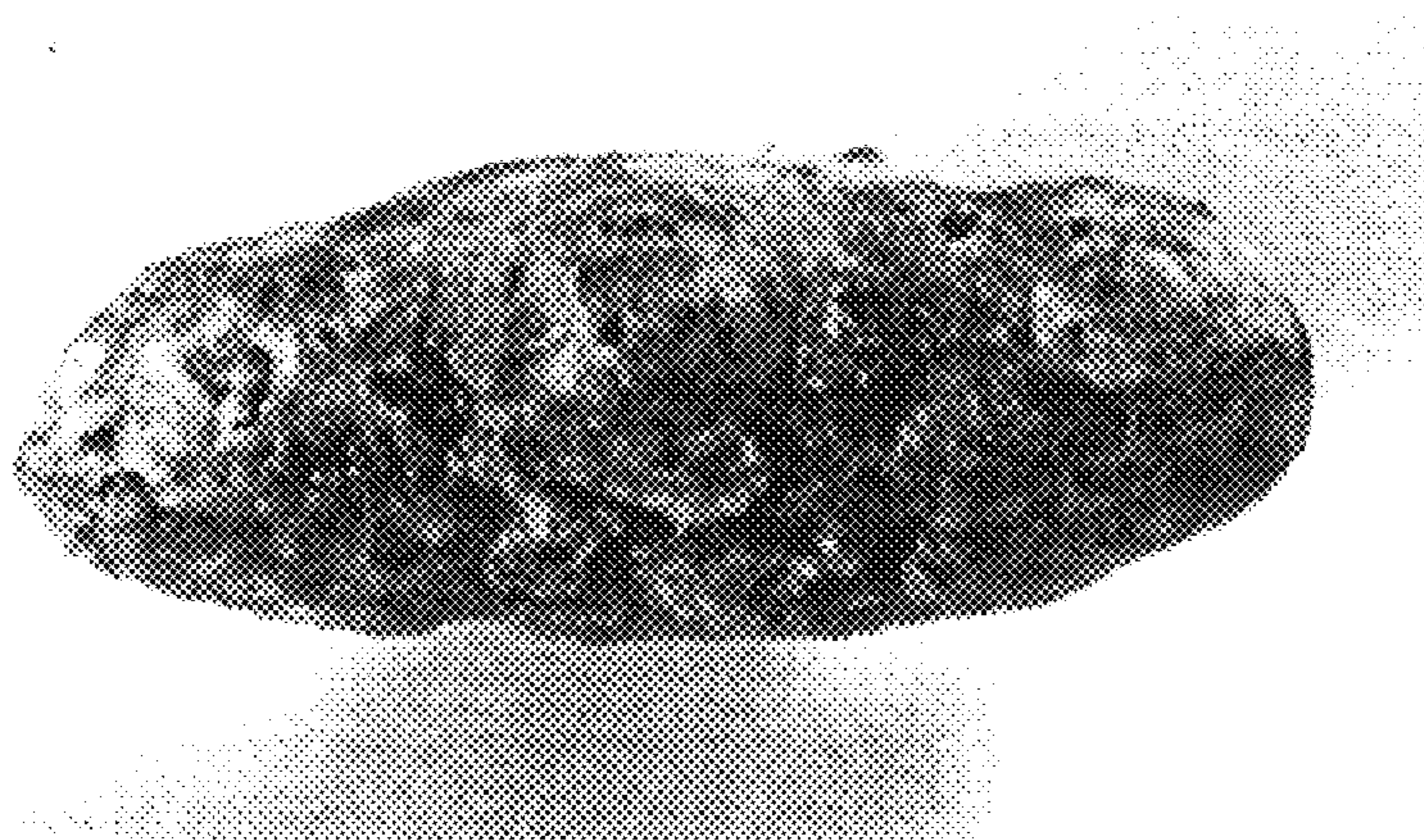

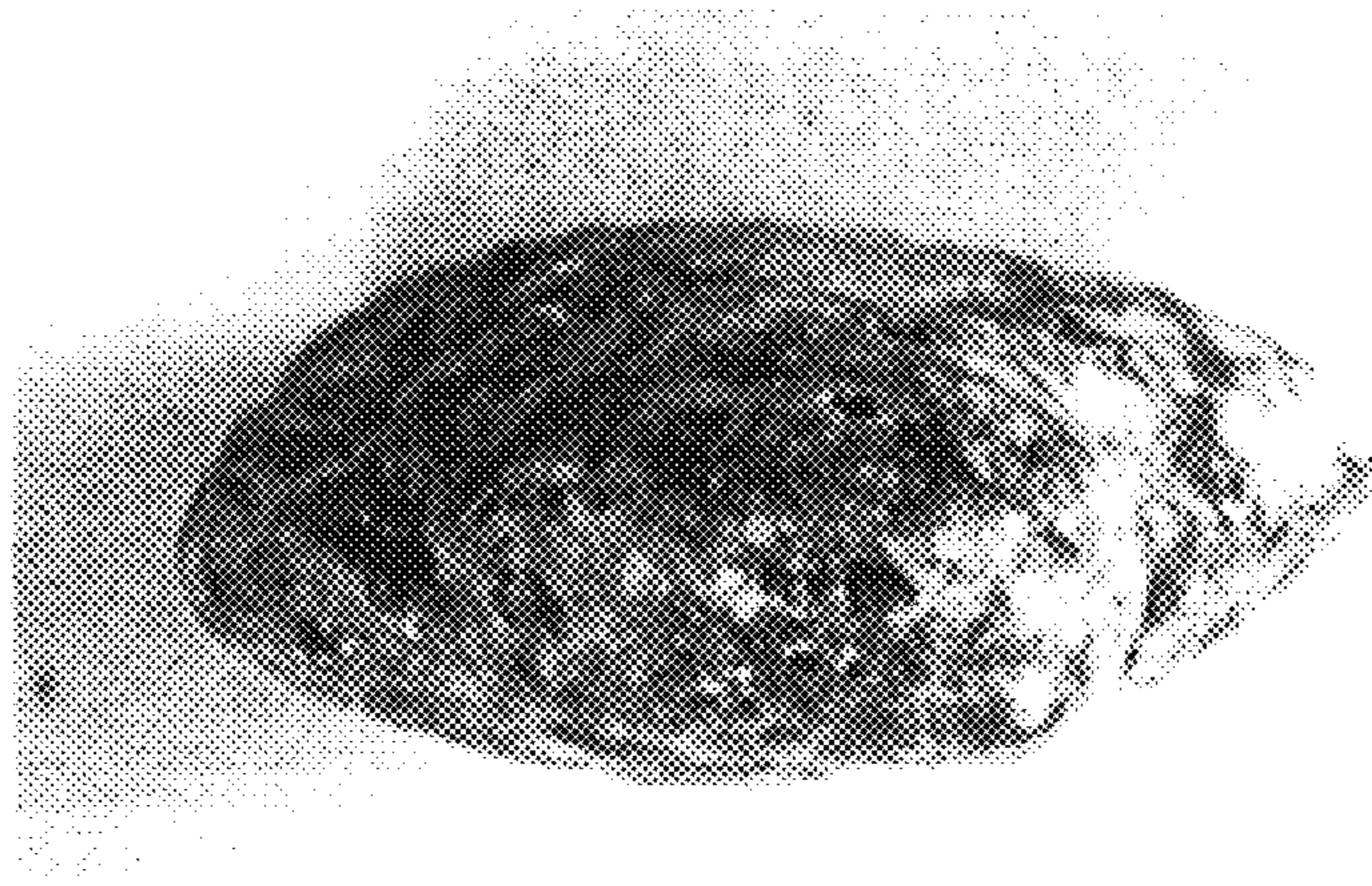

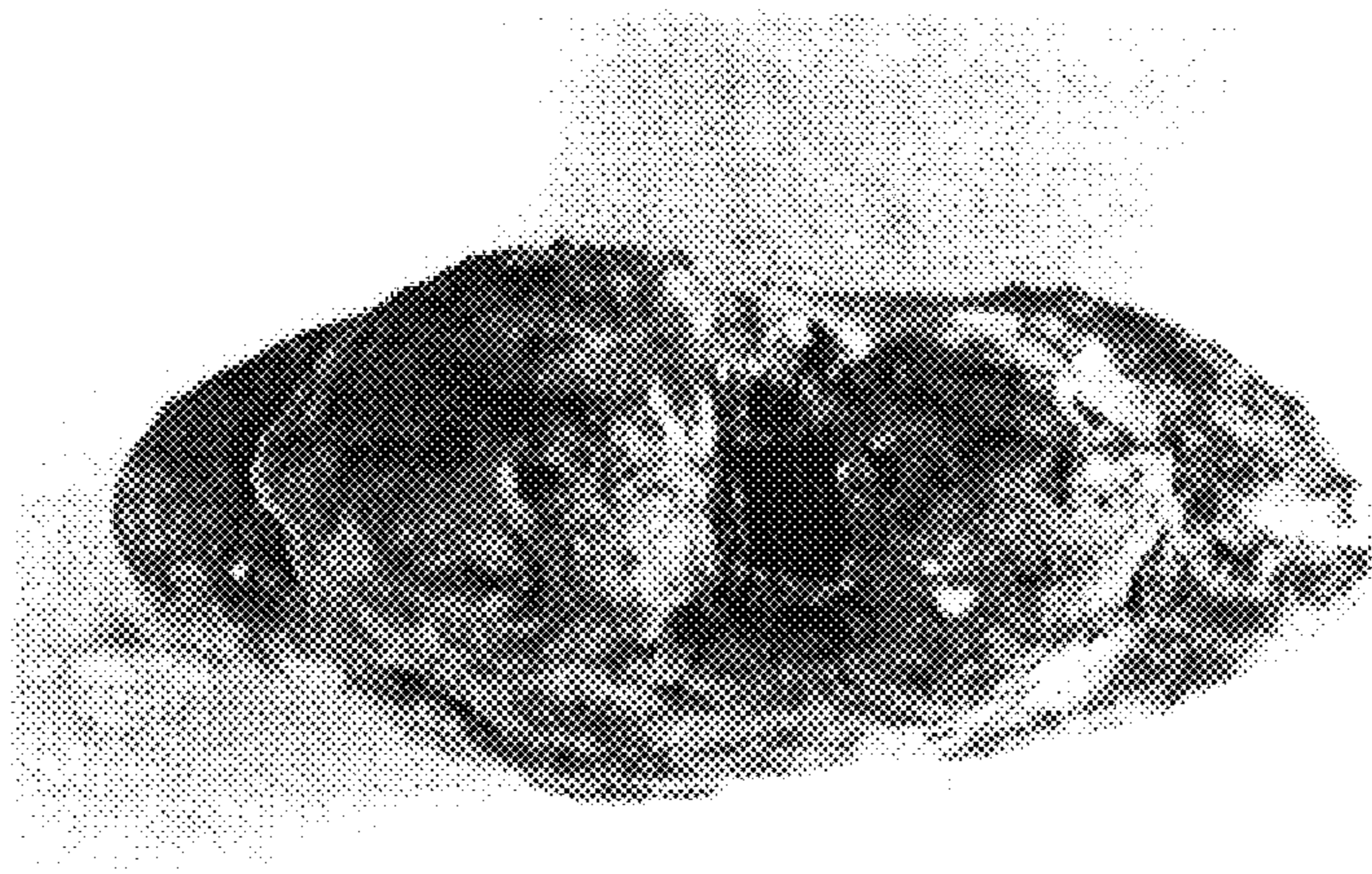

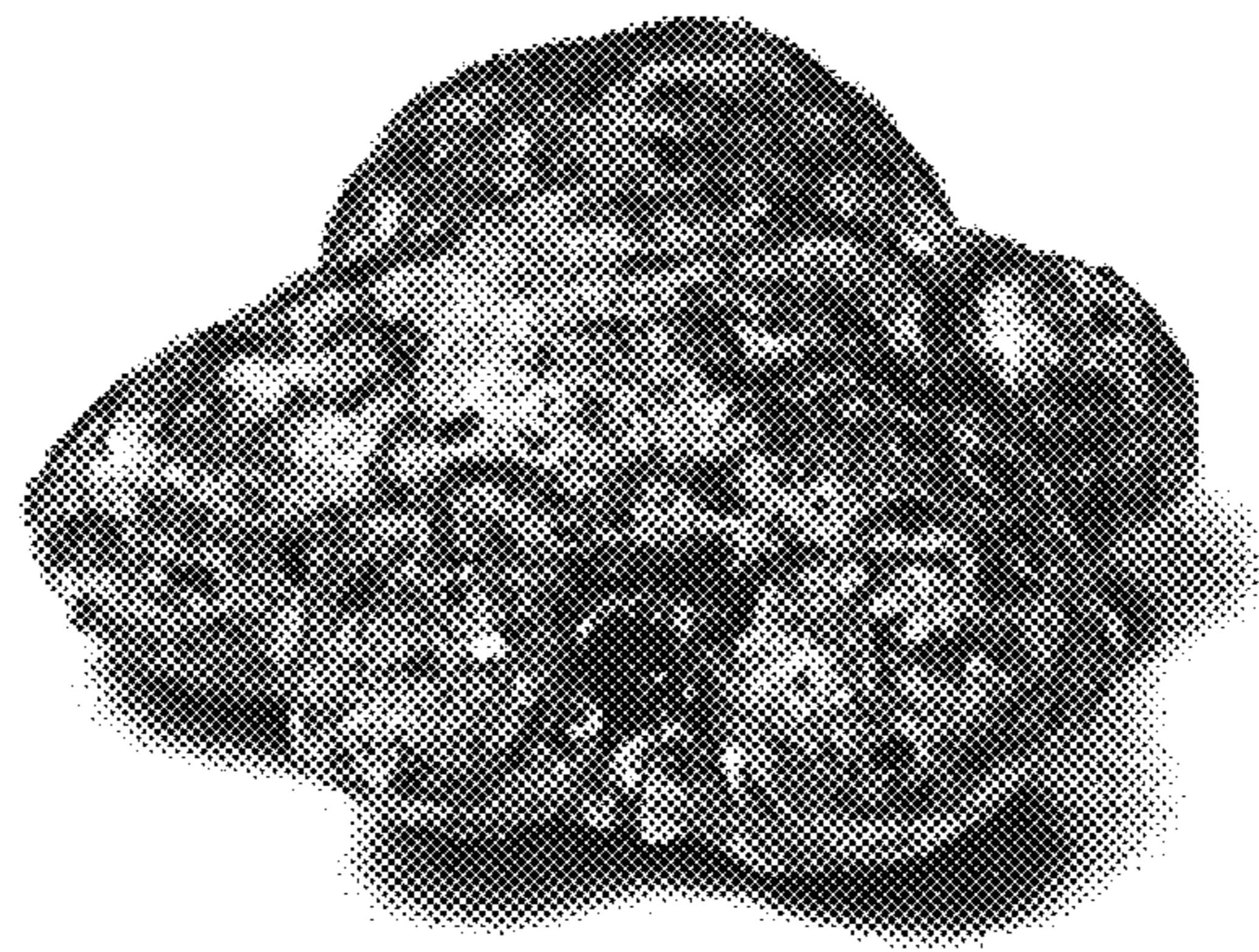
