FIG. 4 is a left side view thereof.

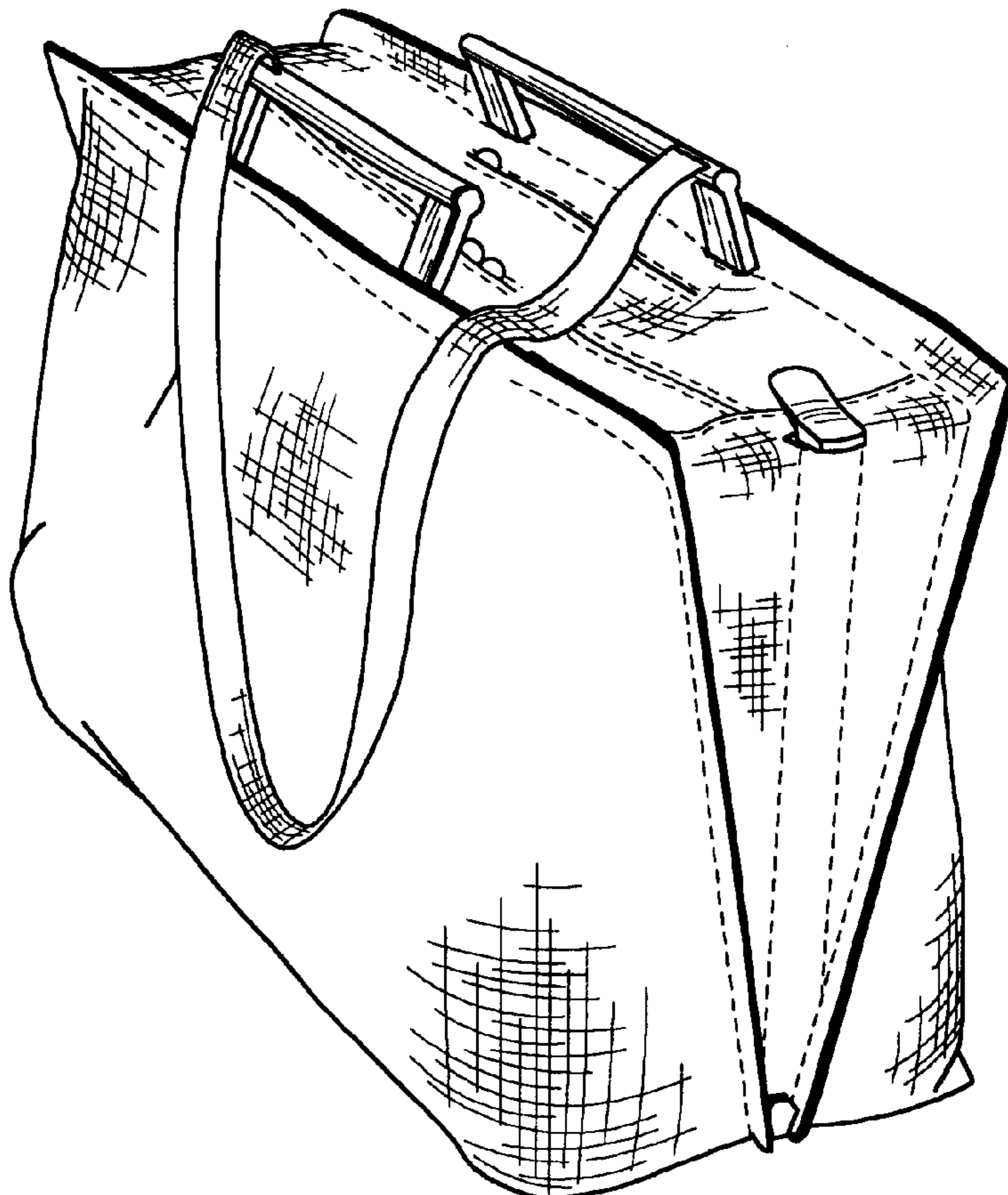
FIG. 5 is a right side view thereof.

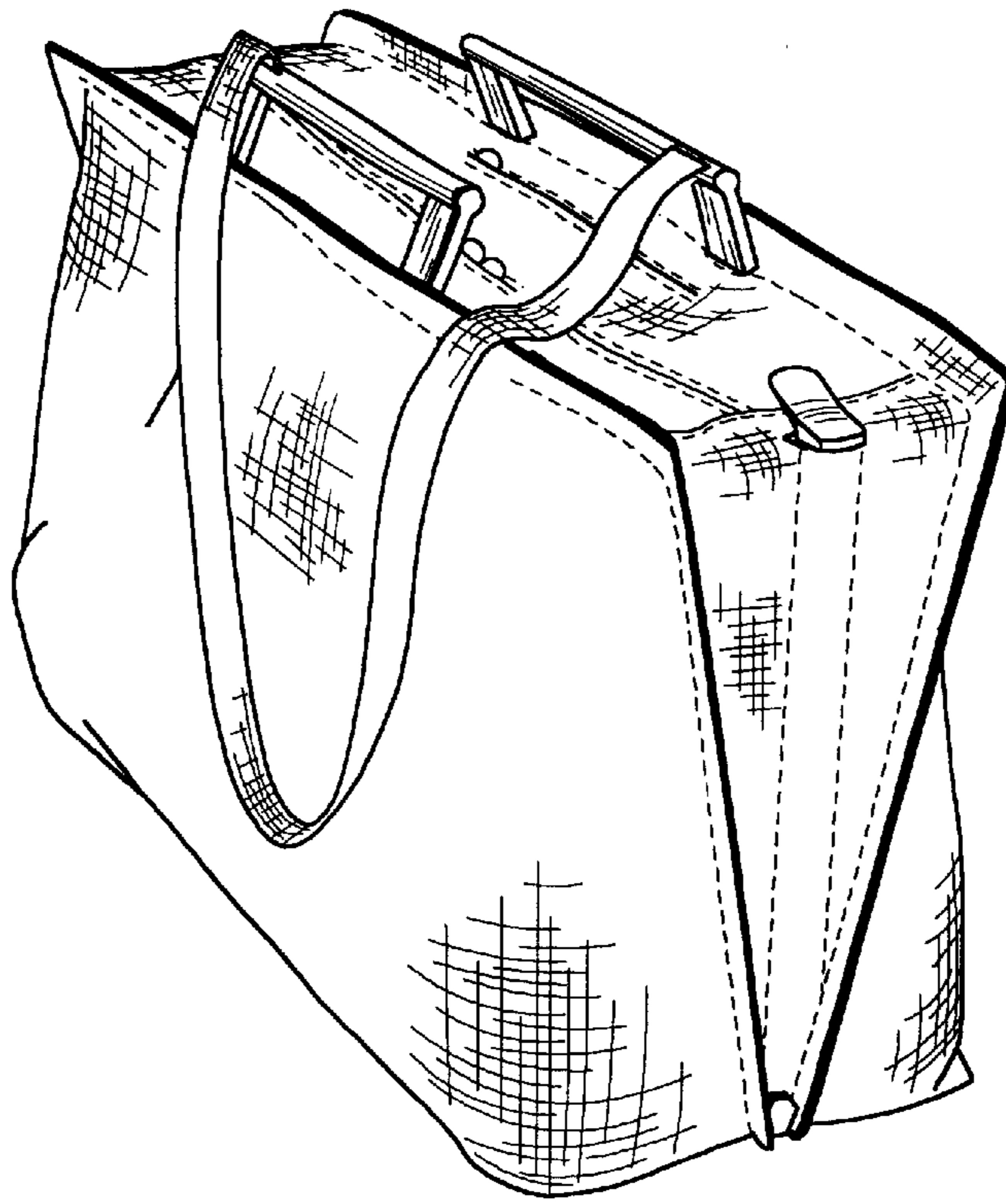
FIG. 6 is a top view thereof.

FIG. 7 is a bottom view thereof; and,

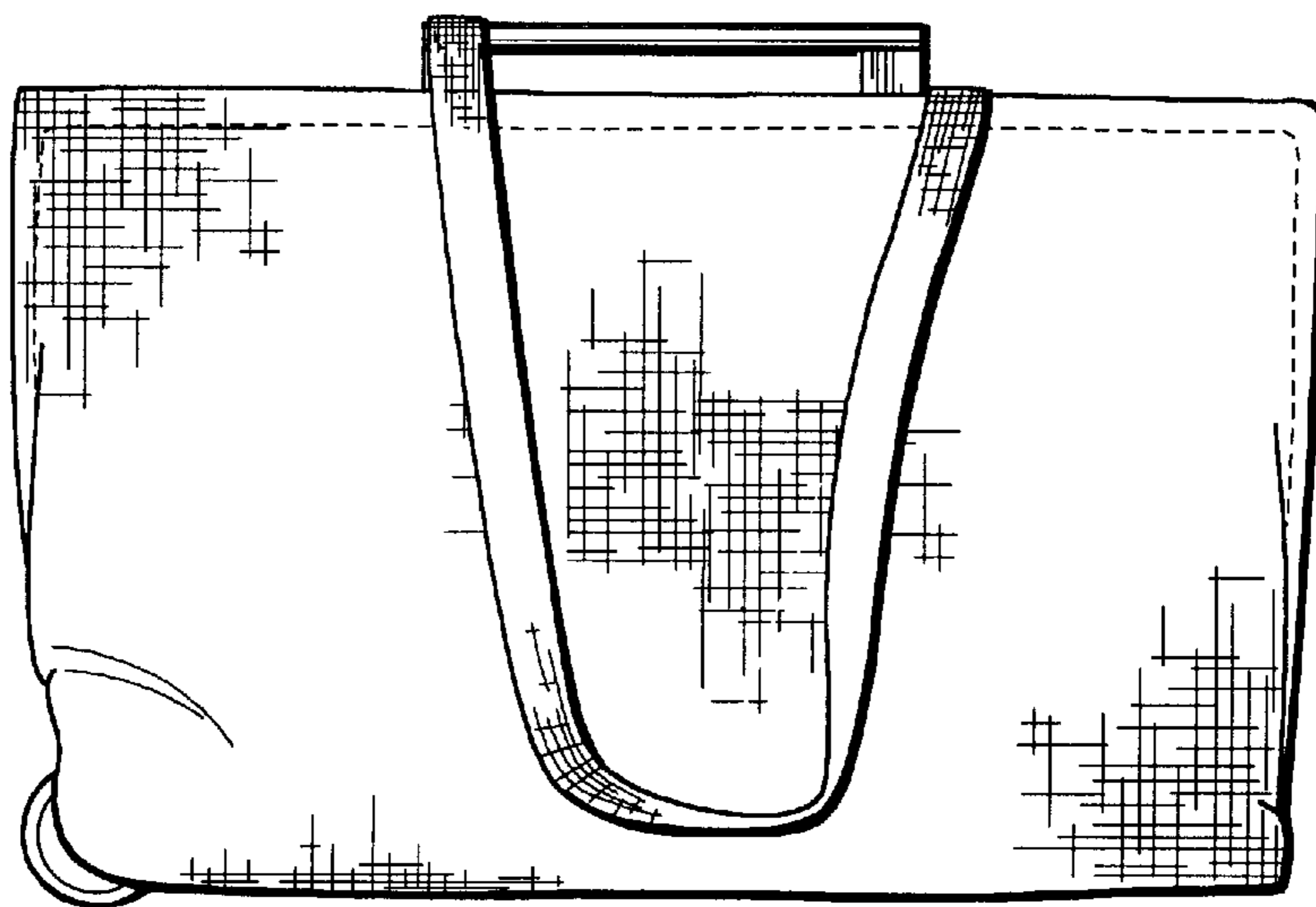
FIG. 8 is a left side view thereof, with the duffel shown in an unexpanded condition.

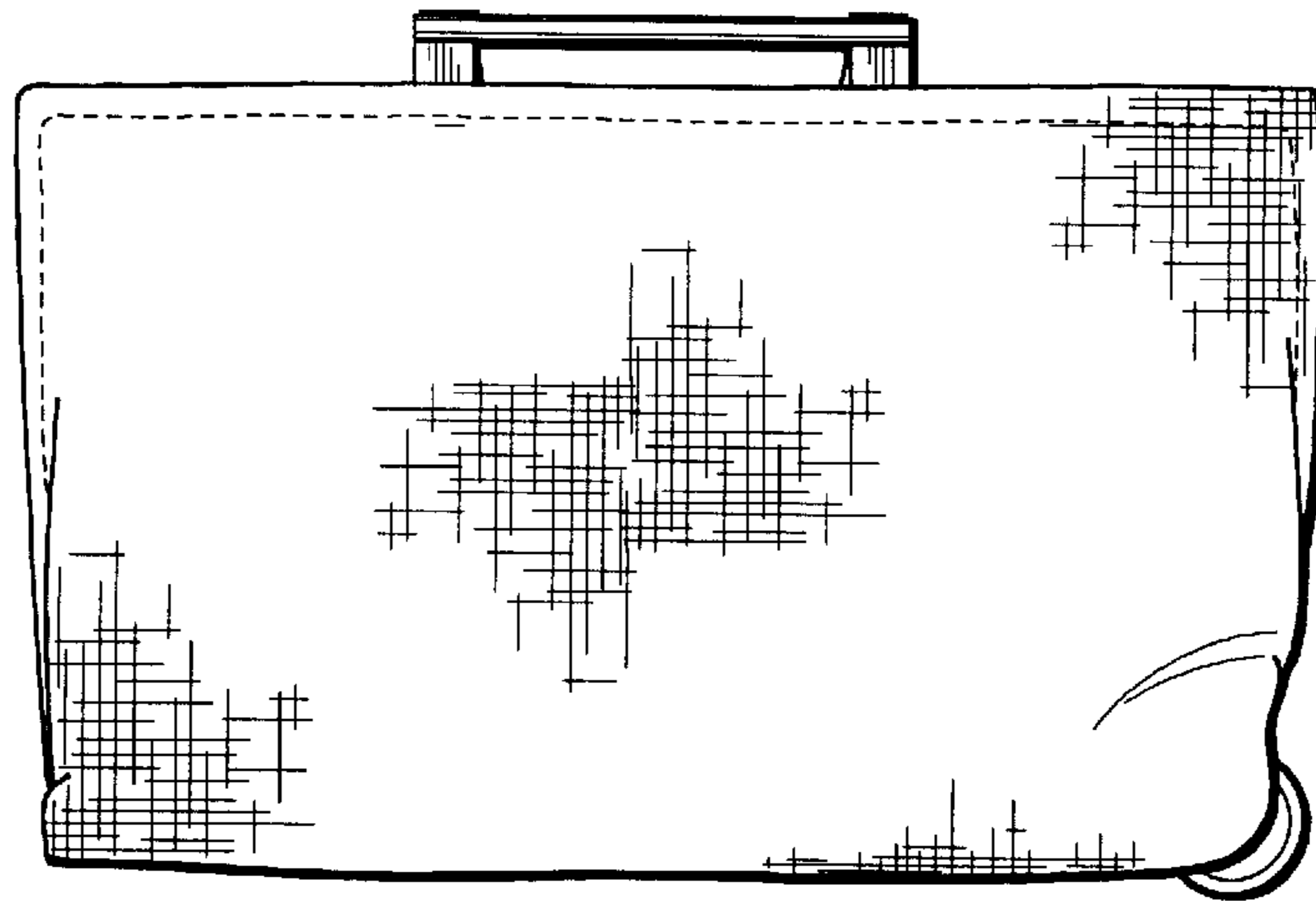




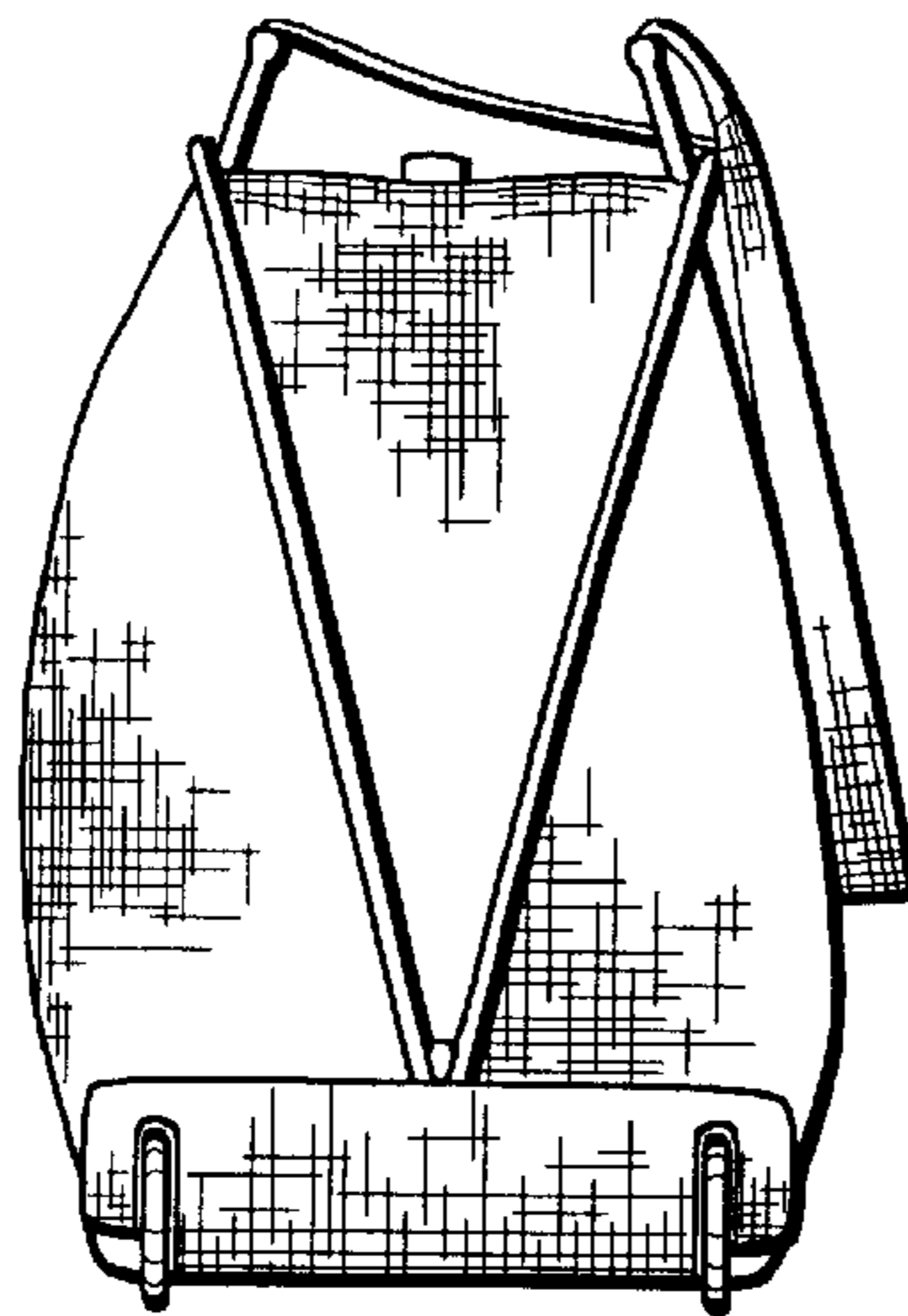

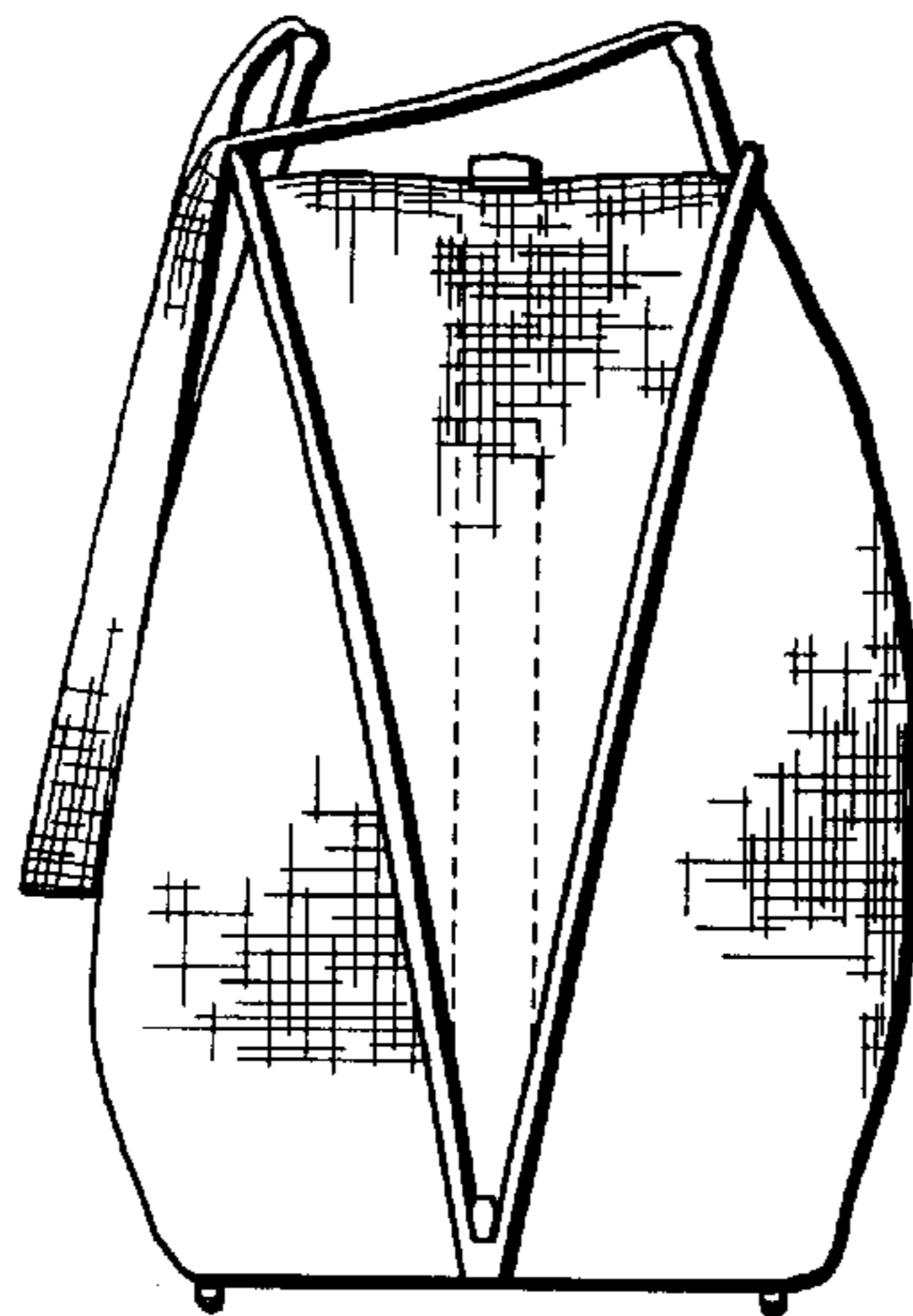

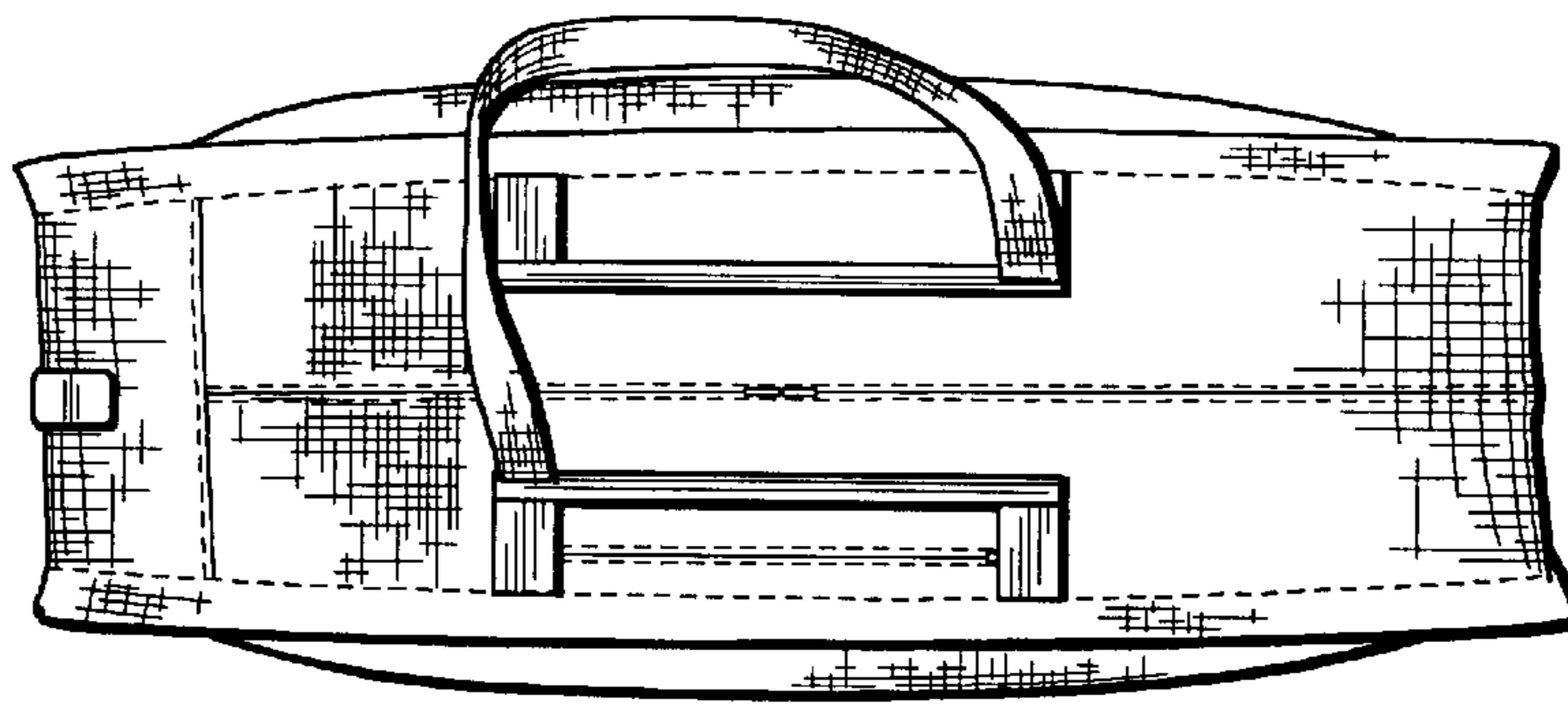

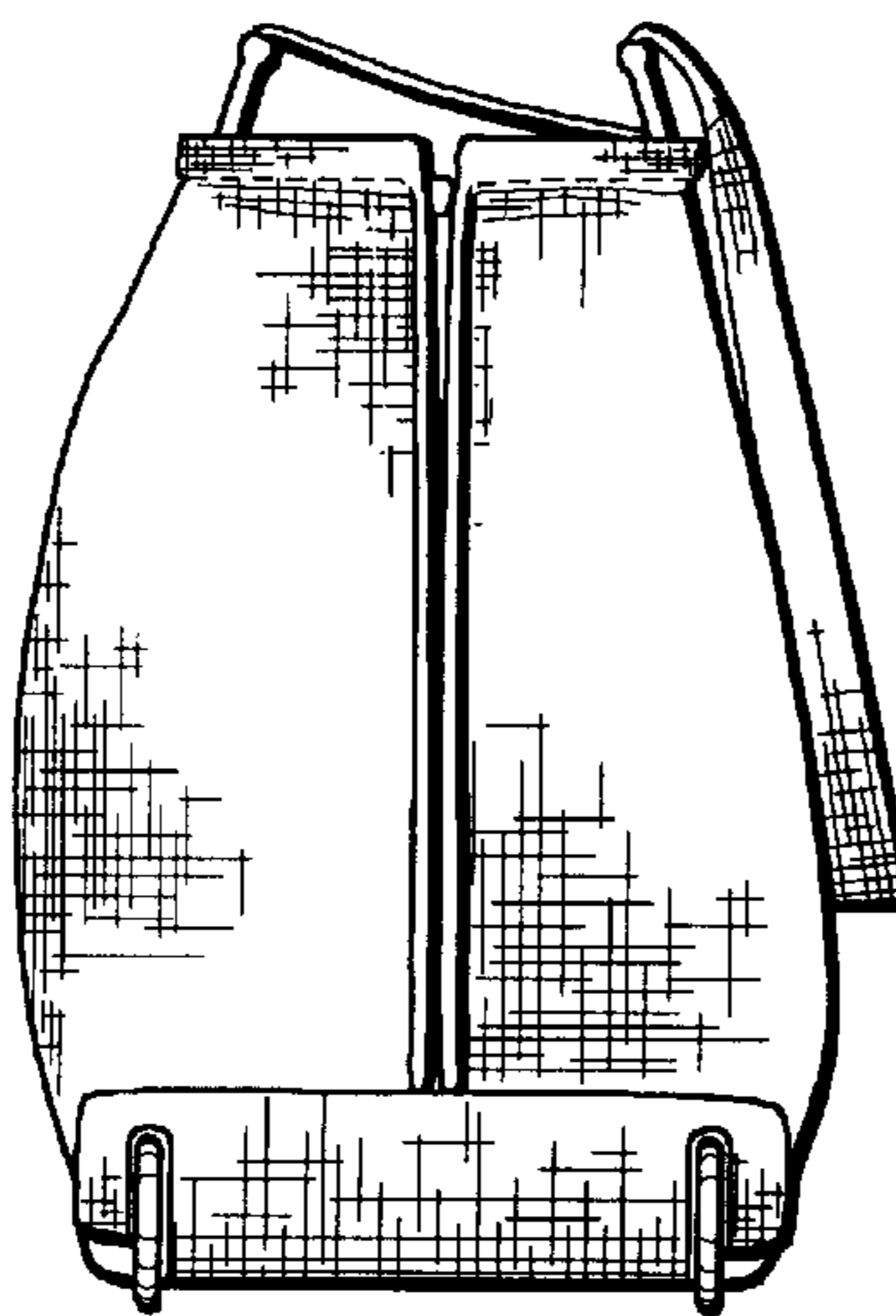
