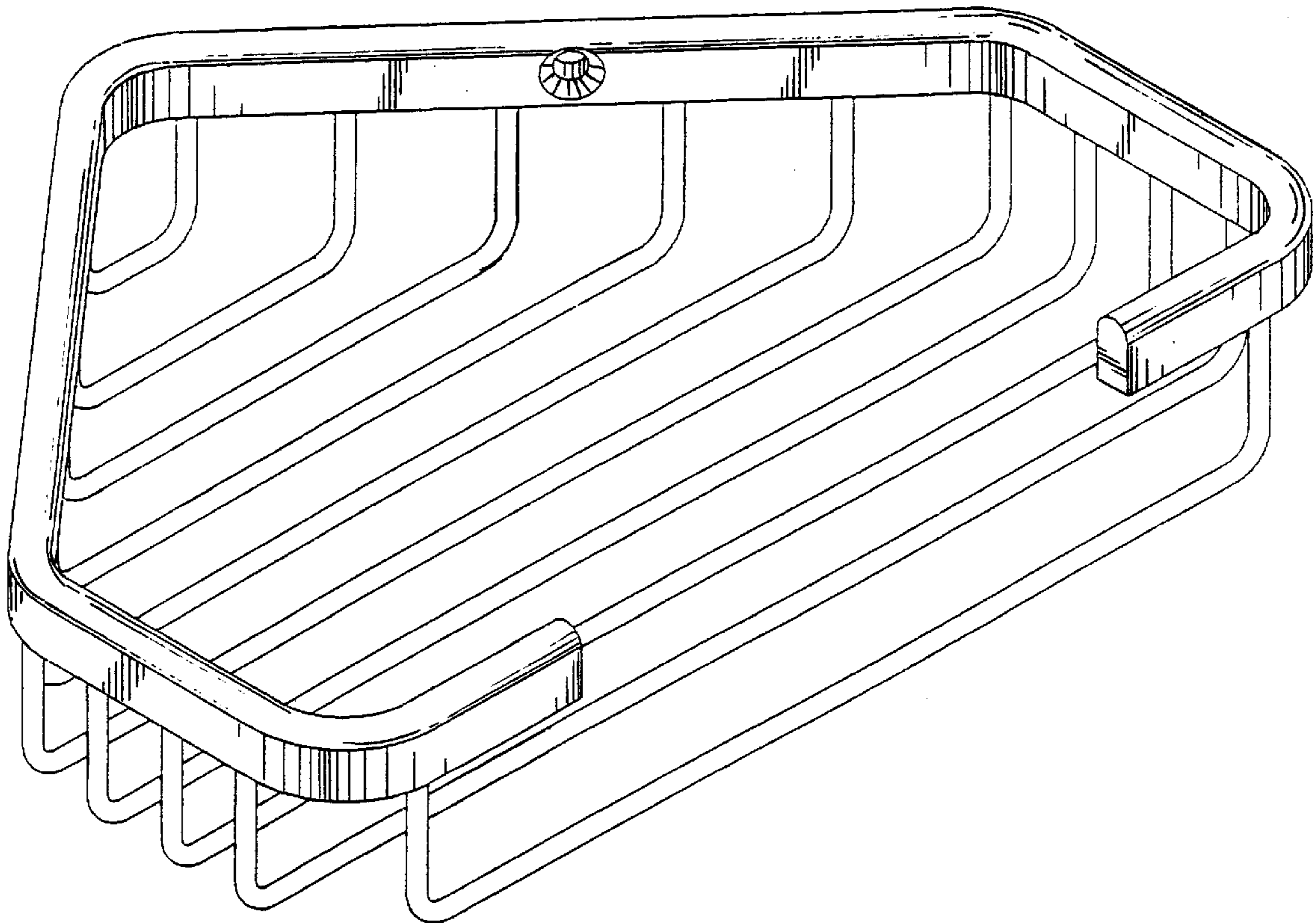
(57) **CLAIM**

The ornamental design for a front opening corner soap dish, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view thereof;
 FIG. 2 is a top view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a rear view thereof;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is a right side view thereof; and,
 FIG. 7 is a left side view, showing a similar countersunk mounting hole on the other right angled side portions of the soap dish's rim.

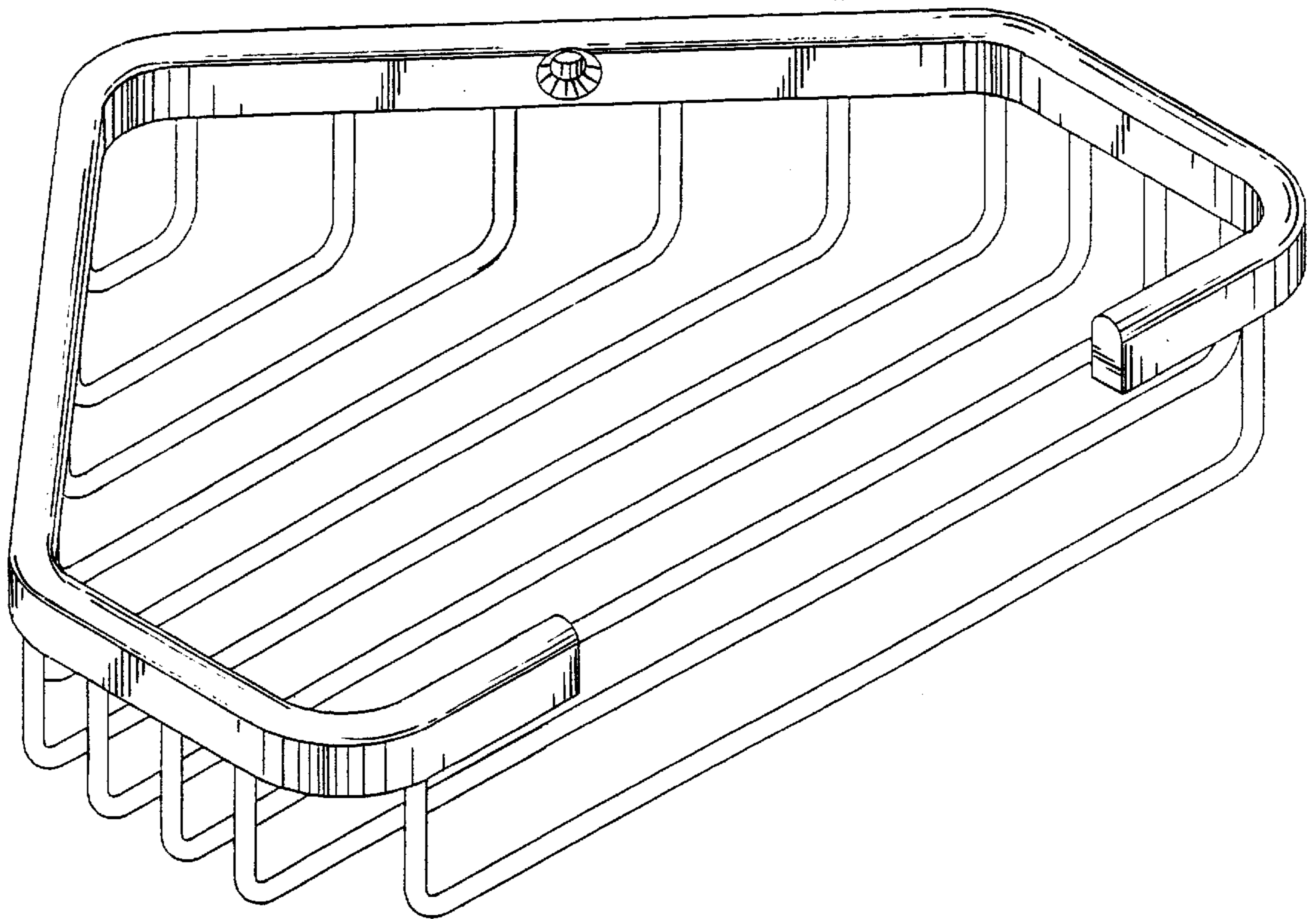

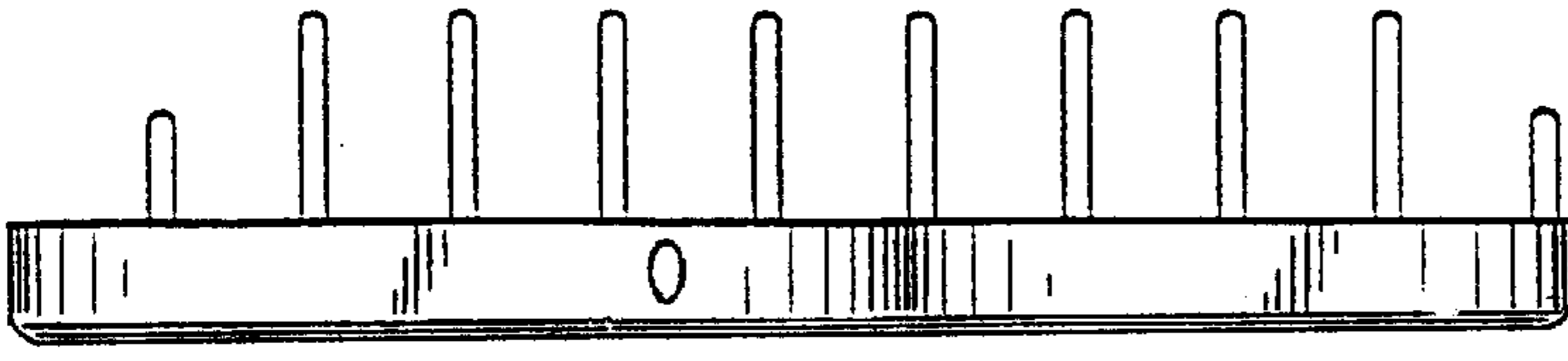

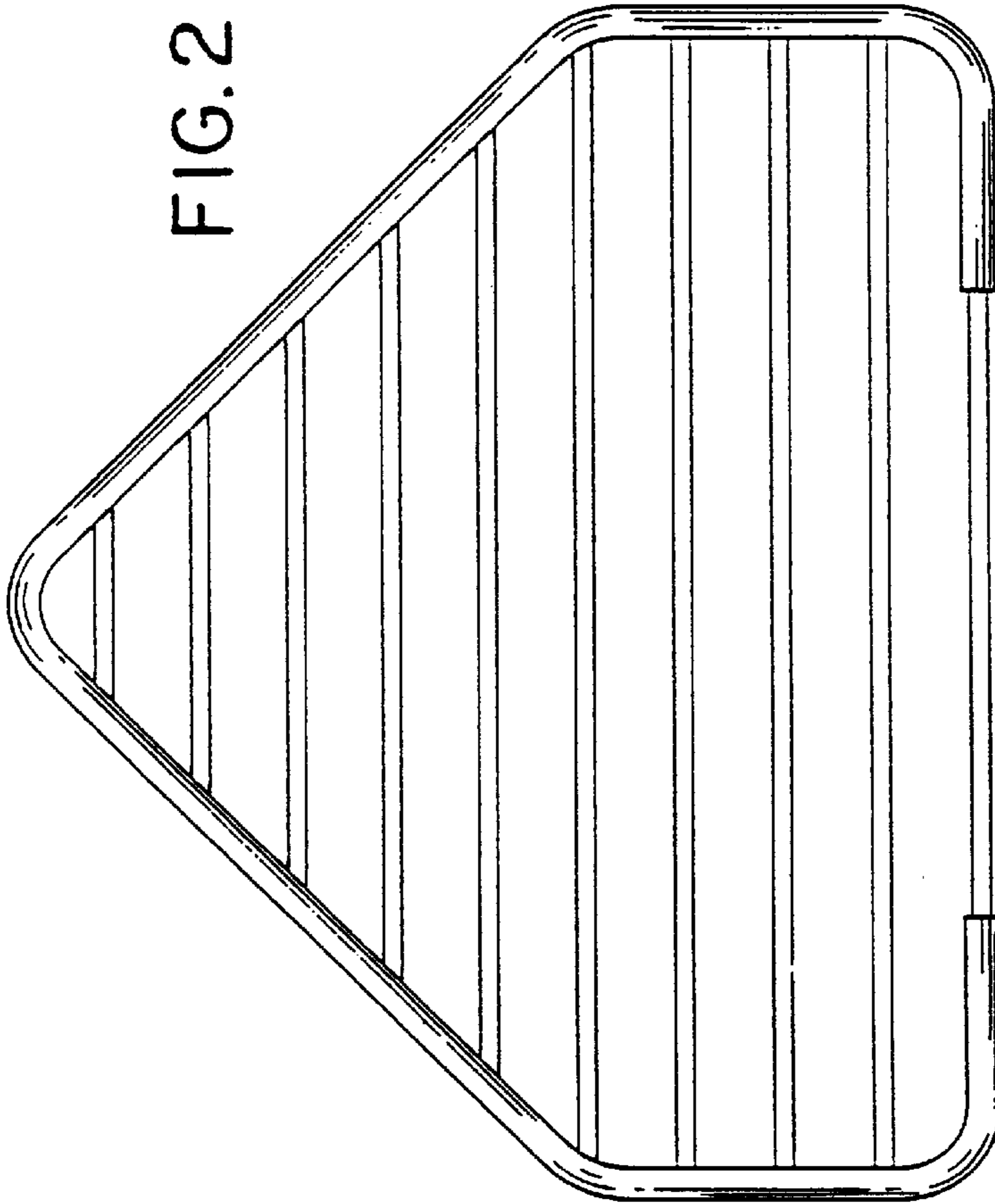

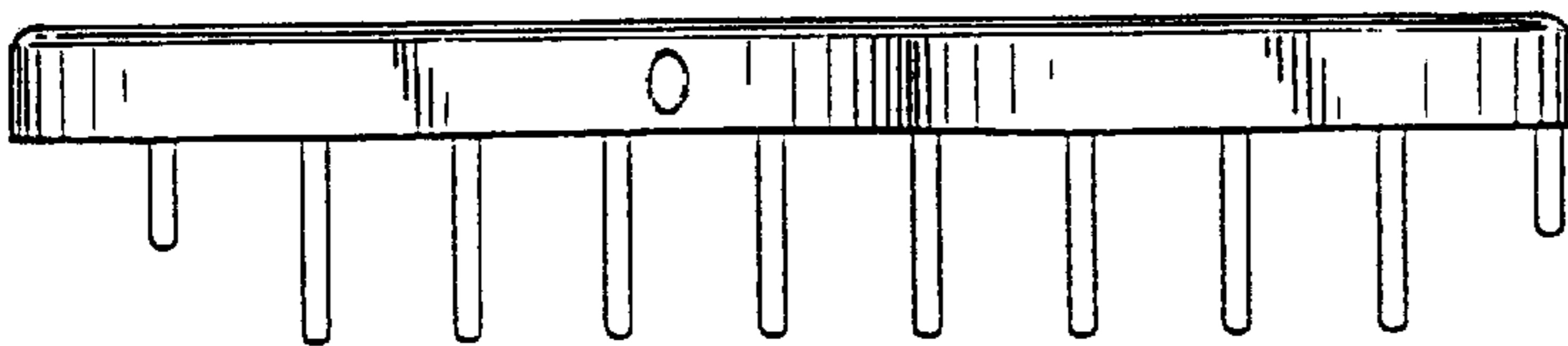

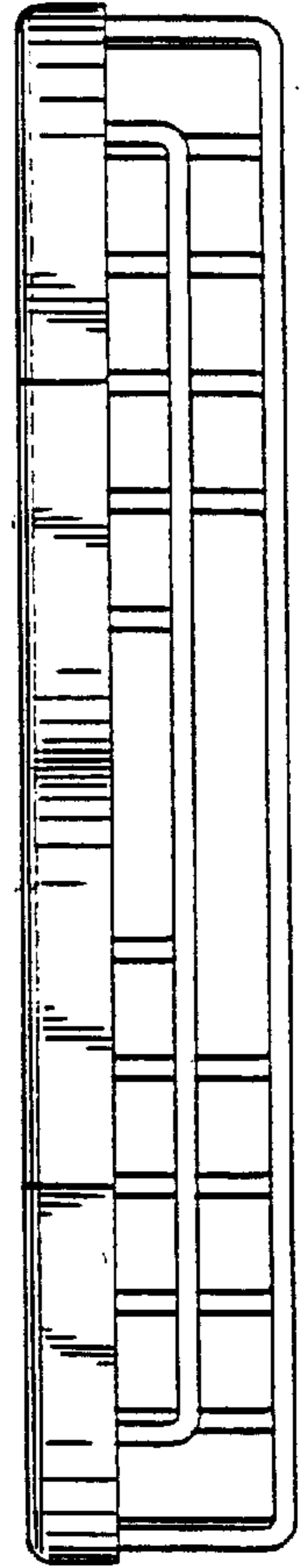

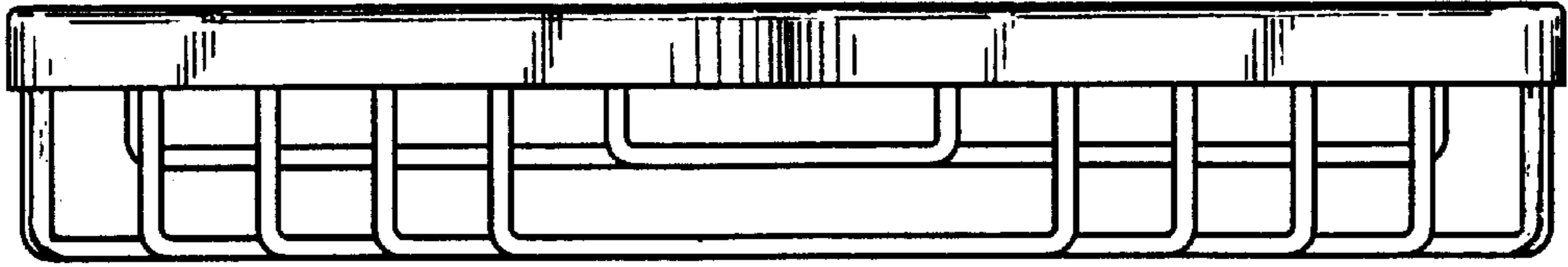

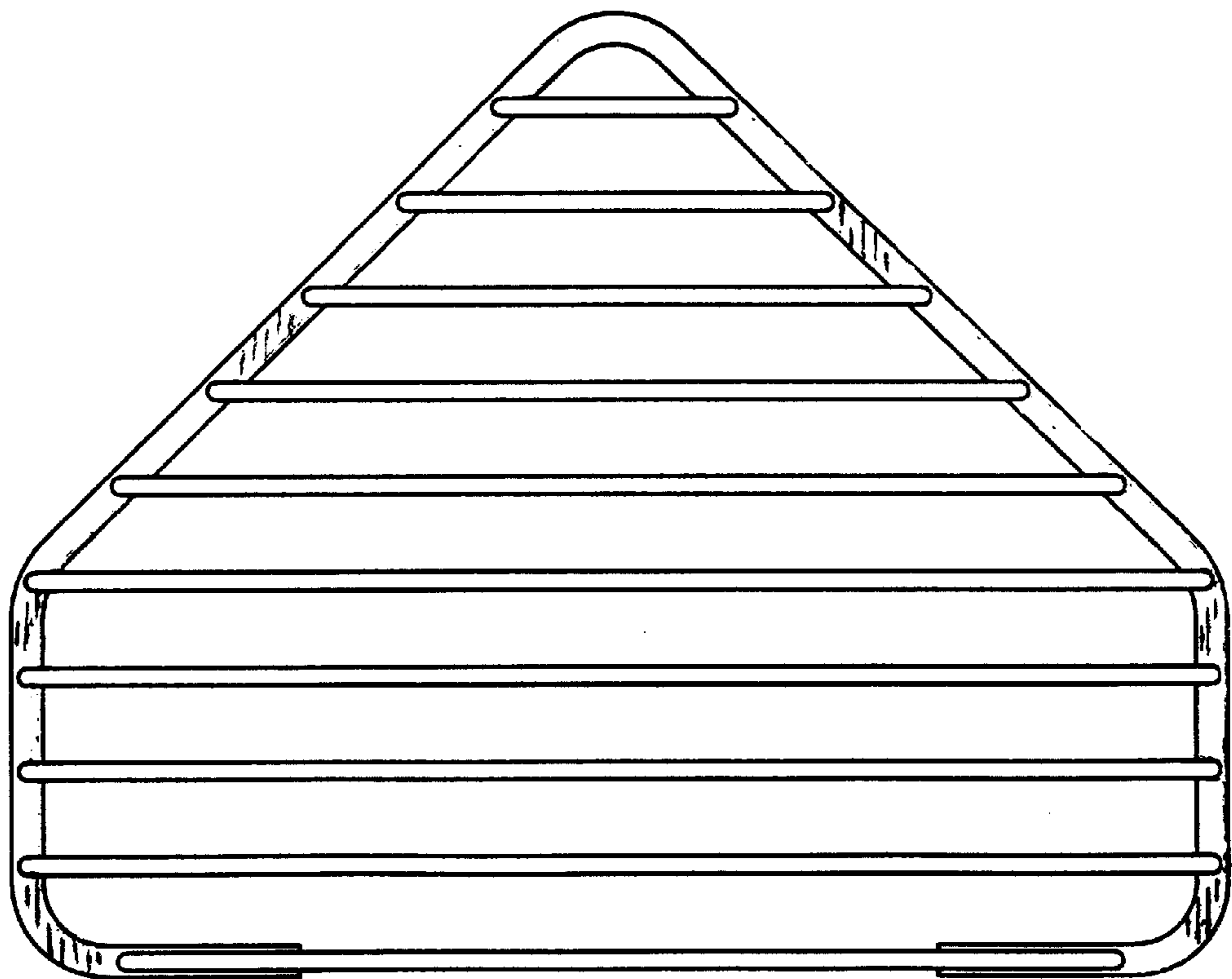
