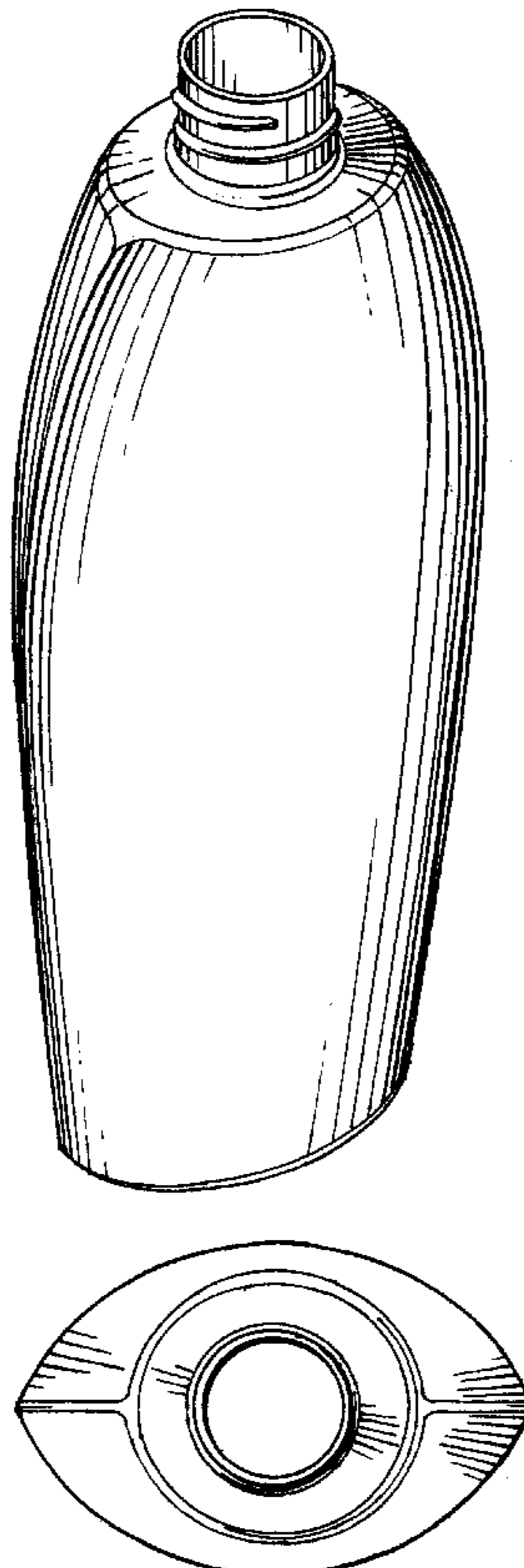
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bottle showing my new design;
 FIG. 2 is a front elevational view thereof, the rear being a mirror image, except for the threads;
 FIG. 3 is a left side elevational view thereof, the right side being a mirror image, except for the threads; and,
 FIG. 4 is a top plan view thereof.

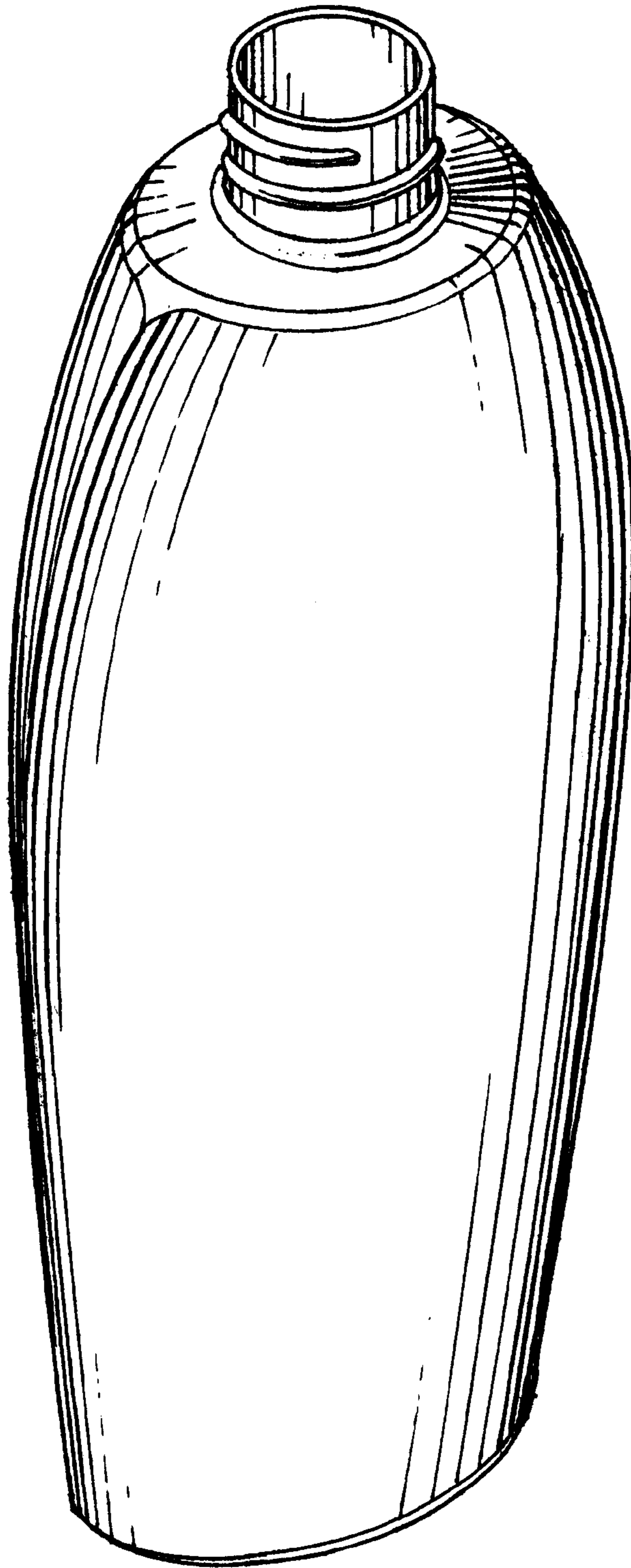

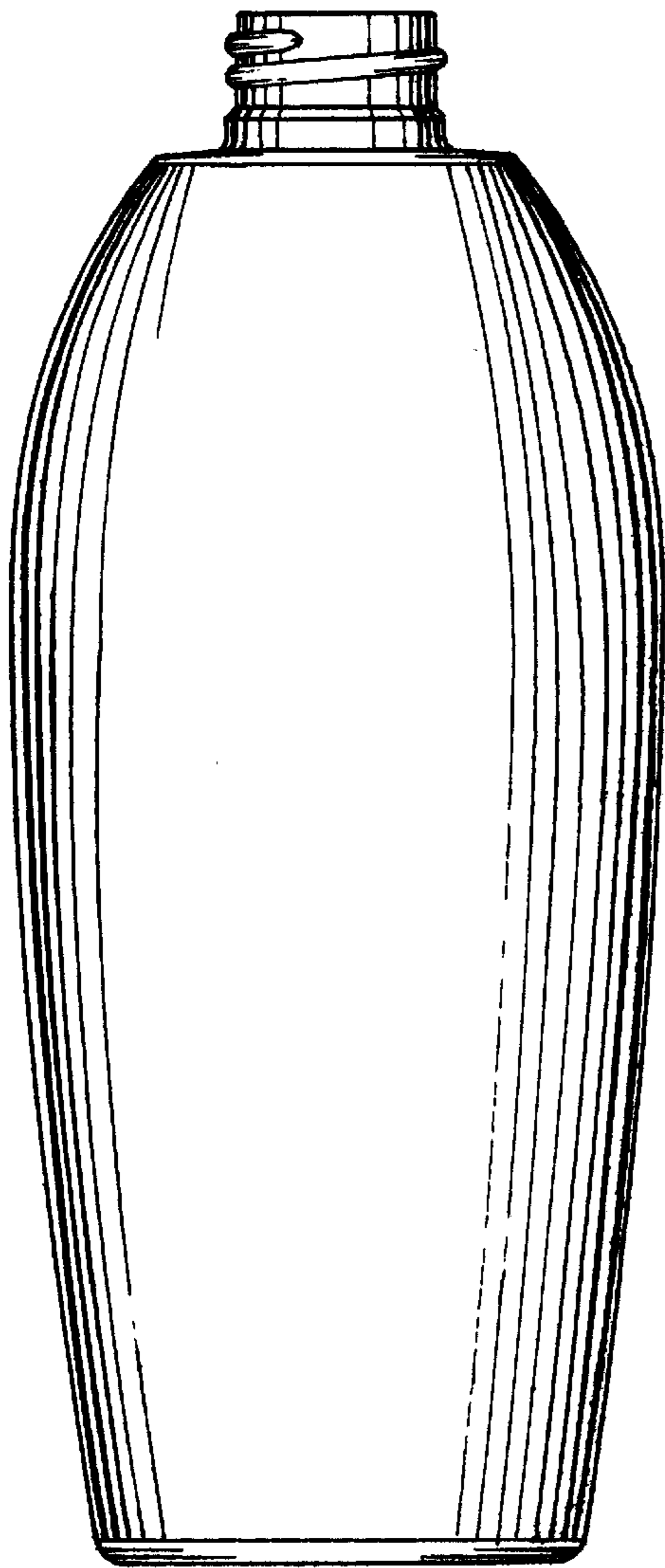

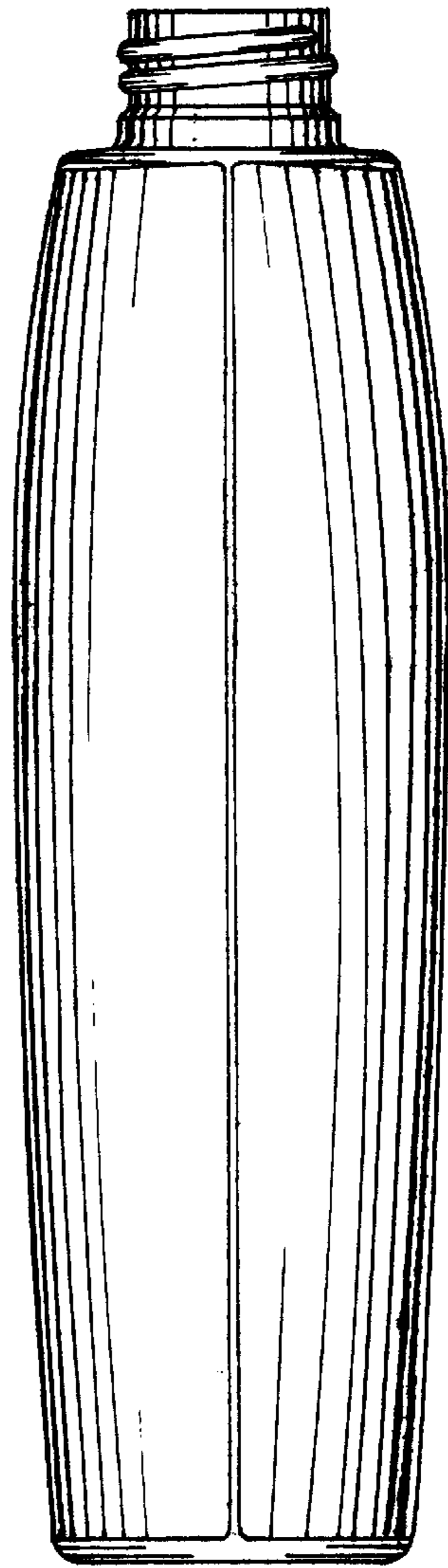

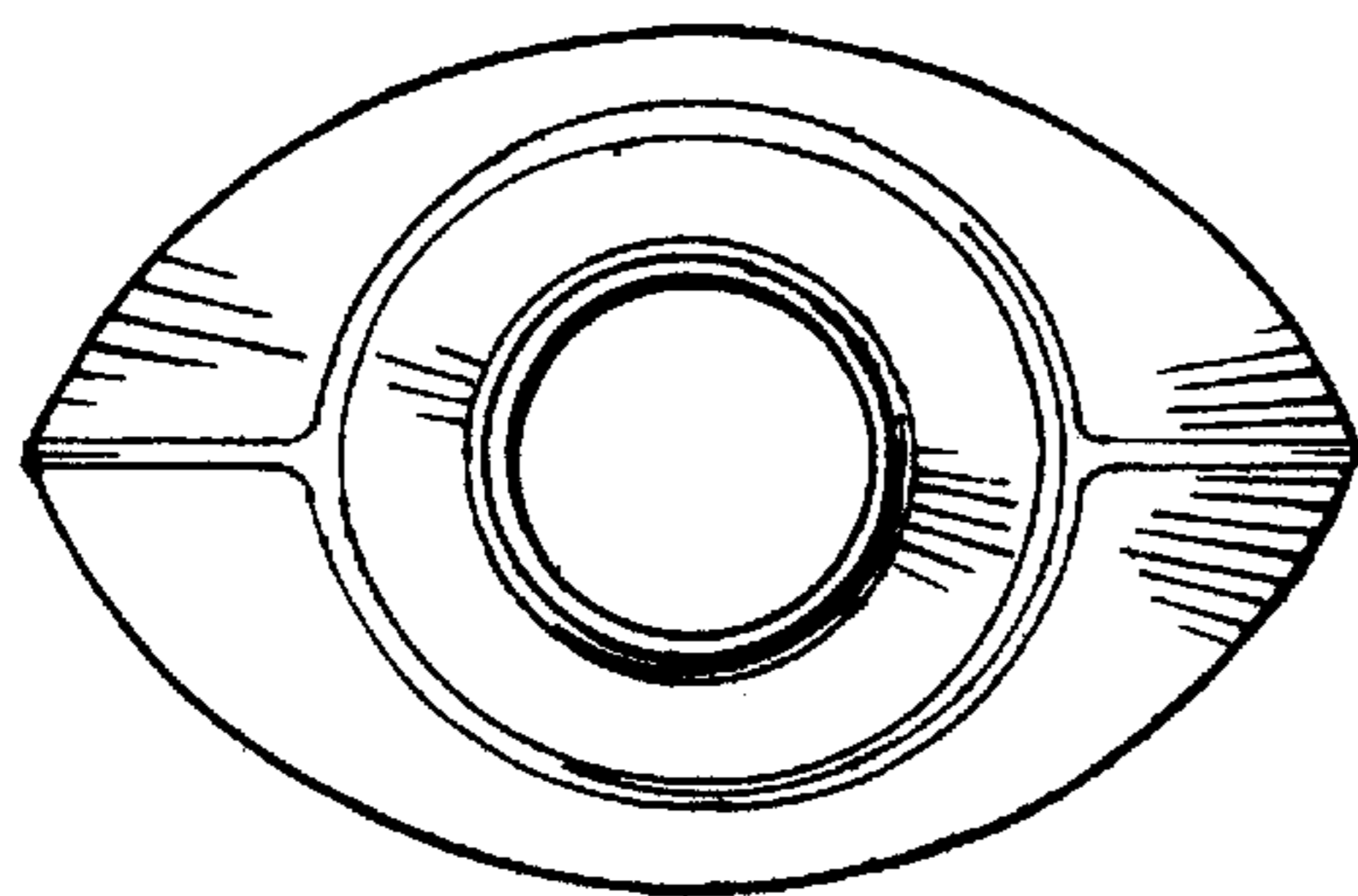
