(57) **CLAIM**

The ornamental design for a personal steam cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a right side, front perspective view of a personal steam cabinet showing my new design, in closed position; FIG. 2 is a front view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof, in open position; FIG. 6 is a right side view thereof; FIG. 7 is a top view of FIG. 1; FIG. 8 is a top view of FIG. 5; FIG. 9 is a front perspective view of FIG. 5; FIG. 10 is a front perspective view of a second embodiment of the personal steam cabinet, in open position; FIG. 11 is a right side, front perspective view thereof, in closed position; FIG. 12 is a left side view thereof; and, FIG. 13 is a right side view thereof. The bottom views of both embodiments are flat and unornamented. The broken line showing is for illustrative purposes only and forms no part of the claimed design.

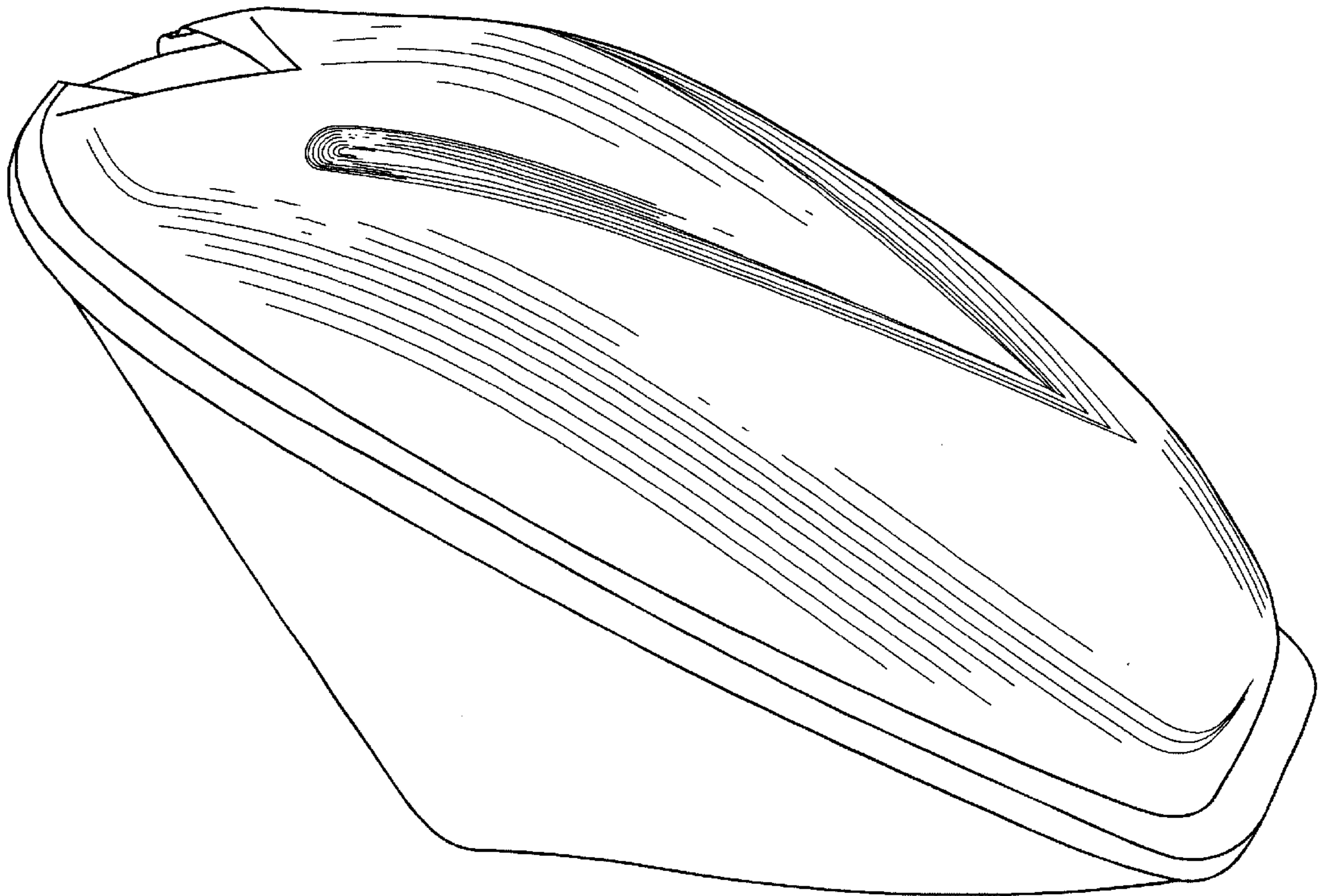
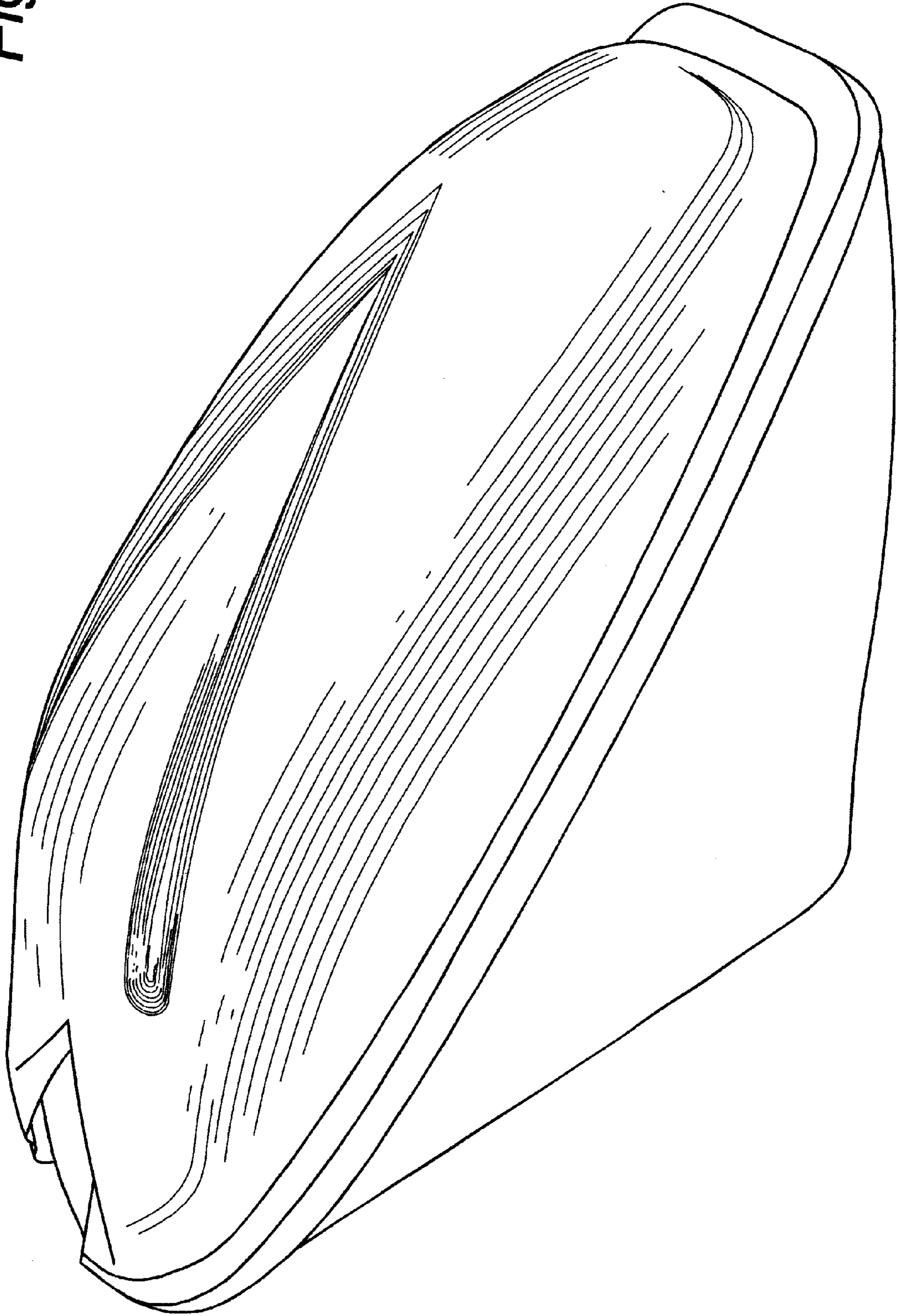

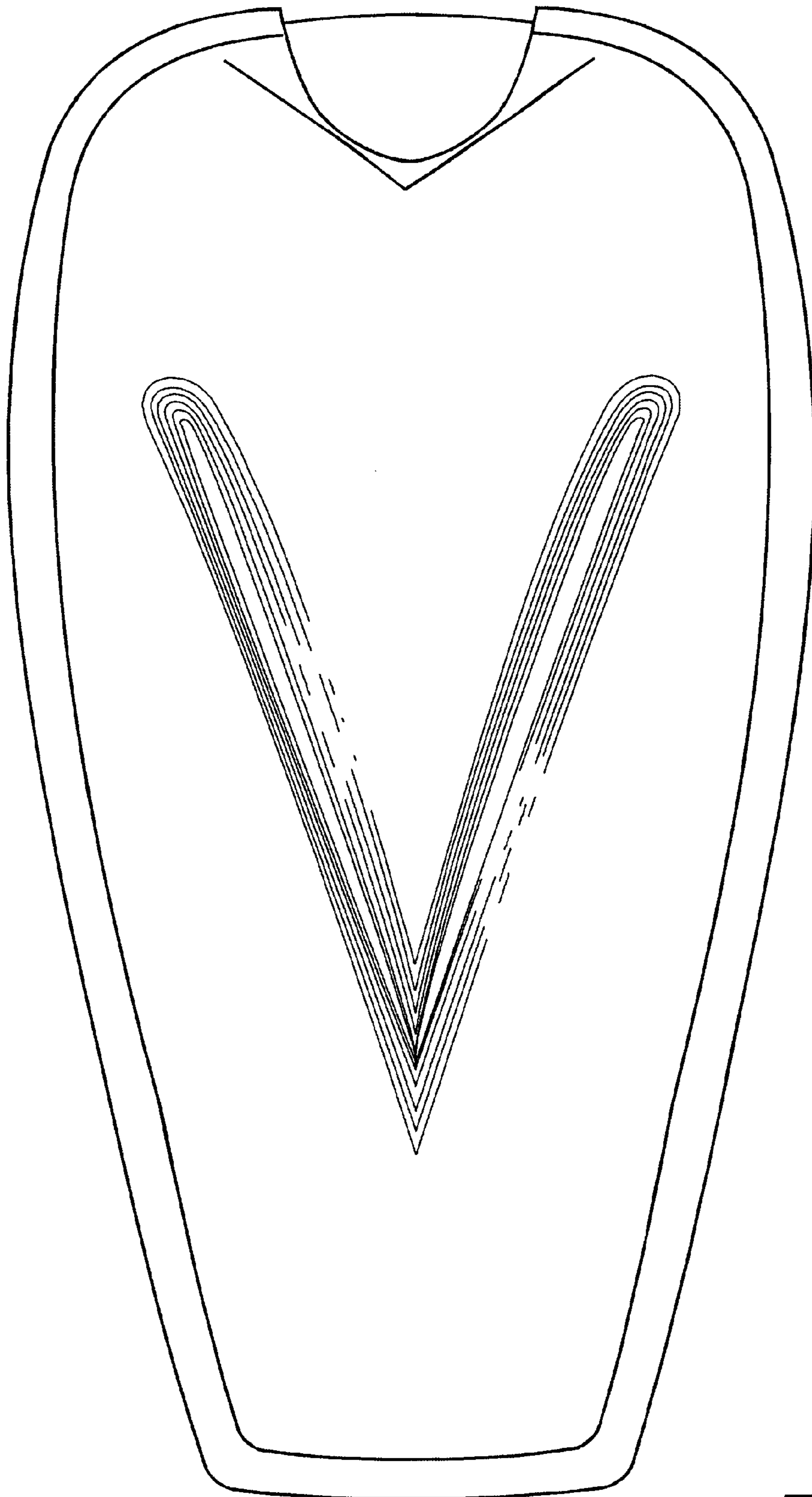

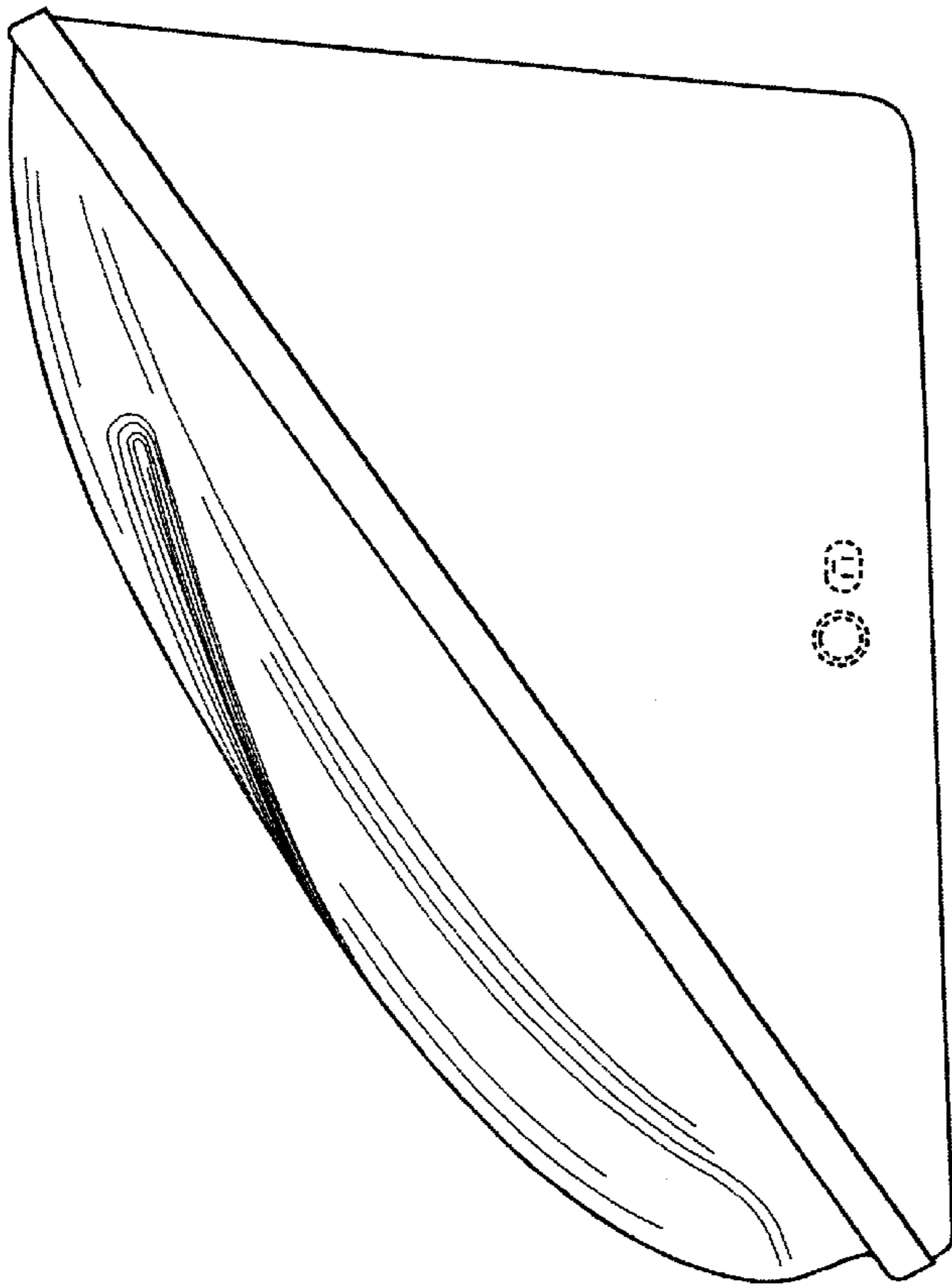

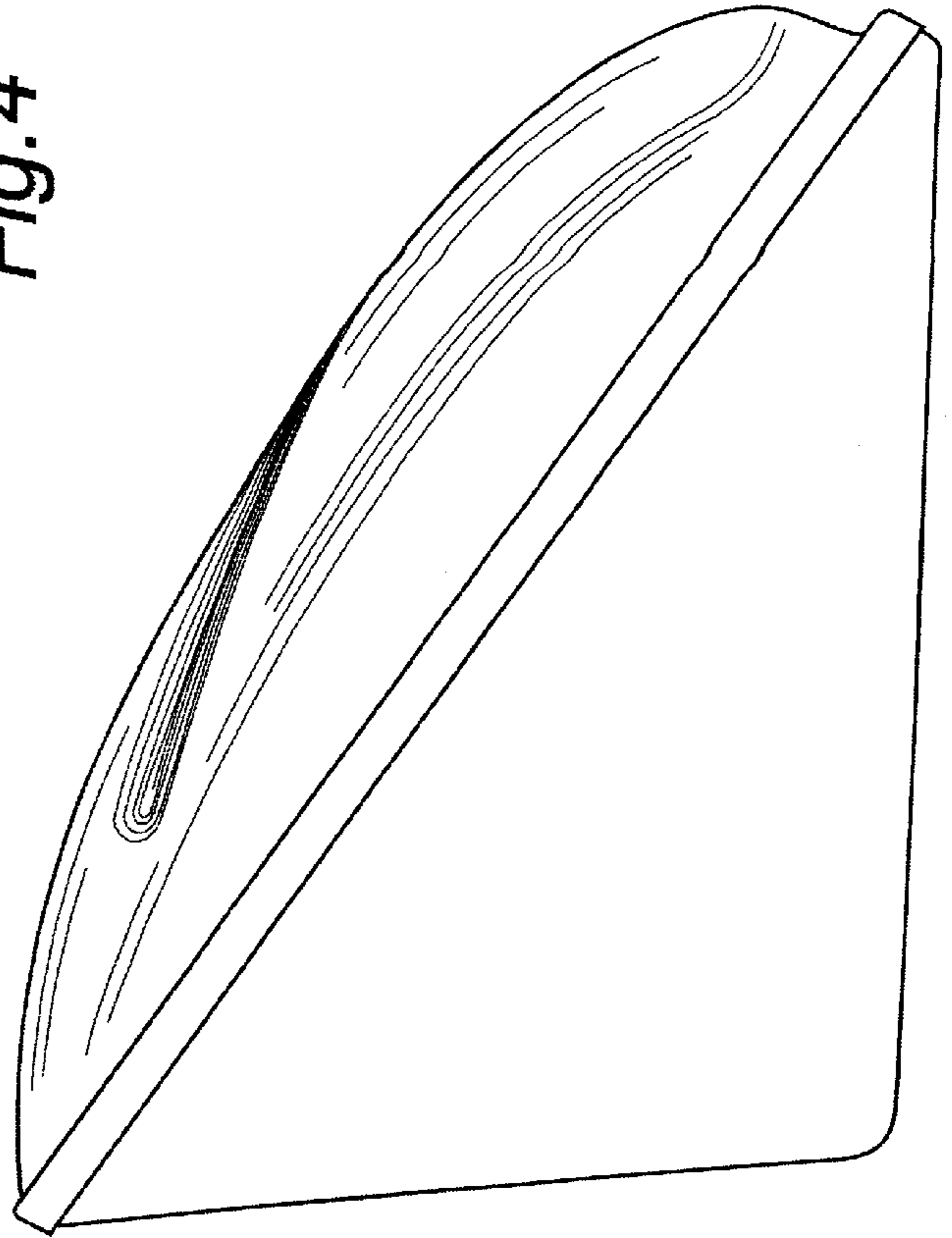

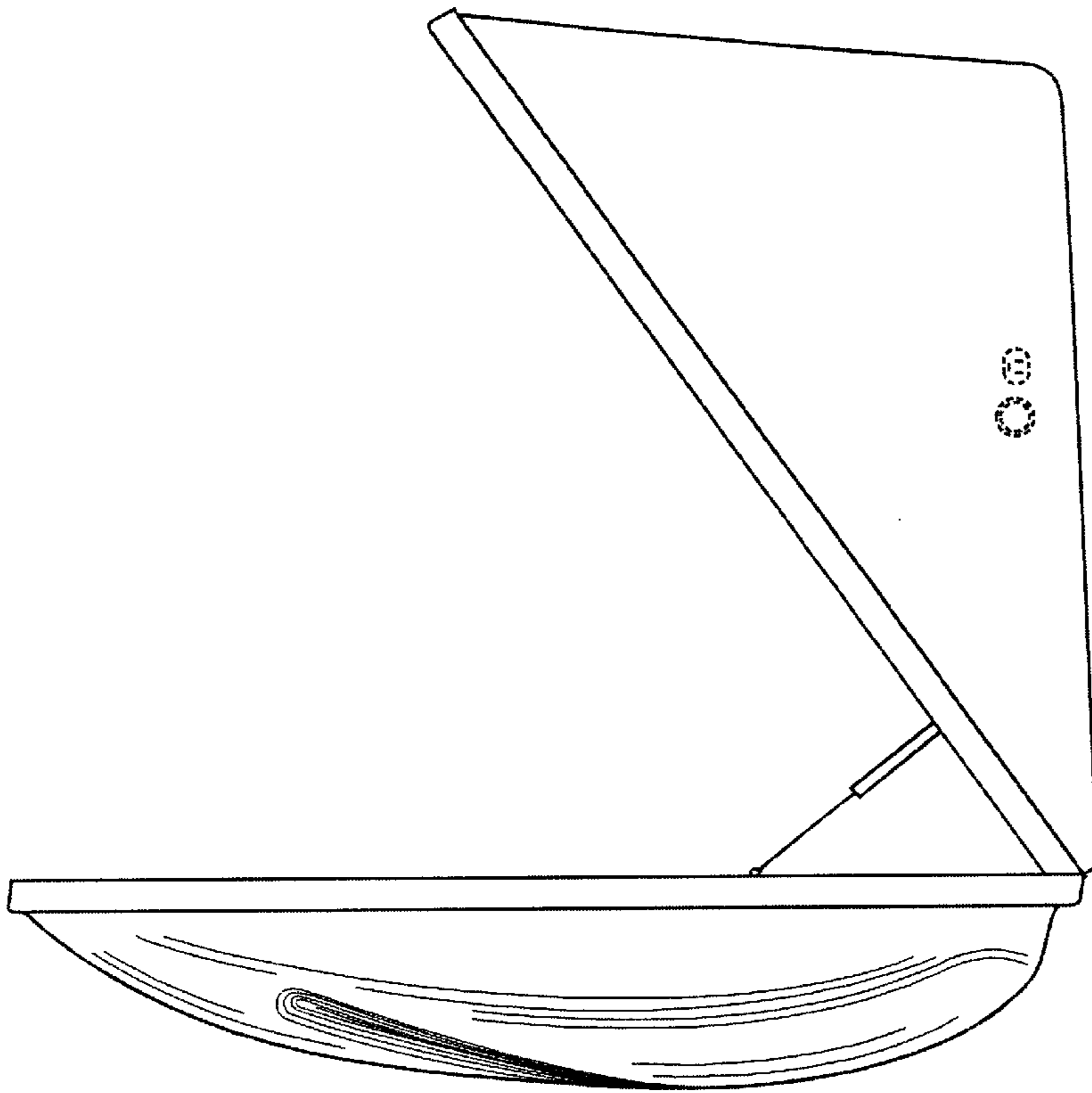
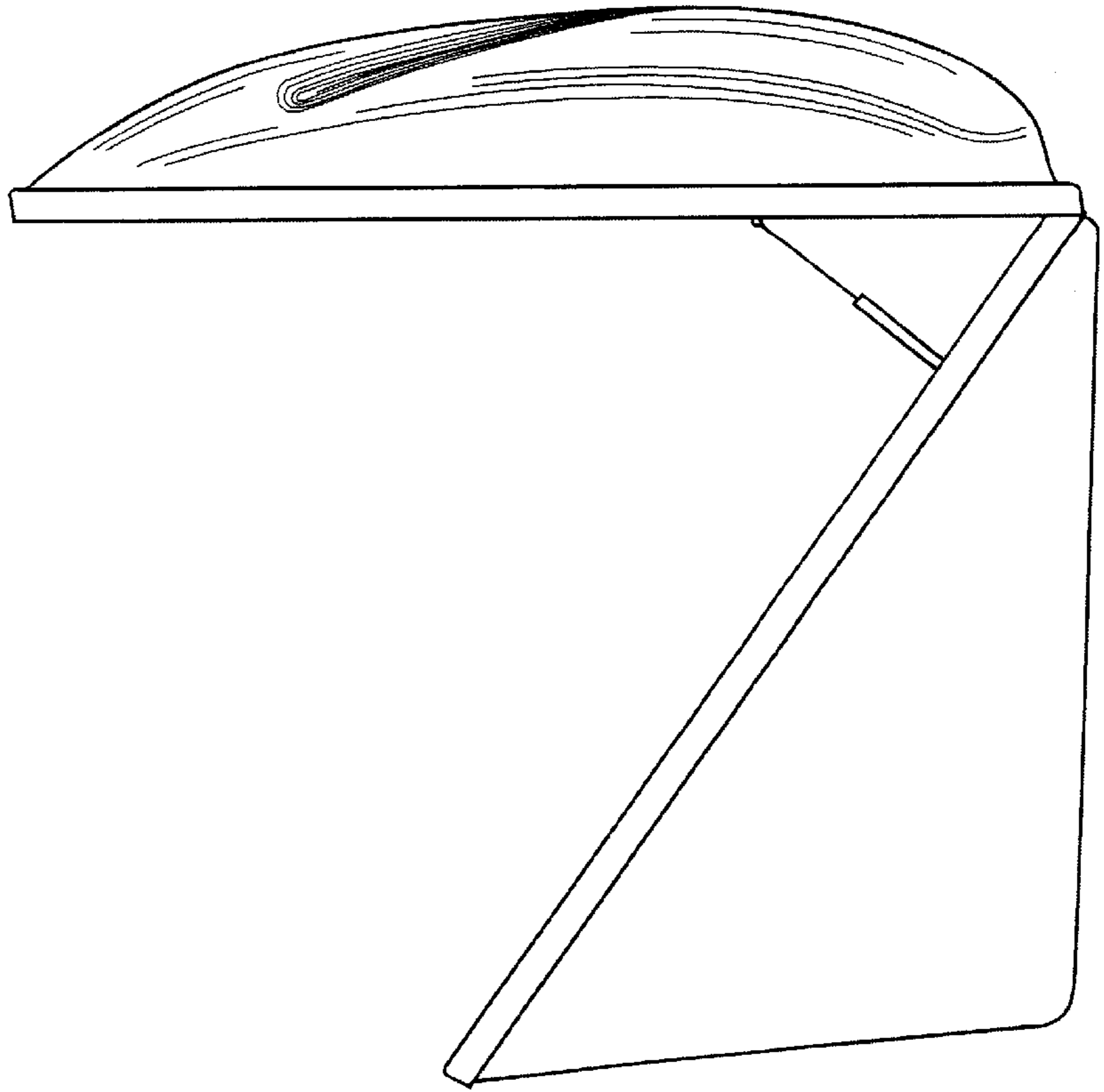

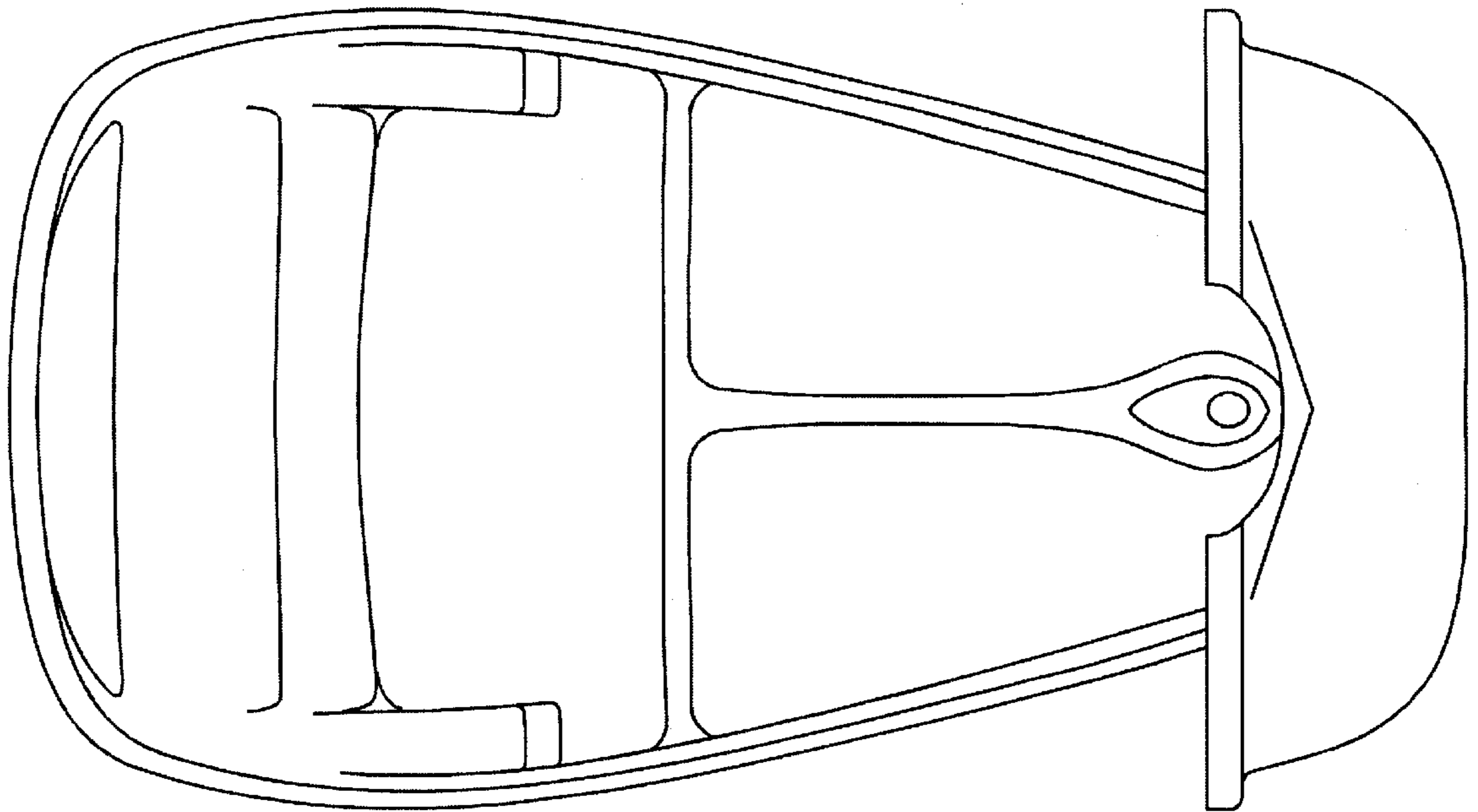

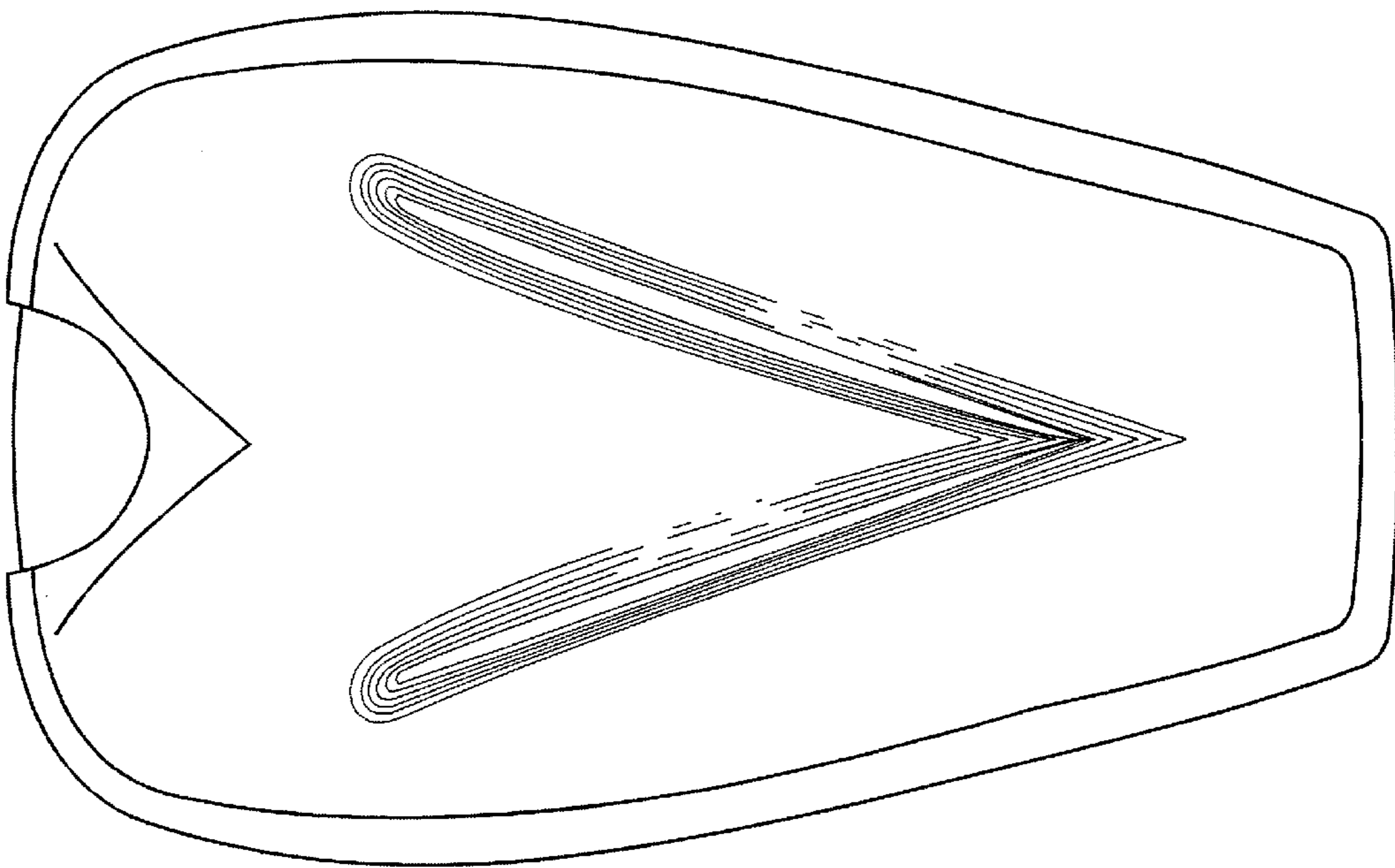

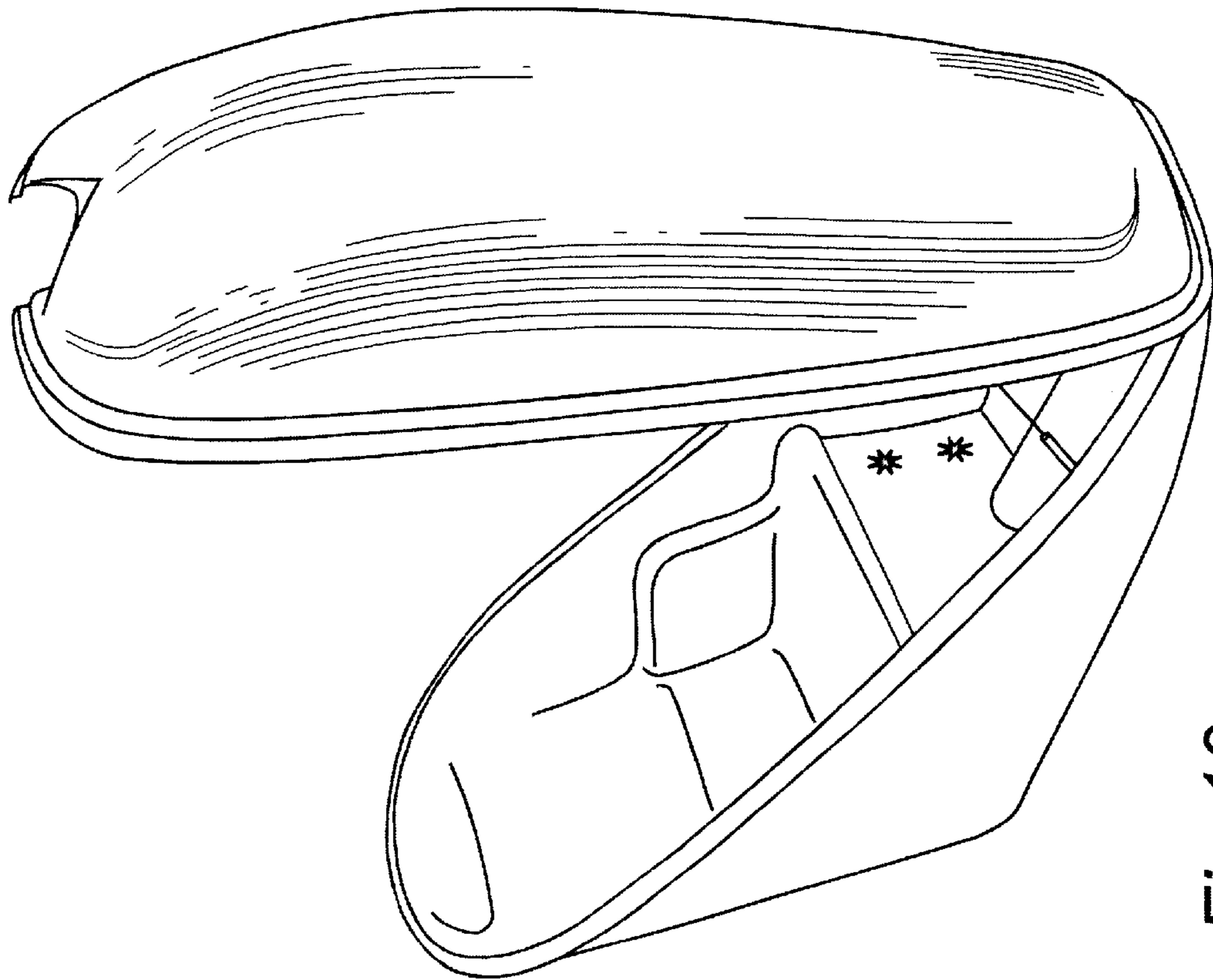

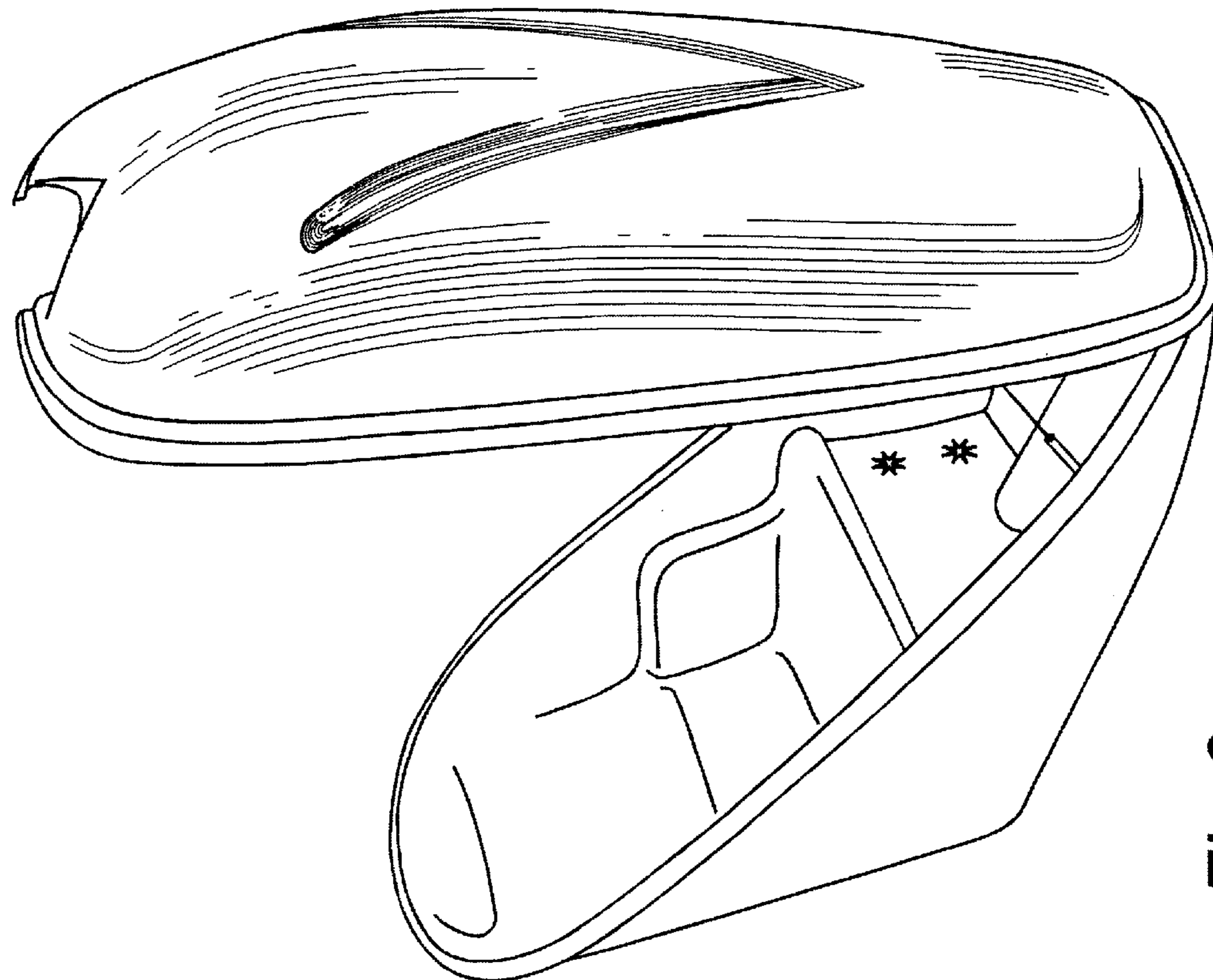

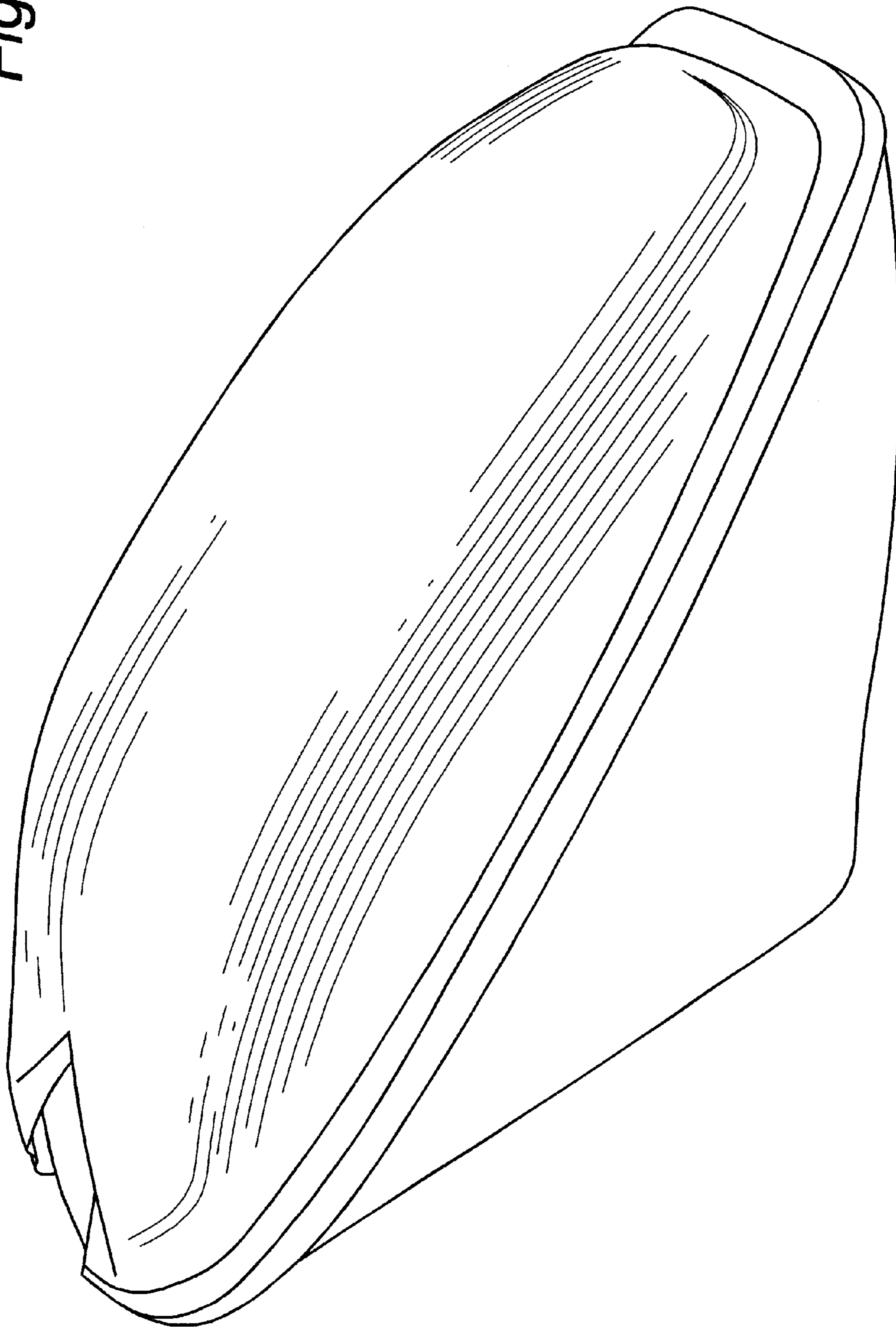

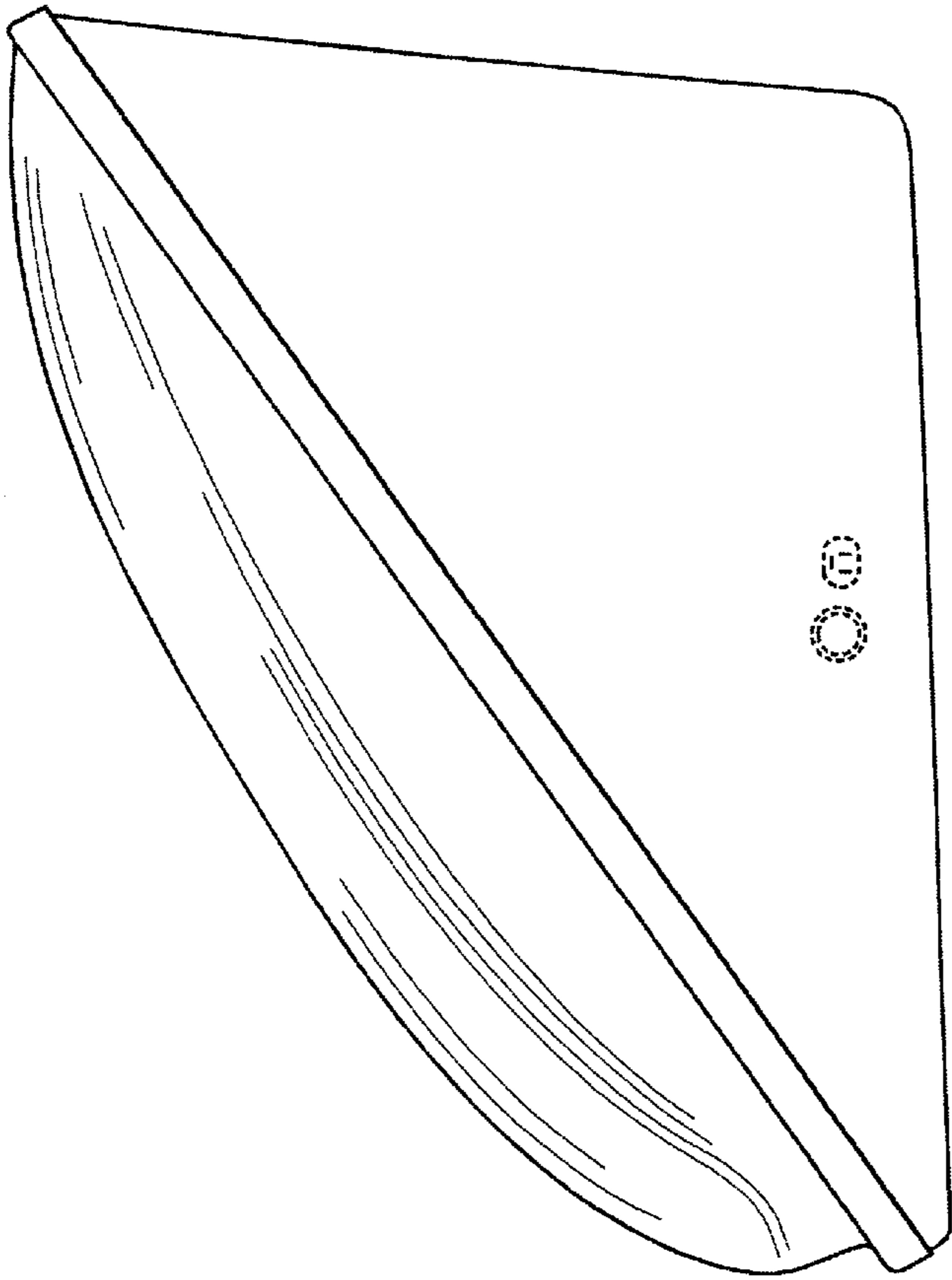
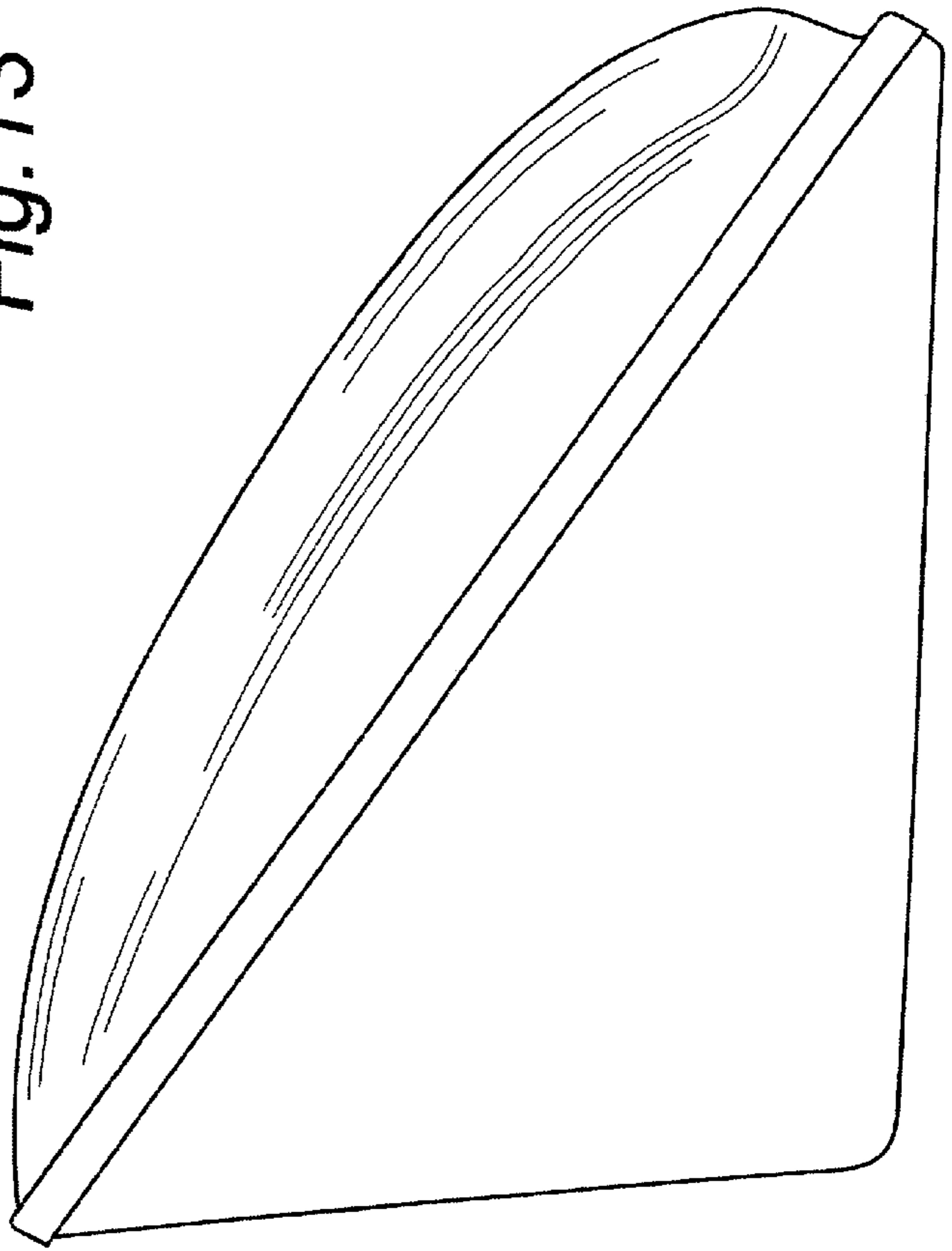
