(57) **CLAIM**

The ornamental design for a self-service terminal, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a self-service terminal showing my new design;

FIG. 2 is a left front perspective view from FIG. 1 the right front perspective view is a mirror image, the bottom and rear are not part of the claimed design;

FIG. 3 is a front view showing my design in a second embodiment;

FIG. 4 is a left front perspective view of the second embodiment, the right front perspective view is a mirror image, the bottom and rear are not part of the claimed design;

FIG. 5 is a front view showing my design in a third embodiment; and,

FIG. 6 is a left front perspective view of the third embodiment, the right front perspective view is a mirror image, the bottom and rear are not part of the claimed design.

The broken line showing of the terminal is for illustrative purposes only and forms no part of the claimed design.

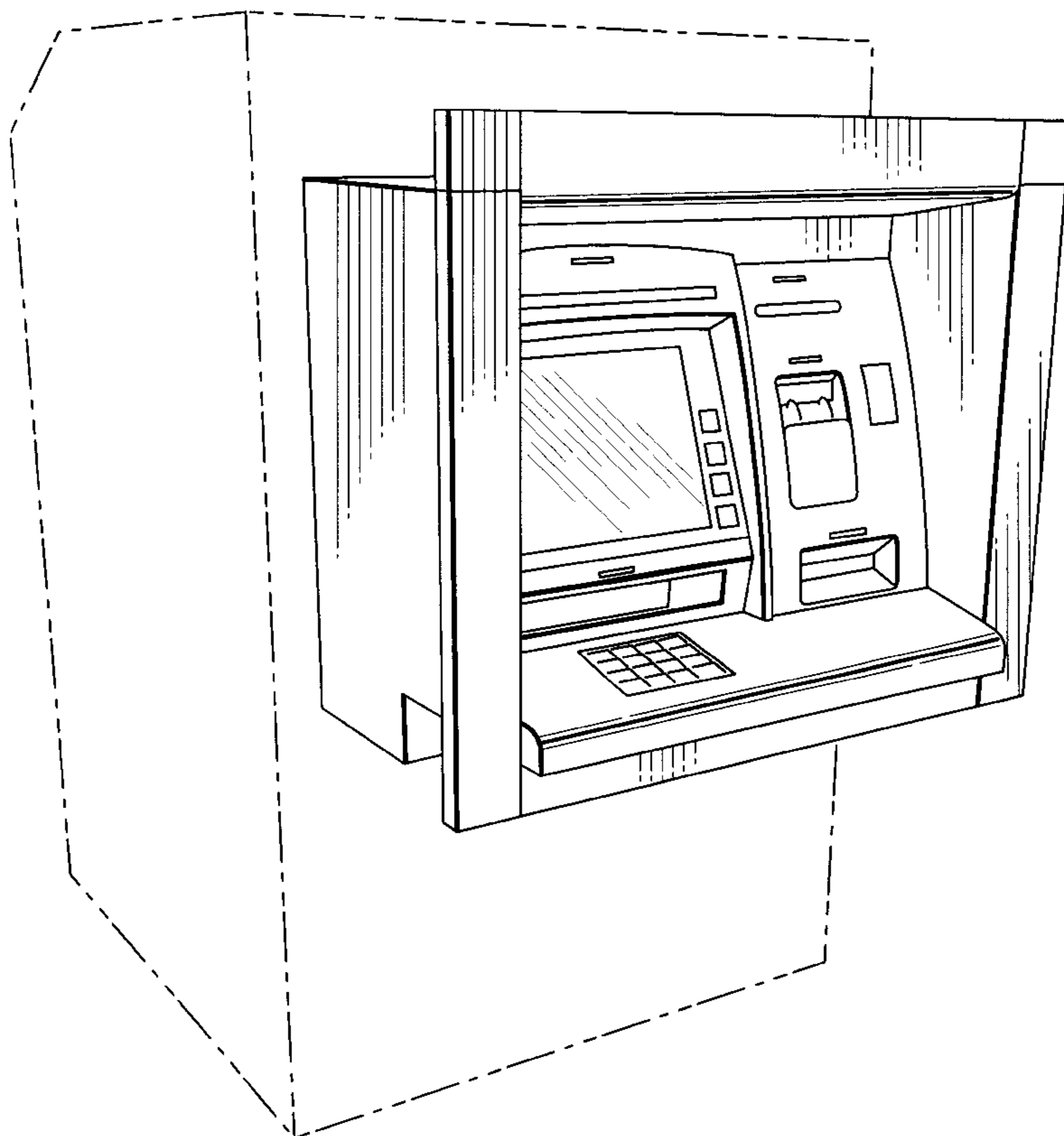

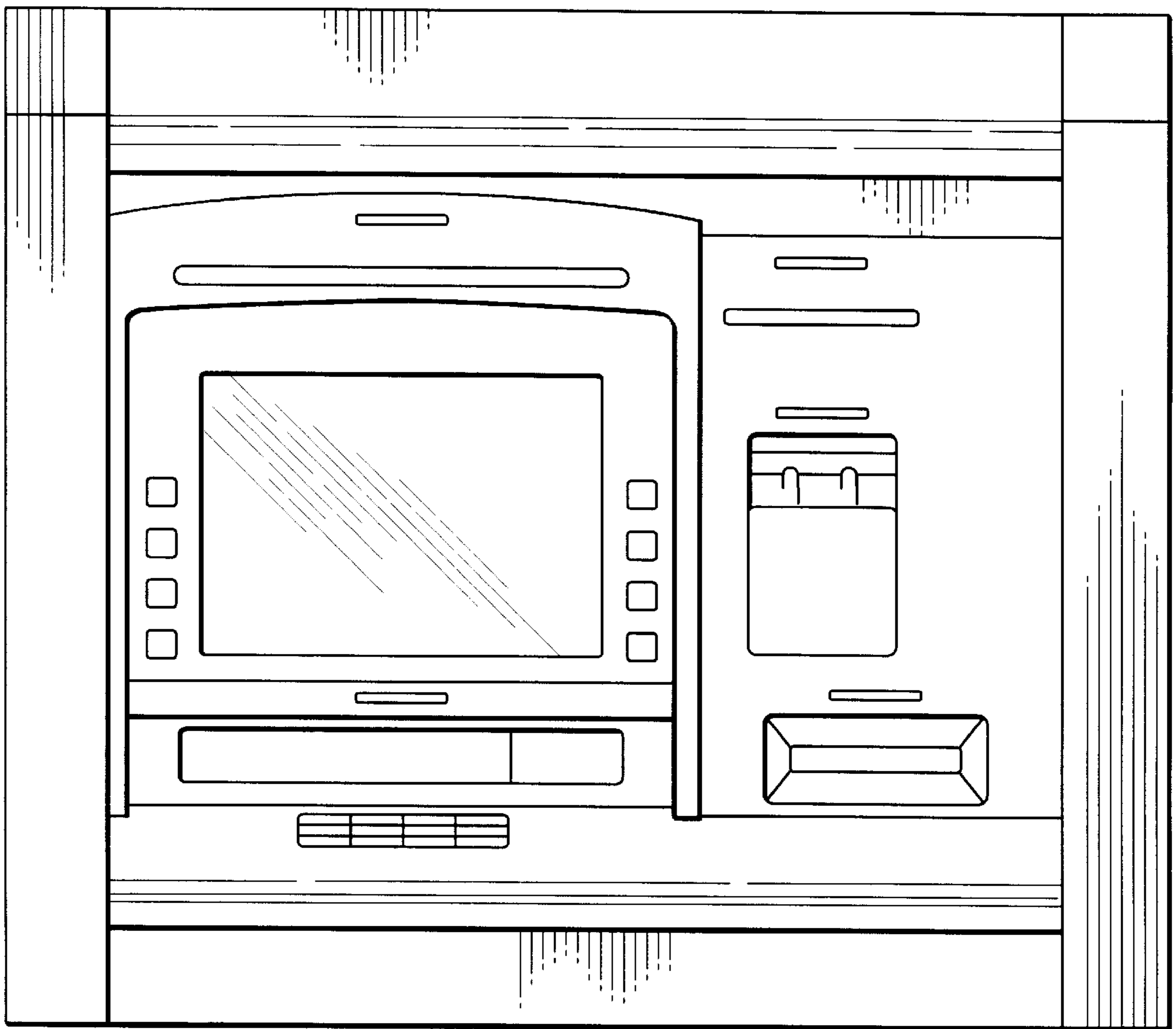

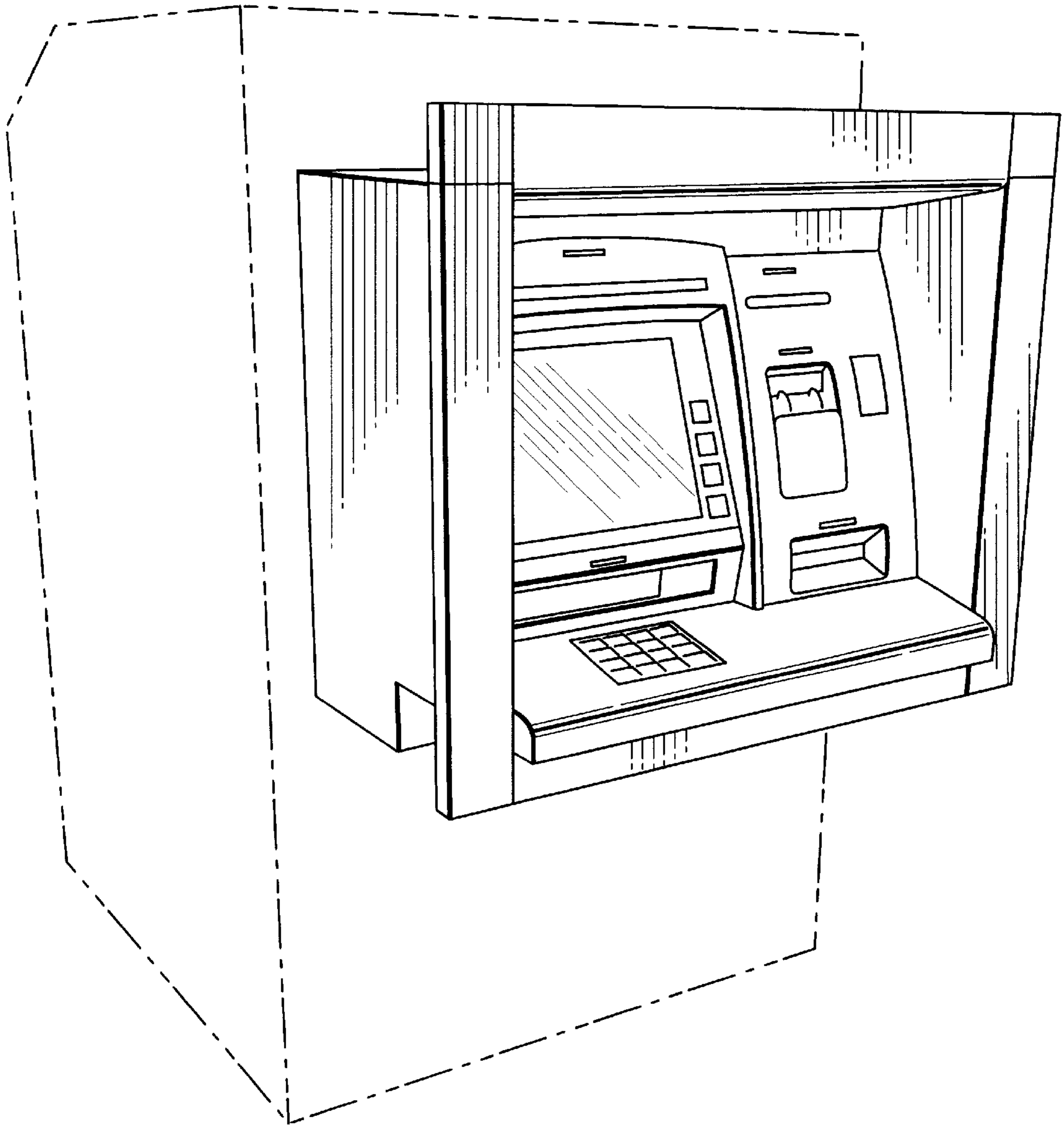

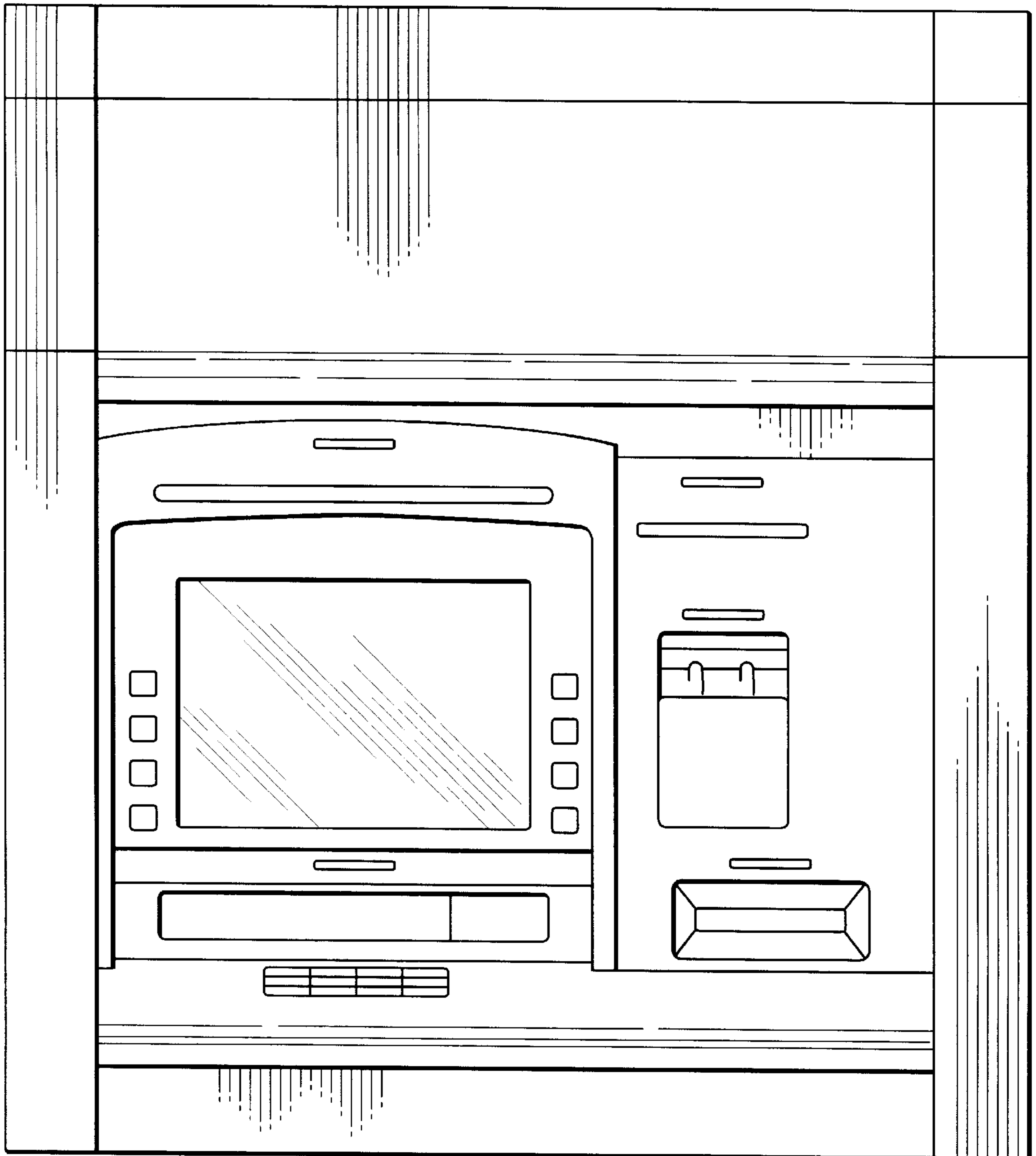

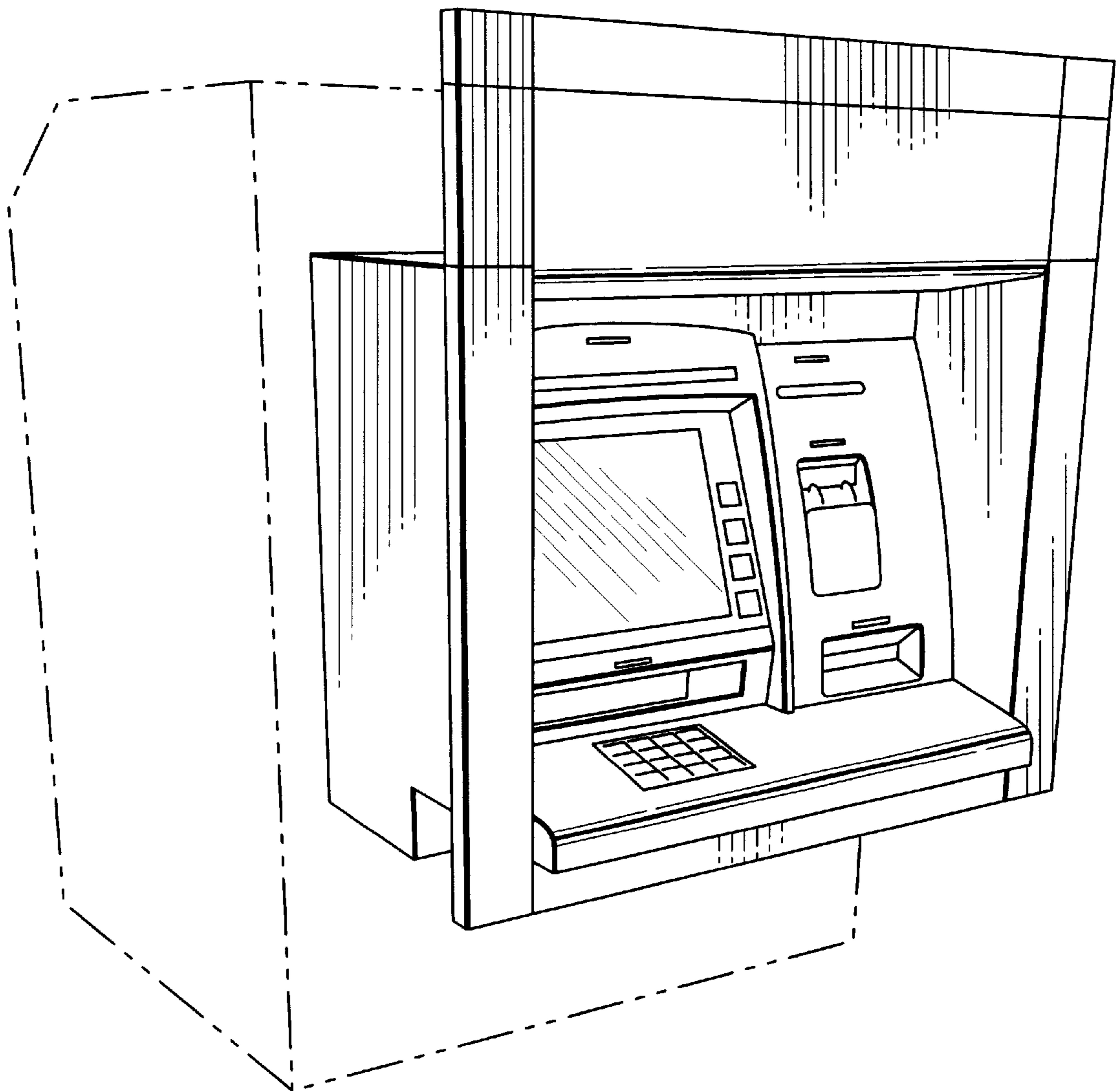

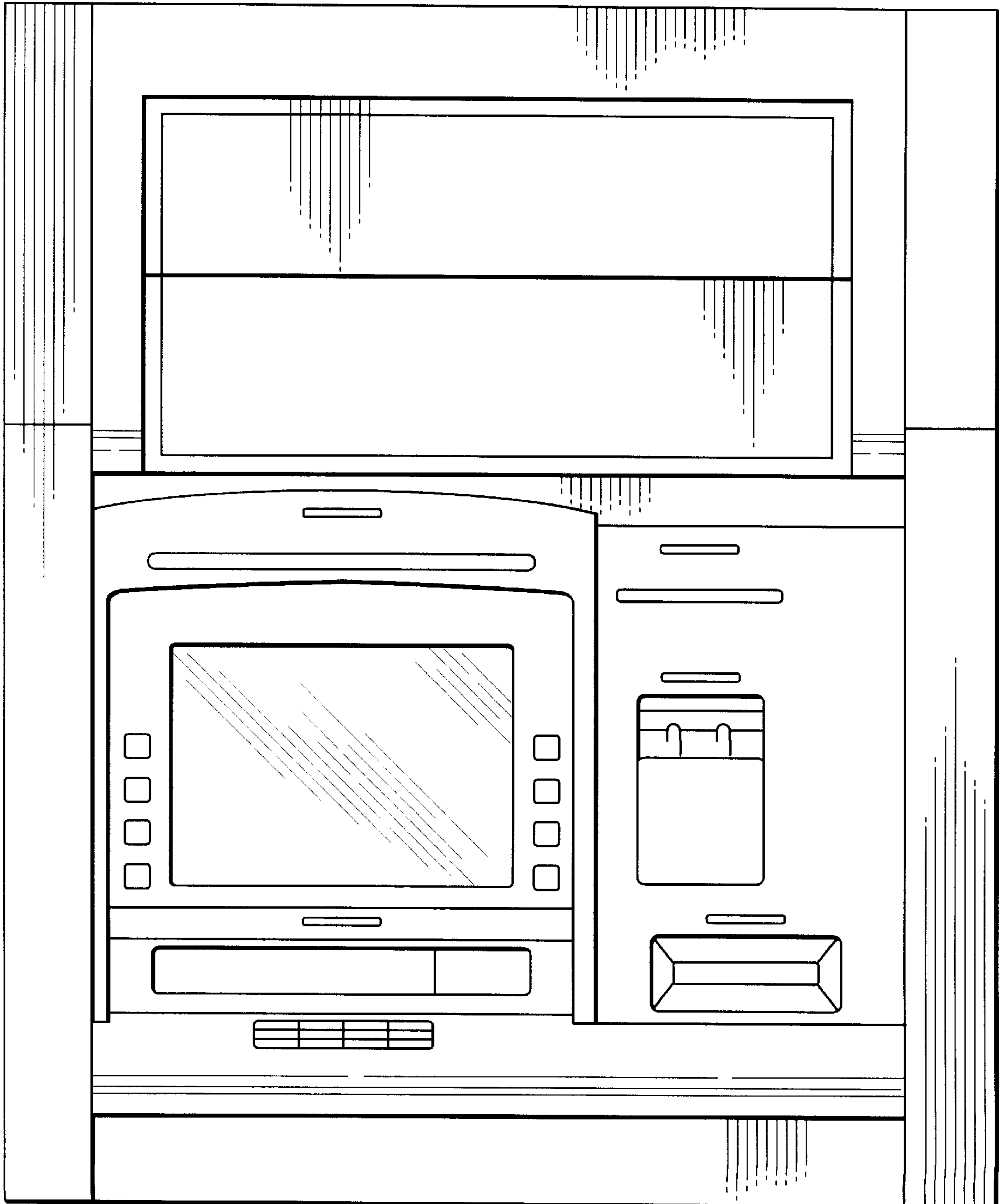
