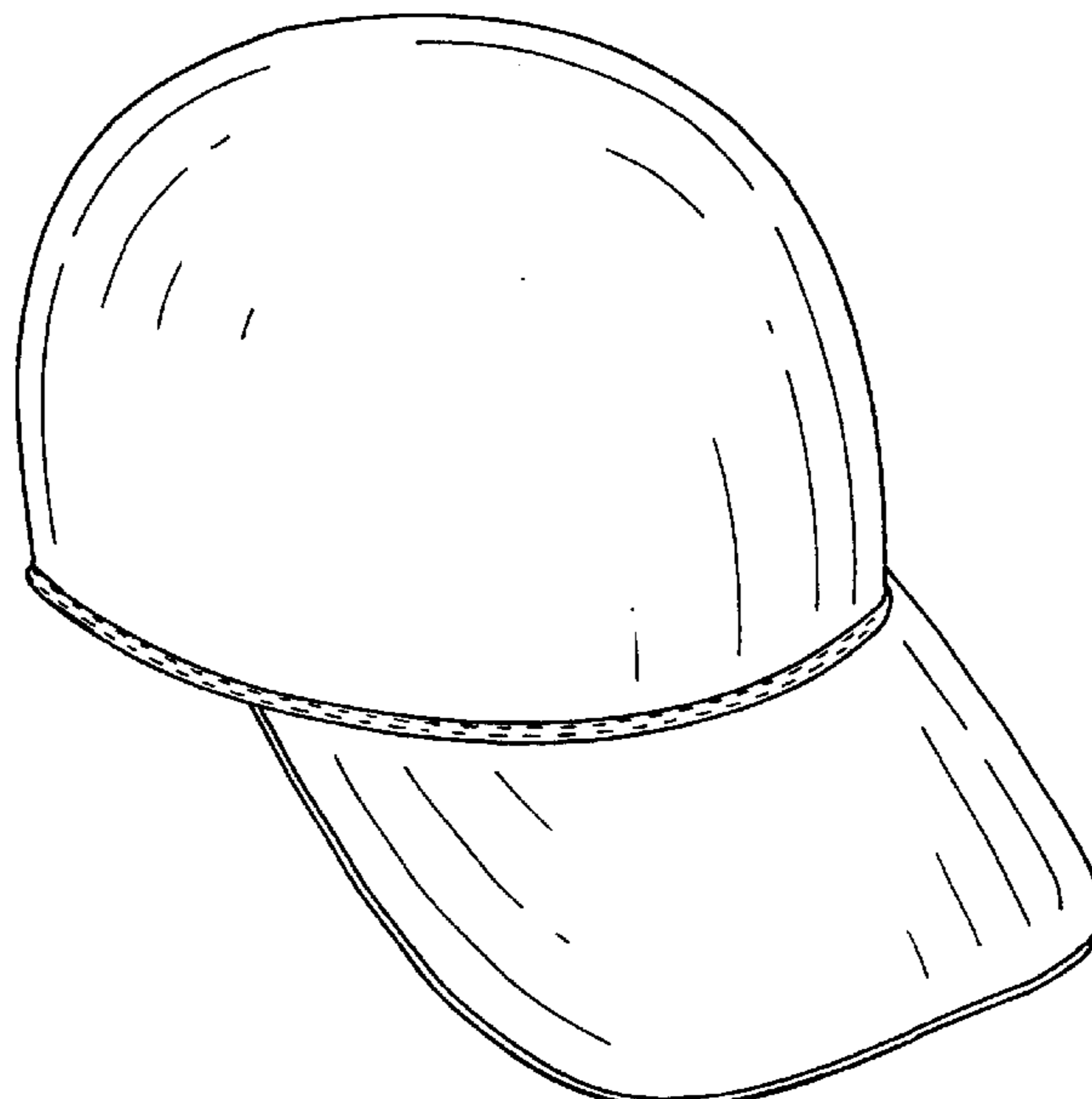

(57) **CLAIM**

The ornamental design for a seamless baseball cap, as shown and described.

FIG. 1 is a front perspective view of a seamless baseball cap showing my new design.

 FIG. 11 is a rear elevational view of the embodiment of FIG. 8.

 FIG. 13 is a bottom plan view of the embodiment of FIG. 8.  
 FIG. 14 is an elevational view of one side of an alternative embodiment showing the location of logo designs which are not part of the claimed design.  
 FIG. 15 is an elevational view of the other side of the embodiment of FIG. 14.  
 FIG. 16 is a front plan view of the embodiment of FIG. 14.  
 FIG. 17 is a rear elevational view of the embodiment of FIG. 14.  
 FIG. 18 is a top plan view of the embodiment of FIG. 14; and,  
 FIG. 19 is a bottom plan view of the embodiment of FIG. 15. The broken lines showing the location of the logo design are for illustrative purposes only and form no part of the claimed design.

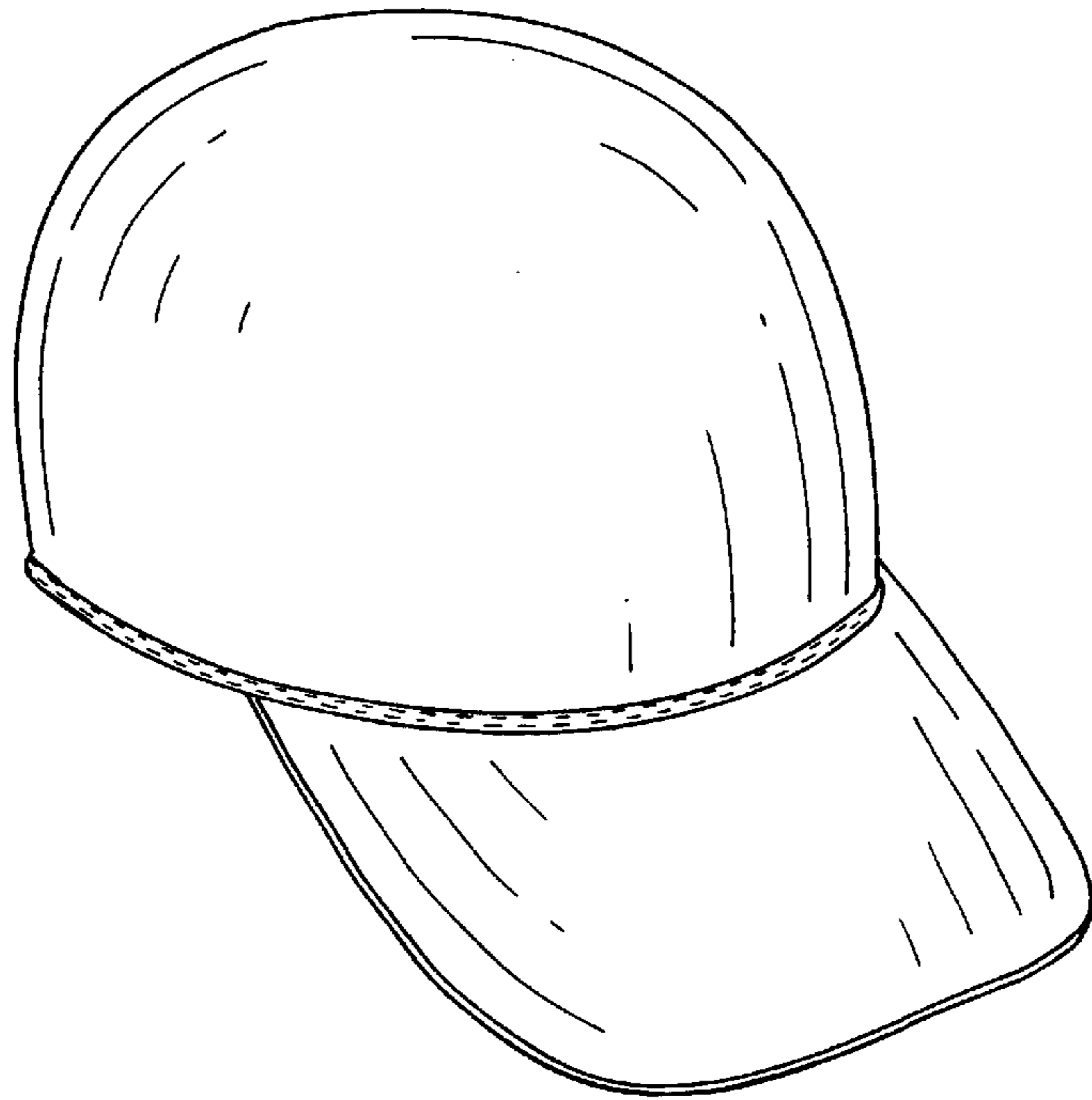

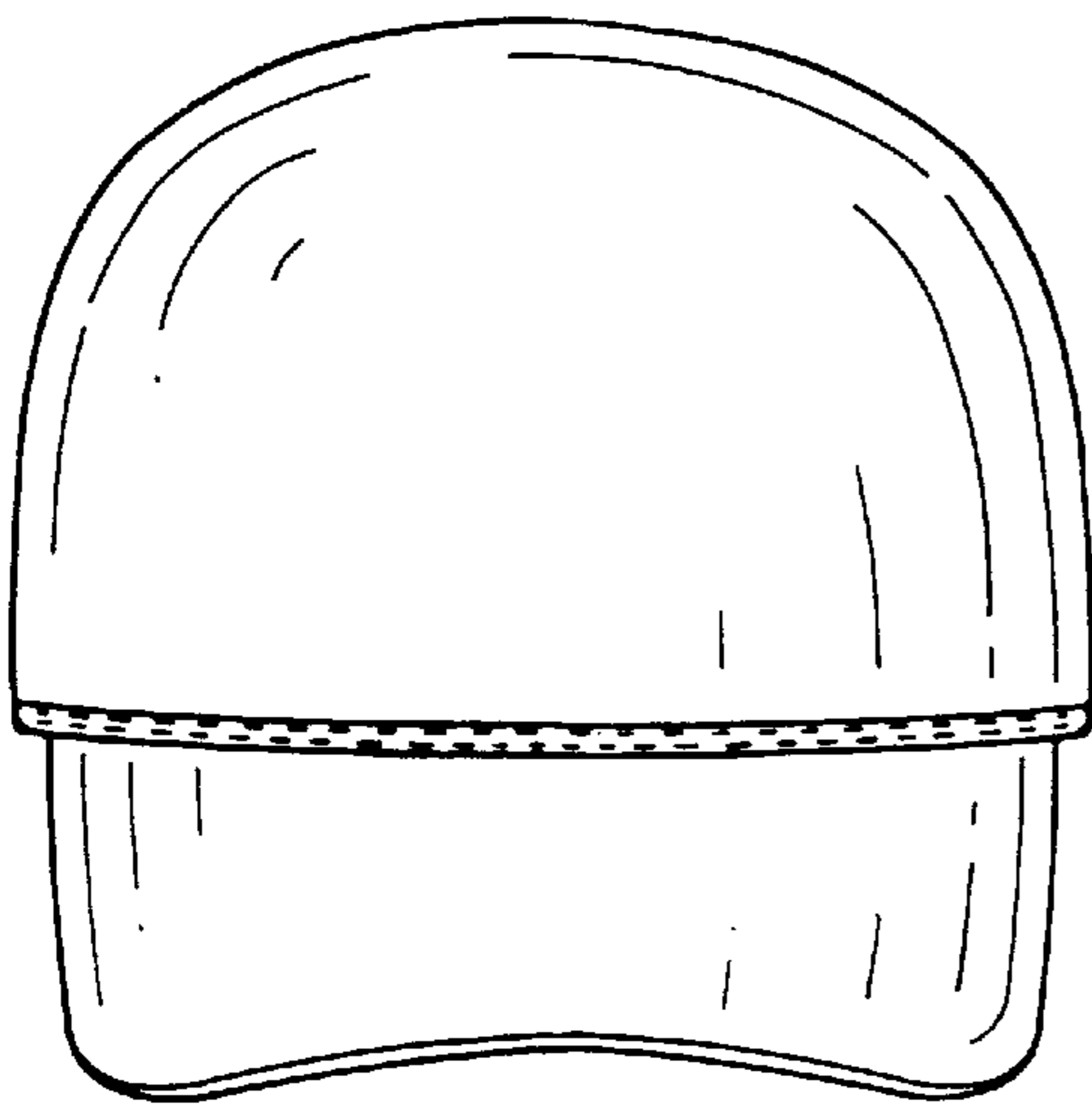

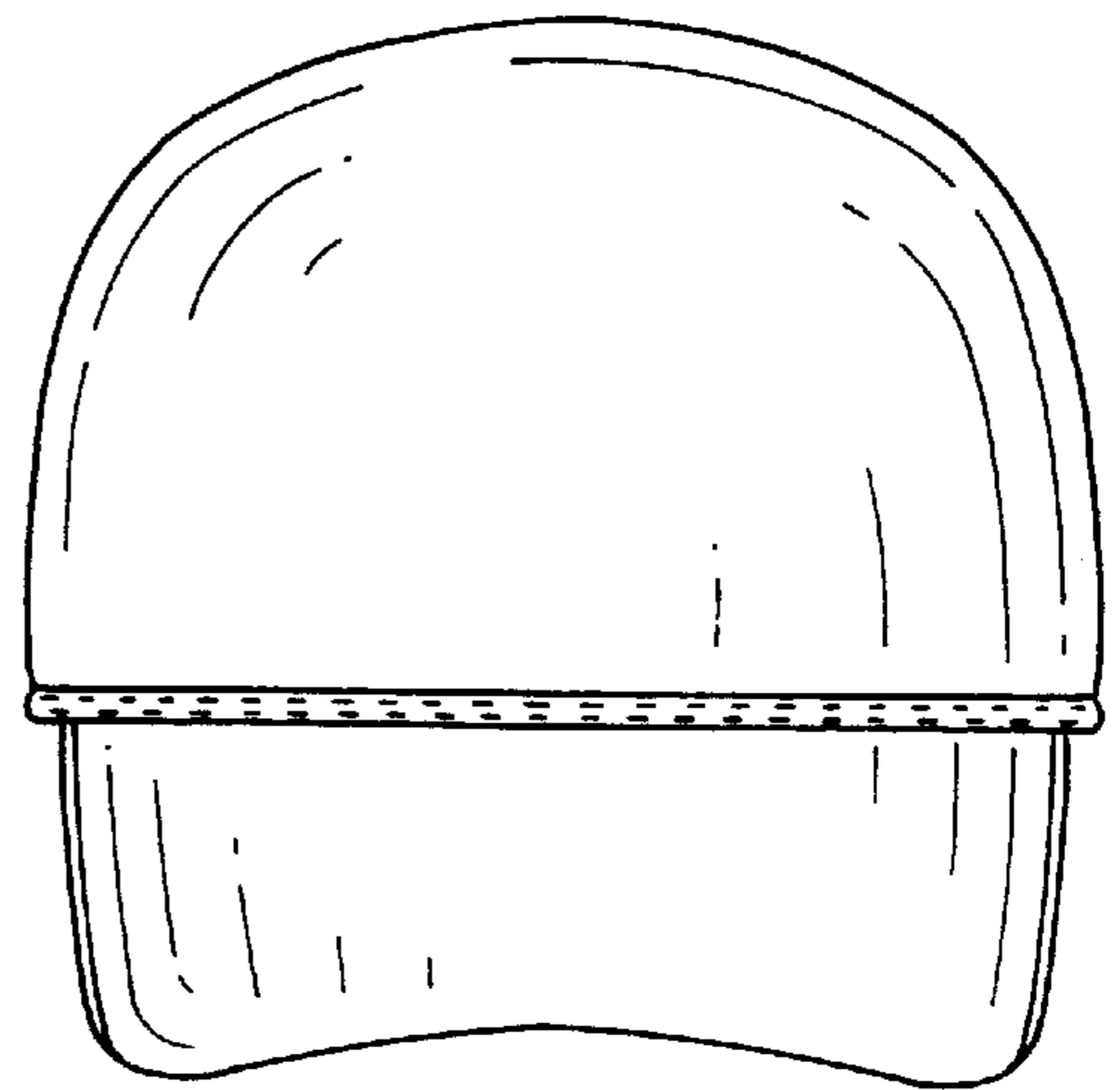

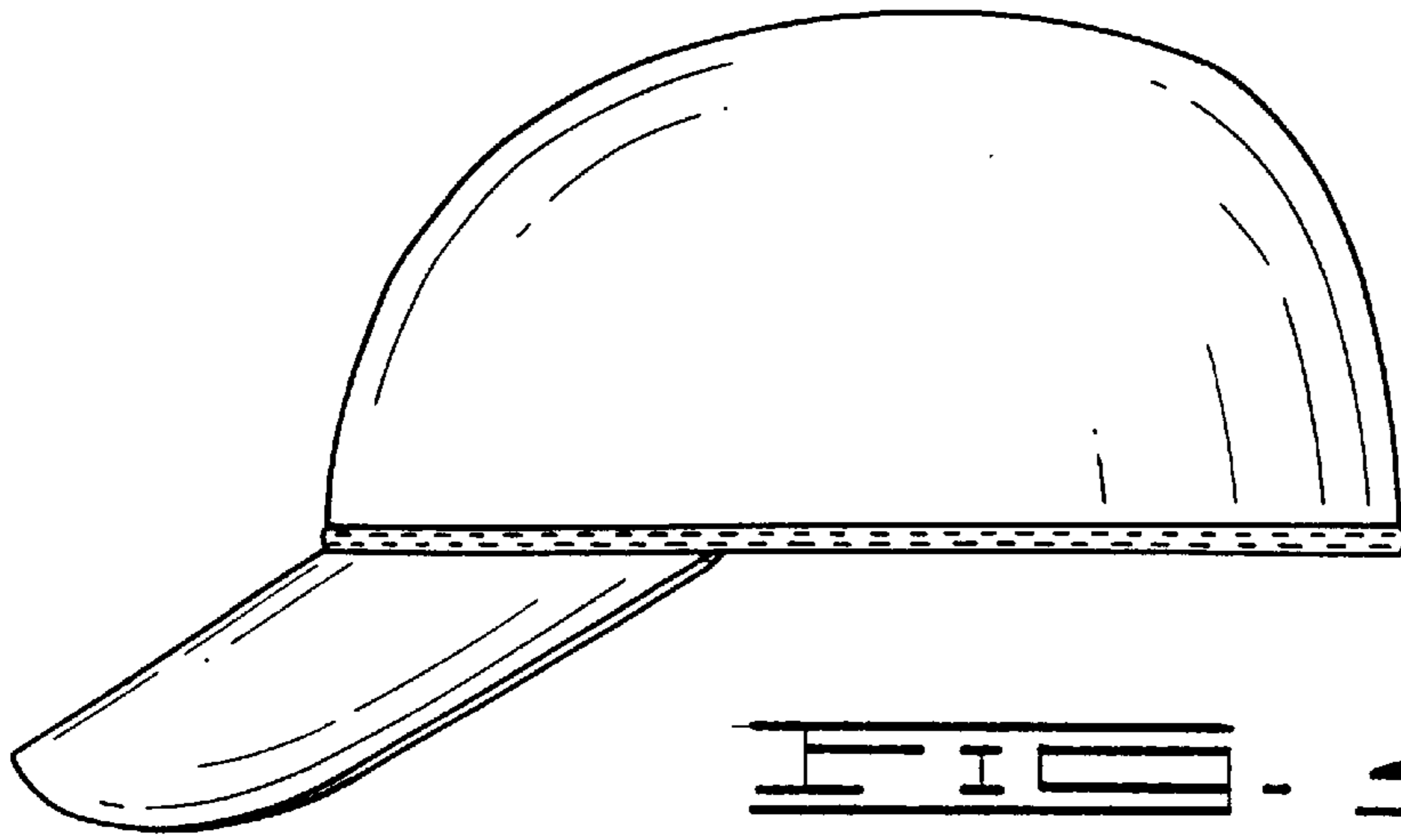

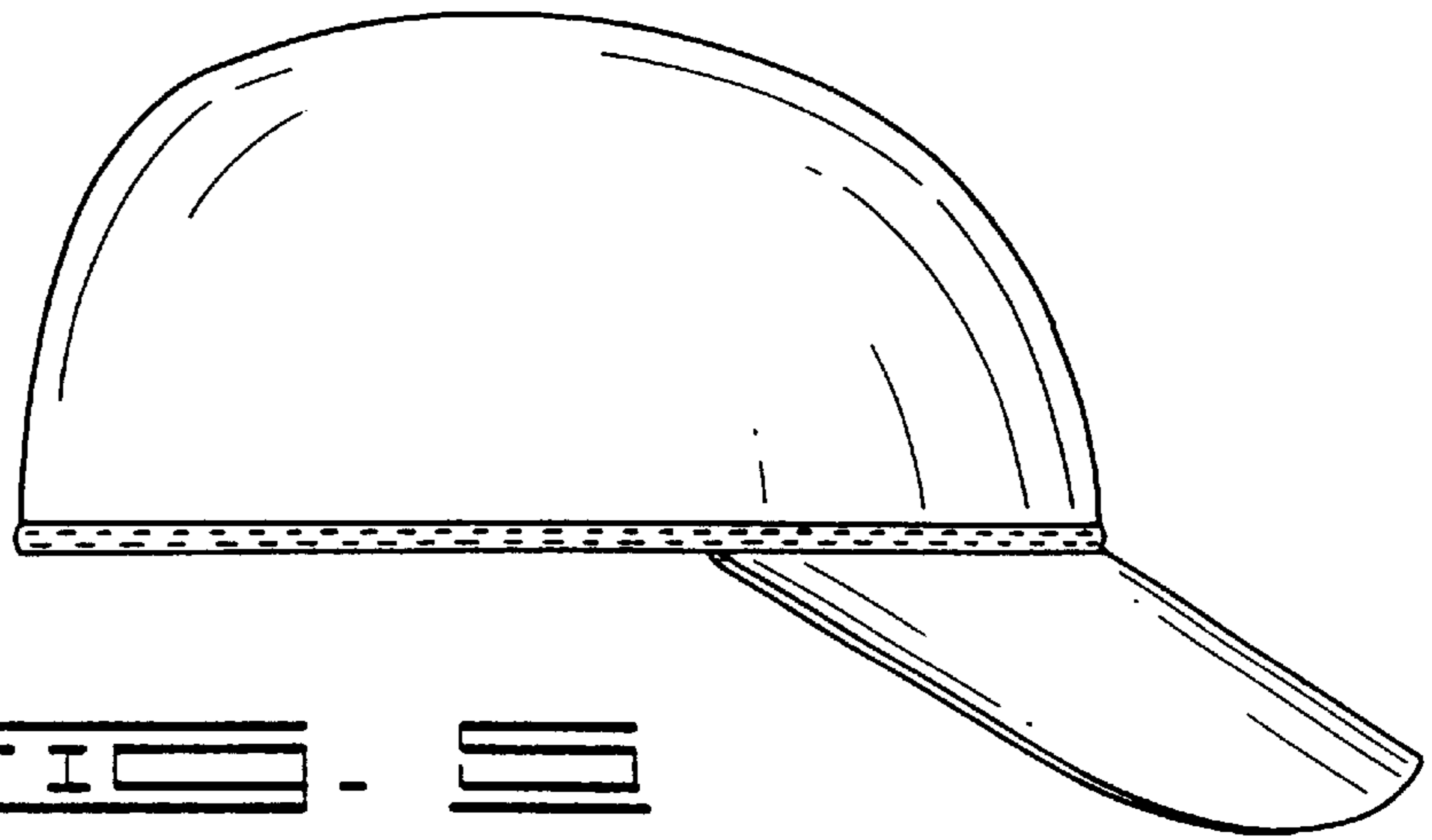

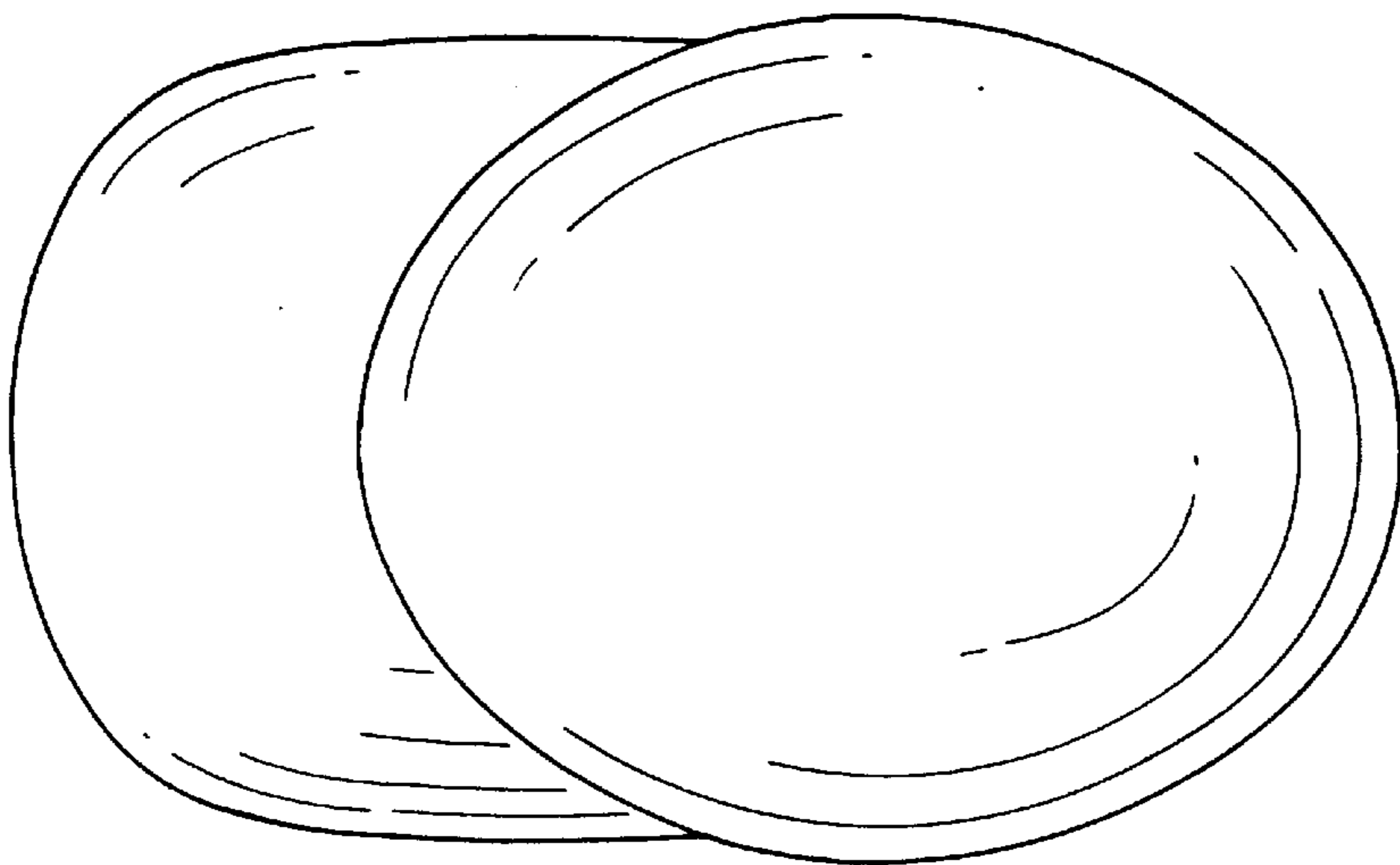

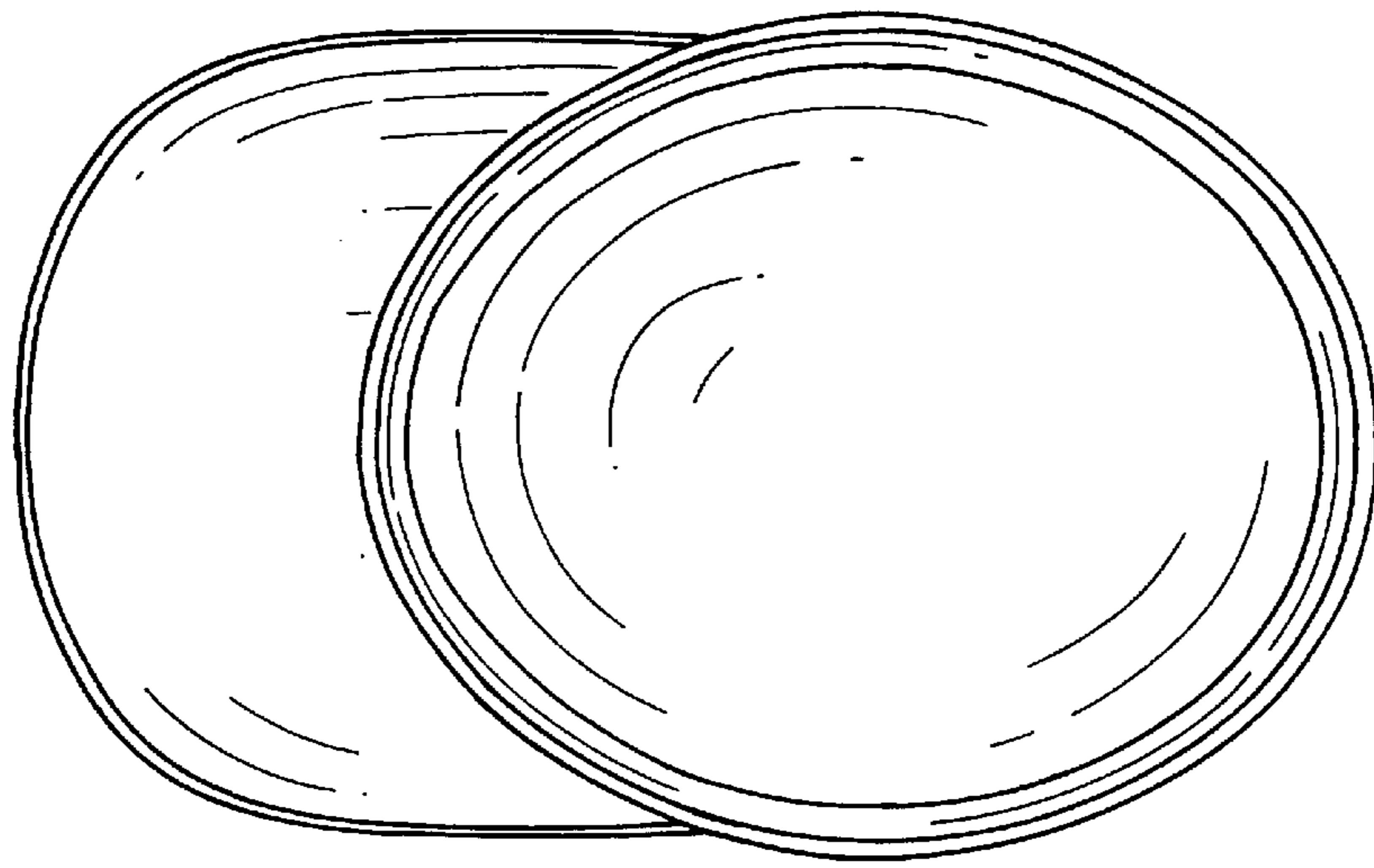

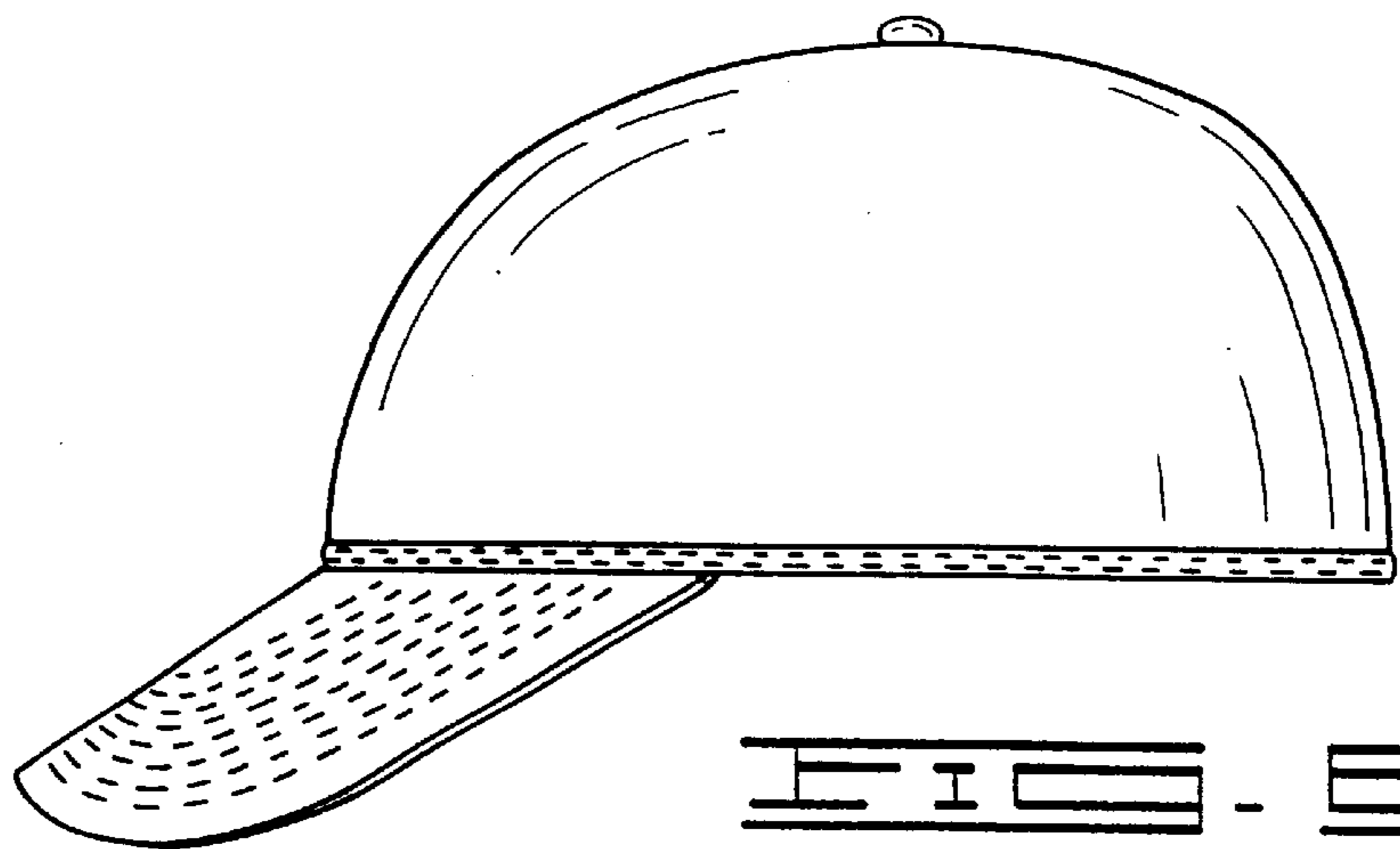

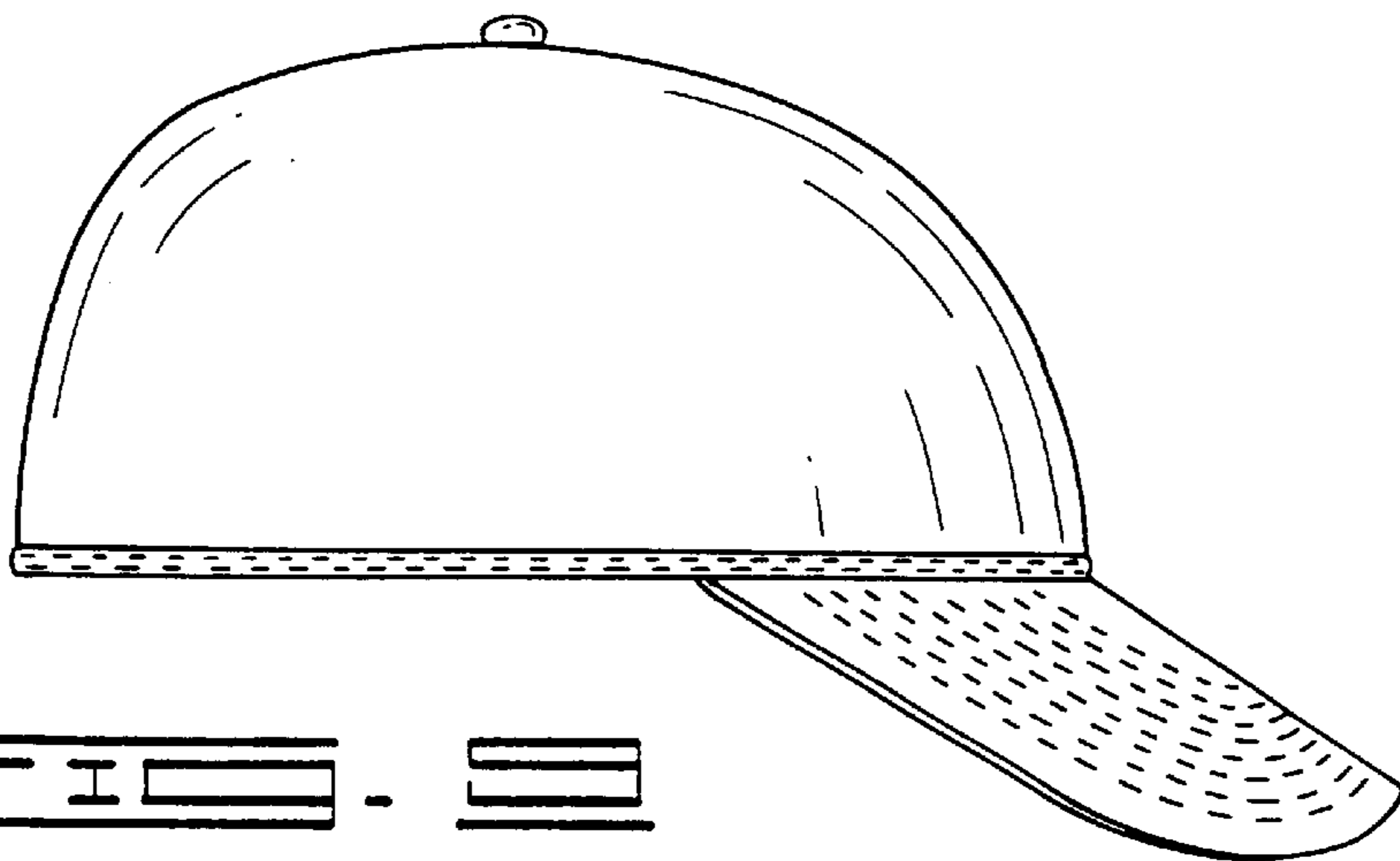

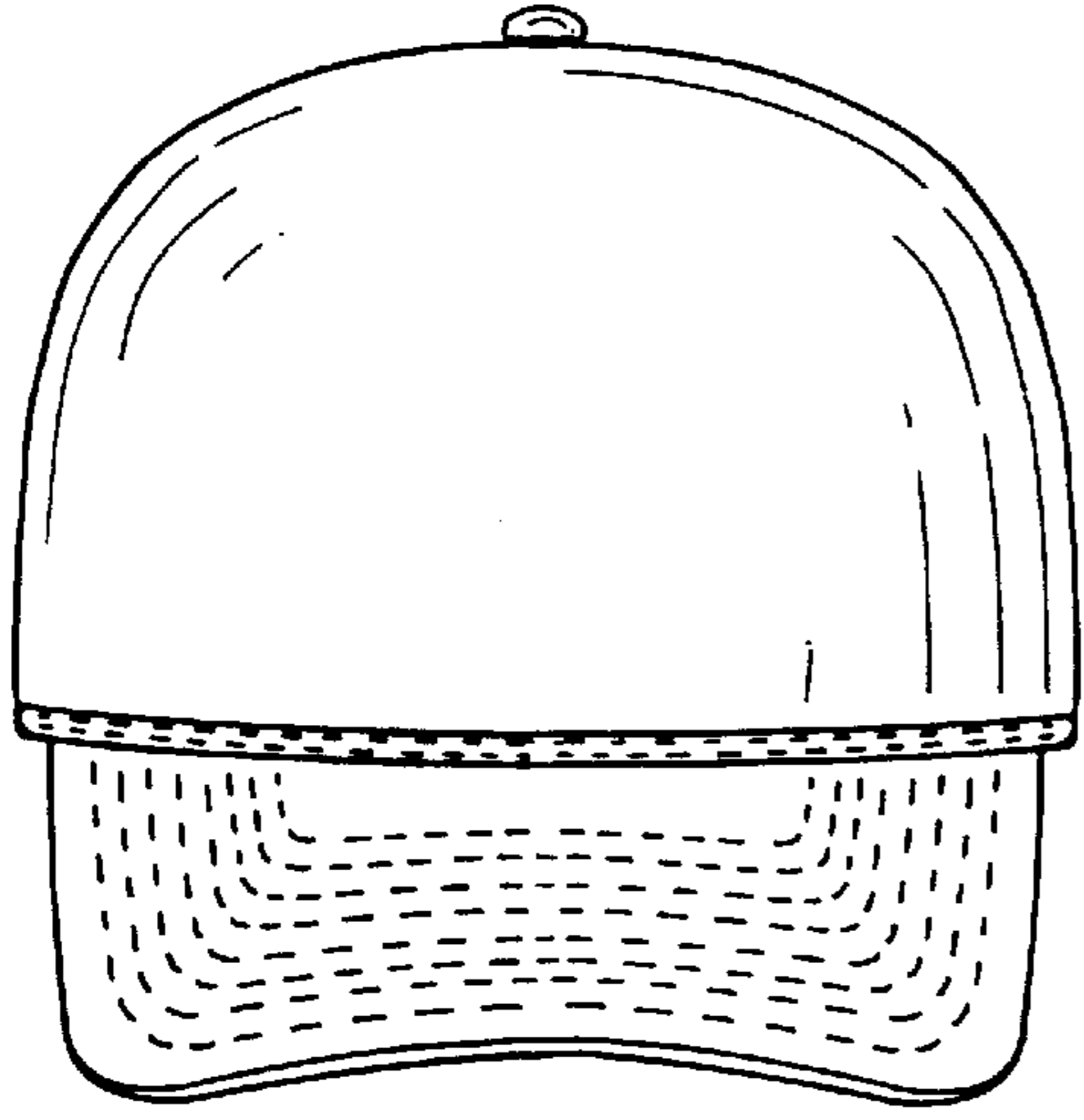

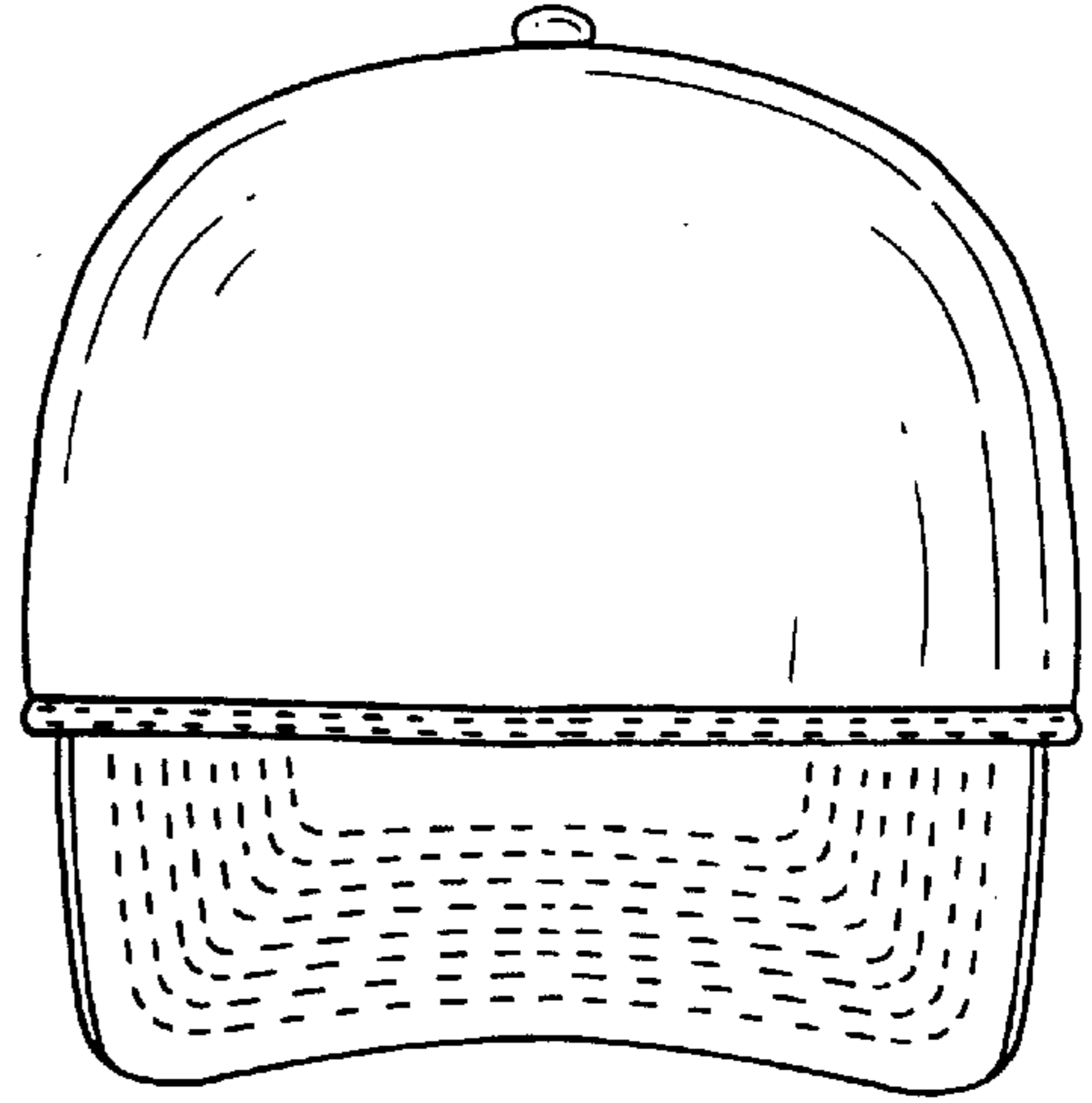

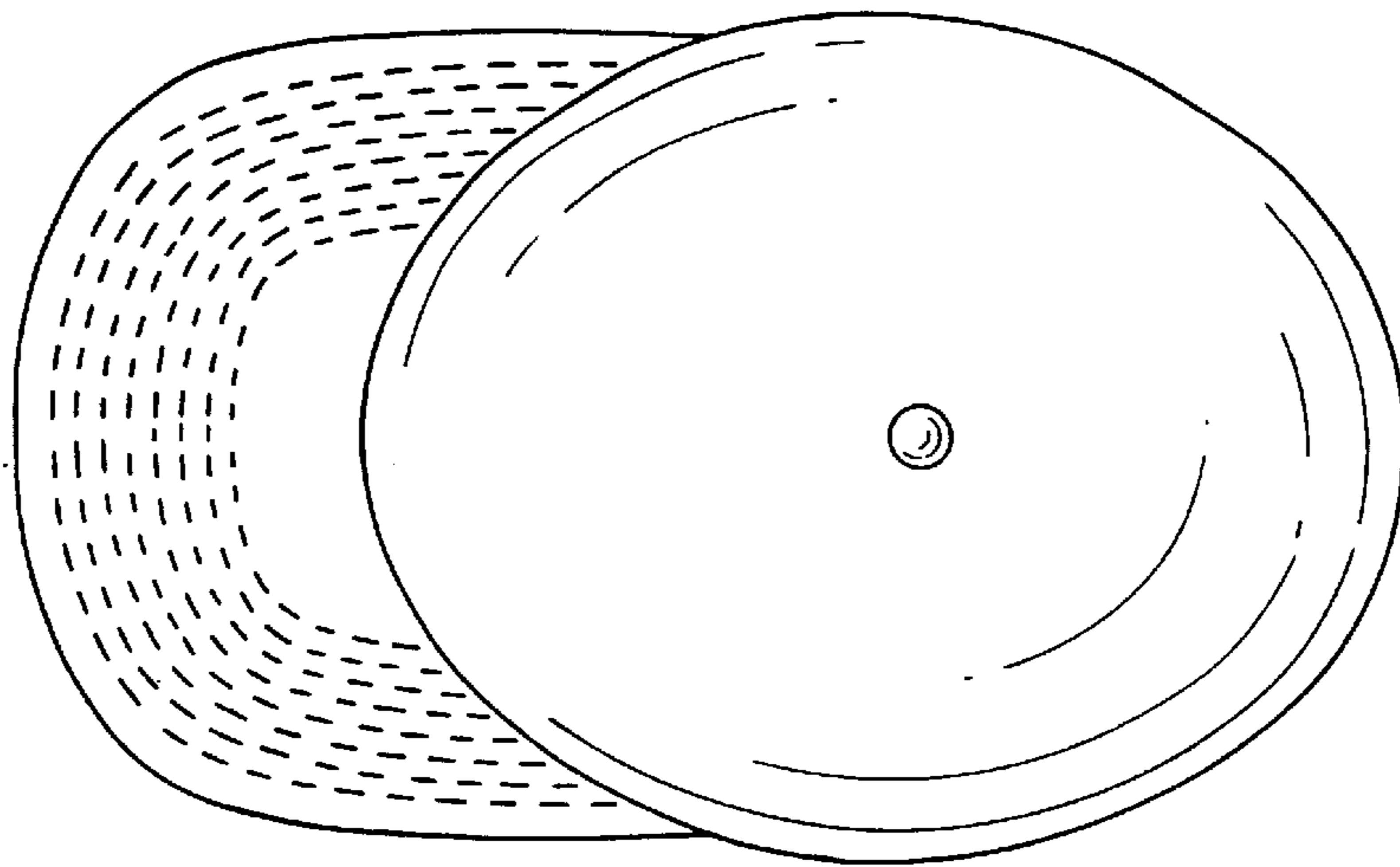

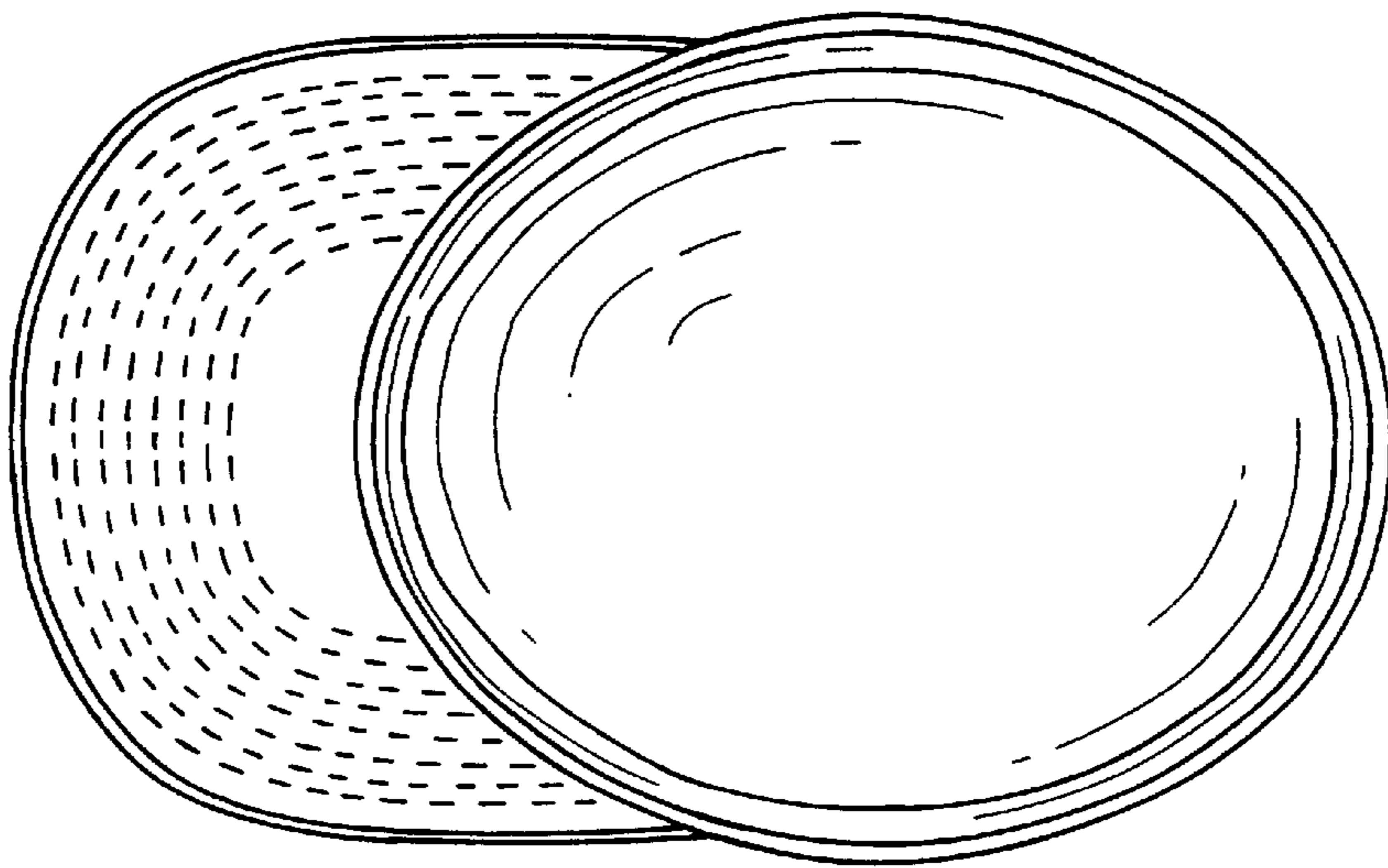

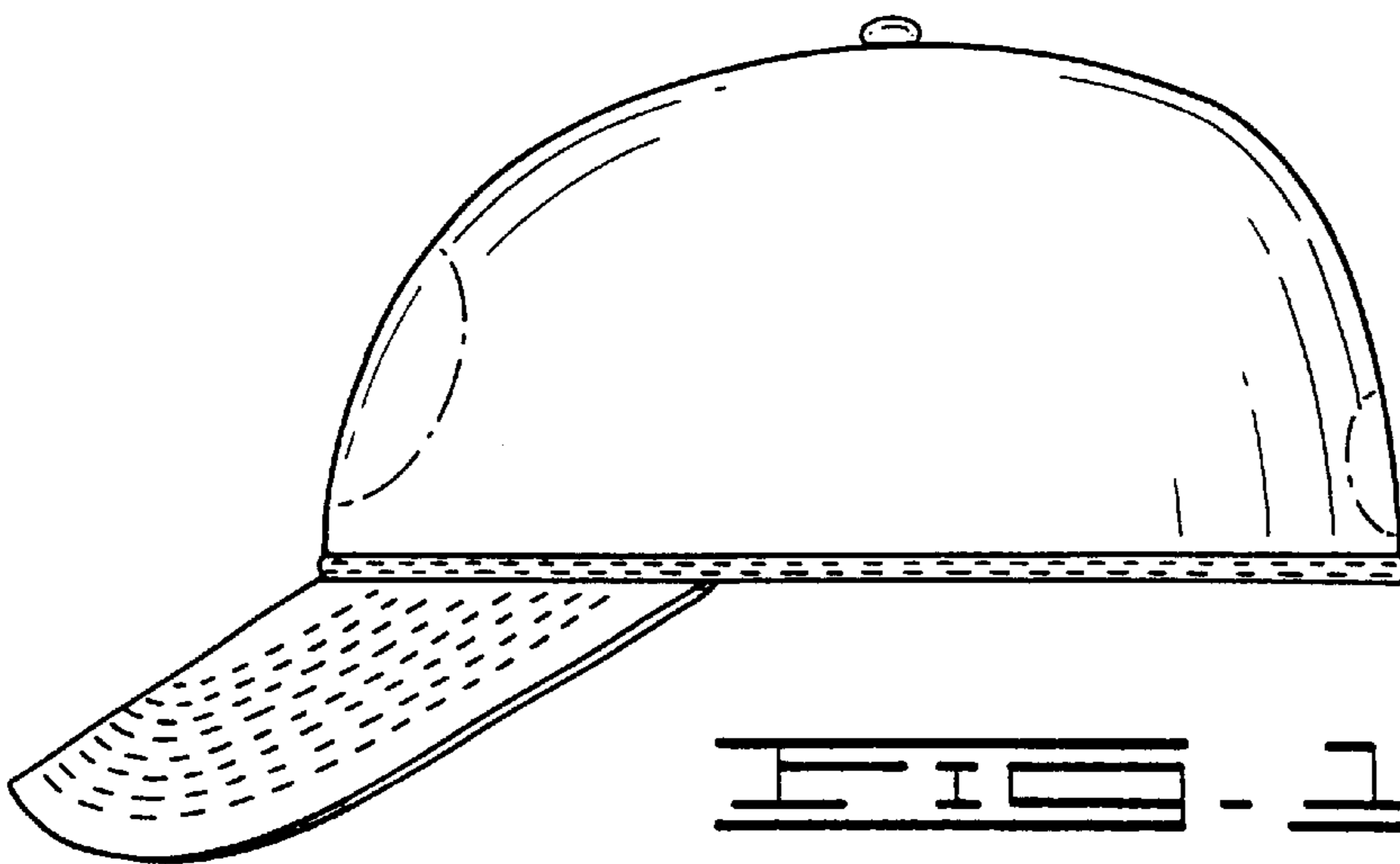

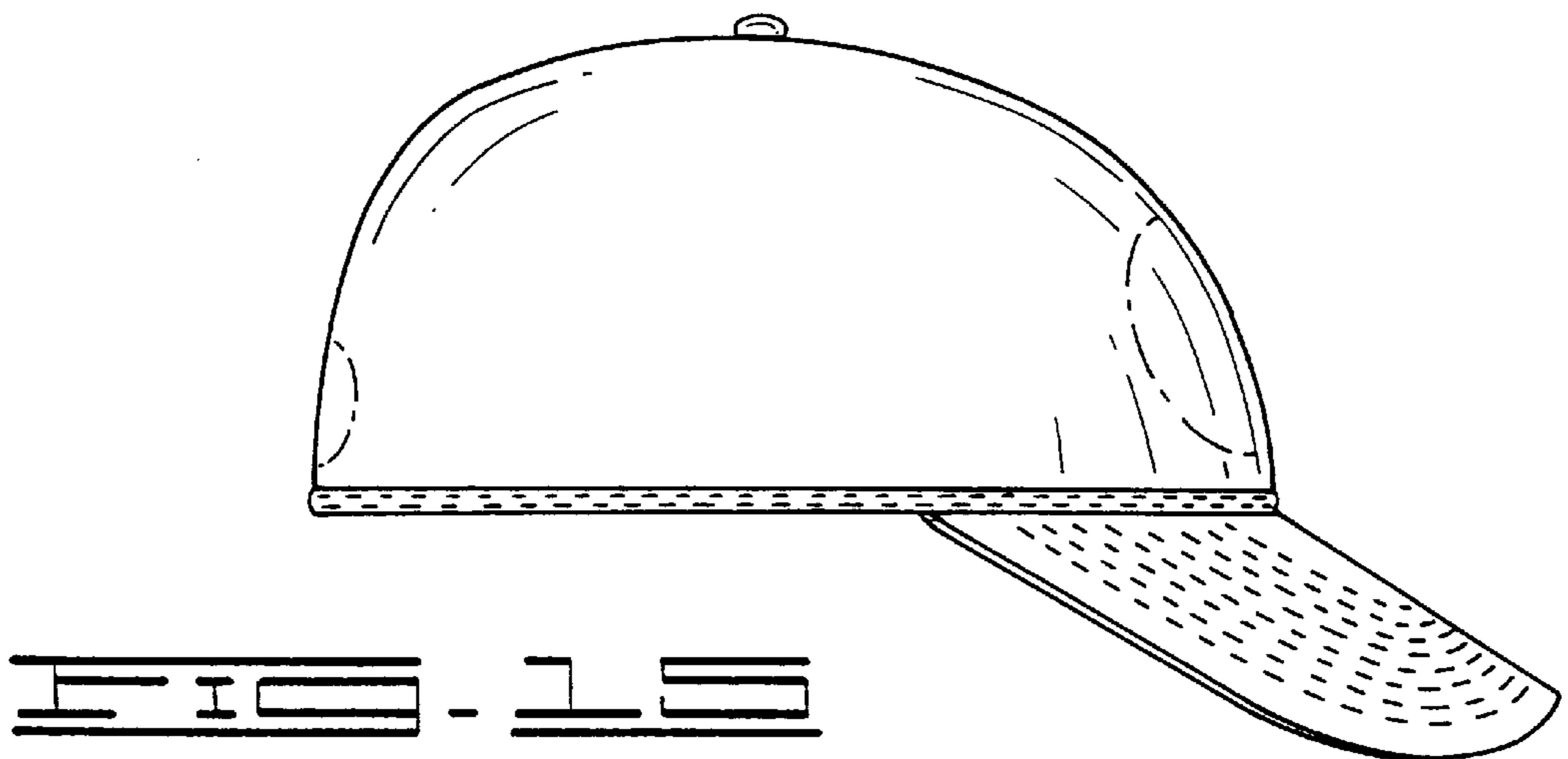

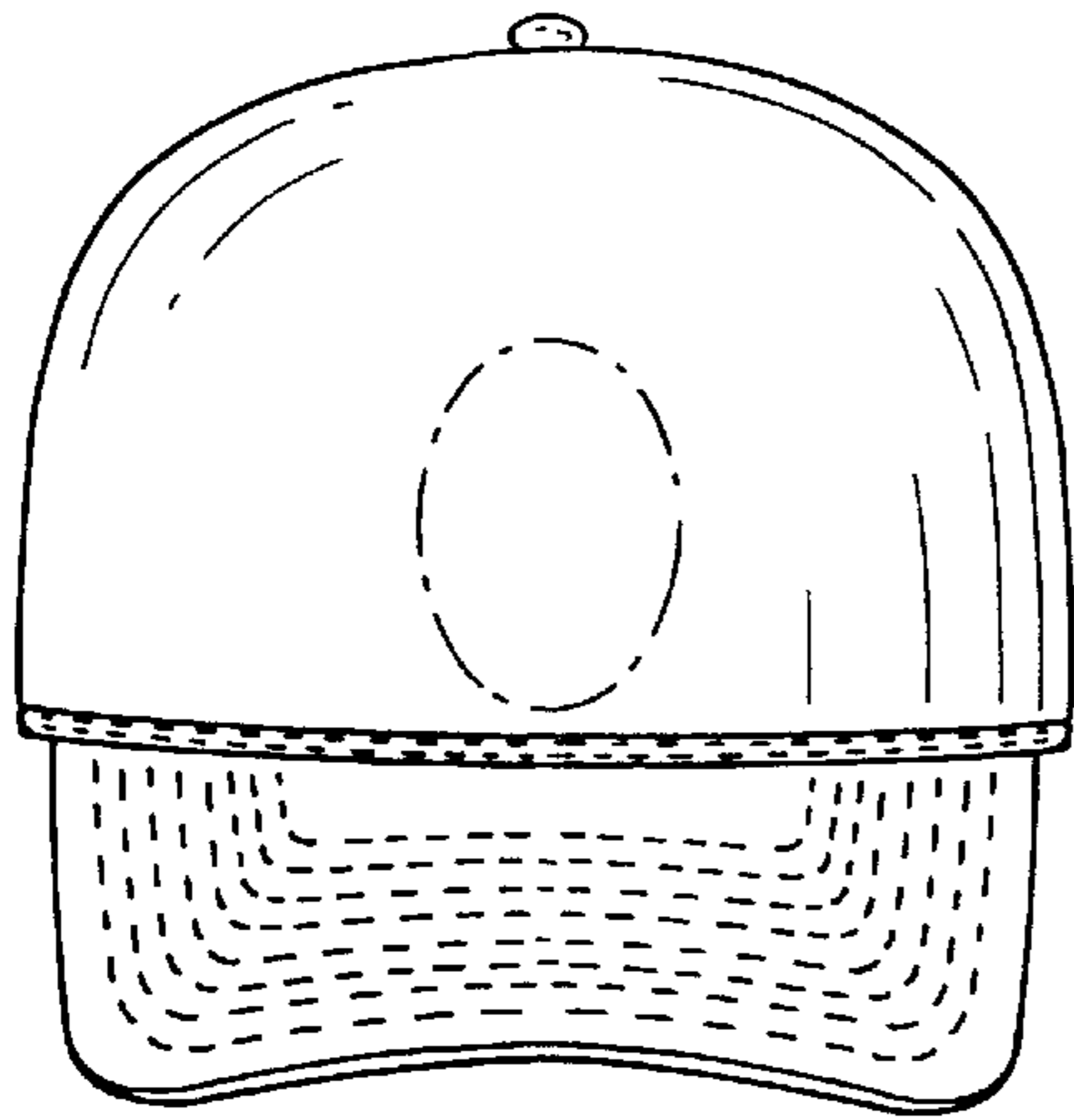

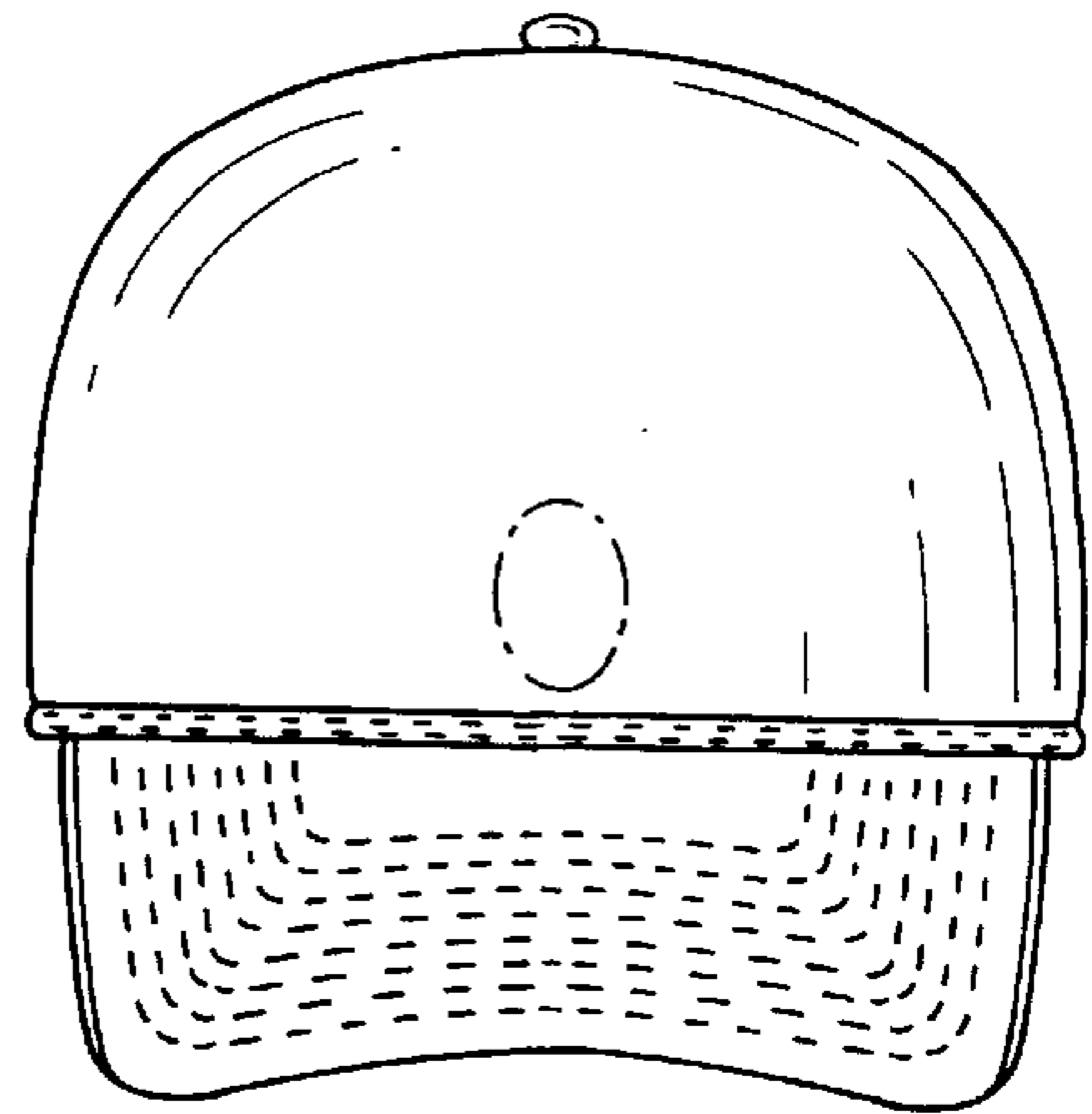

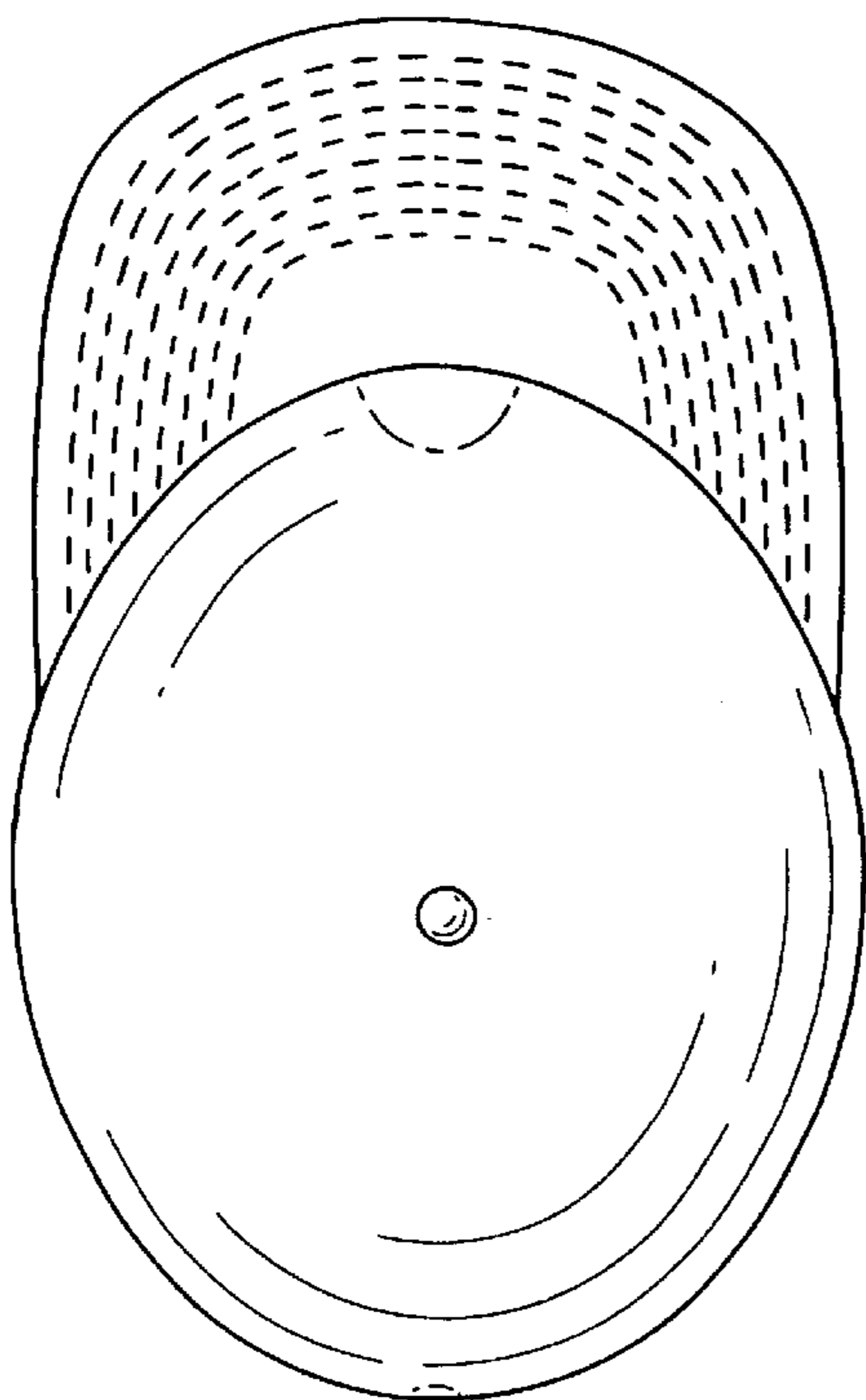

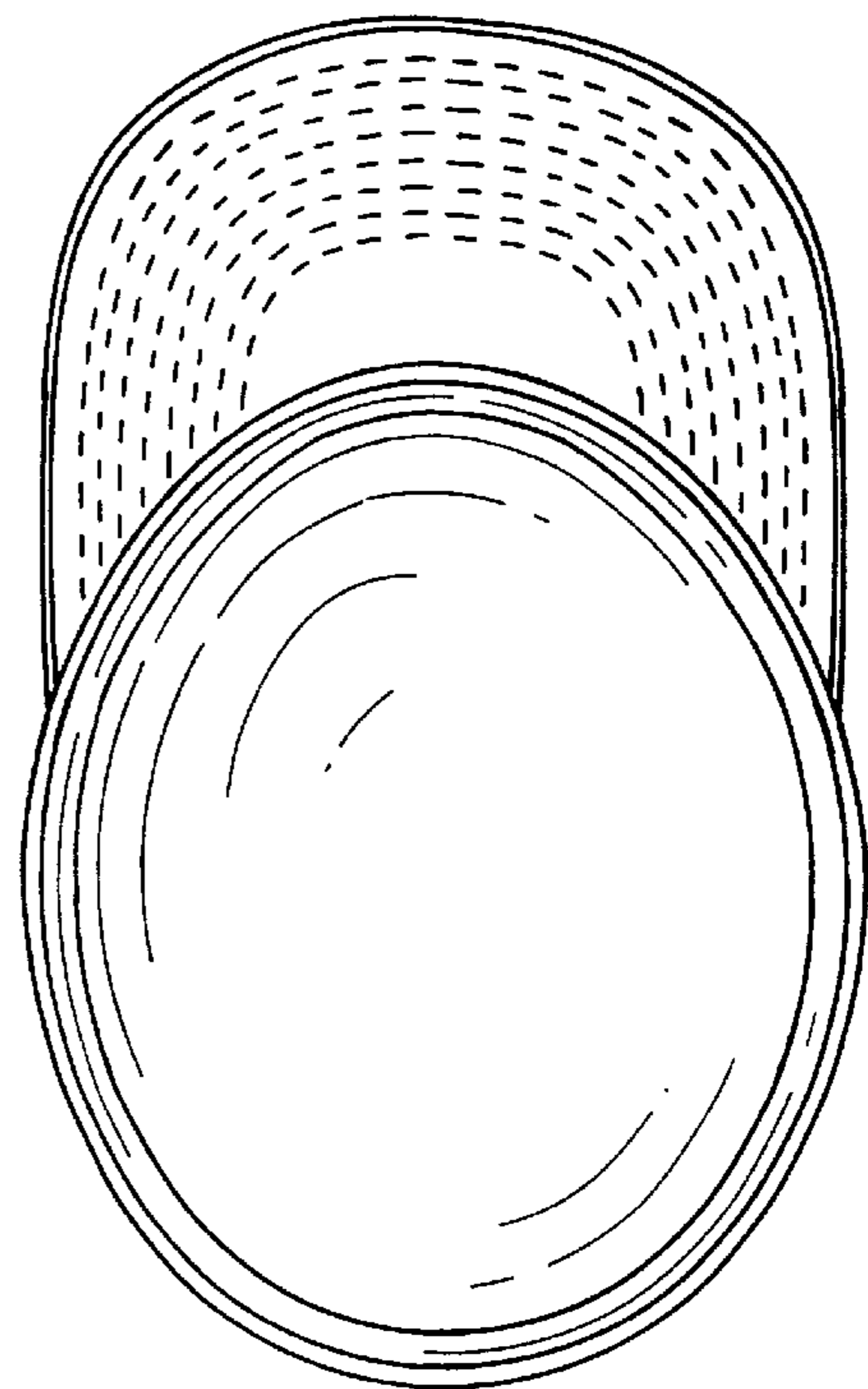
