FIG. 2 is a top plan view;

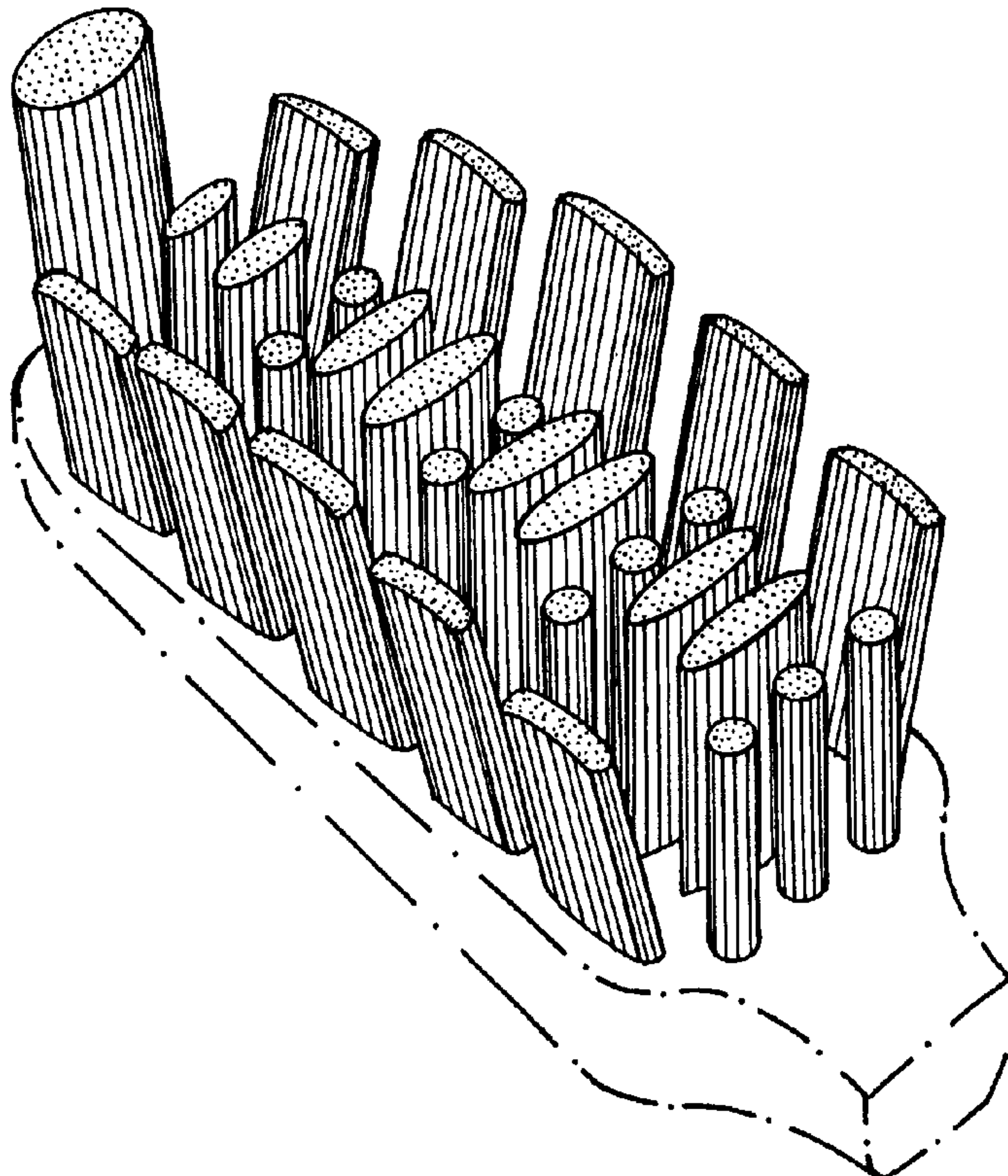
FIG. 3 is a right side view, the left side being a mirror image;

FIG. 4 is a bottom plan view;

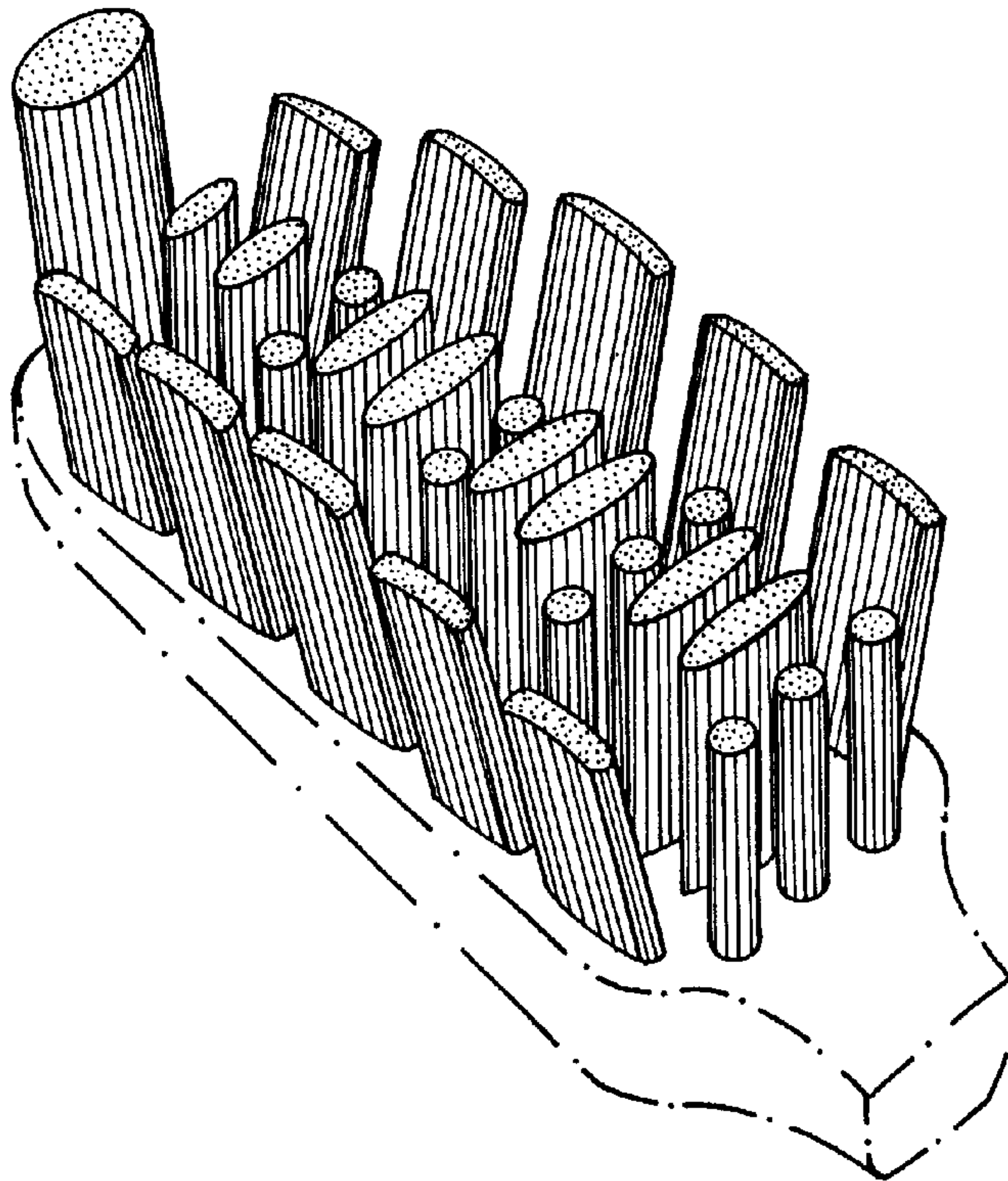
FIG. 5 is a front elevational view; and,

FIG. 6 is a rear elevational view.

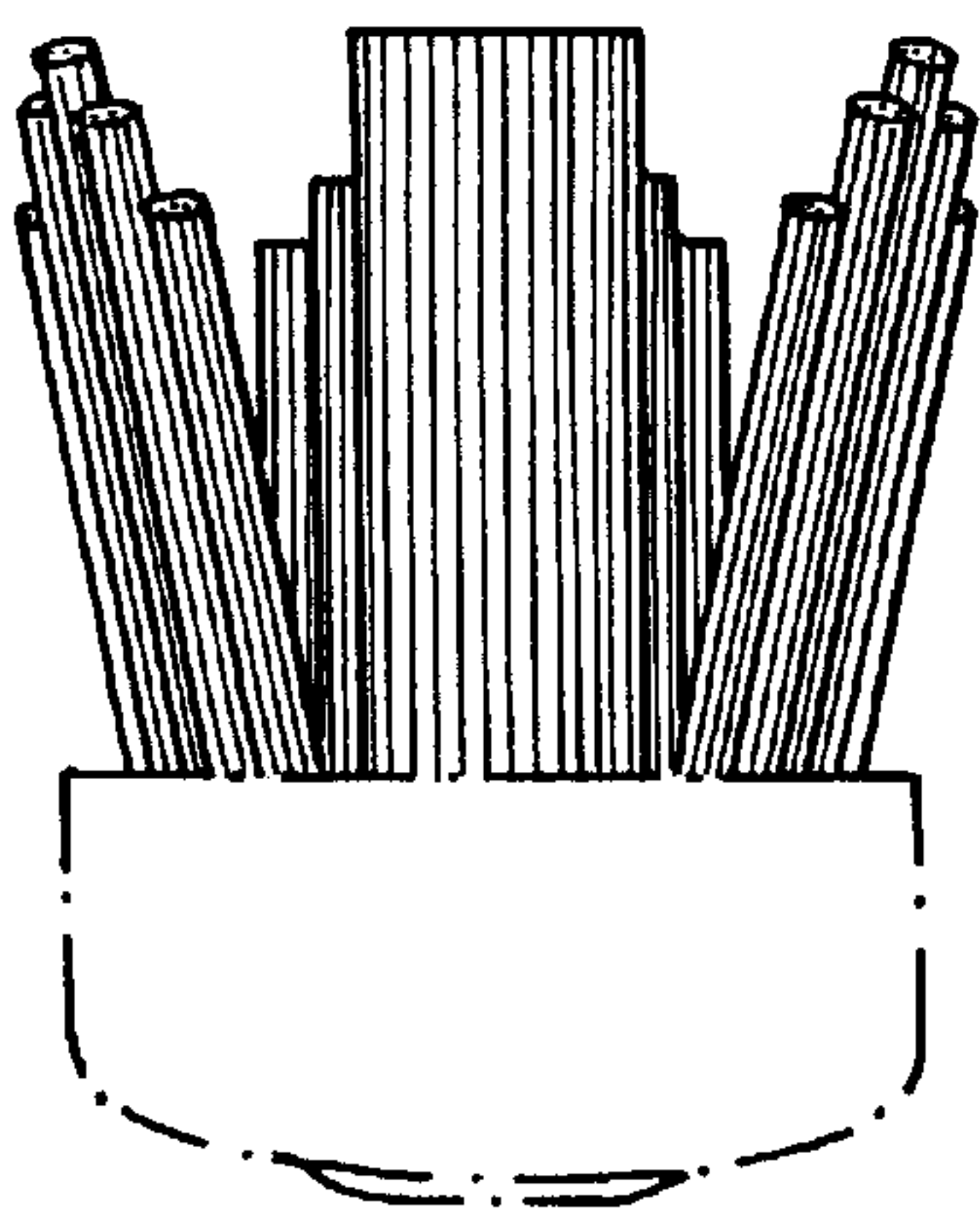

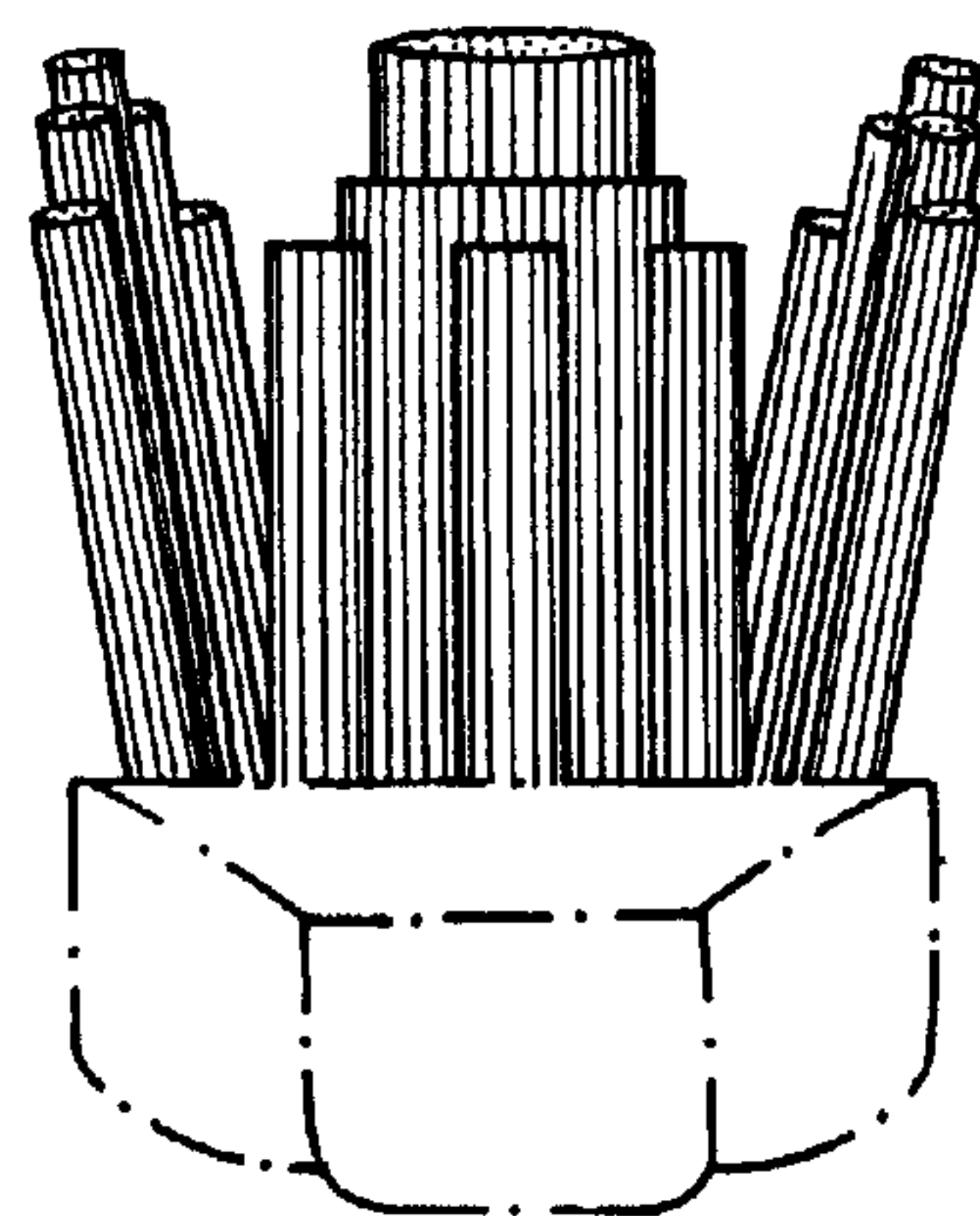

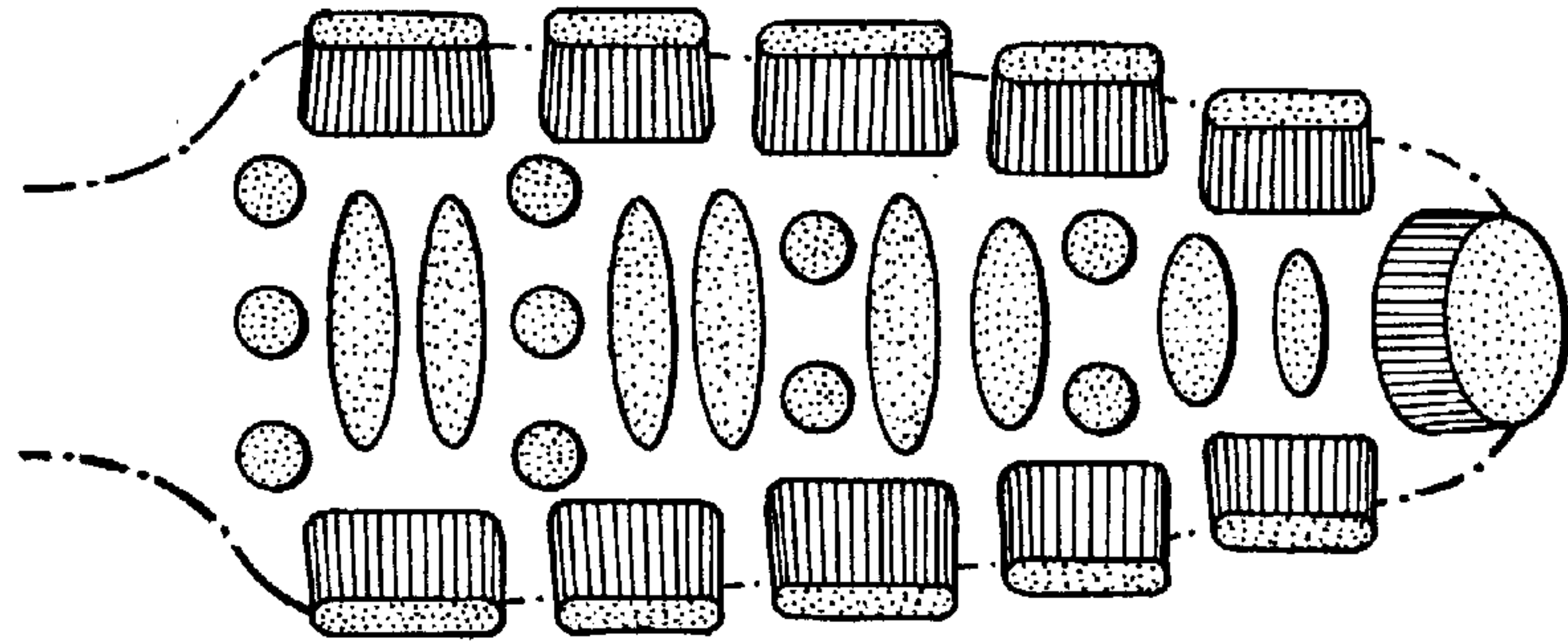

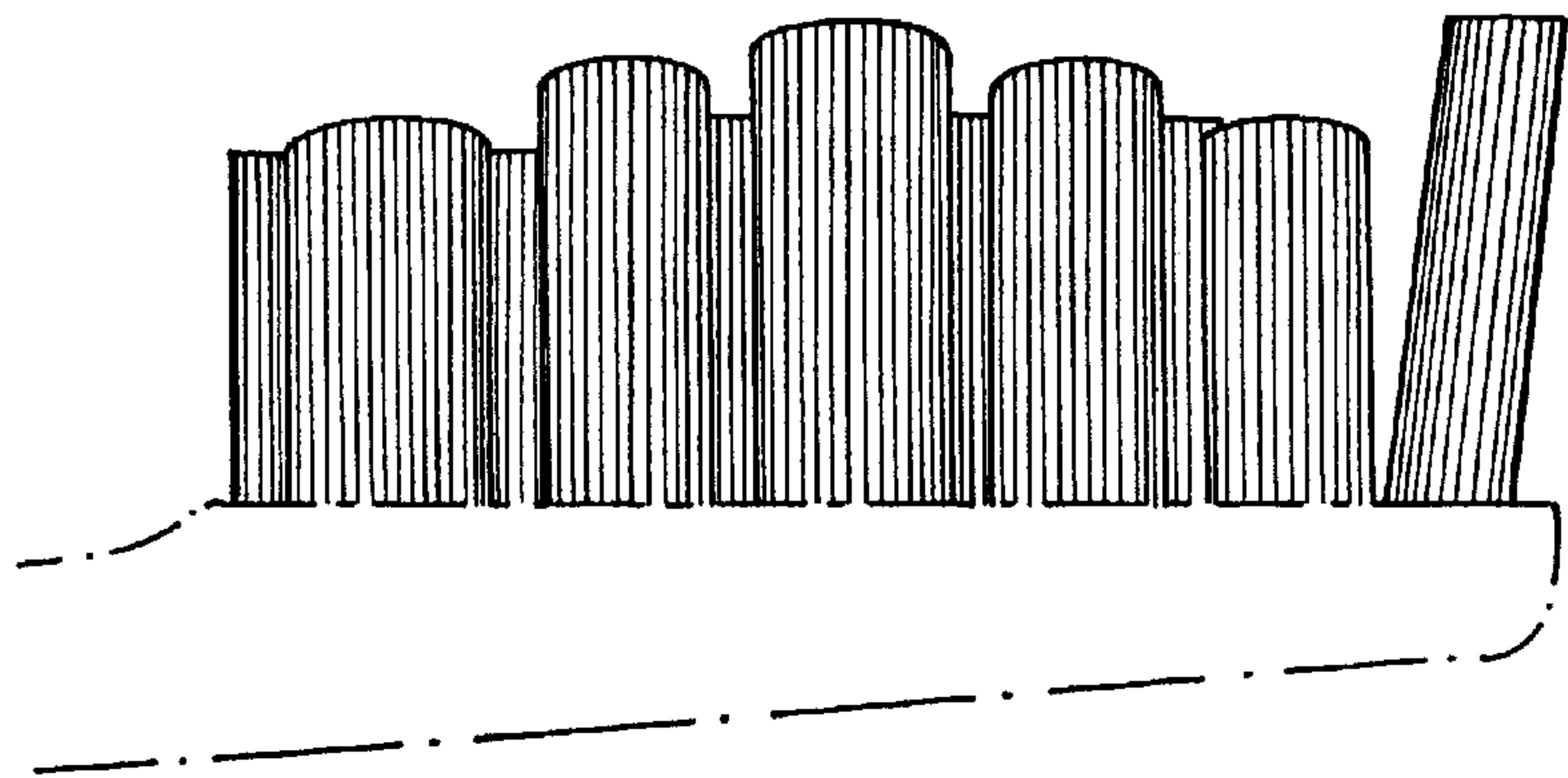
