The ornamental design for a tiered shelf array for wall panel-shelf system, as shown and described.

**DESCRIPTION**

FIG. 1 is a frontal perspective view of a first embodiment of the tiered shelf array for wall panel-shelf system with a shelf mounting panel wall being shown in phantom and forming no part of the claimed design;

FIG. 6 is a frontal perspective review of a second embodiment of the tiered shelf array for wall panel-shelf system;

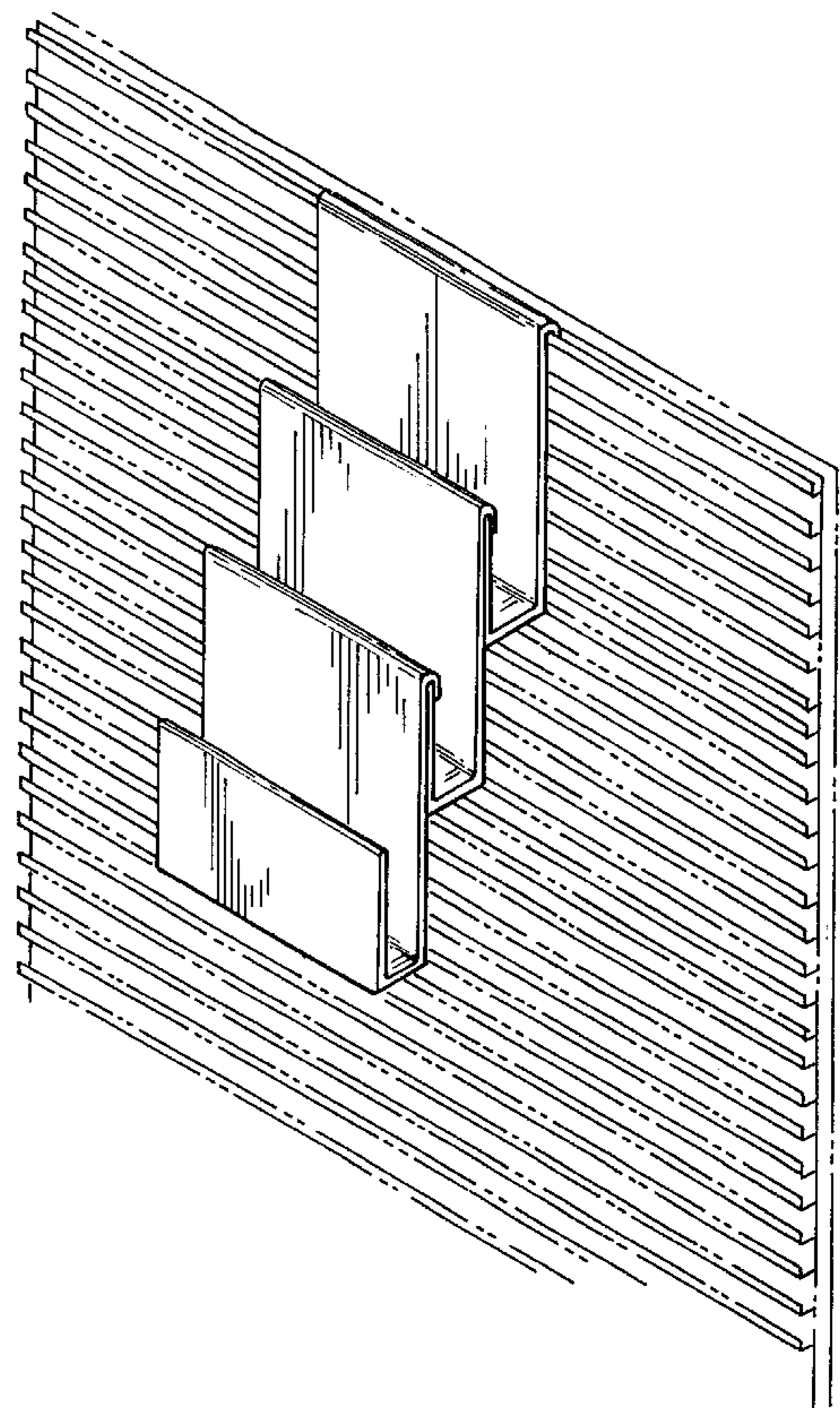
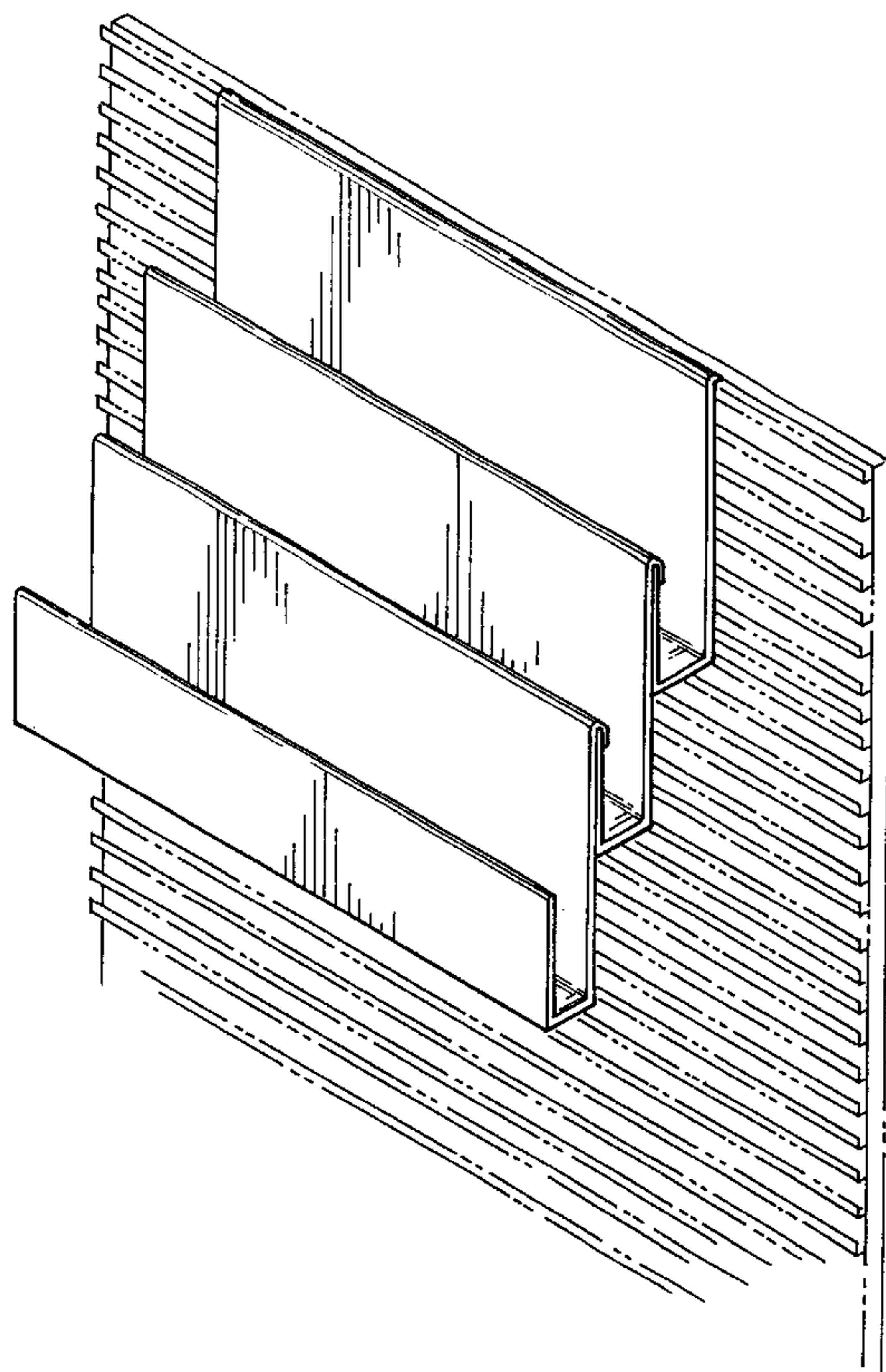
FIG. 7 is a front view;

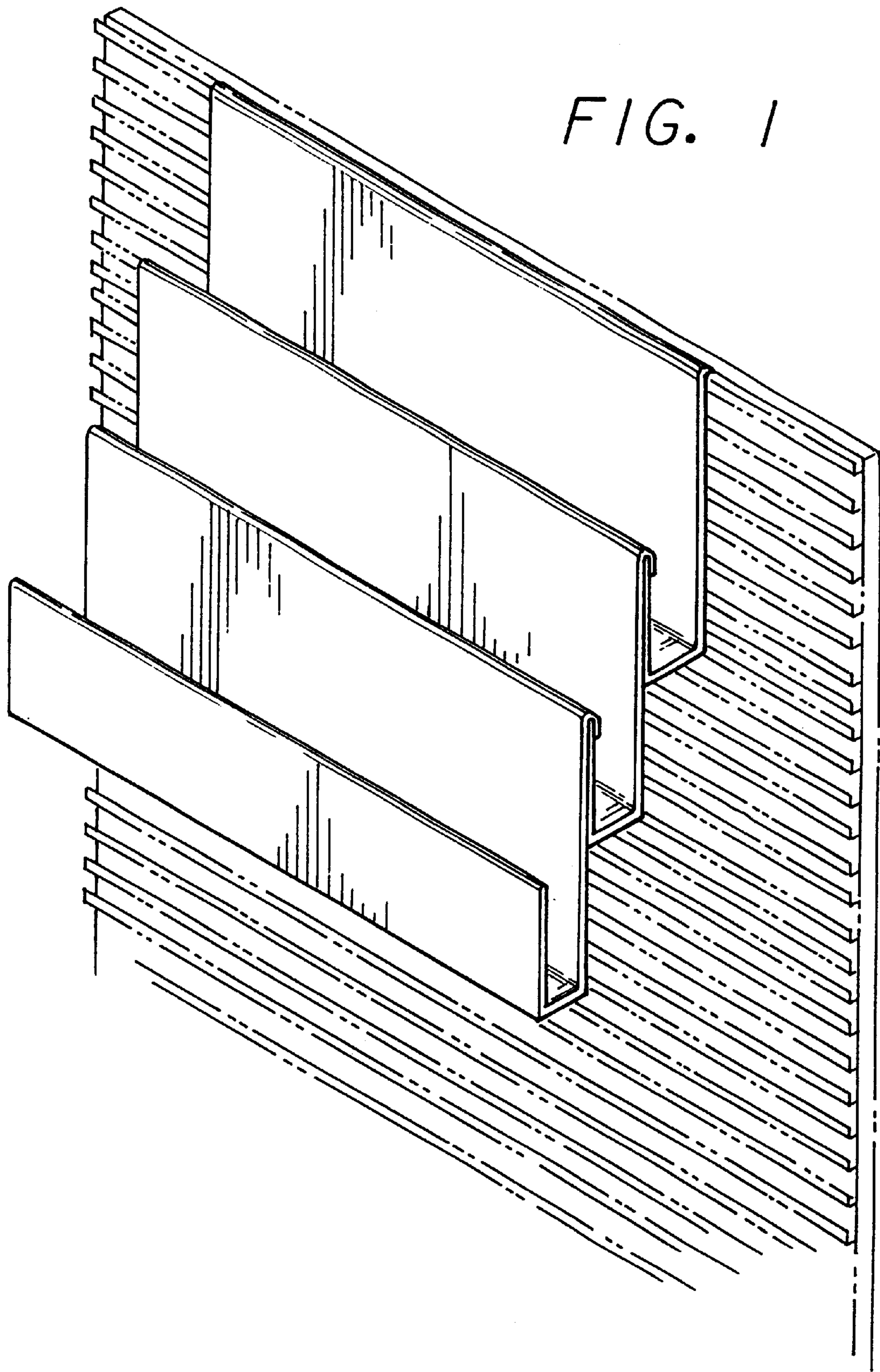

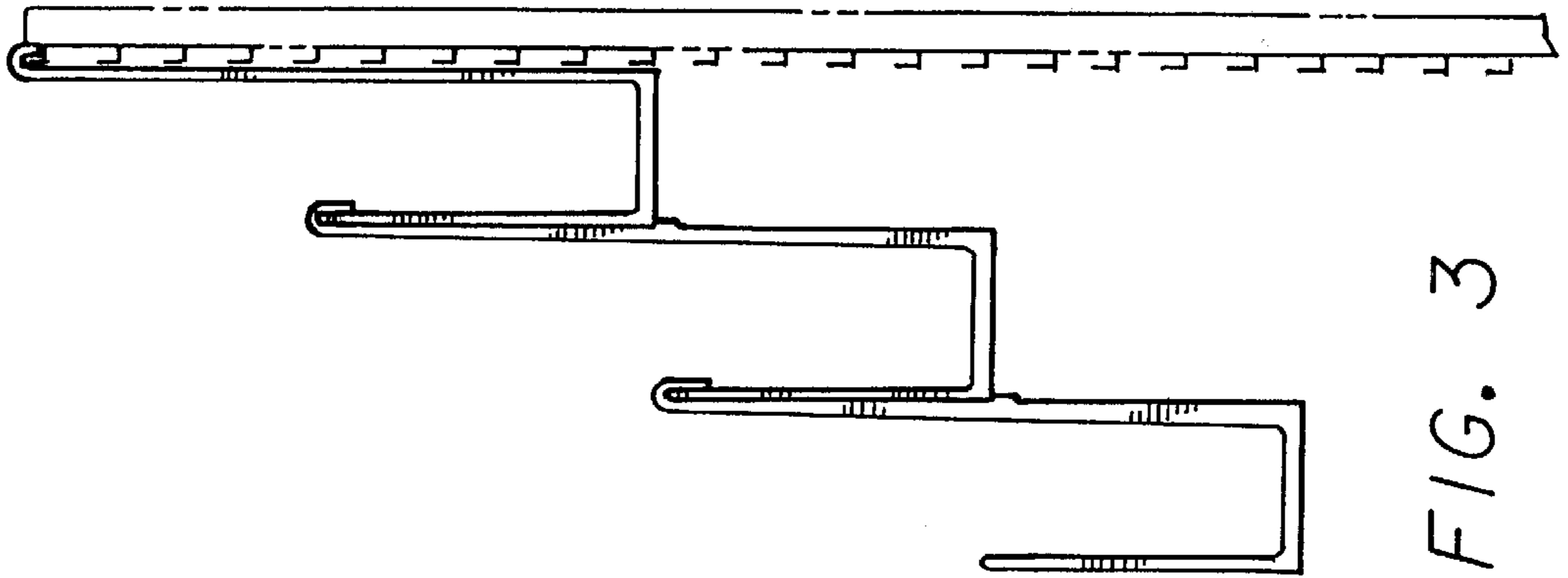
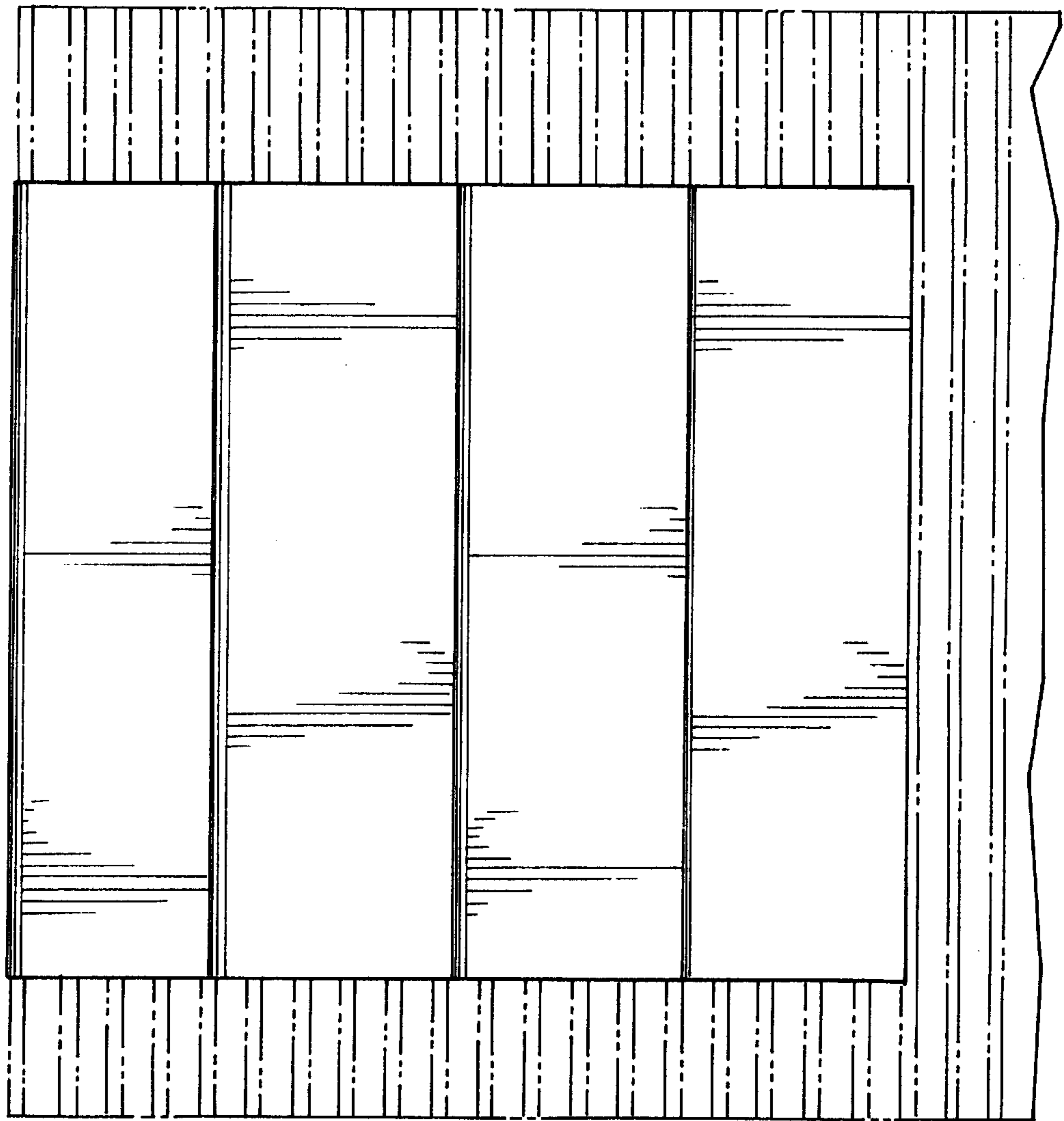

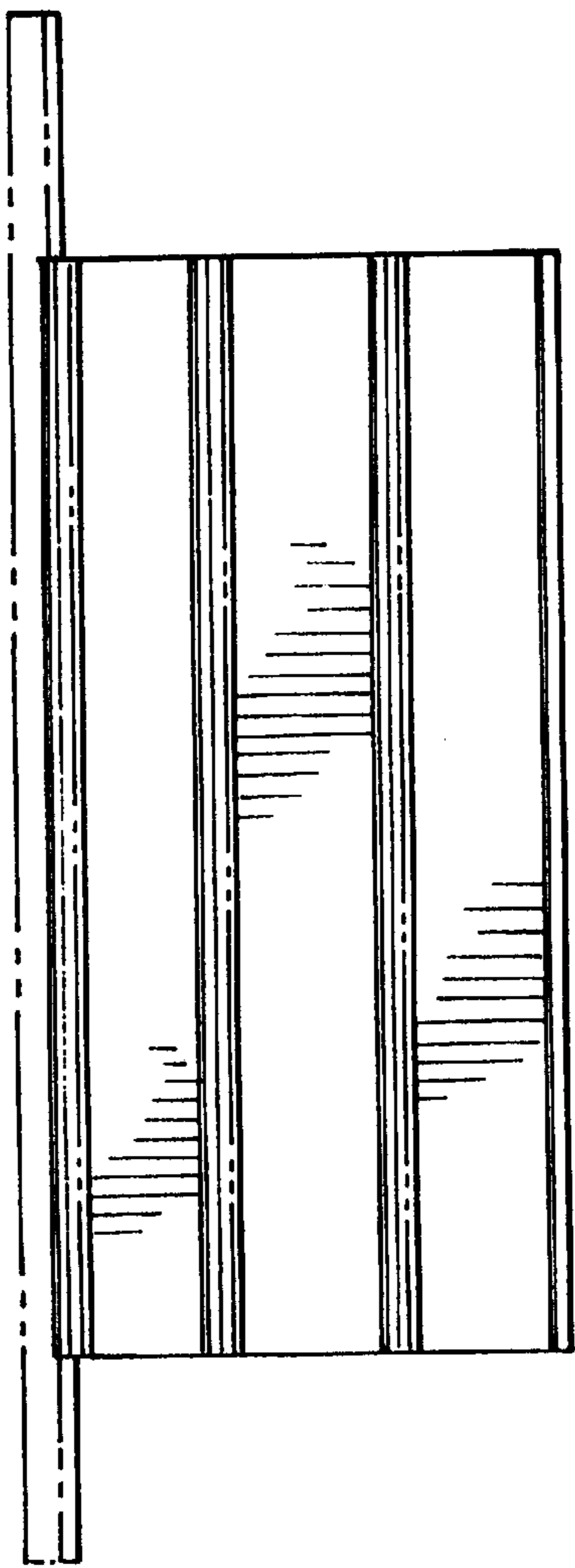

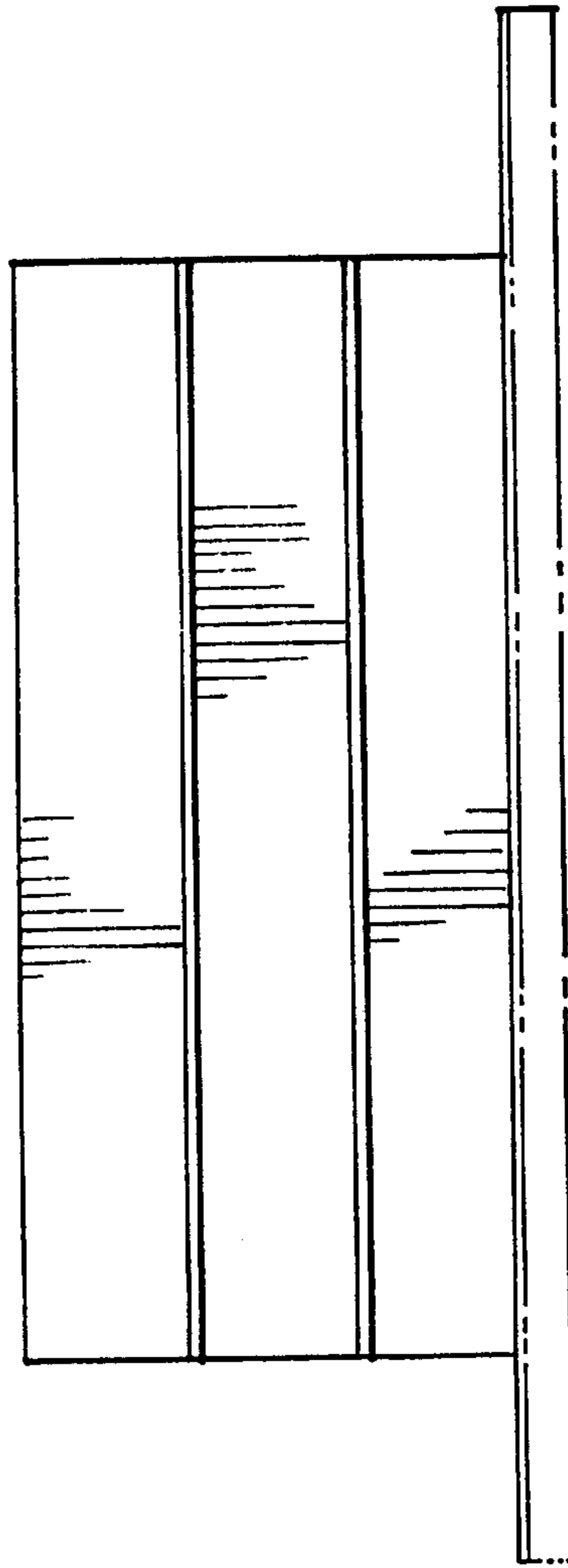

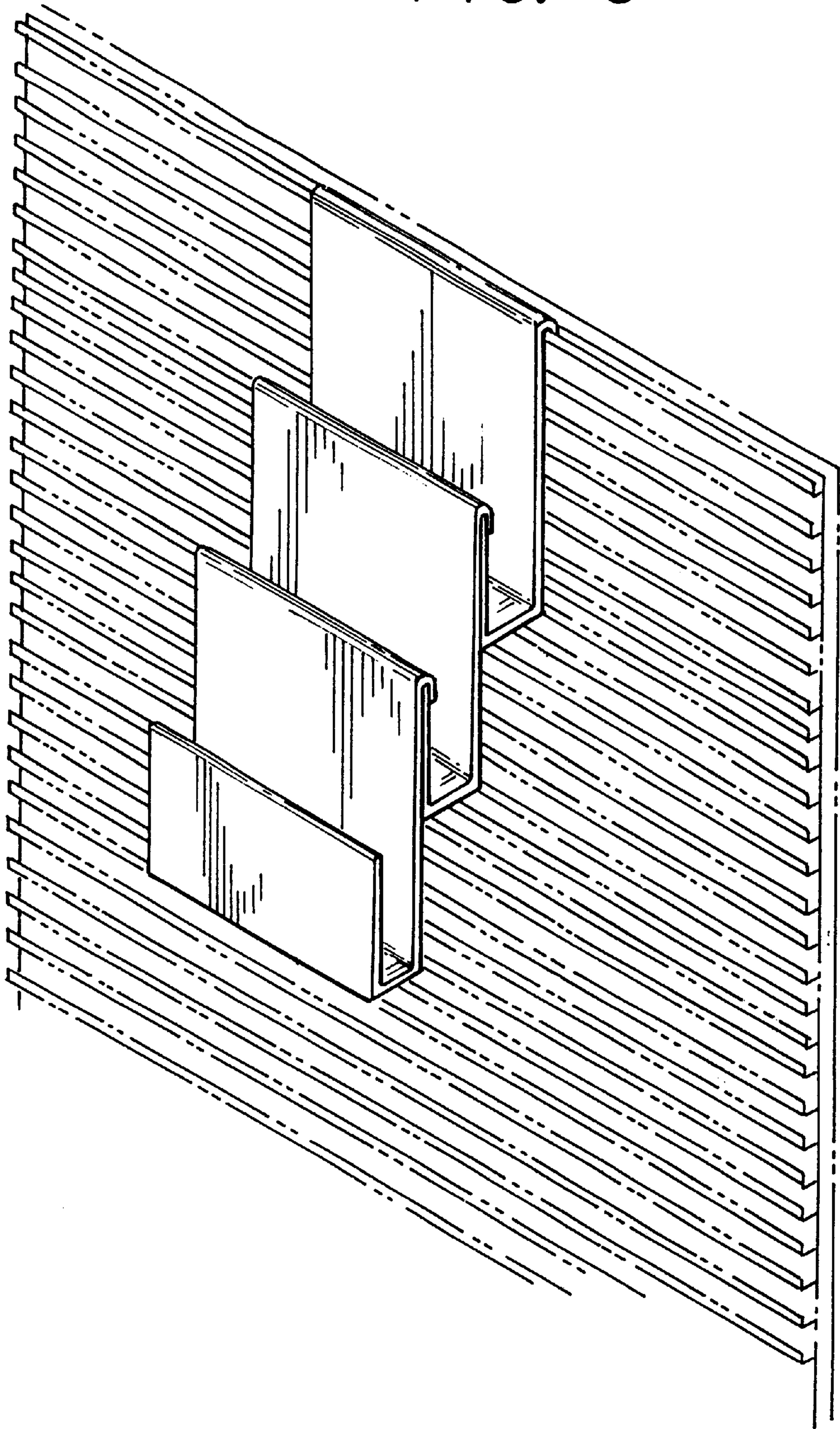

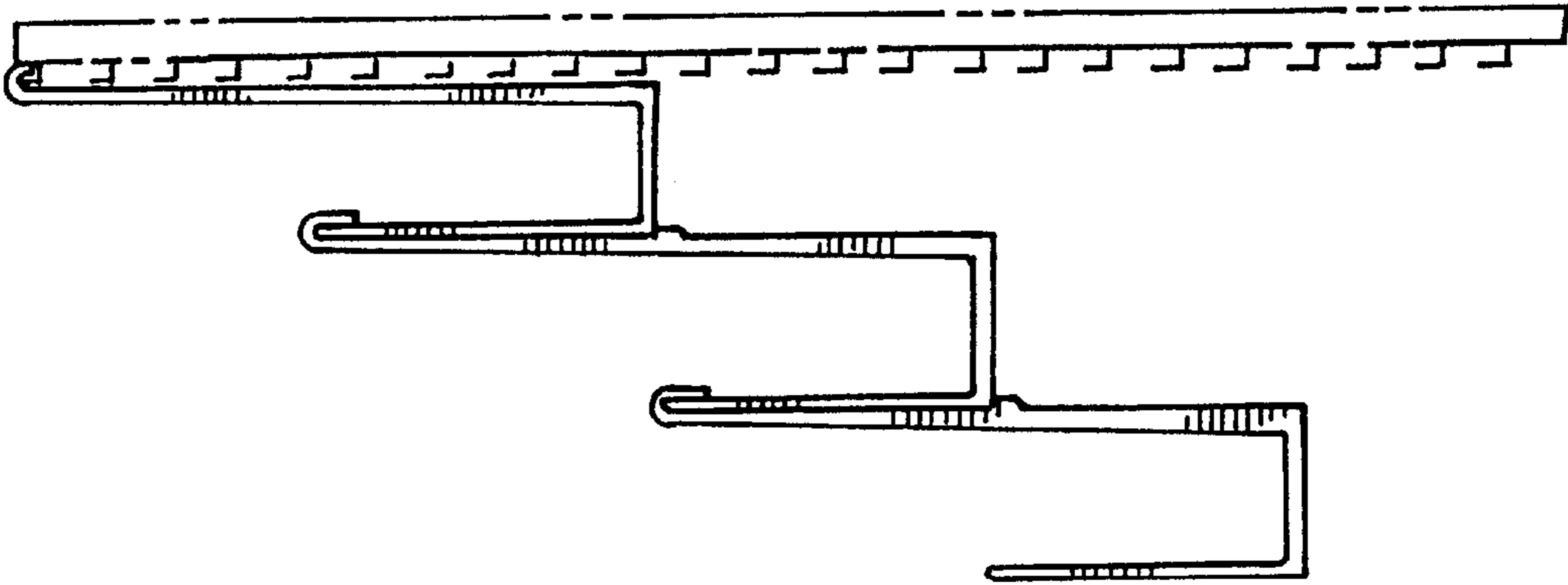
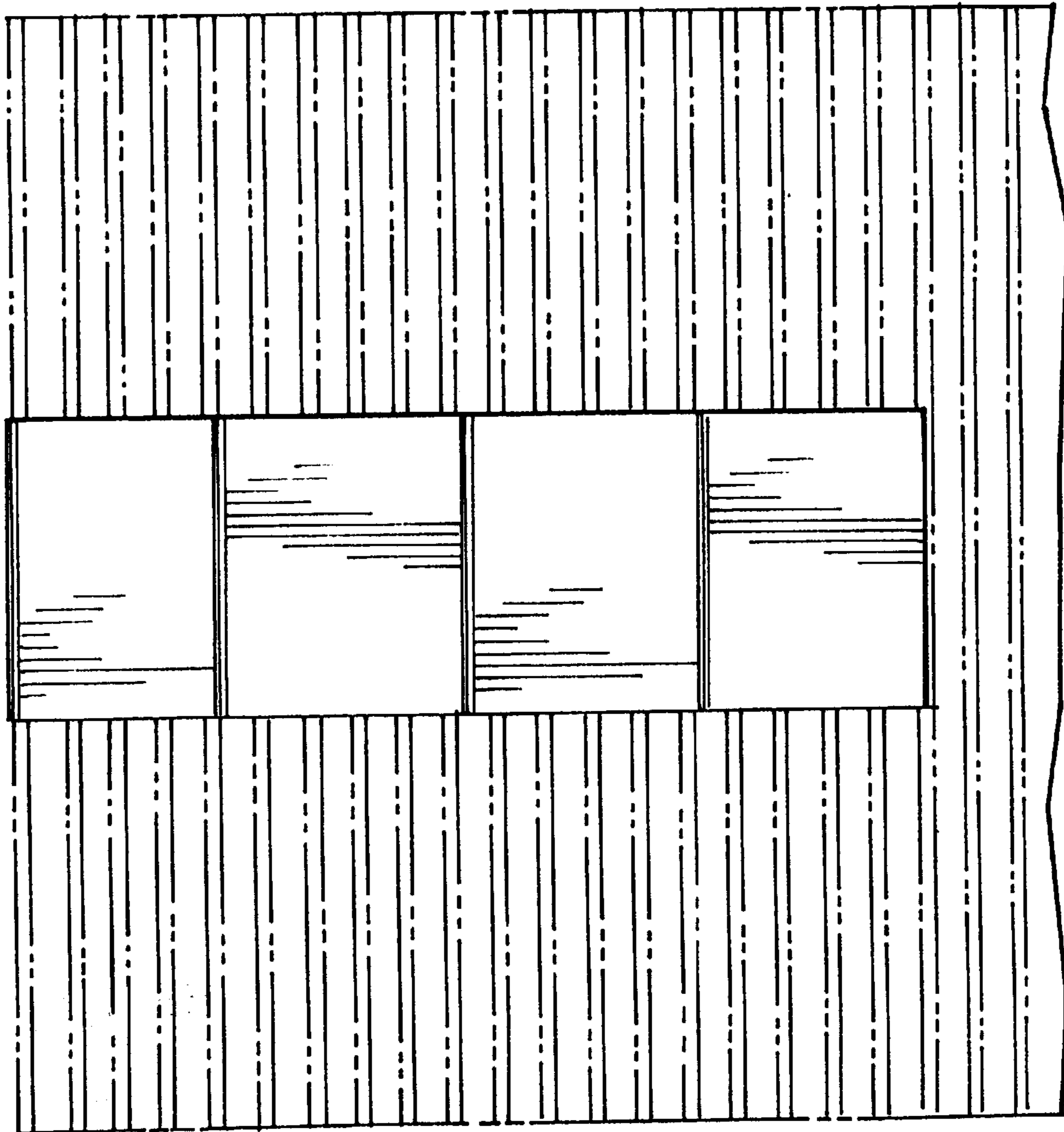

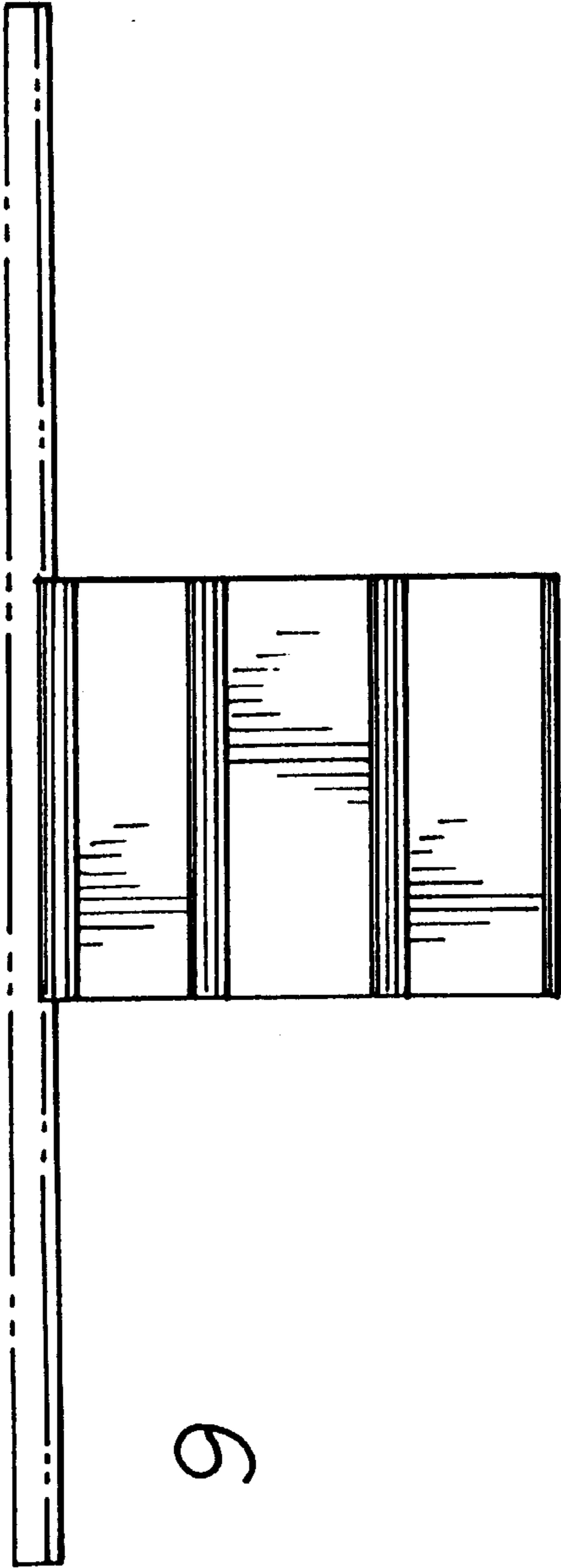

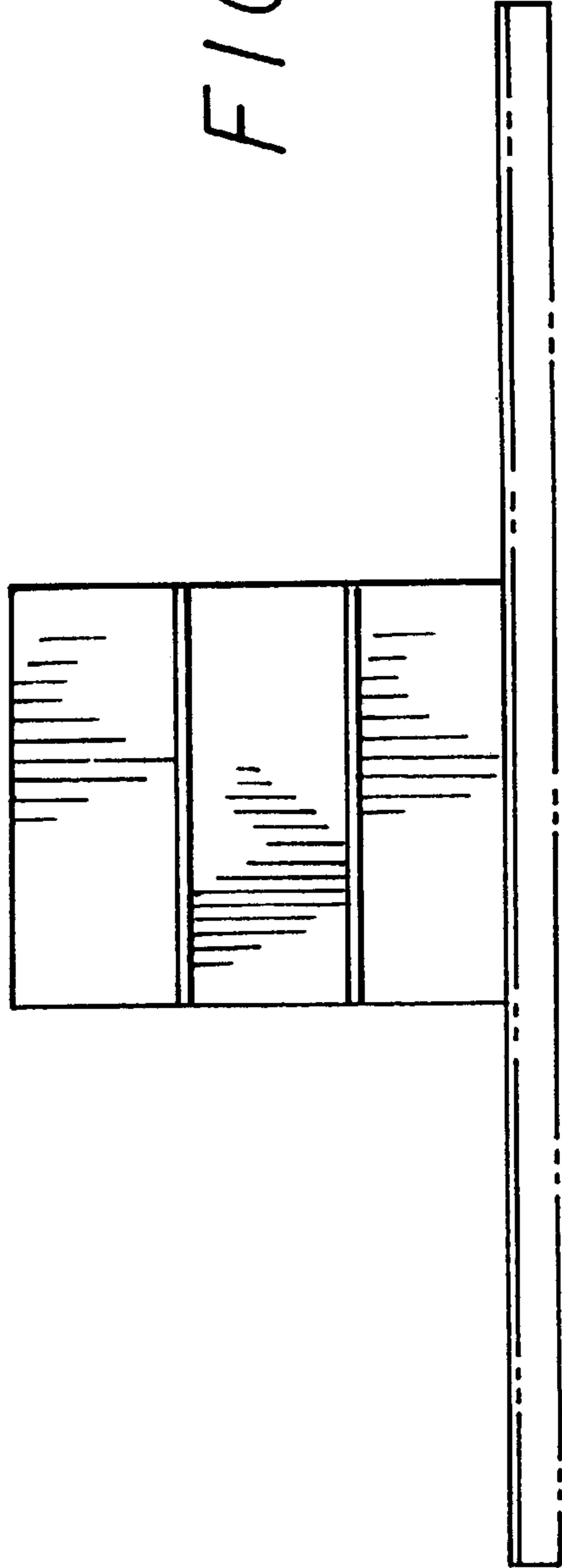
