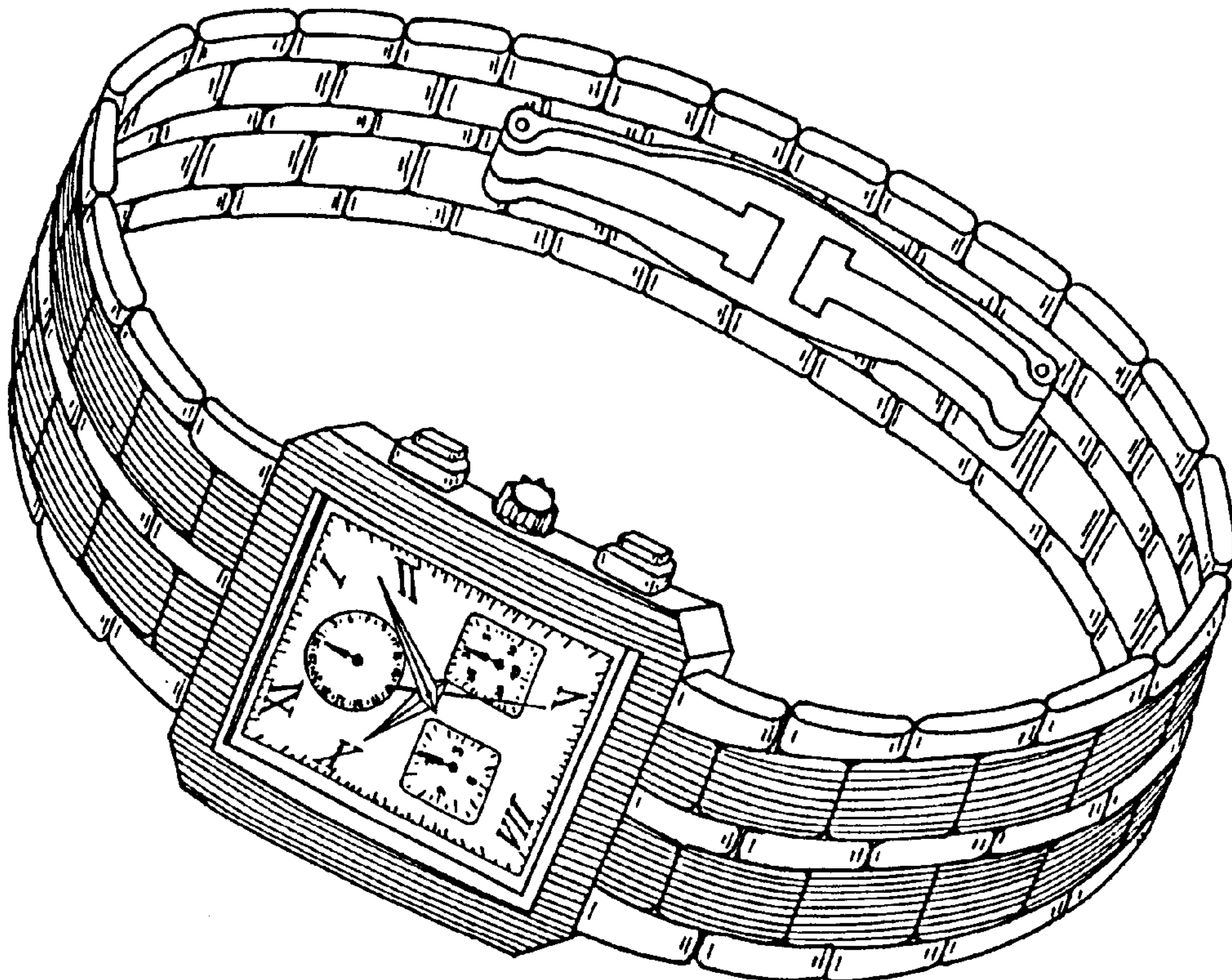
FIG. 1 is a top plan view thereof

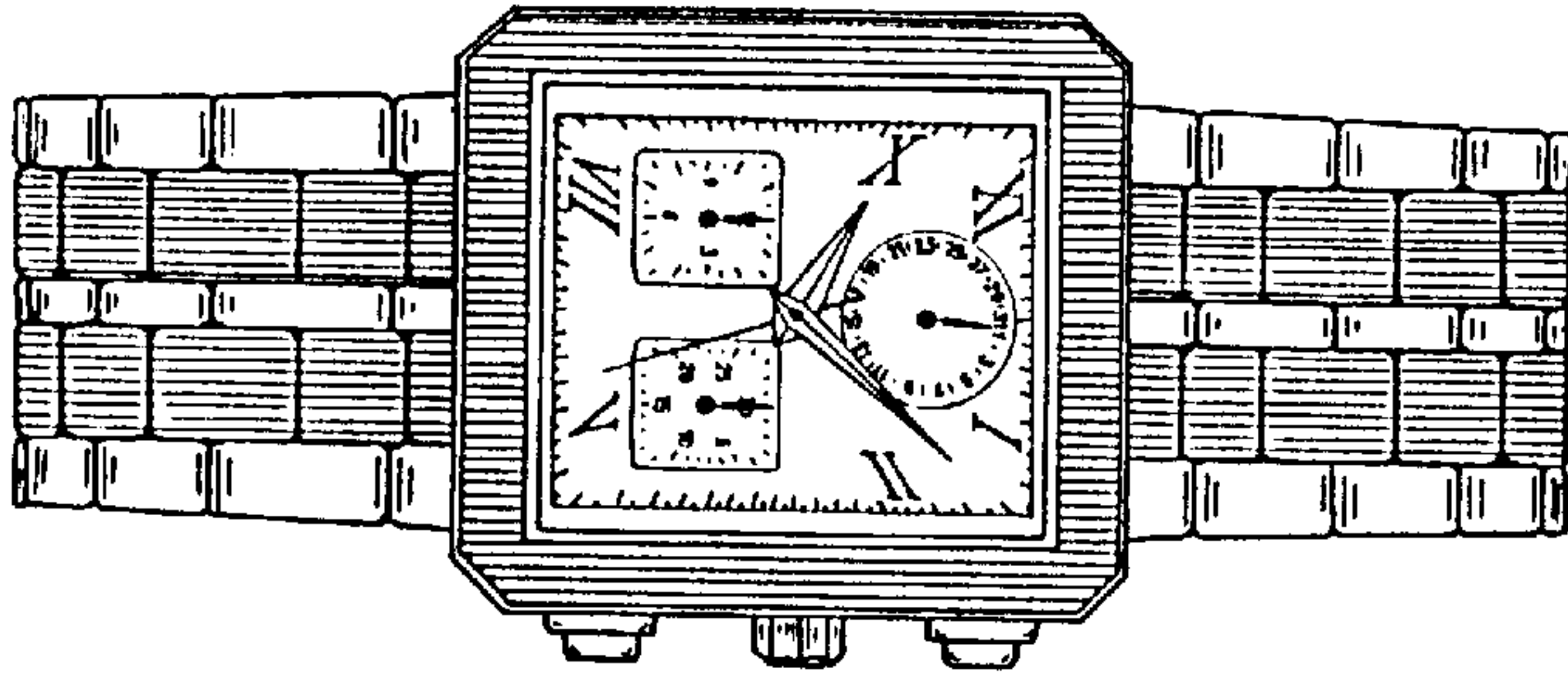

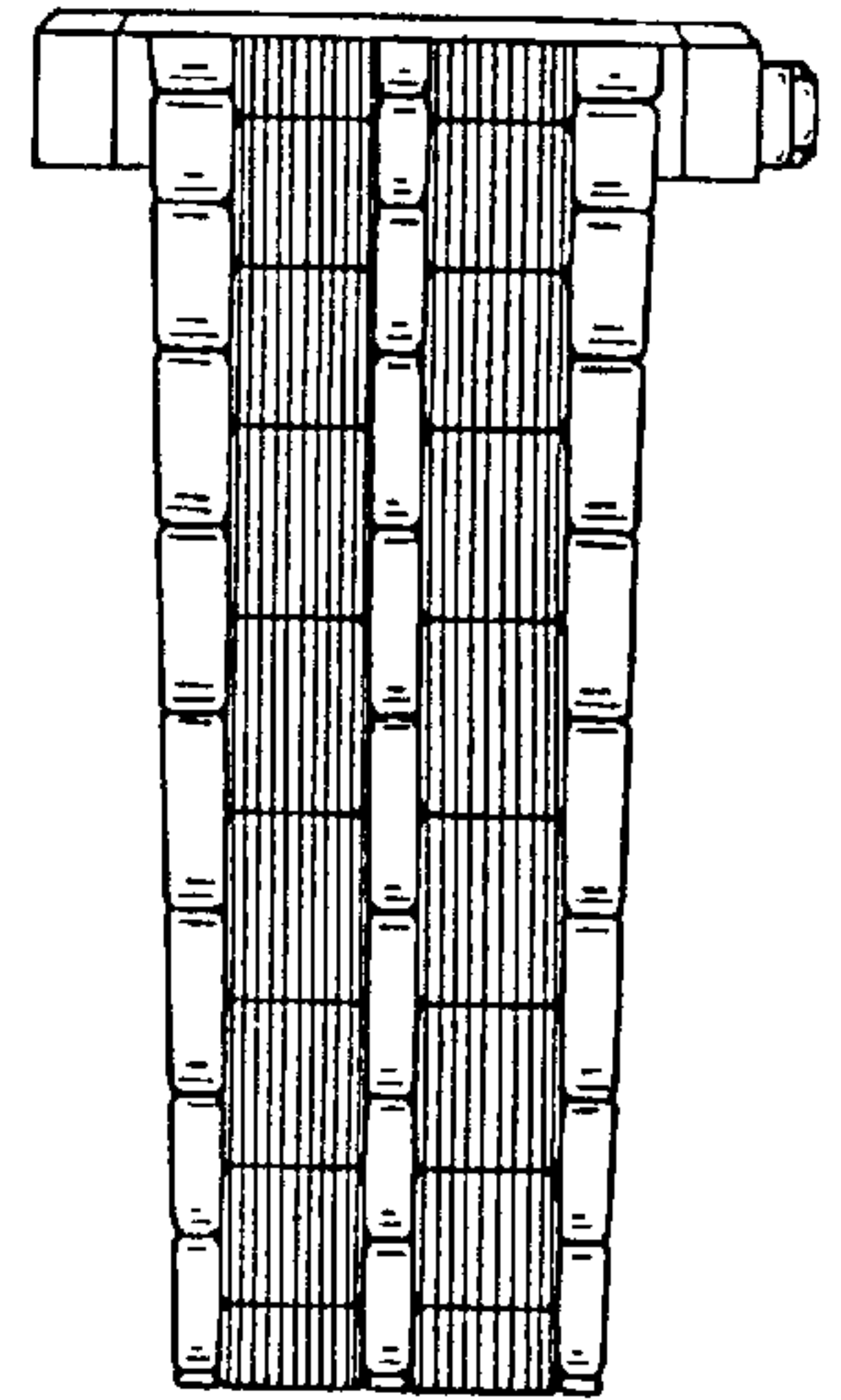

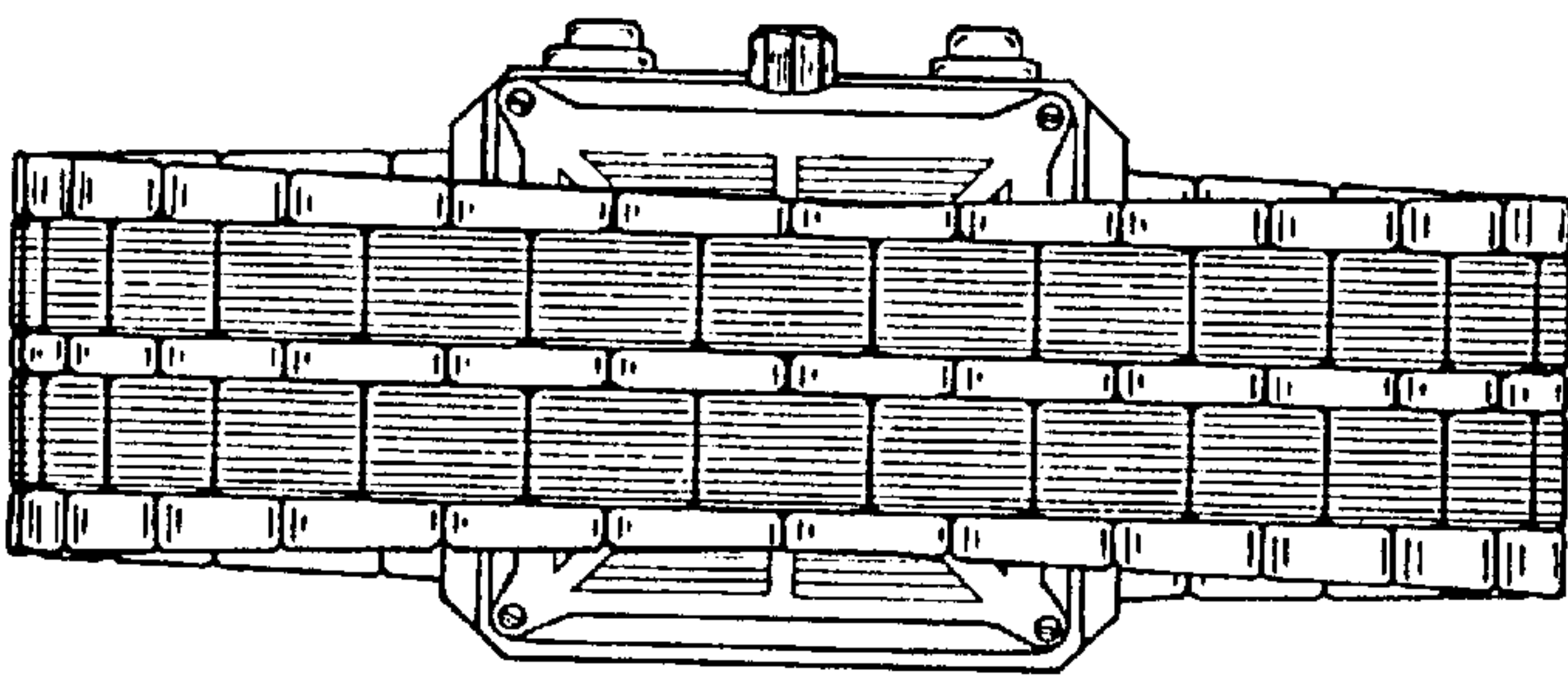

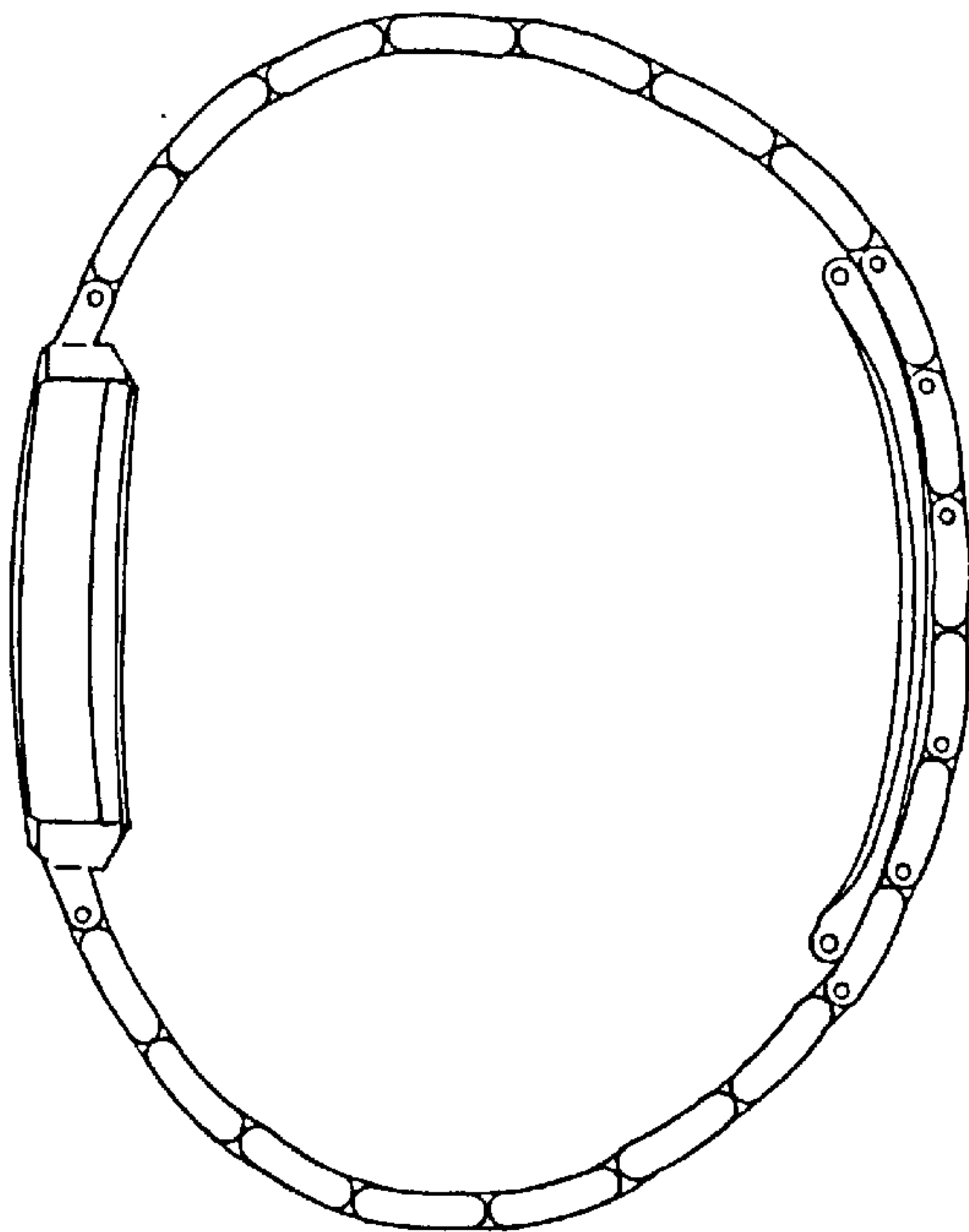

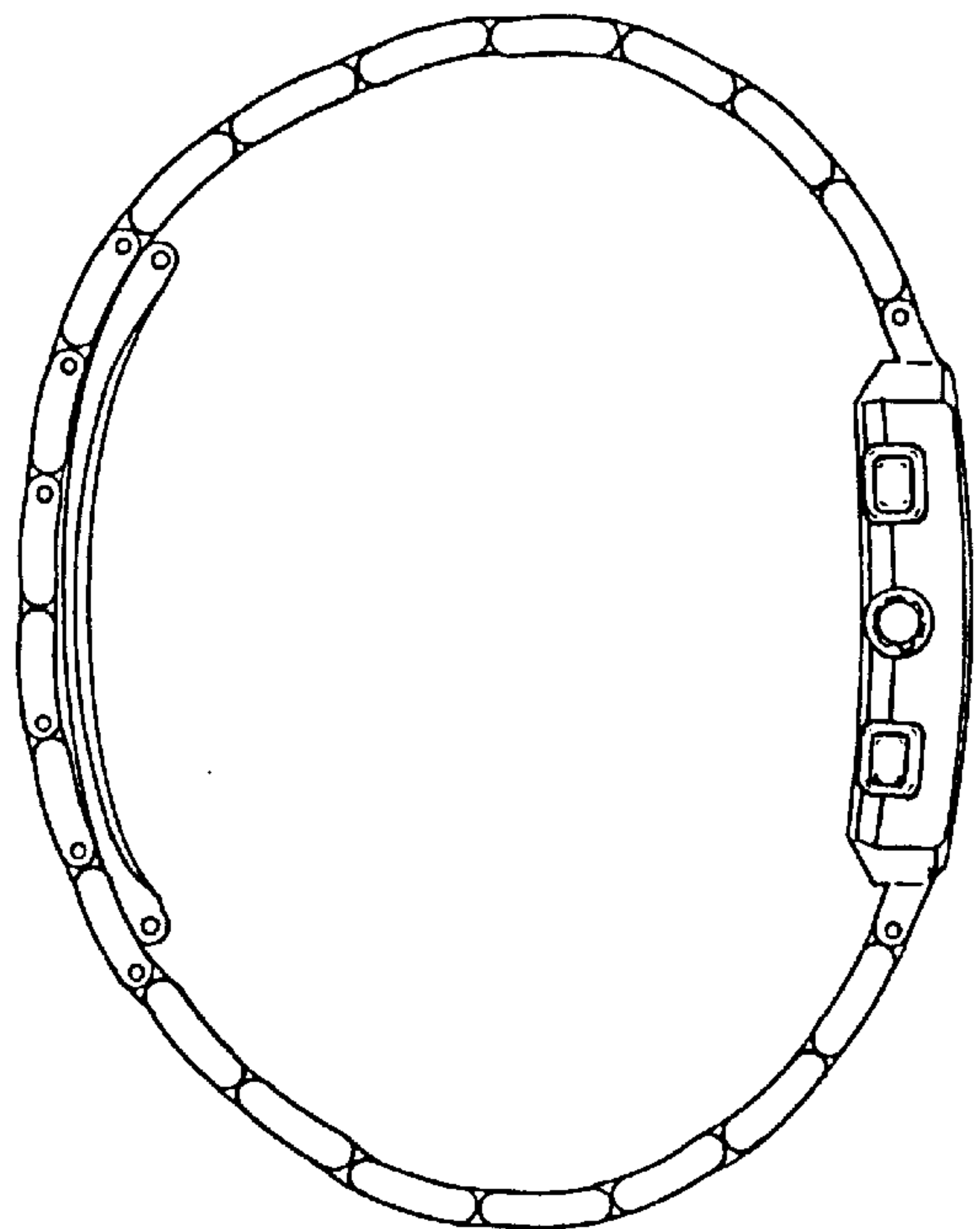

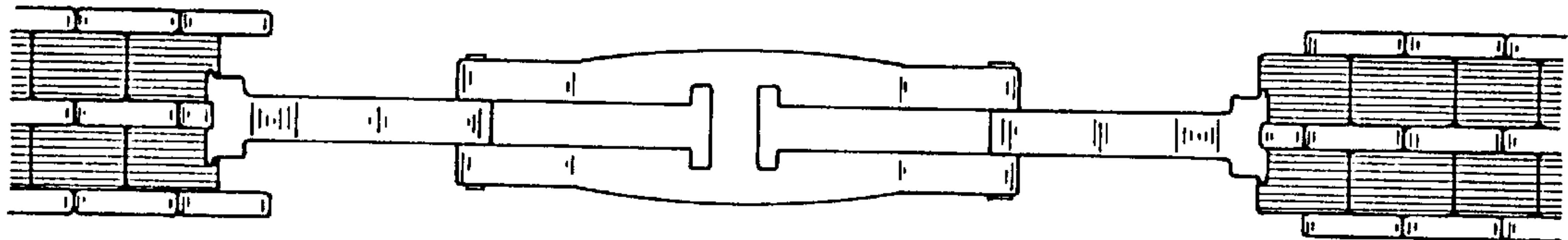

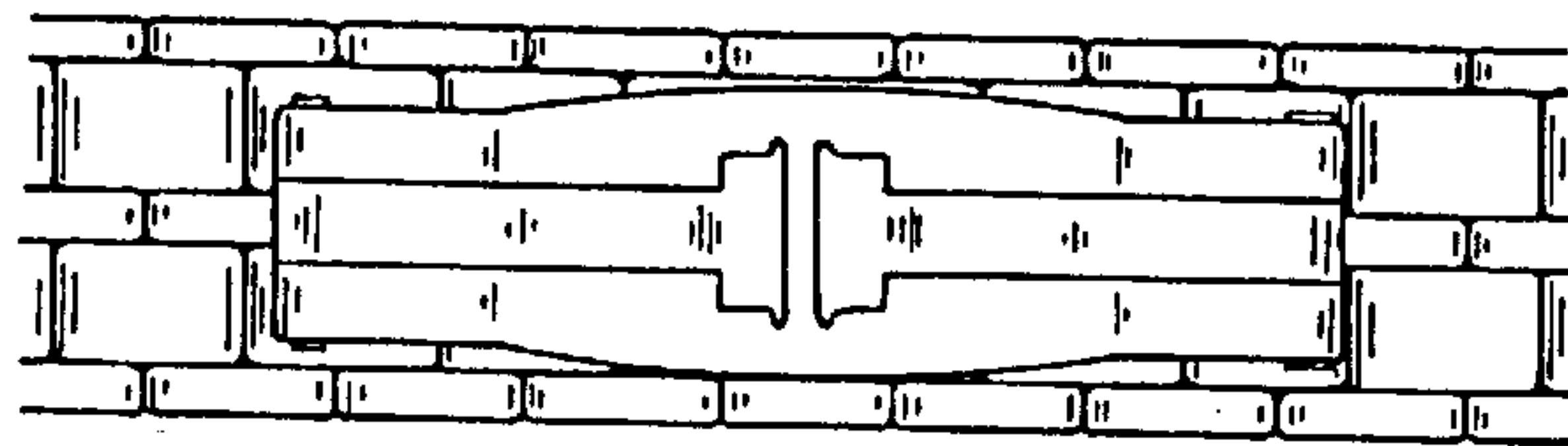

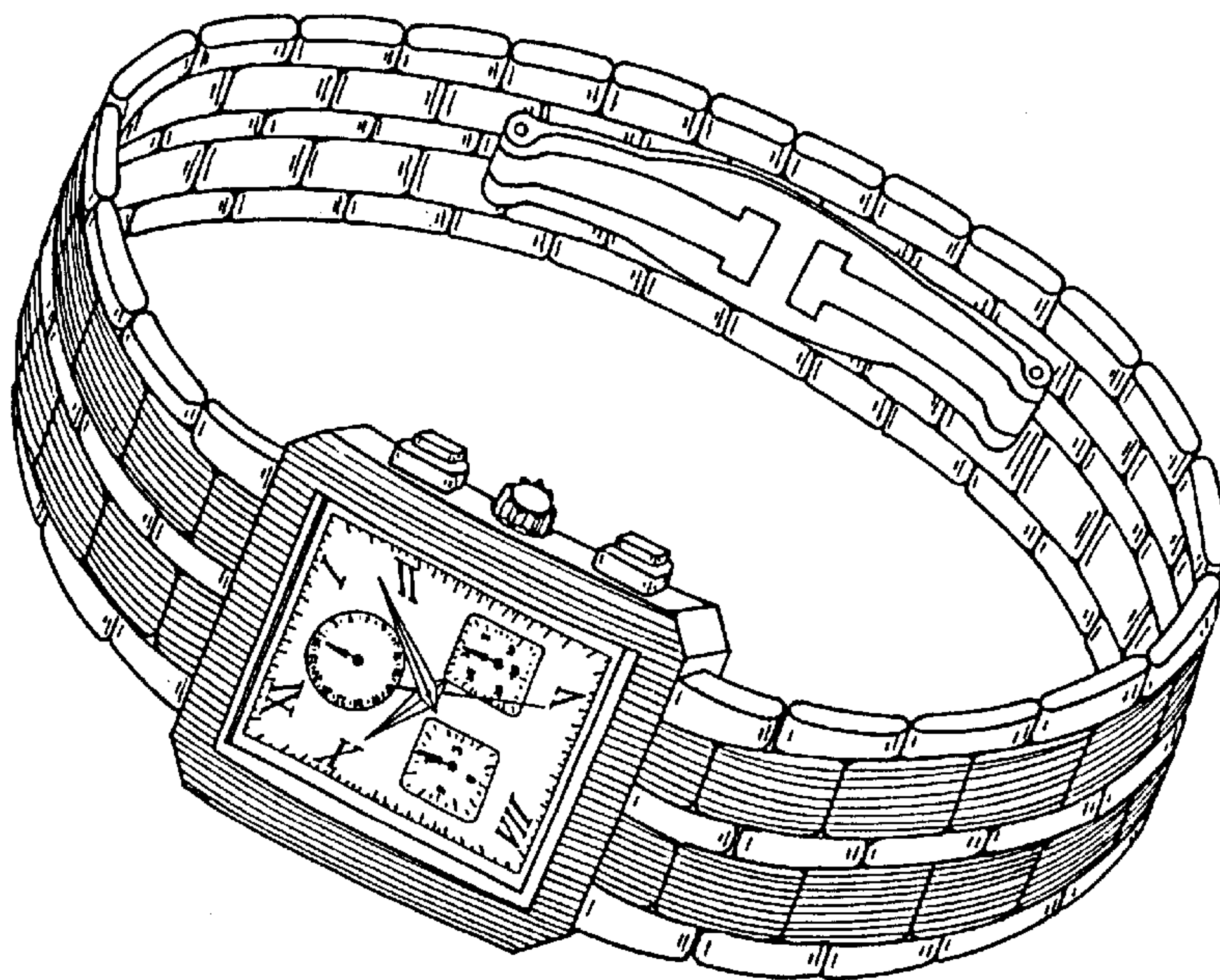
