(57) **CLAIM**

The ornamental design for a playyard canopy, as shown and described.

**DESCRIPTION**

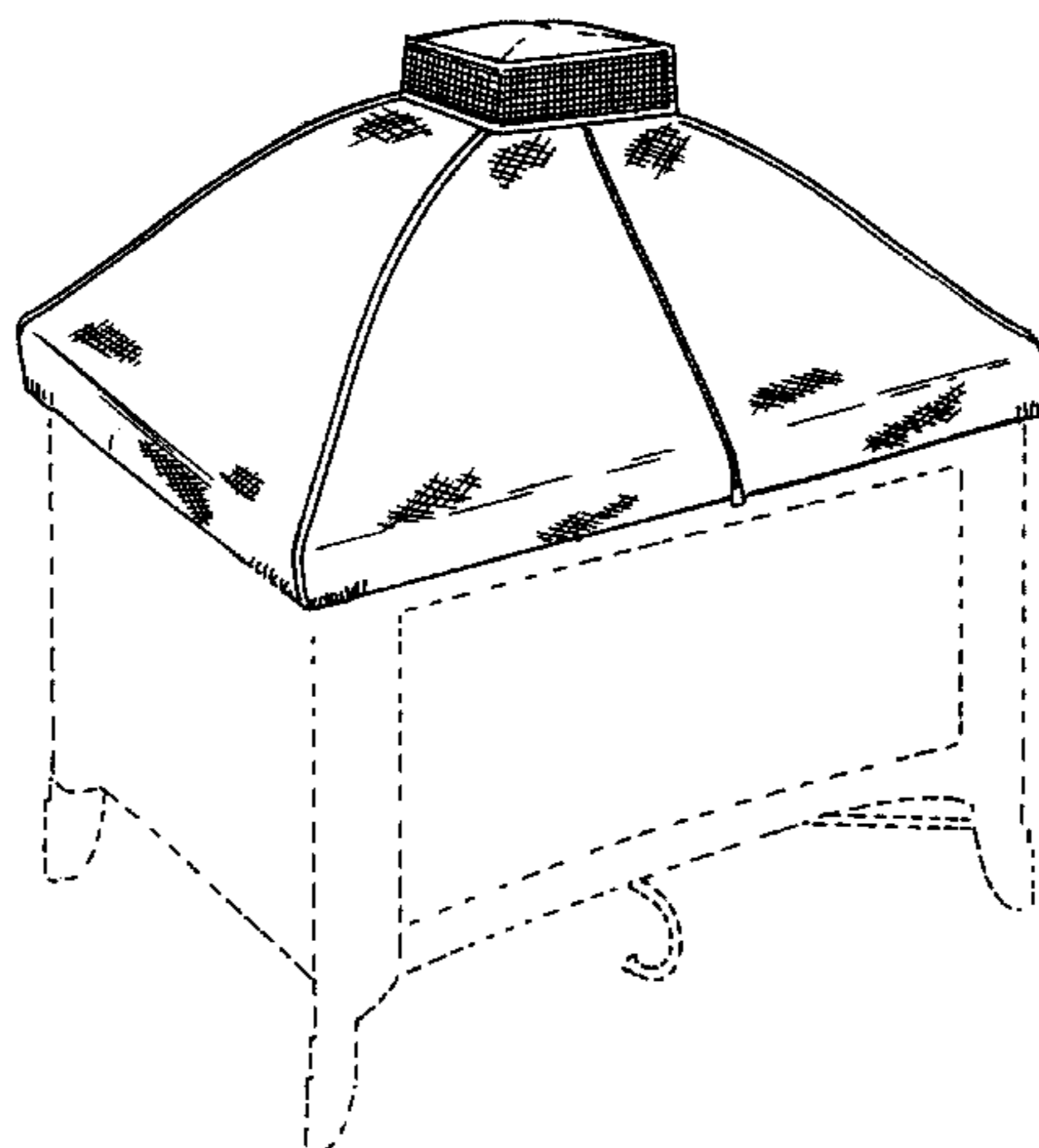
FIG. 3 is a left-side elevational view thereof, with the right side elevational view being identical;

FIG. 1 is a perspective view of a playyard canopy in accordance with our design with a playyard which forms the environment of the playyard canopy and forms no part of the claimed design, the playyard or portions thereof being shown in broken lines for illustrative purposes only in FIGS. 1, 2, 3, and 5;

FIG. 2 is a front elevational view thereof;

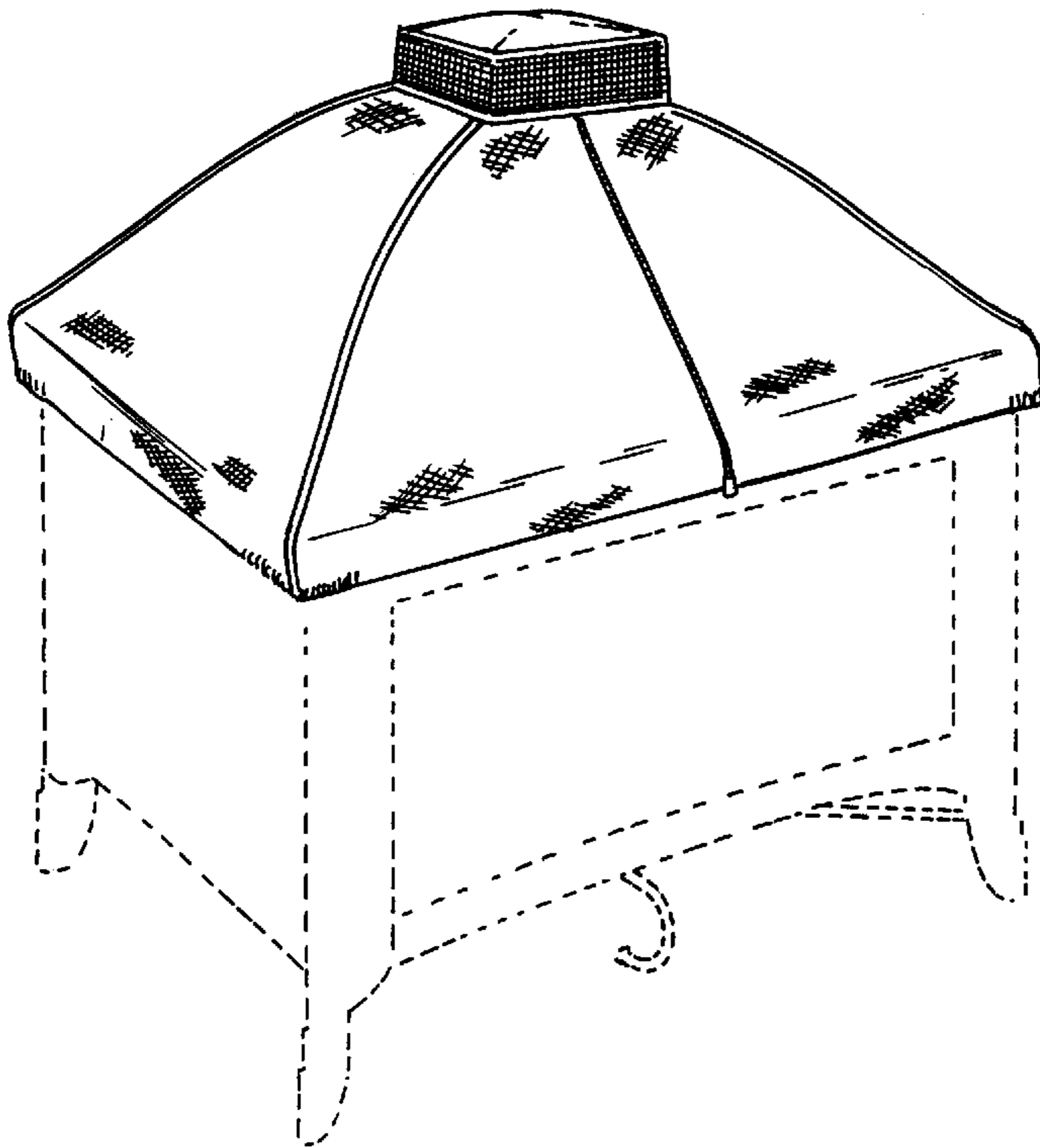
FIG. 4 is a top plan view thereof;

FIG. 5 is a rear elevational view thereof; and,

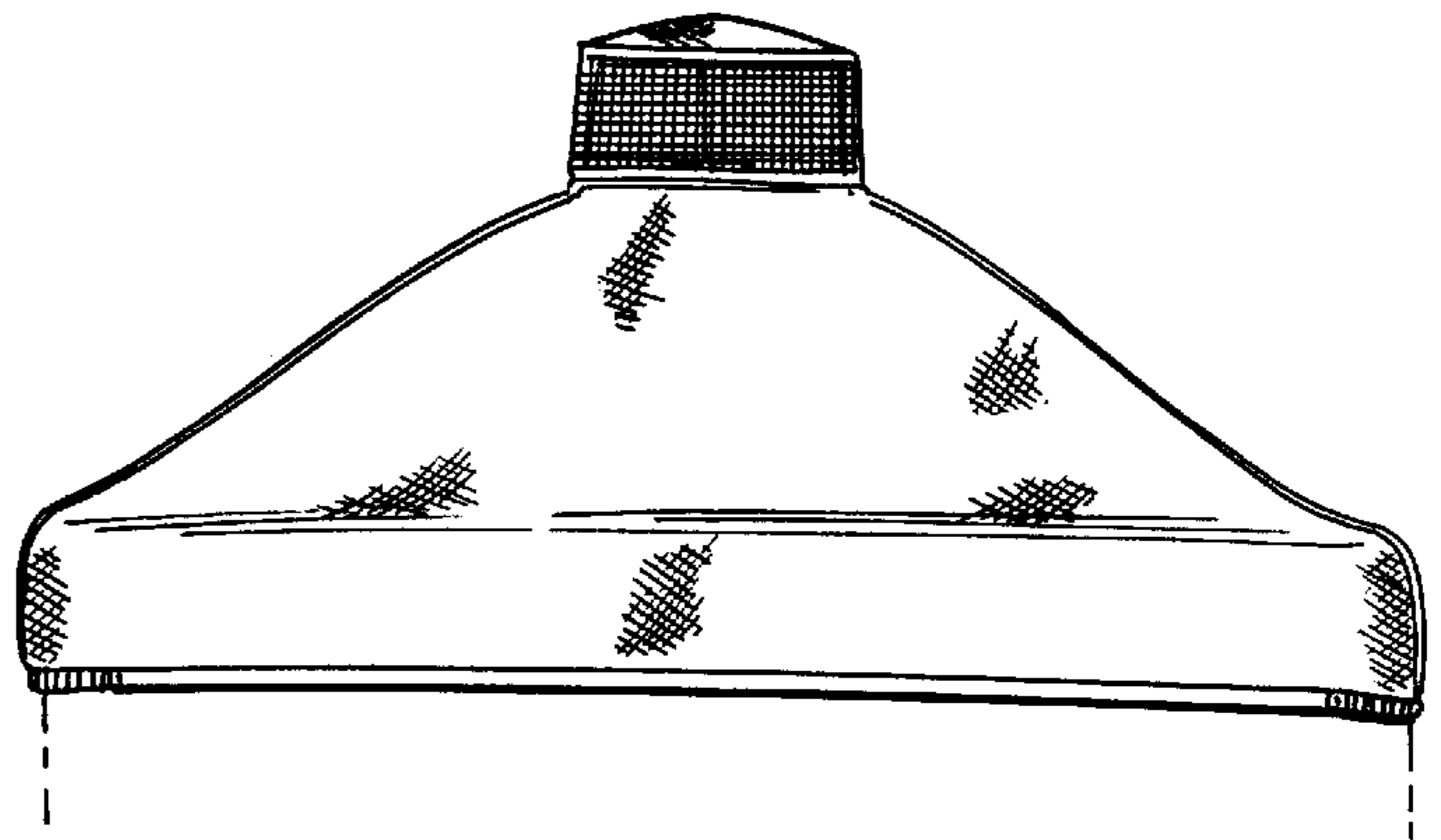
FIG. 6 is a bottom view thereof.

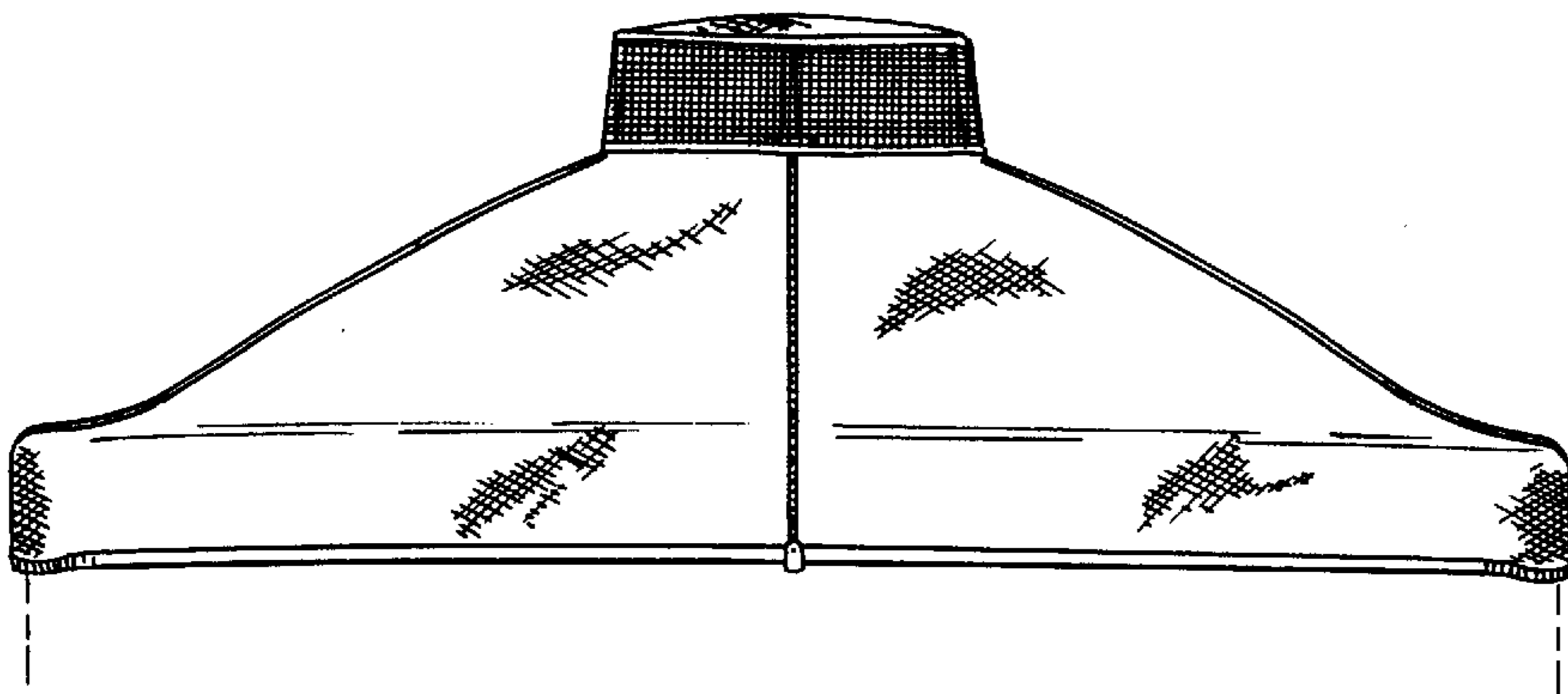

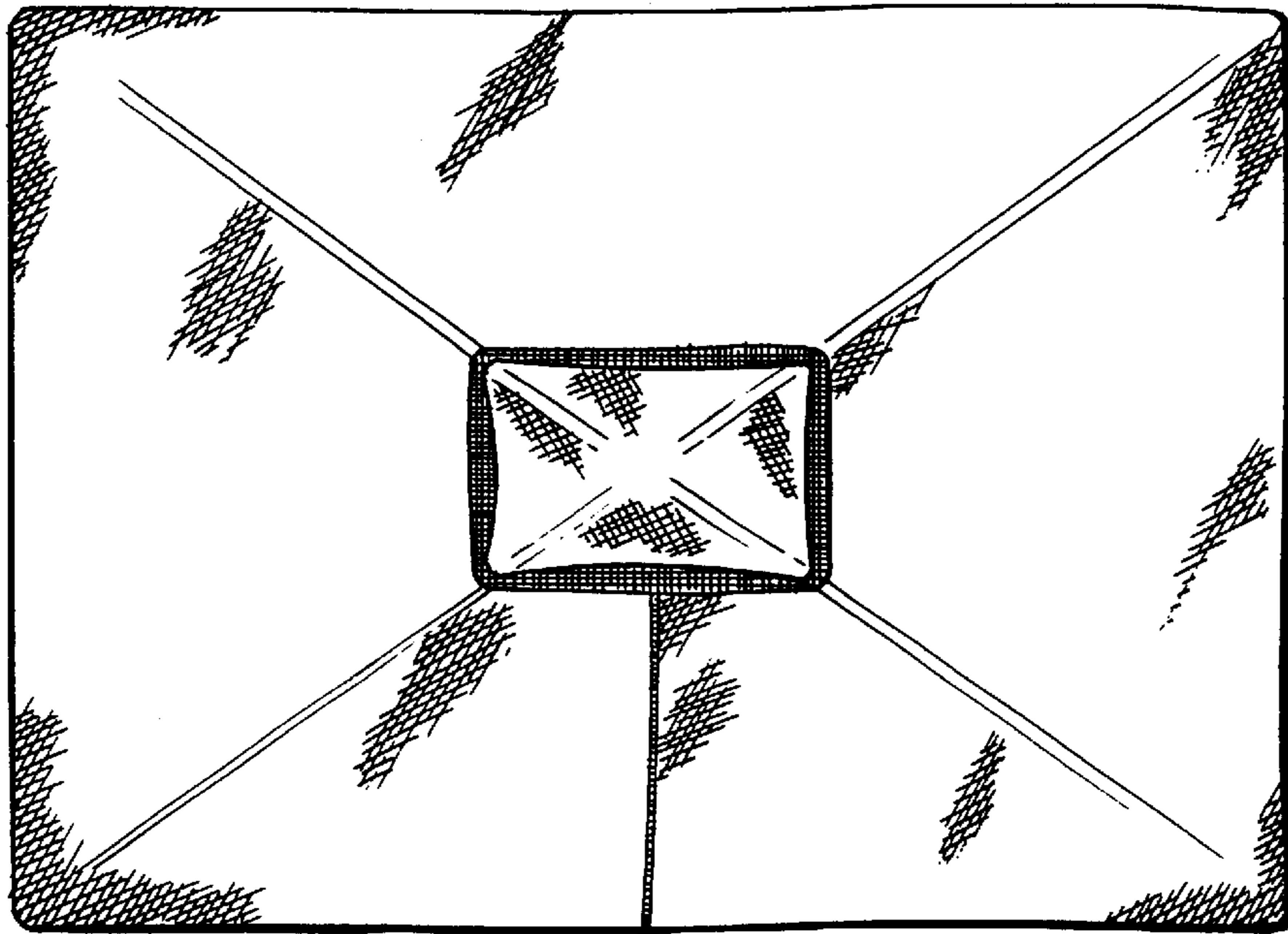

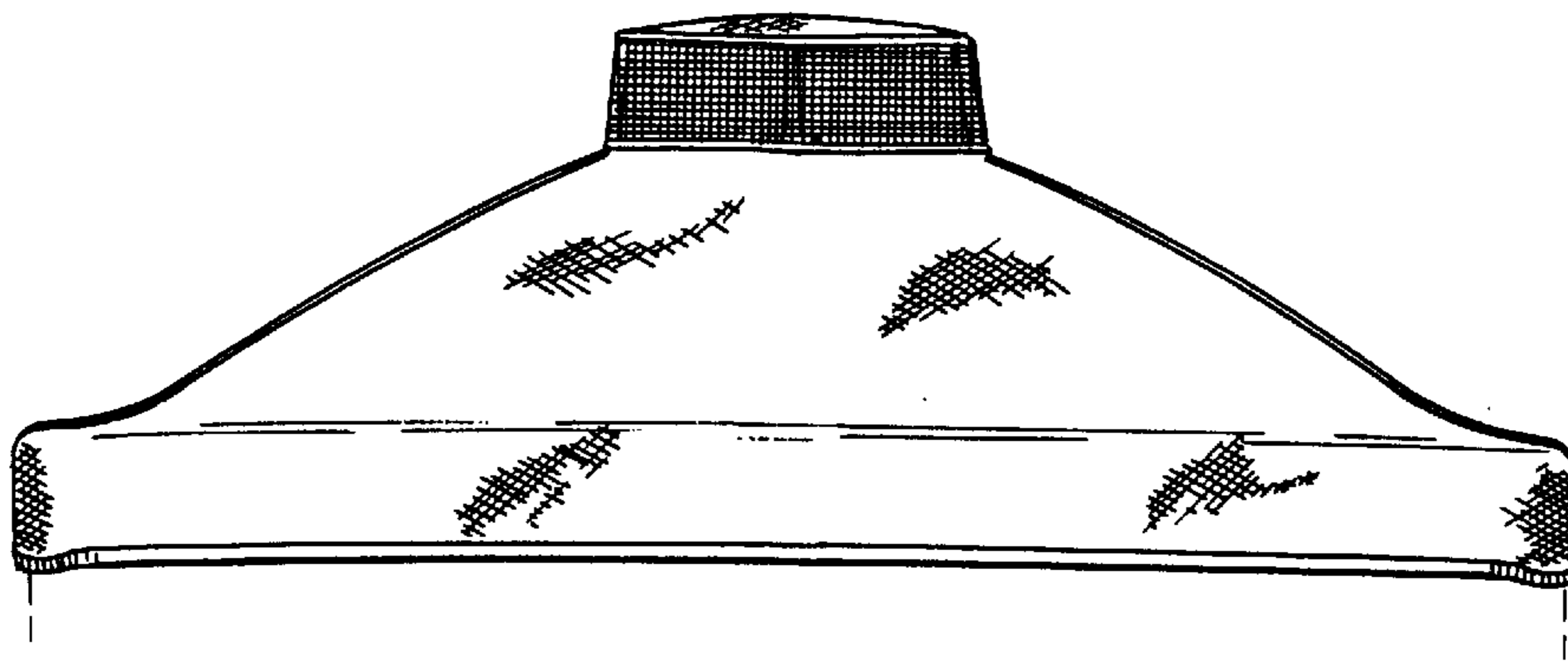

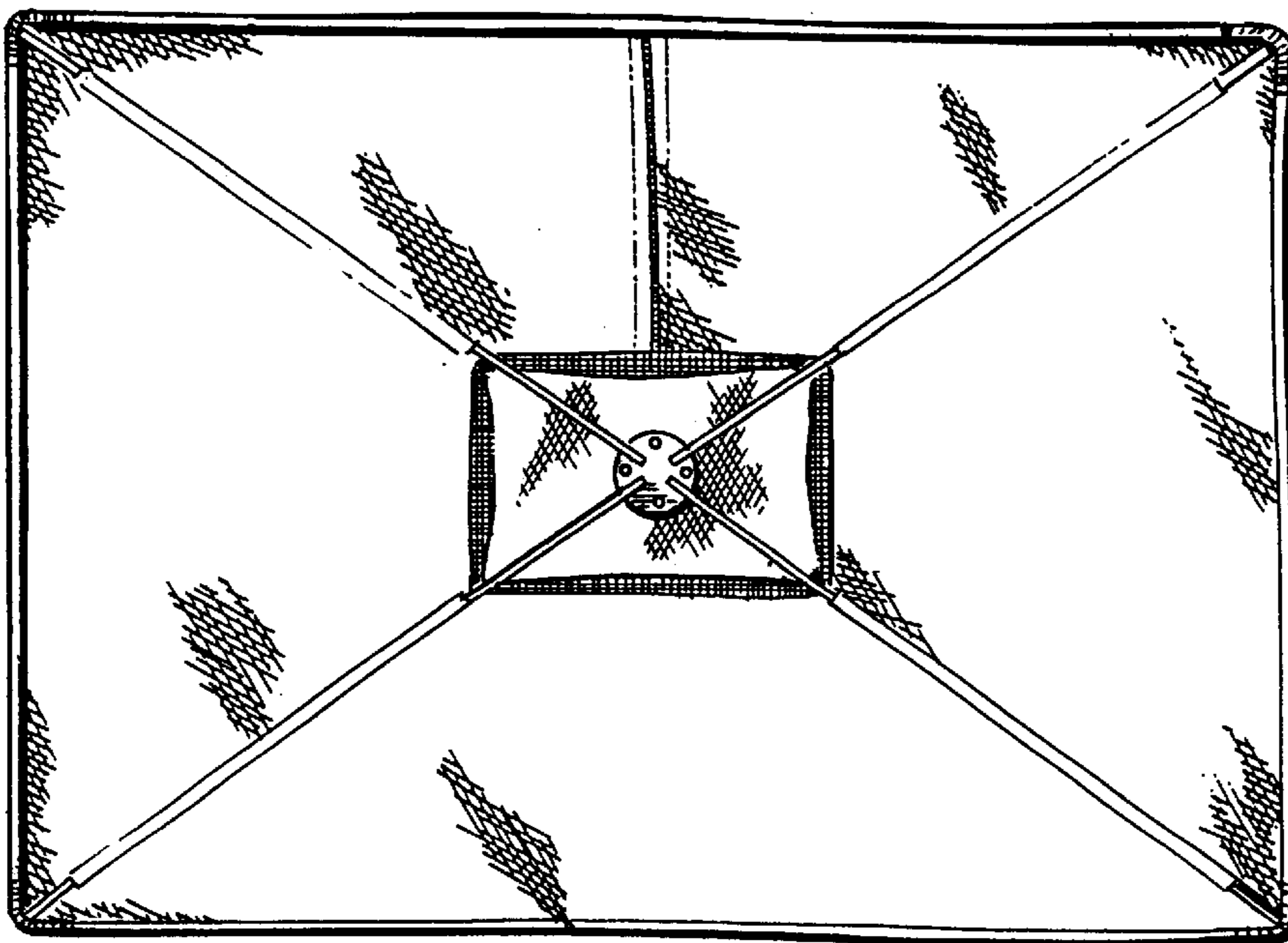
