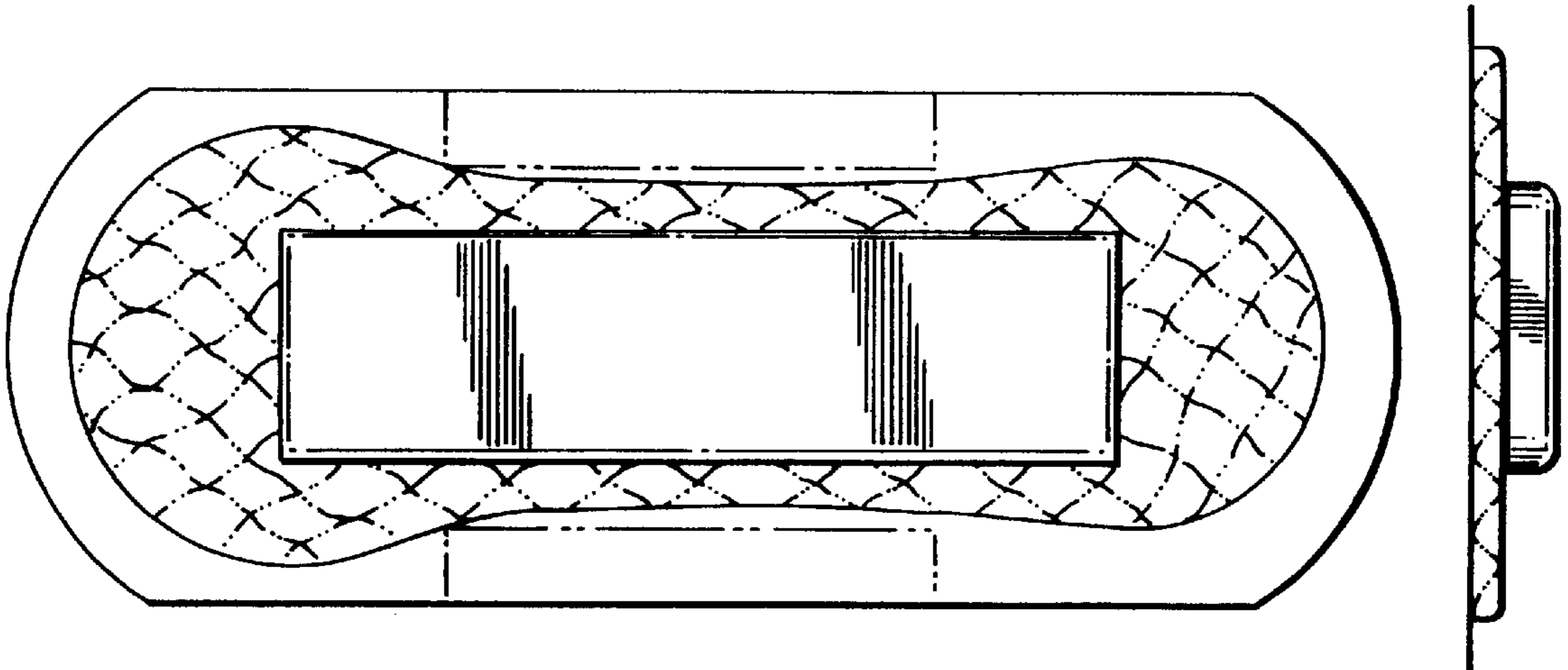
(57) **CLAIM**

We claim the ornamental design for a disposable absorbent article, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a disposable absorbent article, showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a side elevational view thereof.

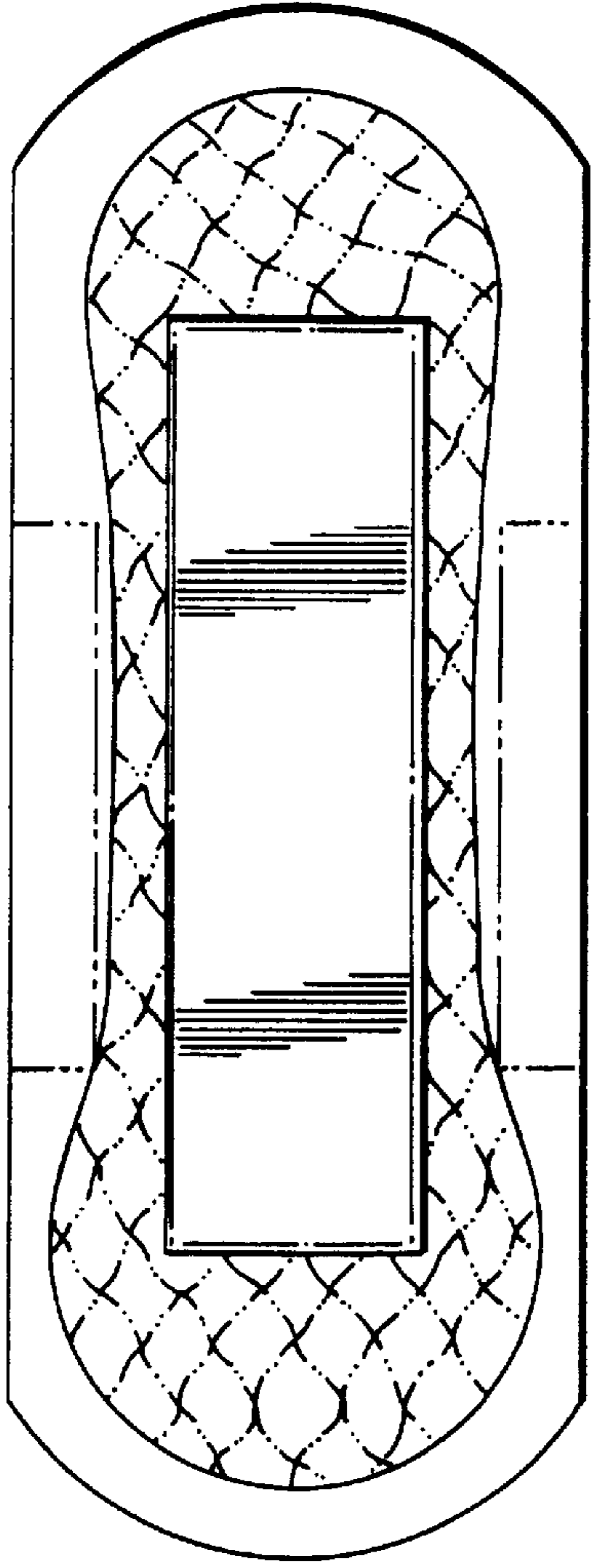

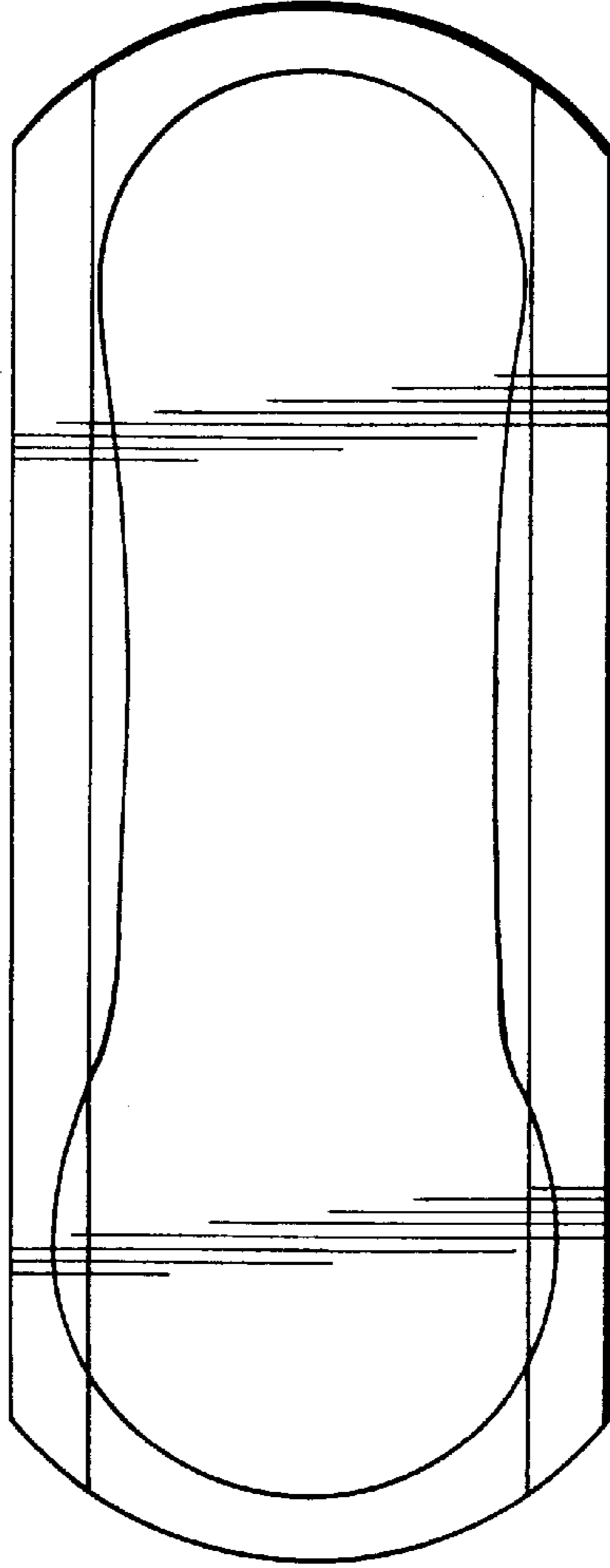
