(57) **CLAIM**

The ornamental design for a small animal enclosure, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the small animal enclosure embodying my new design.

FIG. 2 is a front elevation view thereof;

FIG. 3 is a left side elevation view thereof, the right side view being the mirror image thereof;

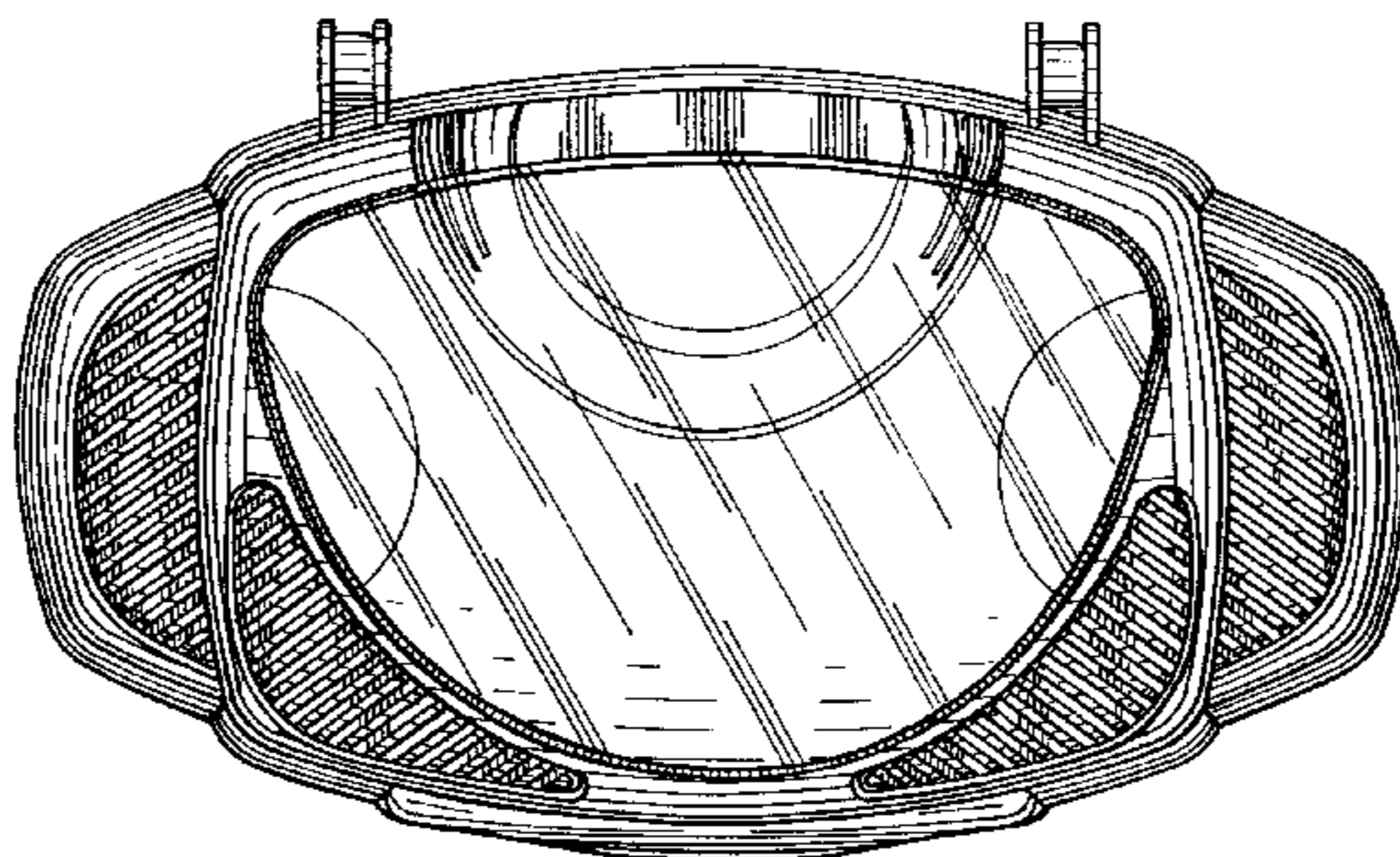
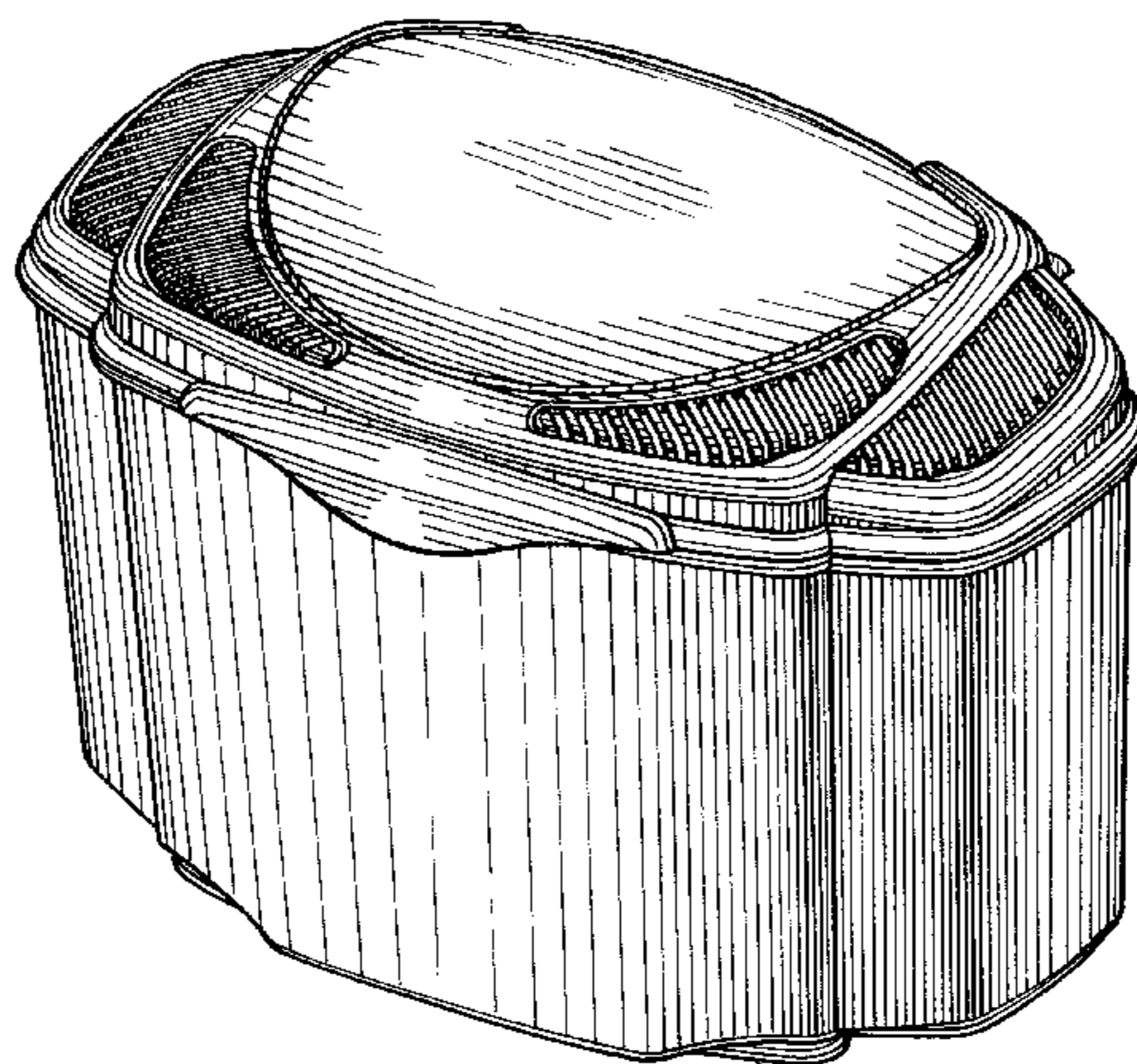
FIG. 4 is a rear elevation view thereof;

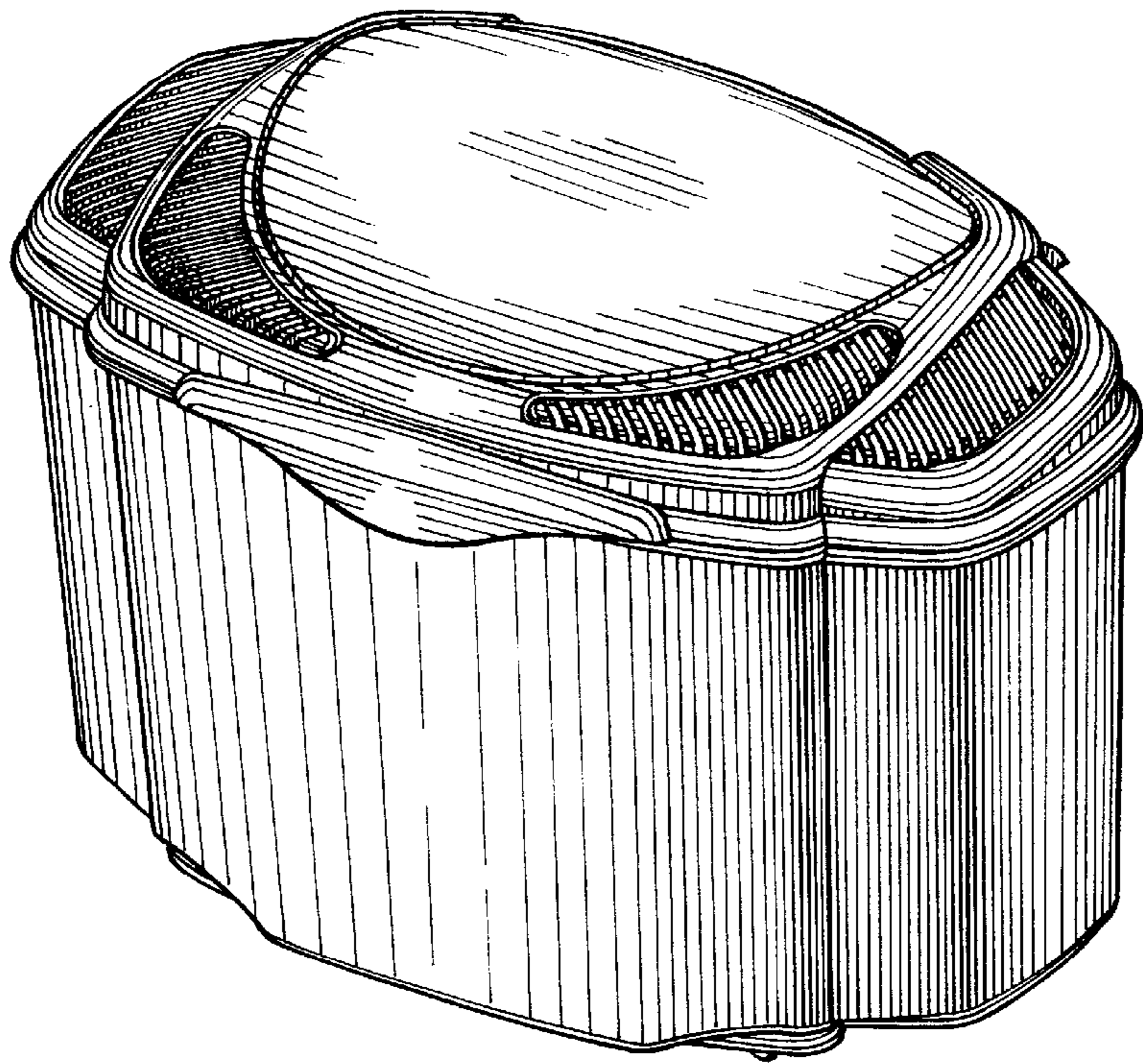

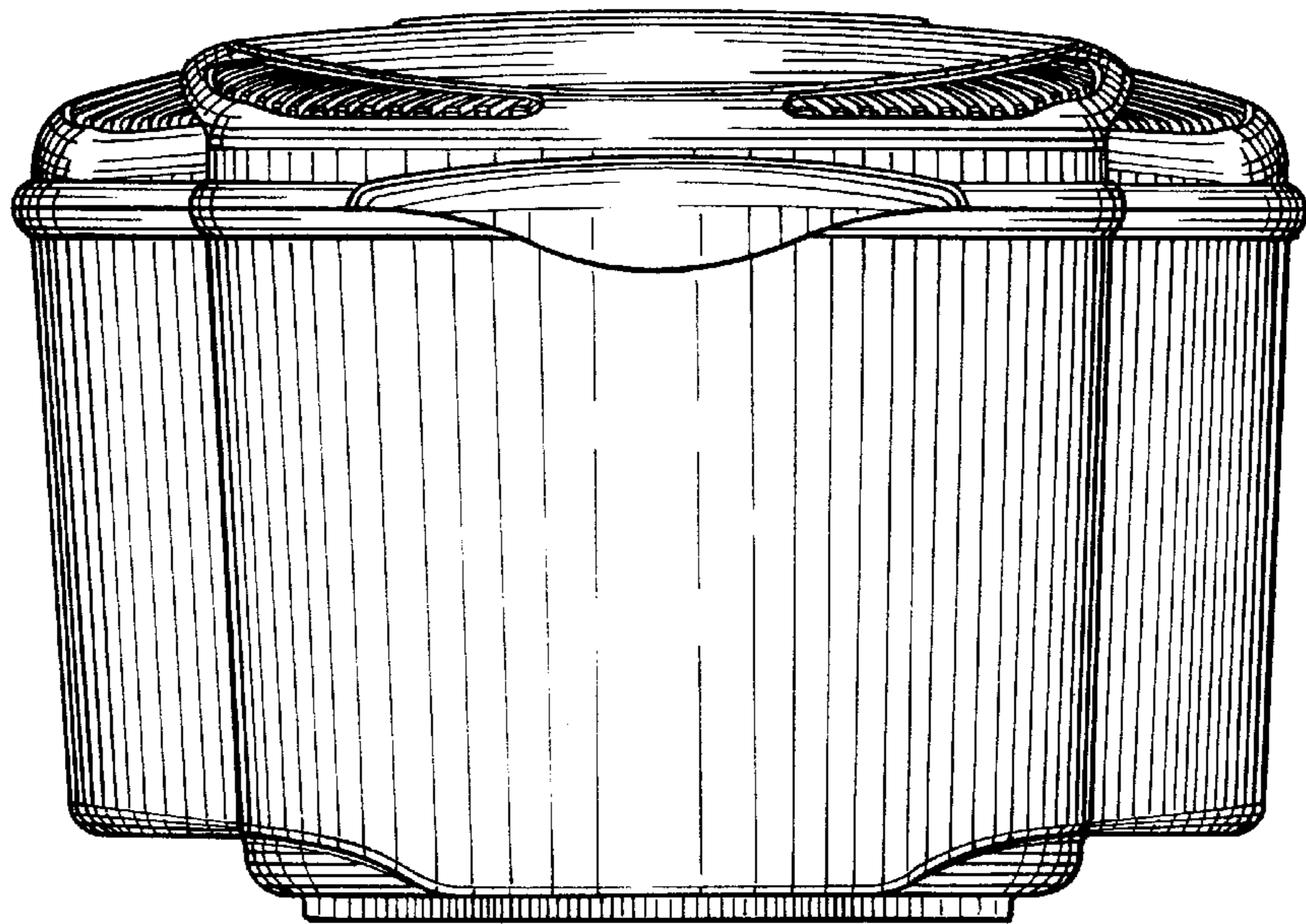

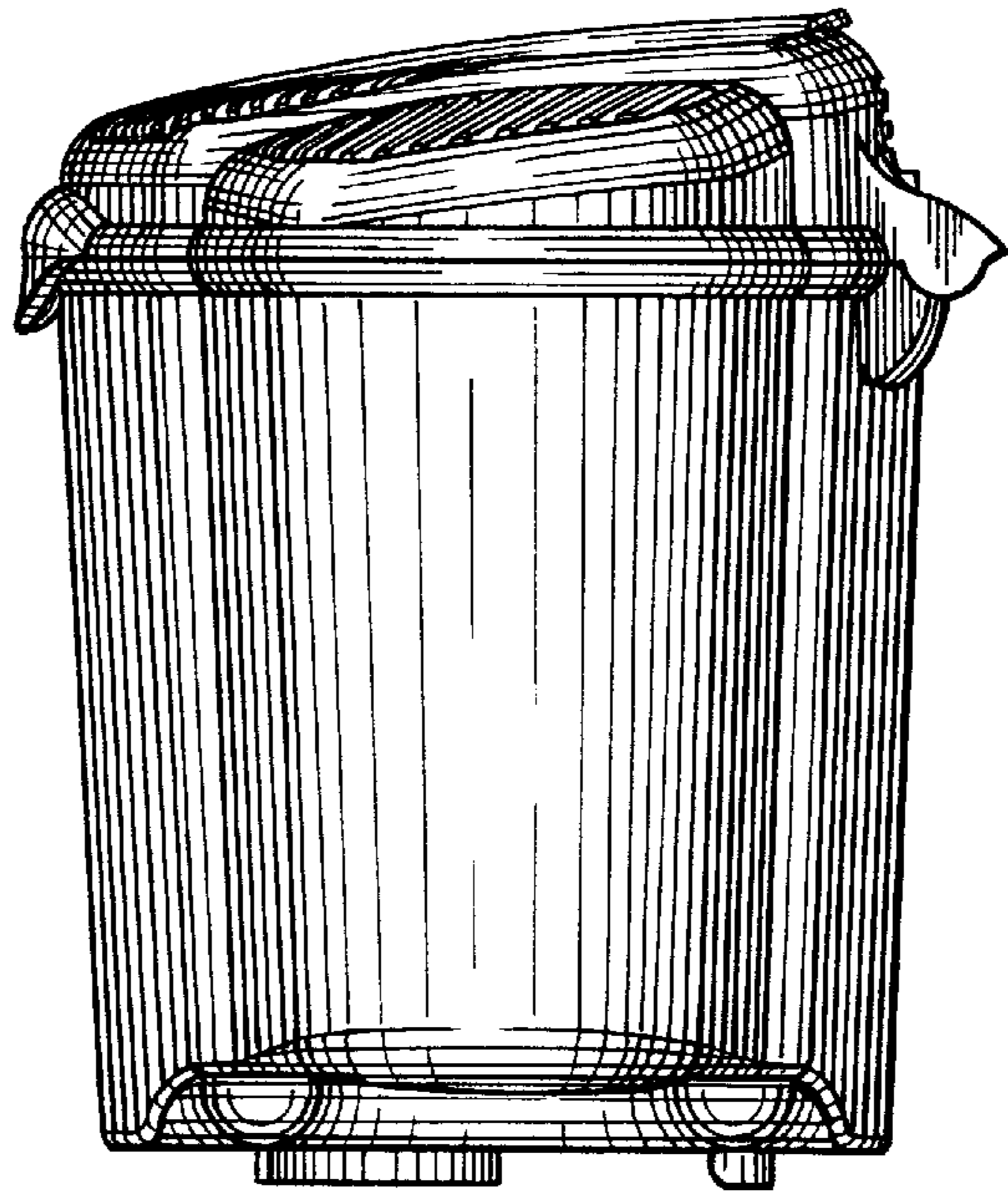

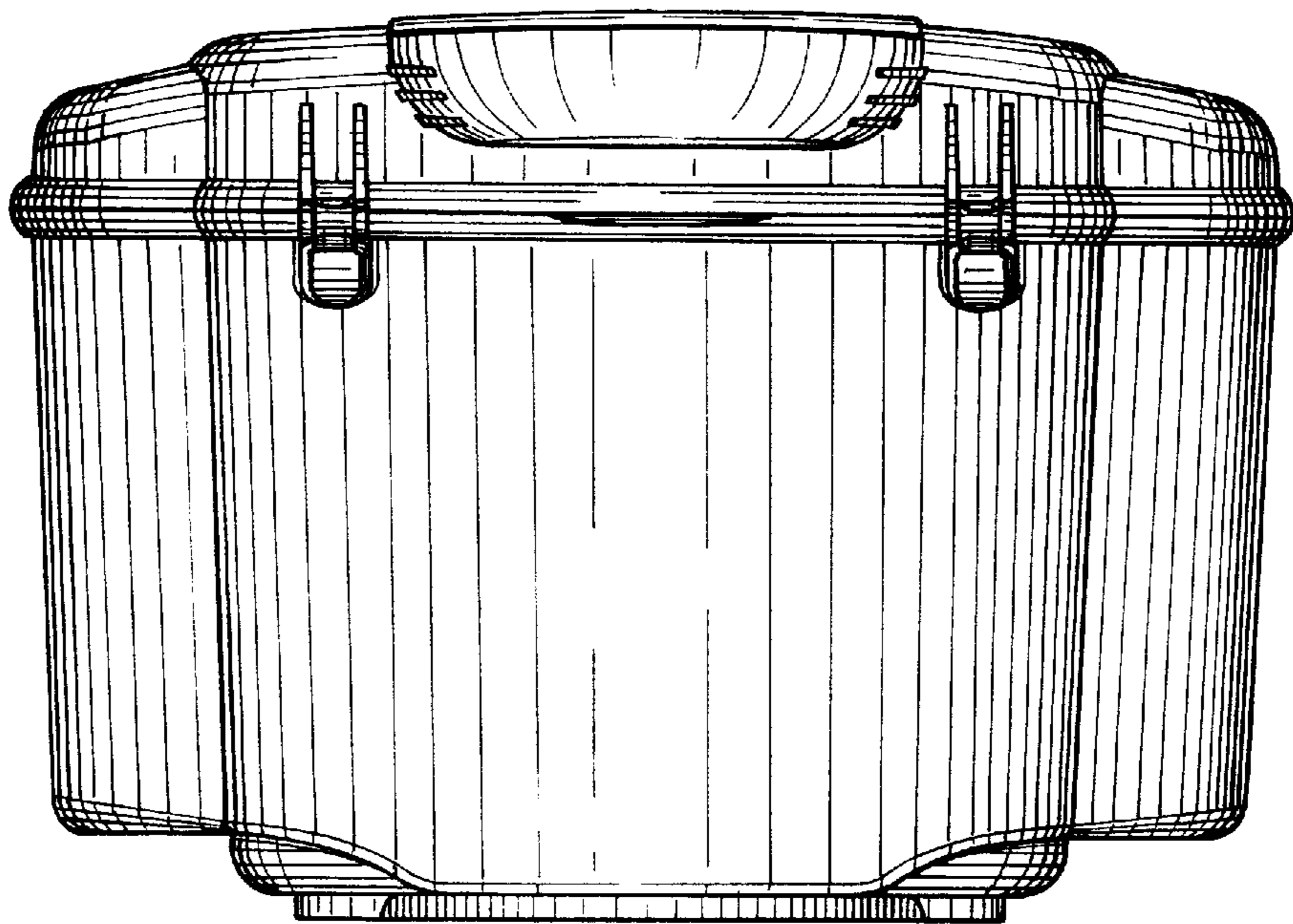

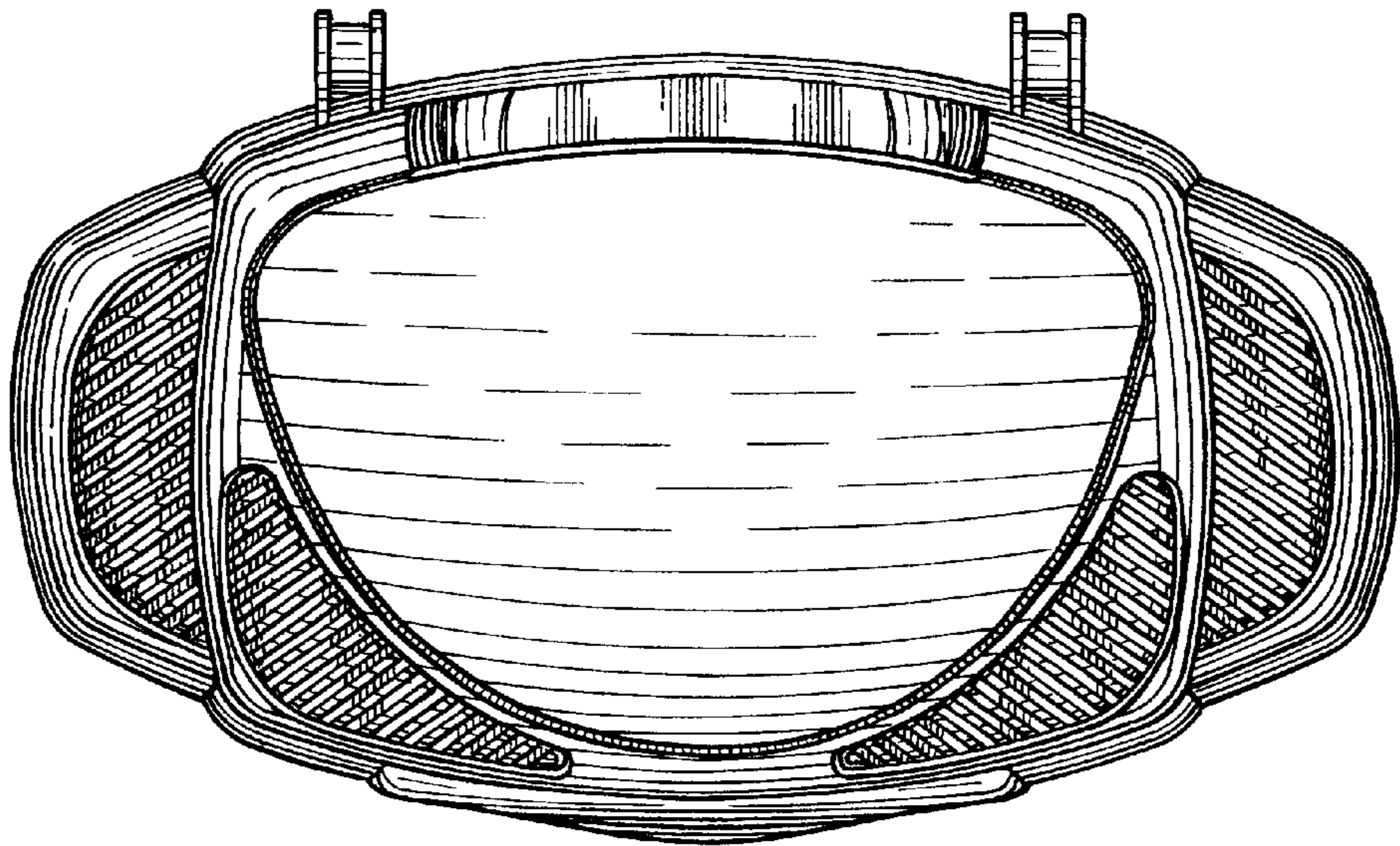

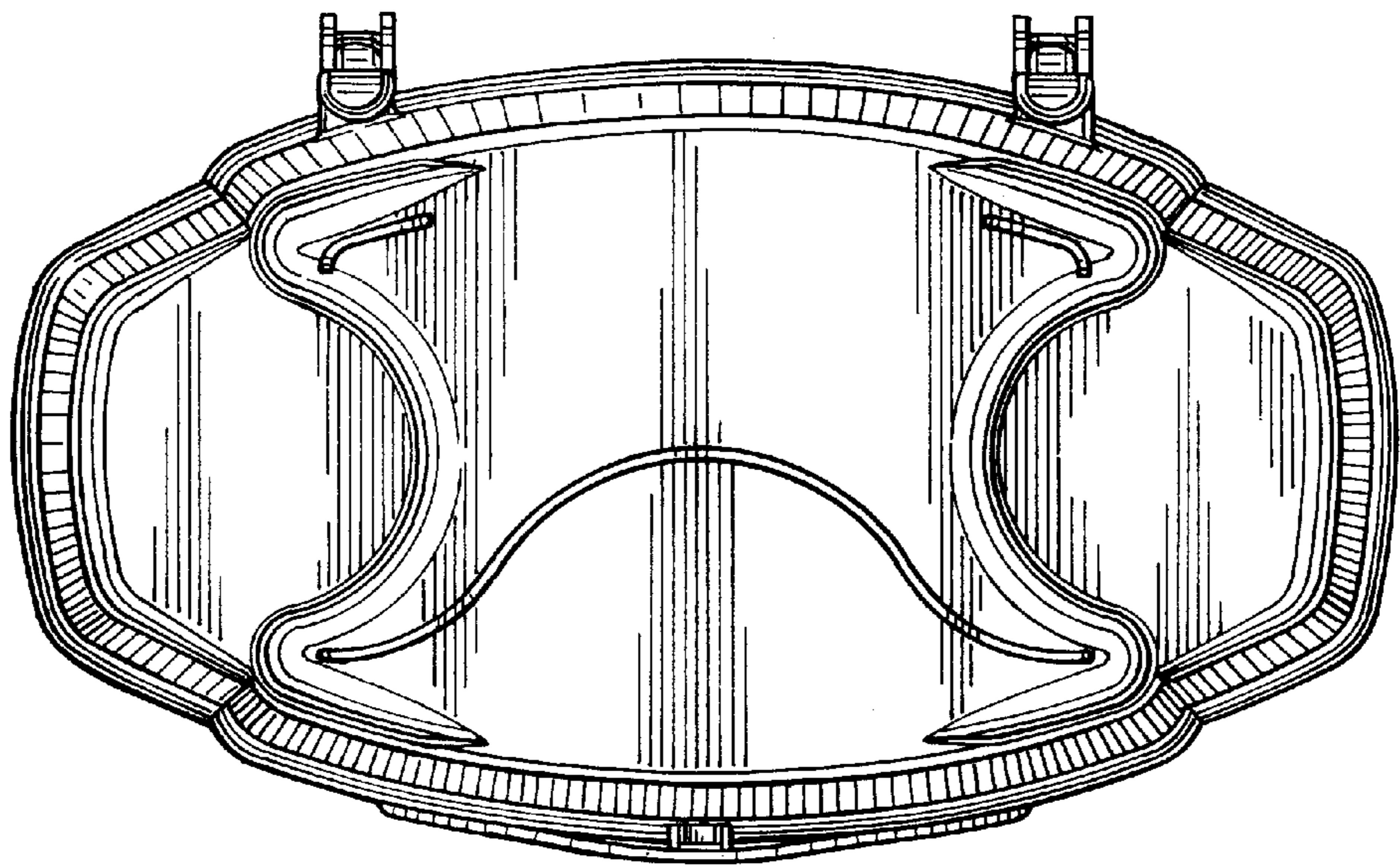

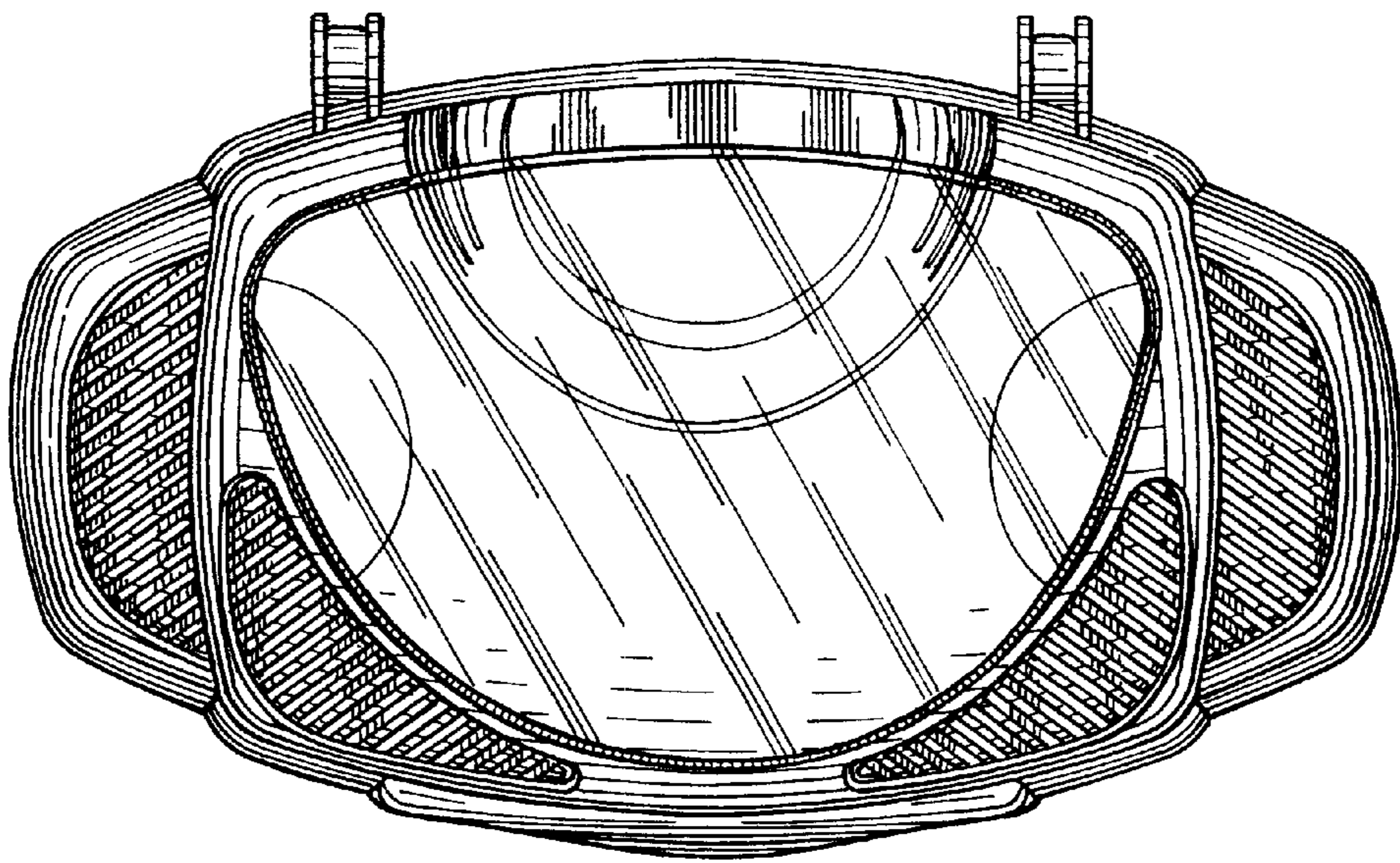
