The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle showing our new design;

FIG. 2 is a top view thereof;

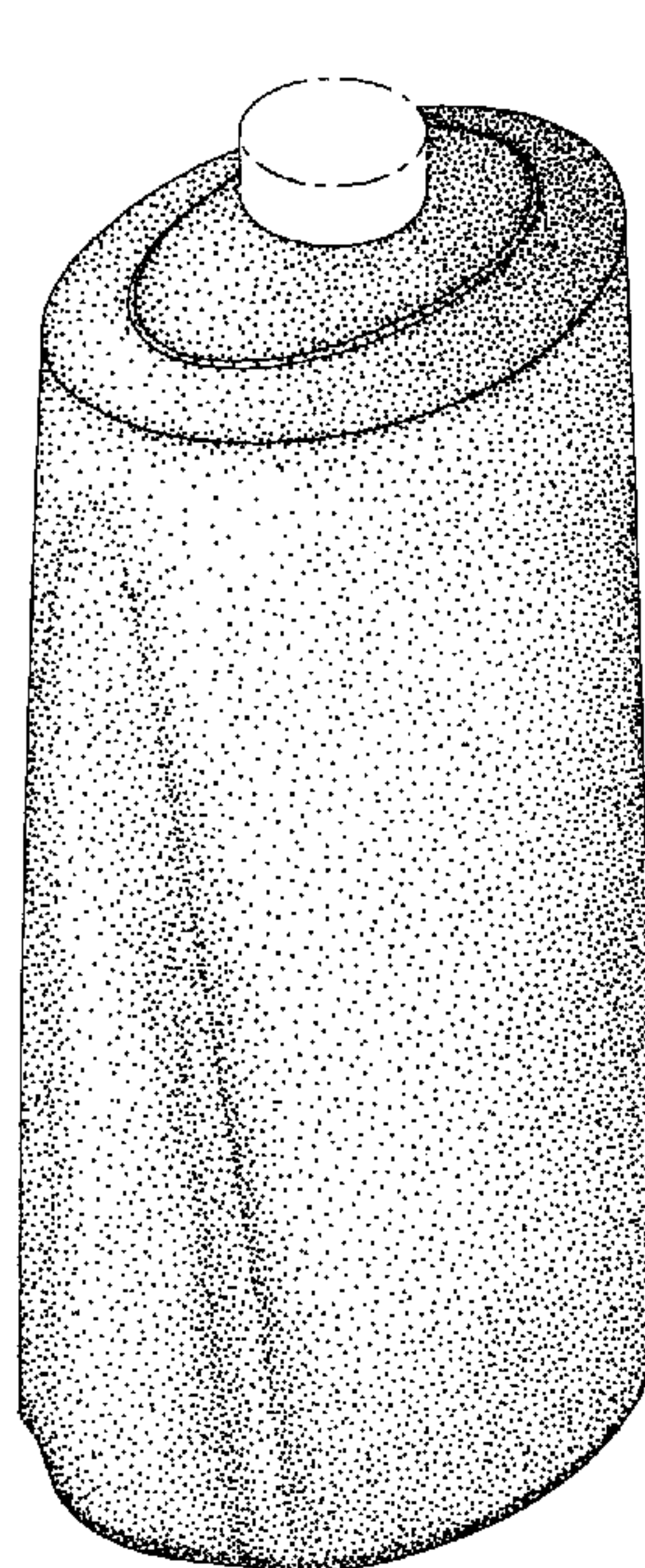
FIG. 3 is a front elevational view thereof; the rear elevational view thereof being identical;

FIG. 4 is a right side elevational view thereof; the left side elevational view thereof being a mirror image; and,

FIG. 5 is a bottom view thereof.

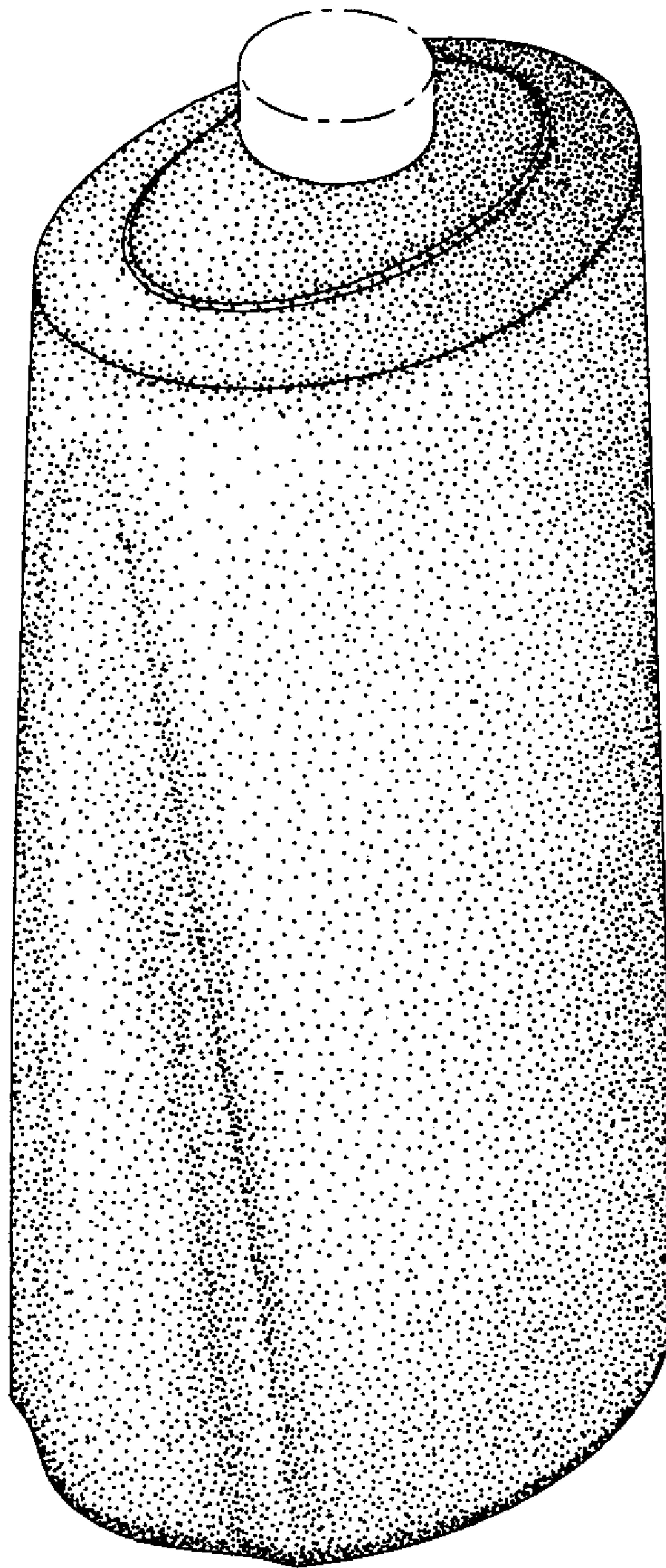

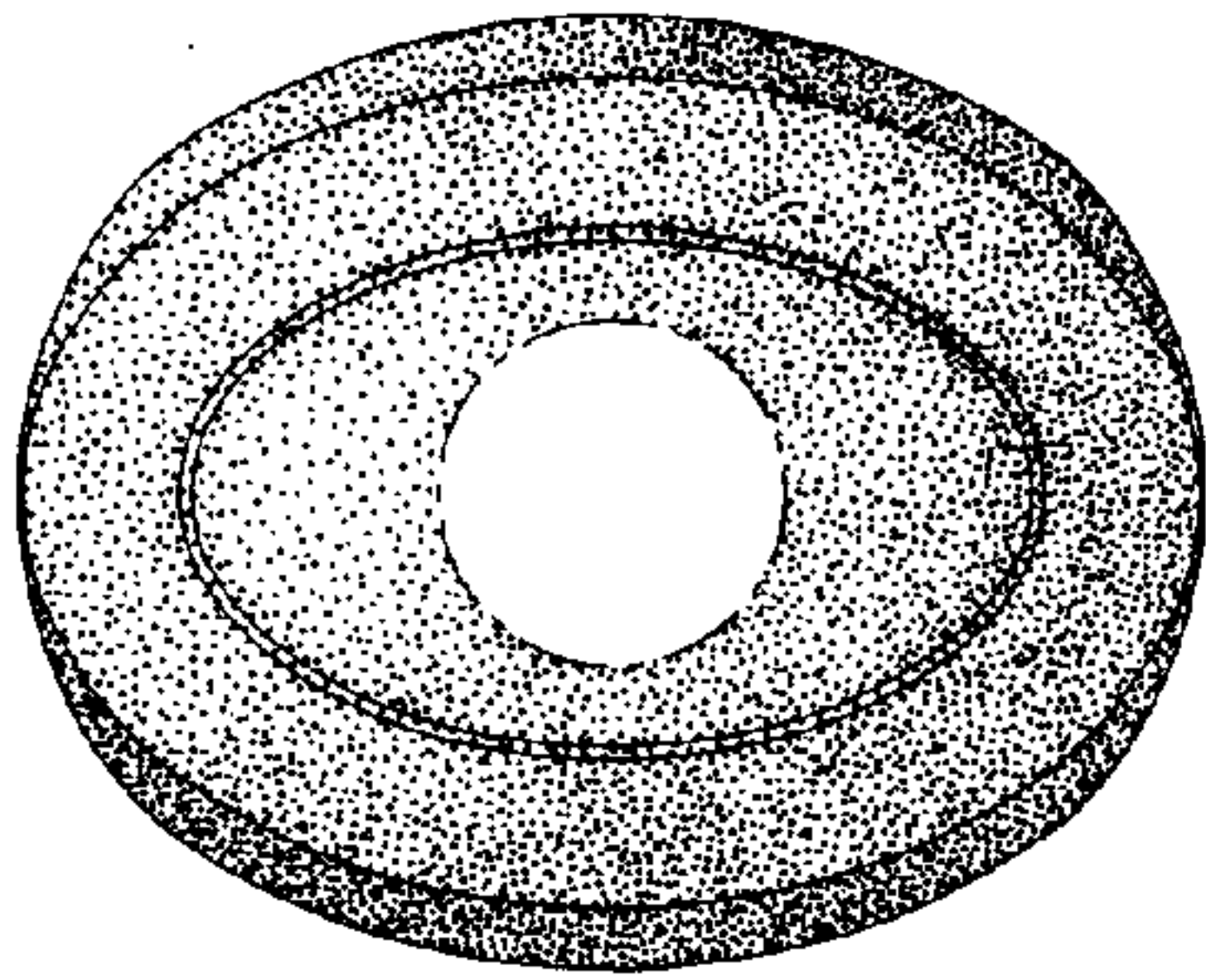

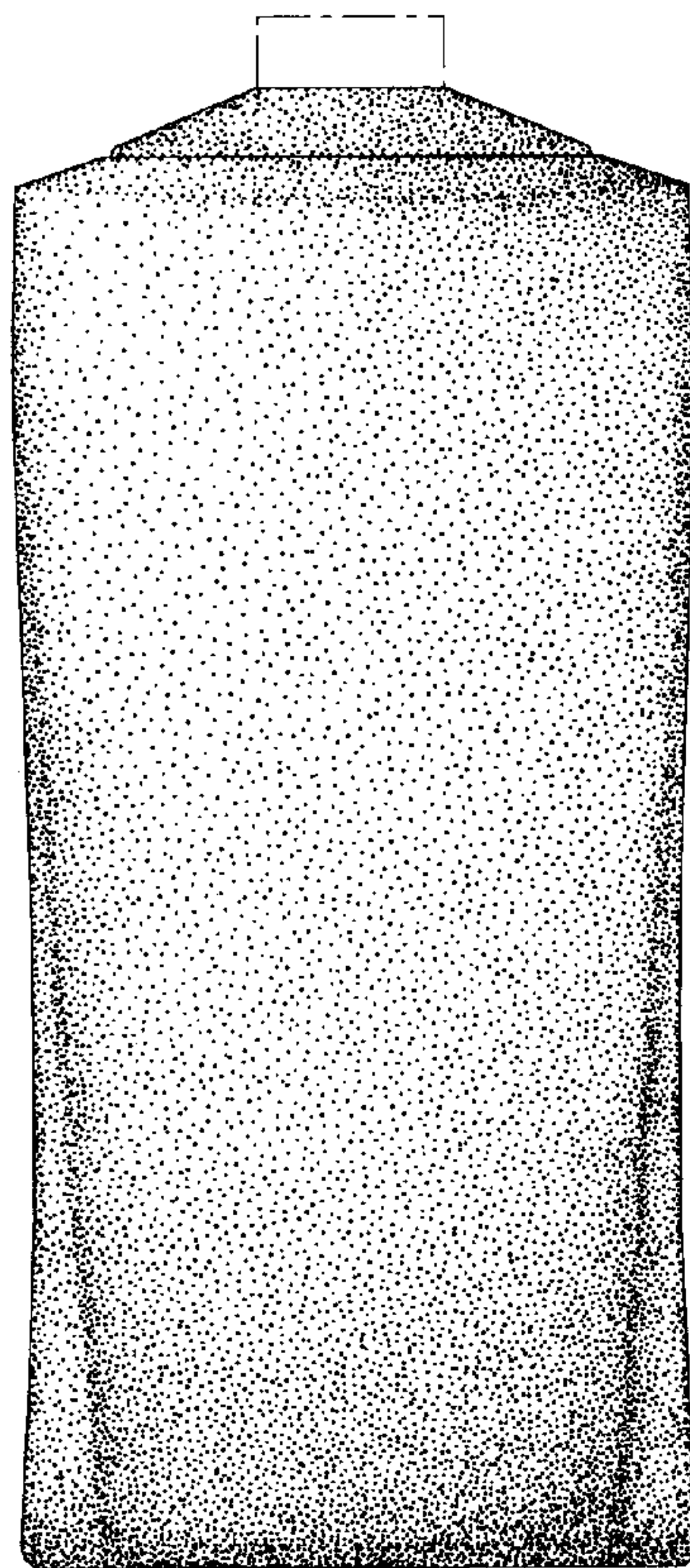

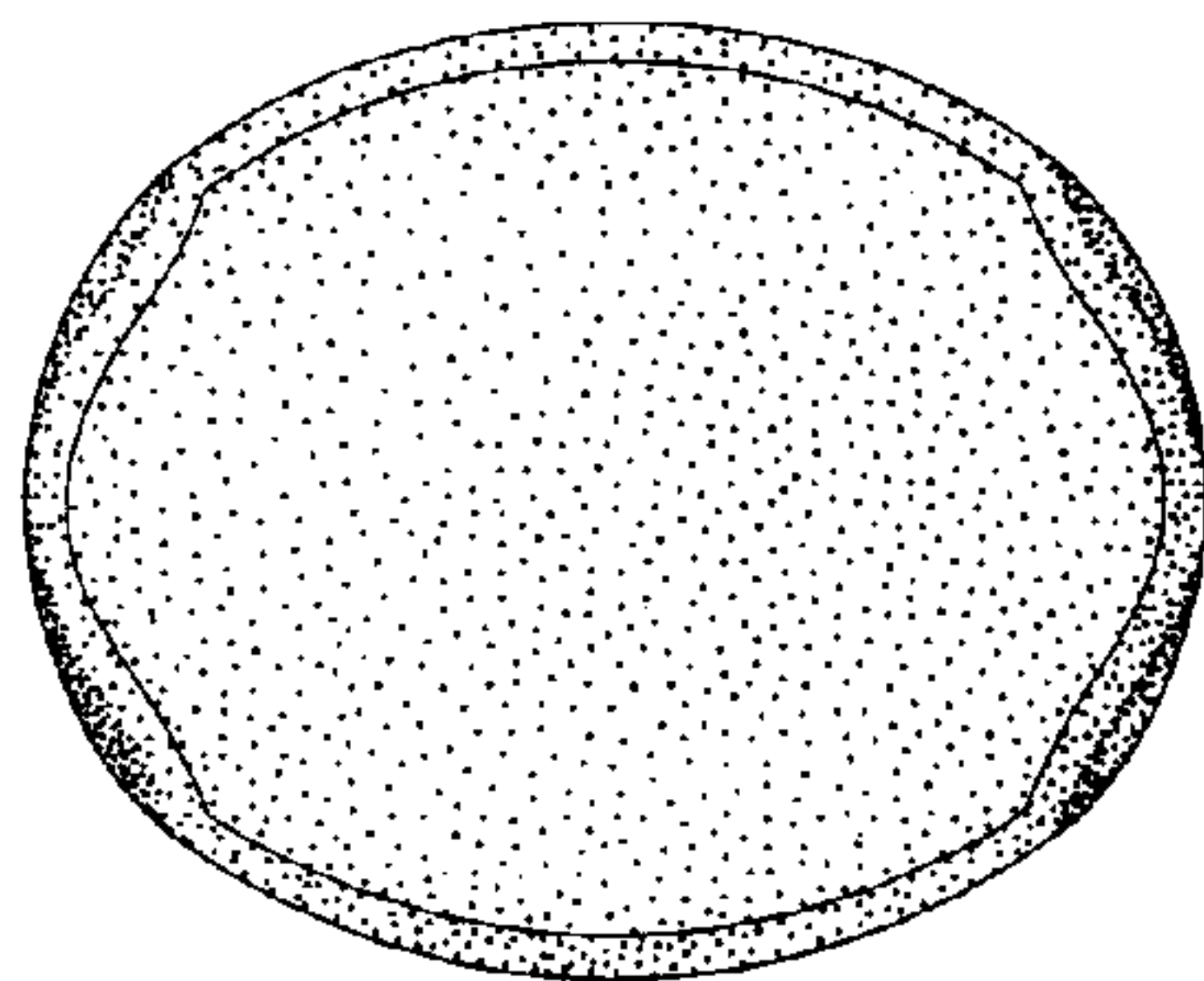
