DESCRIPTION

FIG. 1 is a perspective view of an outboard cowling in
accordance with the present invention.

FIG. 2 is a left side view of the outboard cowling shown in
FIG. 1, the right side view being a mirror image thereof.

FIG. 3 is a rear view of the outboard cowling shown in FIG.
1.

FIG. 4 is a front view of the outboard cowling shown in FIG.

FIG. 5 is a top view of the outboard cowling shown in FIG.

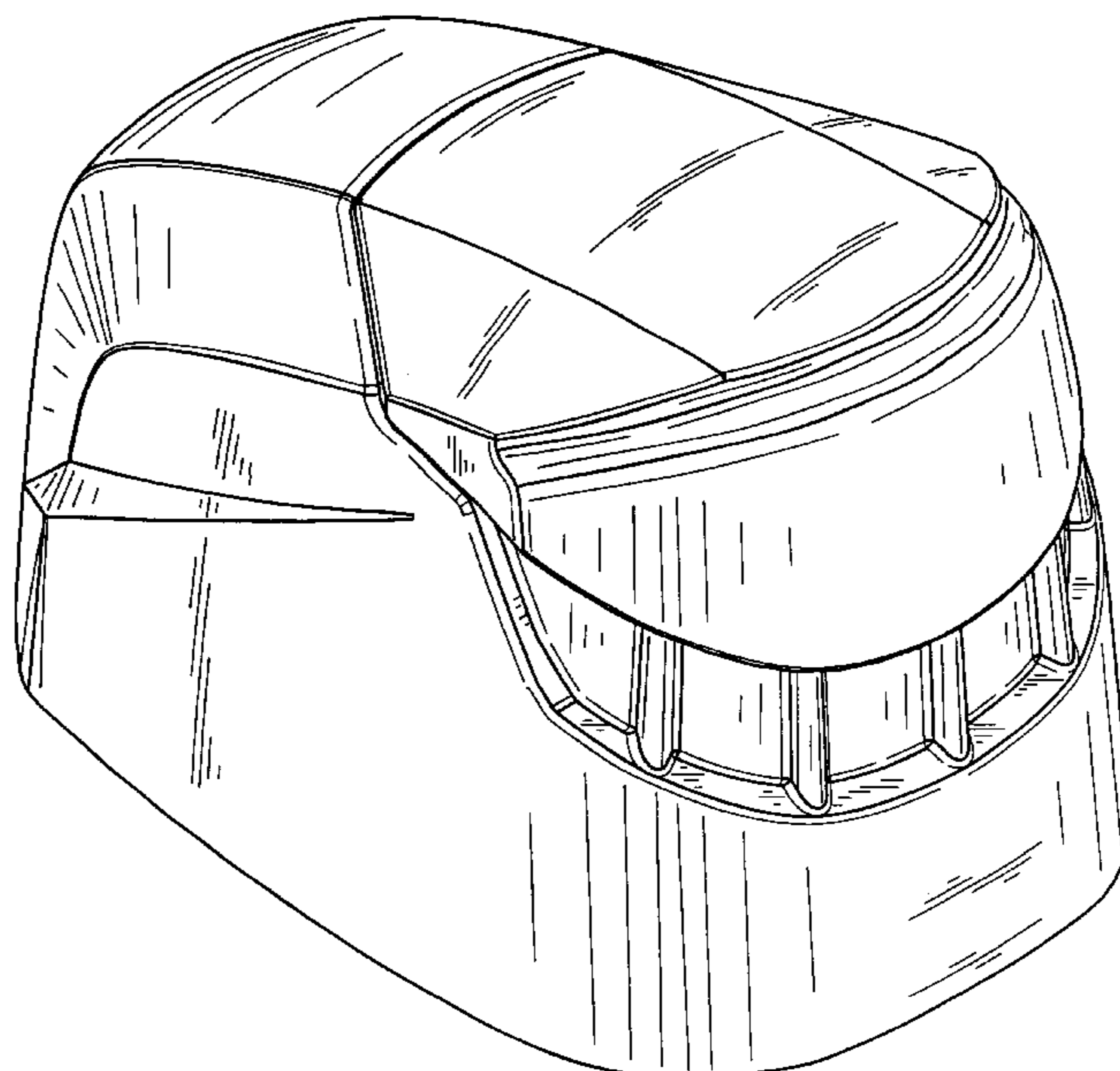

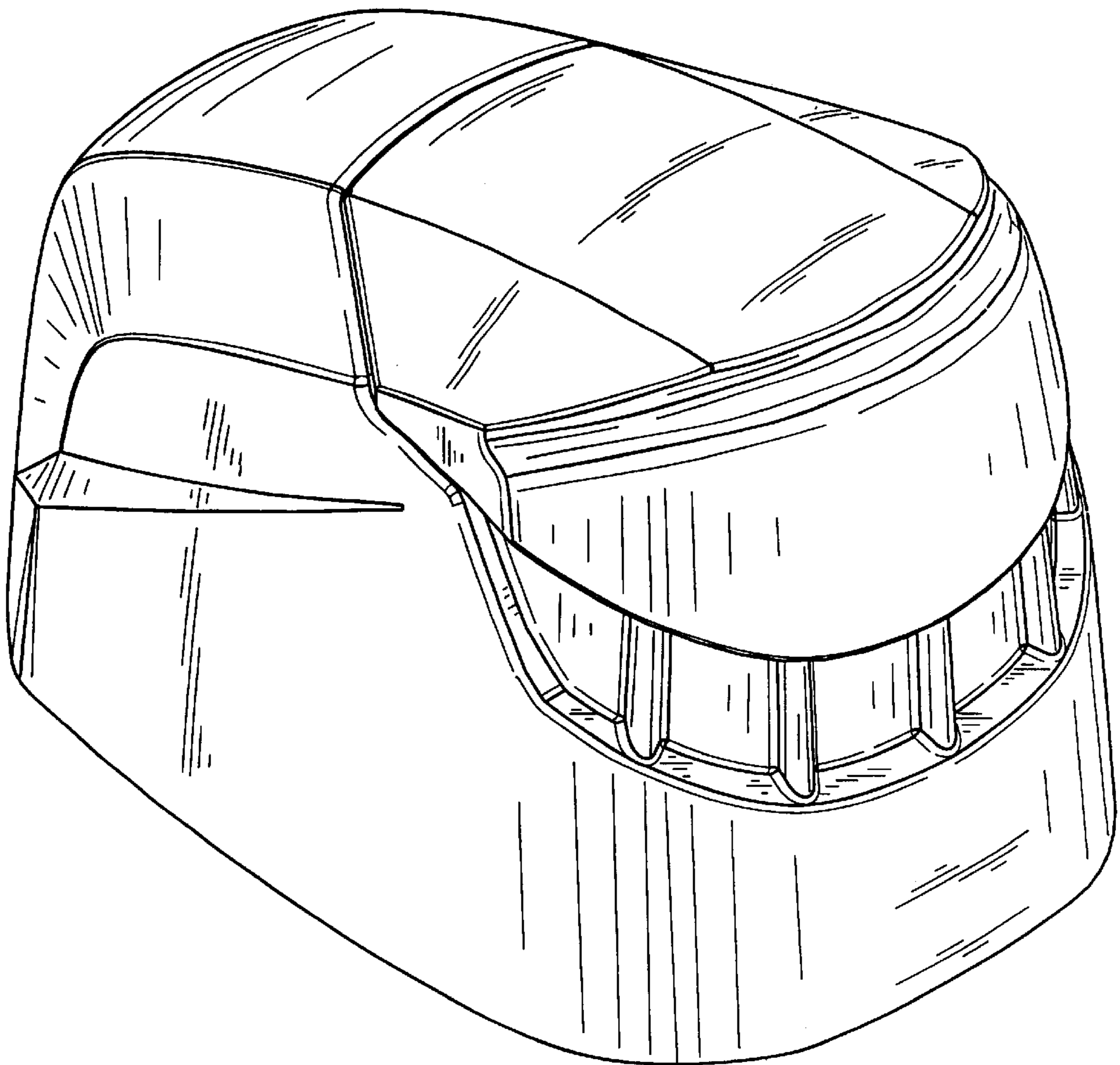

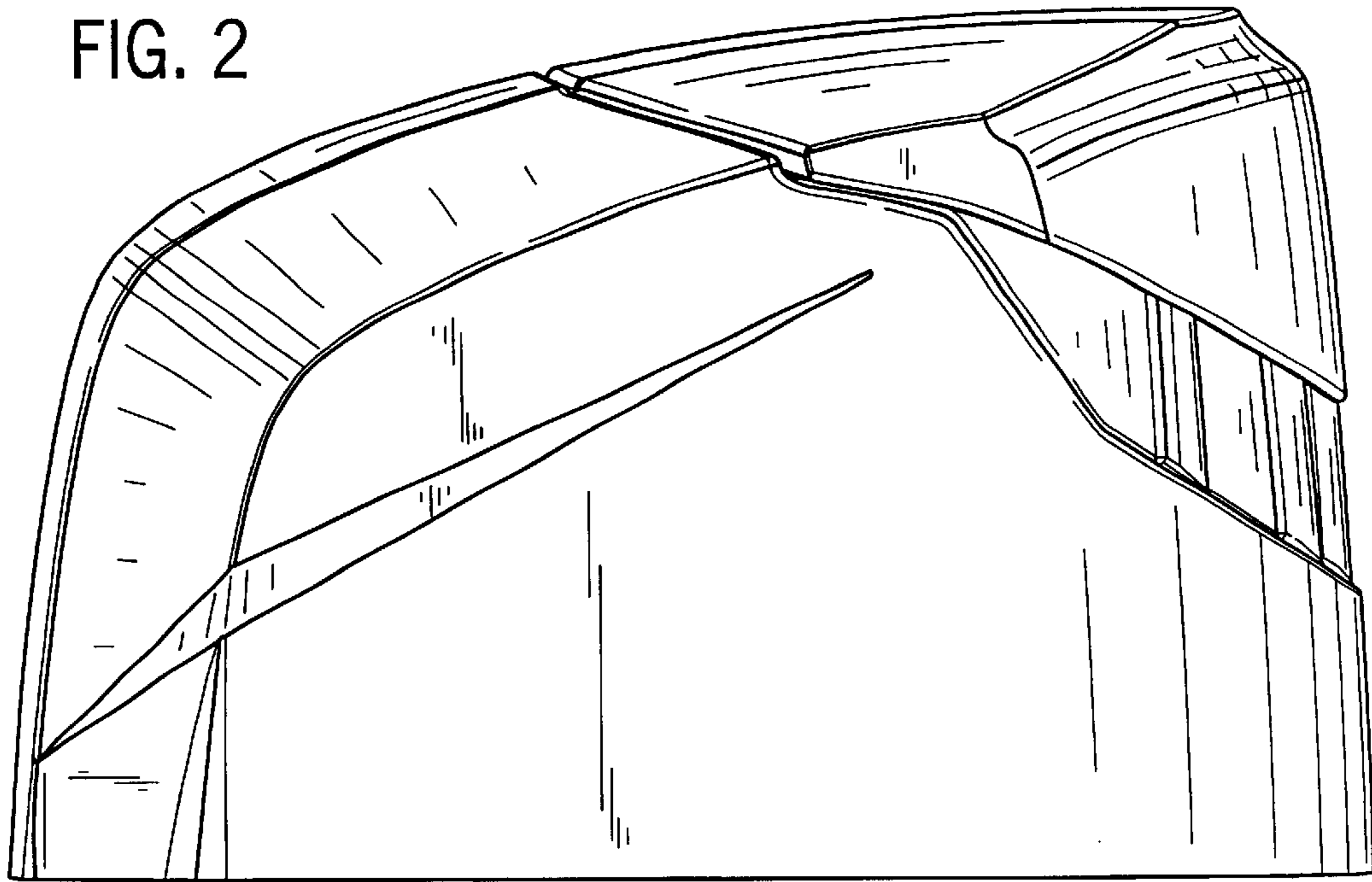

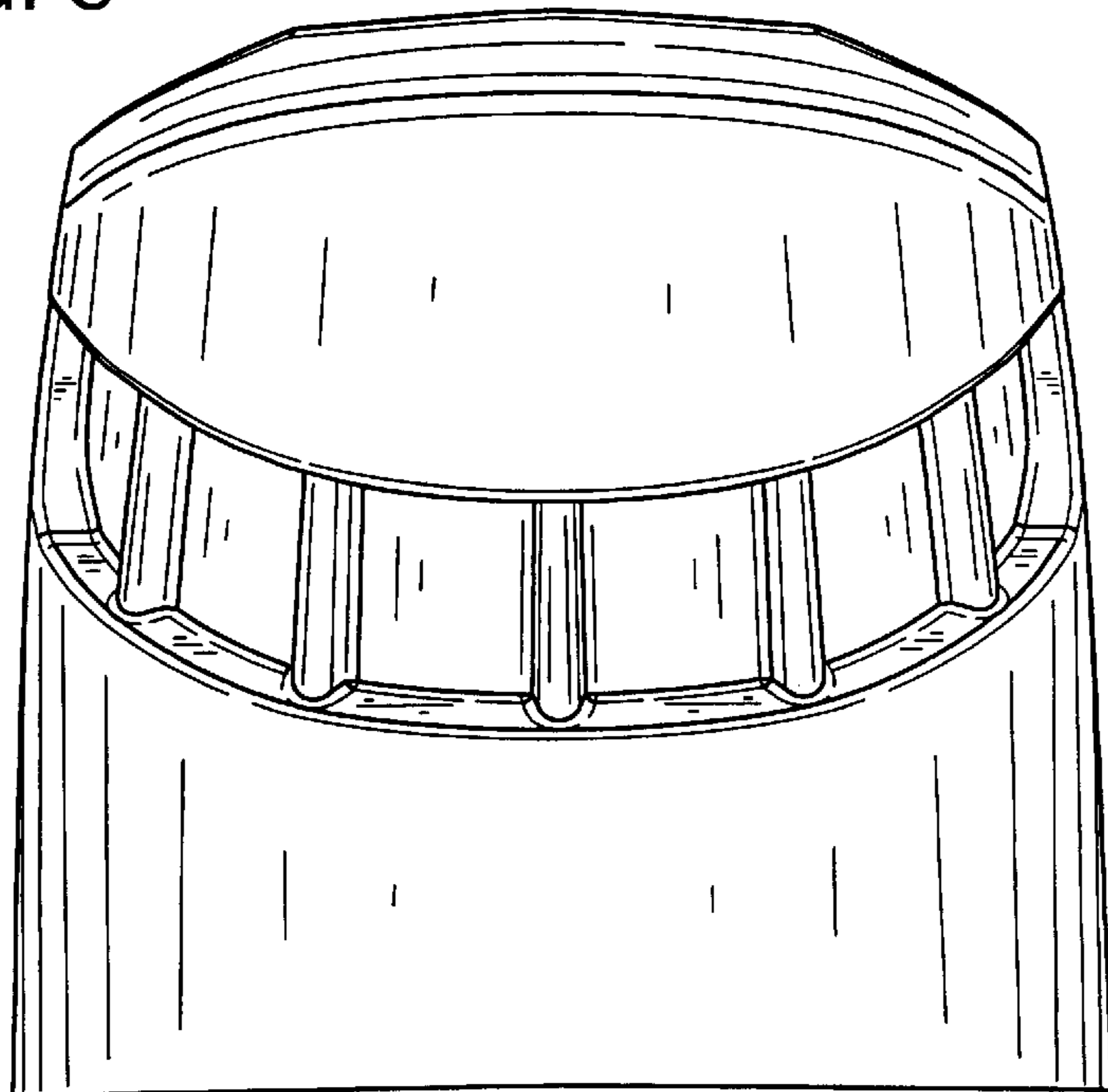

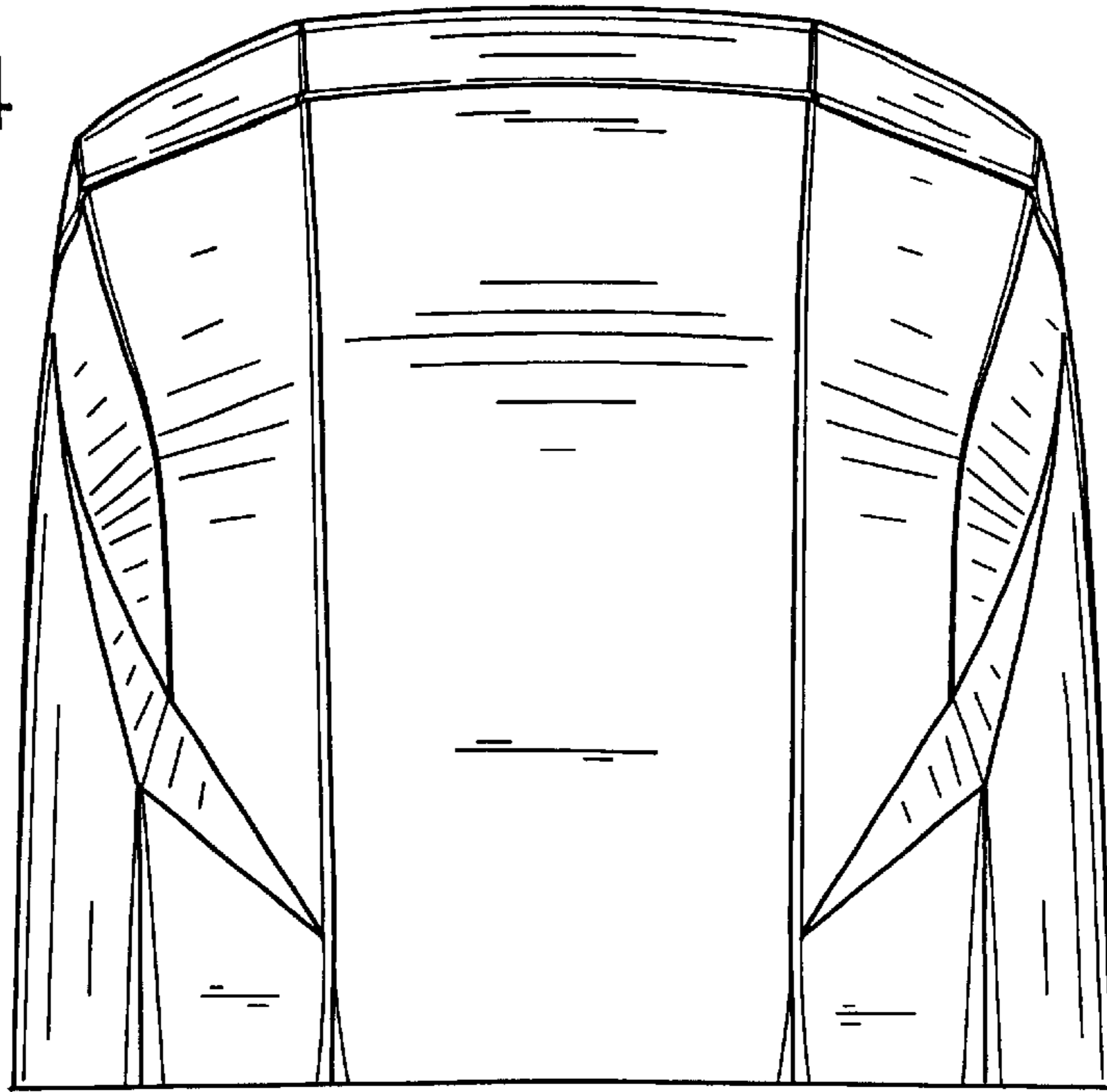
