(57) **CLAIM**

The ornamental design for a laser printable card badge sheet, as shown.

DESCRIPTION

FIG. 1 is a front elevational view of my new design of a laser printable card badge sheet;

FIG. 2 is a right side view of the laser printable card badge sheet shown in FIG. 1, the left side view being identical thereto;

FIG. 3 is an front end view of the laser printable card badge sheet shown in FIG. 1, the other end view being identical thereto; and,

FIG. 4 is an rear elevational view of the laser printable card badge sheet shown in FIG. 1.

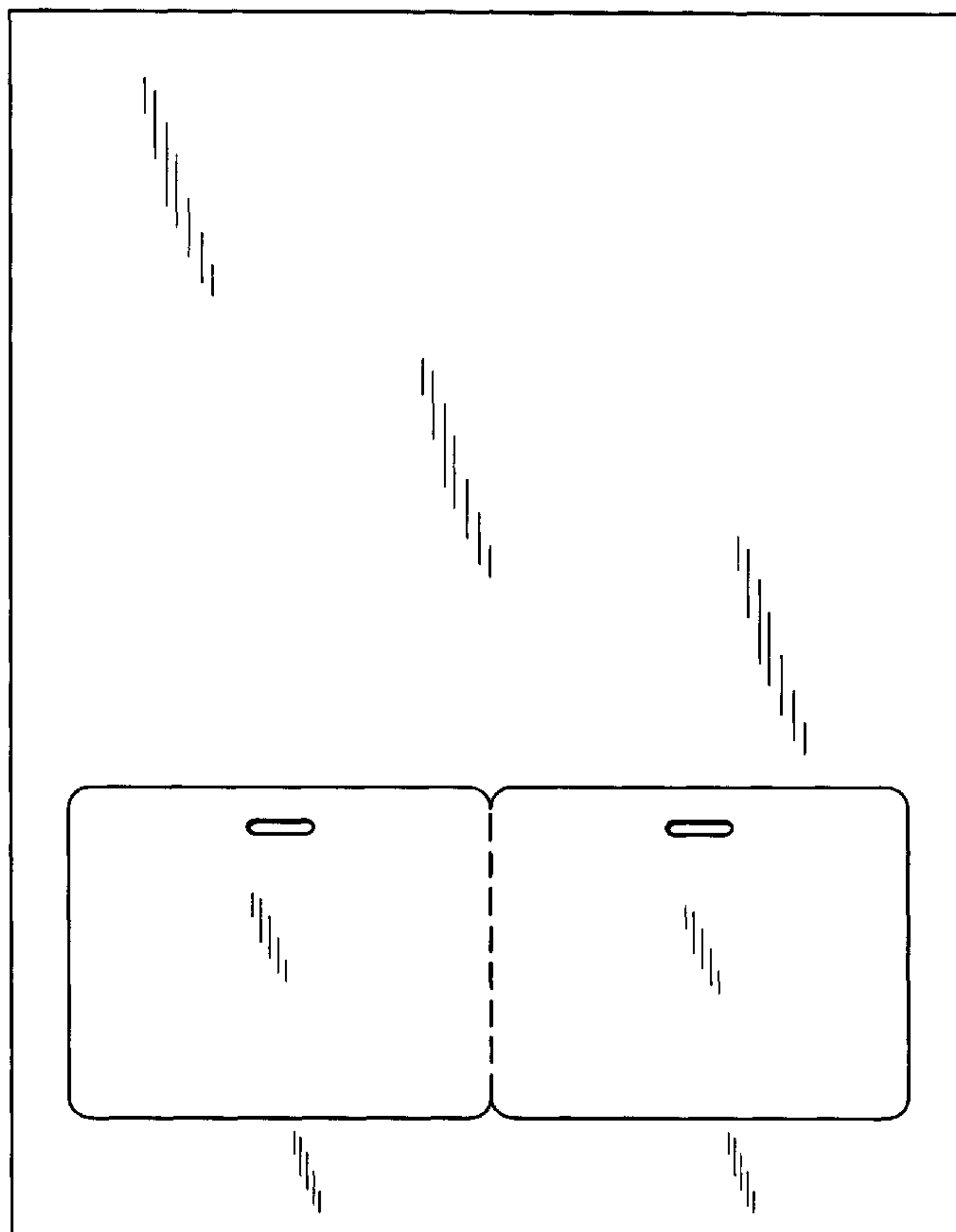

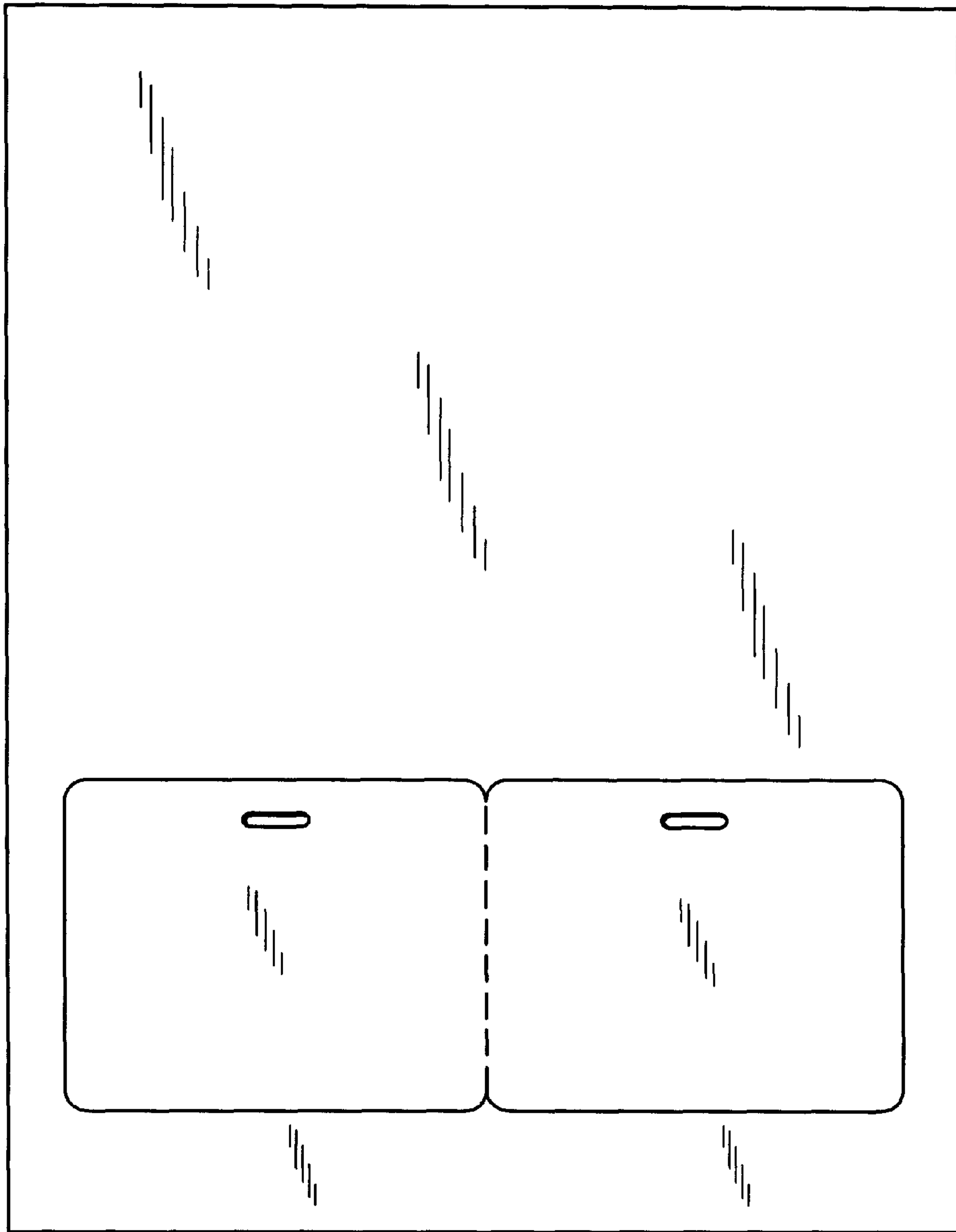
