FIG. 7 is a top plan view thereof; and,

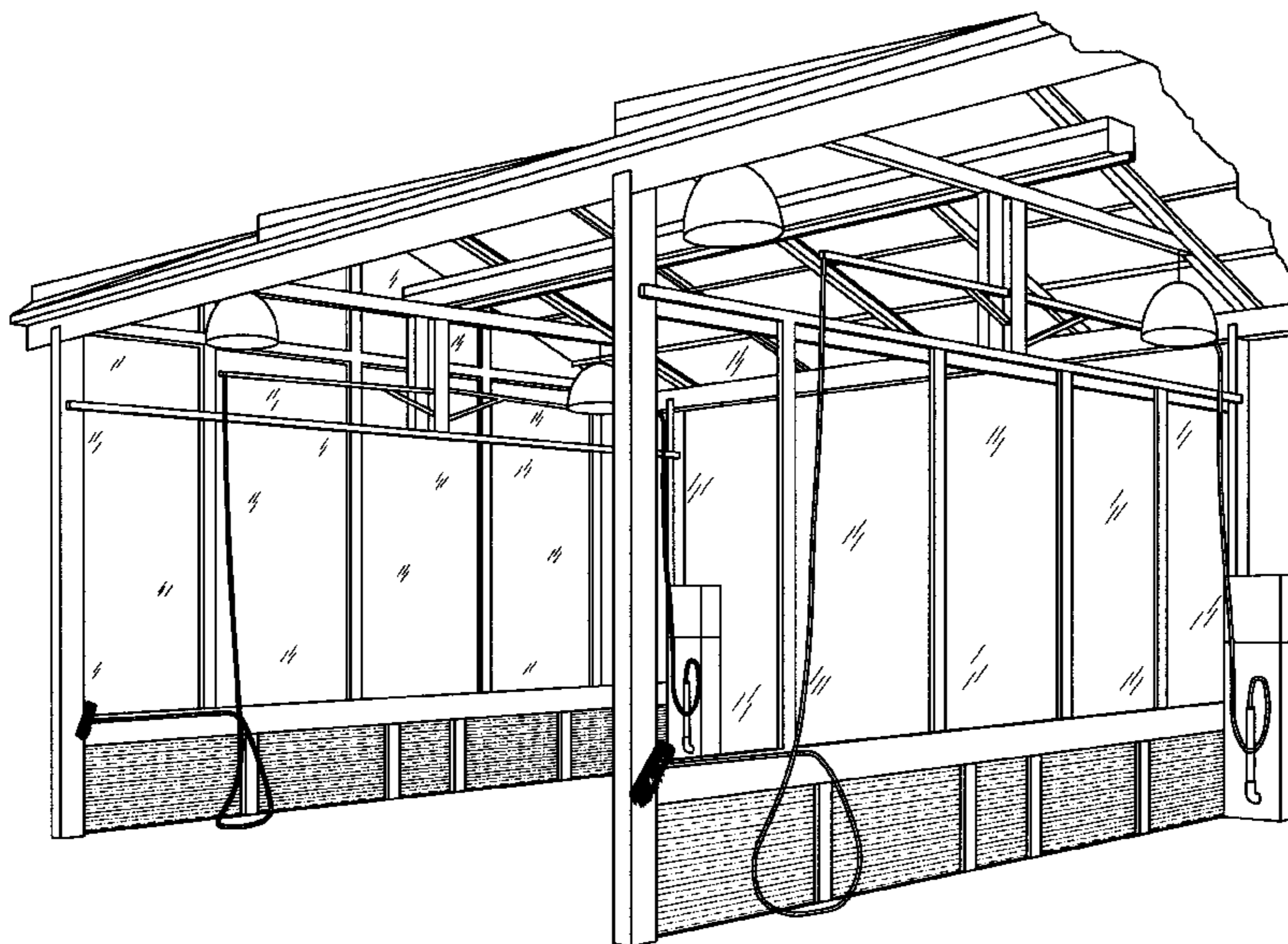
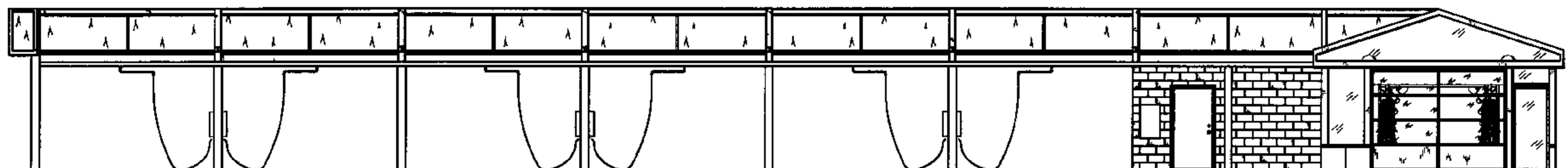
FIG. 8 is an enlarged partial left side perspective view thereof.

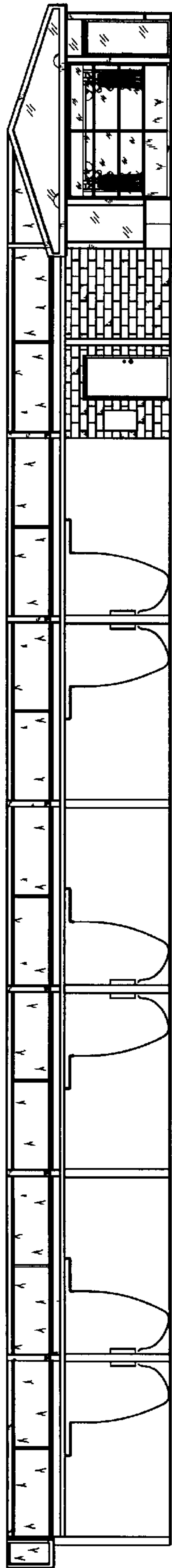

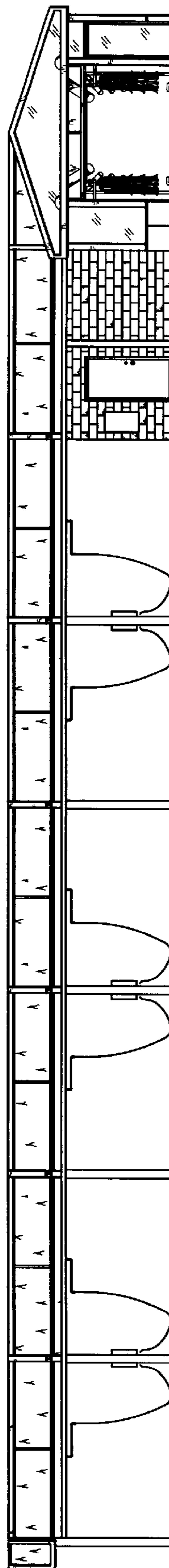

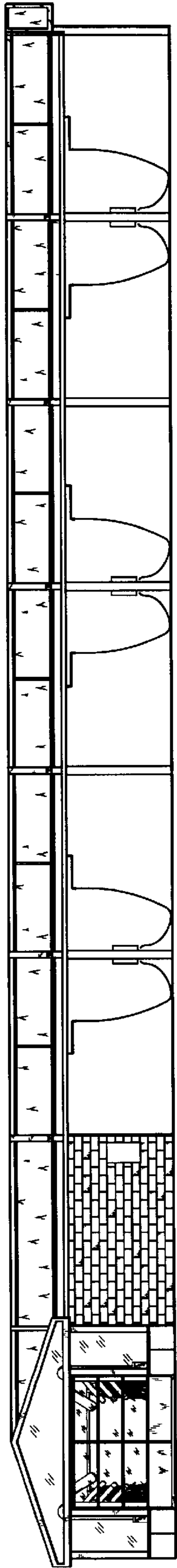

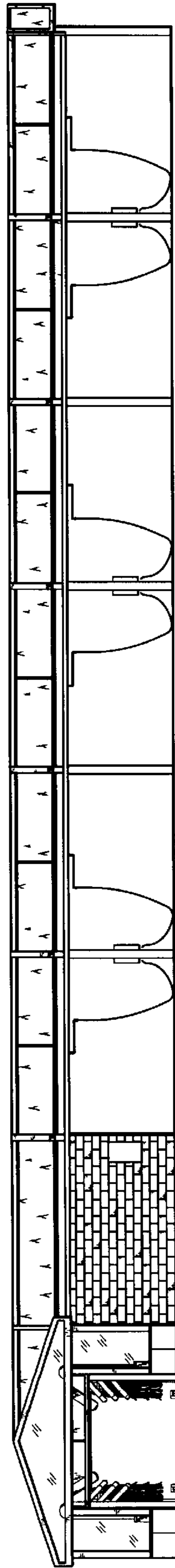

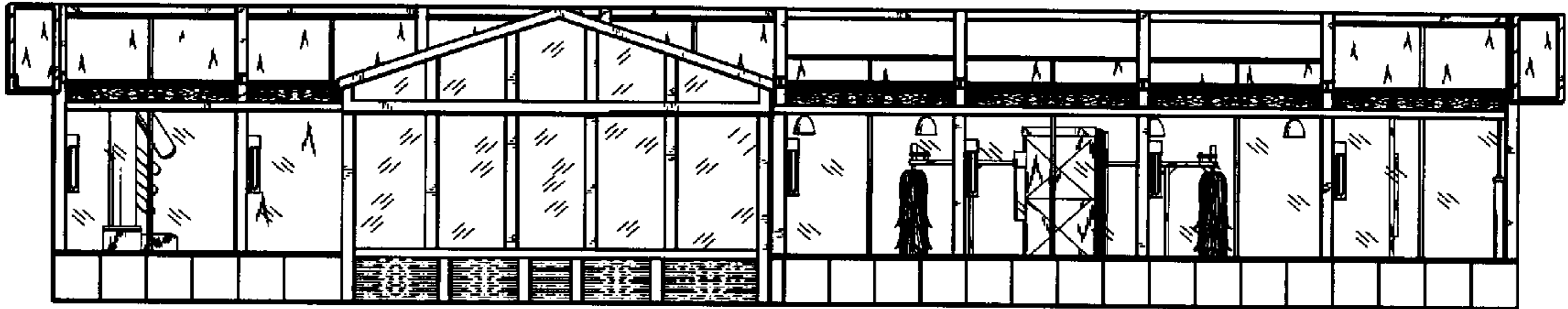

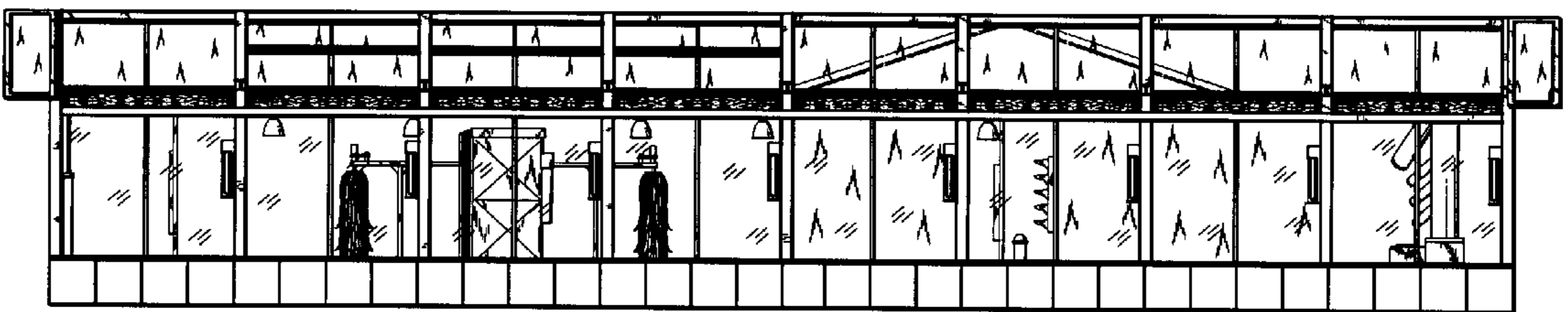

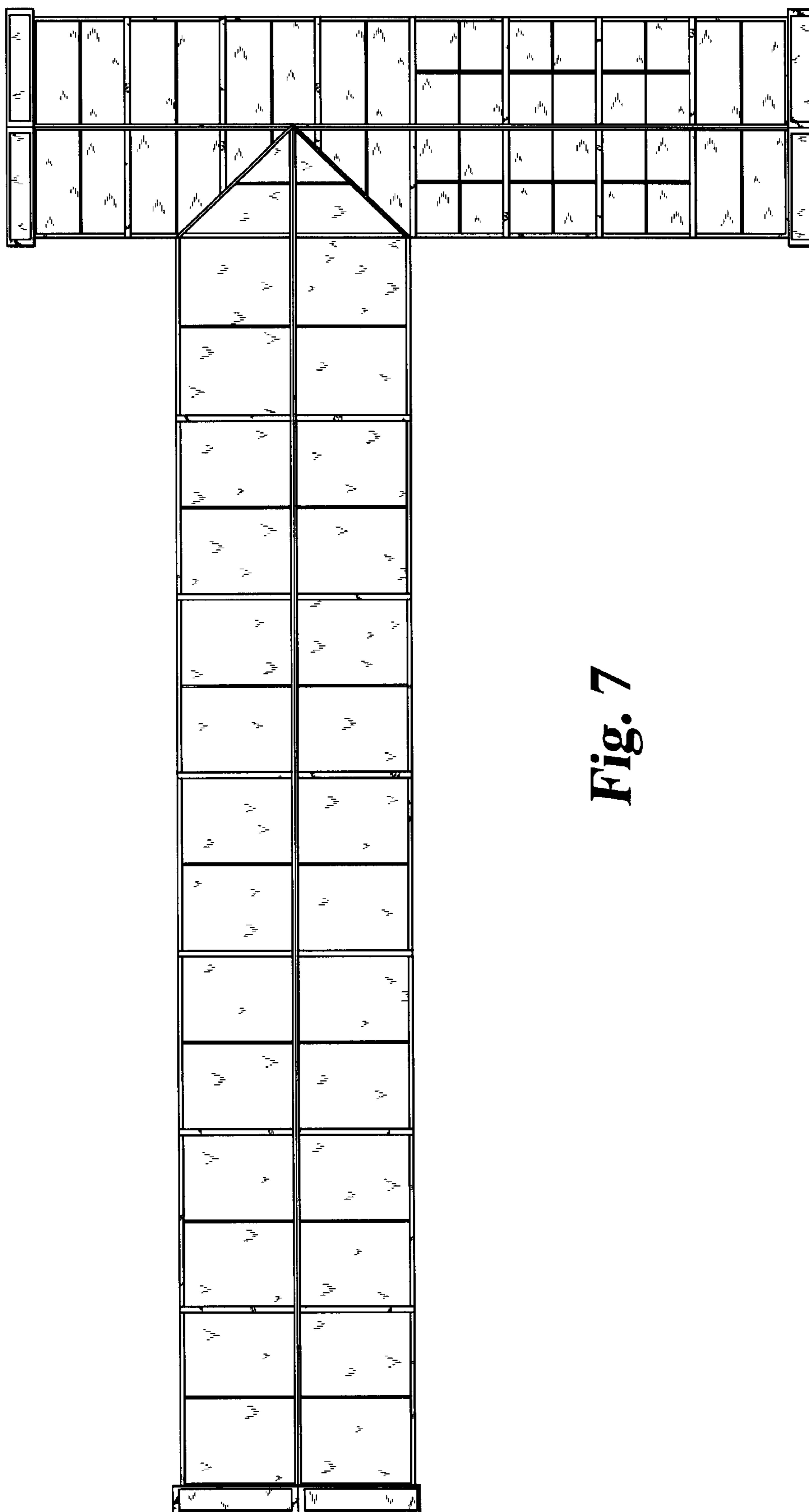

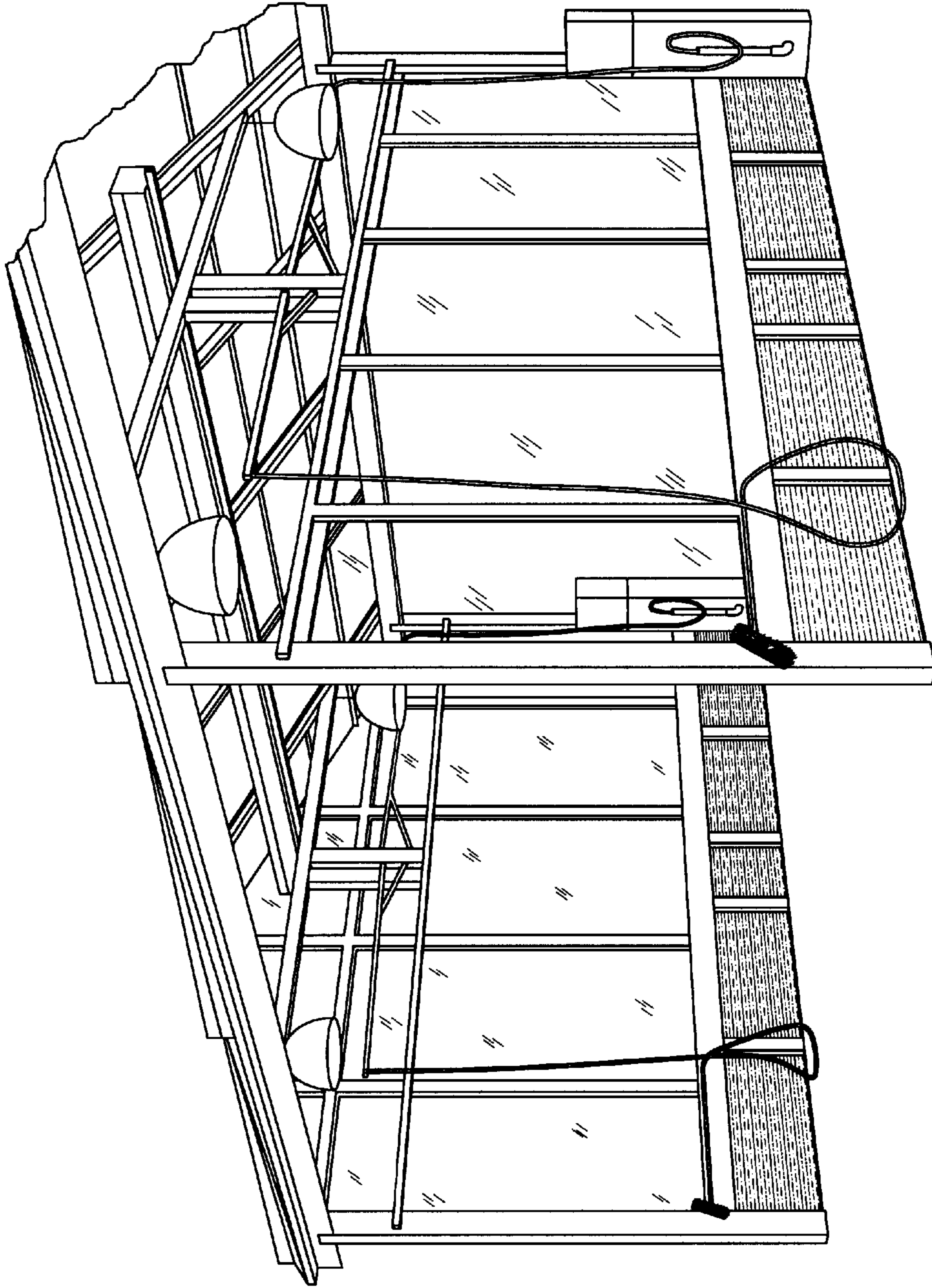
