(57) **CLAIM**

The ornamental design for a storage device for unattended, package pick up and delivery, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a storage device for unattended, package pick up and delivery, according to the design;

FIG. 2 is a left rear, perspective view of the storage device for unattended, package pick up and delivery of FIG. 1;

FIG. 3 is a top view of the storage device for unattended, package pick up and delivery of FIG. 1;

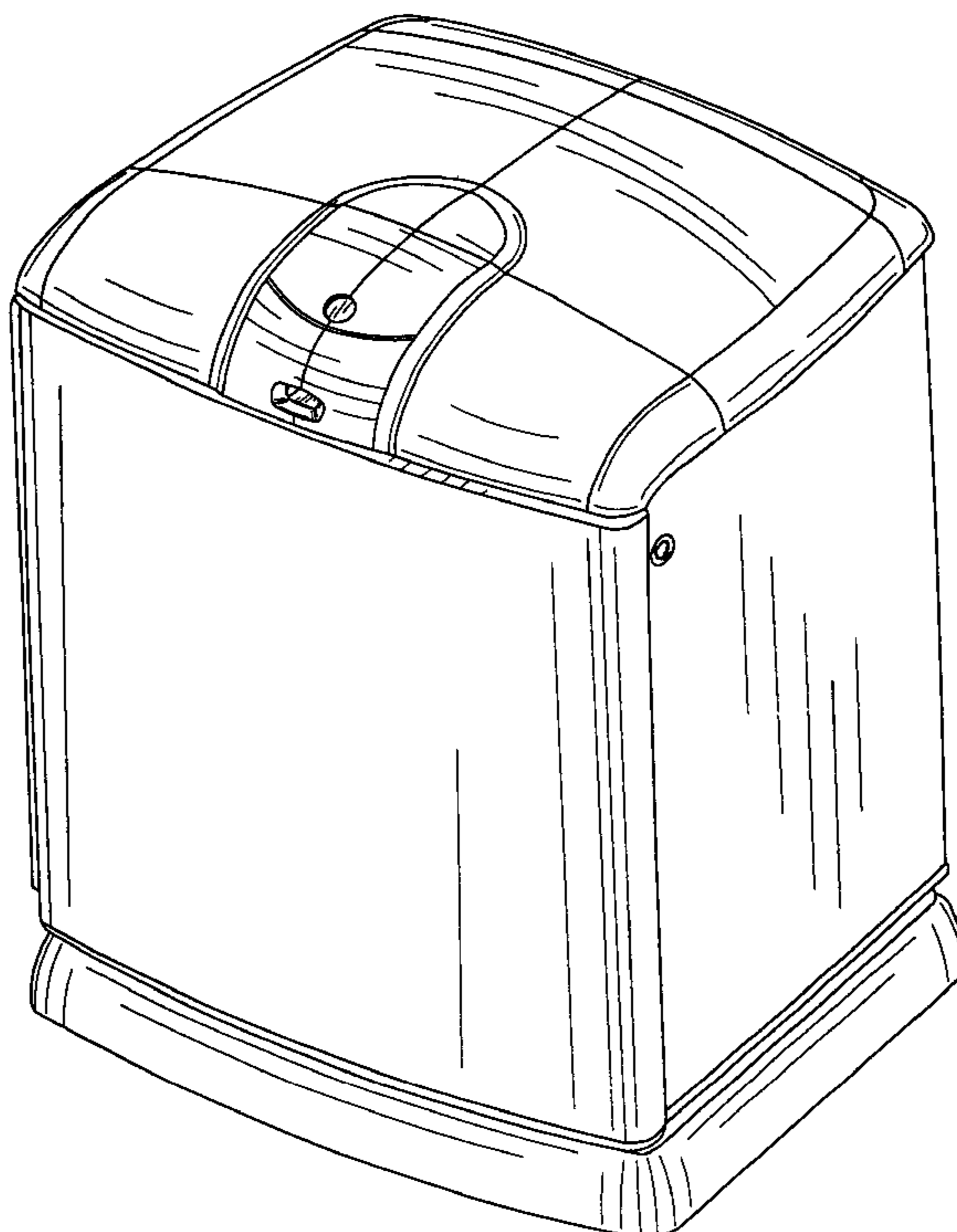
FIG. 4 is a front view of the storage device for unattended, package pick up and delivery of FIG. 1;

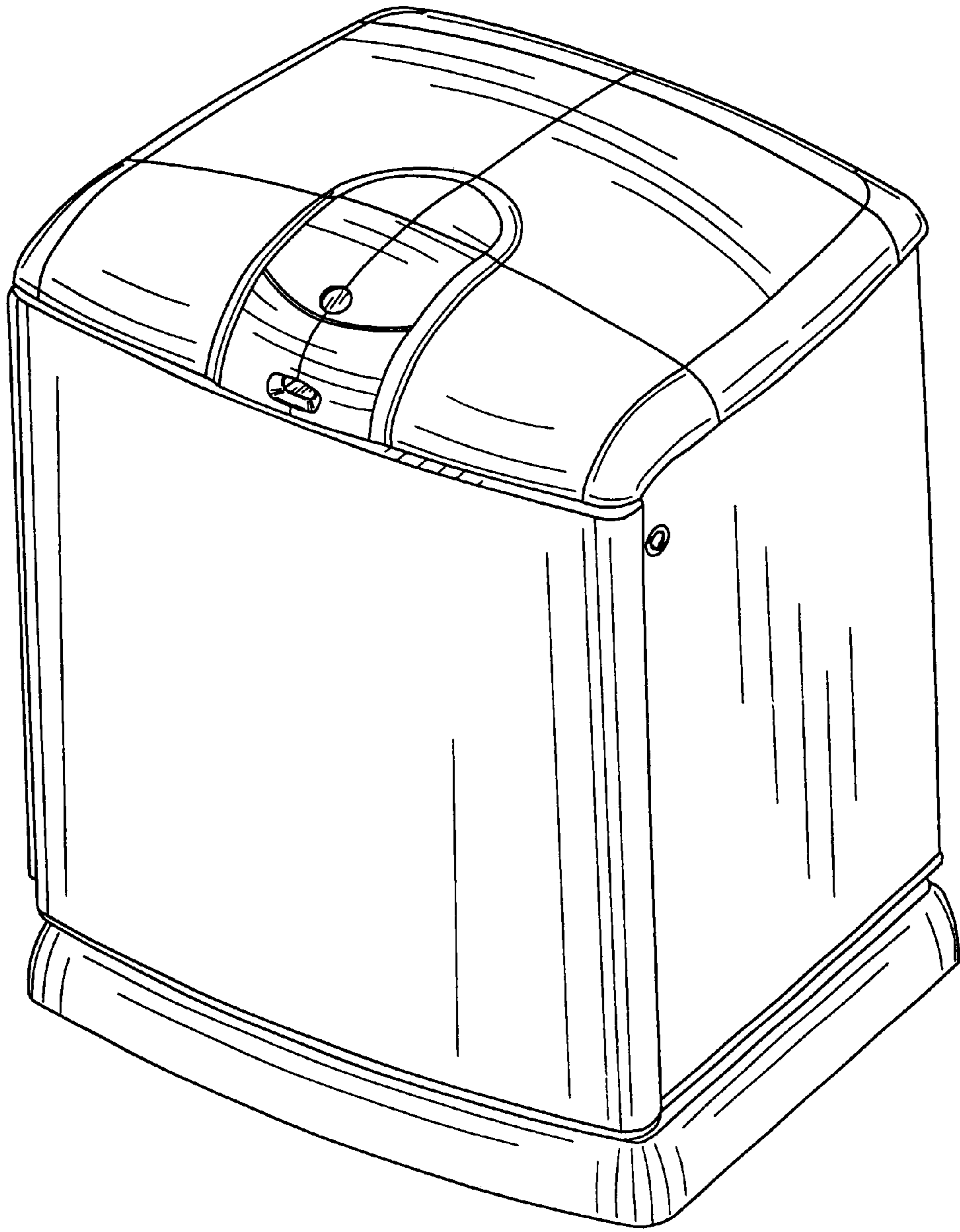

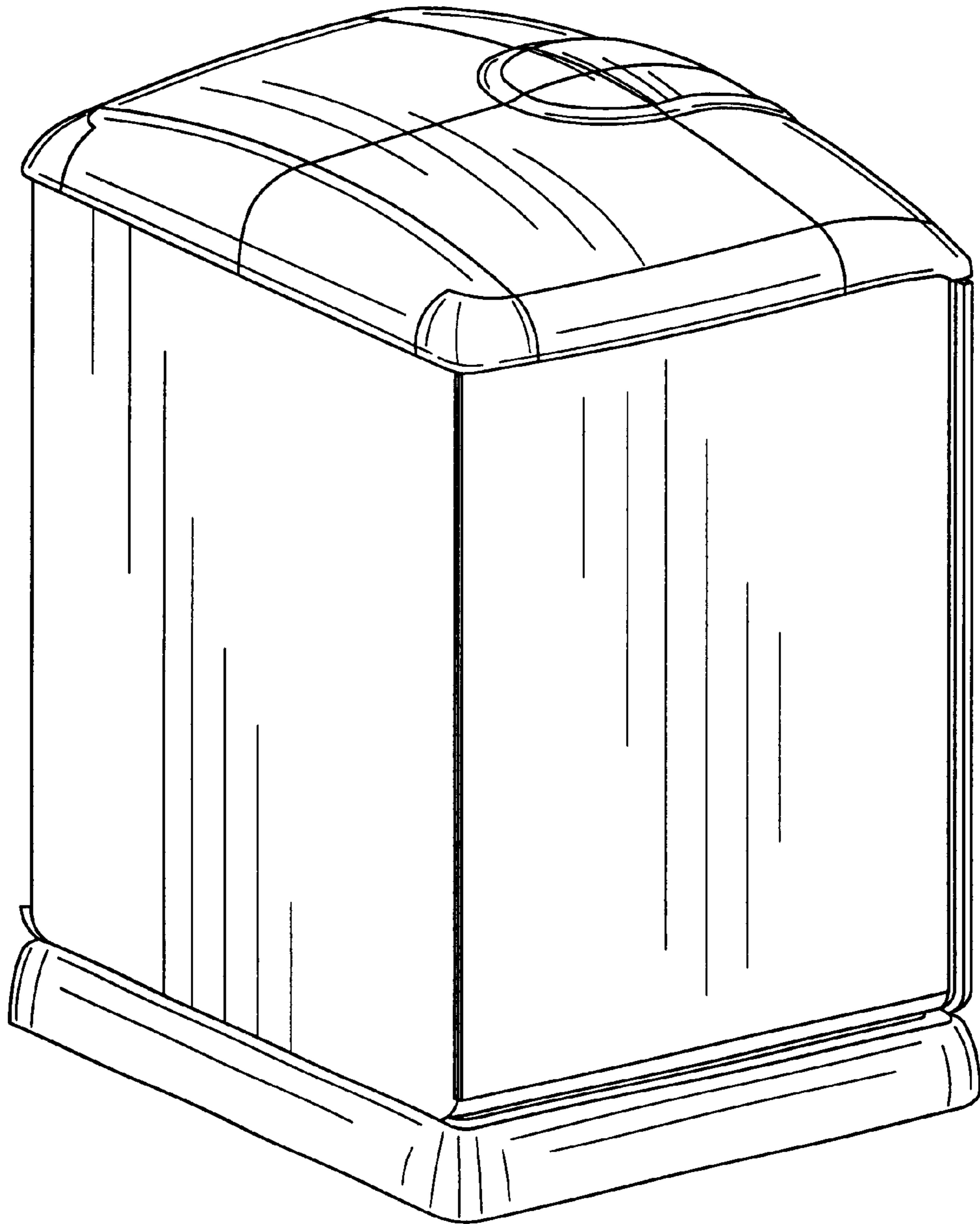

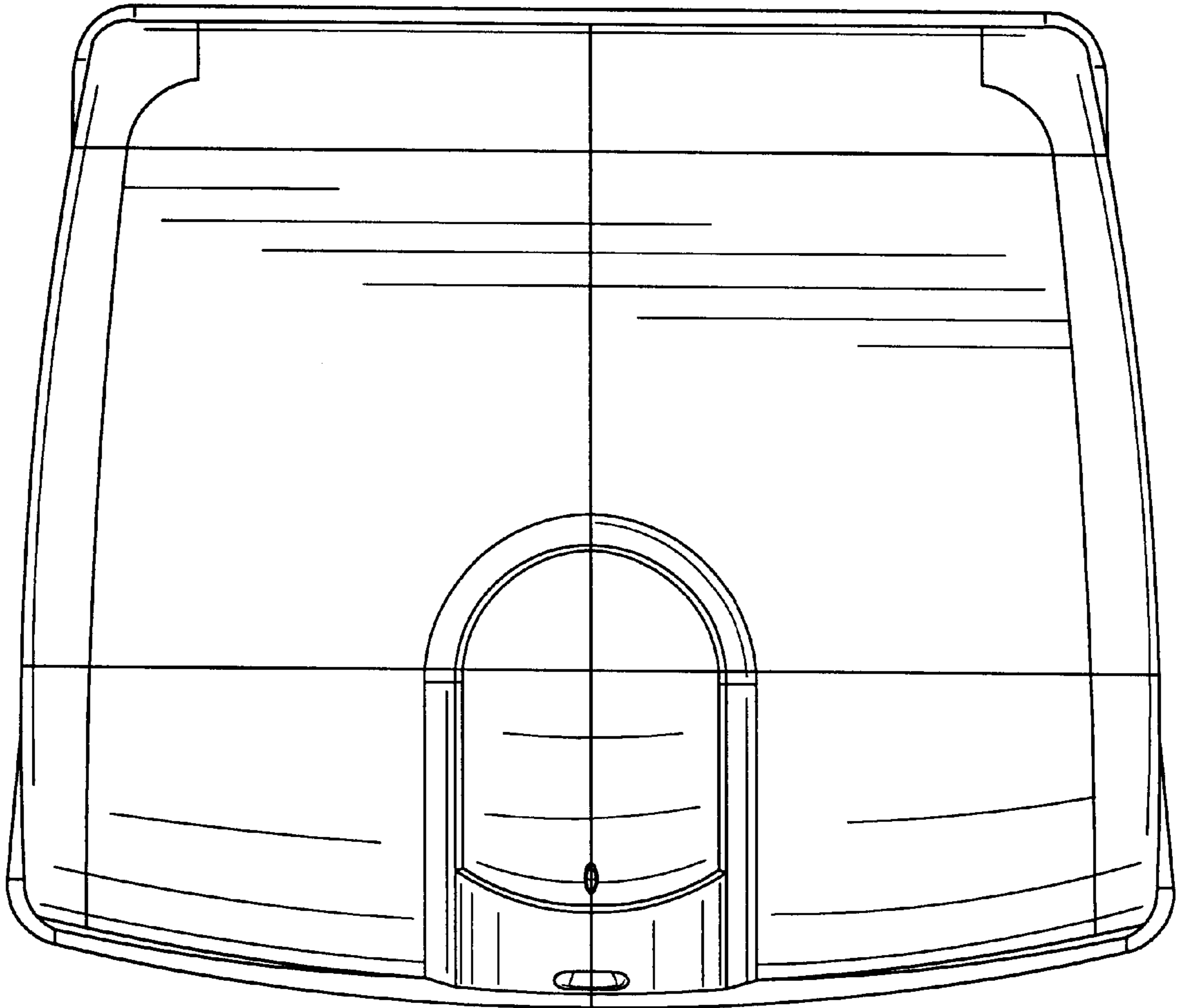

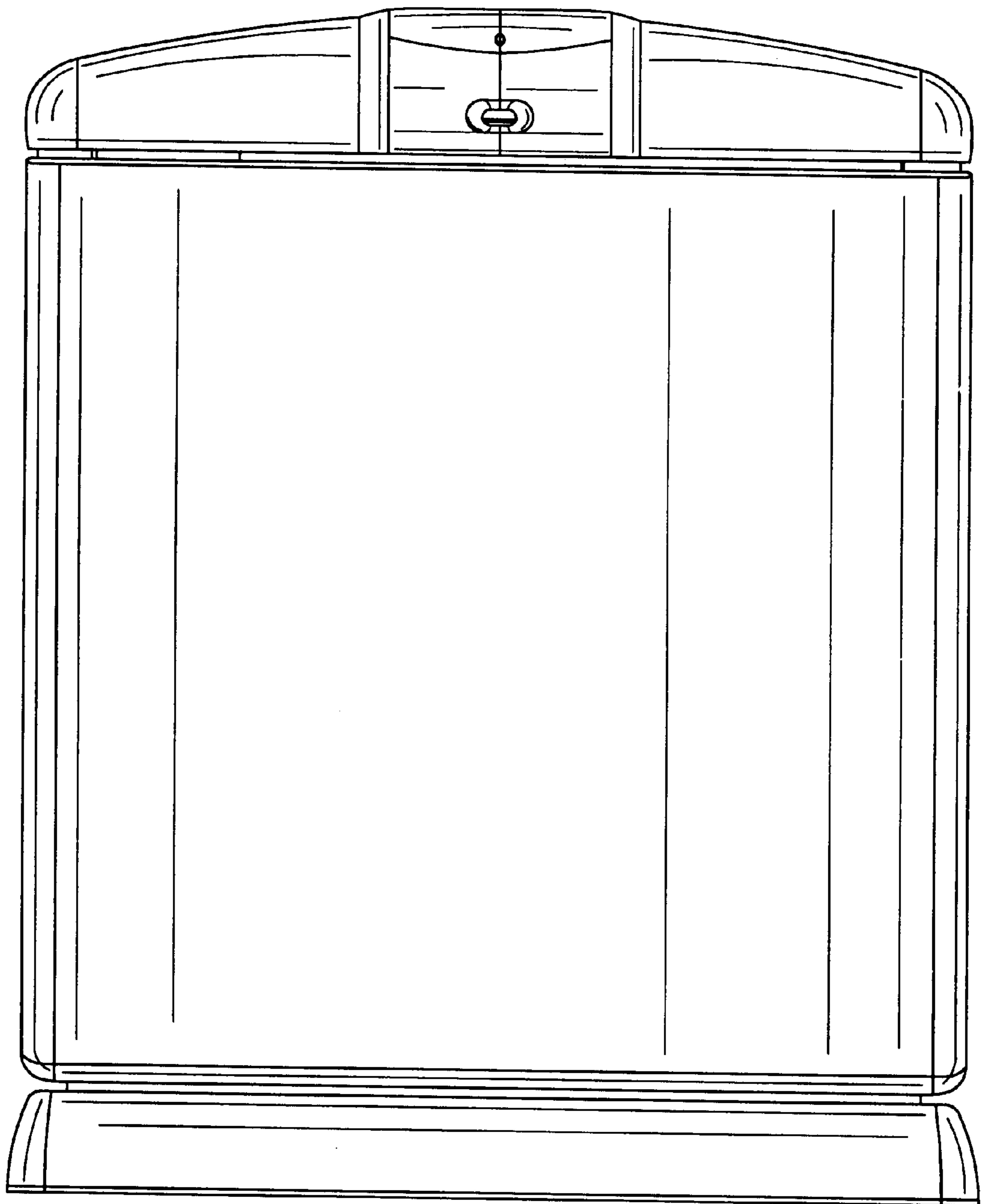

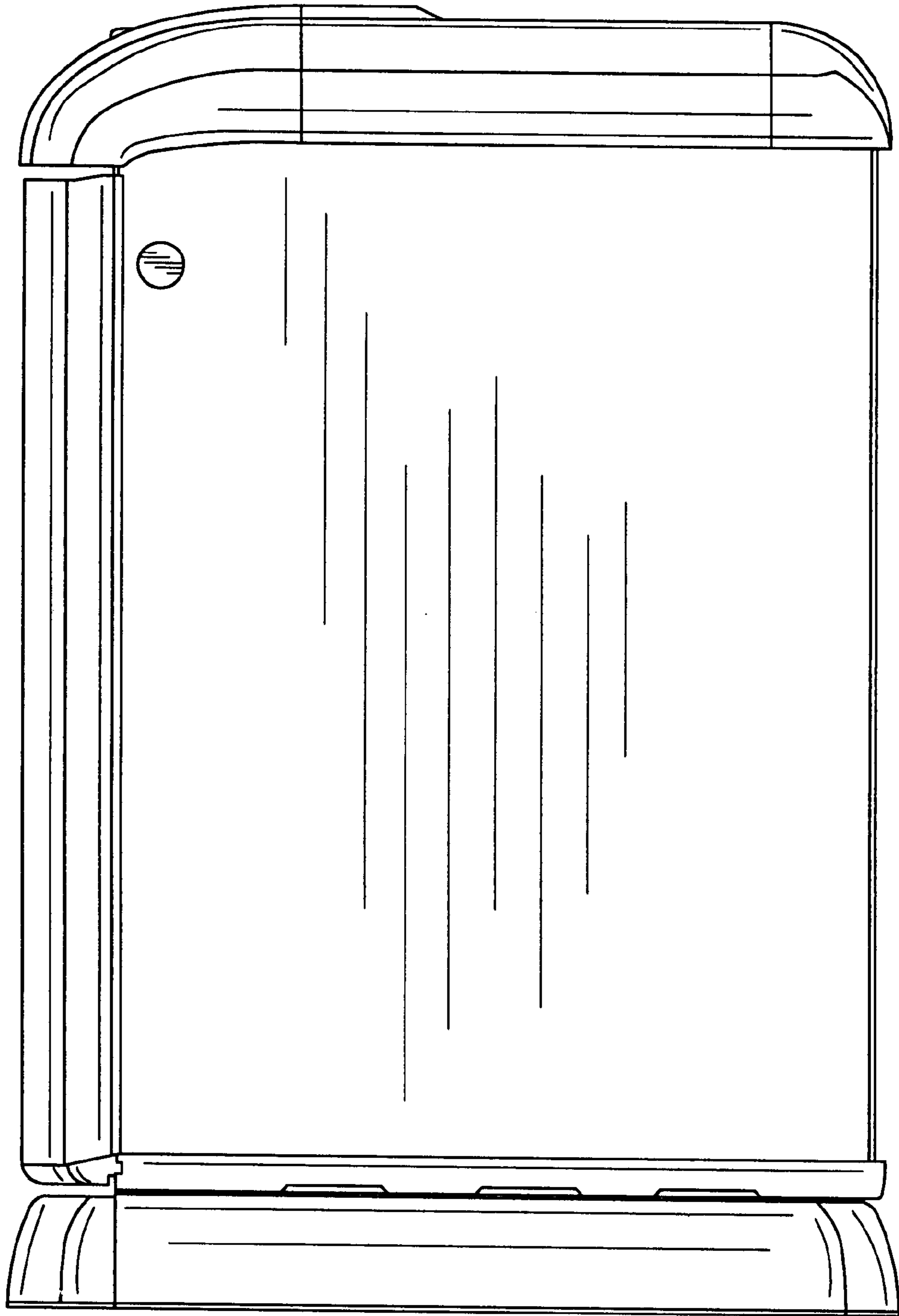

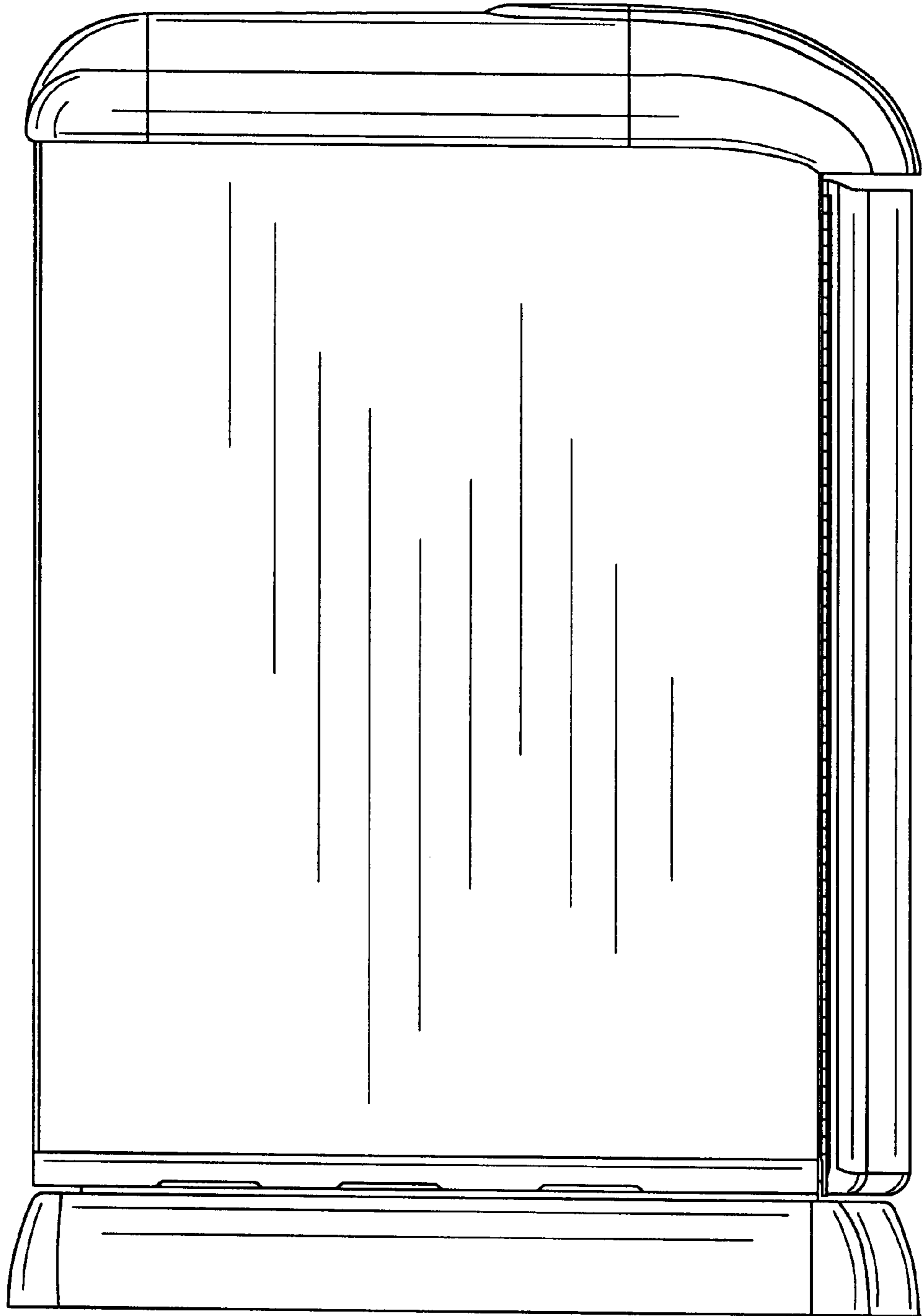

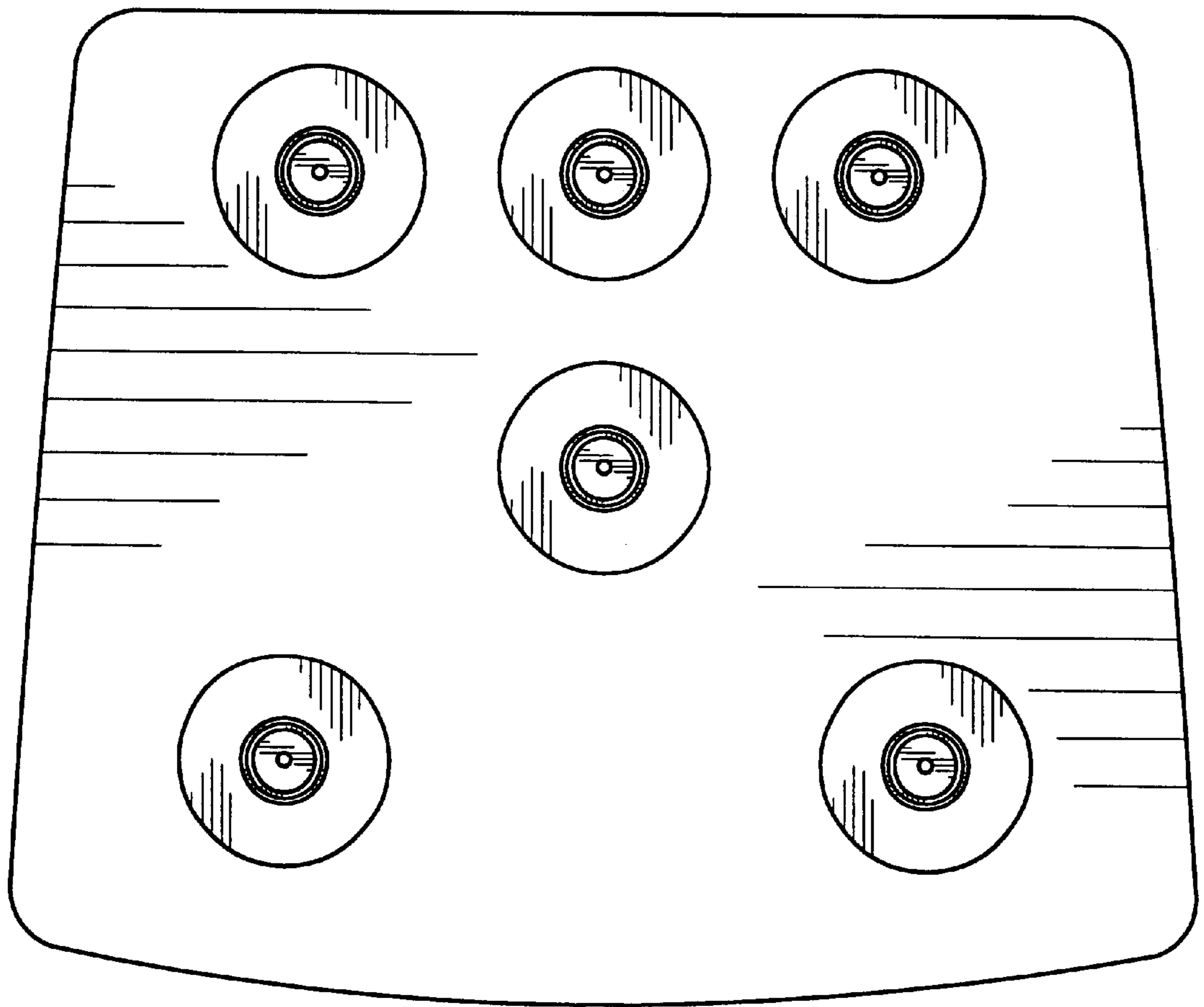
