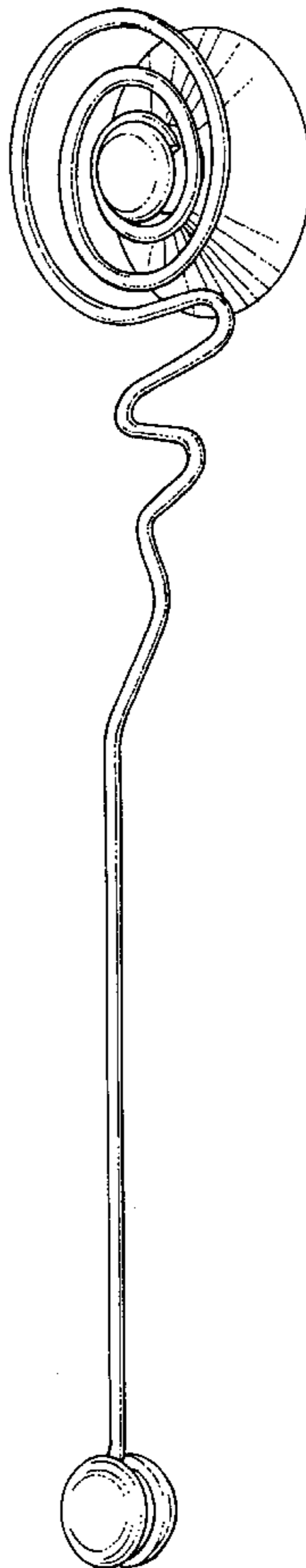
The ornamental design for a picture holder, as shown and described.

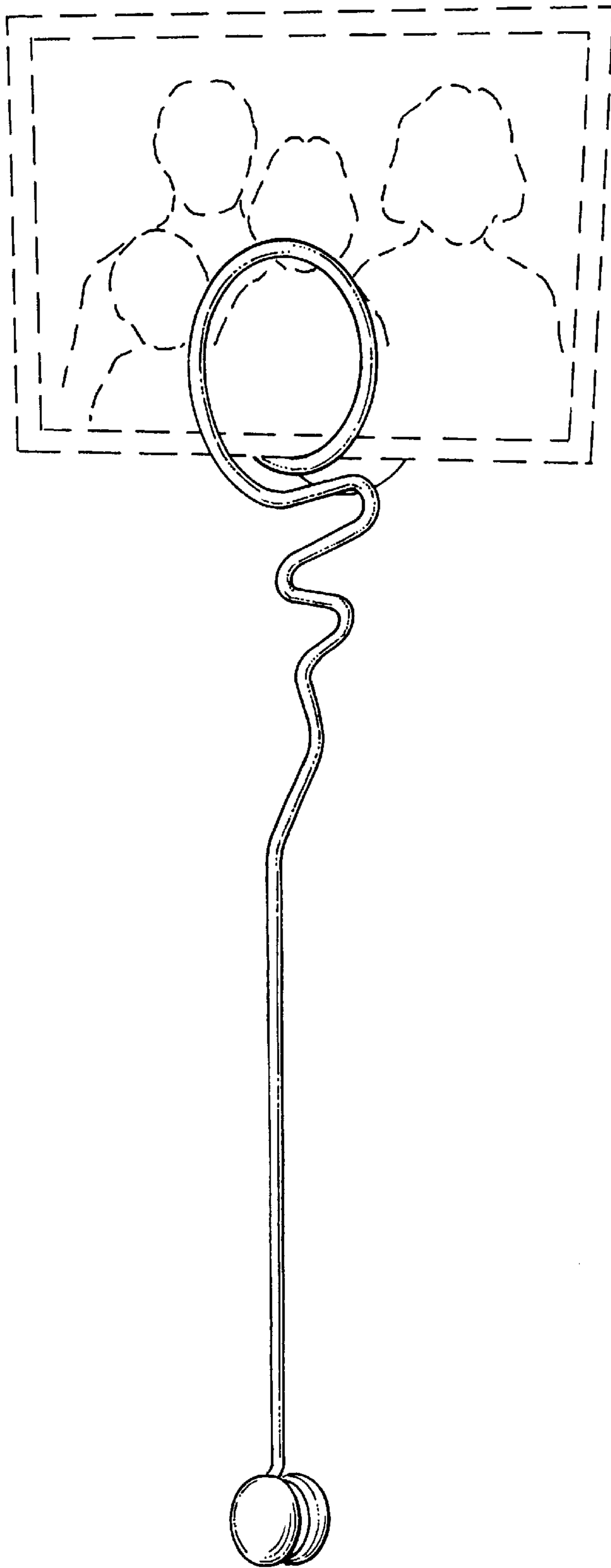
**DESCRIPTION**

 FIG. 9 is a bottom plan view thereof.

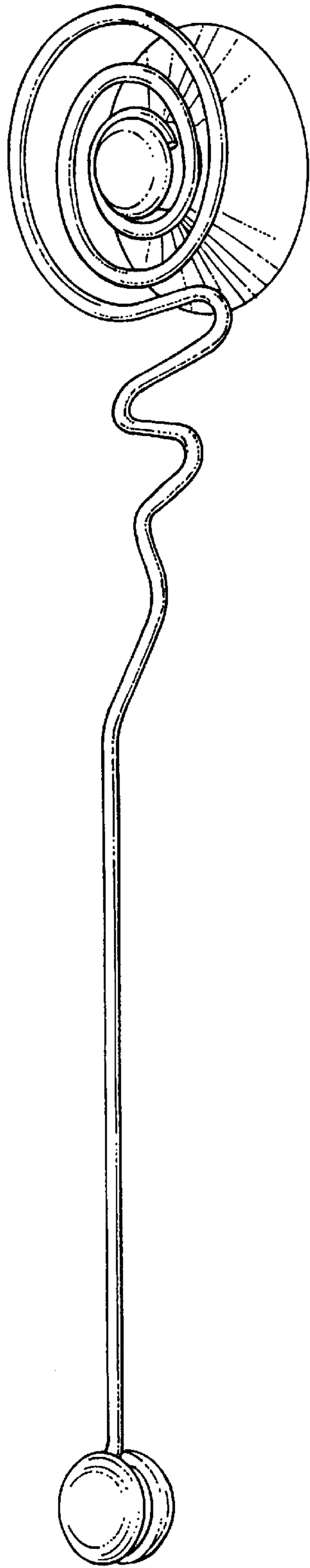

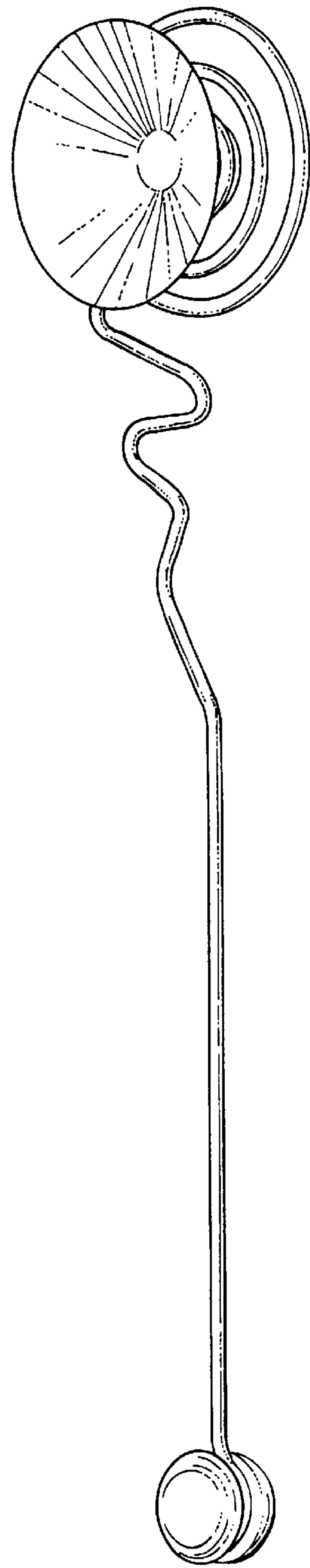




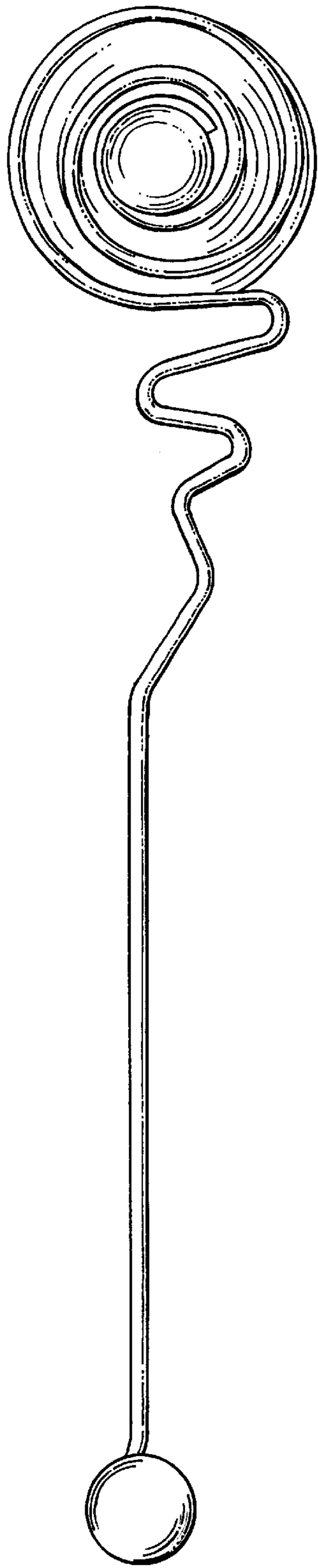

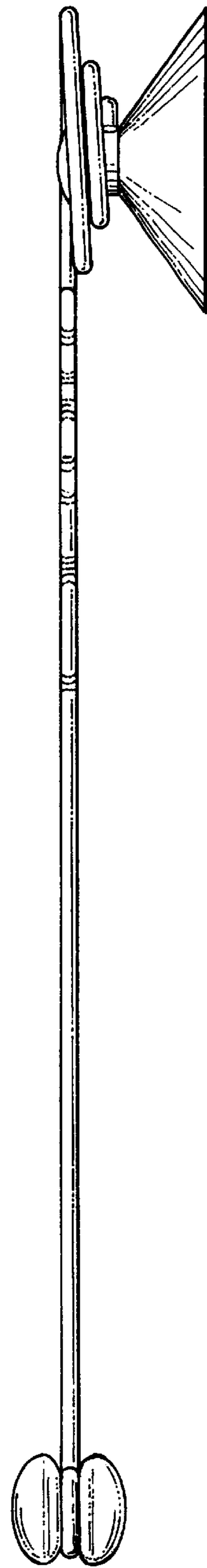

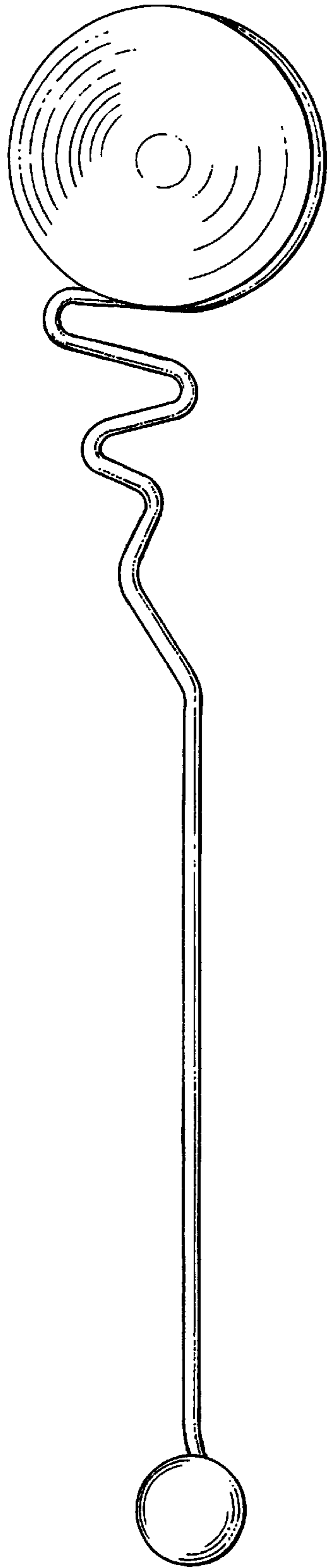

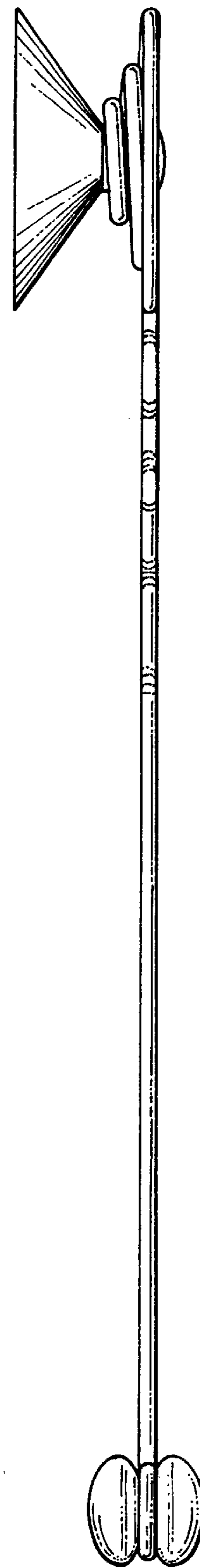

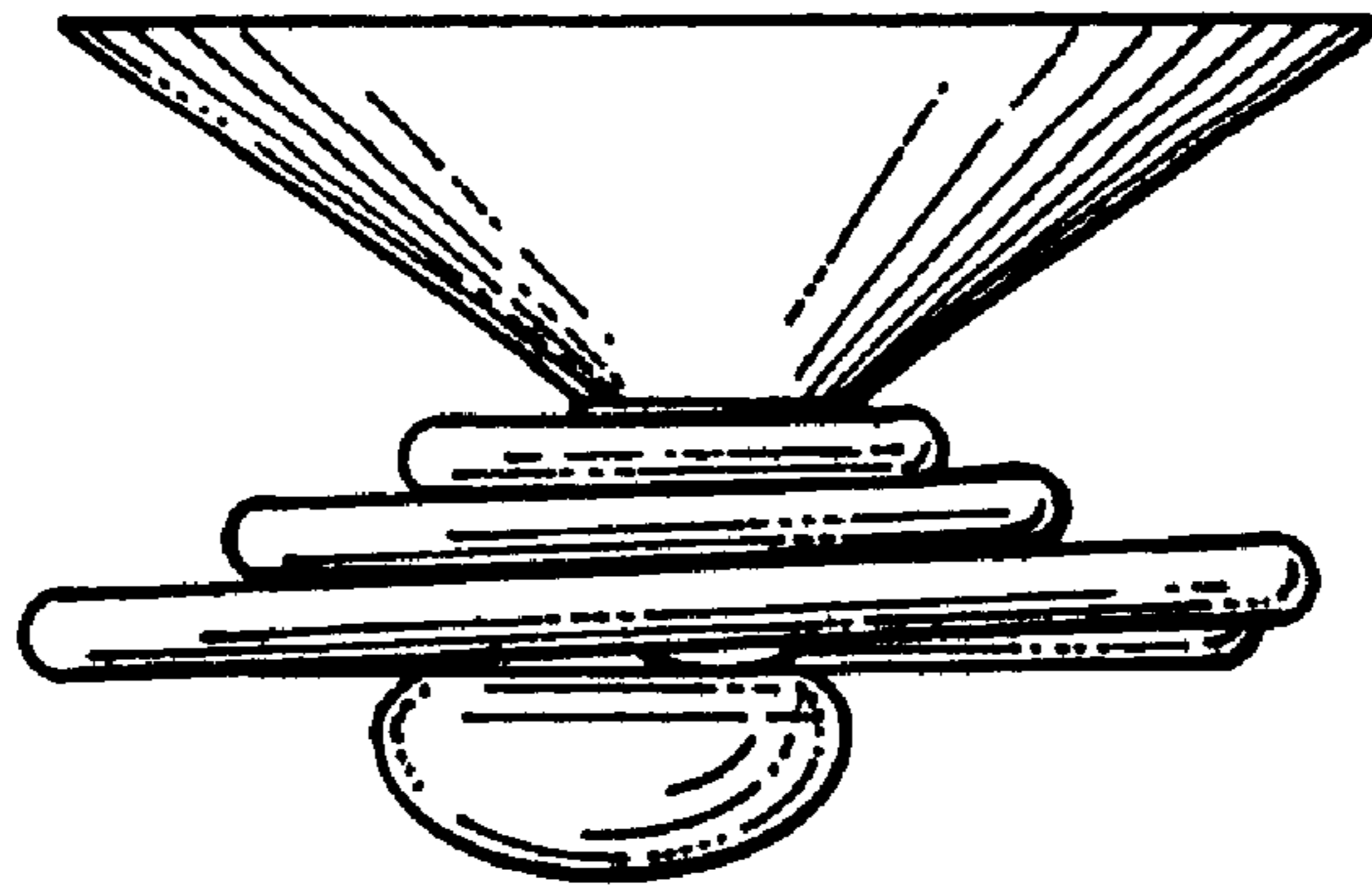

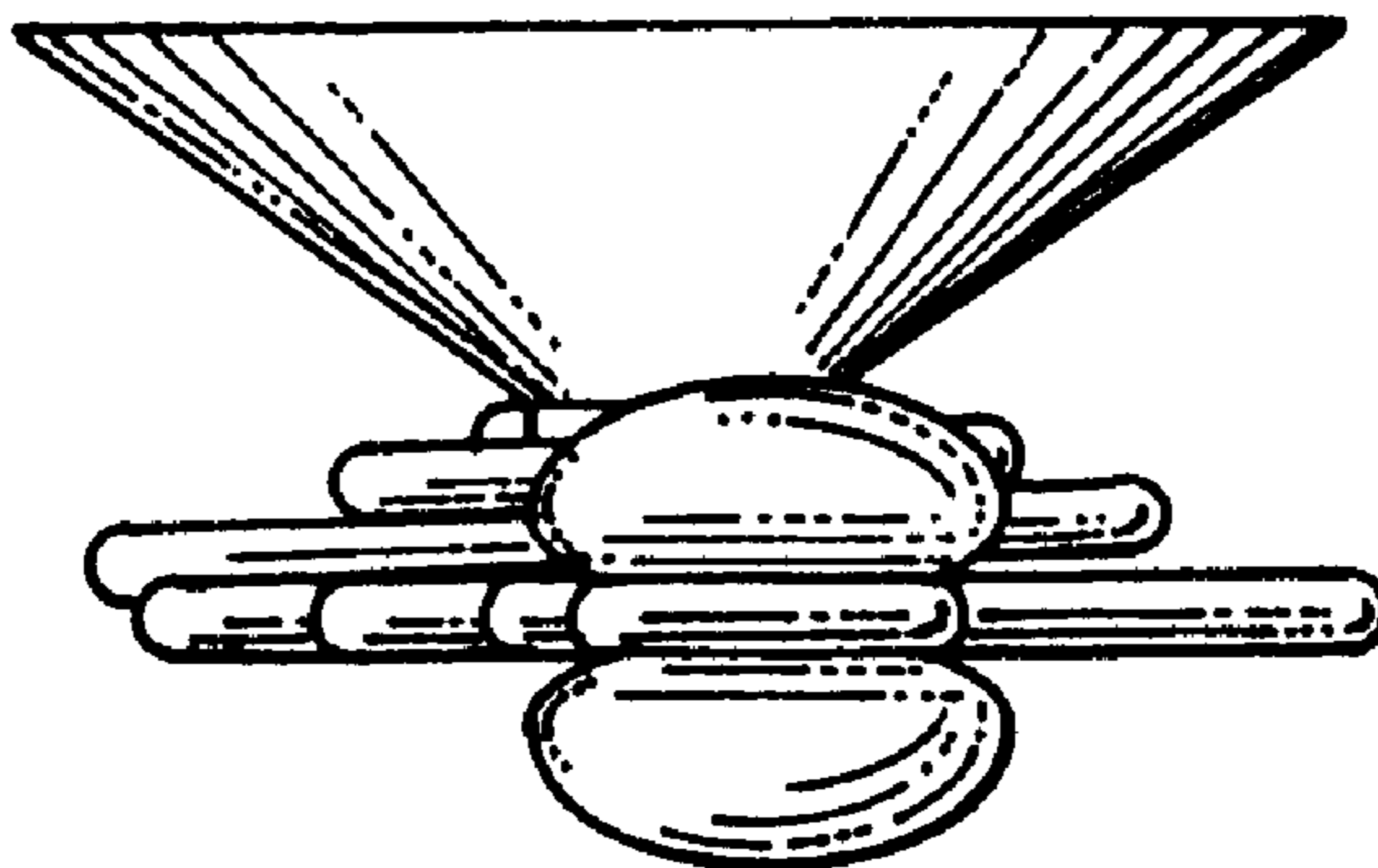
