cleaner cover and tire, as shown and described.

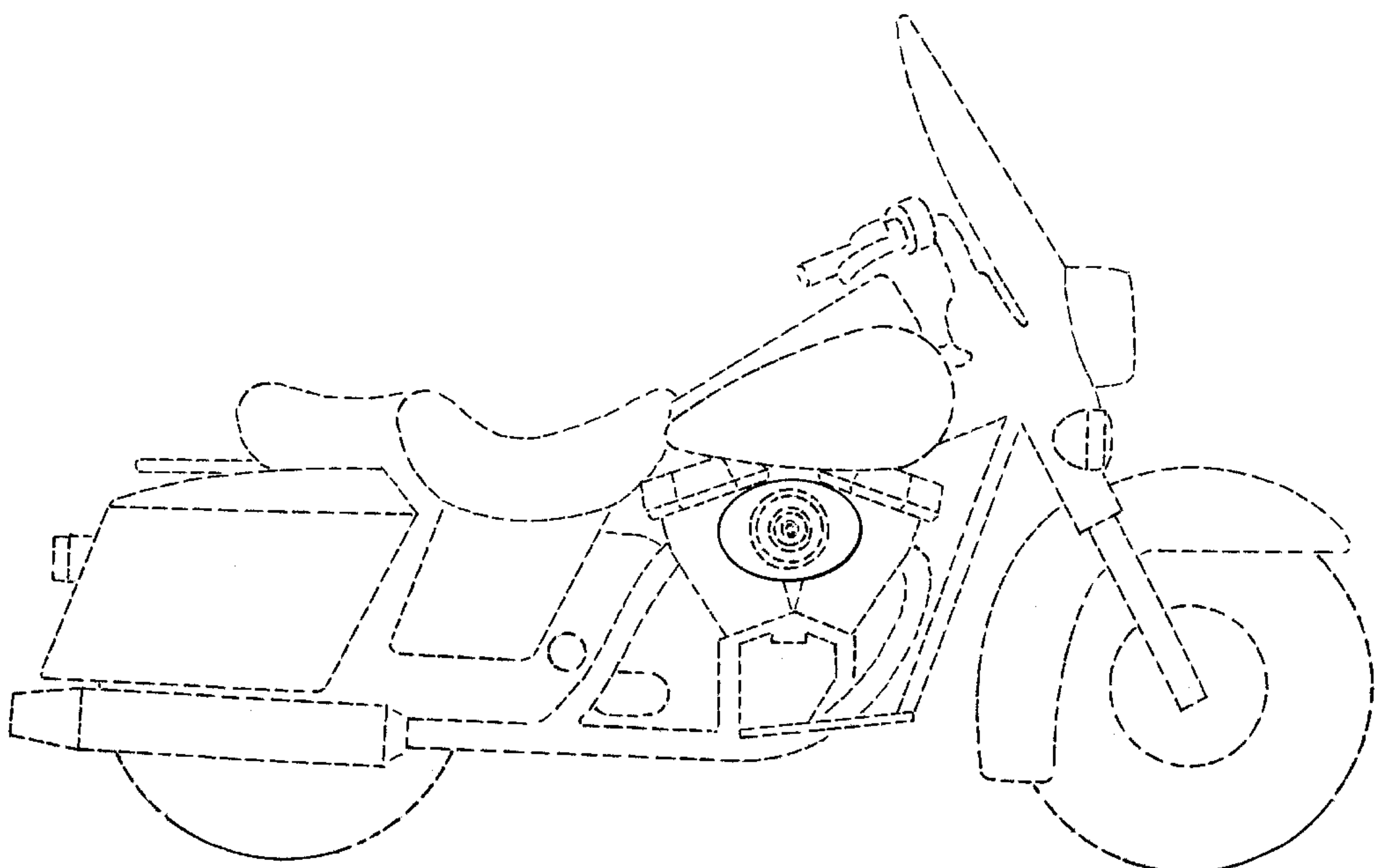
DESCRIPTION

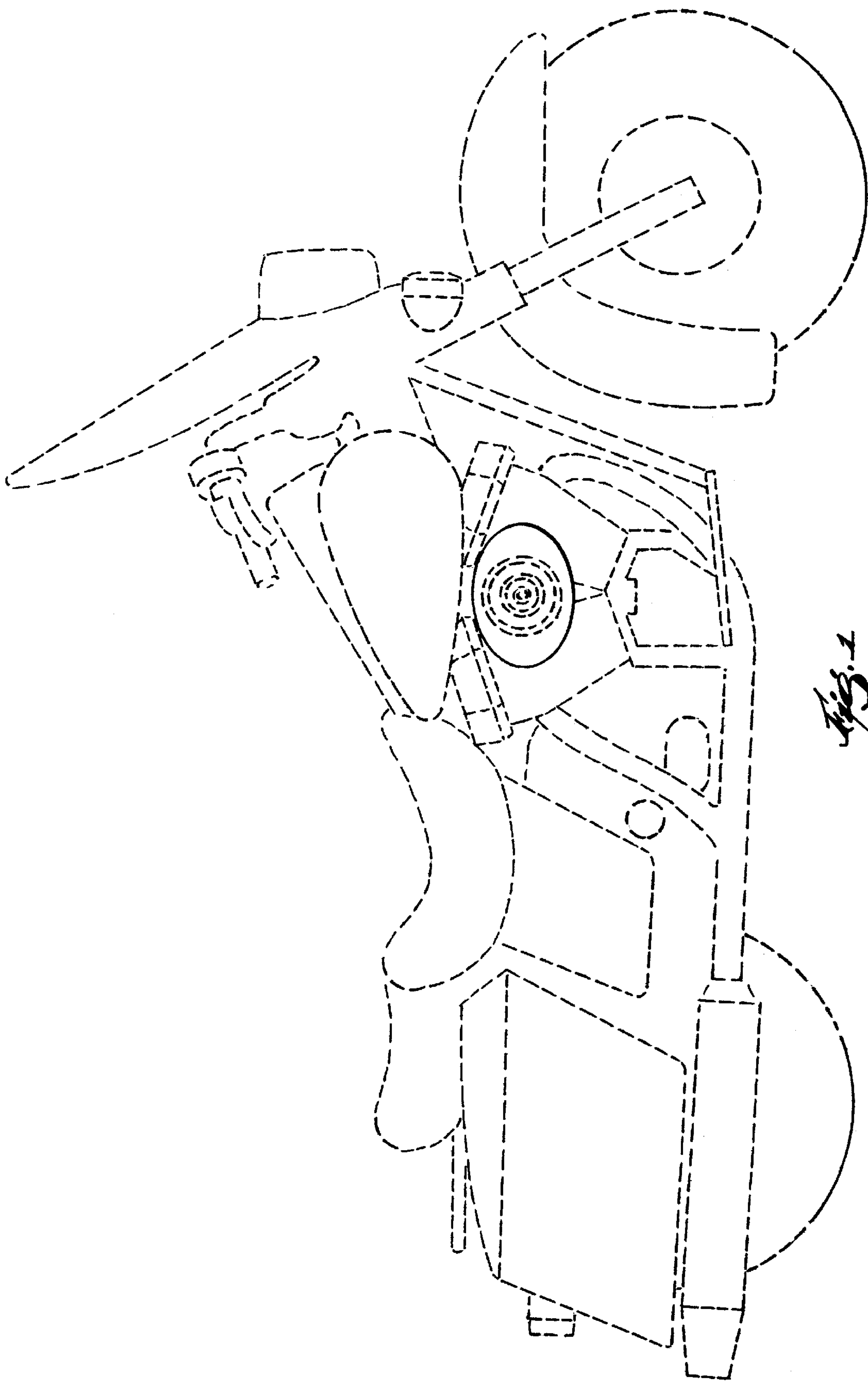

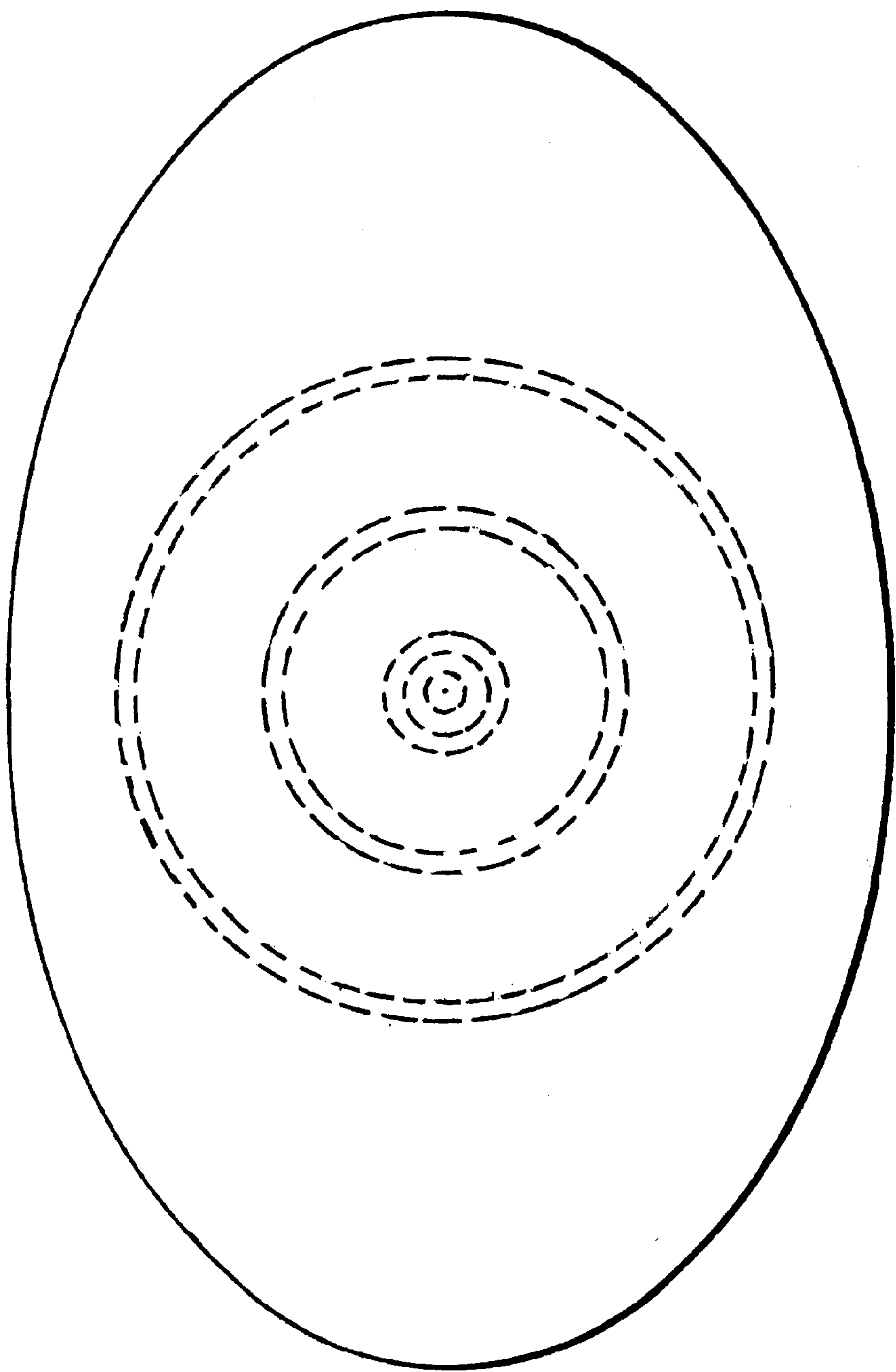
