FIG. 6 is a bottom plan view thereof;

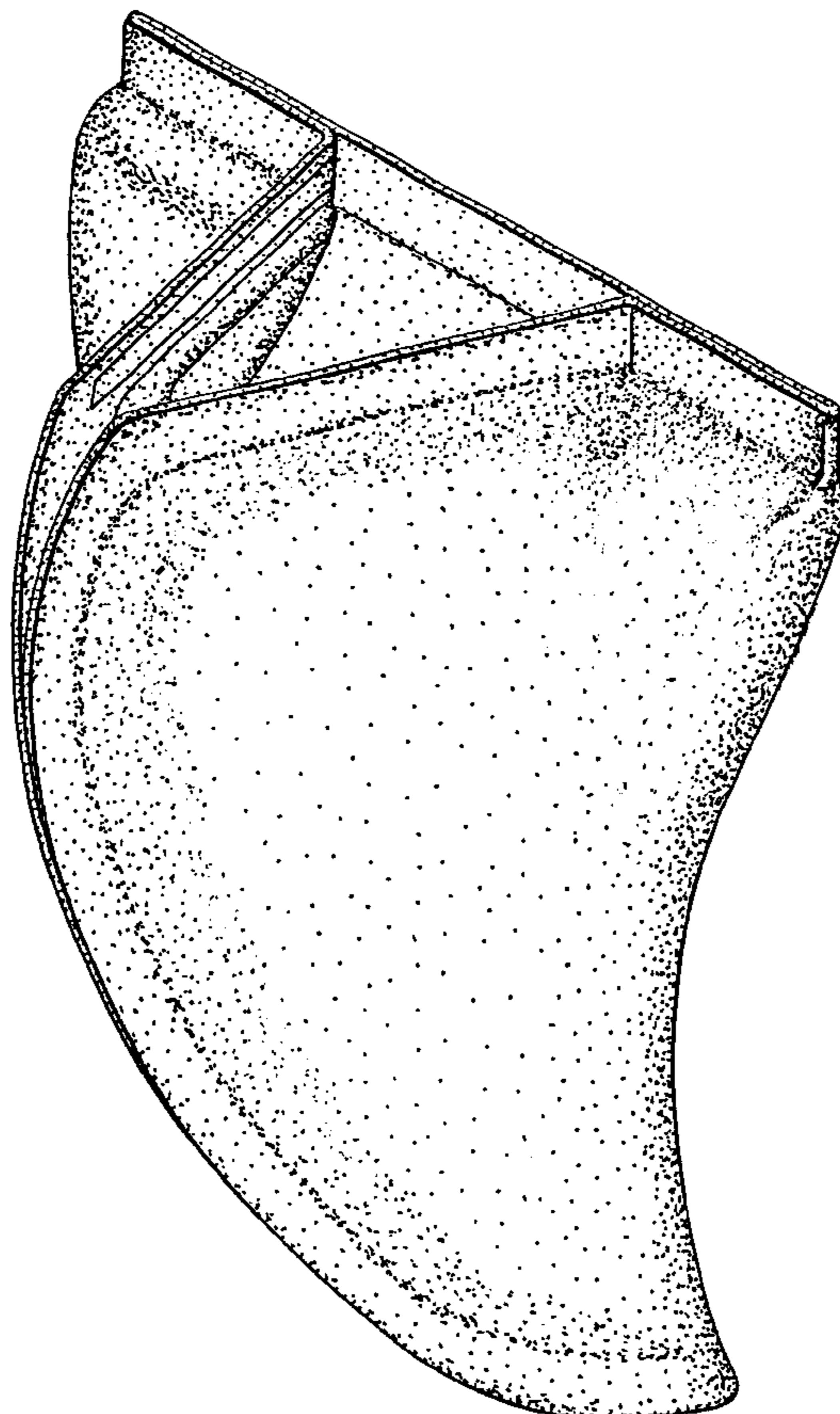
FIG. 7 is a cross-sectional view thereof, taken along line

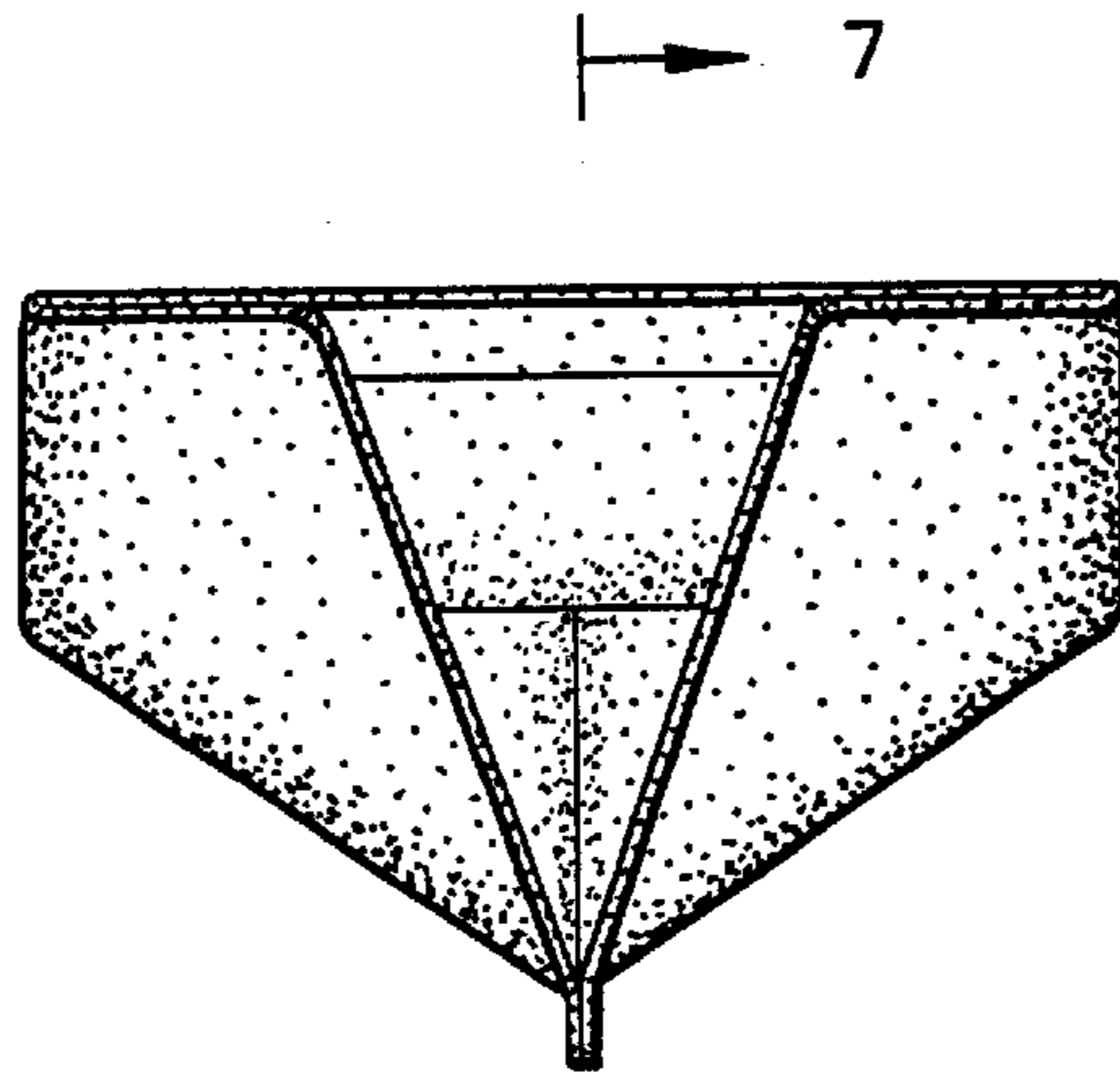

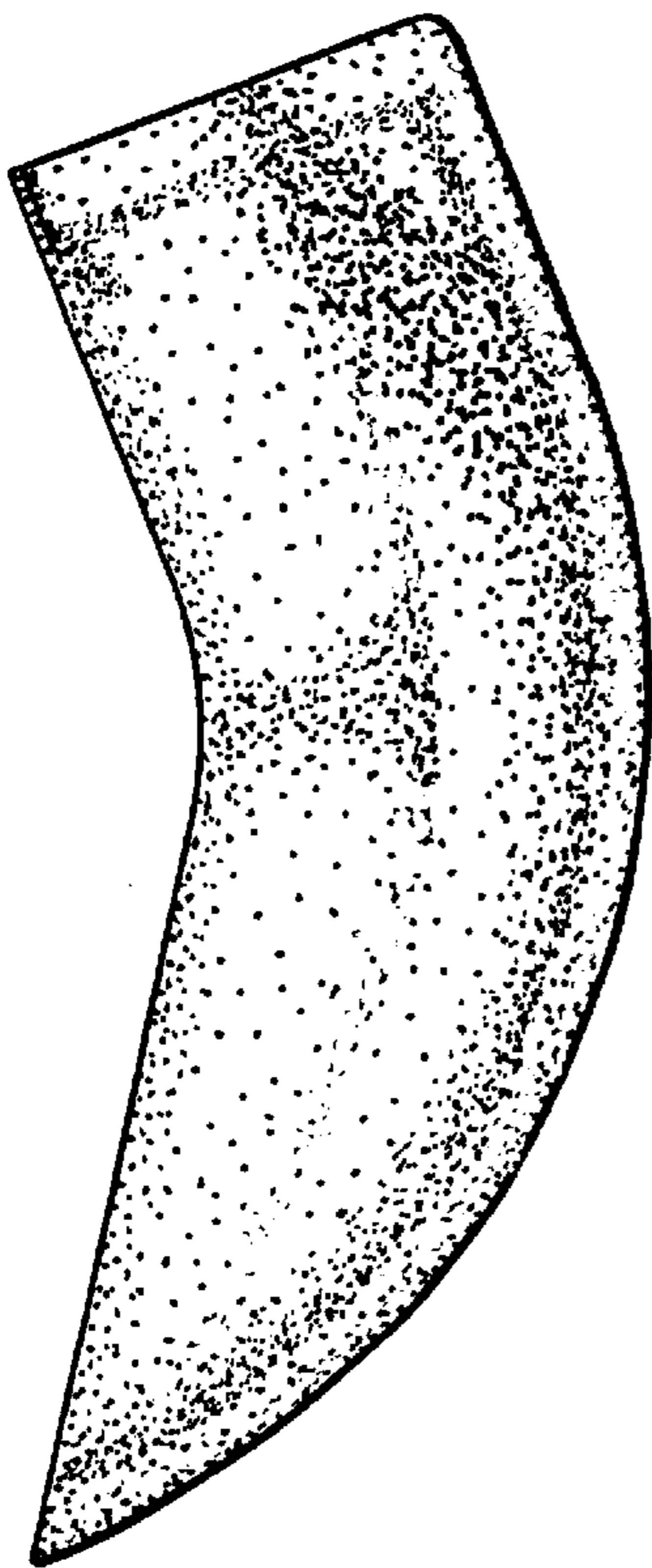

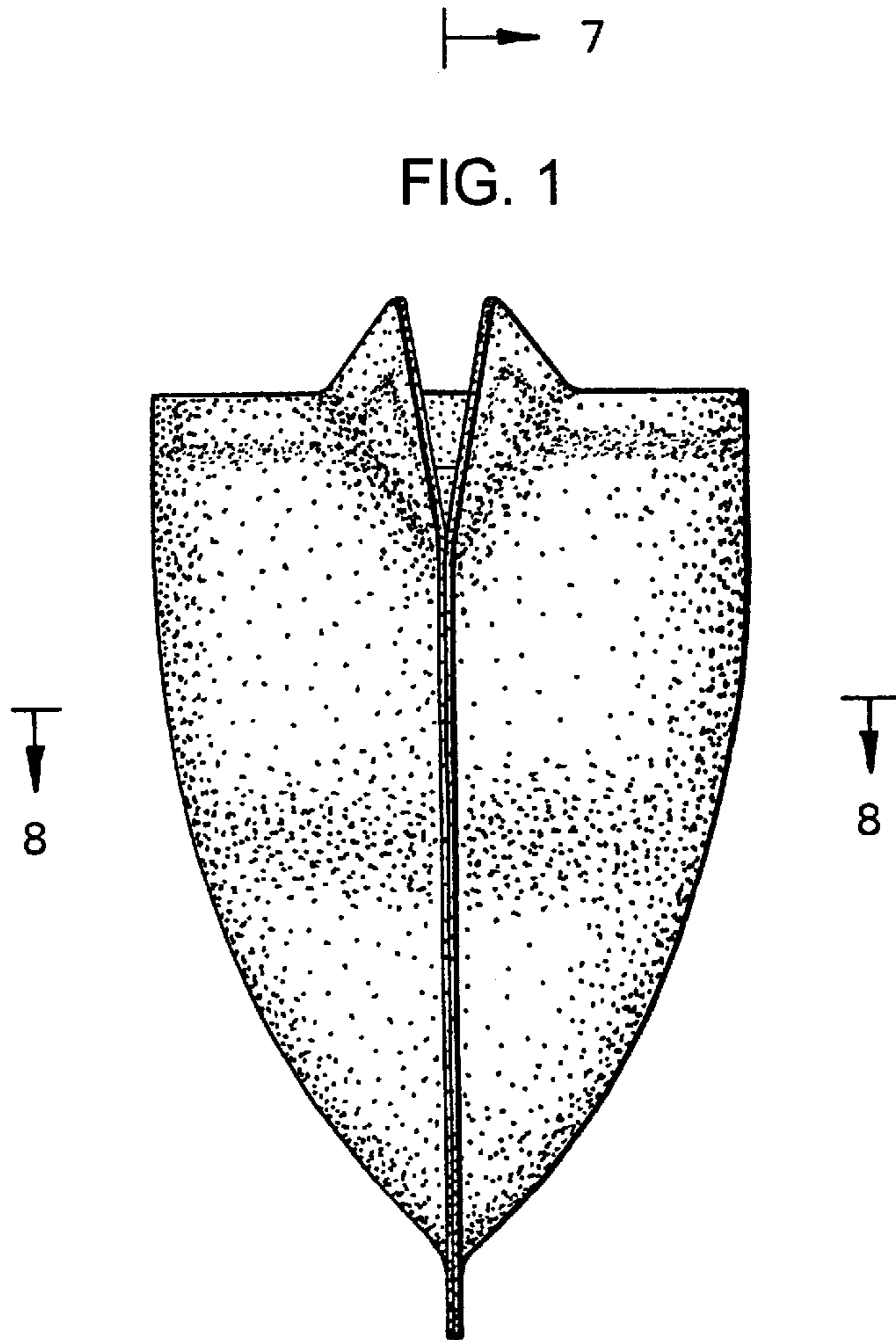

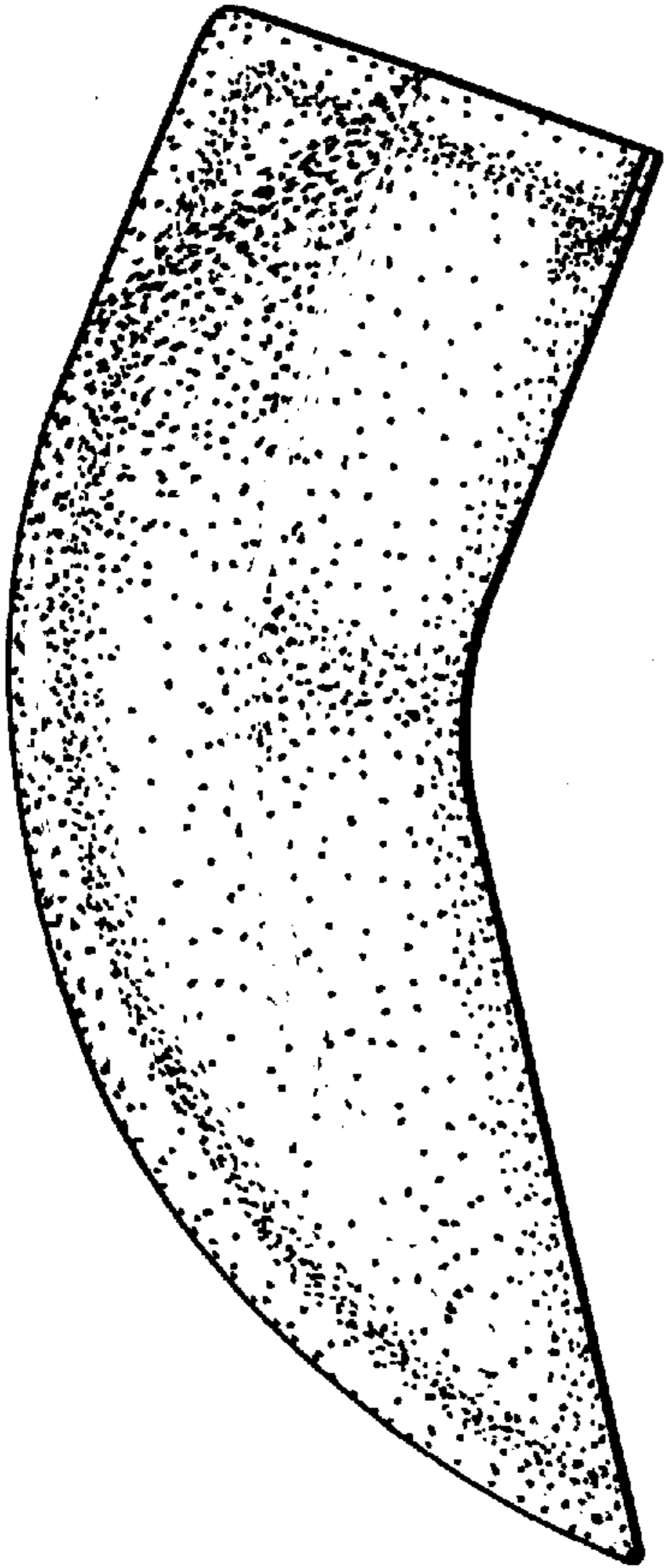

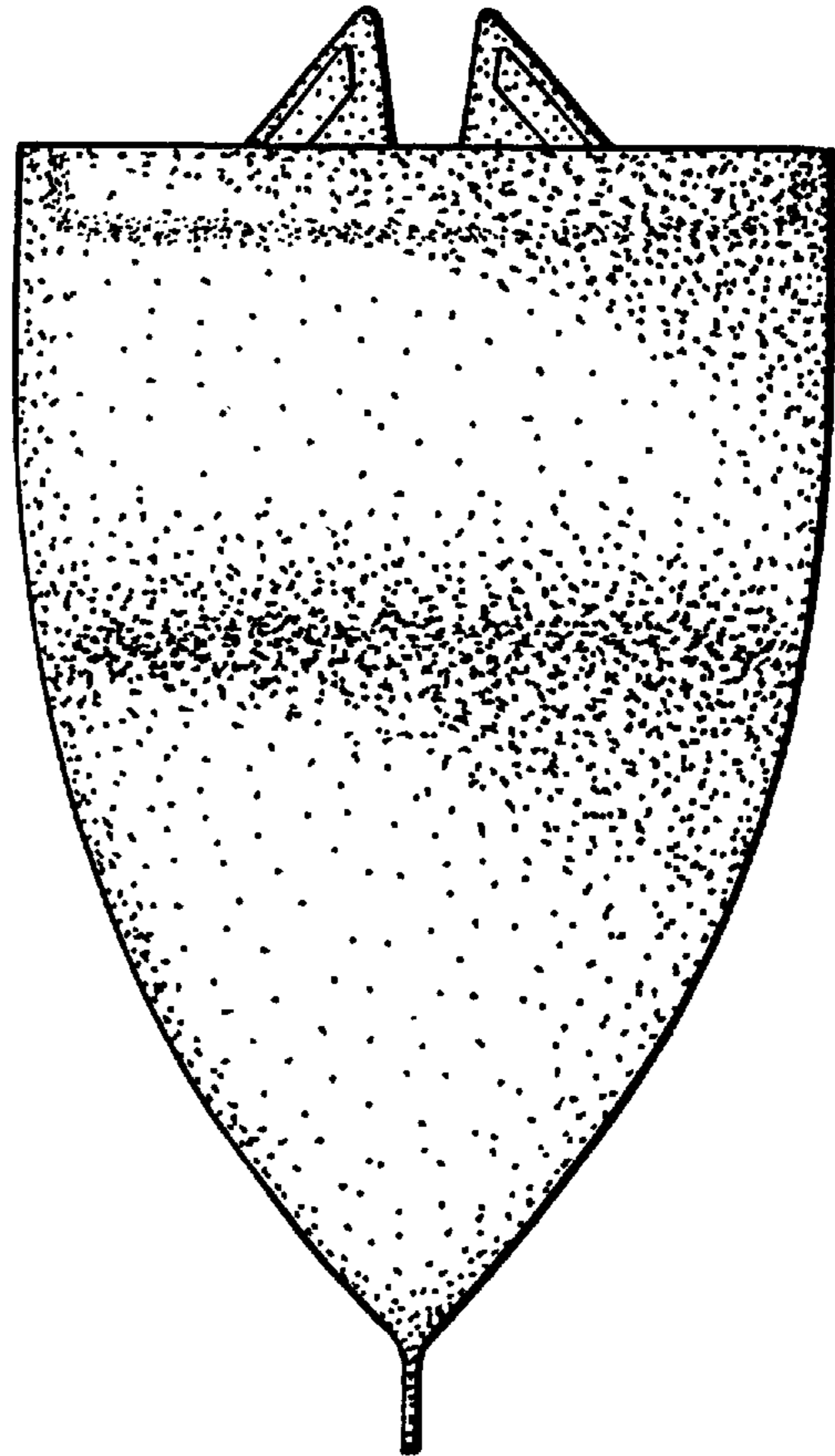

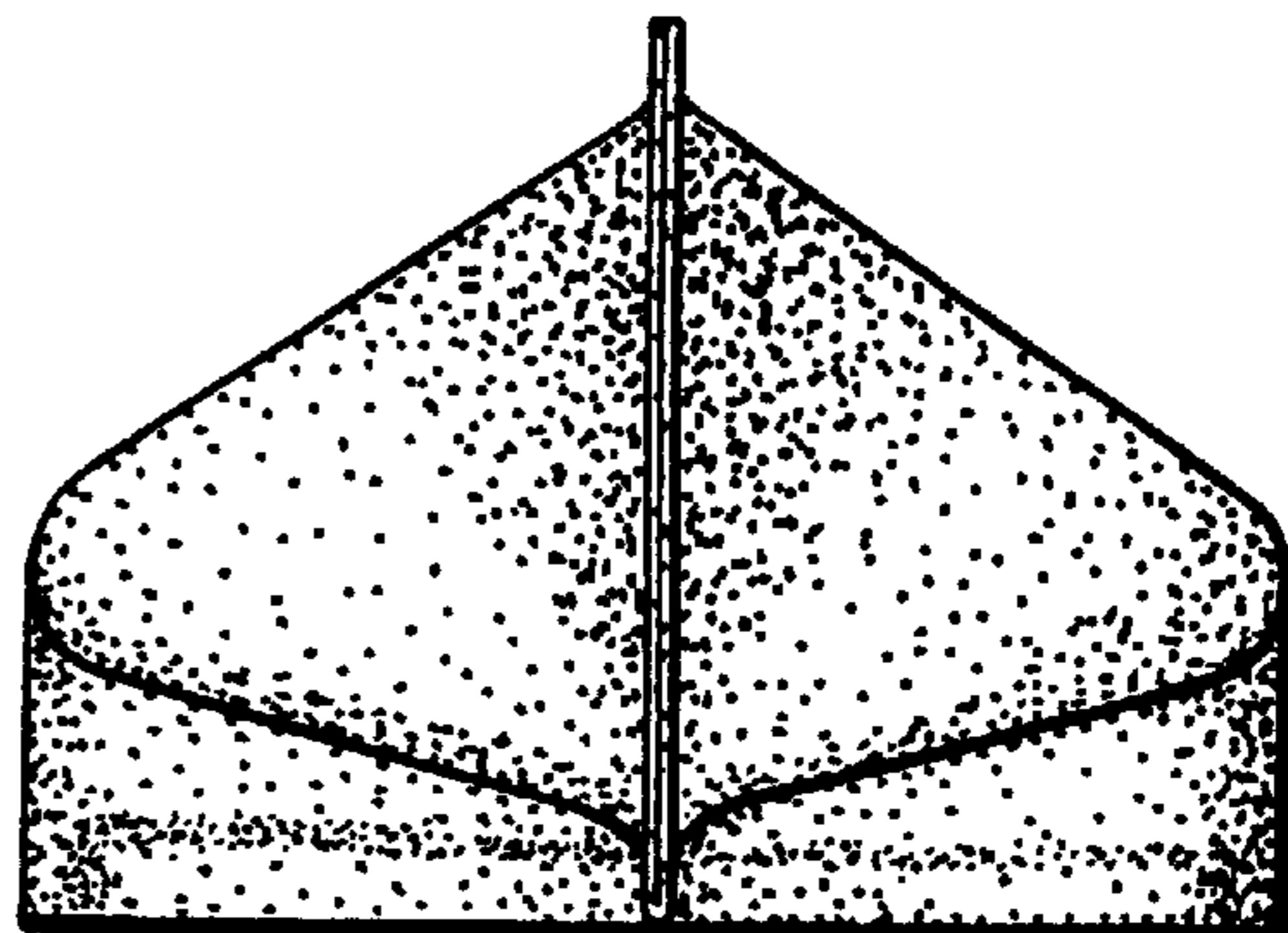

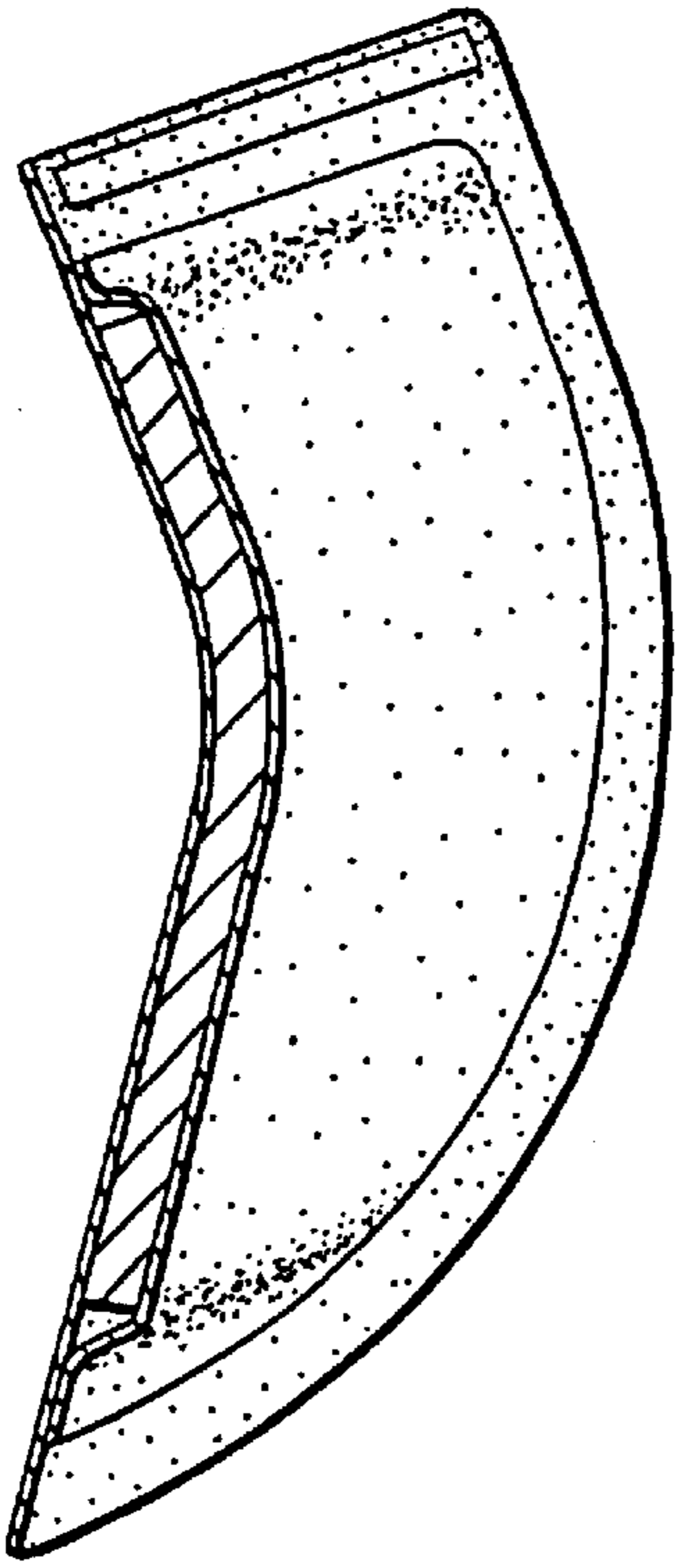

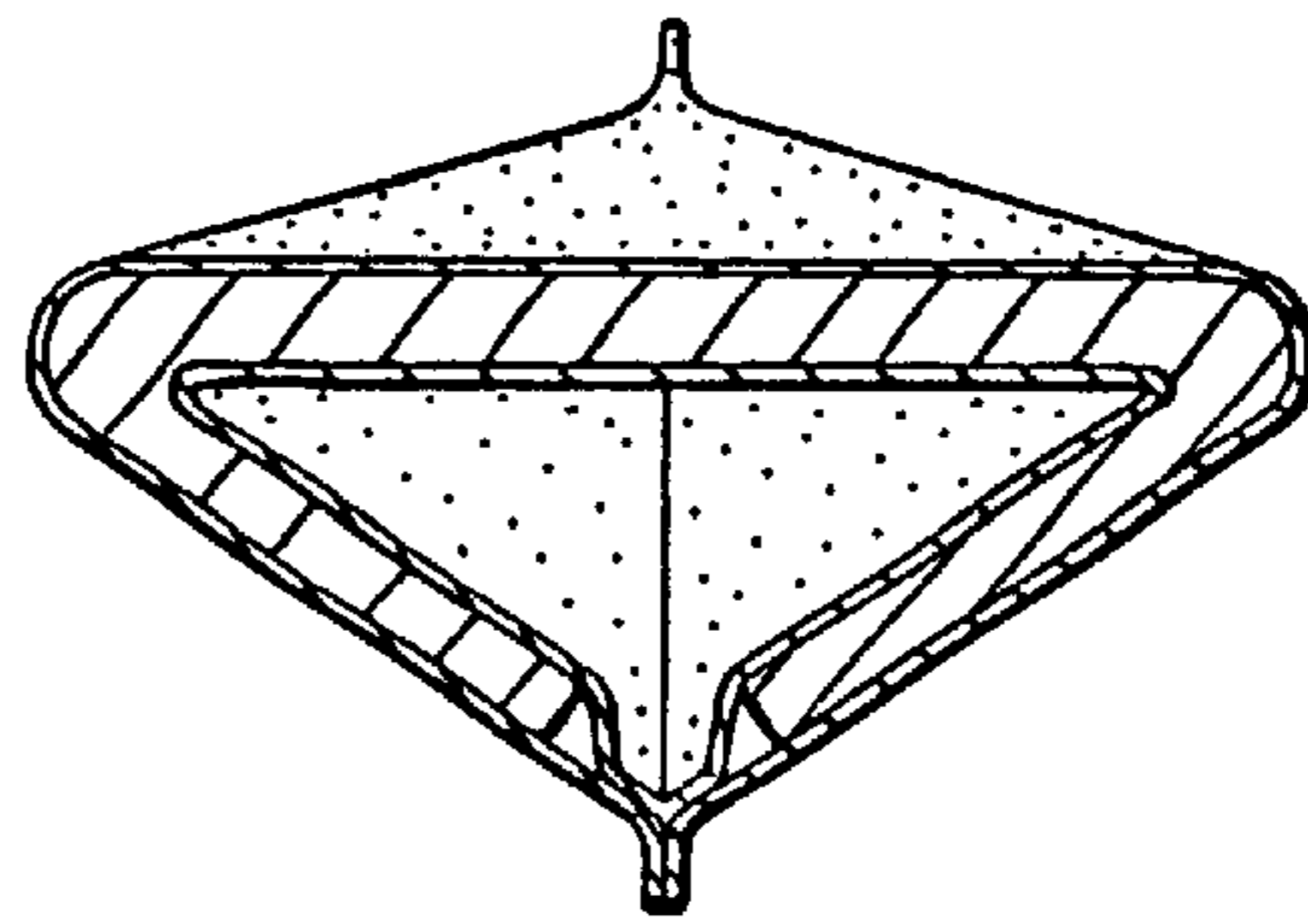

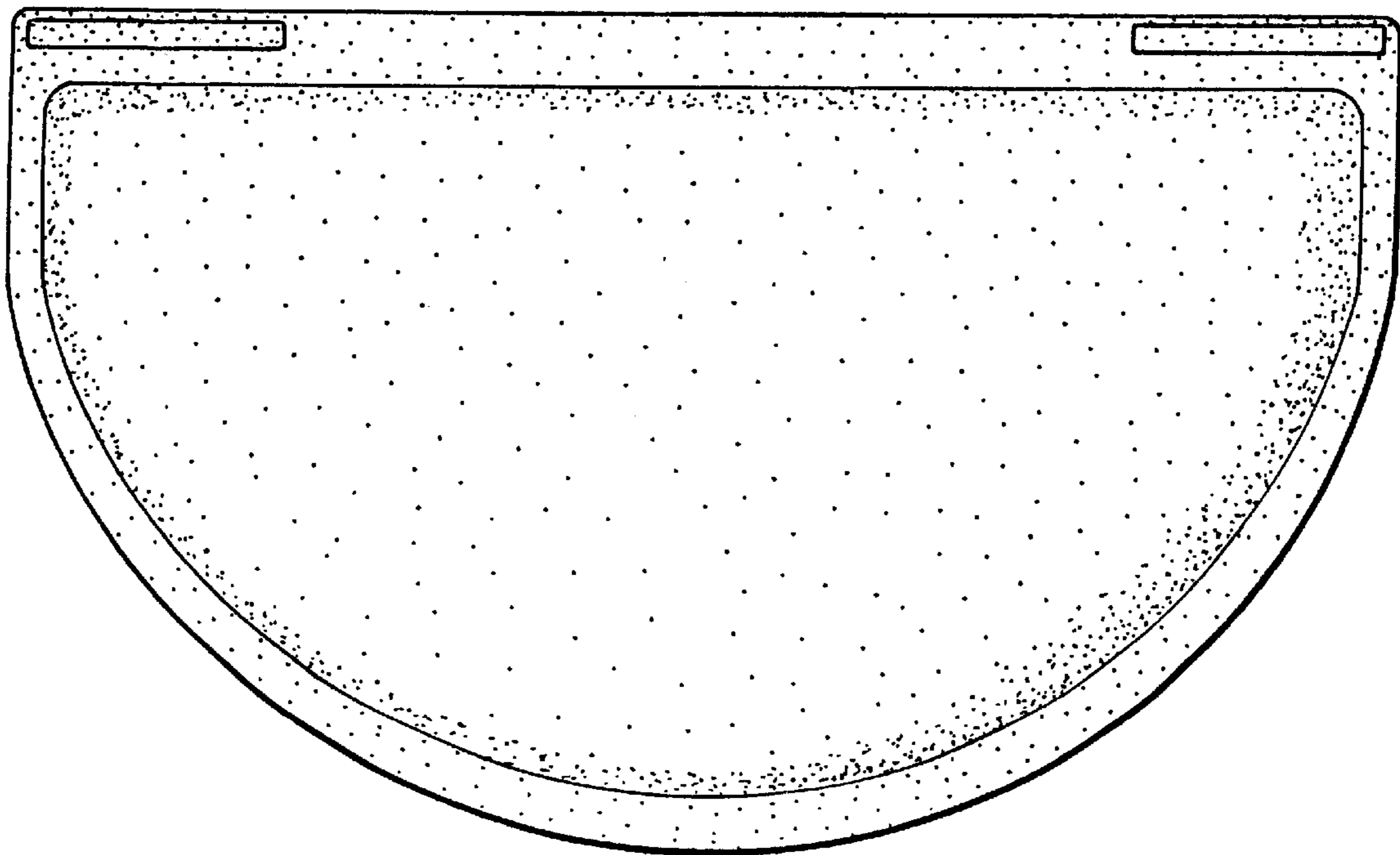

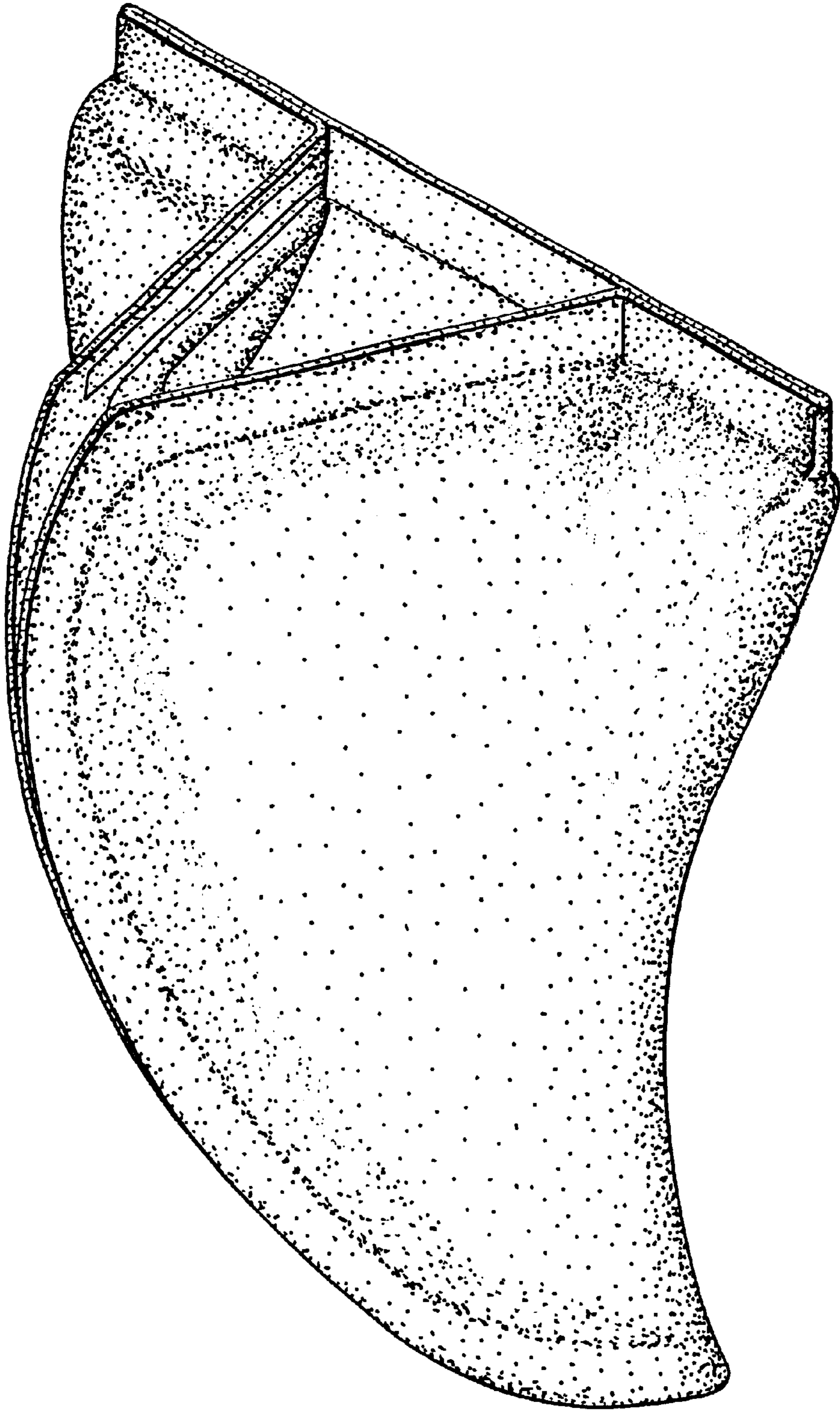
