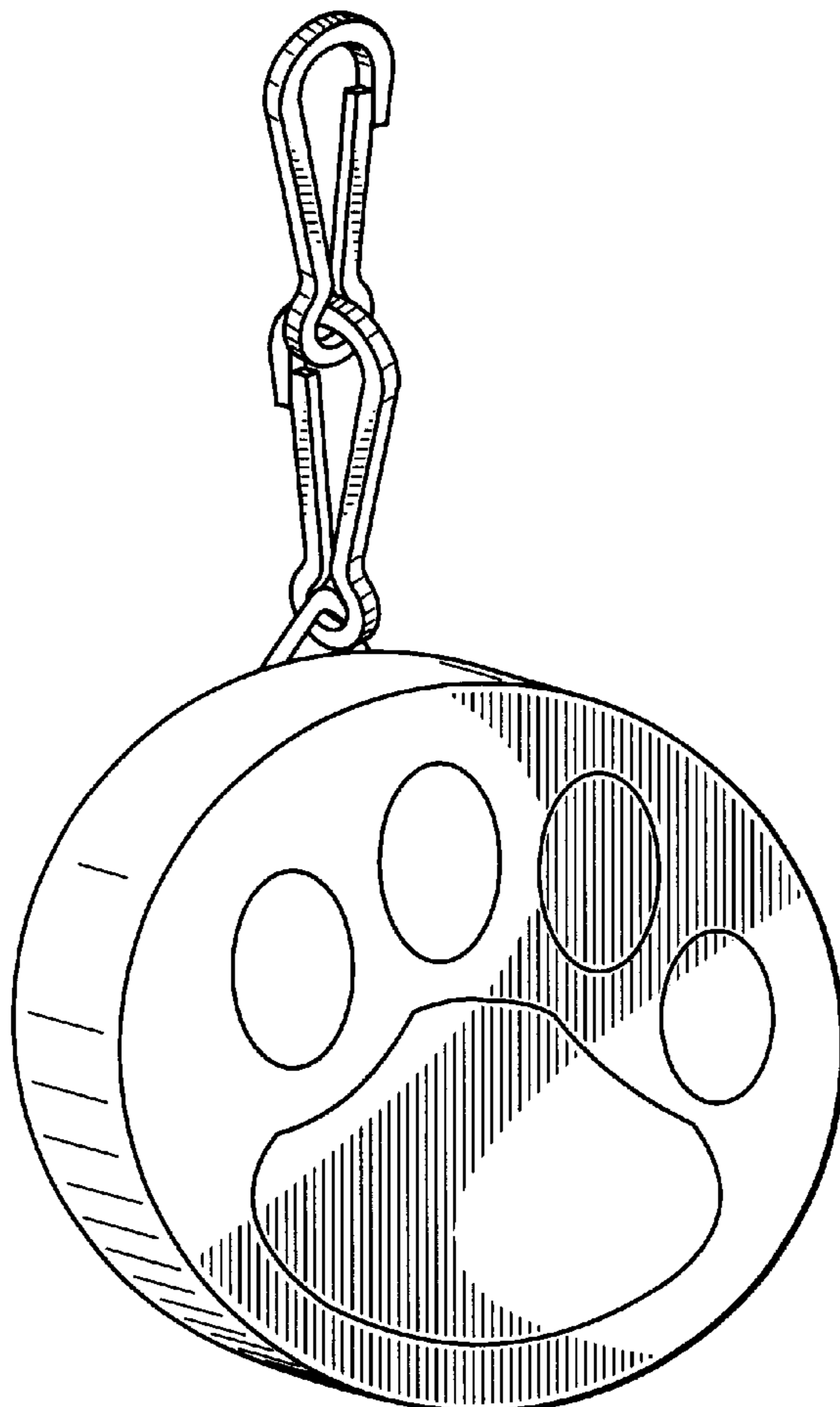
(57) **CLAIM**

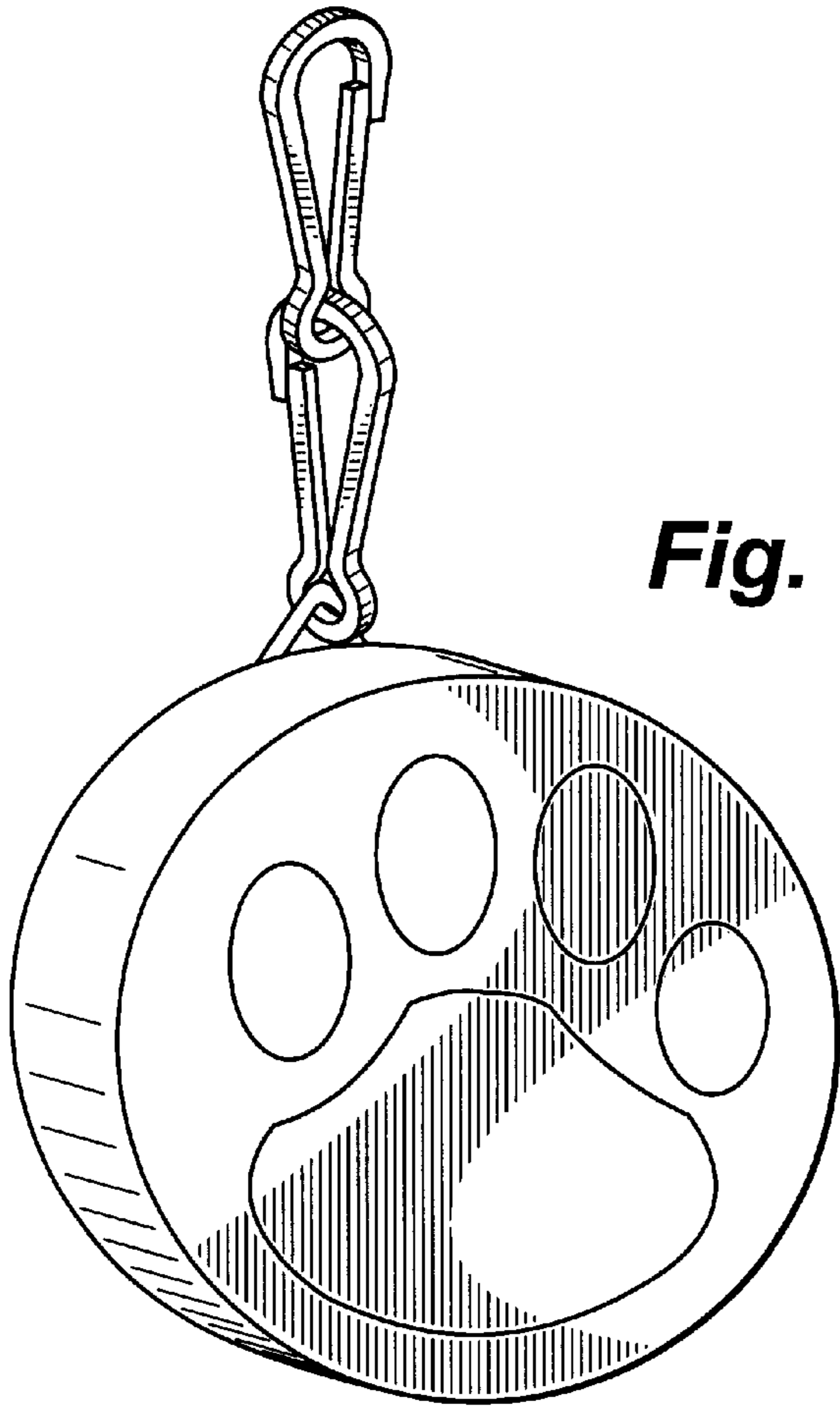
I claim the ornamental design for a pet collar light with paw print pattern, as shown.

**DESCRIPTION**

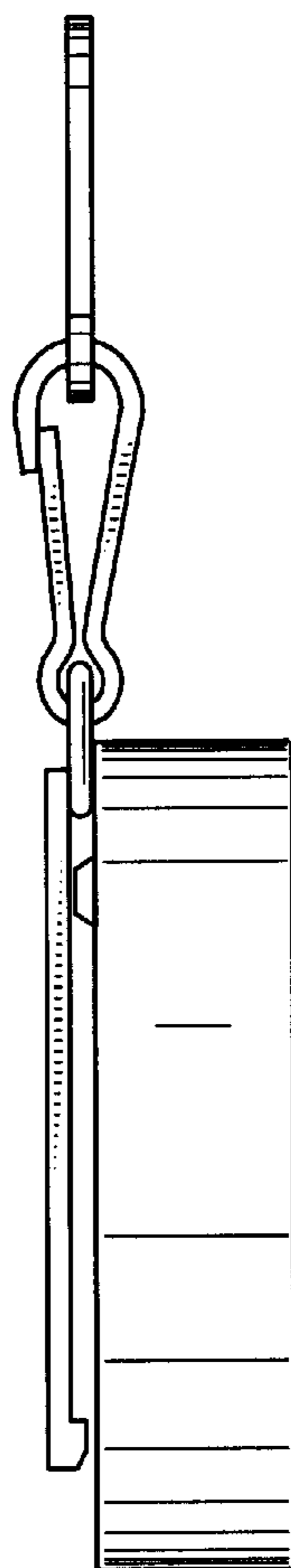
FIG. 1 is a front perspective view of a pet collar light with paw print pattern showing my new design;

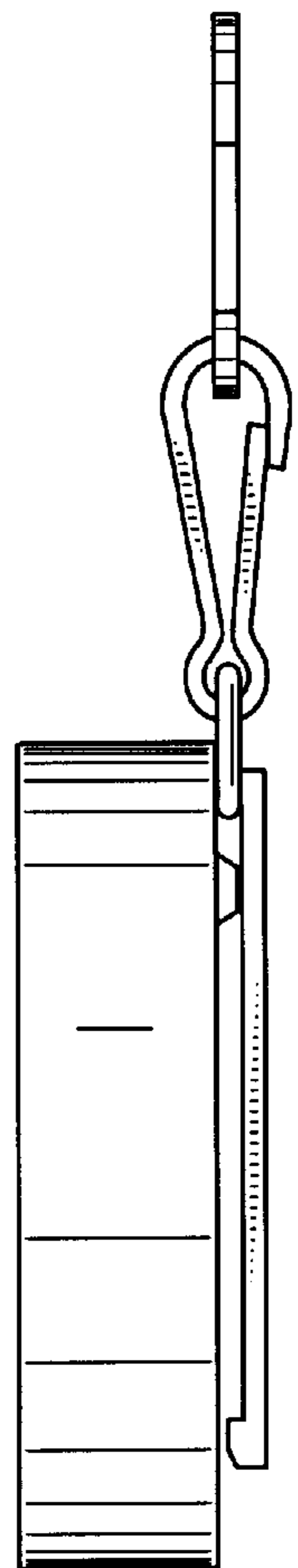




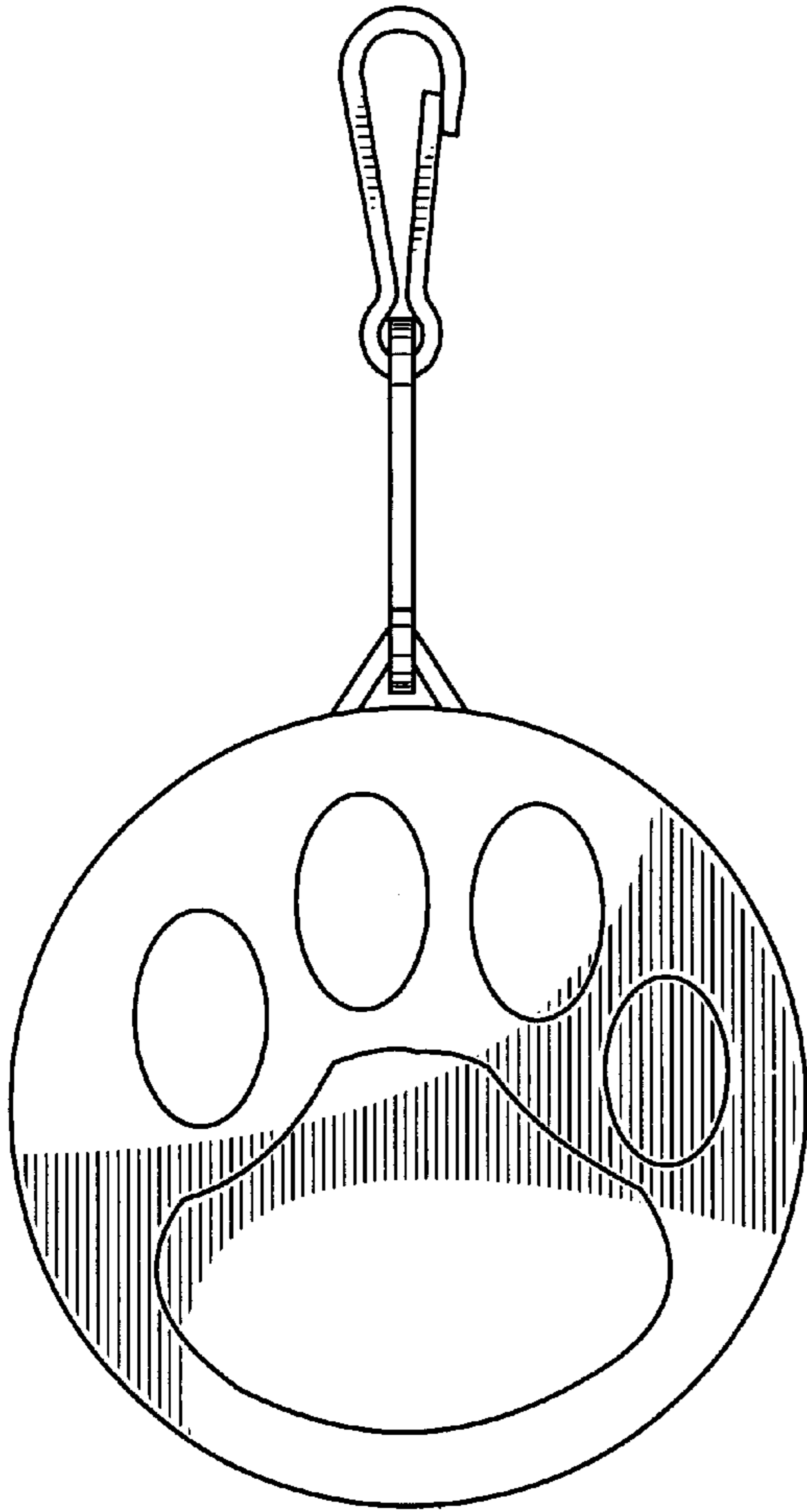

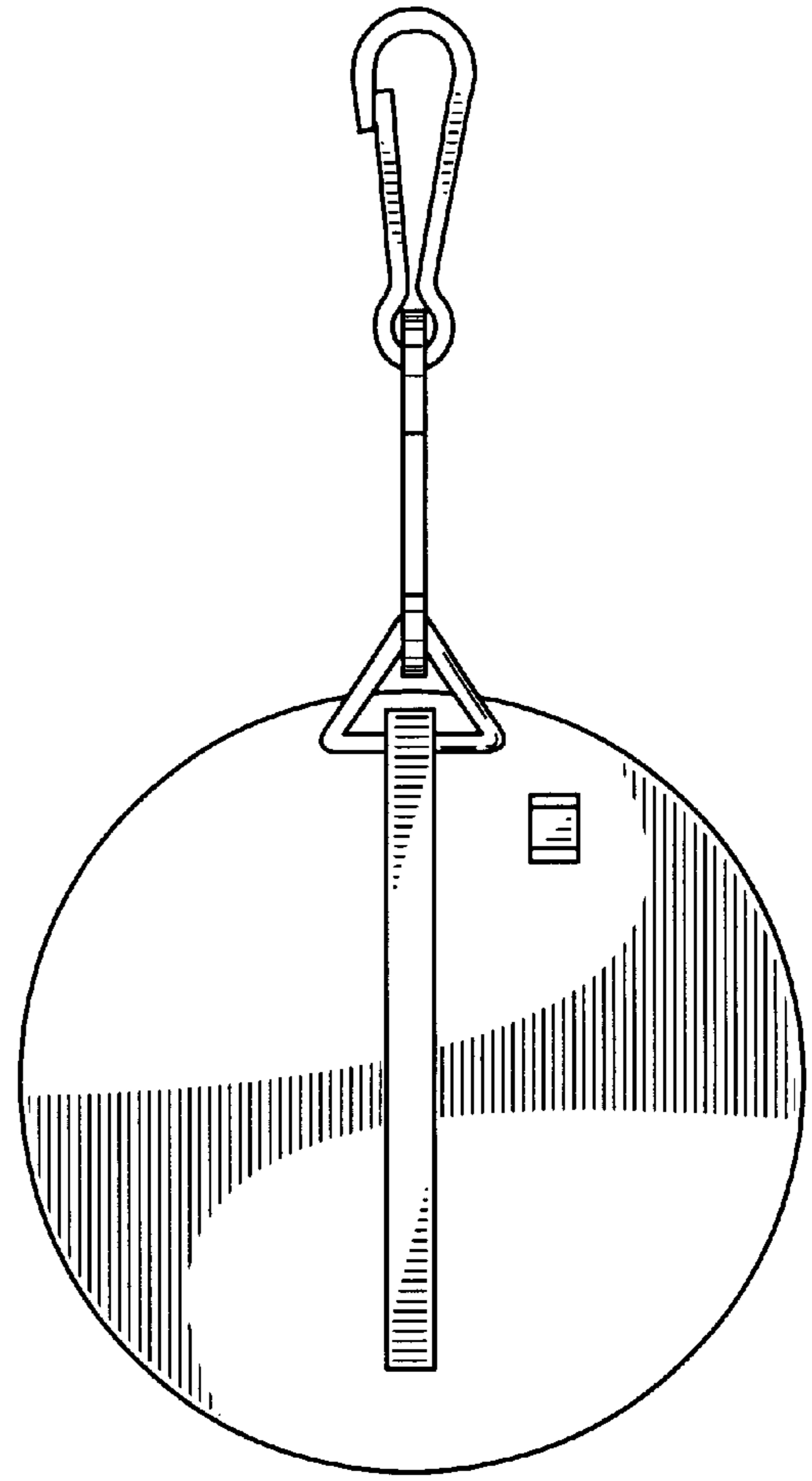

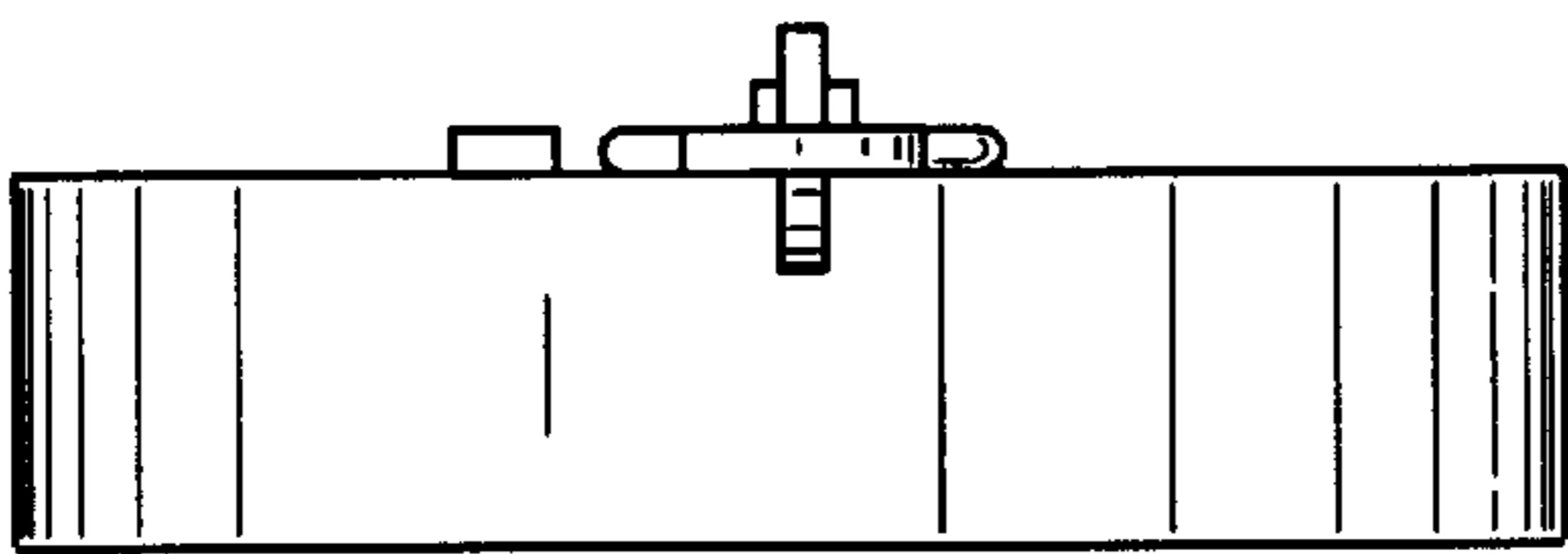

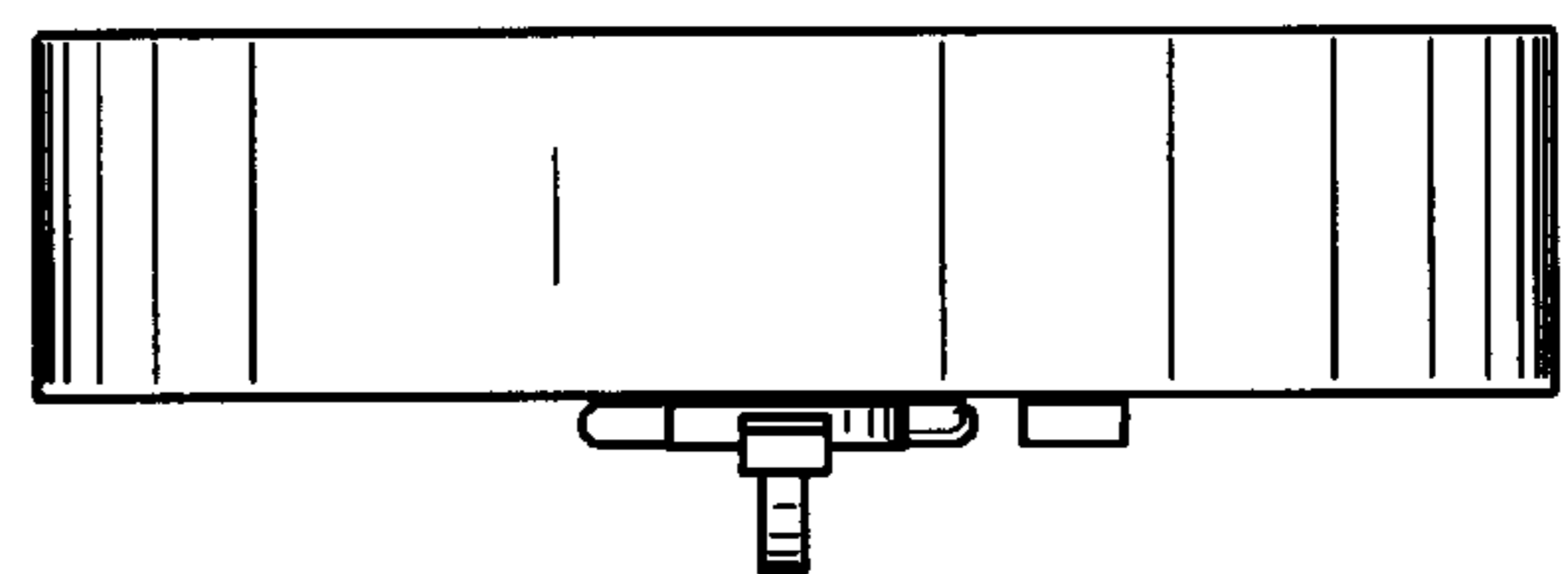
