The ornamental design for a cigar lighter, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of the cigar lighter showing my new design;

FIG. 13 is a right side elevational view thereof;

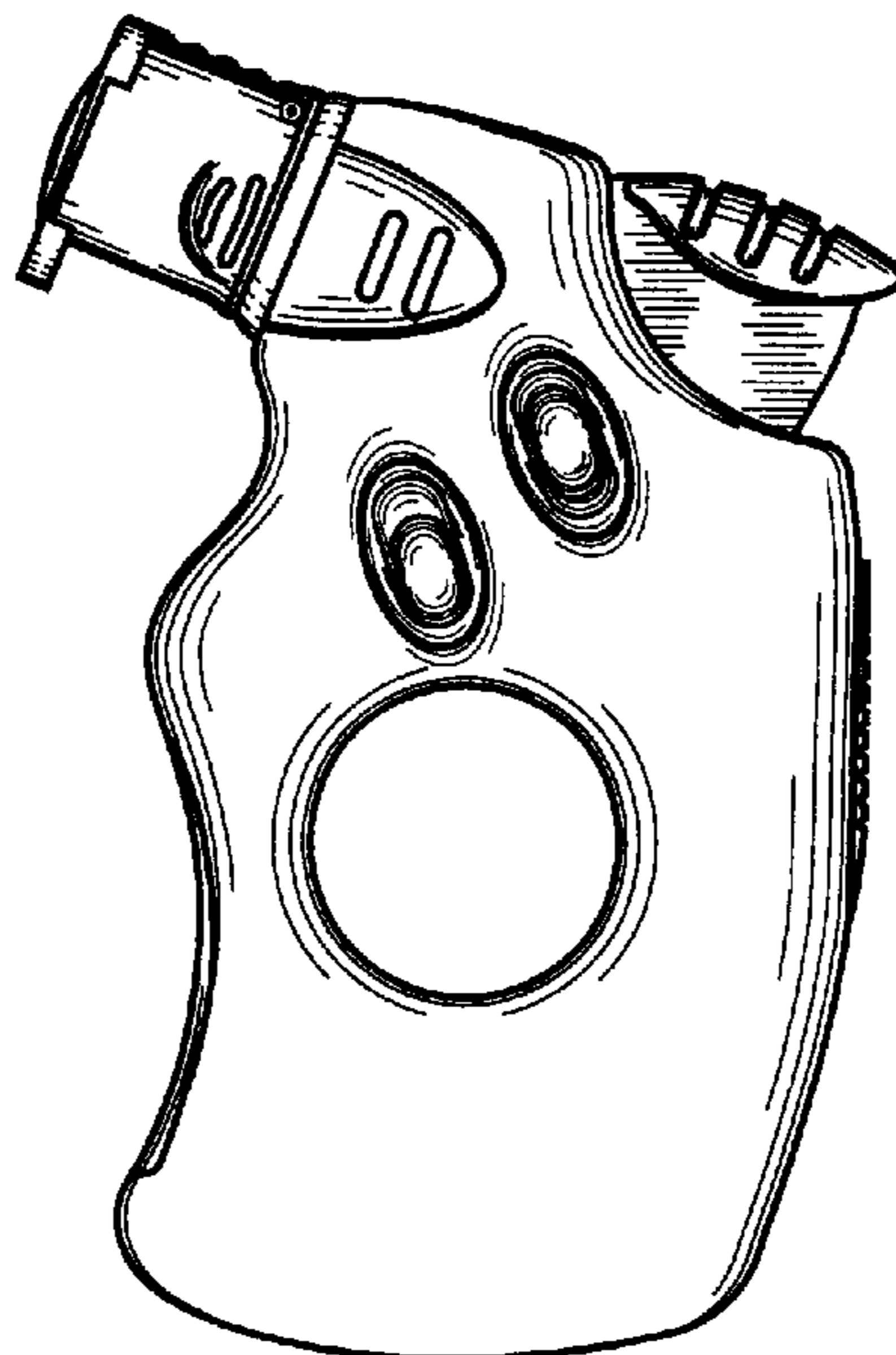
FIG. 14 is a left side elevational view thereof;

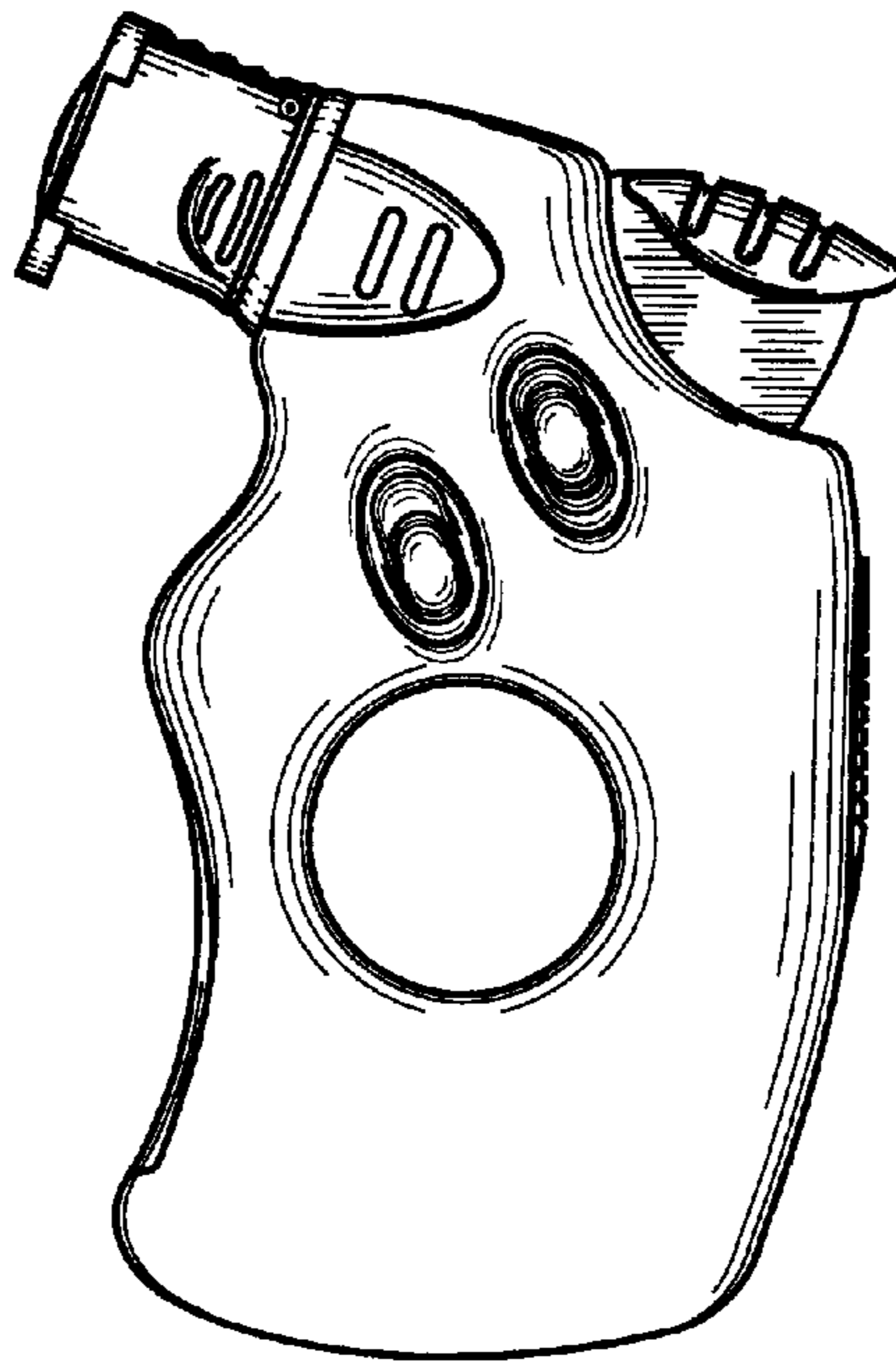

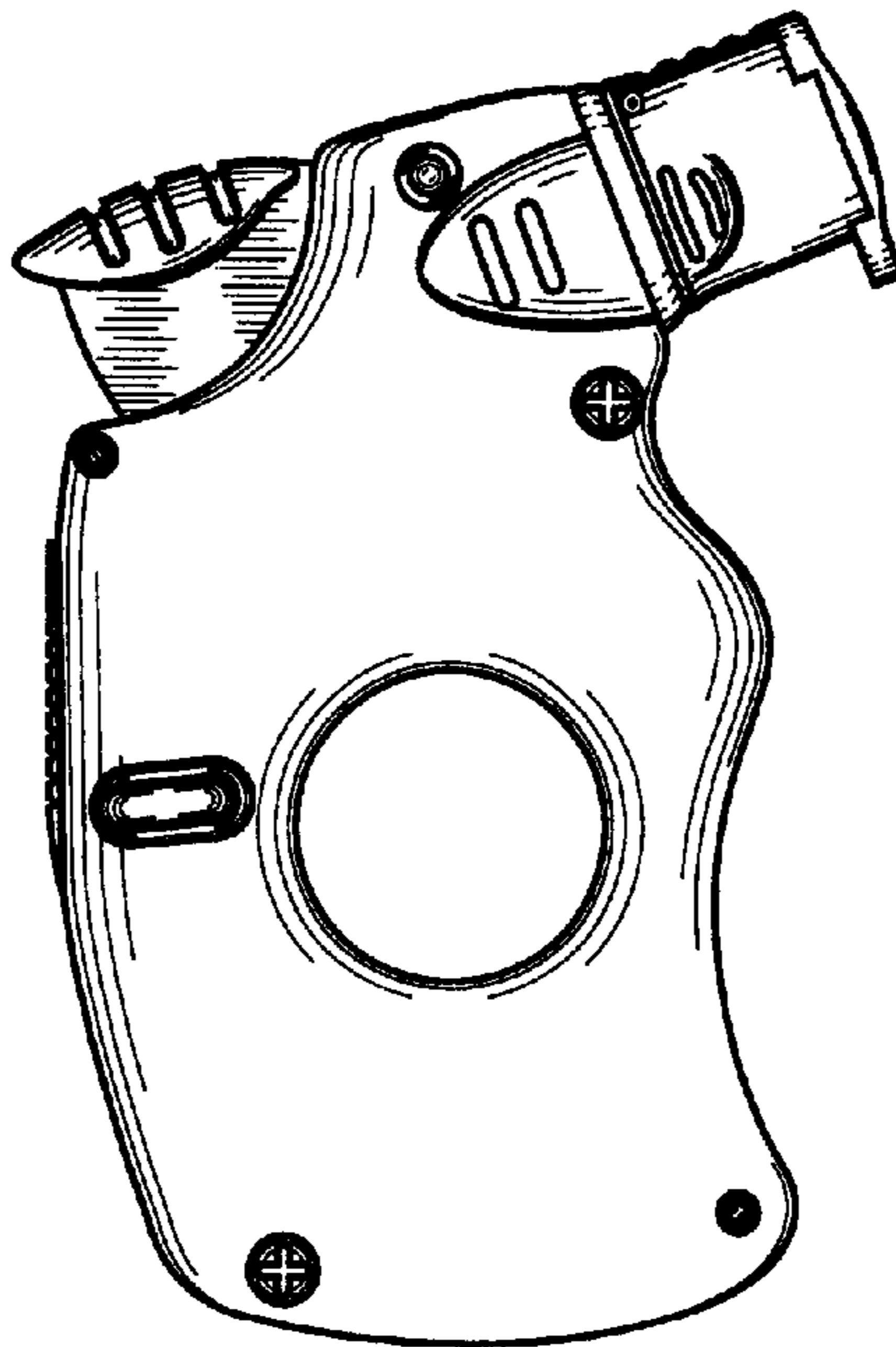

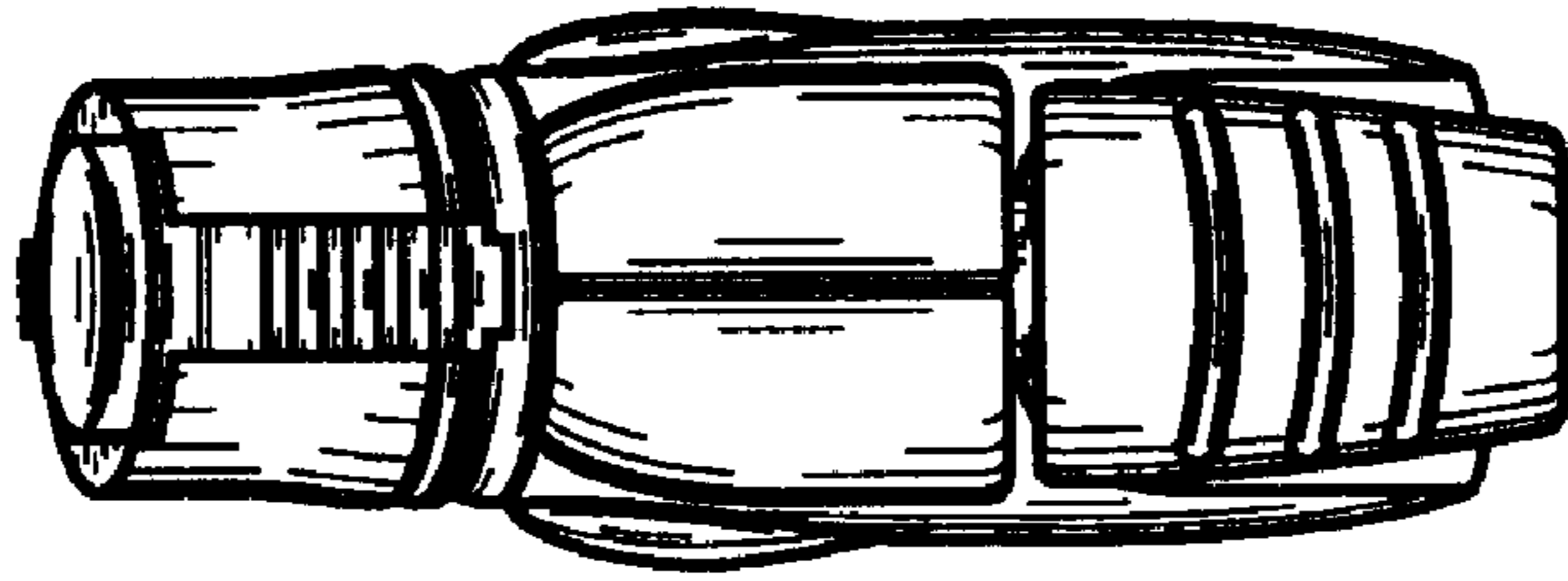

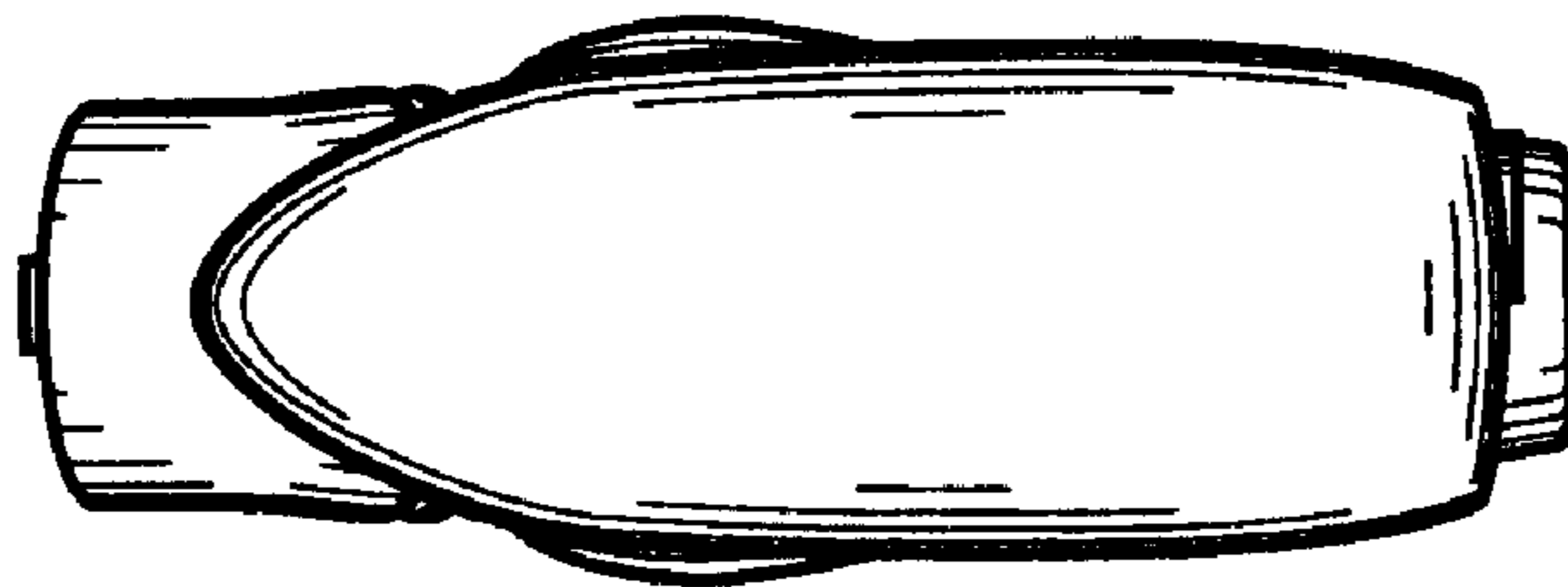

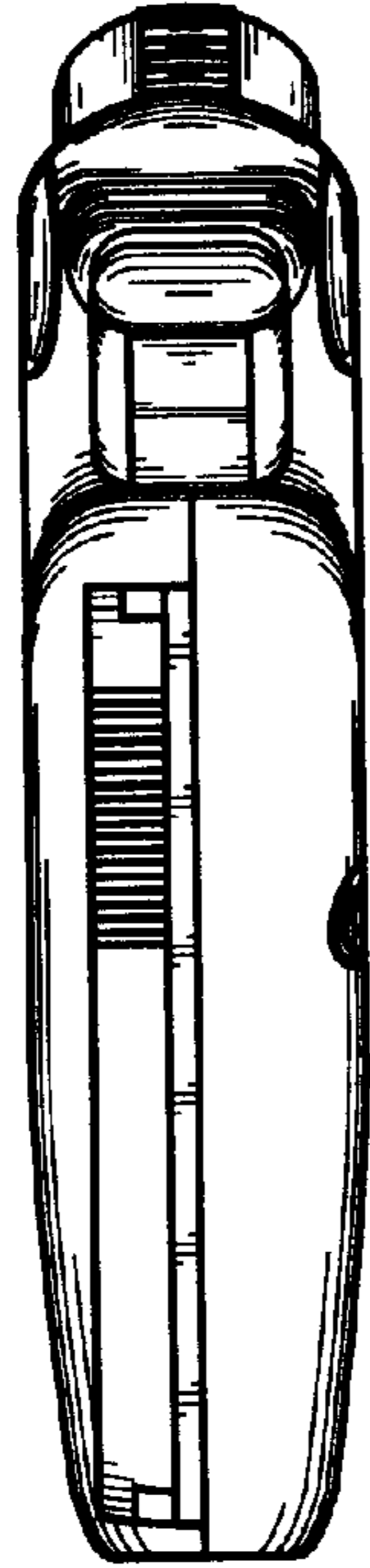

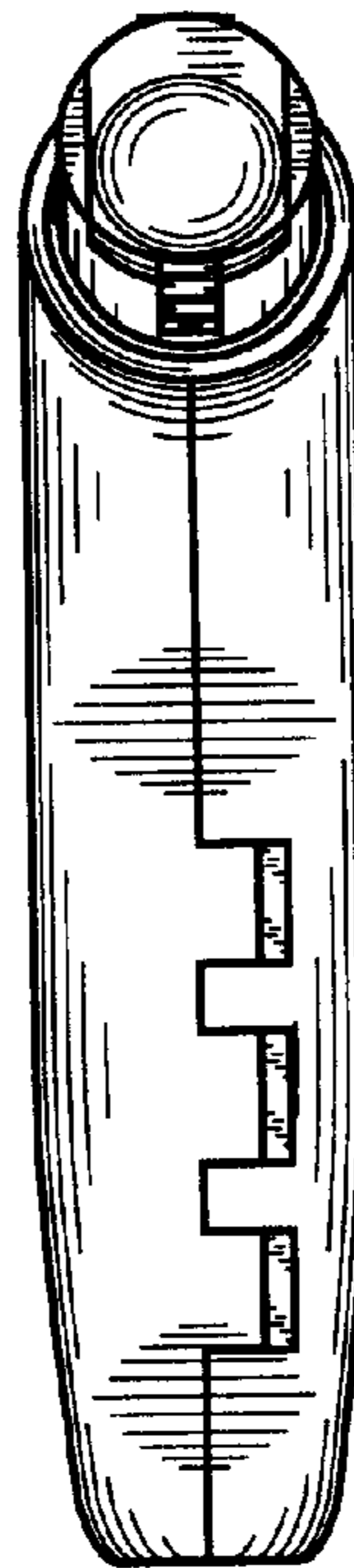

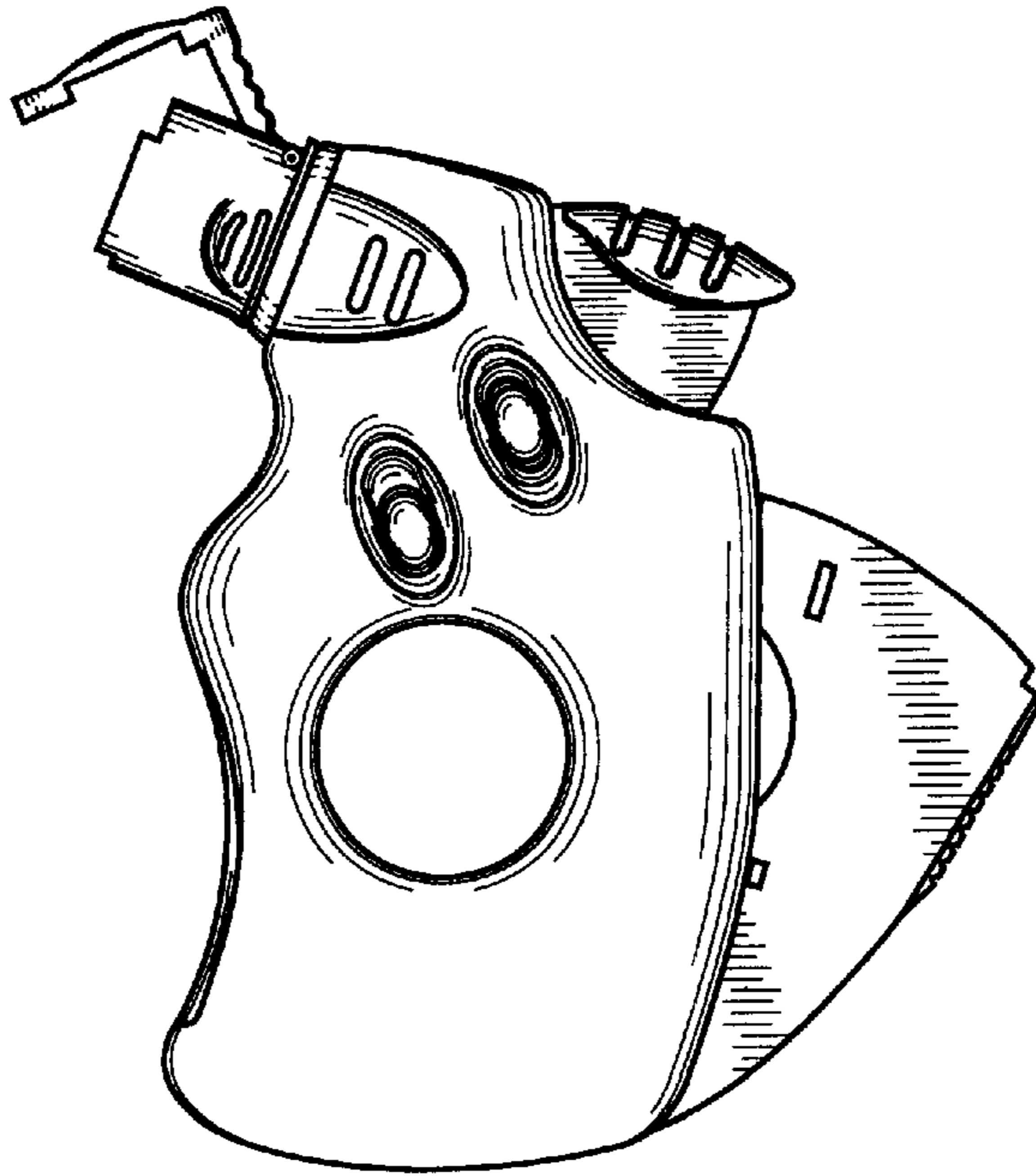

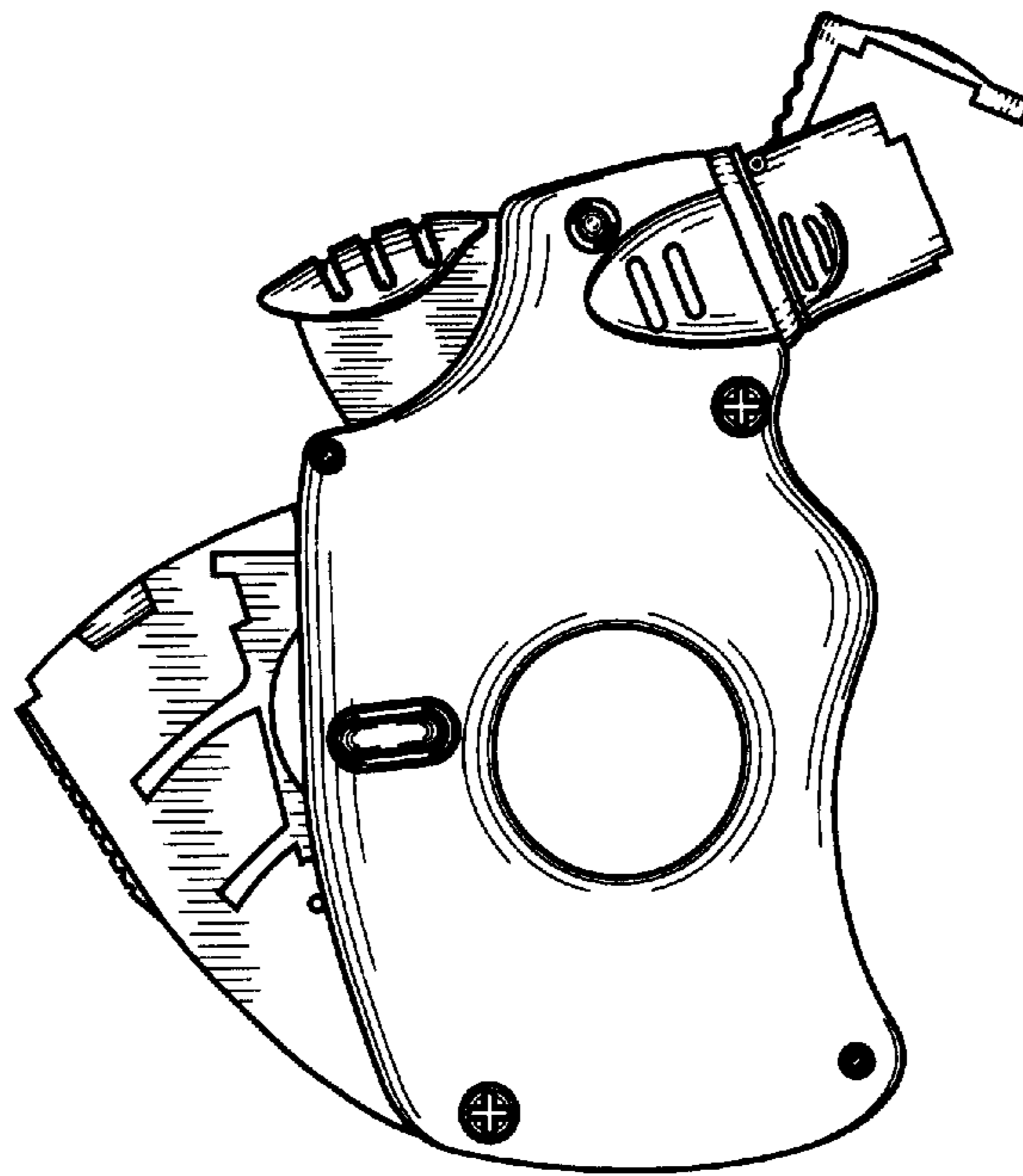

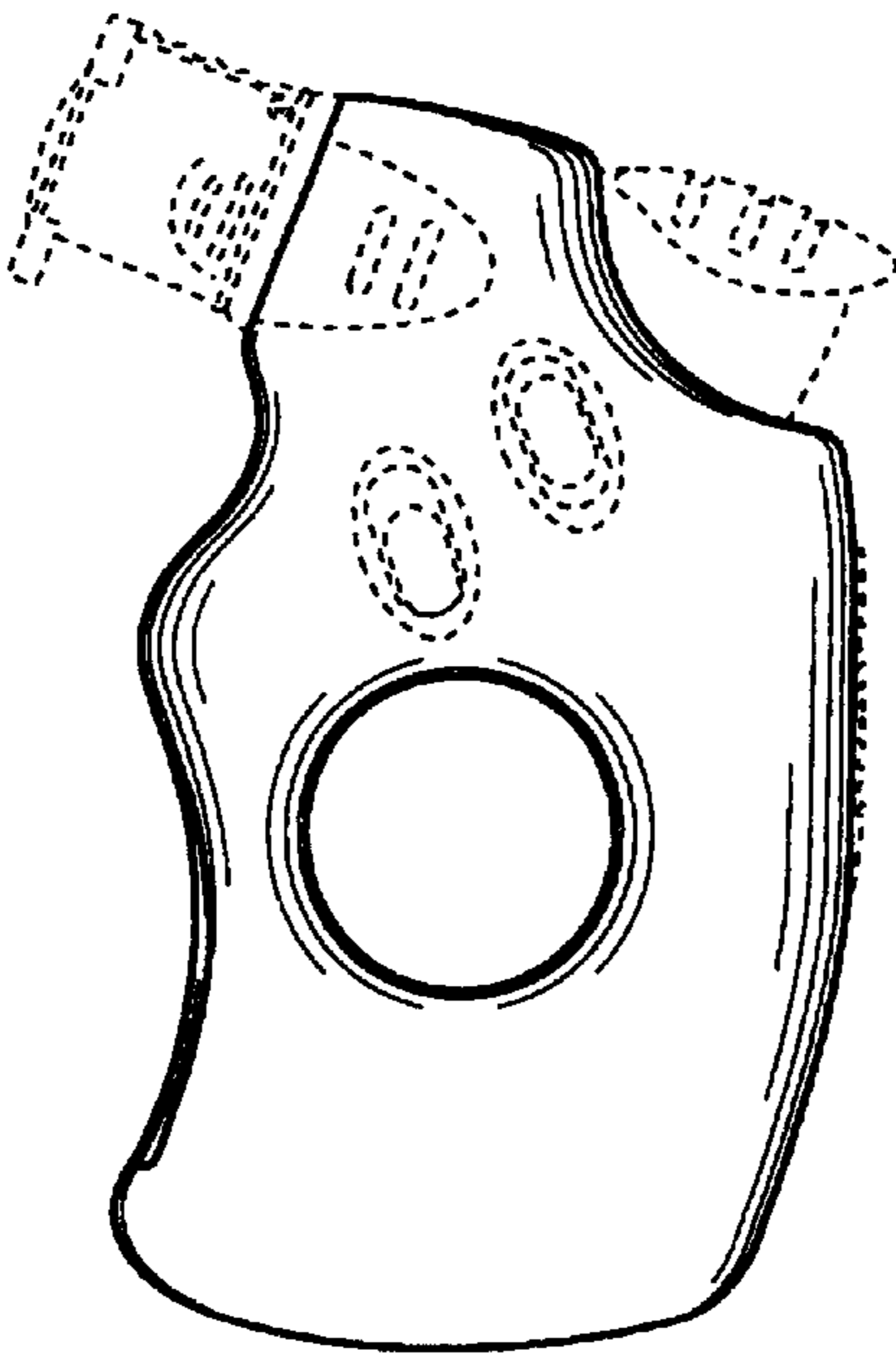

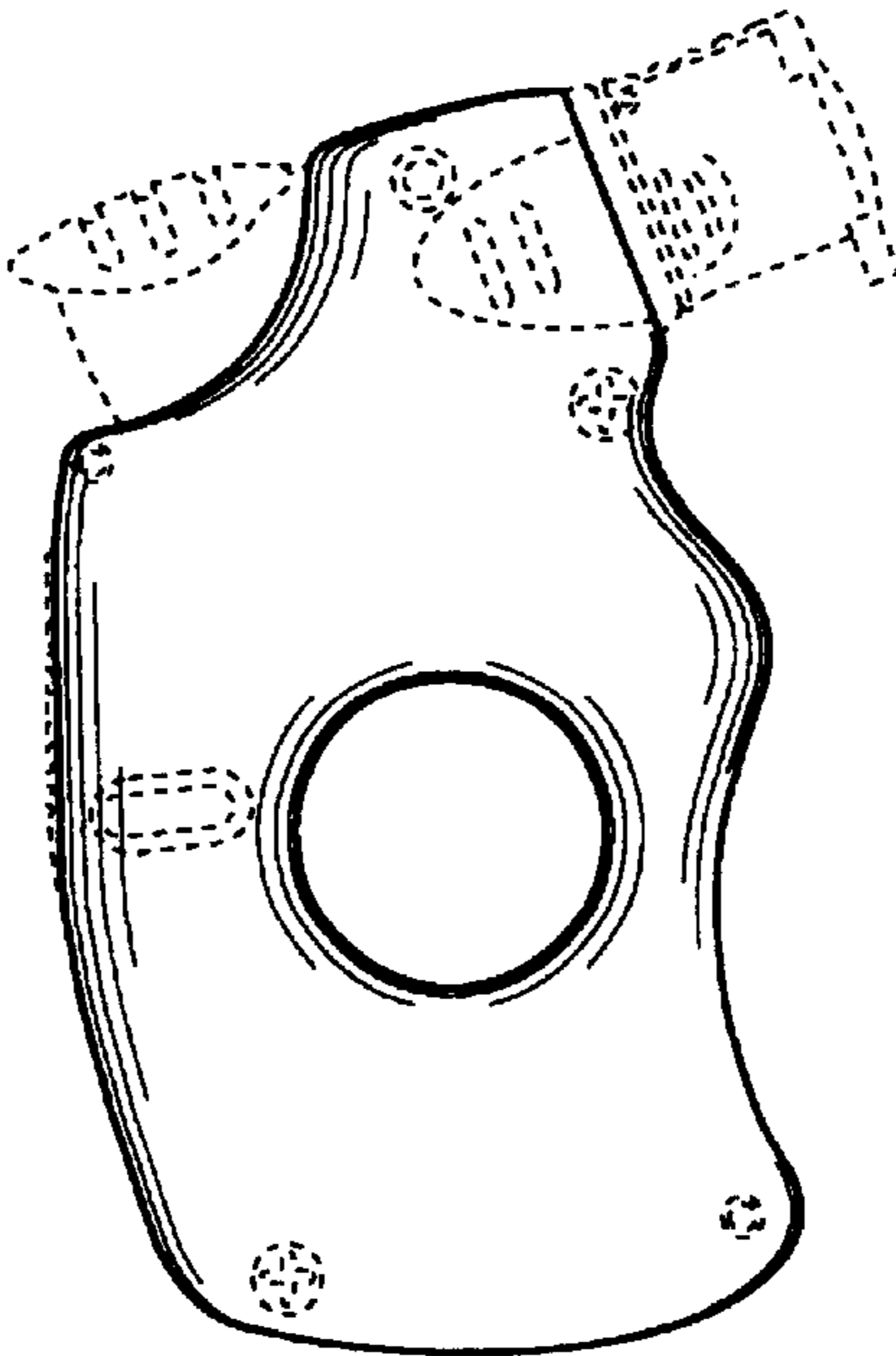

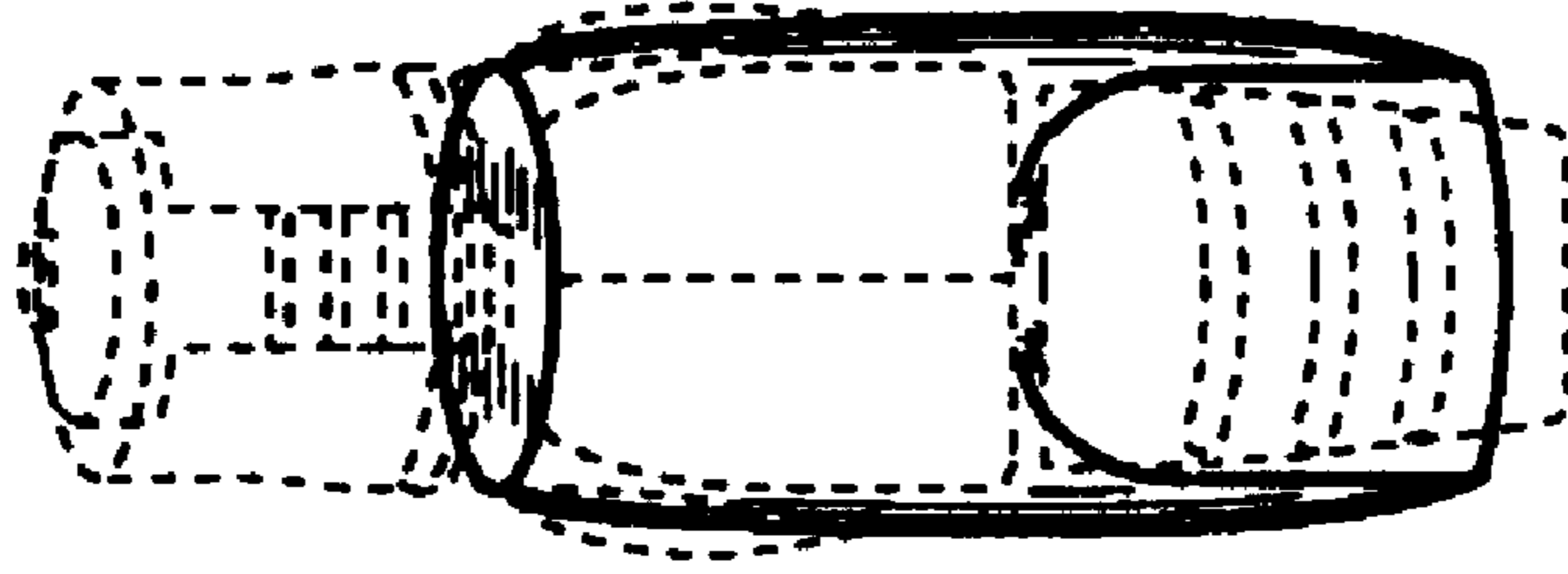

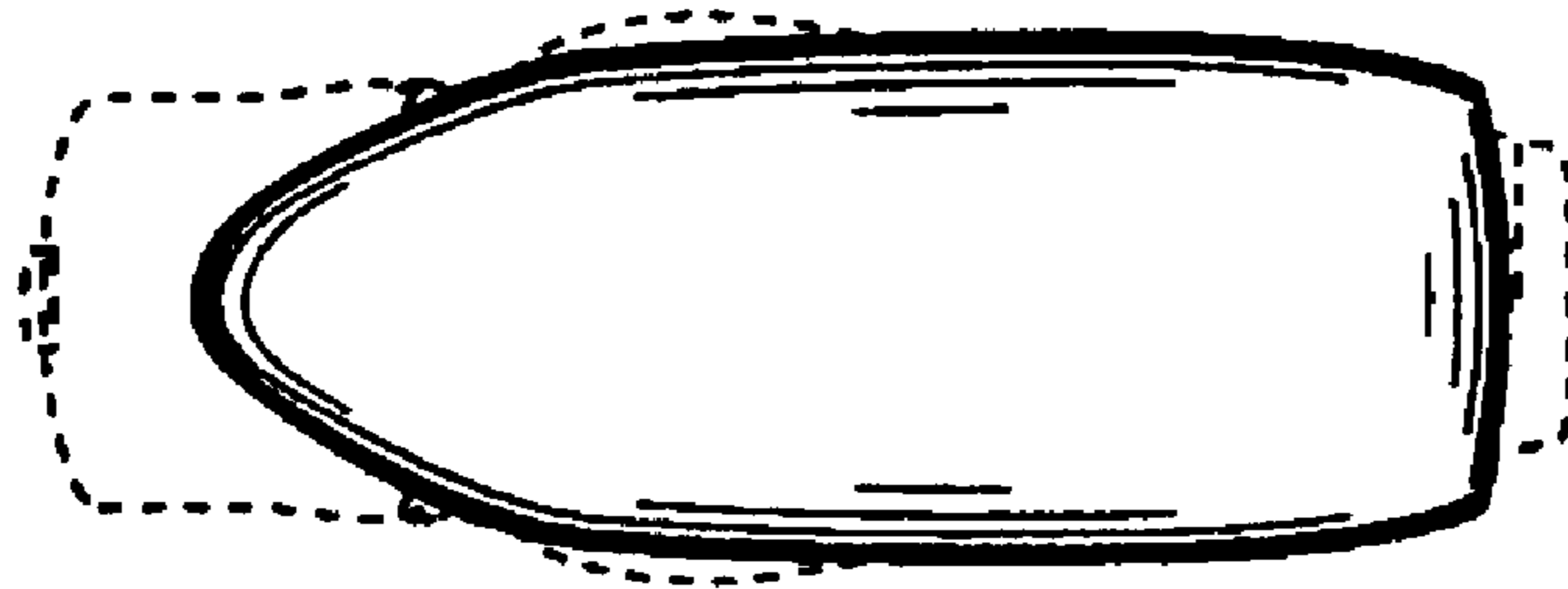

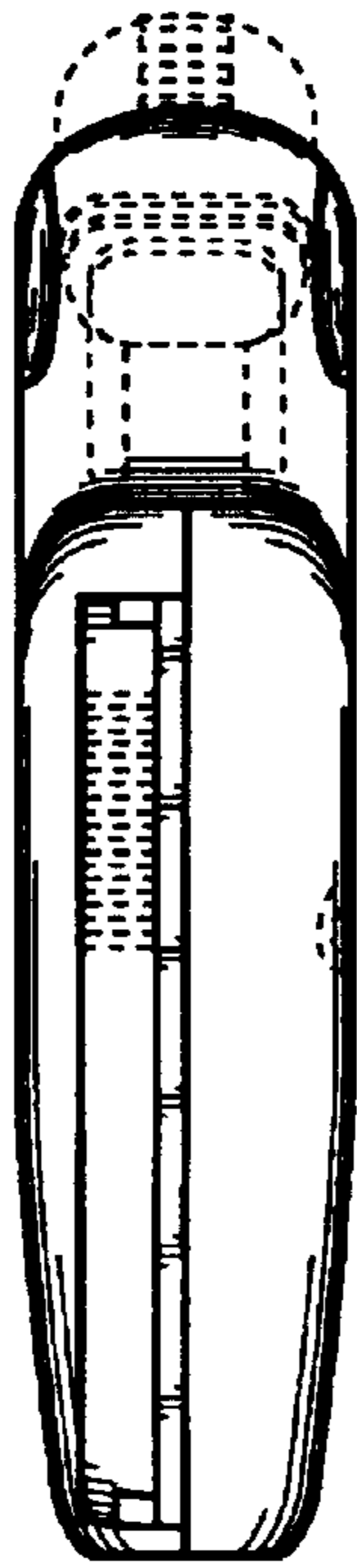

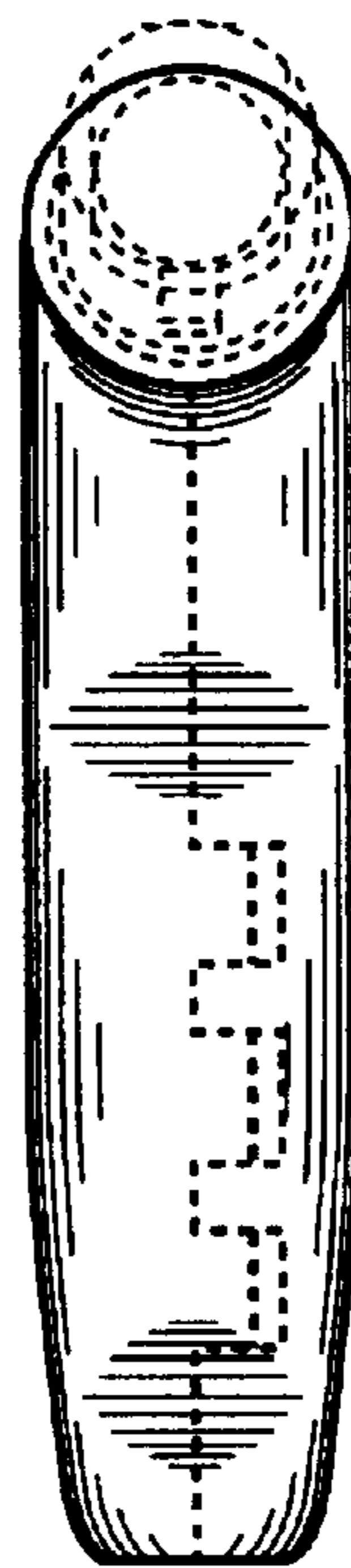

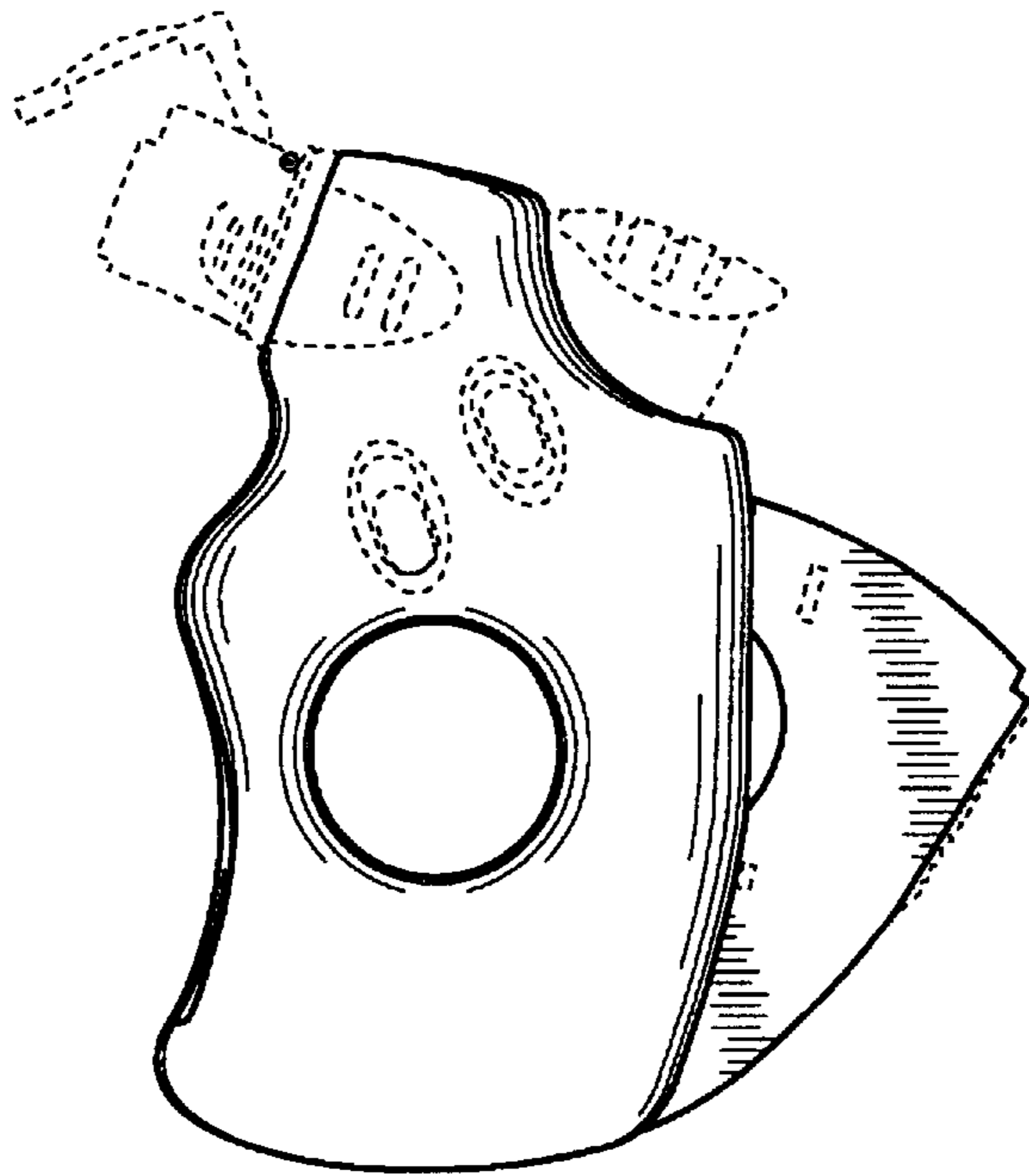

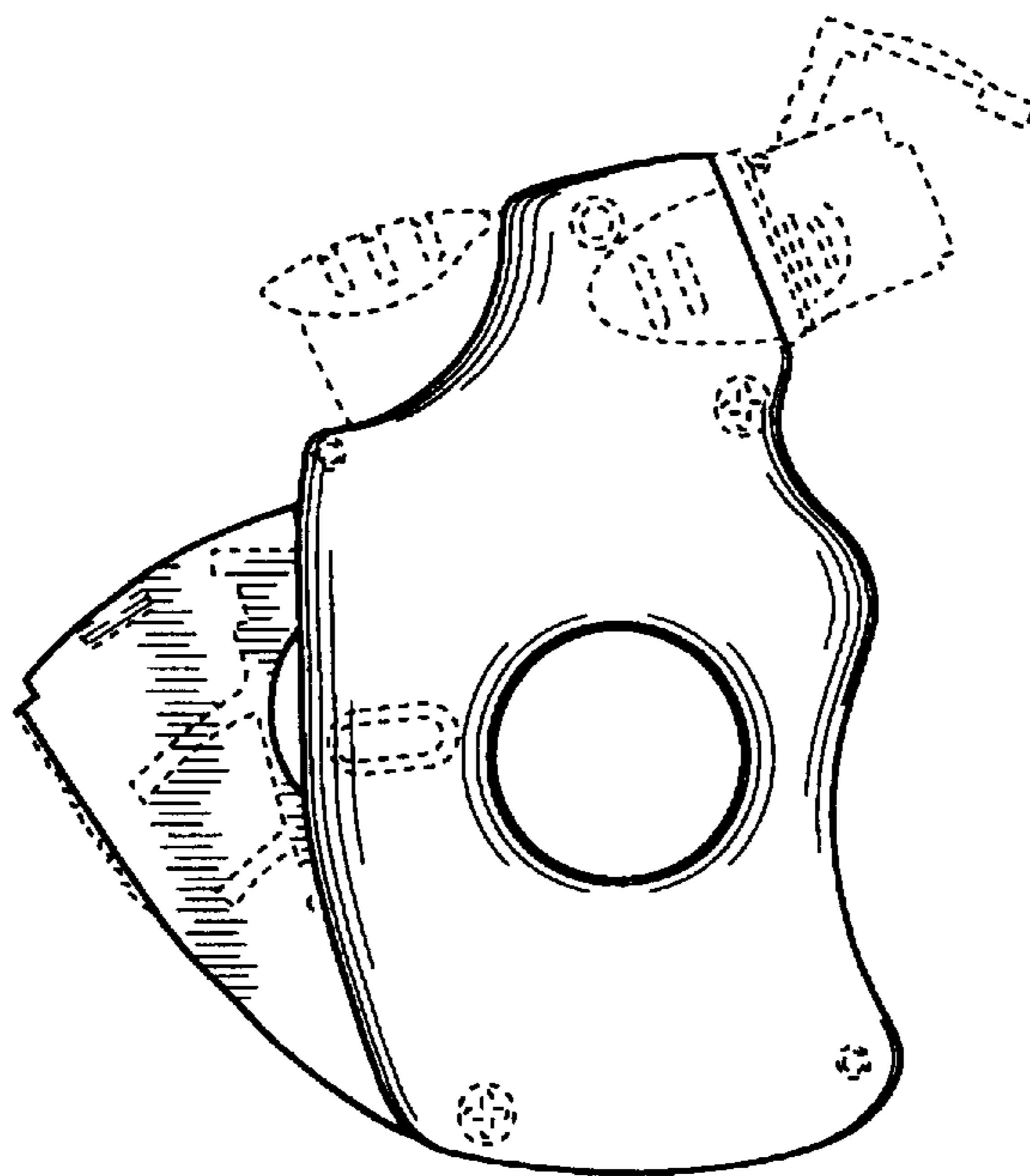
