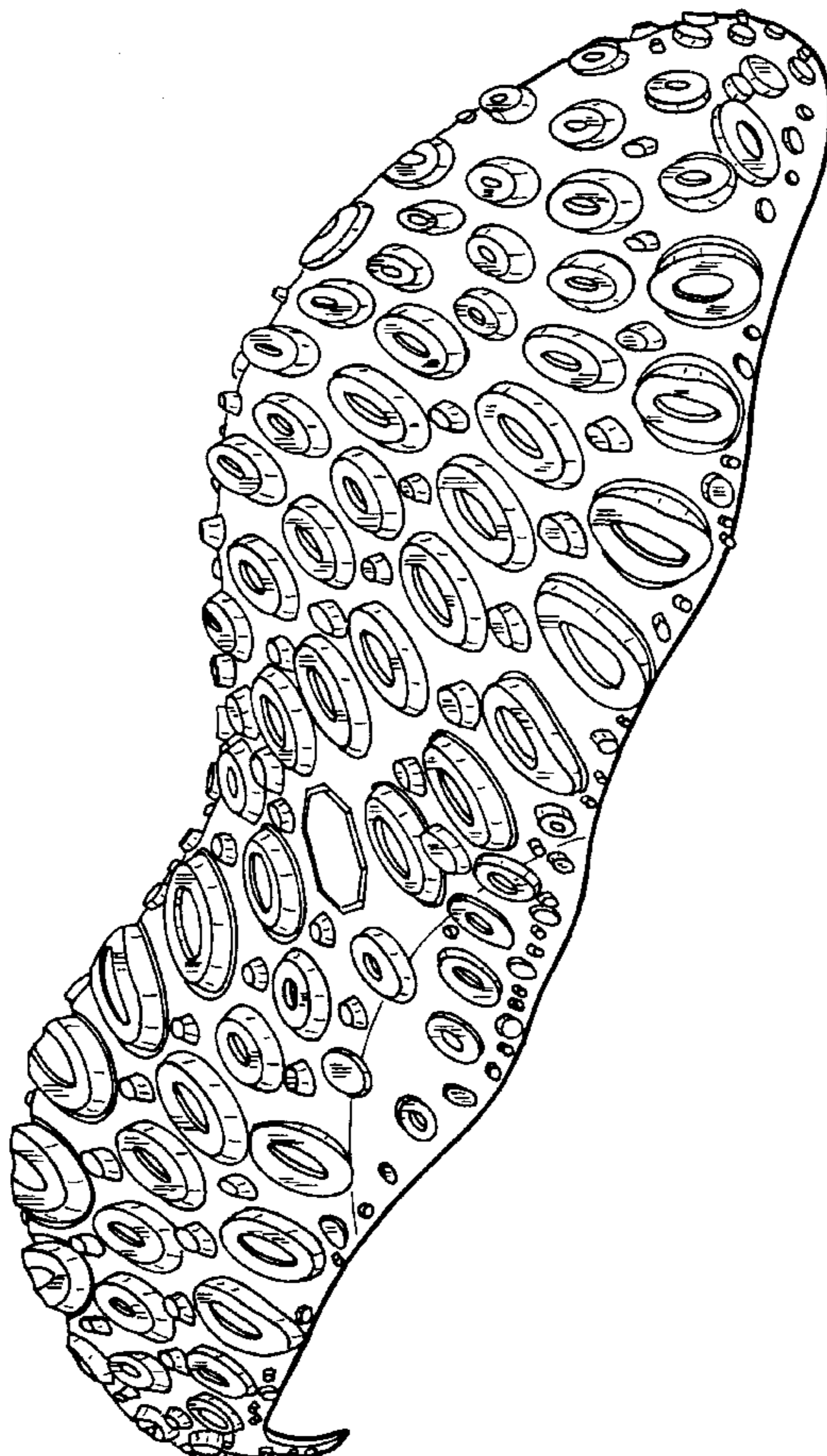
(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoe sole, showing my new design;  
 FIG. 2 is a side elevation view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a side elevation view thereof opposite to the side elevation view of FIG. 2;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a front elevation view thereof; and,  
 FIG. 7 is a rear elevation view thereof.

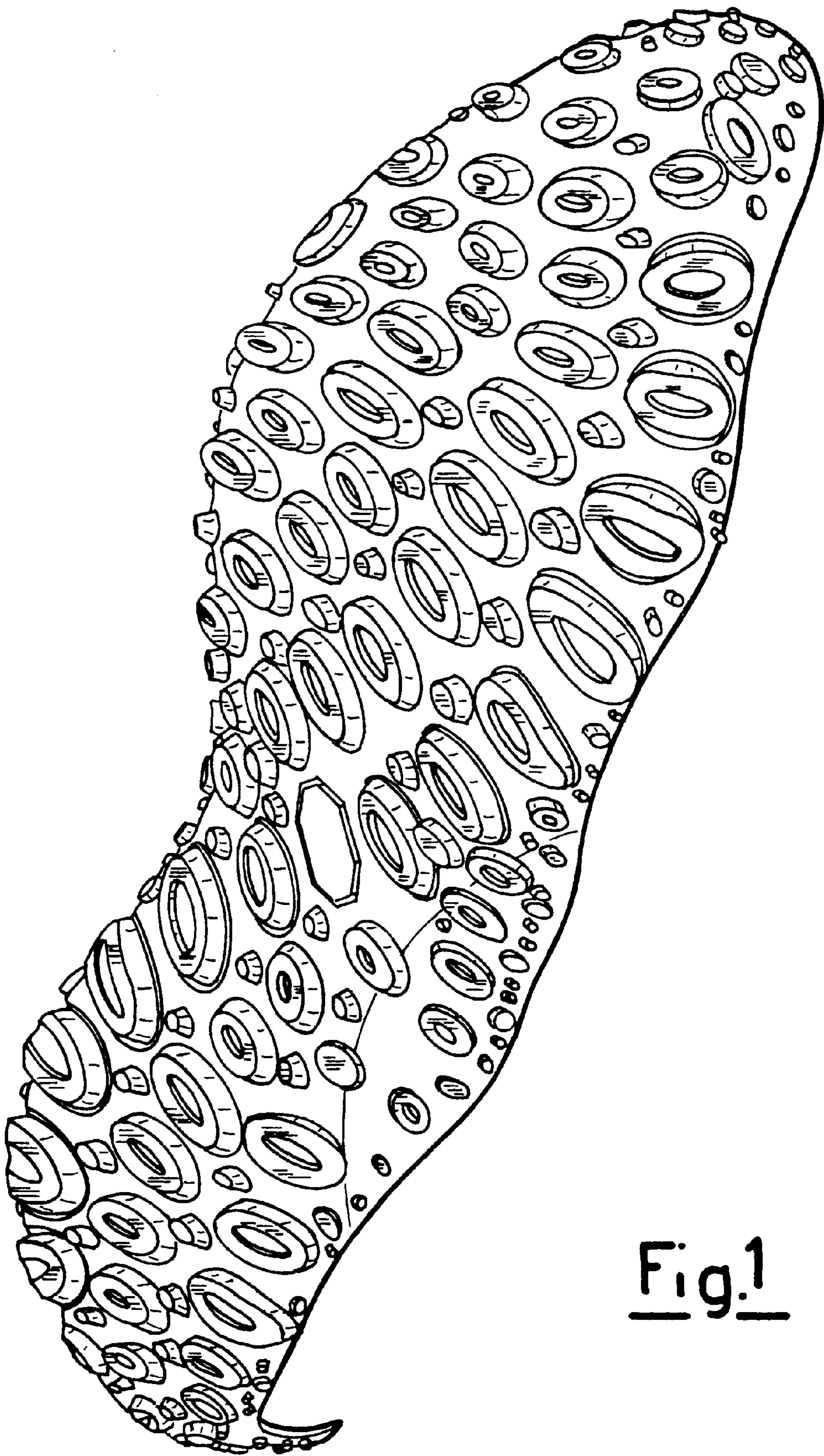

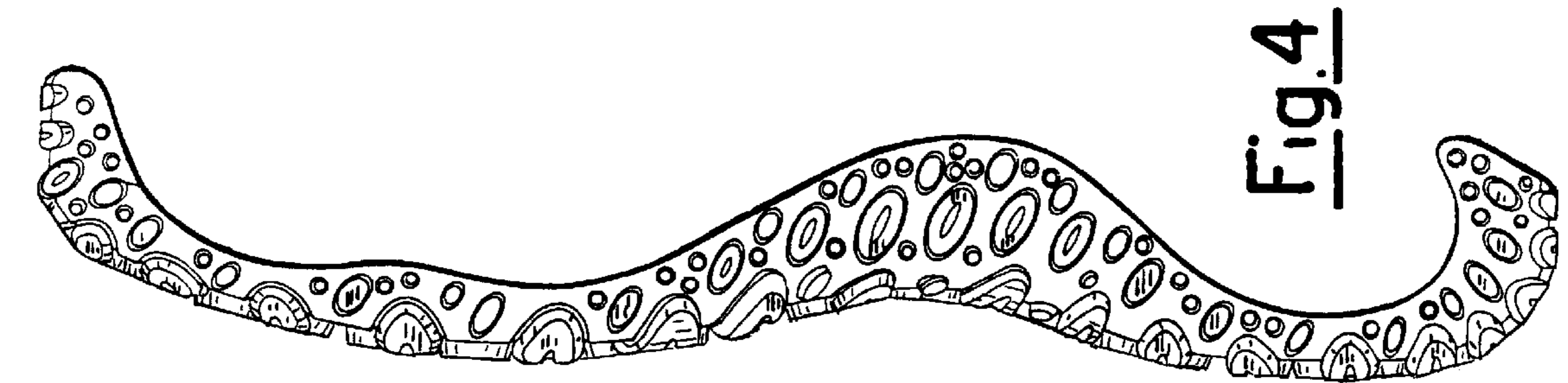

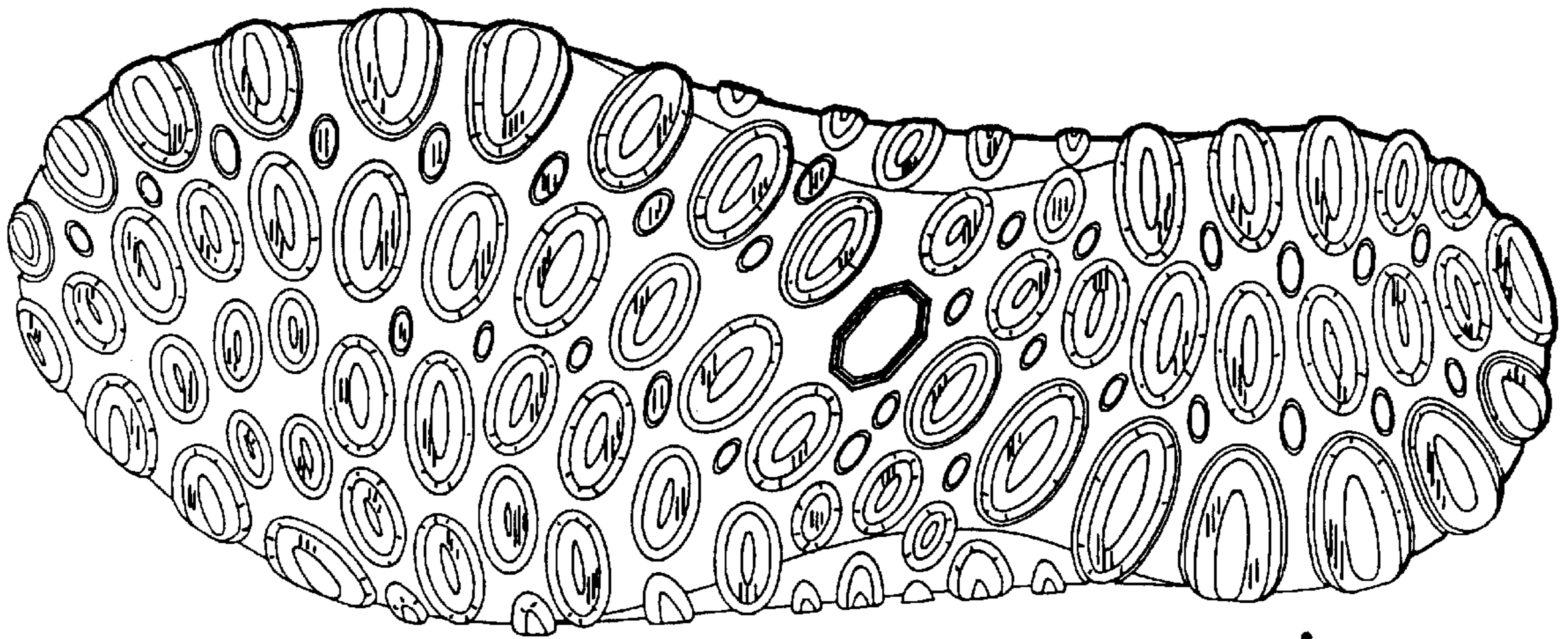

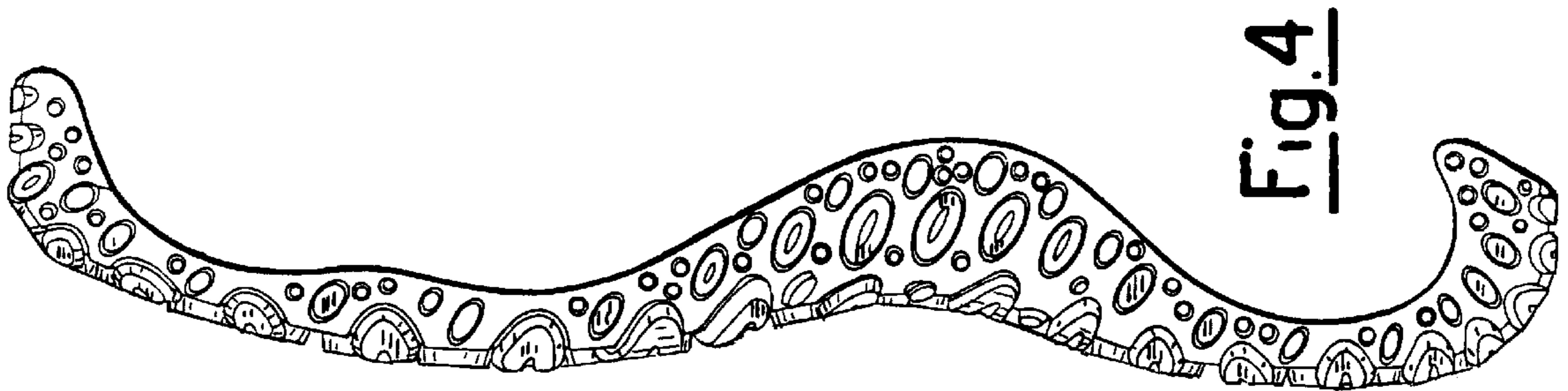

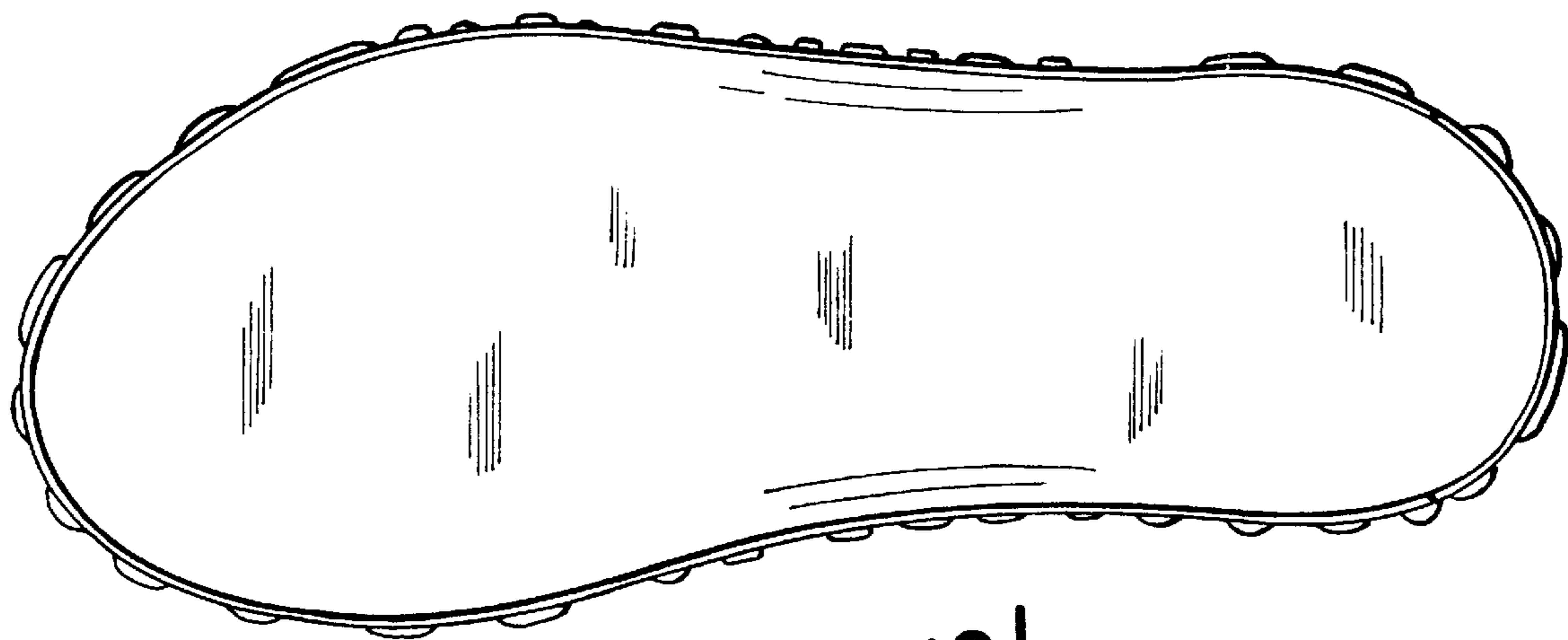

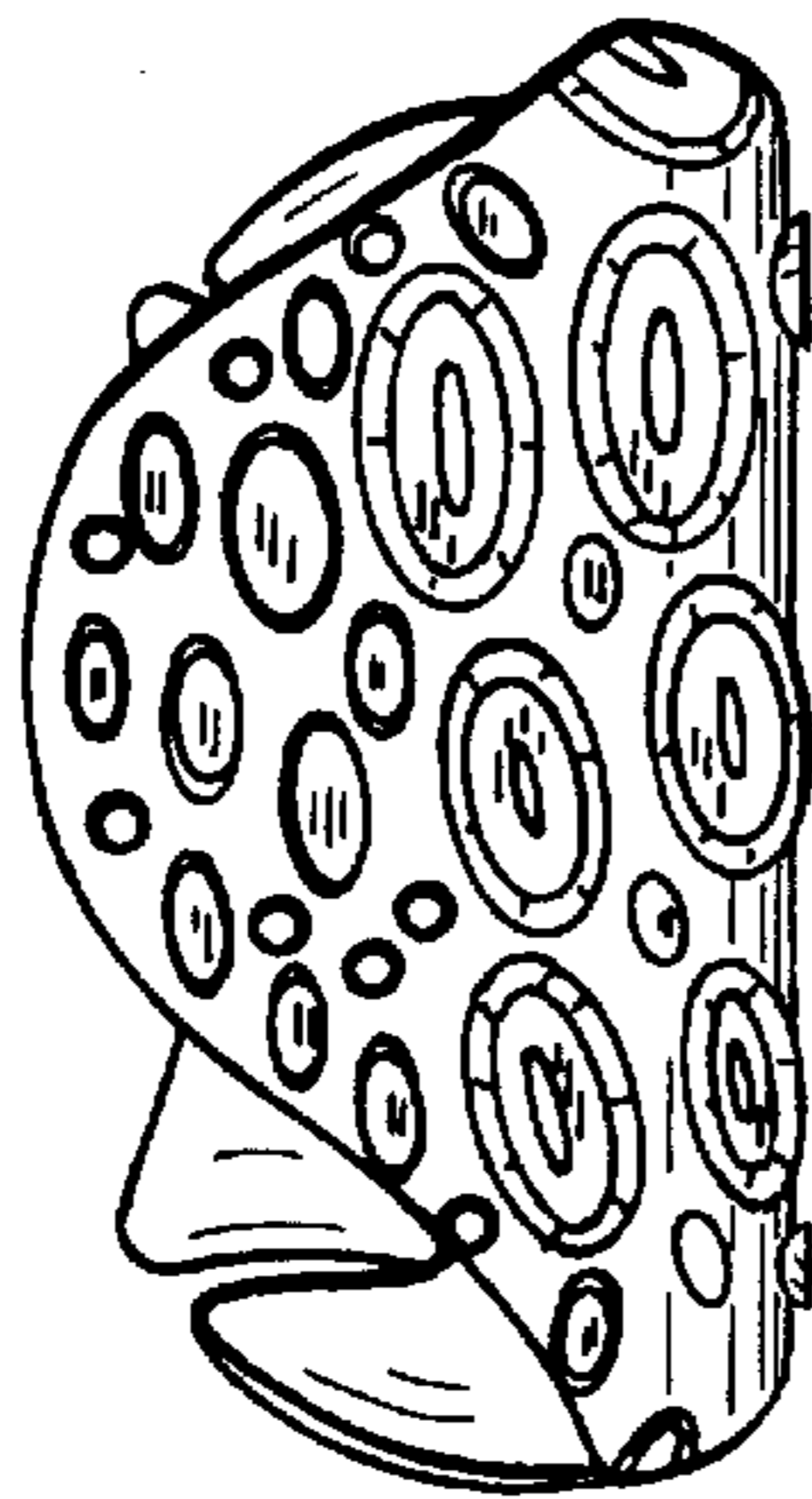

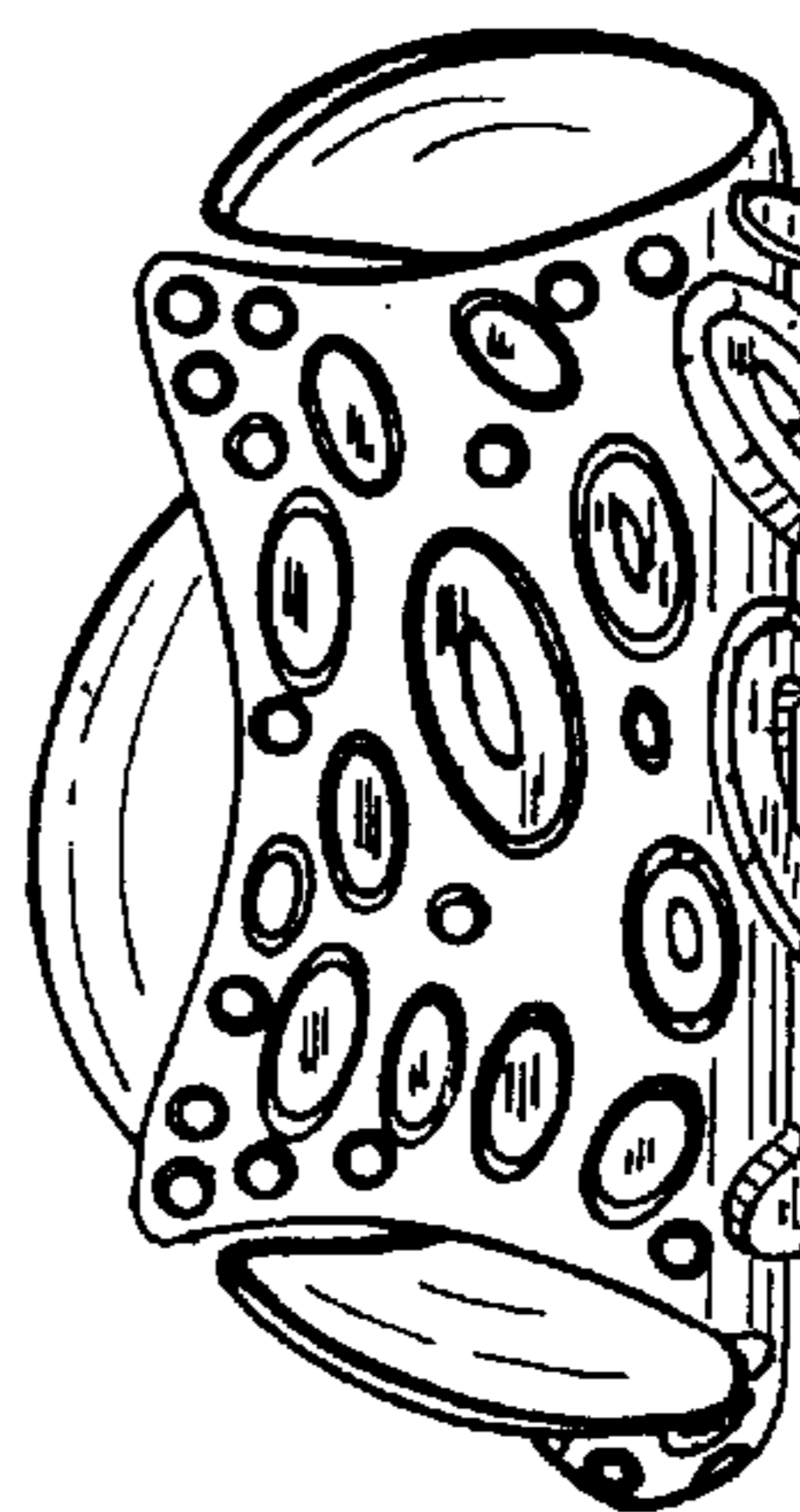
