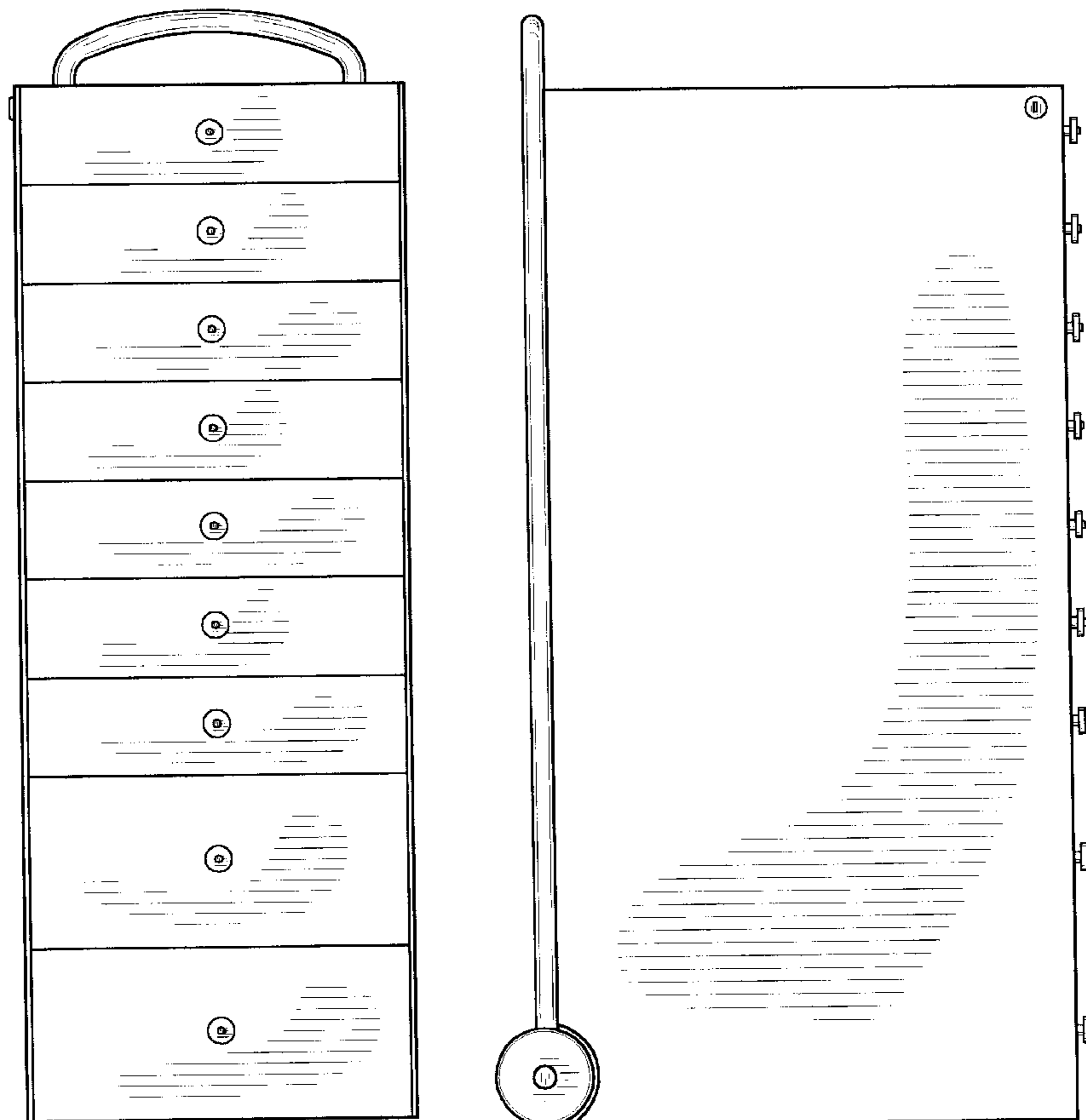
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of the portable storage unit of the present invention;
 FIG. 2 is a rear elevational view of the portable storage unit of FIG. 1;
 FIG. 3 is a left side elevational view of the portable storage unit of FIG. 1;
 FIG. 4 is a right side elevational view of the portable storage unit of FIG. 1;

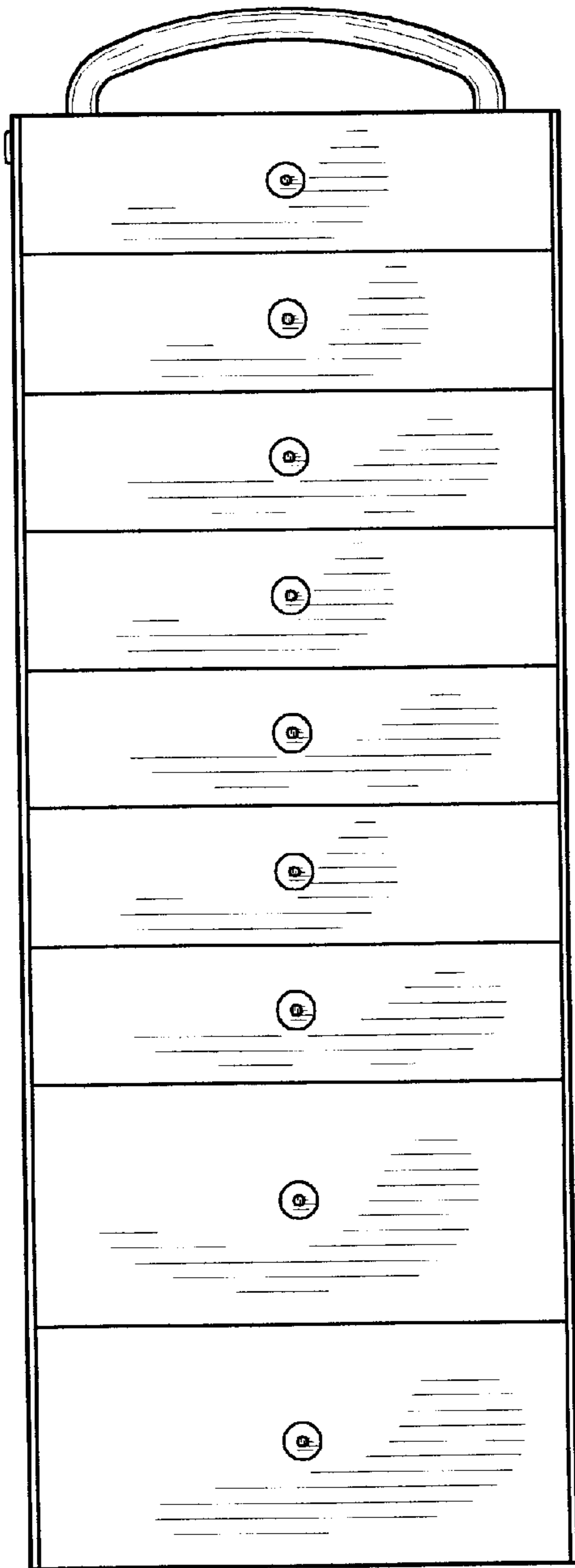

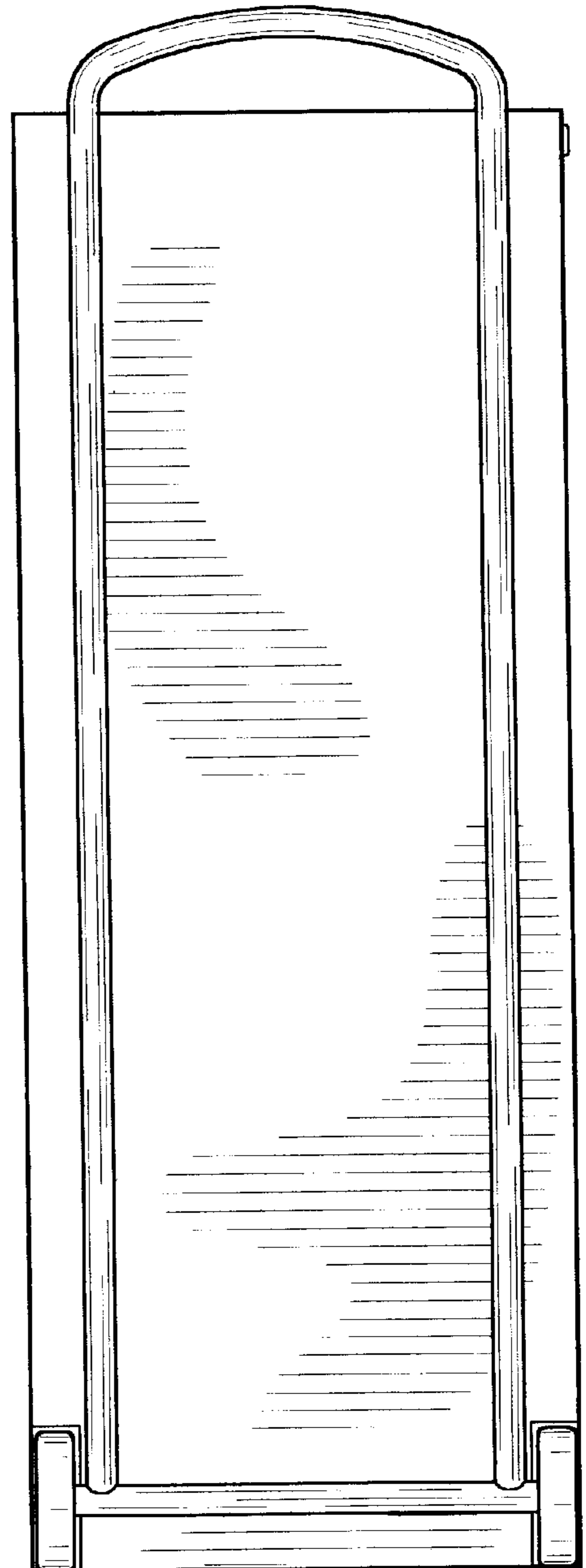

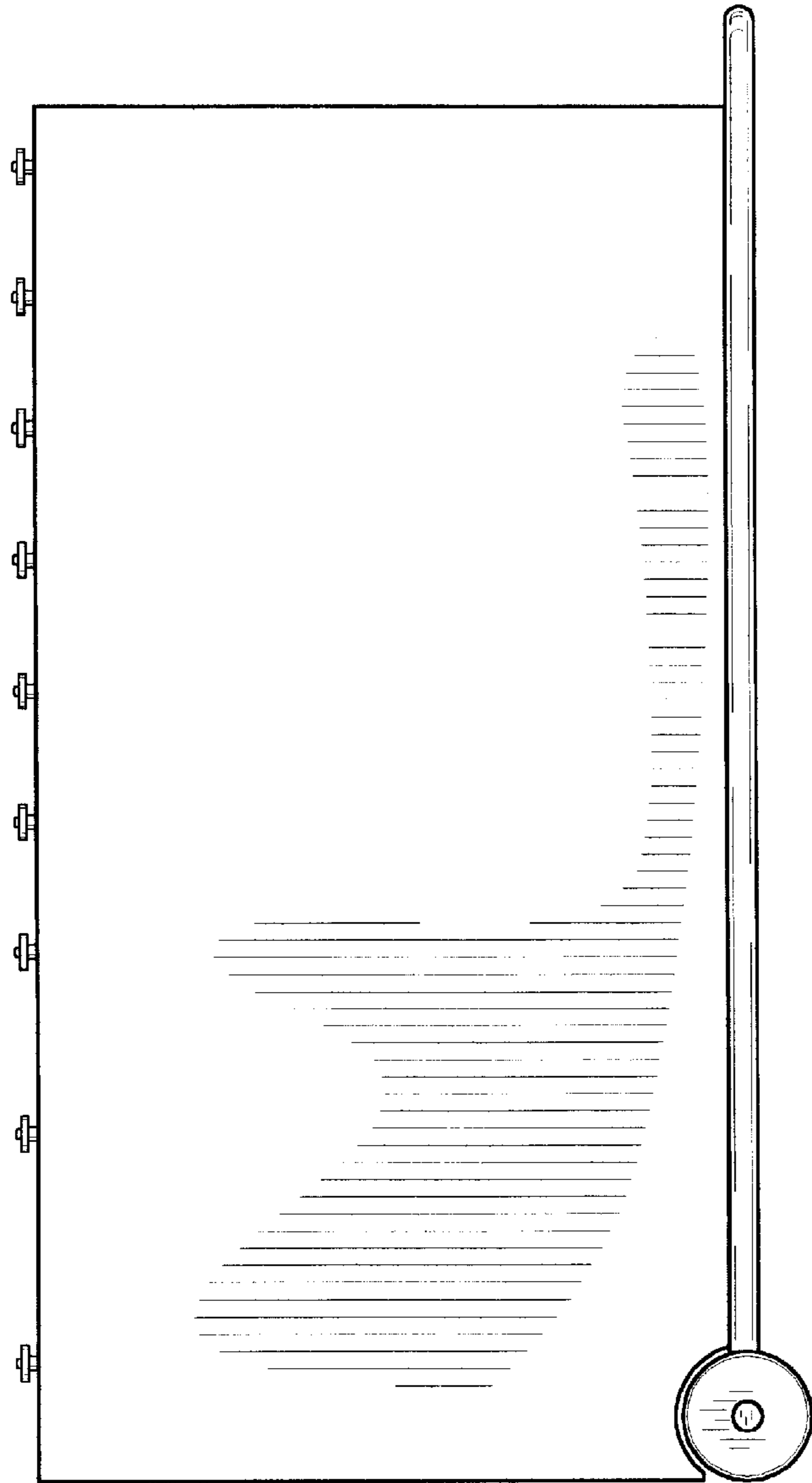

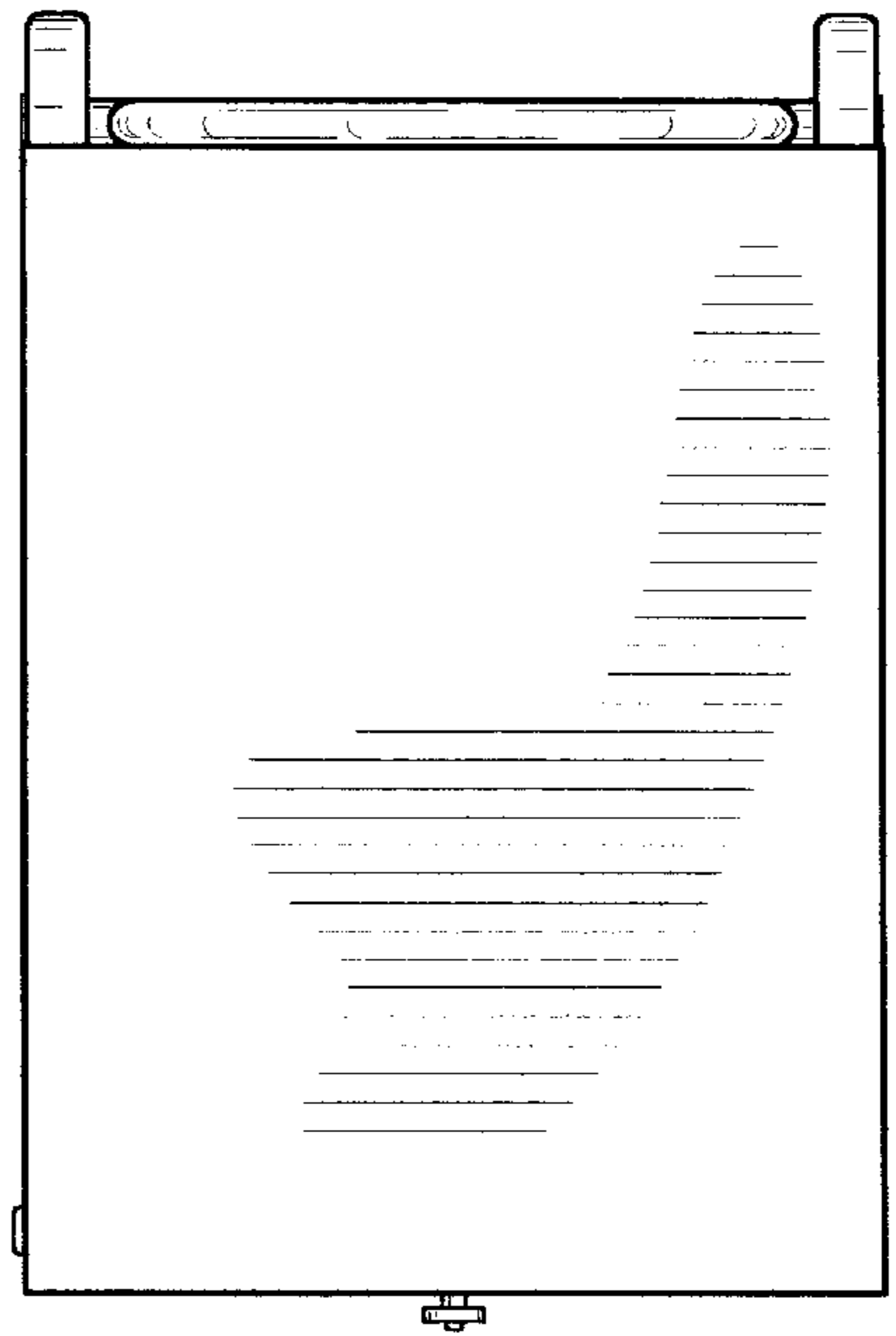

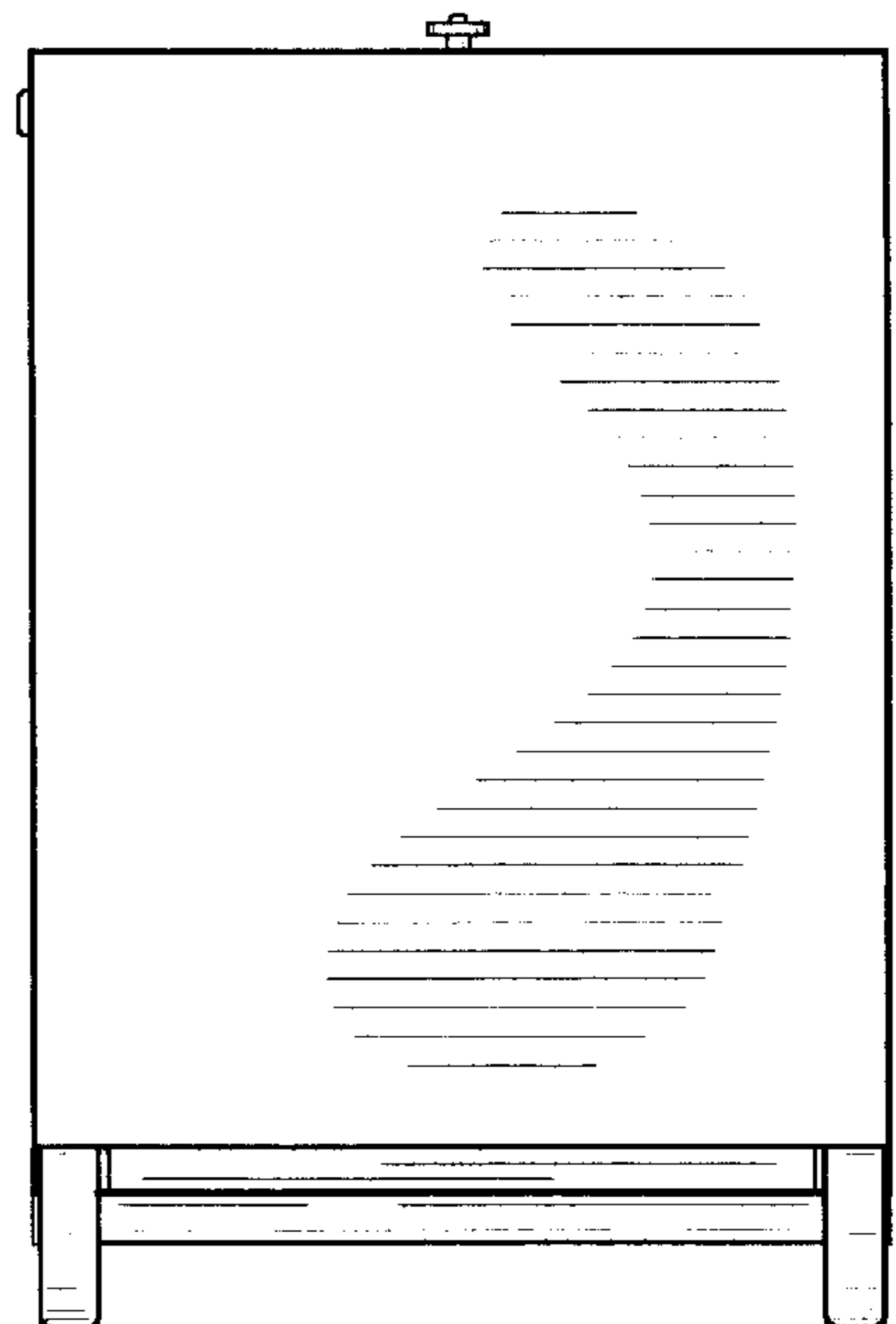
