FIG. 4 is a front elevational view of the bird head furniture support of FIG. 1;



FIG. 5 is a rear elevational view of the bird head furniture support of FIG. 1;


FIG. 6 is a top plan view of the bird head furniture support of FIG. 1;

FIG. 7 is a bottom plan view of the bird head furniture support of FIG. 1;



FIG. 10 is a side elevation view of the second embodiment of a bird head furniture support of FIG. 9.
















