FIG. 8 is a rear view of FIG. 7.

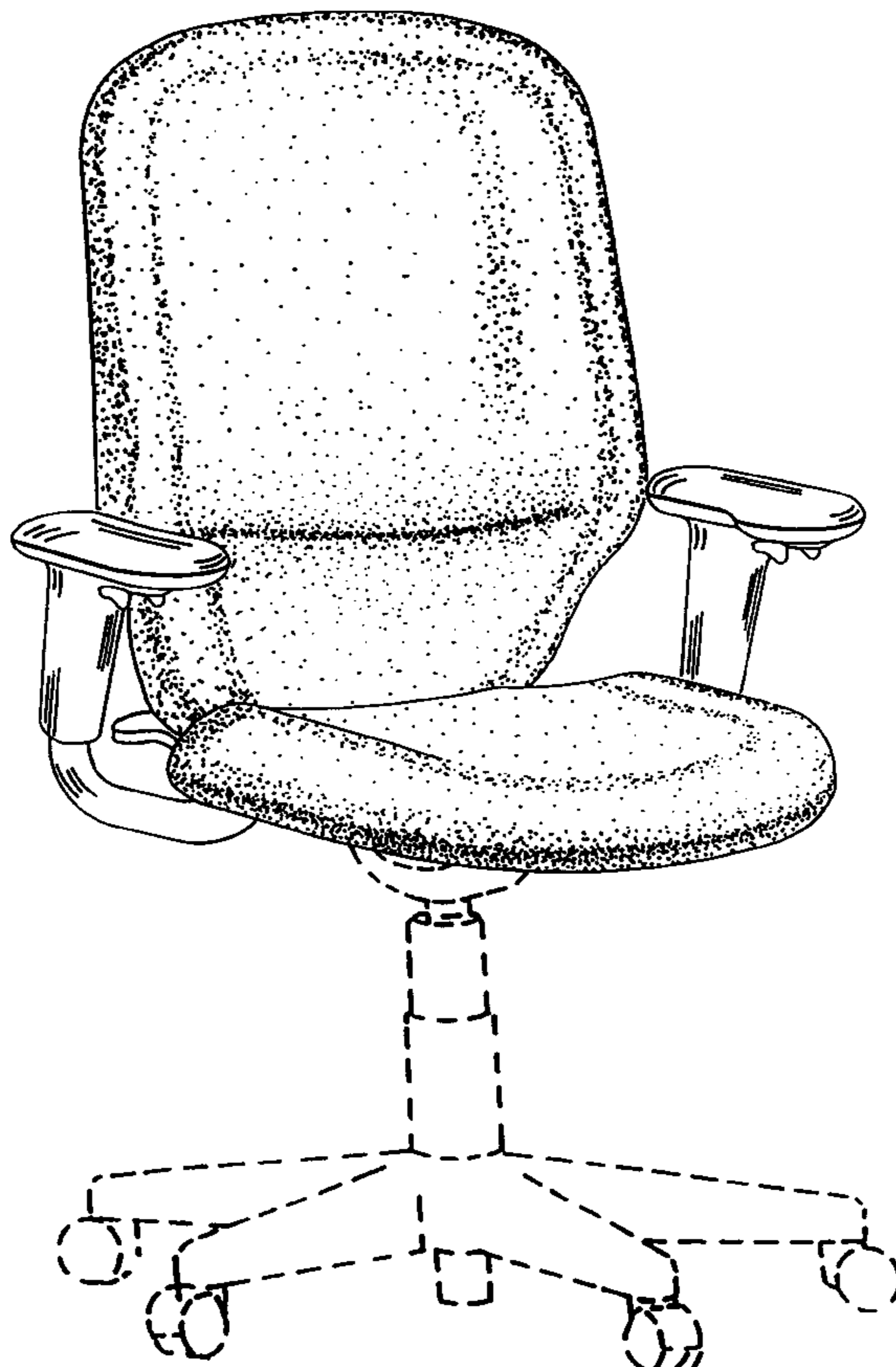
The broken line showings of the chair pedestal are solely for

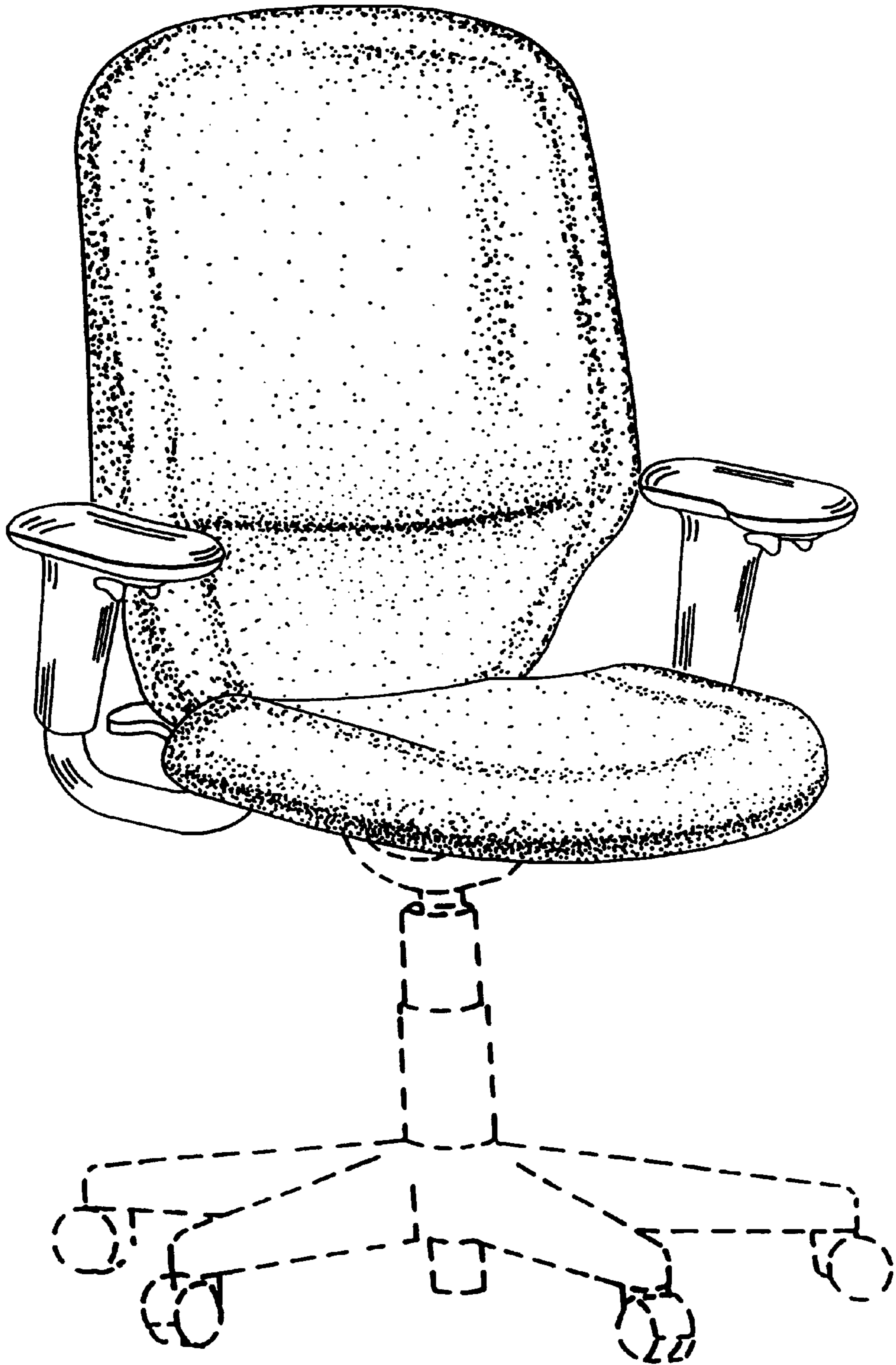

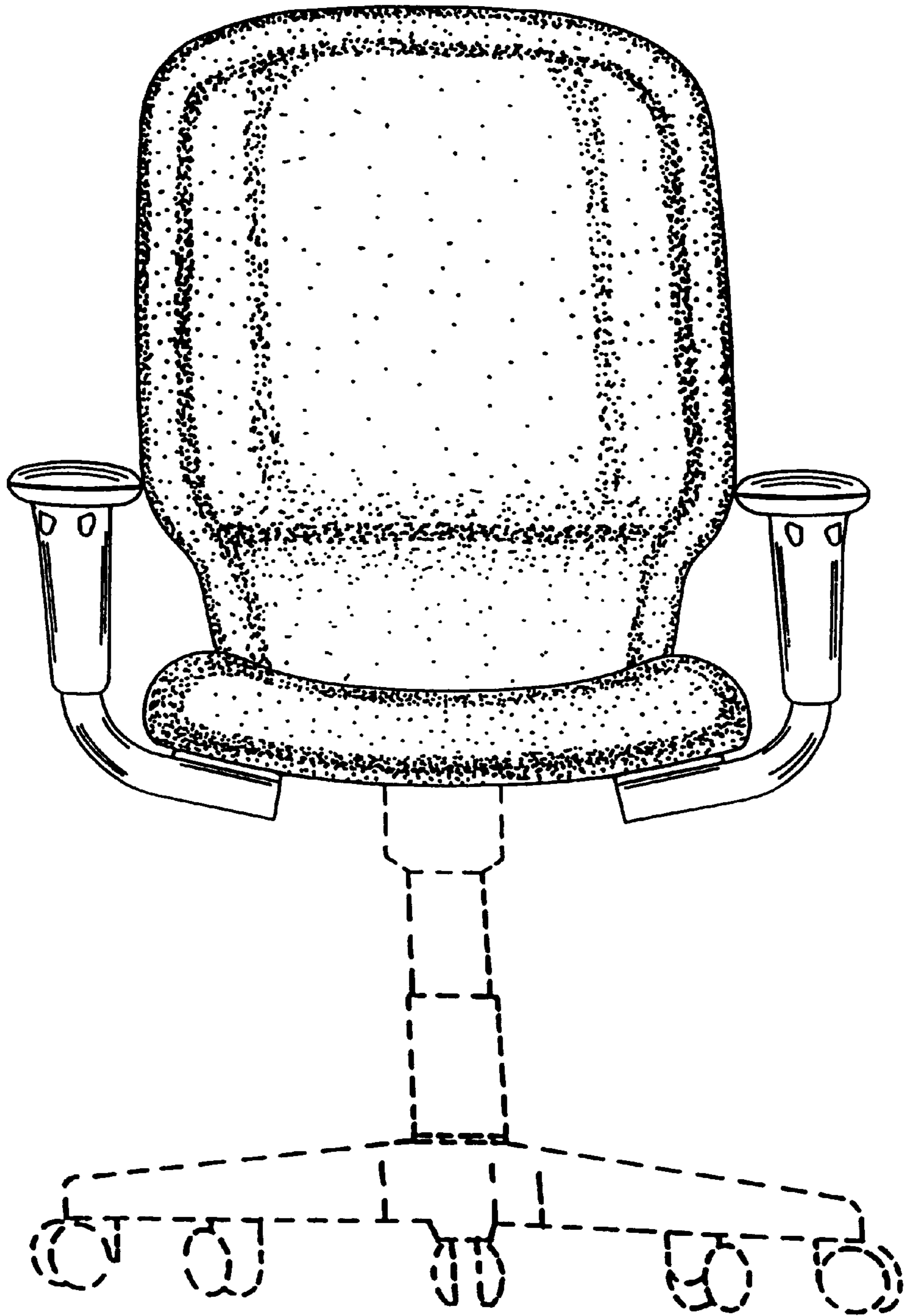

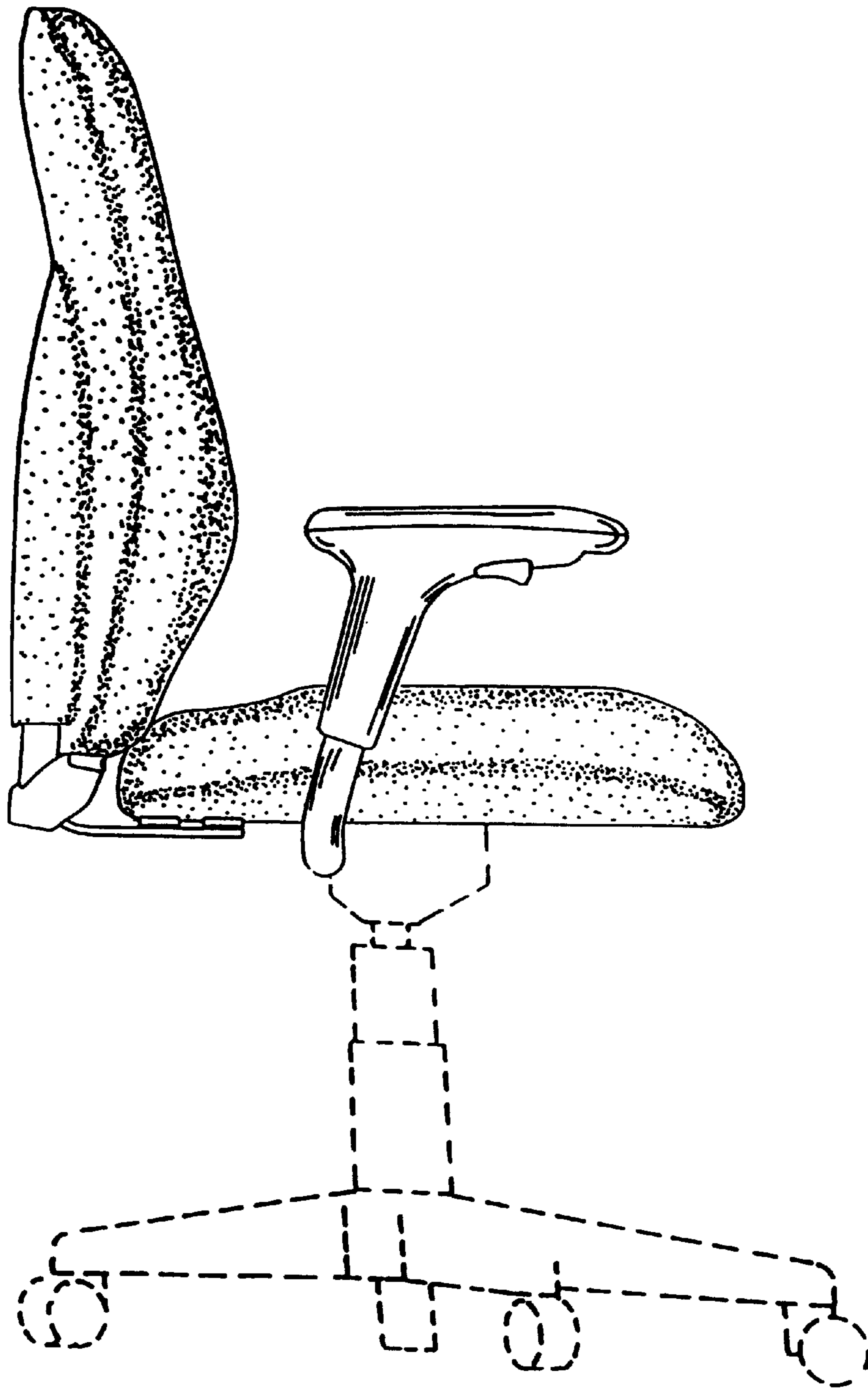

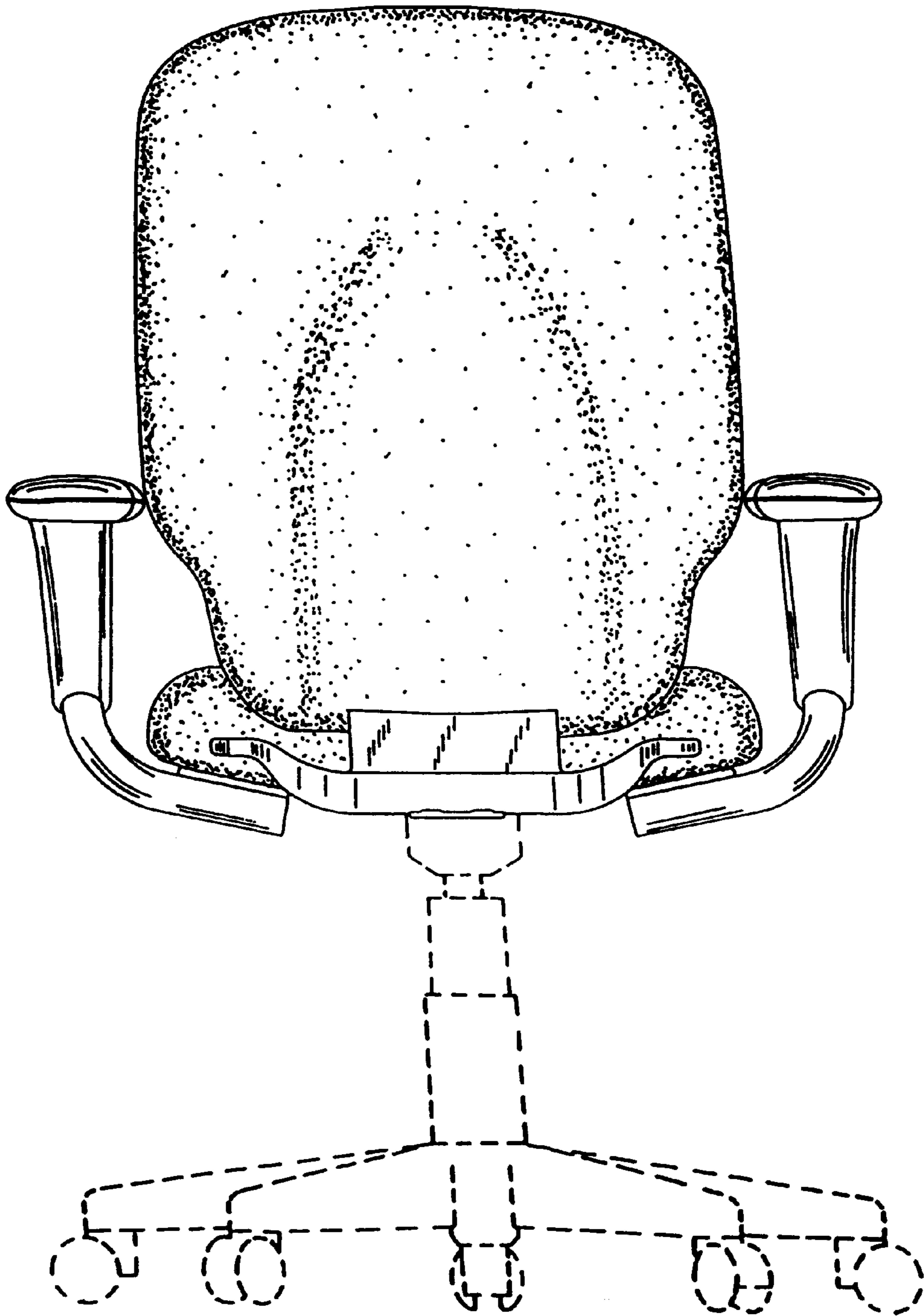

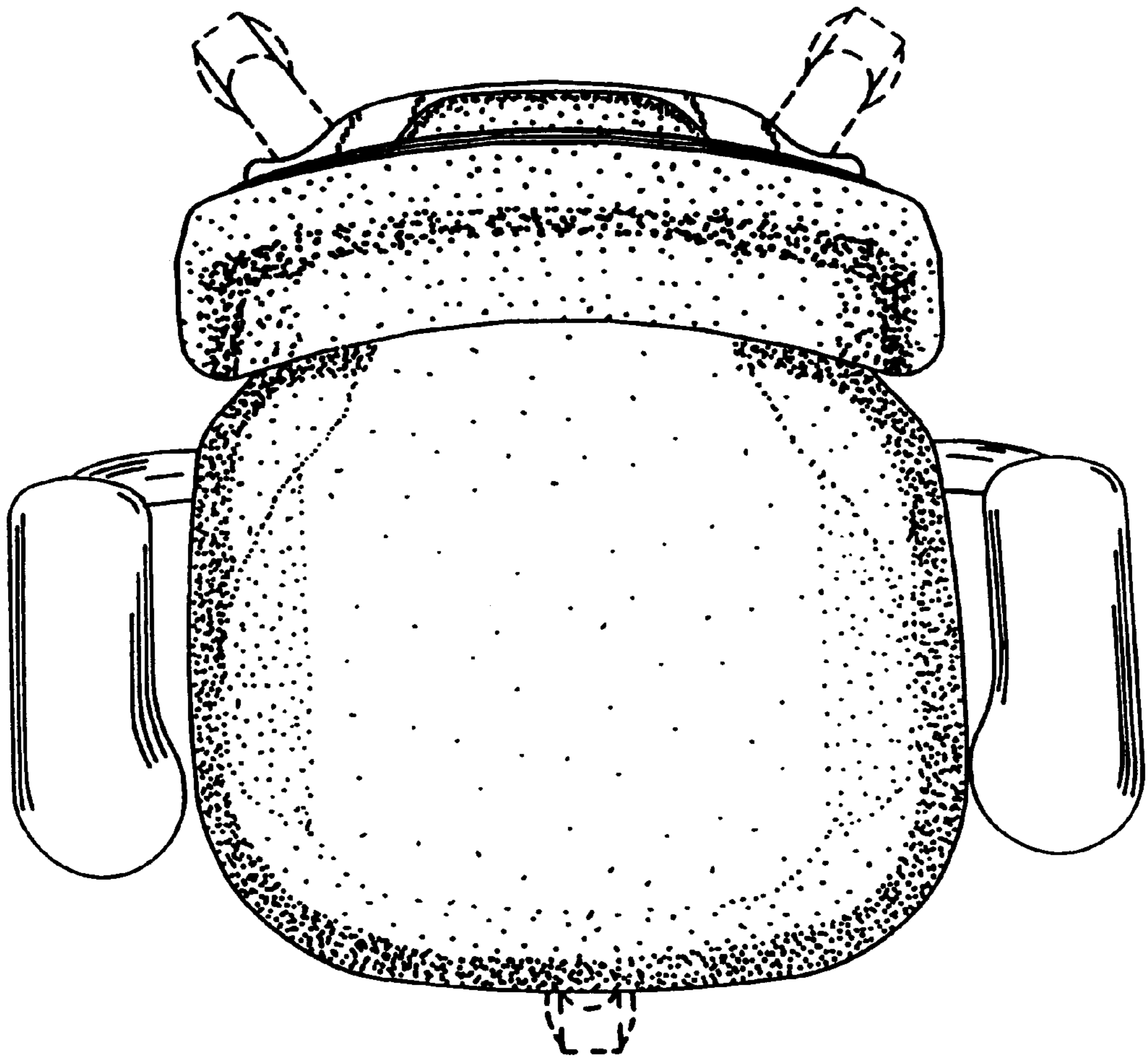

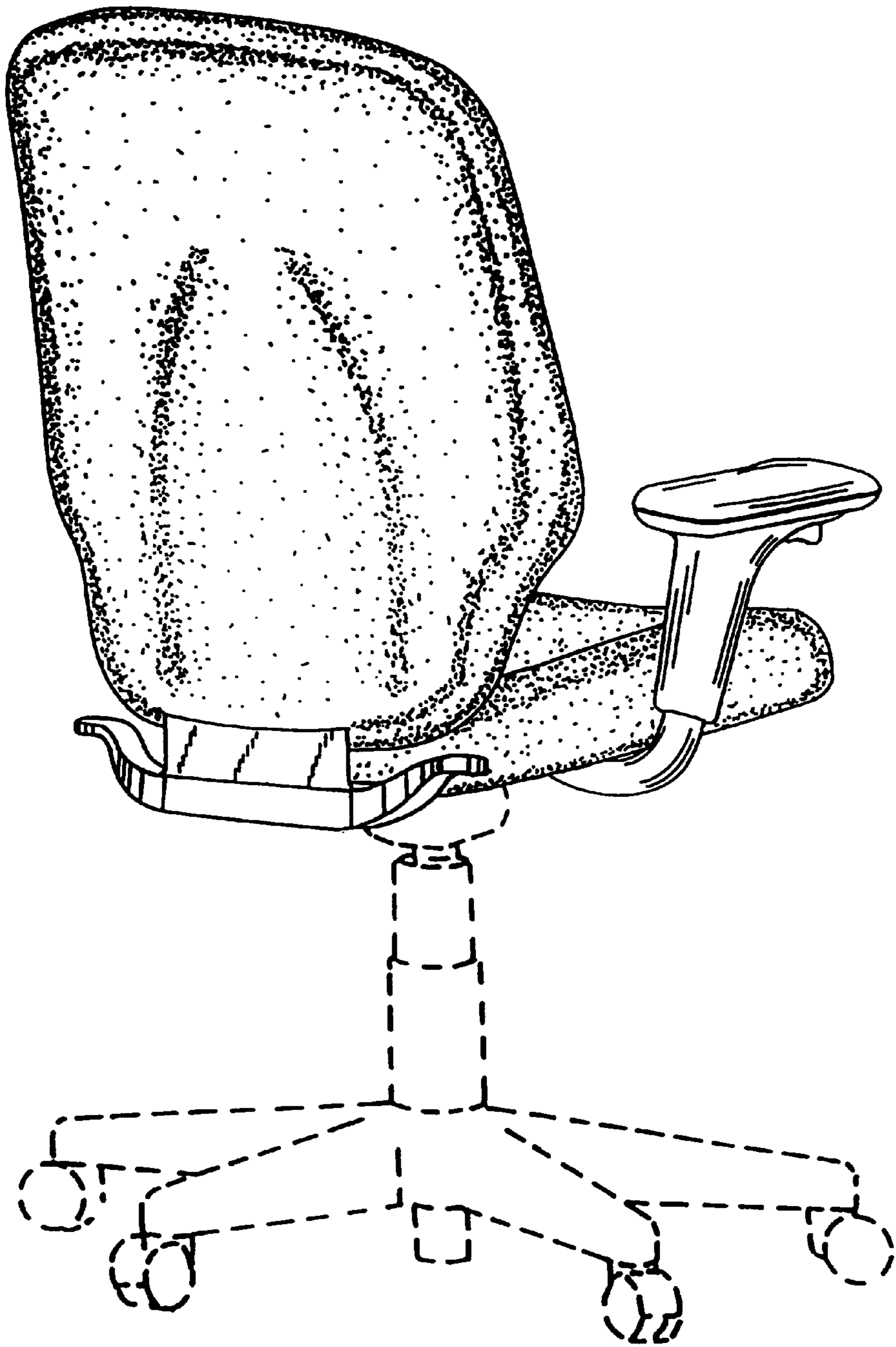

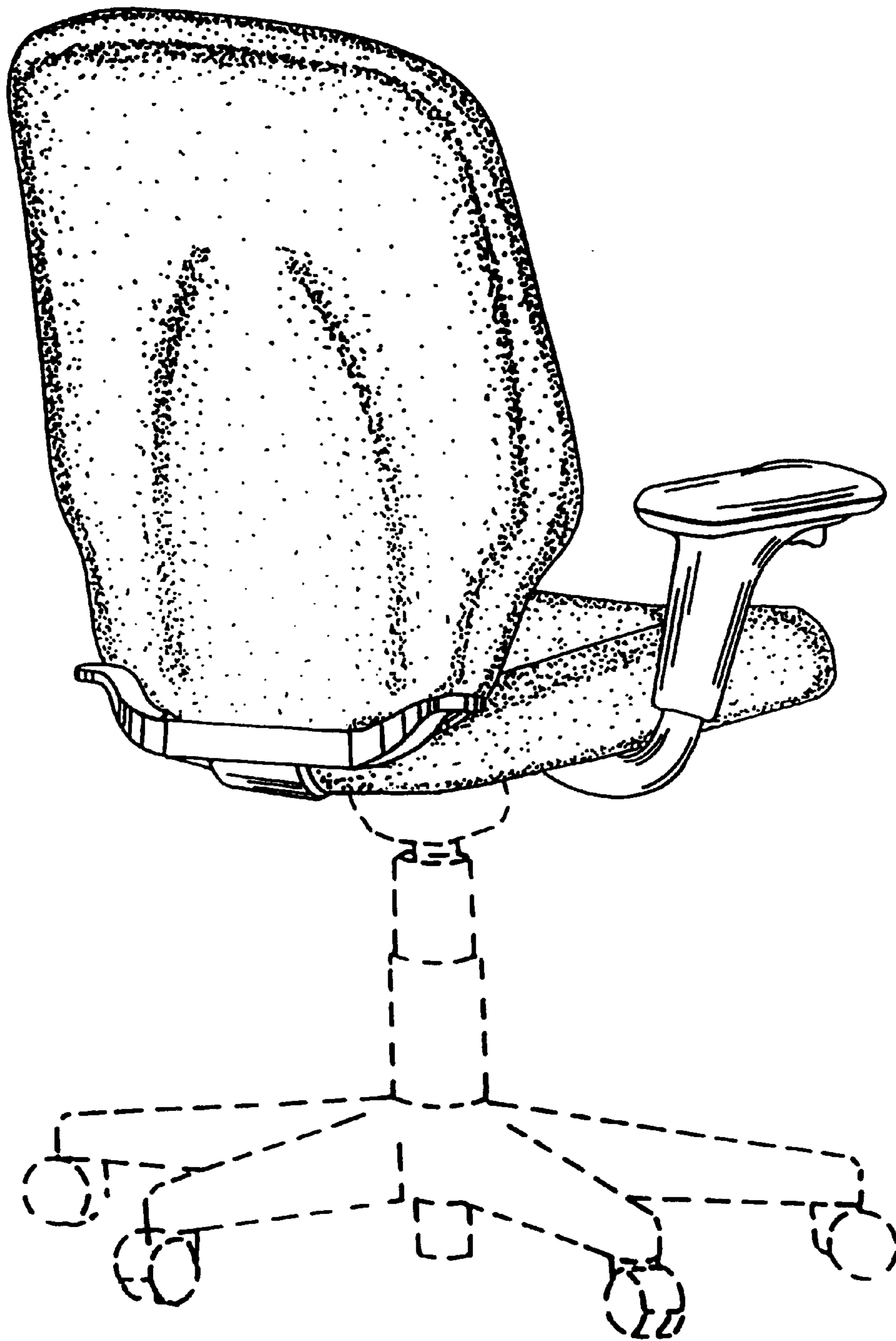

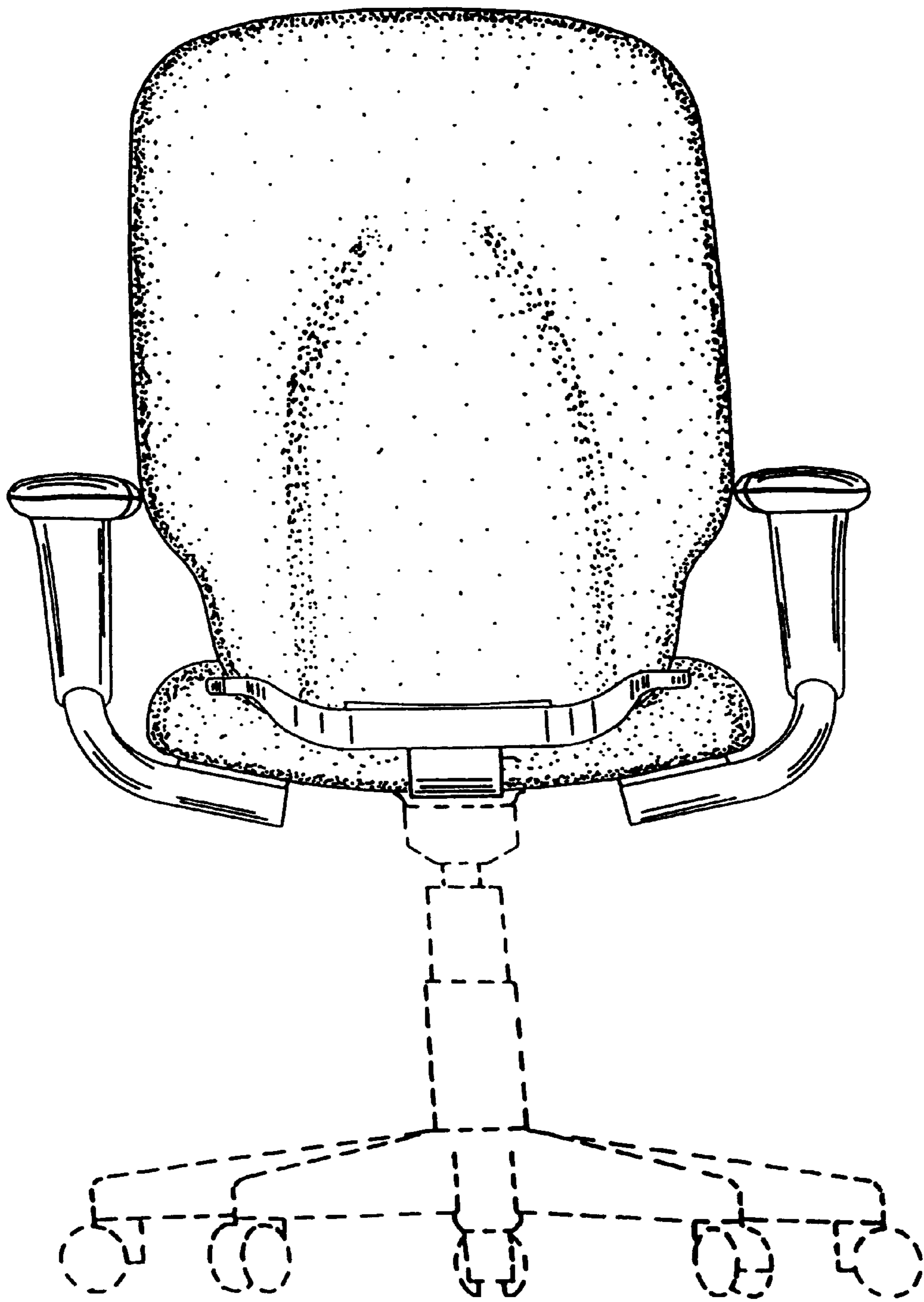
