DESCRIPTION

FIG. 1 is a perspective view, taken from the front, left side,
and top, illustrating our new design of an electric coffee-
maker housing;

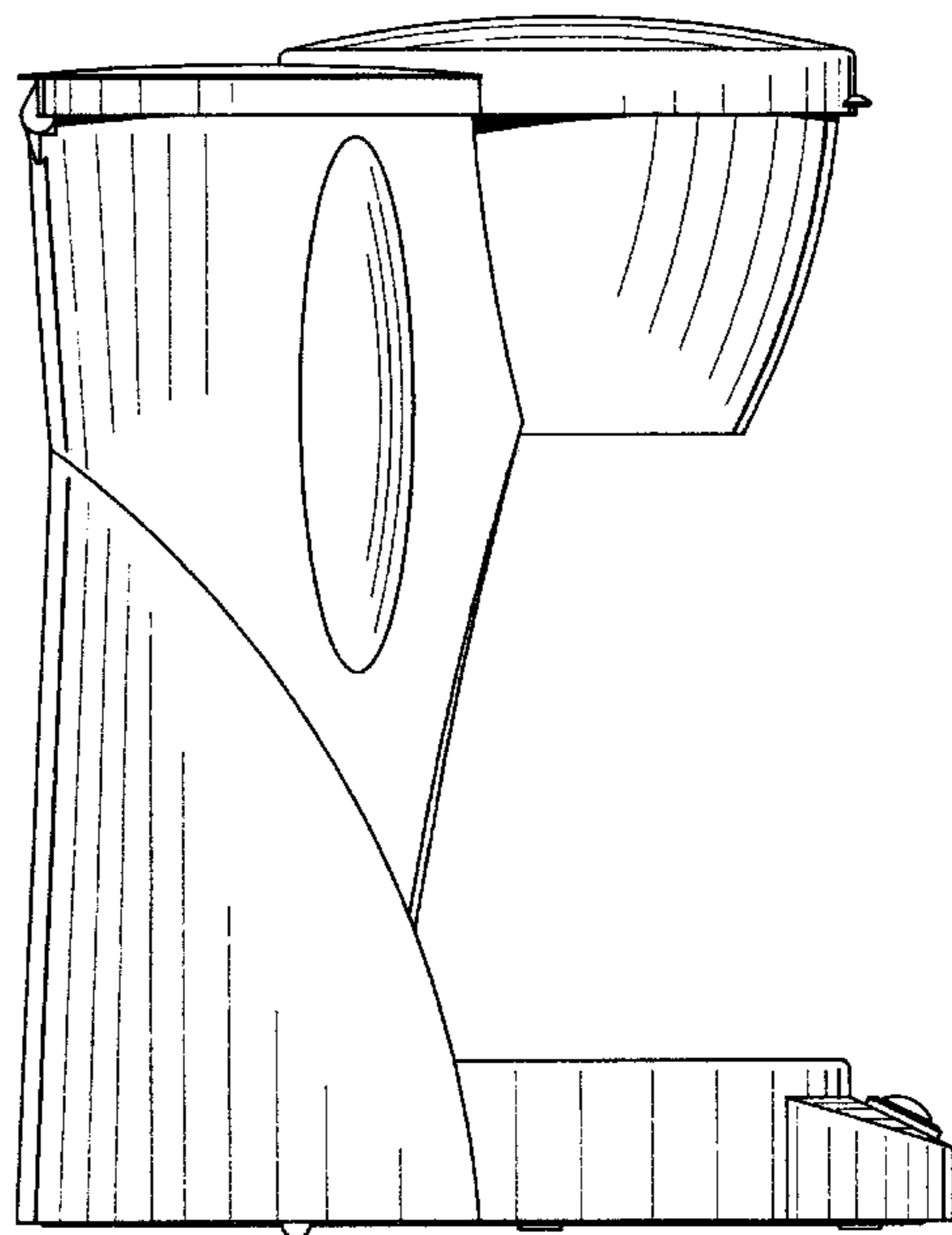
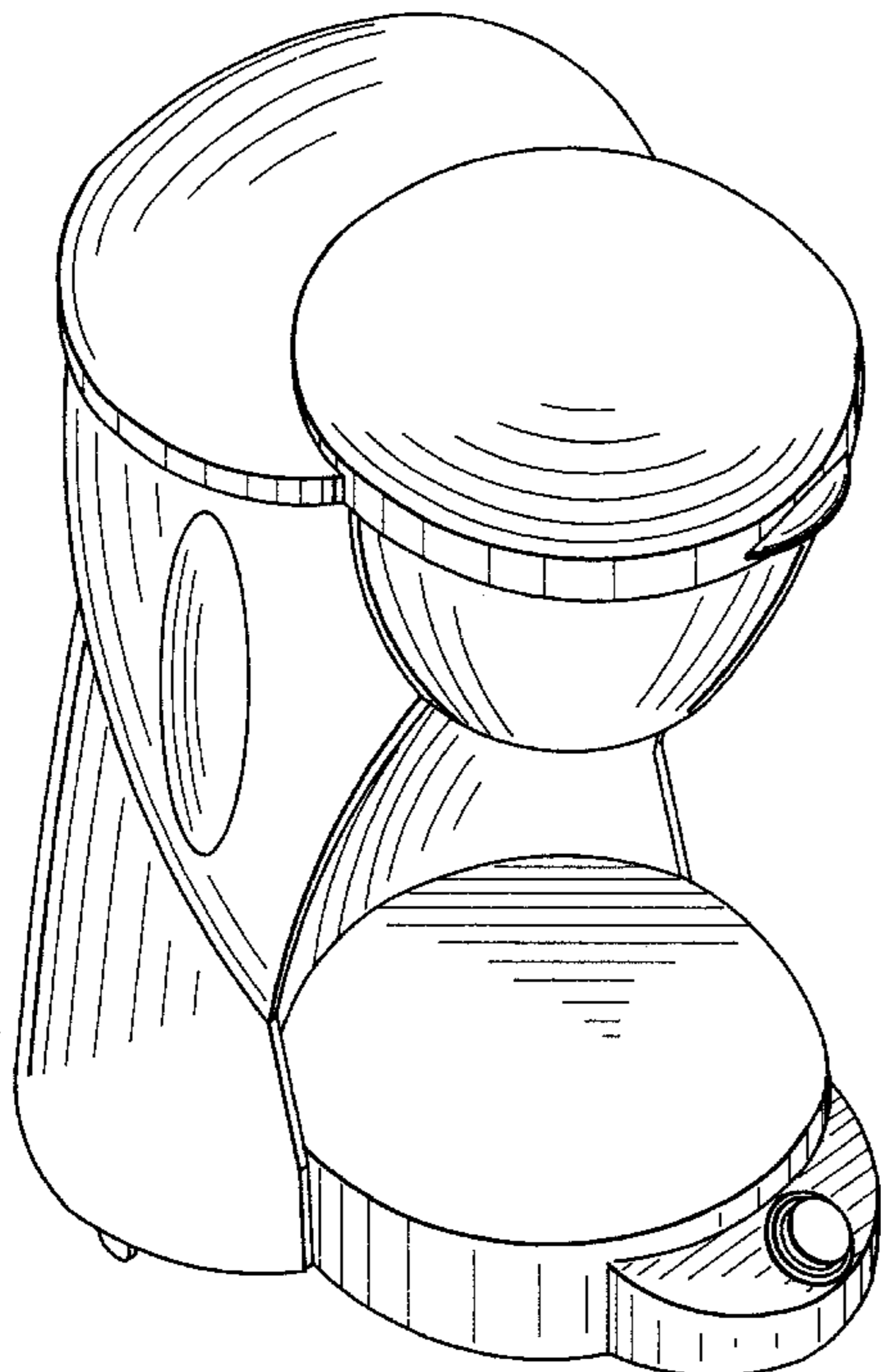

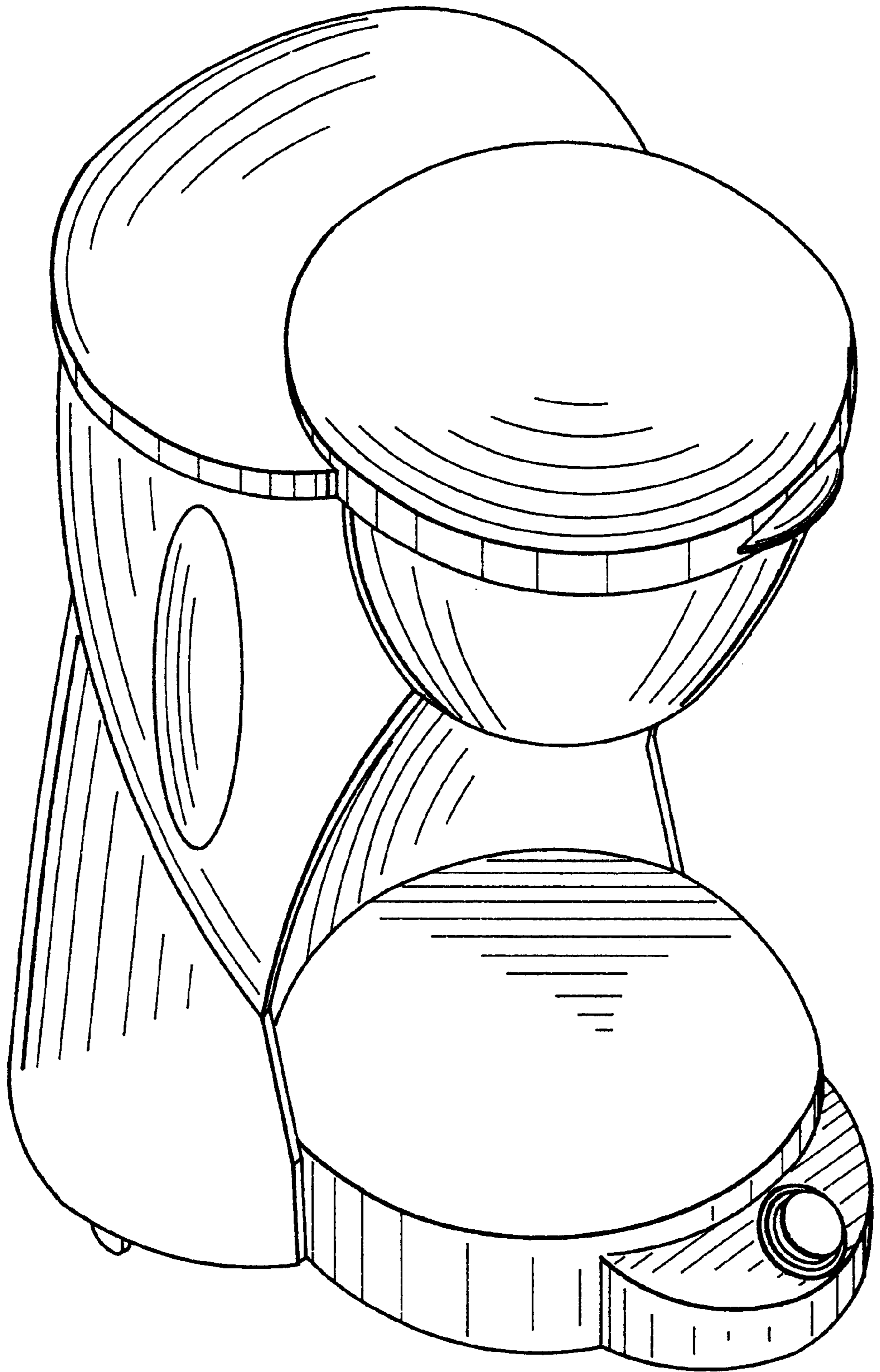

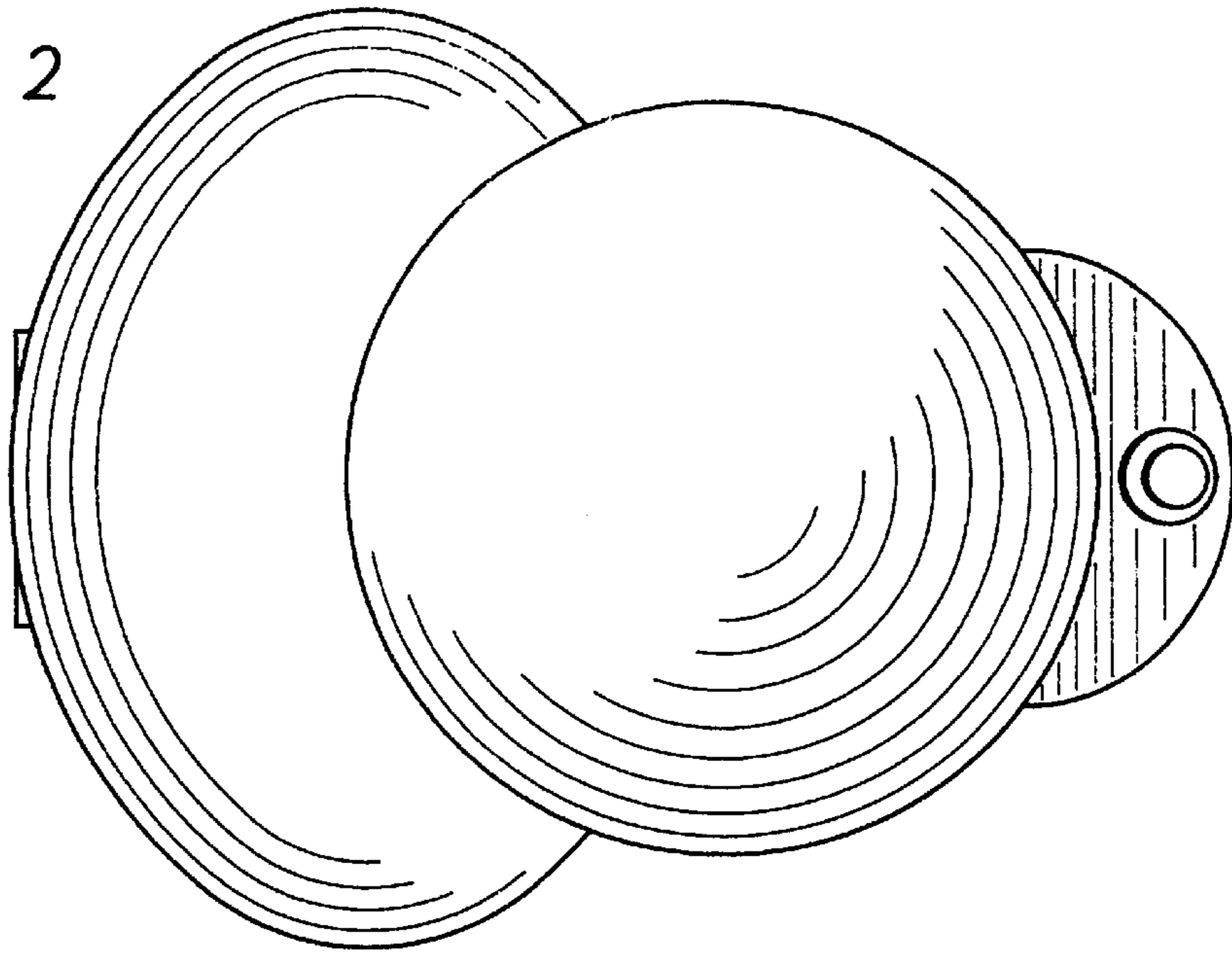
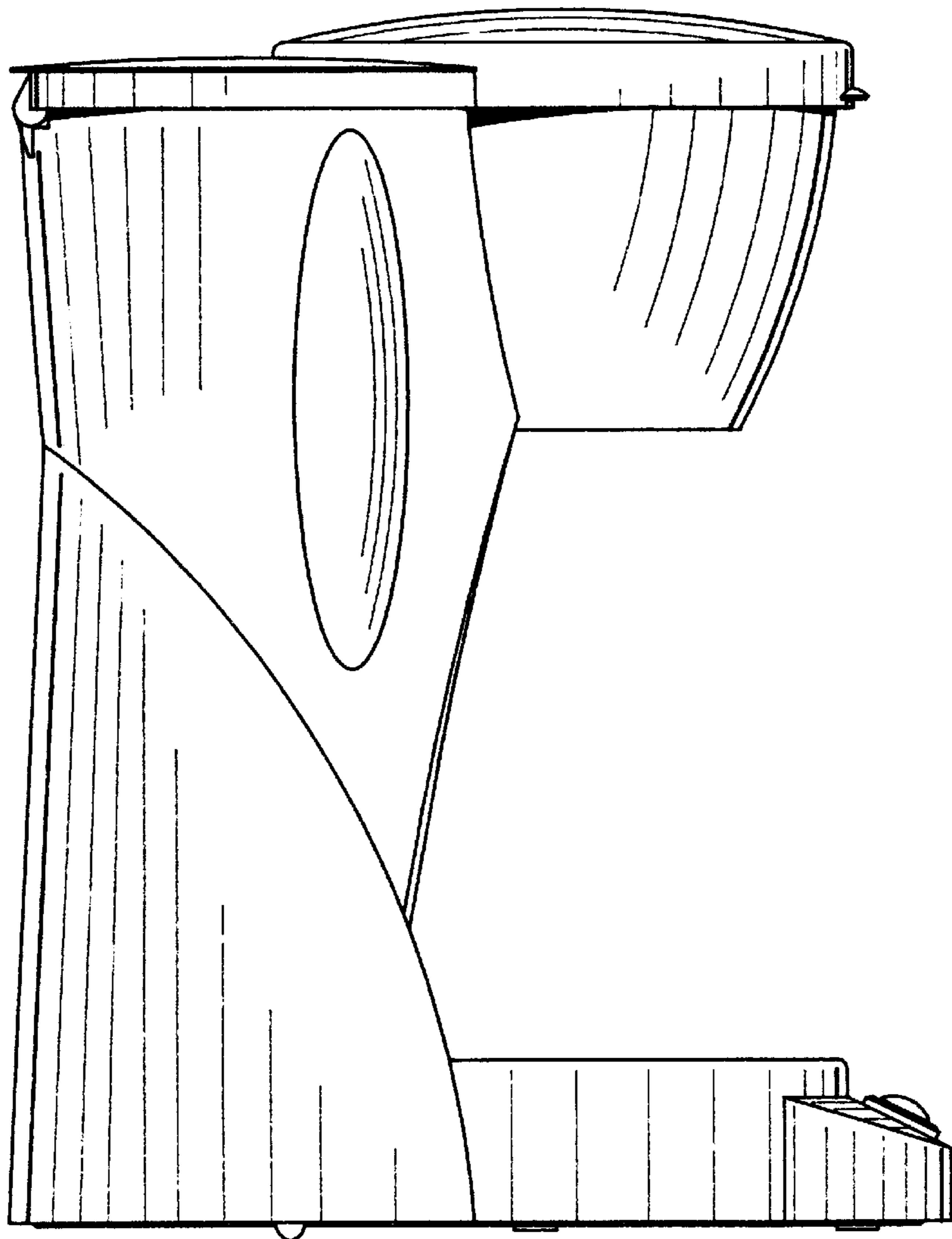

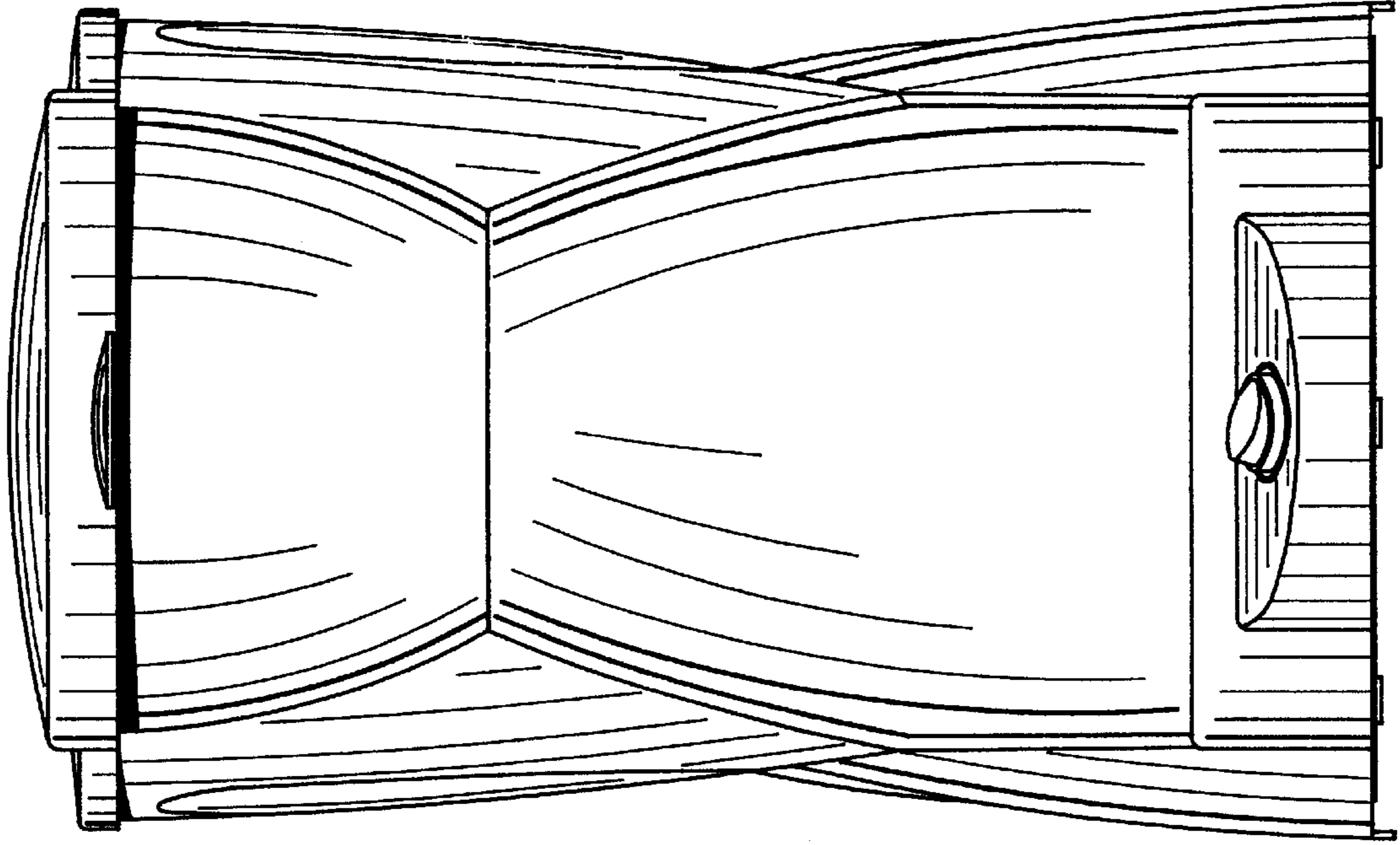

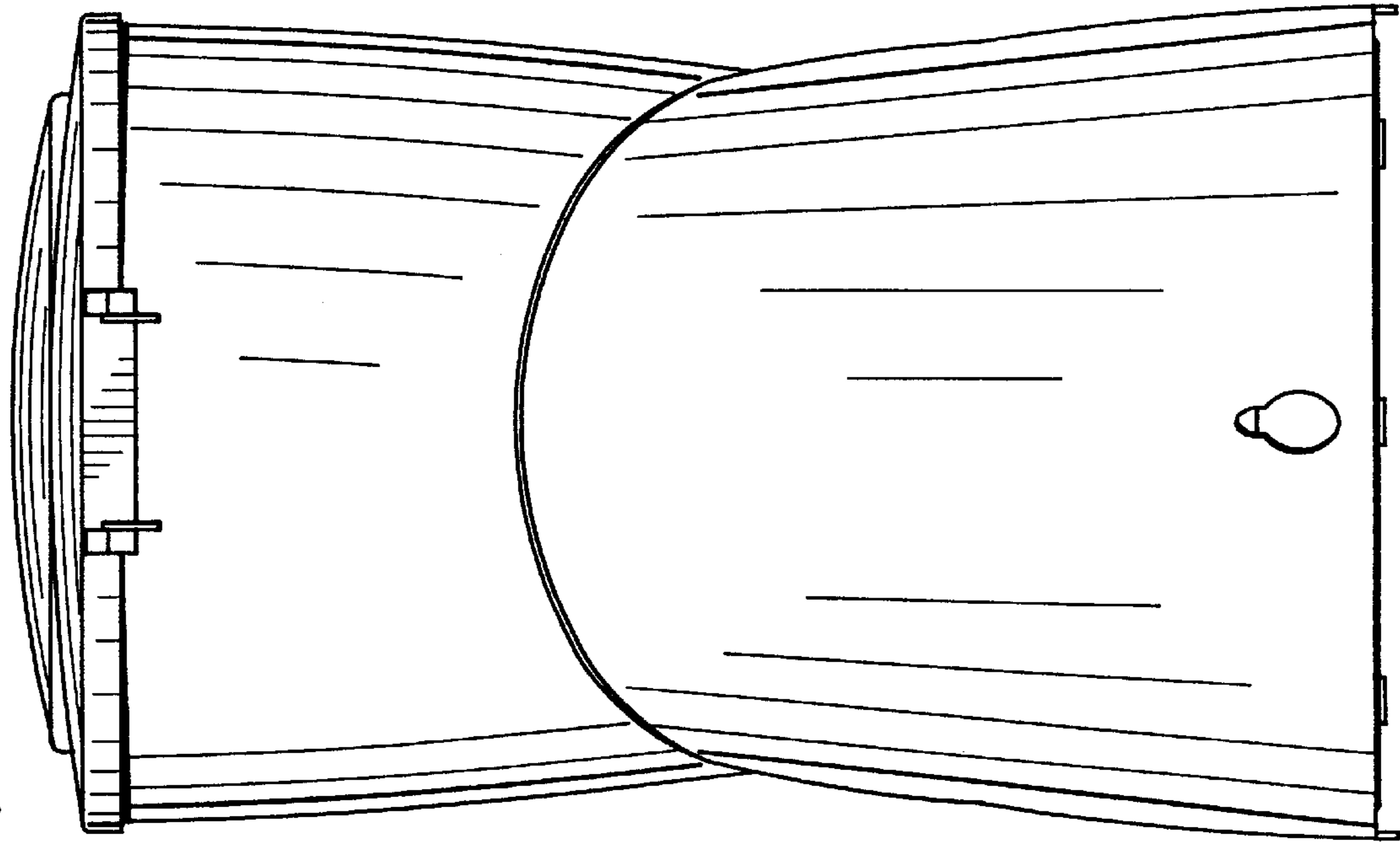

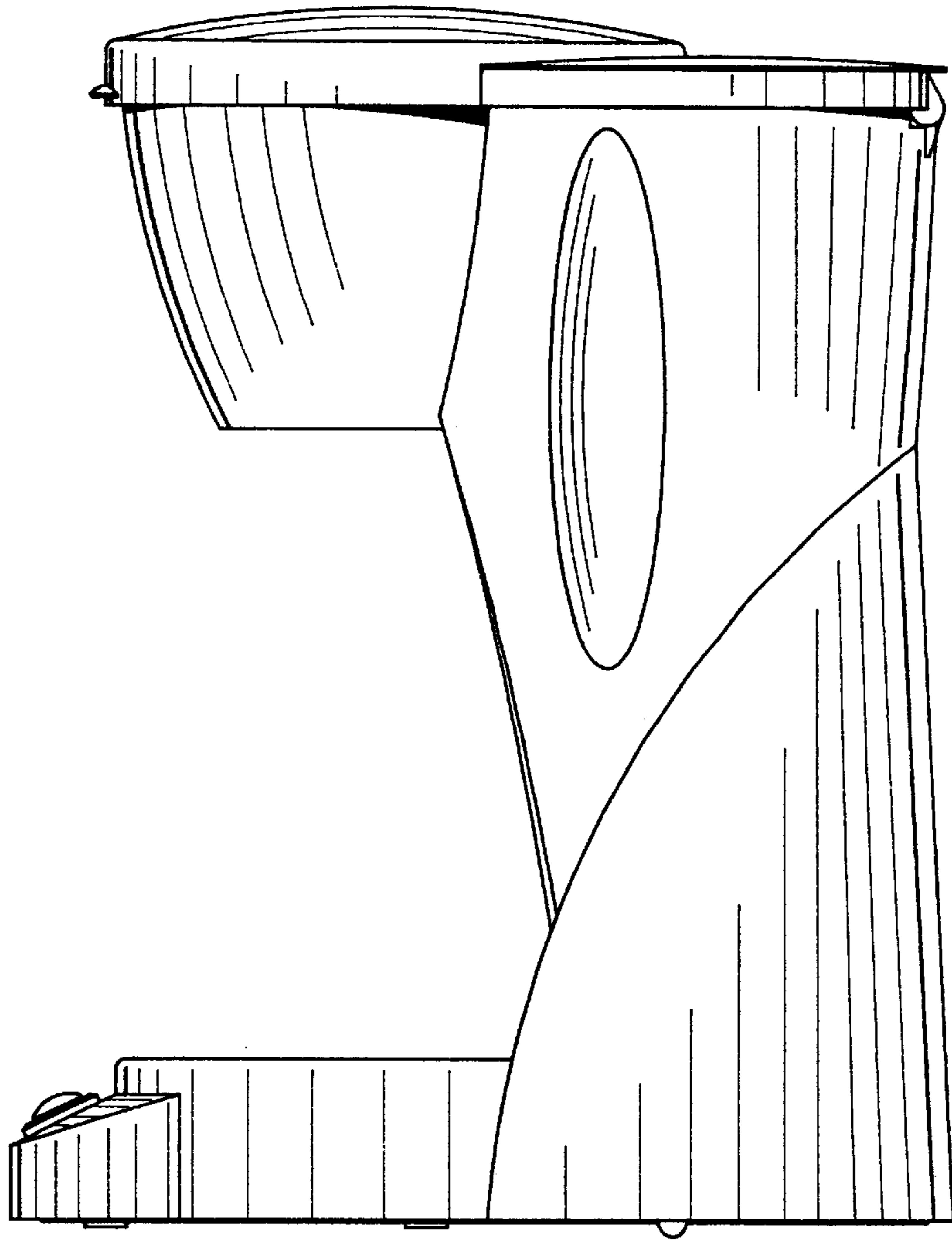
