(57) **CLAIM**

The ornamental design for a four slice toaster, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a preferred embodiment of the four slice toaster.

FIG. 2 is a front end view of the four slice toaster shown in FIG. 1.

FIG. 3 is a rear end view of the four slice toaster shown in FIG. 1.

FIG. 4 is a right side view of the four slice toaster shown in FIG. 1.

FIG. 5 is a left side view of the four slice toaster shown in FIG. 1.

FIG. 6 is a top plan view of the four slice toaster shown in FIG. 1.

FIG. 7 is a perspective view of another preferred embodiment of the four slice toaster.

FIG. 8 is a front end view of the four slice toaster shown in FIG. 7.

FIG. 9 is a rear end view of the four slice toaster shown in FIG. 7.

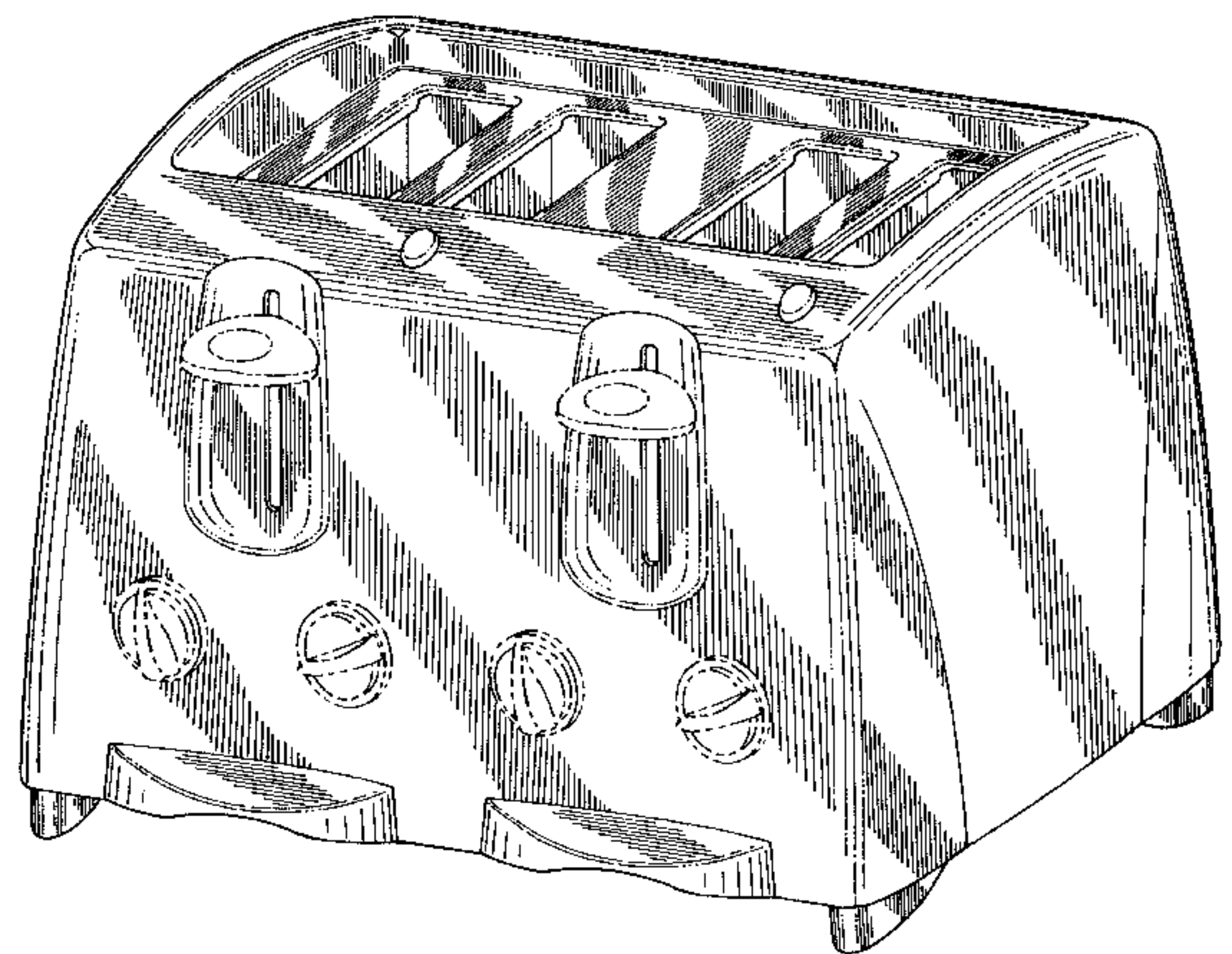
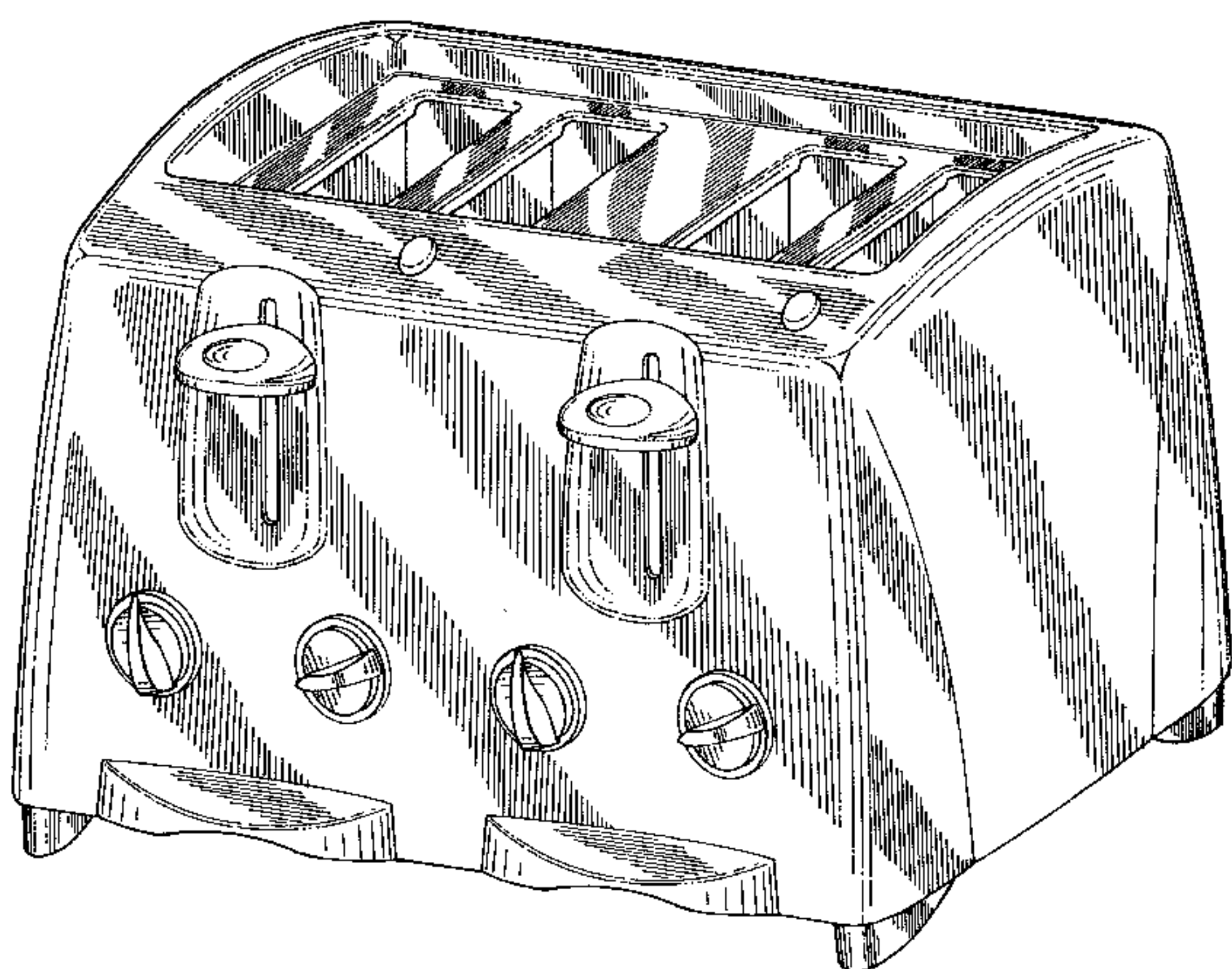
FIG. 10 is a right side view of the four slice toaster shown in FIG. 7.

FIG. 11 is a left side view of the four slice toaster shown in FIG. 7; and,

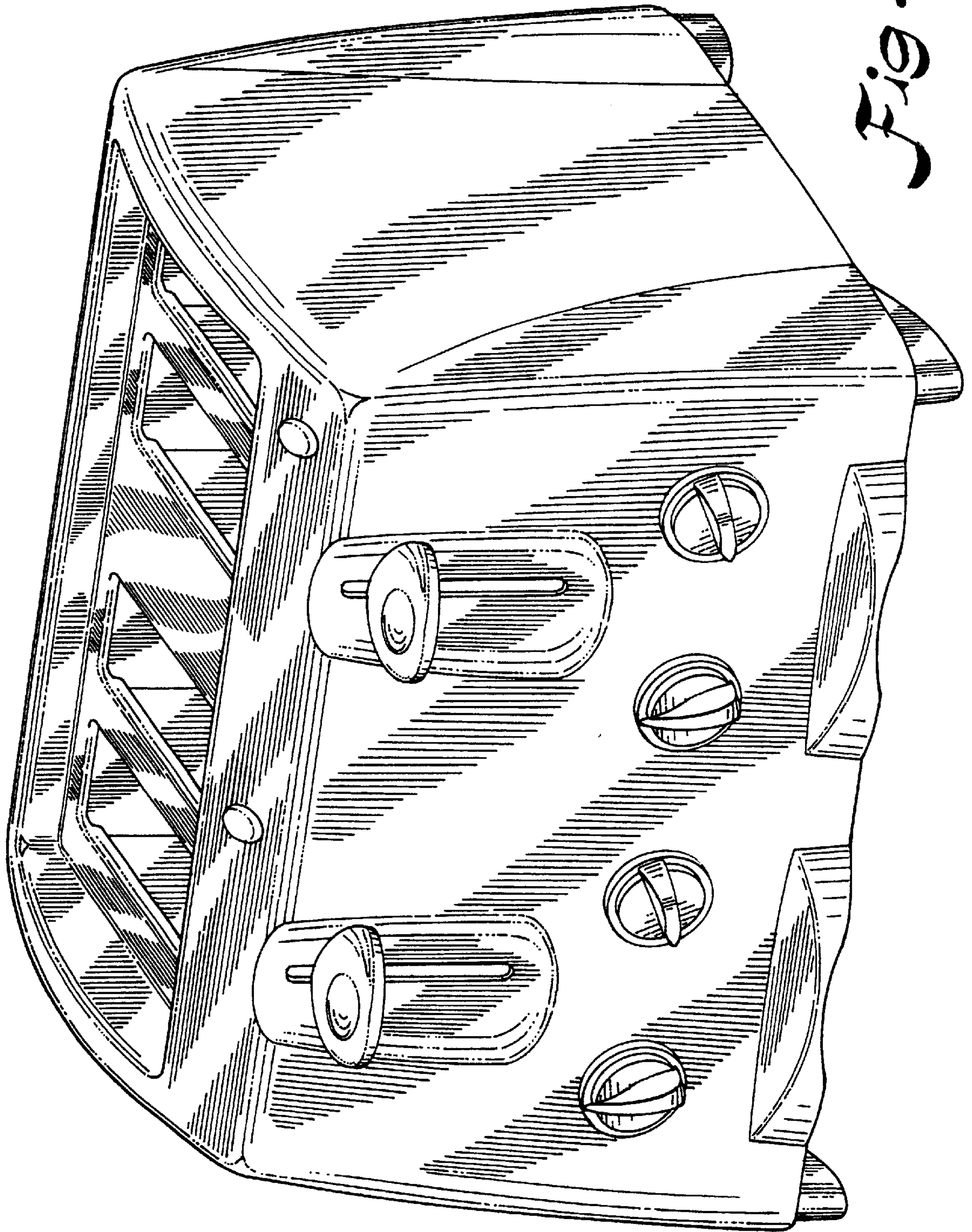
FIG. 12 is a top plan view of the four slice toaster shown in FIG. 7.

The broken lines shown in FIGS. 7-12 are for illustrative purposes only and form no part of the claimed design.

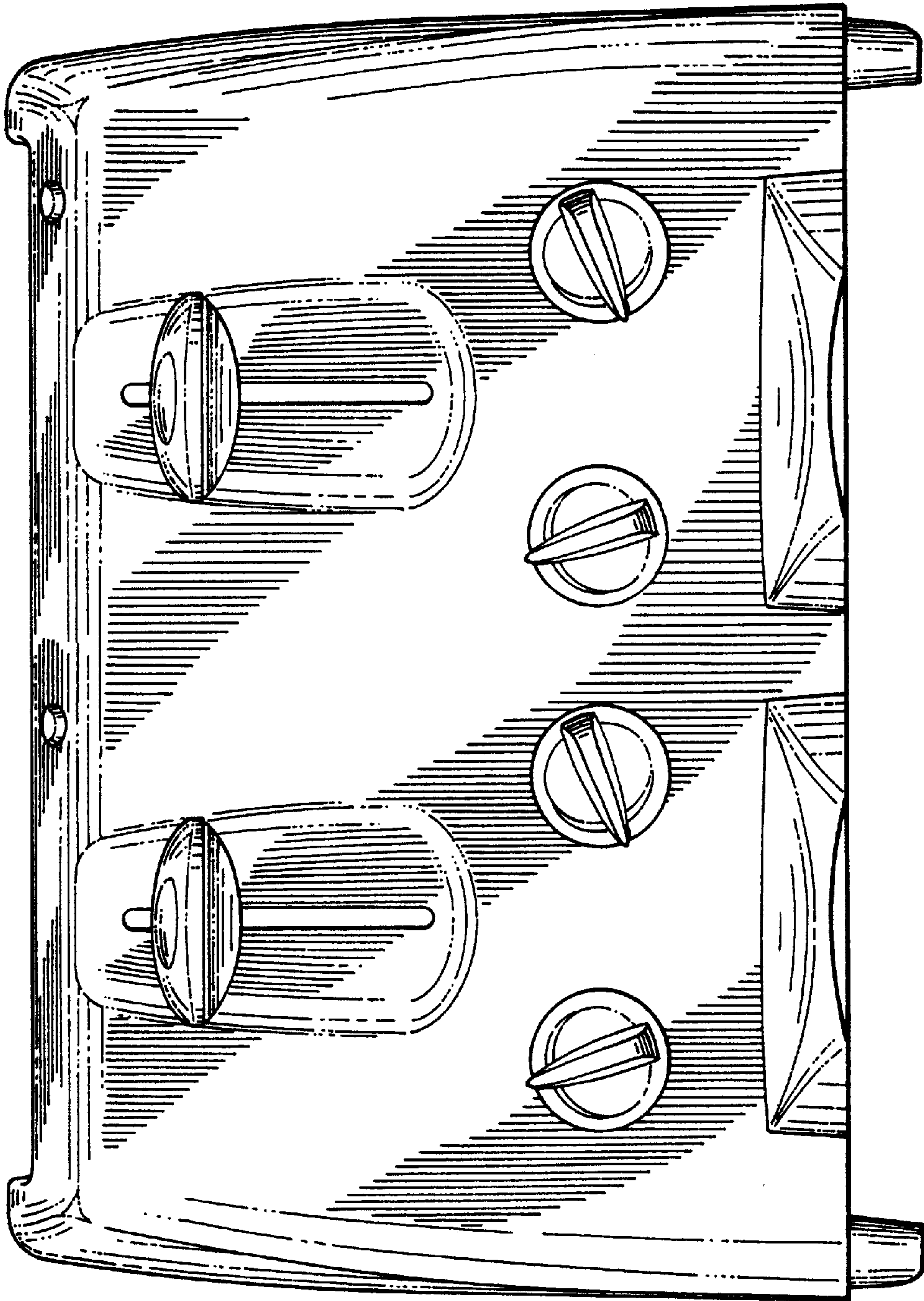

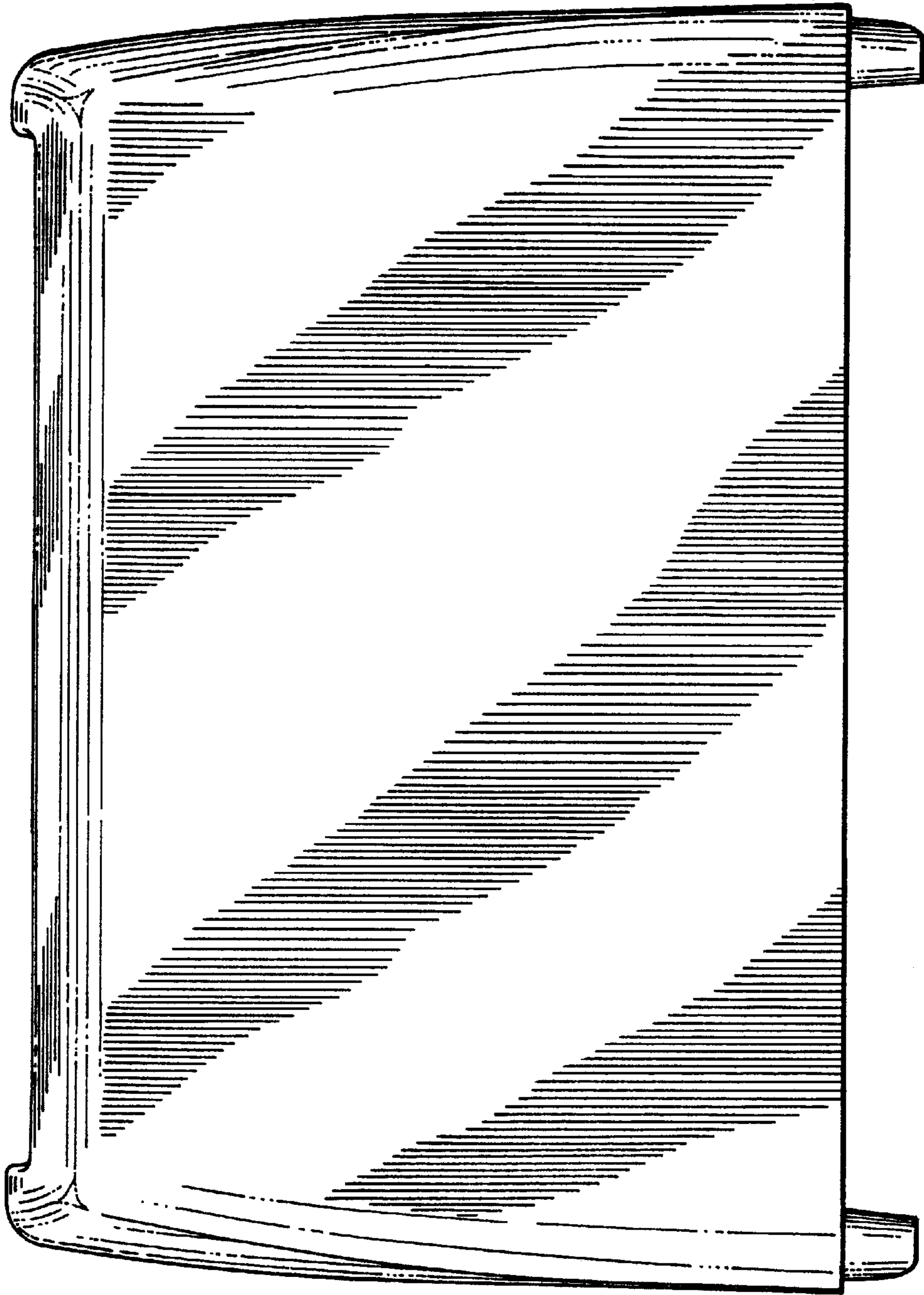

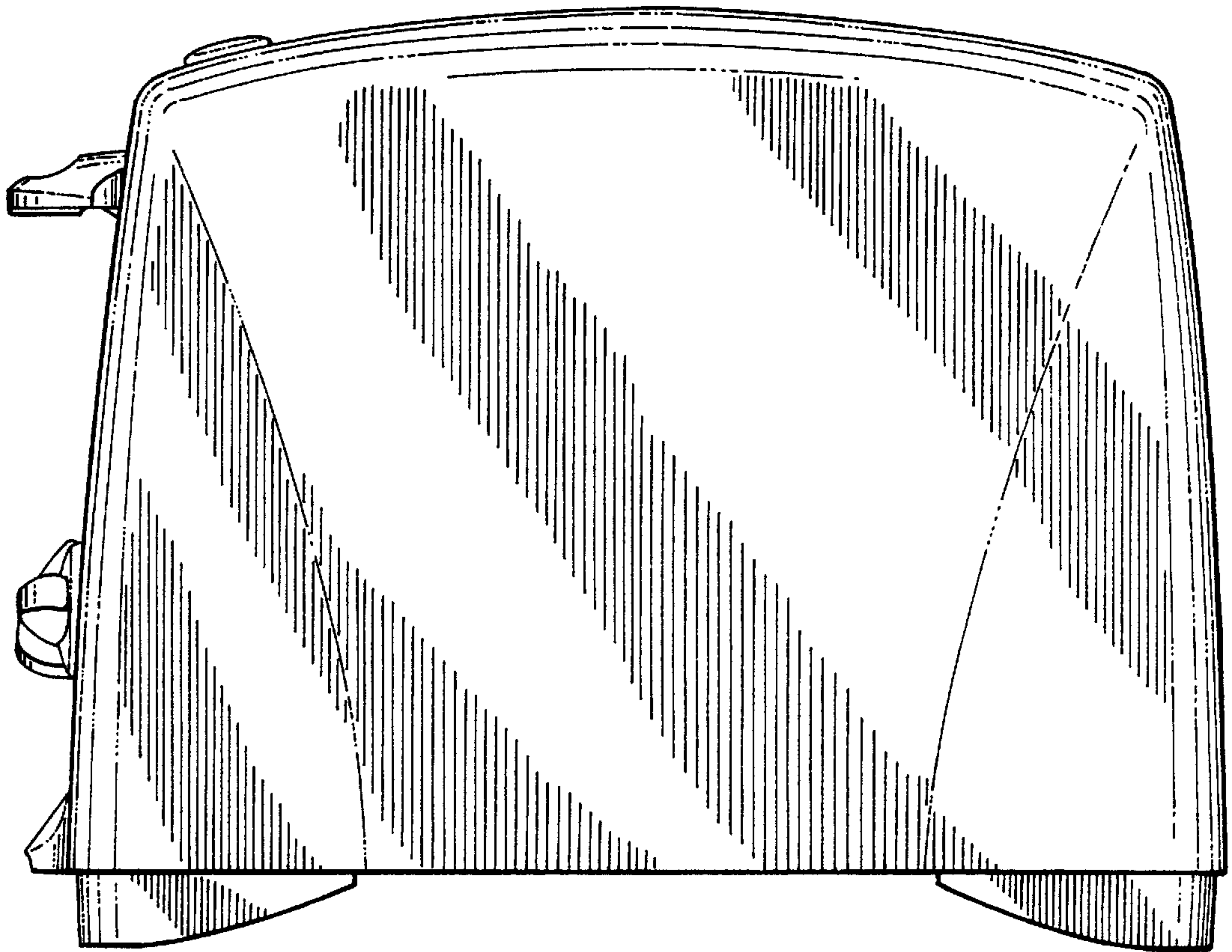

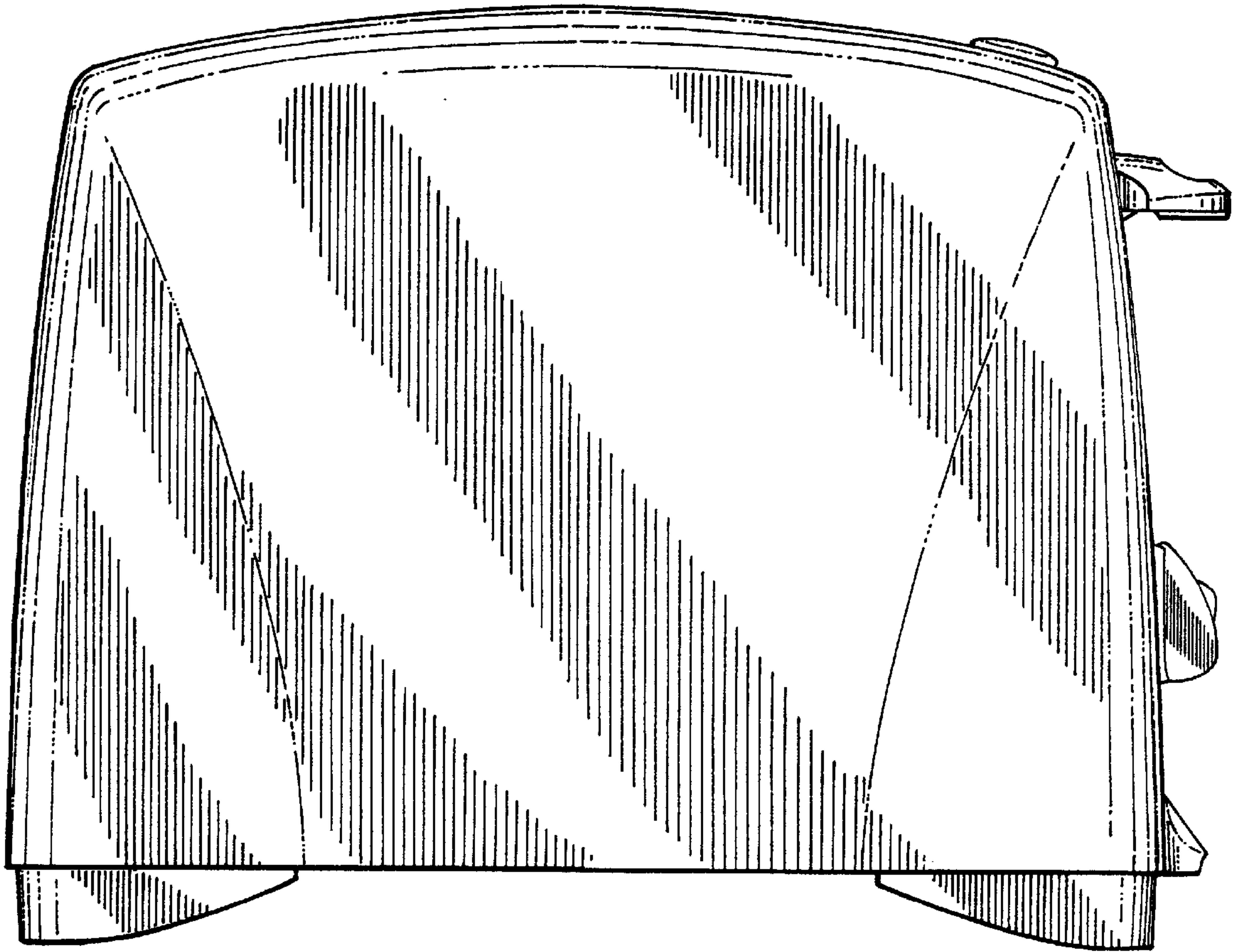

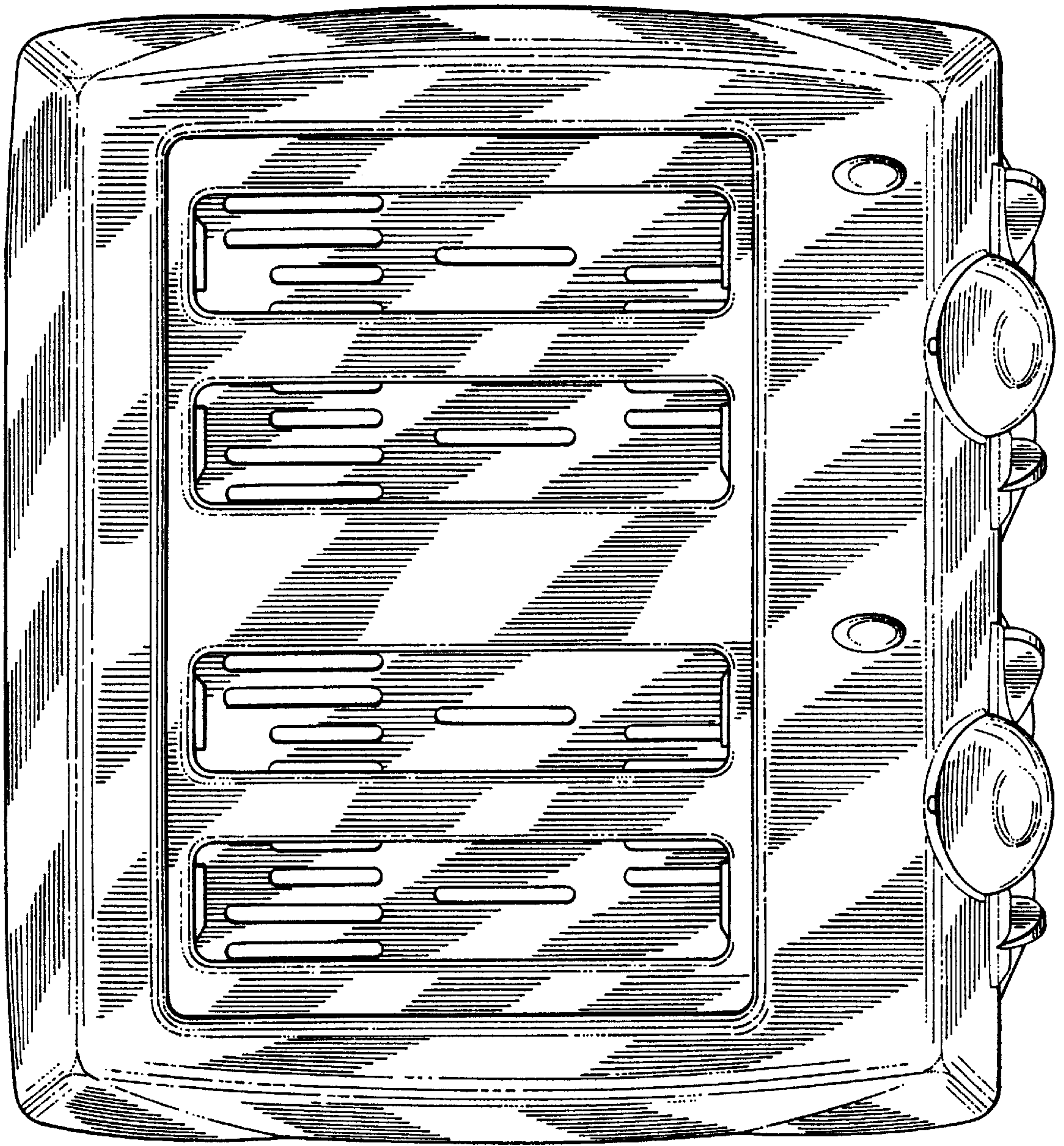

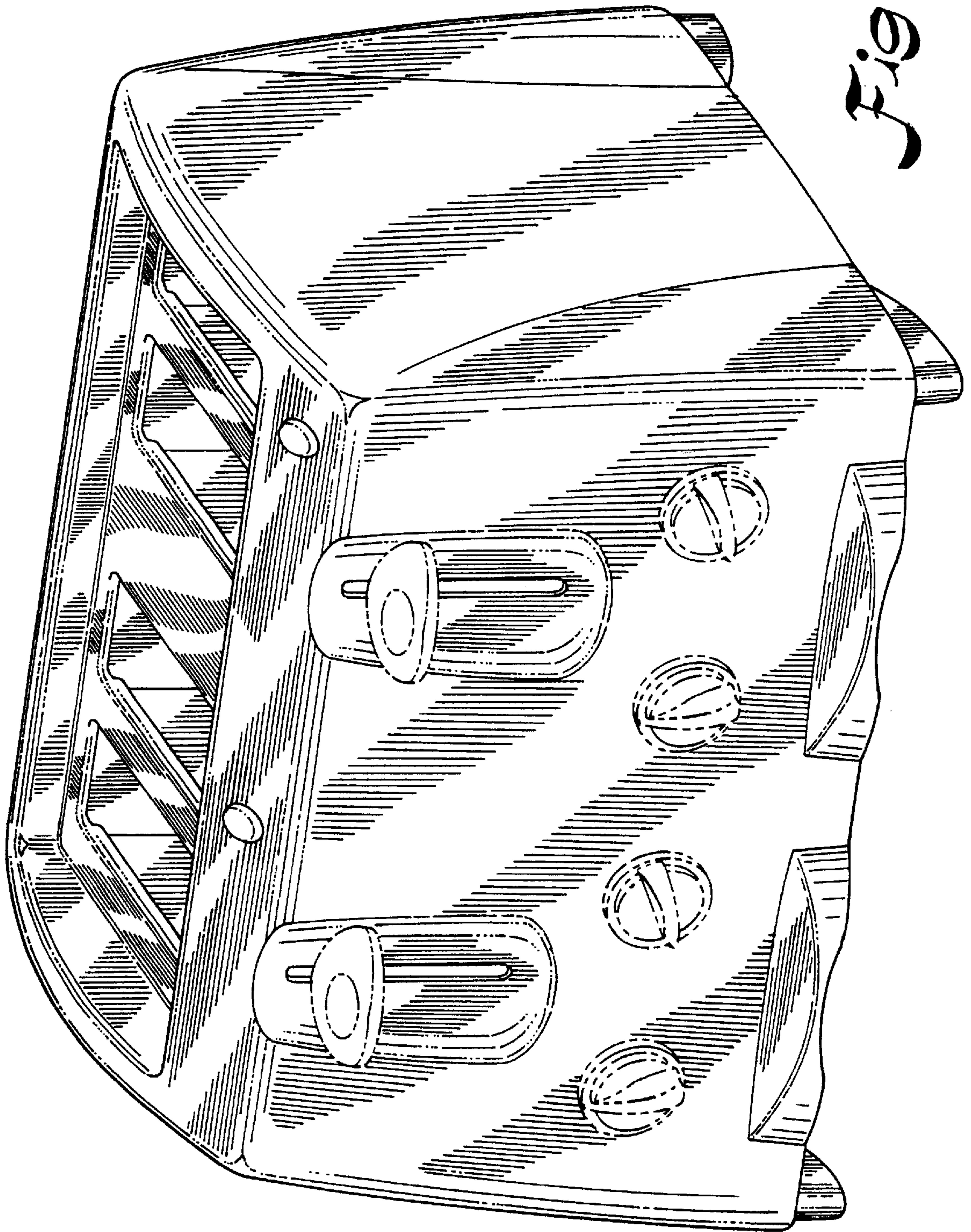

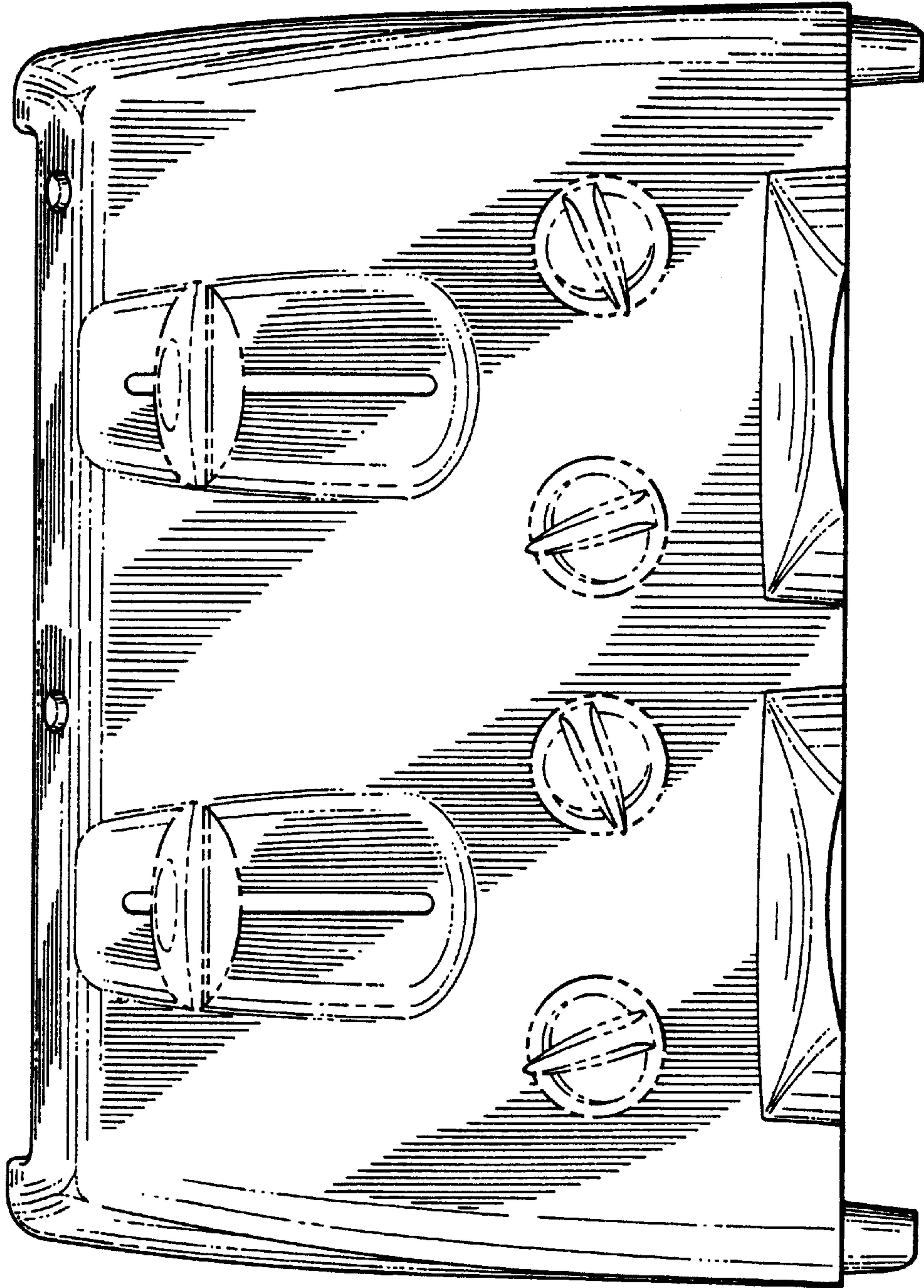
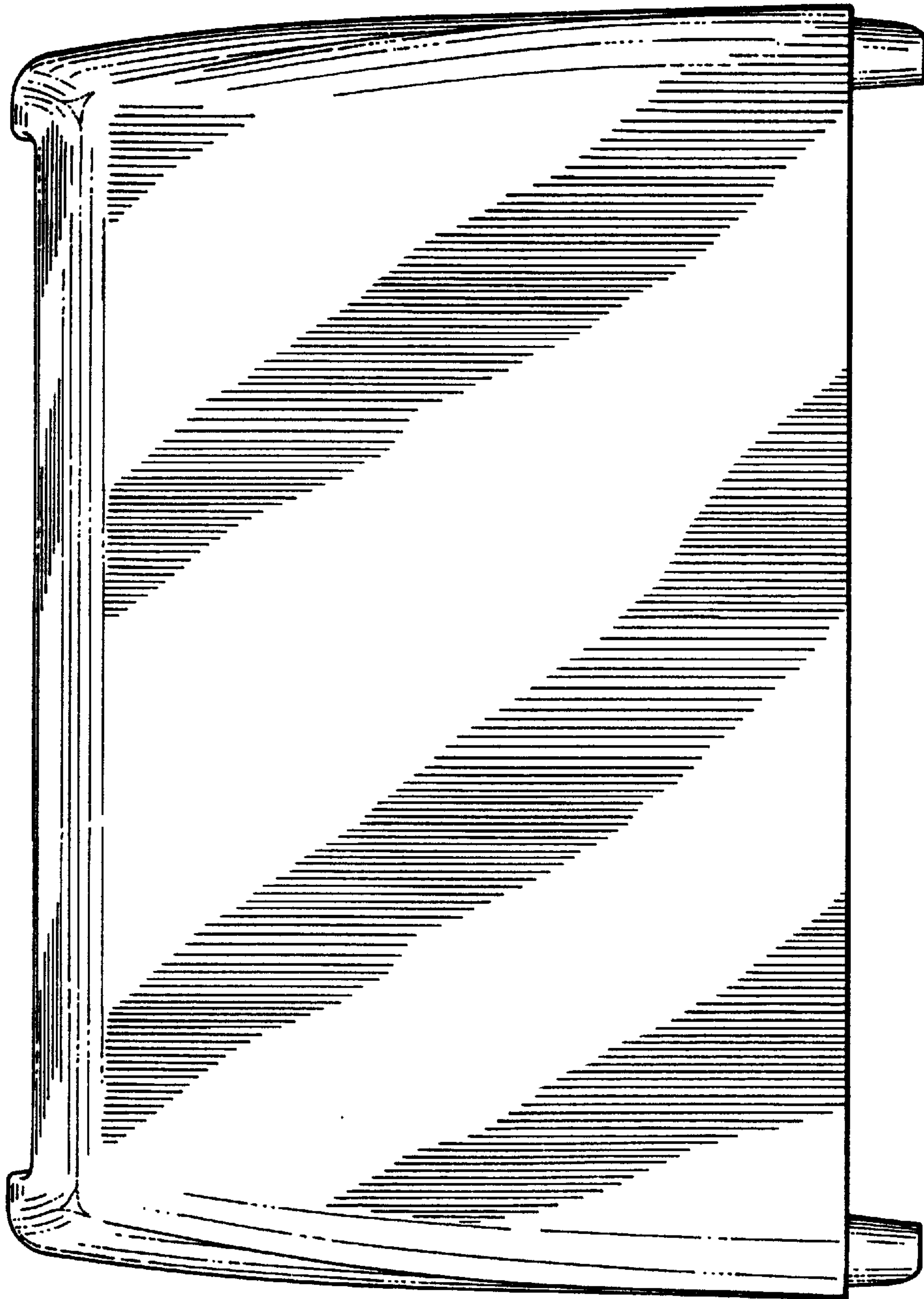
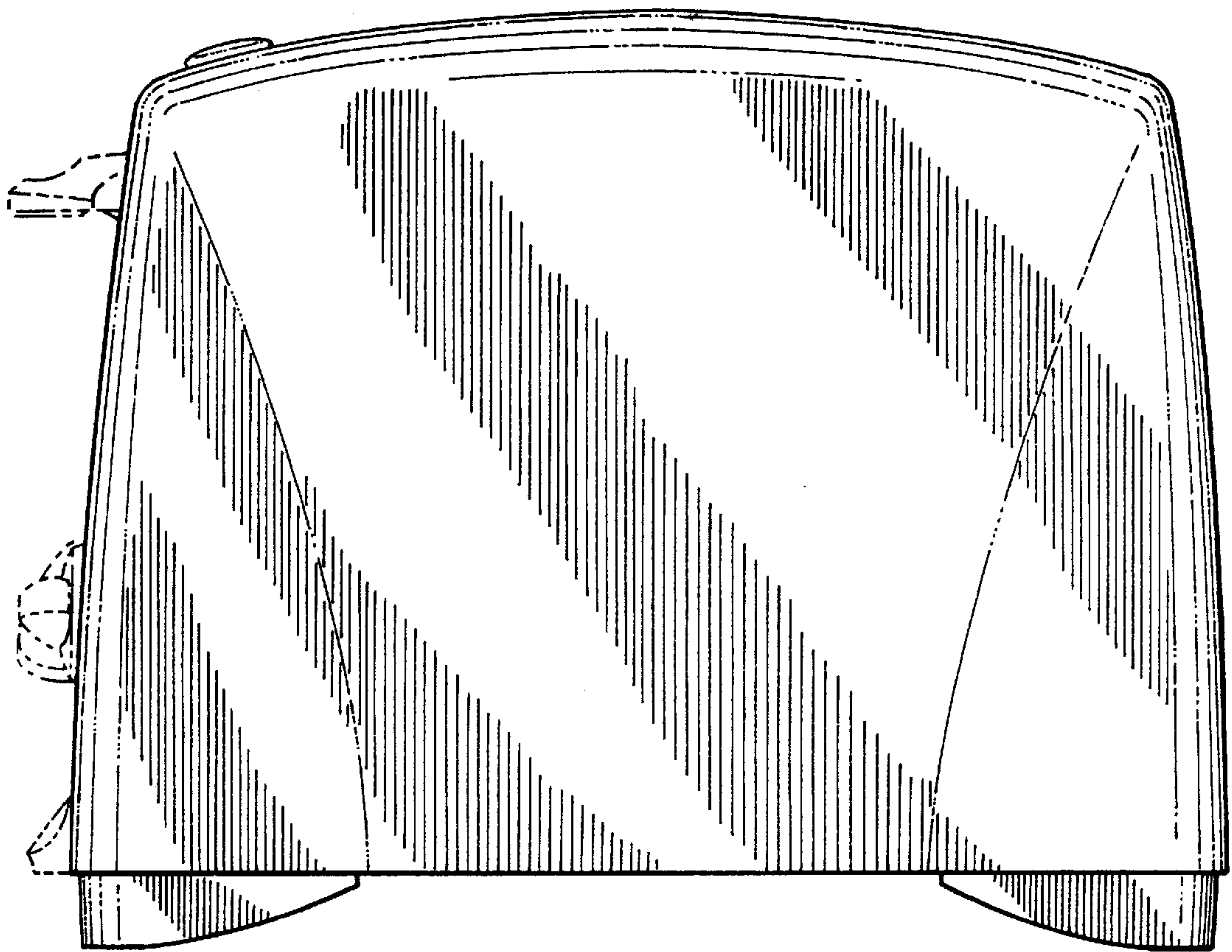

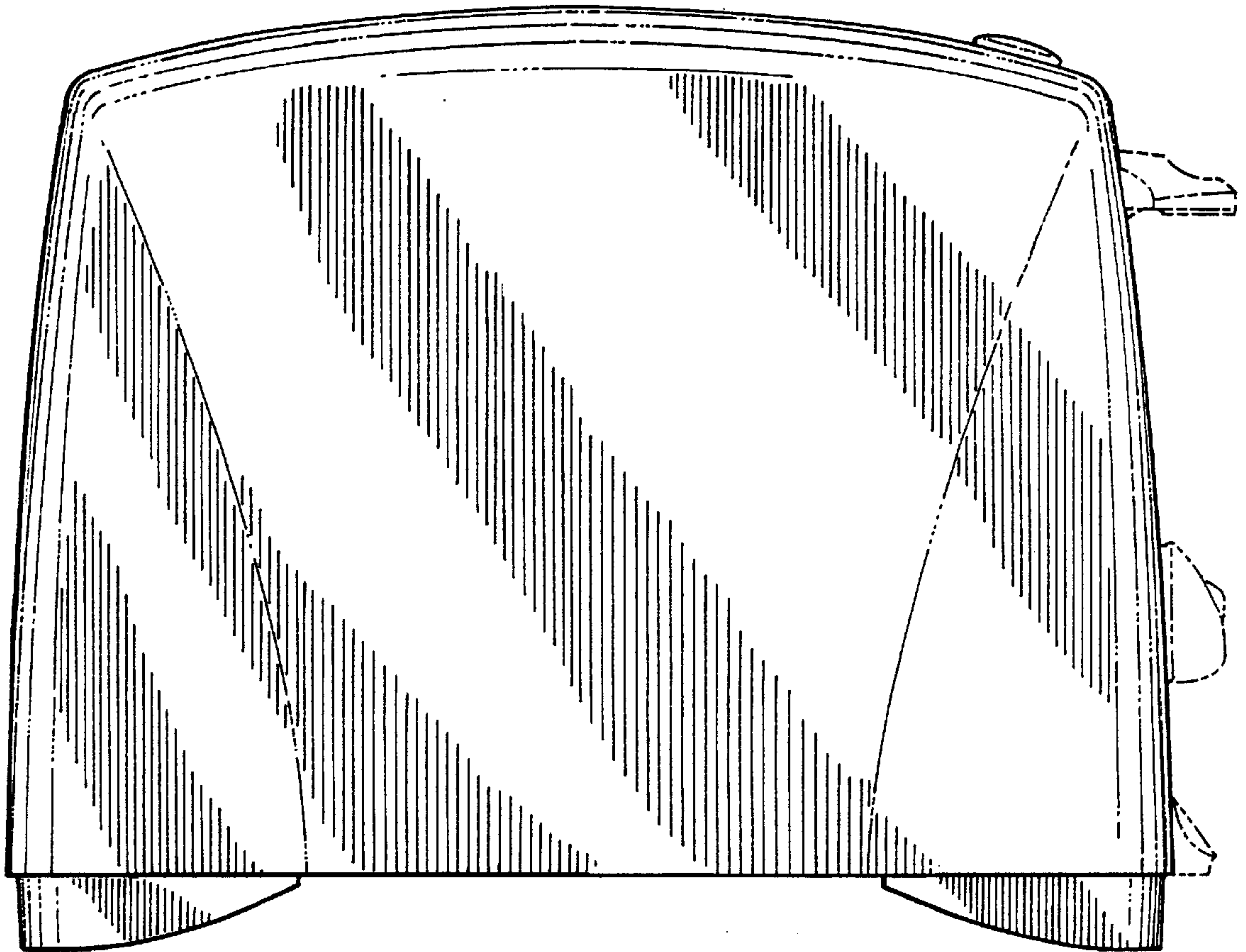
