DESCRIPTION

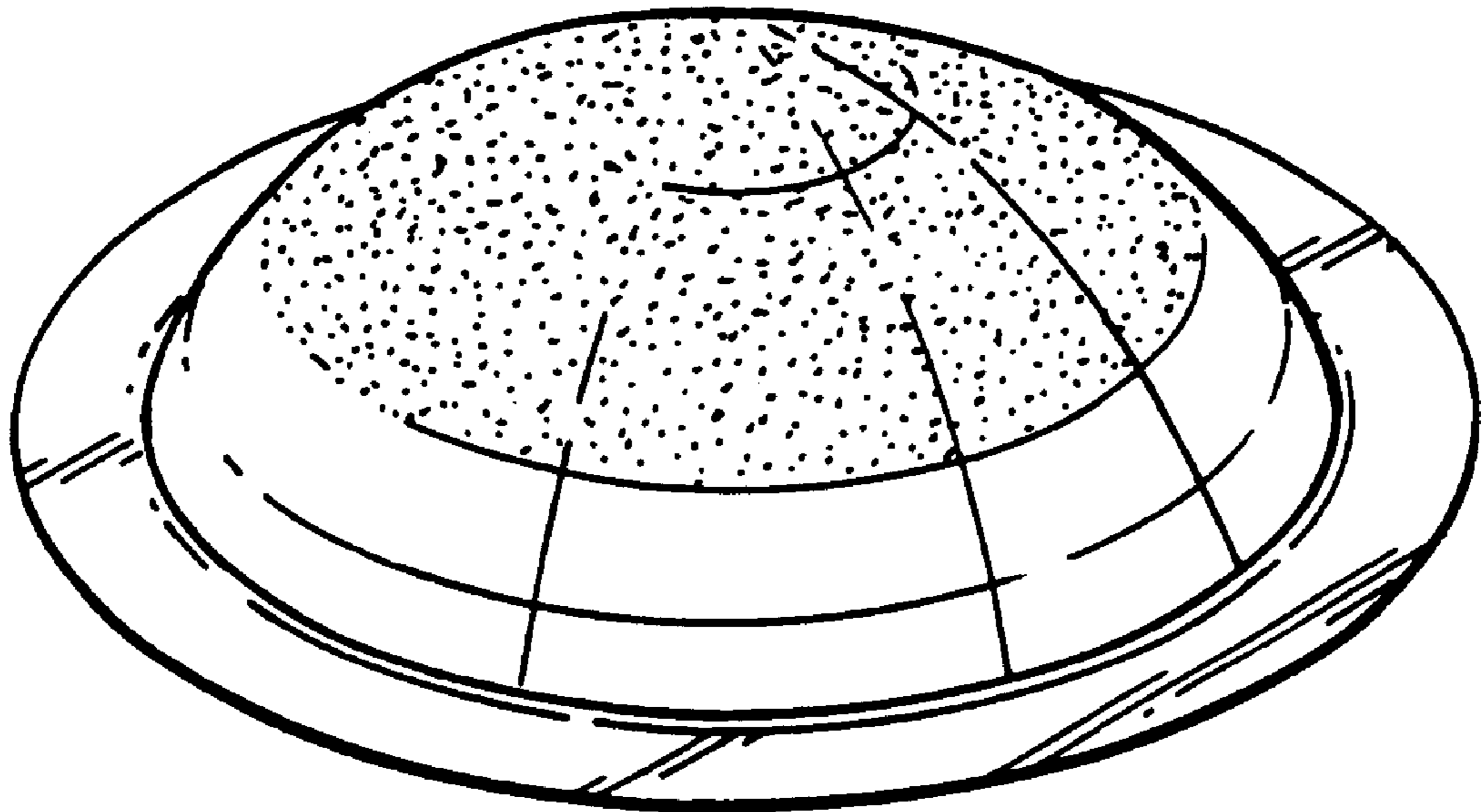
FIG. 1 is a perspective from above the capsule, showing my new design;

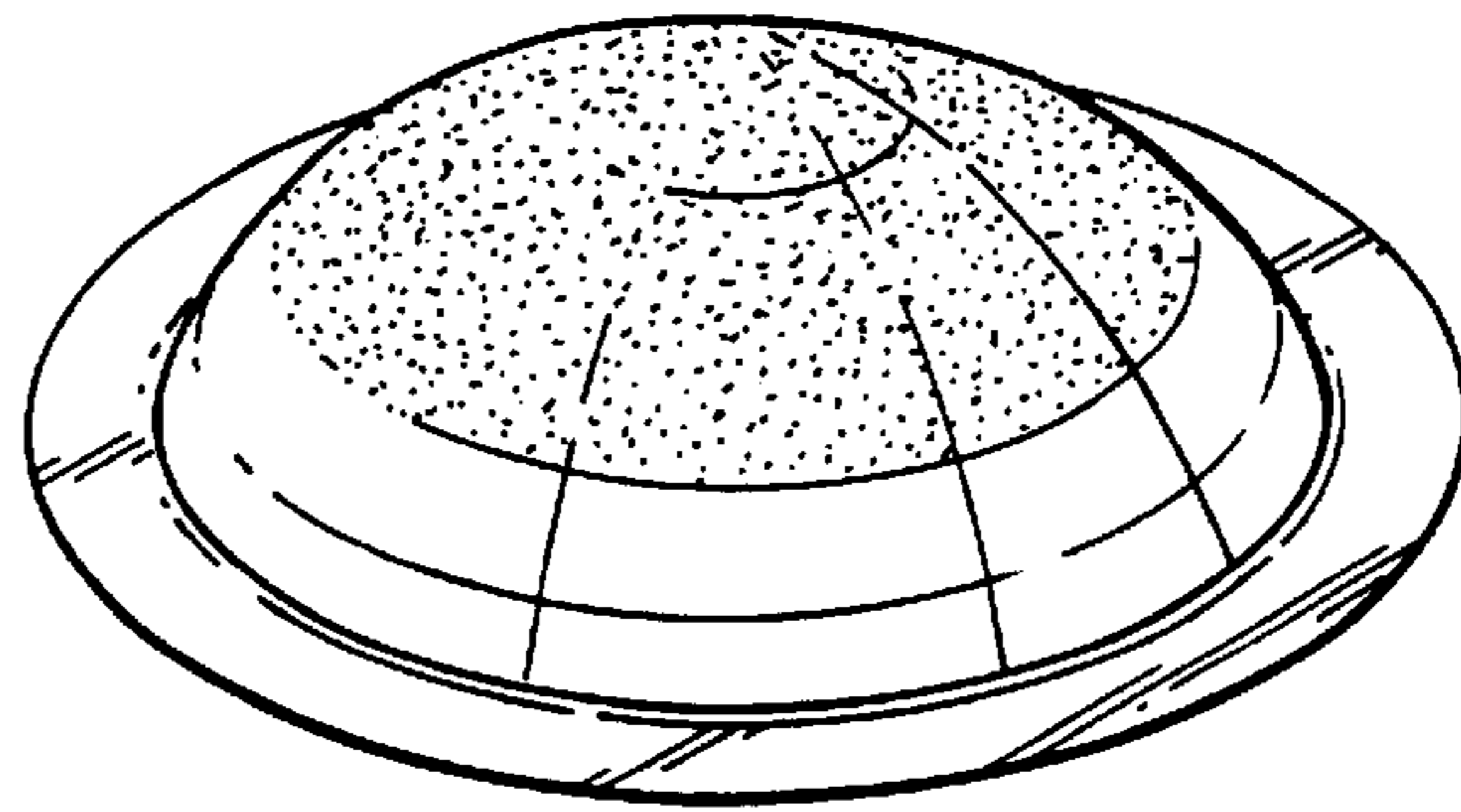

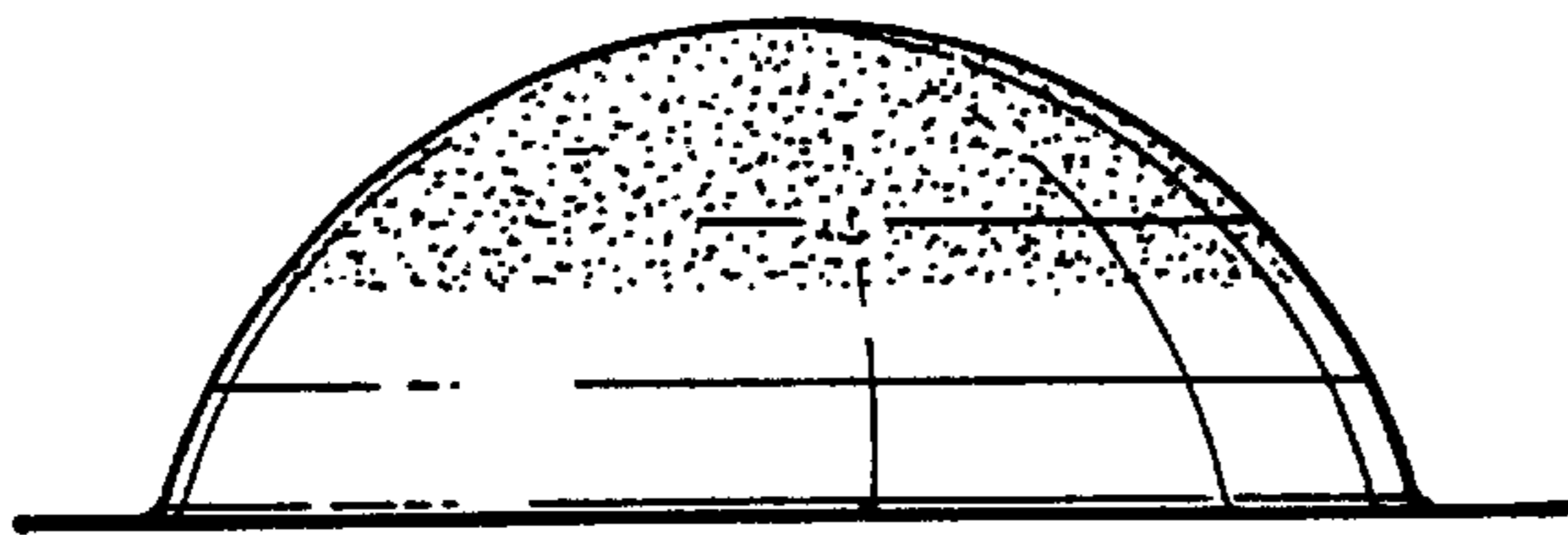

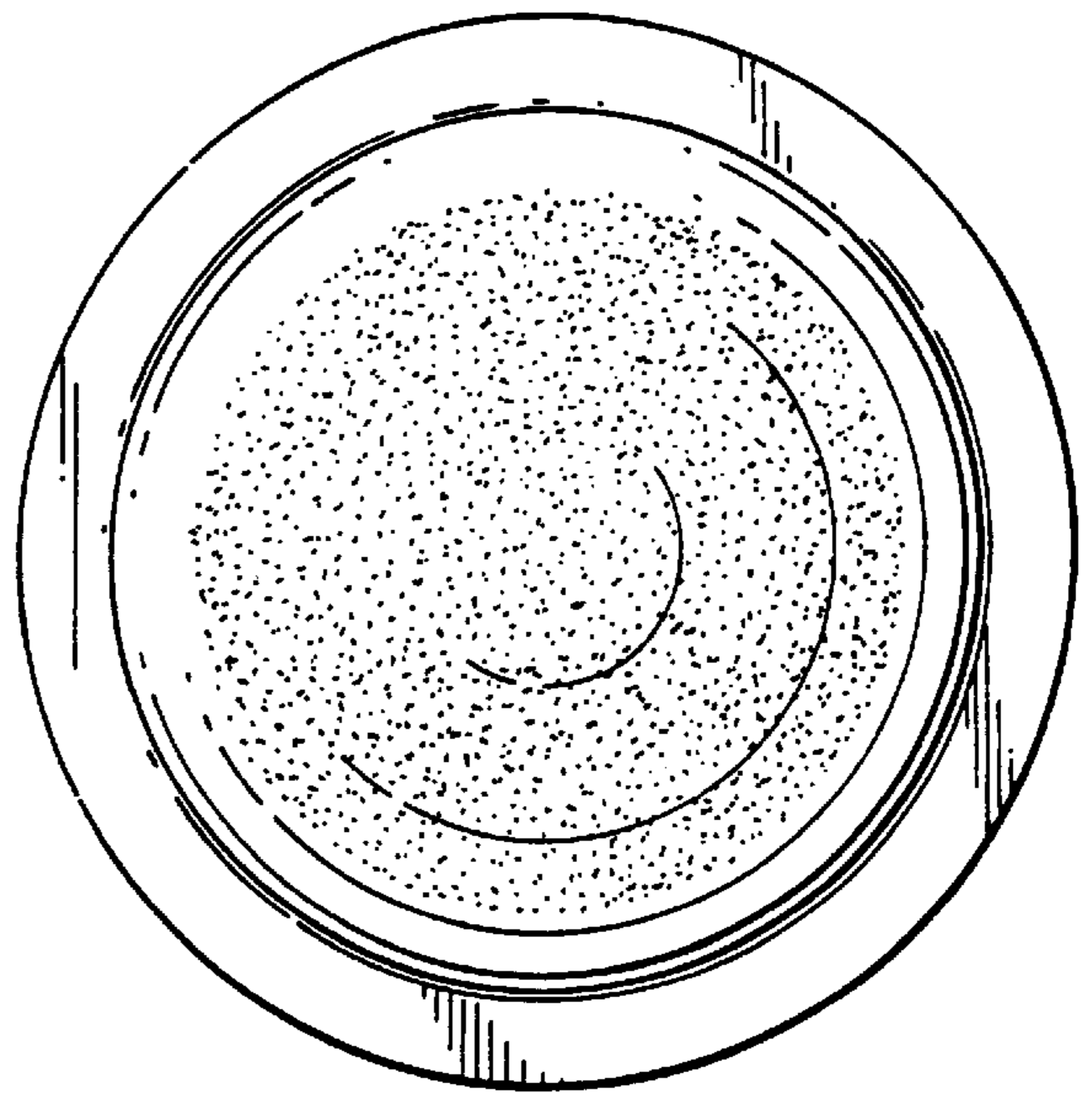

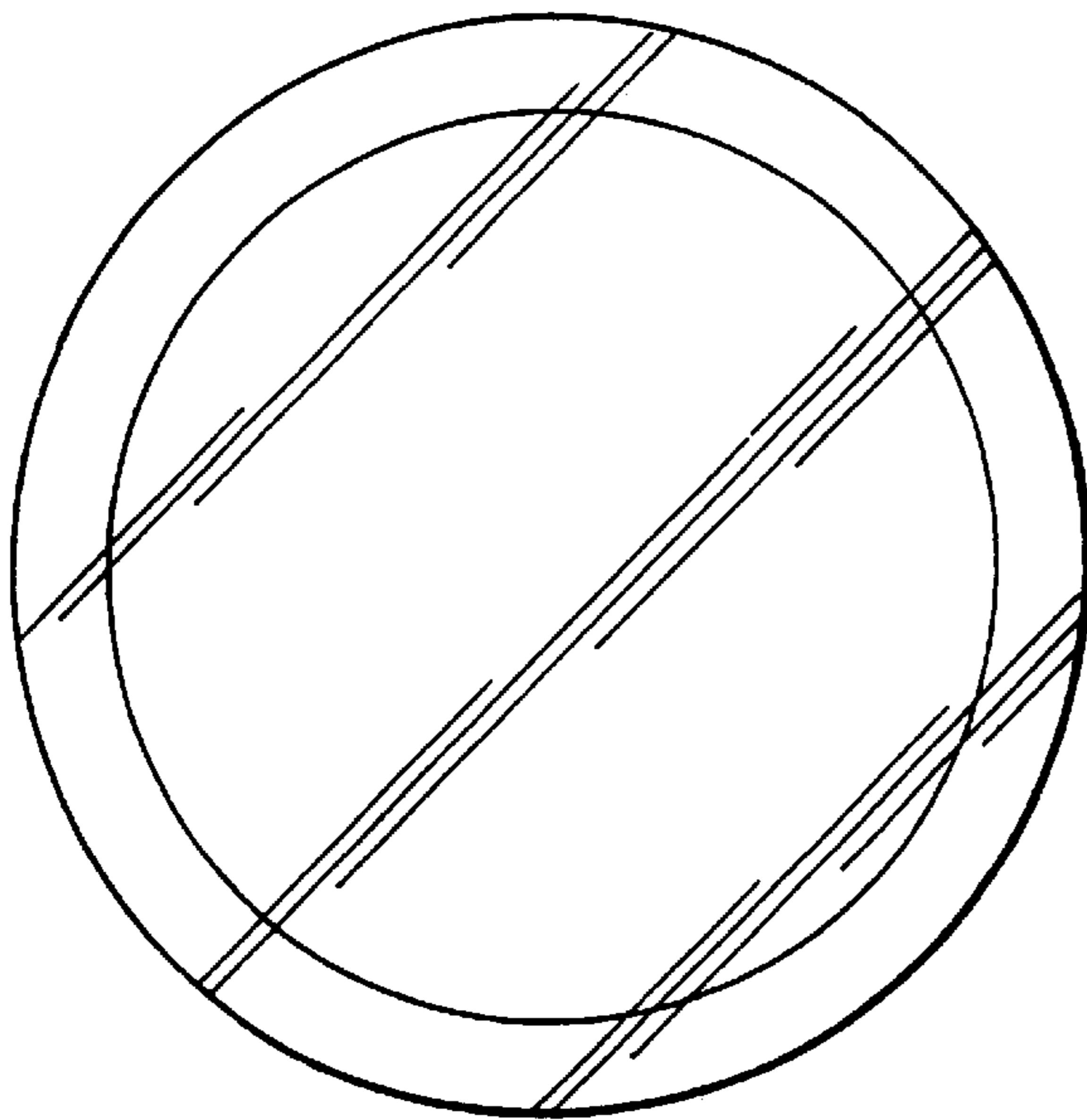
